EVANSTON, Ill., Jan. 27—A book by a Northwestern University professor that says the Nazi extermination of European Jews was nothing more than a Zionist-inspired myth has caused a storm of campus and community protest and hasembarrassed university administrators.

In the book, Mr. Butz argues that there was no German policy of Jewish extermination and that millions of European Jews were not deliberately slain in Nazi concentration camps. Instead, he contends, many of them died of disease and starvation or were "deported to the East."

Assertions of a Jewish holocaust, he writes, were contrived by Zionist leaders to promote sympathy for a Jewish homeland in Palestine.



Various American, British and Soviet officials cooperated in this effort, the book says, and fabricated evidence and coerced testimony were employed at the Nuremberg war-crimes trials in the late 1940s.




