

My courageous young men and I are risking our liberty and our very lives to do what Paul Revere did for America in 1775. His cry, which jolted American patriots awake and into action was, "The Redcoats are coming!"

Our cry of warning to America is, "The Reds are coming!"

Many people will say our cry should be, "The Blacks are coming!" But most of the Blacks who will "march" on Washington, like most of the peasants who have marched in all Communist revolutions, are simply professionally agitated DUPES. They are being told they march for "freedom" and "equality". These are always the battle cries of Communist revolutions everywhere.

On August 28, 1963, the Reds are launching the first testing blow of the Soviet revolution in America. Their purpose is to INTIMIDATE and TERRORIZE our Congress into passing a nakedly Communistic "Accommodations Law". If White Christian America has been sufficiently cowed and beaten so that it will stand still for this Red outrage and occupation of our National Capital, the final blows of their Soviet revolution will rain upon us swiftly and fatally.

To survive, White Christian America MUST demonstrate that it will RESIST! It is not necessary to break the law. We have as much legal right as any gang of marching Blacks to demonstrate in our own National Capital. AND DEMONSTRATE WE MUST!

The Jewish dominated press, radio, TV, etc., have been systematically blacking out all news of our success in recruiting thousands of White men to counter-demonstrate against the Red march on Washington on August 28. In Emporia, Va., where the Jewish Blooms dominate the town with their big department store and money, I was even arrested and charged with trying to start up a "war" against the colored population and for trying to present to my fellow Virginians the facts and documents printed here. Martin Luther King, who HAS started up a very real war against the White people (he and his gang openly call it a "revolution") comes and goes as he pleases and is not even arrested for disorderly conduct in Virginial

But all their lies, propaganda, false charges and intimidation will not stop us any more than it stopped our forefathers in 1776! We have chosen our name and symbol for SHOCK power, because White Christian America needs to be SHOCKED! In spite of all the blackouts, lies and smears in Jewish-dominated papers and on TV, I have been applauded and cheered in every single town in which I have spoken! That is the truth. The good White Christian American PEOPLE of this great Republic, in their hearts, believe EXACTLY as I do. More and more of them every day are beginning to understand that we are not trying to "overthrow" the Constitution, but to PROTECT it and, above all, to save the great White Race, which alone has produced Western Christian civilization!

The other Right-Wing leaders who damn me and my "methods", do not dare stand up to and face that terrible black mob in Washington on August 28!

I WILL! I am convinced this is one of the most deadly moments in American history and only force or death can stop me and my people from defying the Communist Black army of terrorism in Washington on August 28. Thousands of White men have already pledged to be here to oppose Martin Luther King's Black horror on August 28.

Here is what YOU can DO to help at this desperate moment in our history:

(1) Be at the Washington Monument at dawn on August 28 with every single White person—man, woman and child—you can bring. I realize this means sacrifices. But it will be worth it! On
