

# EMORY BURKE QUITS NSRP!!

NEW ORLEANS, LA. -- I have just left Birmingham, Alabama, where I got Lt. Roy James out of jail, with the help of Alabama Patriots -- and Montgomery, Alabama, where I concluded conferences with Emory Burke and other patriots -- conferences which I believe will make history.

When the National States Rights Party was first organized, it was called the "United White Party". I myself was one of the founders at a meeting of patriots in Knoxville.

At that Knoxville meeting, I first met Ed Fields and Emory Burke. All of us had the same idea, and, for a long time, I helped Ed Fields -- and he helped me.

We differed on tactics, but we were 100% agreed on the goal for which we fought: the utter destruction of the Jew-Communist, race-mixing conspiracy and the rebuilding of a true, White, FOLK community in America.

Besides this unity of aim, I knew that the moving force behind the NSRP was Emory Burke -- one of America's naturalborn leaders and one of my best personal friends.

Emory and I -- and other sincere leaders -- saw the American Nazi Party and the NSRP as marching along parallel paths to the same salvation of our White Race and American Republic. We worked TOGETHER, the way Right-Wing groups SHOULD!

Then an unprincipled scoundrel named James K. Warner slithered into the scene and tried to get me to let him use the ANP mailing list for his own personal profit! When I put a firm stop to this attempt to MAKE MONEY out of the tragic concern of Right-wing patriots, Warner STOLE the mailing list, pretending he was leaving just to visit his "dying" mother.

Until this time, Ed Fields and I had exchanged information and literature, and were on friendly terms. But, apparently,

the ANP mailing list was a great temptation, because, soon after Warner left to visit his "dying mother," he (Warner) authored and published an unspeakable and unprovoked personal smear against me -- and recommended that patriots join the NSRP (Giving the address and membership information).

In spite of this attack, I kept negotiating with Ed Fields until finally he kicked money-grabbing Warner out of the NSRP, and printed a notice to that effect in the "Thunderbolt".

But then, several months later, Fields suddenly announced that profiteering Warner was to become an EDITOR of the "Thunderbolt," and began to print worse and worse smears and lies against the ANP and myself! I still don't know WHY he did this.

But from that moment on, it became obvious that Warner had some kind of an evil hold over Ed Fields. The NSRP no longer worked to build an organization or even to fight the Jew-Communists and race-mixers as it had been. Instead, Warner and Fields began to use the NSRP as a PROFIT venture and the 'Thunderbolt' as a tool in an incredible campaign of personal hatred.

In spite of the extreme provocation by Martin Luther King, Jr., RIGHT IN THEIR HOME CITY OF BIRMINGHAM, Warner and Fields would not picket, or even hand out protest literature (several of our elderly lady associates have done that much for us in Washington). They were too busy inside 1906 Mims Street, writing more lies and hate about us in the 'Thunderbolt'".

That's where they were when Lt. Roy James, ANP, all alone, went in among hundreds of agitated blacks, heard Martin Luther King, Jr., saying Sammy Davis, Jr., was the best example of 'Americanism,' lost his temper and leaped up on the stage to knock Martin Luther Coon senseless.

I wondered what had happened that Emory Burke would PERMIT Fields and Warner to stop fighting the race-mixers, to pervert the aims and ideals of the NSRP and to print such vicious lies and smears.

This week, at last, I got together with Emory Burke in Atlanta and again in Montgomery, and learned the incredible answer: true as steel to his principles, Emory Burke had done everything possible to get the NSRP "back on the track" of attacking the REAL enemies of mankind, instead of smearing fellow fighters for the White Race.

But his efforts have been in vain.

Apparently because Warner is aware of certain facts about Ed Fields and a young girl from Louisville, Warner has become the mad "Rasputin" and evil master of misguided, scared Ed Fields. Fields -- Emory reports -- seems to be helpless to resist Warner and his insane personal hatred of me. Warner has gone so far as to announce he is going to hire the Mafia to have me murdered -- believe it or not!

Fields has thus been <u>captured</u> and <u>used</u> in Warner's mad campaign to destroy me and the ANP, instead of fighting the communist Jews and race-mixers.

The NSRP, inspite of its empty boasts of "thousands of members," has NO members who will DO anything at all, as they showed in Birmingham, where they have "hundreds" of members, on paper -- but were unable to get ONE member out to protest the agitation of Martin Luther Coon right in their own hometown!

Emory went up to Birmingham again and again, trying to persuade Warner and Fields to get down to FIGHTING Jew Communism and race-mixing and ORGANIZING the NSRP -- instead of making money and printing smears -- but it was no use. Fields has bought a brand new \$3,300 Pontiac Tempest, has another luxurious place, and has fallen so far under Warner's domination that he will not personally go out and do anything except attend PRIVATE meetings.

Emory, working desperately to keep his lovely wife and four children housed and fed, was even cheated out of \$75 a-month rent on a brand new building he let Warner and Fields use! When Emory had tried everything imaginable to bring Fields to sanity and get him to oust mad-dog Warner, -- without success -- he did the only honorable thing left.

He resigned from the NSRP!

I had hoped I could get Emory to join us. He is a master orator and one of the

best informed men in the world on the race problem.

But Emory sincerely believes that our name, "Nazi", and our Swastika symbol are tactically wrong.

Nevertheless, he has not laid to rest the great sword of the White Race which he first seized up in Atlanta, way back in 1946 when he organized the hugely successful stormtroops of the "Columbians". For this brilliant success, Emory was framed by the Anti-Nazi League and did almost two years on a Georgia chain gang!

Saddened by the collapse of the NSRP as a real fighting organization, Emory has determined to form a new group of his own called the "WHITE AMERICAN NATIONAL-IST PARTY". He takes with him many sincere but disgusted former NSRP members, plus many members of the fast growing Fighting American Nationalists, who have been desperately seeking such leadership as only Emory Burke can supply.

Emory allowed us to review the plans for his new organization, and, while we regret that he couldn't see the value of the Swastika and Nazi approach, we can assure sincere American patriots that Emory's new "WHITE AMERICAN NATIONALIST PARTY" will cut a swath in American politics which will make history.

The new group will fly the dynamic THUNDERBOLT flag, which Emory designed personally, and long ago registered with the U.S. Copyright Office.

Perhaps most wonderful of all, the "WHITE AMERICAN NATIONALIST PARTY" will establish National Headquarters in Emory's own building in Montgomery, Alabama, with an ENORMOUS, forty foot high sign along super-highway 231, with a gigantic THUNDERBOLT insignia and fighting slogans of the White Race.

He already has YOUNG, dedicated men to staff the headquarters, and they will be picketing and fighting for the WHITE RACE all over the South in the near future.

We hope that all sincere patriots who have been taken in by the lies, misrepresentations and smears of Warner and Fields will now rally behind one of America's really GREAT leaders, Emory Burke -- and his "WHITE AMERICAN NATIONALIST PARTY".

# ANOTHER JEW SPY

Ever faithful to their despicable tradition for spying and intrigue, the Jews have now supplied the FBI with one more lesson in WHO the enemy is -- in case they needed one!

# 'NAZI'U.S. MARSHALS???

We wish it were possible to reveal the name of the man who has given us some of the most startling information we have ever received -- but we can't do it.

Nevertheless, we CAN say that he was one of the senior "Marshals" at Oxford, Mississippi, and has given us the low-down on that disgraceful episode in American history -- besides another two items of information which will shake the Jew traitors and race-mixers to the roots.

First, just as we have been preaching that most law-enforcement officers are right-wing patriots -- and as we therefore expected, the vast majority of marshalls in Oxford HATED what they had to do, and act-

This good and brave man told us that for at least TWO weeks, the United States Government has been flying James Meredith on a paid vacation on weekends, AT GOVERN-MENT EXPENSE!!! This black-red agitator (who now threatens to move to Russia if he isn't welcomed in Mississippi), has been flown in a Border Patrol aircraft from Oxford to Memphis Naval Air Station, and there in heavy secrecy, picked up in a NAVY plane and flown for personal visits to Jackson, Mississippi!

This task is so distasteful to the pilots that the marshals were quite horrified that Meredith might "fall out" of the plane on the way!

We are going to use THIS bit of information to look into the possibility of a suit

against the Justice Department for using their government aircraft and gasoline to fly the red agitator for PRIVATE VACATIONS at taxpayers' expense. I feel sure we can file a "taxpayer's suit" in this matter and put the Jew Communists and race-mixers on the "horrors".

In addition to this information, our Marshal friend revealed that TWO WEEKS BEFORE TRUJILLO WAS ASSASSINATED, the U.S. Government sent teams into the Dominican Republic and to key ports to make sure that pro-Trujillo men didn't get back in, once they had been driven out after Trujillo was shot! # Q. HOW DID IT FEEL TO BASH MARTIN LUTHER KING?

A. Well, although I lost my temper, mentally it felt like striking out against everything that was evil and vile. Physically, it felt like smashing your fist through the crust of a

pumpkin.

### Q. WHAT BROUGHT YOU TO BIRMINGHAM?

A. I was passing through on Party business. I had some time to kill, heard King was in town, so I went out to hear the rat speak.

### Q. DID YOU PLAN ON BEATING THE DAY-LIGHTS OUT OF KING?

A. No. Actually, I violated Party regulations It was a spontaneous reaction -- the kind of thing you'd get if you saw a savage black ape, drunk on Jew booze, attacking a young White girl.

### Q. DID HE SAY ANYTHING?

A. There wasn't time. His white eyes opened wide and his lips seemed to be forming into the word "No", but then my fist was pummeling his face.

# Q. WHAT WERE YOUR THOUGHTS AS YOU STRUCK THE FIRST BLOW?

A. Of administering justice to a vile communist race-mixing nigger agitator.

### Q. DID HE BLEED MUCH?

A. Yes, quite a bit. The blood was gushing out all over the place. I think I busted a vein. His face was all cuts, and it began puffing.

### Q. WHAT DID KING DO THEN?

A. He stayed away.

### Q. WHY WERE YOU TRIED SO QUICKLY?

A. The coons and Jews wanted to hush the the whole thing up. I pled guilty so it would not look like I was trying to deny it. After the trial they took King to the hospital.

### Q. HOW WERE YOU TREATED IN JAIL?

A. Like a conquering hero. All the White prisoners wanted to shake my hand. The guards all congratulated me and gave me cigarettes and candy. I don't smoke so I gave the cigarettes to White prisoners.

# Q. WERE THERE ANY CLOSE SHAVES WITH NEGRO PRISONERS.

A. Well, the jail was segregated, but one time, through a mix-up, I ended up in the coon section at chow time. They all stopped eating and stared at me. You could hear a pin drop. I knew if I showed fear I was a goner. So I defiantly stomped up to the coon dishing out chow and demanded a heaping portion.

### Q. WHAT HAPPENED NEXT?

A. He seemed awed. But he gave me the heaping portion. The other coons were all stunned. I ate and left when the gate opened.

### Q. DID NSRP PICKET KING AT ALL?

A. No. I guess they were home thinking up more lies about us.

# Q. WHAT WERE YOUR THOUGHTS THAT FIRST NIGHT IN JAIL AFTER THE TRIAL?

A. I felt good and proud all over. You do, you know, when you belong to the greatest fighting outfit in the world.
