As this issue of the ROCKWELL REPORT goes to press, Goldwater seems sure of the Republican nomination.

I think I owe the regular readers and supporters some analysis of this fact and some predictions of what it will mean.

First, let's recognize why so many otherwise "sharp" right-wingers are being seduced into the Goldwater camp, -even some veteran Jewfighters.

I remember how I felt after a few years in the far Pacific during the war, completely isolated from even the sight of a White woman. Even the black "Gooks" with the pointed teeth began to look "good" to us so long only as they were female.

Right-wing patriots have been so unendurably long without a national leader who appears to have a ghost of a chance that even a Jew is beginning to look 'good' to us. I must confess that I myself am sometimes sucked into this feeling when I hear Barry Morris cooing softly his anti-Communist statements. They sure sound good!

It is easy to see how American patriots, literally starved, as they are, for just one MAN in top government, find it hard to resist Barry's blandishments. One tends to see what one wishes for when the hunger is so desperate, just like a mirage.

But facts are FACTS, and Barry's RECORD just can't be dismissed, -nor can we ignore the pats on the back from Ike, the restrained "blasts" from the Jew press, (nothing like the boiling hatred for McCarthy), nor Barry's oft-repeated statements about his undying support for race-mixing. He is STILL a member of the Urban League.

Barry is the "Ike" of 1964, the "bone" tossed to the yapping pack of rightists at their heels by the sly Jews.

Just how "poisoned" is that Jew "bone" tossed to the rightist "dogs" is shown by Goldwater's brazen and brutal statements, day after day, that he is 100 per cent for race-mixing. In spite of this, he keeps the South following him around like a hungry puppy by saying the STATES ought to do the mixing. But when asked if he would use Federal troops to MAKE the States do it, he is not outdone by any leftist in his determination to use the troops for the niggers and reds.

If it be objected that he HAS to do this to win the nigger vote, let such objector ask himself if he honestly believes for one minute that Goldwater will get the nigger vote, --even if Goldwater did nothing else but campaign day and night to the coons of America.

The little Jews and all the niggers believe Goldwater is one of 'us' just as much as any of the poor, starry-eyed Kosher Conservative following Barry around. They will NEVER vote for him, no matter WHAT he says. If Goldwater were on the level, he would be making STRONG statements to win the WHITE people, and the hell with the coons he will never get anyway.

Thus Barry is still the same old Jew faker we have exposed so many times.

It remains only to appraise the situation now that he will be nominated, barring a "miracle".

The biggest result of Goldwater's nomination will be that the "civil rights" hell-raising will be sharply curtailed, until Johnson is safely in. If the niggers raise the hell they would like to this summer, the "White Backlash" might just put Barry in. This, in itself, would be no catastrophe for the Jews and reds. But too much nigger hell-raising might not only put Barry in, it would also put in a strongly WHITE, rightist CONGRESS and Governors, etc., all over America.

This cannot be chanced, so I am convinced that the worst hell-raising will be NEXT summer, not this one.

I will predict another effect of the Goldwater nomination, a tragic and heart-breaking effect.

With this enormous "victory" for their boy, Barry", the sissy kosher conservatives, from Welch to Buckley and Hargis, will zoom to heights undreamed of, --and drain off millions and millions of dollars from wealthy rightists for another useless project, --the election of Barry.

With the smell of success in their nostrils, be it ever so impossible and phoney, the Hunts, J. Howard Pews, etc. will pour out the loot to the campaign for Barry.

Unless there is an unforeseen catastrophe, nothing on earth can stop Johnson THIS time, because of that damnable habit of Americans of voting by "labels" and "images". Every penny heaved away on Goldwater will be a penny drained from the FIGHT.

Thus I look for some black months ahead, until the elections, for hard-core rightists who dare to face up to the Jew problem.

I still believe Goldwater will be the President in 1968, after four years of unheard-of betral and corruption, crime and communism under LBJ. The people would elect Mortimer Snerd in preference to LBJ in '68. But not NOW.

Finally, it remains to point out the utter brilliance of the Jew strategy used by Goldwasser in having his Hebe cake and eating it too.

Right now, literally MILLIONS of Southern White men are all steamed up on behalf of Goldwater, believing he is on THEIR side. The niggers are picketting him, walking out on him and raging at him in a manner to warm the cockles of any Mississippi heart. Yet not ONCE, never, has Goldwater said or done one thing to HURT them.

"But he voted against the Civil Rights Bill!"
you say, That hurt. It shows he's on our side.

Like HELL! Just as Frankfurter started voting "conservative" once he had the Court packed with enough reds, Goldwater voted against the nigger bil ONLY when it was a cinch to pass.

The Jews do this to our side time after time after time after time and millions of our side keep falling for it.

The thing to REMEMBER out of all of this is that, for long-range victory, we must have an eventual Goldwater VICTORY. Not until the Kosher Conservatives have tried all the EASY ways and had their bottoms kicked for it, will they dare to back a FIGHT. Not until they have tried Taft and Ike and Barry will they be ready for Rockwell.

Pennsylvania Radio Station Gets FCC Warning For Broadcasting and Offering Rockwell Speech

Communications Commission put a Pennsylvania radio station on probation with a reprimand and renewed its license for one year instead of the usual three after it recorded and broadcast an anti-Semitic speech by George Lincoln Rockwell, self-appointed head of the American Nazi Party.

The (Pittsburgh) Jewish

Chronicle reported that the Anti-Defamation League brought the matter to the attention of the FCC. Radio Station WMLP in Milton Pa., not only recorded and broadcast the speech but offered the recording to the public over the air as a "public service."

Brant Coopersmith, ADL's regional director, told the FCC that such "promotional blurbs"

could conceivably be considered an example of giving freedom of expression to different points of view. However, he noted that "one would still be justified in questioning the judgment of a station owner who devotes a disproportionate a mount of air time to build up the activities of the head of a miniscule but viciously bigoted group which calls itself the American Nazi Party and whose headquarters have become the gathering place for a collection of vagrants and convicts."

Coopersmith also said that WMLP's recording of Rock-well's speech and offering it for sale was apparently the only lime this had been done.



Eight innocent men have been convicted in the Supreme Court of Bronx County, N. Y., and six of them face up to ten years in prison when they are sentenced July 16th. The men are white segregationists who were arrested in July last year during C.O.R.E. demonstrations at White Castle Diners and charged with criminal anarchy, unlawful assembly and conspiracy to incite a riot.

There was no riot or conspiracy to incite a riot. On the night of the arrest five of the men met at the Manhattan apartment of James Madole and made arrangements to distribute an anti-integration leaflet. Mr. Madole is head of the National Renaissance Party which has done much to expose Jewish leadership and motives behind the integration movement. Paul Joachim, though not a member of the party, was asked to drive the group to the Bronx where the leaflet was to be distributed. Those who went with Mr. Joachim in his panel truck were Edward Cassidy, Peter Krauss, and John J. Corrigan. One of the group, Daniel Burros, decided not to go and remained with Madole at the apartment.

In the Bronx the group distributed the leaflet to white passersby on the streets. When they finished they decided to buy hamburgers and drove to a White Castle Diner where they met two friends, Anthony Wells and Iah Lehr. The Diner was being picketed by C.O.R.E. demonstrators, and most of the customers inside were Negro sit-ins. One of the white men handed a leaflet to a white waitress. A Negro became abusive and attacked three of the white men. Other Negro C.O.R.E. members joined the attack. Instead of retaliating, the white men asked one of the two policemen present to arrest the Negroes. The policemen refused to act, apparently indicating that they were unable to cope with the large number of Negroes. The Negroes then followed the white men to their truck, kicked the truck and smashed a window. The police still refused to act, and told the white men "to leave and take their complaints to the Mayor" or to "go to the local police station."

Three of the men drove to the nearest precinct and were told by a detective that he would not try to find the Negro who broke the truck window. The police searched the truck, however, without cause or warrant. In the back of the truck were farm tools, camping and miscellaneous hunting equipment, including a cross-bow (dismantled, in a closed box) and a broken gun which had not been registered because it was not in working condition and not intended for use. The police then went to the Krauss home in Queens,

run attacks. When you SET UP SHOP in New York, you must be ready for precisely this kind of Jew frame-ups and persecution. The NRP was a gentle debating society and by no means trained or ready for pitched battle with the Jews, in spite of a few pickets and literature forays. The NRP is perhaps the WEAKEST "Nazi" organization in America, and they tried to tackle the STRONGEST fortress of Jewry with a loose agglomeration of untrained men LIVING RIGHT IN NEW YORK! The results were predictable. I will attempt no strong stand by the ANP until we can SURVIVE and WIN against this sort of persecution. We will also see that trained LEADERS are on the spot to prevent the SECOND big mistake in this affair.

There is no question that the men were not "guilty" of anything. The "weapons" found in the truck were not really "weapons" at all. BUT THEY COULD BE MADE TO APPEAR SO TO A JURY!

And therefore, they should have been ruth-lessly cast out by the operation leader, long before they got near any nigger, Jews or cops. Here in Arlington and at all our HQ's, weapons of ANY kind, even collector's items, are BANNED, and the ban is ENFORCED. When we go on an operation, not even a NAIL-FILE is carried by any man. It is far better to go to the hospital for a few weeks than prison for years.

The question is never, "Is this a weapon?", but "Could a Jew prosecutor make a jury THINK this is a weapon?".

I have even banned the use of wooden picket sticks. We use cardboard "cores" for rolls of oilcloths, etc. -- EVEN THOUGH WOODEN STICKS ARE LEGAL IN MOST JURISDICTIONS.

None of this is to say that we are cowards who fear to fight with guns. When the day comes to SHOOT, we are ready, --and EAGER! But we can not and must not START it, as long as we can win legally, and ARE winning legally, as we are.

In short, when contemplating ANY operation against the villains who have our Republic by the throat, those responsible for the safety of the brave men going out must see to it that, regardless of Jew frames, etc, our position is so strong that we can make FOOLS of would-be 'framers'.

The biggest danger fighting right-wingers face is not starvation or injury, --but PRISON, Almost every tough right-wing leader in the last quarter century went to PRISON on some rigged Jew "case". Only fools fail to learn from experience.

Let us learn from the vicious injustice and Jew railroad job being done on our racial comrades in New York. Let us help them all we can. But let's quit making the same mistakes they did, too.

BLACK NIGHTMARE CLOSER!

Several issues ago, we pointed out that more than 50 per cent of the applicants of the Armed Forces are now BLACK, and predicted that as the blacks moved in, the Whites would move out.

Now comes an article from the New York
Times by Hanson Baldwin showing that, as predicted, OFFICERS ARE RESIGNING ALREADY
FROM THE ARMED FORCES, -- and the figures are nothing less than terrifying!

In 1958, 59, 60, 61 and 62, resignations for all Armed Forces averaged less than 837 per year.

In 1962, the Armed Forces began an all-out push to MIX, cramming blacks in as never before.

Baldwin's figures in the New York Times now show that the resignation rate went up ONE HUN-DRED PERCENT! In the Air Force, alone, 750 Officers resigned in 1963, almost as many as in all the services together any previous year. Total officer resignations were almost TWO THOUS-AND!

As anybody who has ever seen a White Neighborhood turn black knows, there is no 'balance-point' in the process. It goes ALL the way until the neighborhood is ALL black.

The graph of the growing blackness in our Armed Forces indicates that they will be ALL black, based on "take-overs" in other fields, in less than TEN YEARS!

They need to get only about 60 per cent black before the Whites flee in horror and disgust, and they are already getting more than 50 per cent black recruits NOW!

The "Kosher Conservatives" who pretend there is no race problem have less than five years left for this suicidal game. By that time, "Federal Occupation", as practiced at Little Rock and Mississippi will mean NIGGER occupation, by a NIGGER Army, with NIGGER OFFICERS! And they will not be Congo-type cannibals armed with spears, but millions of highly trained blacks armed with the most terrible and deadly weapons in human history!!

WHATS BEHIND "YOCKEYISM"?

There is rising all over the world, among hard core National Socialists, a new cult of what I will call "Yockeyism".

I found much of interest in Yockey's book, "Imperium", and actually helped promote it. But the cult founded on this man is dangerous and, I believe, in some ways downright EVIL.

In a pamphlet called "World in Flames,"
Yockey wrote that Western Civilization could not
be saved UNTIL AMERICA IS BEATEN IN A
WAR BY THE SOVIET UNION!

That particular pamphlet was promoted and pushed by two very odd animals, Keith Thompson and Fredrick Charles Weiss. Thompson is an extremely clever operator who became a "member" of both the ANP and the NSRP as "George Copeland" in Seattle, only to publish all our letters in a big expose in a JEWISH paper published by the Jew, Lysle Stuart. Weiss, perhaps the most dangerous man in America to rightists, is the TOP ADL agent, and we have affidavits and proof to back that statement up. Weiss, for instance, approached my old friend, West Hooker, in New York, and wanted him to set up as a Nazi FAVORING VIOLENT OVERTHROW OF THE GOVERNMENT AND DICTATORSHIP, in which case the ADL would back him. Hooker, of course, threw this rat out, and the Jews pulled their "dirty" on poor Jim Madole of the National Renaissance Party. Weiss' job is to pose as the biggest "Nazi" in America, and suck unsuspecting idealists right into the hands of the vicious Jews at the ADL.

Thompson circulates in a ring of homosexuals, and is extremely friendly with a gang of "Nazi" pansies, an impossibility like dry water or sunny darkness.

When Yockey was captured by the FBI for having several passports, he was captured in the home of a RABBI!

What horrifies me about all this is that I have found an unnerving connection between the ring of disgusting queers who pretend they are the "real" National Socialists, and this Yockey cult!

There seems to be no explanation possible for some of the associations and actions of some of the people mixed up in this thing, --except that they are a gang of pansies trying to be "Nazis".

Hitler had trouble with the same kind of filth, and had to shoot Roehm, the leader of the gang.

When it can be done legally, I will not hesitate to do the same thing.

Nazism is, above anything else, an almost religious drive toward WHOLESOMENESS in civilization, --naturalness and health. And the MOST unhealthy, most un-wholesome cancer in any civilization is homosexualism. Whenever it appears and gets the upper hand, as it did in Greece and Rome, civilization ROTS and DIES.

I am not ashamed to say that, through the powerful regenerative doctrines of National Socialism, I have been able to rescue several young men who were sucked into the nightmare life of "queers" in the rotten atmosphere of our colleges, and turn them into fighters for wholesomeness the same way an ex-alcoholic can be the best fighter for sobriety. But a queer who is PROUD of it, and downs Nature and wholesomeness, is the foulest creature on the face of the earth as far as I am concerned. Too many of the "Yockeyists" have turned out to be these slimy creatures, and I believe we will one day discover the connection.

SIT-INS INTHE LADIES ROOMS!?

After all the heavy drama and danger of the past months, maybe we would benefit by a bit of fun.

In that spirit, I suggest that we might organize a new kind of "March on Washington".

With all the hell-raising going on about segregation and discrimination, people have forgotten one of the RANKEST forms of segregation which is still going on, and which need to be rectified in the name of justice and human dignity.

"Separate but equal" has been ruled NOT equal by the Supreme Court, and those who are thus divided have the right to MIX.

Well all over this Nation MEN are being discriminated against by this doctrine of "separate but equal".

We are cruelly barred from ladies'rooms.

As a man, I have often been psychologically damaged and warped by signs "for WOMEN" on doors. I have been told that any effort to stage a sit-in in these segregated places would bring out brutal policemen who would drag me out and beat me. Those who have tried to exert their natural human right to mix in this fashion assure me that there is the utmost police brutality when these reactionary bullies catch a man in the Womens' Rest Rooms.

What kind of human dignity can we have when we are thus shunted aside to "separate but equal" facilities just because of a slight difference in our physical make-ups which is no fault of our? WE did not have anything to do with this accident of Nature, and we are all God's children.

And yet, I have been forced all my life to go into these rigidly divided facilities because of this accident of nature which I can't help.

Most Men's rooms have nasty poems and dirty pictures on the walls. I am told these shocking things are not so common in ladies' rooms. Is it not clear that to subject me to these warping influences and bad environment is very likely to turn me into a vicious criminal, maybe a rapist, a stick-up artist, a mugger or killer? How can I HELP myself if I am forced to use Men's Rooms where these degrading influences can work their will on my innocent and helpless soul? It is society's fault if I knock people in the head, now, after all these years of being cruelly forced to use sexually segregated rest-rooms. I am permanently and psychologically damaged! Those naughty poems and pictures have made it impossible for me to obey the law!

What is needed is a revolution to mix the Nations bathrooms!

No wonder men commit most of the crime!

They are SEGREGATED!

We must MARCH! Tens of thousands of us must pour into Washington for a gigantic rally at the new Roosevelt Memorial, which we understand will look like giant, monumental men's urinals with FDR's immortal phrases of treason scrawled thereon. We will come by the hundreds of thousands, strew our trash and salami wrappers all over the Park's, we will sing our brotherhood and sisterhood hymn, "Nature is calling us Together, hand in hand we GO!"

Then we will all adjourn to the White House where we will have a brother and sister-hood

ceremony in the President's bathroom, with good old Mixing Jack officiating at the formal proceedings.

I have a dream! I have a dream! I see the little black and white and yellow and green kiddles holding hands in the utmost love as they skip to the mixed bathrooms!

I have a dream! I see America HAPPY! I see men and women going TOGETHER, side by side, in mutual respect and human dignity!

We will be FREE! Free at LAST! Thank God ALMIGHTY, FREE AT LAST!

I will admit right off the bat that I have no real hopes that our side will have enough imagination and determination to DO IT, but I cannot help muse on SOME of the ways we could tear the guts out of the Civil Rights Act, --and have a ball doing it. I have already taken the first steps myself.

As soon as the Bill passed, I got off a registered letter to the President of the B' nai B' rith.

Under provisions of the Act, I demanded my right to join the Hebes.

I then gathered together about twenty-five of my meanest and nastiest young Nazis, and we headed for the local "Tel Aviv" area, Silver Spring, Maryland.

After carefully informing the Police that we wanted only to look into the possibility of "em-racing Judaism" and dressing in our best Sunday go-to-meeting clothes, we marched up to the doors of the biggest Synagogue in Silver Springs at precisely time for the Jew service to begin.

Needless to say, the consternation of the Kikes was delicious to behold. They want to mix everybody else, but when you try to mix with THEM, it's something else.

Next step is to file a suit in Court and then go to Bobby and demand that HE help get us into the Jew Synagogue with Federal Marshalls, under the provisions of the Civil Rights Law. Ought to be fun.

An even more interesting test of Civil Rights is something we are considering. The law, reaching undreamed-of heights of insanity, bans all discrimination based on race, color, creed, National Origin, --- and SEX.

According to that, it is a violation of Federal Law to excluse a male from the Ladies' Room. That "Separate but Equal" stuff has been ruled unconstitutional, and these separate facilities, therefore, are an AWFUL violation of the new law. If I didn't think it would be too undignified, we would test this separate but equal ladies and mens room business in the Federal Courts!

In fact, I have printed herein a little piece inspired by this thought, plus a vivid memory of Martin Luther Coon's speech last August at the Washiington march.

More seriously, there is something dignified and concrete the South COULD do in the face of the damnable provocations of the Jews and niggers who are invading Mississippi, trying to get it to rise up so they can occupy it with Federal Troops.

Damned few coons in Mississppi have ever seen a hundred dollars in their whole lives.
