## RACE AND NATION

WHAT IS NATIONAL SOCIALISM?

This special edition of ACTION is an effort to explain to the good thinking, right wing people of America the theory of National Socialism. (Nazism)

I have been a member of the right wing movement since I was 18 and have had a chance to study National Socialism on a world wide basis. In my contact with the good, well meaning people of the right I find a friendliness towards the ACTIONS of National Socialists, but a lack of understanding as to just what National Socialism is.

On the American scene, there have been a voluminous amount of books, magazines 'and leaflets, both pro and con (mostly con), written about the Nazi movement, however none of them have managed to give the people a true understanding of that movement. This lack of information has led to a lot of speculation and empty headed talk among some of the acknowledged leaders of the right wing who, because of their lack of knowledge and intense study of National Socialism, do NOT really understand it. Many people know that the National Socialist is for the White race and against the jewish domination of Western Civilization. What they do not know, however, is that National Socialism is a complete racial and cultural philosophy within itself. A philosophy built upon the race feeling, history and honest outlook on life initiated in ancient India and Persia and practiced by our White Aryan ancestors. Since no functioning National Socialist government exists today, we must obtain our information on National Socialism from the writings of the leaders of the European NS governments which existed between 1933 and 1945. Their political philosophy can be compiled from their writings, laws, and actual programs put into action. Much information concerning National Socialism and it's history has been compiled by the East Indian Mrs. Savitri Devi and by the National Socialists in present day England. These latter, in fact, namely Colin Jordan, John Tyndall, Ken Foster and John Bean, may for all intent be considered the National Socialist prophets of today. They understand and express the overall philosophy of National Socialism apart from it's racial viewpoint. However, the greatest exponent of National Socialism, and it's relation to race in the modern world, was our late leader Commander George Lincoln Rockwell.

## THE FUNDAMENTALS OF RACE The Myth of Equality by John Bean

DUE TO THE PRODIGIOUS OUTPUT of war-time anti-racialist propaganda it is only within the last six or seven years that the people of the Western Democracies have dared to give thought to, let alone discuss, the racial differences that so obviously exist in mankind. This resurgence of racial consciousness has been brought about by three factors. In the world at large people have become aware of the inescapable fact that the great changes that have occurred in Africa and Asia are manifestations of African and Asian racialism. In the United States, the White people of the Northern and Western States are becoming as equally race conscious as their brothers in the South due to the suicidal policies of the Eisenhower/Kennedy regime in forcing through integration with the American Negro. In Britain, and to a lesser degree in France and Holland, the flood-tide of coloured immigration has brought race and its problems into the lives of every city and town dweller.

In the story of the racial re-awakening, the African Negro-or his descendant-plays an important role: more so than the Aryan Indian or the seminegroid and inferior Dravidian Indian. It is because the great differences, mental and physical, between the Negro in our midst and the Nordic Whiteman are so apparent, that people have in consequence also become aware of the differences between other, more kindred racial groups. A scientific study of the physical and mental differences between the Negro and the White man, based on proven fact and not conjecture, will show why it is suicide for our race and its civilisation for integration of the two to continue.

tive to jaundice, pneumónia and tuberculosis. Notwithstanding all this, hospitals still mix European and Negro blood, and refuse to even test Negro blood for contamination. In genetic effects, the genes (that part of the reproductive cells that determine the physical and mental traits of any offspring) of the Negro are more dominant than the European races, and particularly the Nordic. The Negro gene is dominant over the European gene at a 4 to 1 ratio. In other words, if a Negro marries a European and they have four children, three of them will in all probability be predominantly black and one child would be mostly white. This proves that we cannot assimilate the Negro and part Negro immigrants in our midst. The Negro gene would devour our entire race and the vast majority of the offspring would be black.

building of cultures and civilisations, but environment (training, education and cultural surroundings) can only act within the limits of the race. That the environment of the Whiteman's civilisation can indeed be harmful to the Negro race is indicated by the following.

In the July 1, 1954 edition of Jet, a magazine published by and for American Negroes says this, on page 57: "A study of mental disease among negroes in New York state, conducted by Dr. Benjamin Malzberg of the state's department of hygiene, showed that proportionately, negro insane outnumbered whites 2 to 1 and their insanity rate is rapidly increasing. It has been estimated that one out of every 200 negroes has been in an asylum, and one out of 10 now walking the streets is sufficiently neurotic to require medical care."

#### Below Whites in Intelligence

In regard to basic intelligence between

#### **NEGRO PHYSICAL TRAITS**

A few of the principal physical differences betwen the Negro and the Nordic Whiteman are as follows:—

The Negro's head shows the archaic form. The front of the Negro's skull is much smaller than the whiteman's, thus giving the Negro less room for the higher faculties, such as affection, self control, will power, reason, judgment, apperception, orientation and a feeling for the relationship of personality to environment.

Formation determines the amount of intelligence that will be reflected just as the size and shape of a glass pitcher determines the size and shape of the water in it. If this were not so there would be no law governing intelligence and one organism would reflect as much mind as another regardless of its construction. The Negro's whole skull capacity is much undersize, so that his brain weighs 35 ounces as against 45 ounces for the Caucasian brain. In the Negro the cranial bones are very thick and the cranial sutures unite early in life. This checks the development of the brain and explains the sudden stunting of the Negro intellect shortly before puberty. The Negro's hair is flat and without a centre core or duct. It is not a true human hair but resembles the wool of the lower animals and it can be felted. The Negro's eyeball is tinged with yellow as is the ape's. The jaw protrudes so that the facial angle of the Negro is 60 degrees compared with the ape's 50. The white man's facial angle is 70.

#### Negro Blood Disease

One of the so-called arguments of the advocates of mongrelisation is that Negro blood is red, as is the Whiteman's, therefore we must be equal. Ignoring the fact that the blood of a dog or a rat is also red—as it has to perform the same basic function as that of a human being—we would stress that it is cell structure that makes the difference. A fact which has been known (though suppressed) since 1910 is that a substantial percentage of Negroes (8 per cent. in the U.S.A.) are affected with the so-called "sickle cell trait," a genetic or hereditary blood characteristic peculiar to the Negro race. When two Negroes with this trait have offspring, they are sickly and sometimes die. Whites do not inherit the sickle cell malady, but when sickle cell contaminated blood is given to ailing white patients, severe damage can result. the Negro and the European, it is worth noting some comments by a Miss A. M. Shuey on Negro intelligence in the U.S. Armed Forces in the last war that appear in her book "The Testing of Negro Intelligence" (1958). She states:

"Negroes appear to be farther below whites on the Army General Classification Test in World War II than they were on the combined Alpha and Beta scale in World War I. In a long variety of tests from Strong in 1913 to Hess in 1955 in which negro and white intelligence was compared, the coloured averaged consistently below the whites."

The author goes on to make a final conclusion from these findings that they, "all point to the presence of some native differences between negroes and whites as determined by intelligence tests."

The Negro's nose is concave at the bridge as is the ape's. The nostrils turn up and show the red inner lining. The lips are everted and show the red mucous membrane.

In the whiteman the alvoelar arch and palatine area of the mouth became shortened and widened and the tongue became shortened and more horizontally flattened which allows for greater refinement in pronunciation, while the Negro palate and tongue remained ape-like (macrodont) and he is unable to pronounce sibilant sounds. Sibilant sounds are unknown in Negro dialect.

## MENTAL INFERIORITY OF THE NEGRO

WE DO NOT DENY that within the ranks of the Left-Wing inter-

nationalists there are — amongst many fools — men and women of intelligence, but one could be forgiven for thinking otherwise when one hears parrotted out to the point of boredom that the only difference between the European and the Negro is the colour of the skin. In the last part of this article it was shown how inconsequential is the difference of colour compared with the numerous other physical difference : facts that cannot be disputed on biological grounds but are ignored, or glossed over, in order to perpetuate the myth of racial equality. Differences between these two extreme racial groupings do not, of course, stop at the physical, but as shown by a few examples in the previous part of this article make themselves very apparent in the mental behaviour of the two racial groupings.

#### Negro's Failure to Create

In spite of self-deceptive propaganda of the internationalists it is apparent to any observant person that there is a profound disparity between the performance of the European and Negro races which is grounded upon certain inherent racial characteristics which makes it impossible for the Negro race to think creatively with the vision and sustaining power that is required to develop and perpetuate a civilisation. We are, of course, told by "emminent authorities" that the reason for this apparent backwardness of the Negro is due to his environment — his different surroundings to that of the European. That this is not basically so and that environment can only mould what is already there to start with is borne out by many varied intelligence tests carried out on Whites and Negroes in the United States over a considerable period of time. the White on standard intelligence tests." He states further that : "These results are sufficiently numerous and consistent to point to a racial difference in intelligence."

S. D. Porteous and M. E. Babcock, in their more recent study "Temperament and Race" evaluated many comparisons of Negro intelligence with other races concluding that:

"These studies show that the Negro actually belongs, as far. as all-round ability goes, to an inferior race."

S. M. Derrick in "A Comparative Study of Intelligence" of seventy-five White and fifty-five Negro college students by the Stanford Revision of the Binet-Simon Scale, found Negro intelligence compared with that of Whites as follows:

"The Negro college students are older than the White; and according to chronological age he is more retarded. The White college students have a higher average I.Q. than that of the Negroes, their average being nine points higher."

#### North v. South Europeans

#### Negro's Small Brain

The frontal lobes in the brain of White people are developed to a greater extent than in negroes (the contrast is even greater between Nordic and Negro). As the front part of the brain is the seat of consciousness, where intellect, memory, judgment and conscience are located—hence we have the term "highbrow" to describe an intellectual person—and as the foreskull of a Negro is round and often low and receding, it would again be logical to assume that the size and shape of his brain affects his mentality and make it interior to that of the White.

Let the final word on brain differences go to Prof. Huxley—hardly a "racialist right-winger," who stated in "Man's Place in Nature": "The difference in weight of brain between the highest and Thomas Dixon, the well-known novelist and student of races, expressed this failure of the Negro to create or progress in the following vivid language :

"The Negro has held the continent of Africa since the dawn of his history, crunching diamonds beneath his feet. Yet he never picked one up from the dust until a white man showed him its light. His land swarmed with powerful and docile animals, yet he never built a harness, cart or sled. In a land of stone and timber, he never carved a block, sawed a foot of lumber or built a house save of broken sticks and mud, and for four thousand years he gazed upon the sea, yet never dreamed of a sail."

#### U.S. Intelligence Tests

In a work entitled "Applied Eugenics" written by Popenou and Johnson and published in 1918, we find reference made to a study by G. O. Ferguson of a test given to 486 White and 421 Negro students with the following results:

Full-blooded Negroes scored 69.2% as high as Whites. Three-quarter Negroes scored 73% as high as Whites. Onehalf Negroes scored 81.2% and onequarter Negroes scored 91.8% as high as Whites.

In his study "Intelligence Testing," by Rudolph Pintner, published in 1931, he concludes in his summarisation of many tests made upon Whites and Negroes by himself and others that : "All results show the Negro decidedly inferior to An interesting point is made on the effect of slight Negro traits by Kimball Young in "Mental Differences in Certain Immigration Groups." He found that the European peoples though probably all of near kind showed a marked mental superiority in the North European nationalities as against those from South Europe. He says in explanation of this, on page 98:

"The South Europeans have considerable negroid strains in the masses of the people and this fact may, in part, account for the divergence from the intelligence of the North European descendants."

In 1930 we had 210 cases of drug smuggling in which 42 Jews were involved or 24%. In 1931 the percentage of Jews was 9, in 1932 it was 12, in 1933 and 1934 increases to 14 and 17% respectively. When one bears in mind that the proportion of Jews to Germans in Germany according to the latest official tsatistics is 0.76%,—one realizes that the above figures show an alarming state of affairs. The number of Jewish doctors in Germany involved in this traffic is also worth mentioning. In 1931 their percentage was 16,—in 1932 there were 27%, this dropped to 14% in 1933. In 1934 there were 17%, which increased to 29% for the first half of 1935. These figures, therefore, support the measures which Germany has been compelled to take against the Jews. They represent a concrete form of self defence. When one sees how Jewish doctors enrich themselves through this illicit drug traffic at the expense of national health, no further proof for the counter measures which Germany has taken should be necessary. ### The Swastika

In Europe, as in Asia, the swastika has always been considered a magic sign. It has been taken as a symbol of the sun, source of life and fecundity, of the thunder, a manifestation of divine wrath which has to be appeased. In contrast to the cross, the triangle, the circle or the crescent, the swa--stika is not a primitive sign which could have been invented and re-invented at any time in history of humanity or at any place on the globe, with a differnt symbolic meaning every time. It is in fact the first sign traced with a definite intention. The study of migrations raises the problem of the common origins from the earliest times of the various religions and of the prehistoric relations between Europe, Asia, and America. The earliest known specimen of the swastika is supposed to have been found in Transylvania, dating from the end of the polished Stone Age. It is found on hundreds of spindles as far back as 1400 B. C. and in the remains of Troy. It appears in India in the fourth Century B. C., and in China in the fifth century A.D. A century later it is found in Japan at the time of the introduction of Buddhism which adopted it as an emblem. Of capital importance is the fact that is it entirely unknown, or only occurs accidentally, in all Sem-

-the type that preys upon the industrial life of the country. I refer to that type of swindling blackguard who in innumerable instances takes advantage of a trust placed in him by the small man in order to subsequently embezzle his entire savings of a life time. I am also reminded of the unclean methods adopted by the same type in commercial

#### spheres

whereby thousands are ruined simultaneously. The law is such that a blackguard of this description can unfortunately still escape through one of its loopholes. Under this heading we can include

unclean dealings in stocks and shares, loan negotiations, insurance frauds, etc.

In spite of it having been possible to reduce the number of swindles in Berlin during 1934 from 31,000 to 18,000-nevertheless the total amount of damage done in this city still stands at 112.5 million Reichsmarks.

### **On National** Socialism

Nationalism, which is opposed to everything international in nature and form, must with all vehemence reject interference in national affairs by an alien layer people who are international and the originators of all international dogmas.

The fundamentals of a nation are BLOOD and SOIL. Nationism means not only attachment to the land upon which we are oorn and upon which we live, but pride in being a member by BLOOD of the people who comprise the population of a land. Nationalism means further the conscious upholding and protecting of the best elements within a people for the advancement of the nation. Those elements who today comprise the ruling power of America do not by blood belong to the American people; they are therefore attached neither to the people nor to the soil of the nation. They are not interested in the national welfare of the American people, but in furthering their own international program of world enslavement of those people who are not of their race.

the people constitute the only government truly representative of a people, because it positively and without compromise excludes internationalism.

This means that the NA-TURE of a people must be reflected in its government. A truly national government therefore can be had only if it

In this connection, we were able to definitely establish

that the majority of these fraud cases were perpetrated by Jews.

Gut of 22 fraudulent cases which came before the Berlin Prefecture it was proved beyond all doubt that no less than 20 Jows we mnected therewith. In Cologi the Police were successful in 4 cases in smashing up a gang of insurance swindlers of whom all were Jews. Investigation showed that the

one gang was entirely a family concern with 70 members composed of sons, daughters, sons-in-law, cousins, etc. This particular gang had its headquarters in Aix la Chapelle, a German border town, and worked in conjunction with a Jew in Brussels. As soon as a "case" was reported as settled, the Brussels Jew appeared on the scene, collected the insurance money and disappeared over the border. In several instances, these Eastern Jews were successful in obtaining as much as 10,000 Reichsmarks from each of the various insurance companies concerned, by false declarations and affidavits, forged signatures and the like. The more one concerns oneself with the subject of the professional swindler, the more one realizes that Jews are predominantly active under this heading. The Jew prefers that class of swindle and fraud that will enable him to keep well in the background, without much risk to himself, and yet assured of his profits. The Jews principal activity lies in the illicit drug traffic, and here I am able to support this with a few figures taken from statistics issued by the Central Board under the control of the League of Nations. It has been ascertained that out of 272 drug dealers throughout the world in 1931, 69 thereof or 25% were Jews.

Jews,

The intense campaign waged by the National Socialist Government against these dens has resulted in a diminished percentage of convictions but nevertheless, their danger is still in evidence. In 1934 the percentage of Jews concerned was 42.6% and this has increased to 59% in 1935.

The figures relative to pickpocketing

are still more suggestive. Prior to National Socialism coming intol power, this class of theft was overwhelmingly carried out by Jews. In 1932, out of a total of 411 arrests, 193, or 47% proved to be Jews. These figures do not give the true results, as at that time the authorities were deliberately lenient towards Jews in response to official instructions. Subsequently, these figures diminished somewhat, although up to 1st July, 1935, 24 Jews were still concerned in 67 pickpocketing cases, a percentage of 36%.

Another remarkable feature is the number of Jews that is connected with gangs of international thieves. One can state definitely that here the Jews hold sway. In 1932, 163 cases of international thievery were closely watched, and in no less than 134 instances, that is 82% were Jews involved. The figures for 1933 and 1934 were 65 and 42% respectively. Up till July 1935 as much as 65% had already been registered. The coming of National Socialism to Germany made the ground too hot for these international thieves, and according to Police statistics, the greater part have migrated to neighboring countries, such as Poland, Czecho - Slovakia, France, Belgium and Holland, which countries are now pestered with these crooks.

country can be concerned about the welfare of the NATION. Love where it concerns a nation and people is but another word for Nationalism; welfare but another term for Socialism.

National Socialism is not new. It is the political term applied to the age-old laws of nature that determine the line of the individual in relationsnip not to the universal, but to his people as part of them. National Socialism is re-awakened race-consciousness asserting itself in opposition to international dogmas that seek the destruction of all naturally developed and organically grown human ties and relationships.

The international social Democracy of Marx, while asserting the equality of the White, Mongol, Negro and Jew, promotes bitter enmity among people who are united by ties

itic regions such as Egypt, Chaldea, Assyria and Phoenicia. It is an exclusively Aryan symbol.

In 1911, Ernest Krauss drew the attention of the Germanic public to this fact: Guido List, in 1908, described the swastika in his popular science books as a symbol of racial purity, and at the same time, a sign of esoteric knowledge revealed by the deciphering of the Icelandic epic poem known as the Eddo. At the Russian Court the swastika was introduced by the Empress Alexandra Feodorovna. Now, Thibet is one of the countries in the world where the swastika, turned either to the right or the left, is most commonly met with.

The 1992 proportion was 294 73 or 25%. In 1933 the number of Jews involved increased to 30%. In Germany, the proportion of Jews involved in this traffic is

Going to the anti-jewish meetings of the right, I have found there to be many good, well meaning people attending and getting rid of their frustrations listening to speeches which confirm what they have already known for thirty years and listening to leaders who have done little more than talk for thirty years. 

Q: Does National Socialism believe in Free Enterprise?

Q: What was the aim of National Socialist Economic Policy?

A: To protect the little man from unfair competition. The critics of National Socialism bitterly complain about the Free Enterprise system that existed in Nazi Germany. The left wing book "The Spirit and Structure of German Fascism", while criticising National Socialism, gives us an insight into the relationship between business and National Socialism: "In the first place, the sanctions on which capitalistic business enterprise rests have not been disturbed in any significant sense. As has been The official literature, in fact, approves of these elemental rights as the foundation stones for the new economic system of the Third Reich. IN MY ARTICLE, "Private Enterprise In The Nationalist State", emphasis was placed on the ignorance of many consumers regarding the value of property they purchase and how many property owners, Asiatics and Africans in particular, lacked the knowledge to preserve what their European predecessors created. Such predecessors being capable of understanding the requirements of property preservation, advancing as they did on a different path but at an equal pace with their history of property development and design.

As the quality of a craftsman's product is dependant on his qualities as a craftsman, so will the care and usage of his tools be dependant on his knowledge and understanding he has acquired through self experience, or instruction from others of his craft. 
#### Race and the 'Underprivileged'



## THE FUNDAMENTALS OF RACE by John Bean The Five Races of Europe

UNLESS THE READER is one of those few who buy this paper out of morbid fascination, the majority of readers can plainly see that apart from his colour the African Negro is totally alien to the racial stock of Europe, both in physical appearance and mental behaviour—this was dealt with at length in our last two issues. However, although there is a considerable kinship between all the European peoples, few realise that there are also considerable differences and that the indigenous European stock is in fact composed of five different races.

The true Mediterranean race then, which is found in Britain in its purest form in Cornwall, Devon, Wales and parts of Eire, is painted by all observers as passionate and excitable. It loves strong, vivid colours and vivid impressions of all kinds, and has probably greater appreciation of artistic values. than the Nordic, although in other ways has less depth of mind. The Mediterranean tends to take a deep interest in its fellow-men and finds great joy in the spoken word and in pleasing and lively movements. With all these qualities the Mediterranean man looks on life with merry eyes more as a play, whereas the Nordic live it more as a set task. The Mediterranean is eloquent and often a skilled orator (Mussolini?). His spirits are quick to rise and quick to sink and he is very ready too to fall into hot strife. But with all this his lively sense of honour does not forsake him. The Mediterranean man is not particularly hard-working, and sometimes he can be lazy: he likes to enjoy life the more. He is not very drawn to money-making. The faith of the Mediterranean man is not so deeply rooted in conscience as with the Nordic; it belongs rather to the senses, is an expression of the joy of living and of the goodness of heart so often characterising him. This goodness of heart shows itself first and foremost in the Mediterranean man in his love (which to the Nordic often seems exaggerated) for his children, and in general in the deep affection of the family life.

In any nation, the Alpine section, which is not that of the leaders, but of the led, will by its plodding industry, temperance and thrift and by a certain sober, sound common-sense, most likely make up a peaceful bourgeois element, appearing in every calling and class.

#### The Dinaric Race

Dinaric traits are comparatively rare in Britain, although they can be found amongst people in certain parts of the East Coast. It is said that Dinaric blood makes the difference between the nature of the Bavarian and the North German.

The Dinarics are characterised by a rough strength and downrightness, trustworthiness and a feeling for honour and love of the home. He also has a warm feeling for nature. Characteristic of the Dinaric is an inclination to sudden outburts, to quick anger, and to combativeness, characteristics, however, which but stand out from the general level of a disposition that is on the whole goodtempered, cheerful and friendly. The Dinaric mentality has a range of development decidedly narrower in every direction than the Nordic, though the will is as strong. He is often somewhat uncouth with a rough cheerfulness and wit and has a gift for coarse repartee and vivid description, showing a decided knowledge of mankind. The gift for music, above all for song, is particularly pronounced. The predominantly Dinaric Alpine district is where German folksongs most flourish.

This lack of knowledge of the very biological origins of our people is, of course, primarily due to the "iron curtain" that has been dropped on racial studies during the past twenty years, and even the very denial of racial differences by Communist and Liberal Democrats, often through the media of United Nations Organisations. This in turn has led to the muddled thinking of referring to the "British" race, or the "German" race, etc., which as shown in the first two articles in this series do not in fact exist.

#### **Common Interest of All European Races**

In those first two articles the main physical characteristics of the five European races were given, these races being the Nordic-of which Britain still has a 60% strain, the Mediterranean-30% in Britain, Alpine, Dinaric and East Baltic. In this article we shall define the main mental differences in these races -far more important than the physical. Our reason for doing so is not to prove any particular superiority of one European race over another, which is rather splitting hairs at a time when the White man as a whole is confronted by common enemies and is commonly threatened with racial extermination by the influx of completely divergent racial types from Africa and Asia. Rather is it to show why the European nations, composed of varying proportions of these races, have developed their own national tracter, why this character changes with drastic racial upheavals—such as Ancient Greece, Rome and modern-day France—and why in consequence some countries have more in common than others; the Northern Europeans being a typical case in point.

ness are peculiarly Nordic virtues, and his word once given after reflection is his bond (hence the old proverb that "An Englishman's word is his bond"). His imaginative powers are not easily roused, but rather shows a calm evenness, although not lacking in boldness. The sense for reality, the sustained energy, self-reliance and boldness of the Nordic race are one reason why all the more important statesmen in European history would seem, judging from their portraits, to be predominantly Nordic.

However, Nordic boldness can easily rise in some Nordic men to such heights that they incline to foolhardiness and become careless of their own good. The Nordic inclination towards a care-free life is also to be seen in the fact that the Nordic man seems to find it absolutely necessary to have times of joyous laziness or untroubled devotion to bodily exercise, wandering or travelling. These points were particularly marked in the Vikings. Town life, as such, seems to weigh on him far sooner that it does other races except perhaps the Dinaric.

In Nordic man there is often a peculiarly wide range of mental development, taking within its grasp broad fields of action and knowledge, and at the same time a complete range of emotional life, from kindliness to ruthlessness, and from "dreamy" to resolute. It is not surprising that energetic members of the race rise into the leading professions; but this move into the upper section of society often brings a lowered birthrate. Thus it is the very qualifications for leadership in the Nordic race that bring it down in the struggle for existence, for it is the birthrate, only that decides.

In public life the Mediterranean man shows a somewhat diminished sense of law and order, and a want of forethought. He is quickly roused to opposition, and is ever wishing for change. Thus there is sometimes a tendency to lawless conditions and to secret societies, such as the Mafia in Italy and Sinn Fein in Ireland.

#### **The East Baltic Race**

Again, there are few people of East Baltic Race in Britain. The term Slavic is a linguistic and cultural grouping and is often used to describe East Baltic people, who abound in Poland, European Russia and Eastern Germany. At first glance, the East Baltic seems reserved, moody, mistrustful and silent, content to live on little and ready to spend week after week in dull and dogged toil. However, when his tongue is loosened among intimates, or by alcohol, he can change from taciturnity to a lively flow of speech and wealth of words. He reveals imaginative powers breaking out in all directions, and ever at work on a welter of images. The conversation wanders off into vague, ever-changing plans for the future and the craziest of notions. This attitude of mind is reflected in many of the great Russian writers. He cannot decide for good or for evil and so often puts everything into "God's hands," with a gloomy belief in some destiny overhanging him. His disposition being such, he can bear suffering, privation and oppression from those in power (this explains the Russians' comparative lack of opposition to oppressive measures from both the Tsars and the Communist rulers throughout history). There is a lack of any real creative power and he is opposed to all individuality and always cultivating a dead level of thought for all. He has a particularly lively sense of patriotism, but needs to be led. Well treated, he is a faithful, often a meek subordinate. This again shows why the Russian people so readily accept Communism. To his neighbours he is usually helpful, and hospitable; to his kinsfolk he is kind, not so much in word, as in deed. From this brief outline of the characteristics of the European races, it can be seen that whilst there are many similarities there are also many differences. which have gone to make up our national character. A little foresight will show that indiscriminate mixings can only work to Britain's and Europe's disadvantage.

#### The Nordic Race

According to Dr. Hans Gunther, Grant, Keith and others it appears to be generally recognised that the Nordic invariably attains the mastership of his own nature which makes him an individualist more able to withstand the influence of others. He shows a strong urge towards truth and justice, which in modern times can often lead to an urge for championing of the "underdog"frequently to his undoing. Together with this he has a decided sense for competitive achievement. His inclinations are always towards prudence, reserve, steadfastness, and calm judgement. Just as he himself quickly grasps the idea of duty, so he is inclined to demand the fulfilment of duty from those around him, as he does from himself; and in this he easily becomes hard and even ruthless. In his intercourse with his fellows he is reserved and shows little insight into the nature of others, and in fact a certain lack of knowledge of mankind. The gift of narrative, with a sense for describing events and landscape and a tendency to roguish humour, is common in the Nordic race. Fairness and trustworthi-

In science the Nordic seems to incline rather to the natural-sciences than to the cultural; in the arts he inclines particularly to poetry (the Viking Sagas, Shakespeare, Goethe), music and to a slightly lesser extent painting and drawing.

It is not surprising, therefore, that it is this Nordic race that has produced so many creative men and that a predominant proportion of the distinguished men in European and North American history show mainly Nordic features.

For example, the most Nordic part of the British Isles is Scotland, and the Scots yield a particularly large number of the leading and pioneer men in Britain and the White Dominions.

#### The Mediterranean


In talking of the Mediterranean race let it first be remembered that Sicilians, Cypriots and Maltese, although today frequently referred to as "Mediterraneans," are very far removed from the true Mediterranean race: rather are they a mixture of original Mediterranean stock; plus Hither Asiatic and Negroid strains. Such racially mixed types abound in Southern Italy as well as Sicily and it is they who would flock to Britain and other Northern European lands under the Common Market's free movement of labour rather than the energetic, cultur. ally elite of Northern Italy, who are of true Mediterranean, Nordic and Alpine blends.

#### The Alpine Race

The Alpine race, although constituting less than 10% of the British people, is quite dominant in central and southern France, the southern half of Germany and in Austria. The Alpine man is sober, practical, a hard-working small business man, who patiently makes his way by dint of economy, and sometimes shows considerable skill in acquiring culture' and social importance. He shows reserve, sullenness, mistrust, slowness and patience when he is dealing with strangers. Since his aims are narrower and he lacks any real boldness in thought or deed, he often gets on better than the more careless, daring and often unselfish Nordic and Dinaric man.

The Alpine man tends o worship uniformity, and to him class distinctions have little importance. He is consequently a great believer in "all are equal," and has a liking for the mediocre and the ordinary, and discourages competition. Sometimes this leads to a positive hatred of greatness which they cannot grasp.

In his religious life he shows himself to have warmer, if not deeper feelings than the men of the other European races. He inclines to a calm piety cultivated in carefully hedged-in groups, but which can readily take on a dull, narrowminded touch.







## GREATEST MATERIAL ASSET

WE RACIAL NATIONALISTS do not look upon the soil as simply a source of immediate financial profit, as does the Capitalist. We recognise it as the treasure-house for the physical subsistence of our race and nation, a heritage of our folk; and farming, with its intimate participation in the healthy workings of Nature, as a vital influence for a natural healthy society. Thus a love for the soil, and an appreciation of the salutary bond of blood and soil, folk and land, characterises Racial Nationalism.

Man depends for his life and health on the few immeasurably precious inches of the earth's top soil, and the food this provides, including the food resulting from the animals fed from the earth's vegetation. The soil is therefore man's greatest material asset.

Man is bound to the soil to the extent that his body is principally the product of the fruits of the soil, and, with death, returns to the soil and re-enters its processes of decomposition and re-creation. This is the cycle of life.

We Racial Nationalists, appreciating this reality, believe in a harmony of man and nature. We recognise not only the paramount value of the soil for its food, but the social and spiritual importance of farming, close contact with the organic processes of Nature stimulating natural values such as those of good breeding, and encouraging a natural way of life and a natural order of human society, with politics viewed as the good husbandry of the state and race. Accordingly, our farming must be protected and encouraged as the backbone of the country's economy. The worker on the land must no longer be rated as inferior to the factory operative or office clerk. Smallholding, and thereby the recreation of the peasantry, must receive national promotion. Forestry must also be encouraged on a grand scale to restore timber supplies for the nation's needs, utilising land less suitable for other cultivation. Corporate village life must be ener-

getically rejuvenated to stop the drift to the towns.

We must produce not only more food but better food. The fertility of our native soil must be maintained and improved so that the food derived directly and indirectly from it will contain the maximum nourishment for our people. Today much of our soil is drugged and debilitated for the sake of quick profit, with a consequential decline in the quality of the food obtained from it, while even that food itself is often so processed that its nutriment is further diminished.

The British National Party thus stands for a thriving sufficient British farming which will ensure a healthy folk from healthy food from a healthy soil.

on the District of Columbia in 1957 clearly reveals the mental inferiority of the Negro students. It is significant from the many tests

It is significant from the many tests which were given that the Negro students scored below the White students not only on the overall ratings, but on each different test. These findings revealed the fact that integration has not raised the mental level of Negro pupils to that of Whites as Negro equalitarians claimed it would.

In an article in "The Mankind Quarterly," July-Sept. 1961, R. Travis Osborne, Professor of Psychology at the University of Georgia, concludes his findings on tests carried out on Negro and White pupils by stating: "After making necessary adjustments


"After making necessary adjustments for the mental ability and chronological age differentials, Negro pupils significantly under-achieve white boys and girls in the same school grade. This fact would seem to have considerable practical significance for communities forced to reorganise their educational systems to include racially balanced Having learnt their leason Irolli the First World War, in World War II the only place where the American Army used Negro troops in battle was when the 92nd division was exposed to German fire in Italy, with about the same result

as before. Total war dead of American Negroes was under 500, compared with 200,090 White troops who died in battle.

#### World Health Report

In case the reader should think all these authoritative reports are biased let us 'turn to a publication of the World Health Organisation (bardly racialist!) entitled "The African Mind In Health and Disease" by J. C. Carothers, 1953, Chapter 6, pp. 85-94. Here we find the following significant passage.

"With the Negro emotional, momentary and explosive thinking predominates . . . dependence on excitement, on external influences and stimuli, is a characteristic sign of primitive mentality. Primitive man's energy is unstable and spasmodic. , He is easily fired with enthusiasm for an undertaking and begins his work with great zest; but his interest dies down quickly and the work is abandoned . . . Where the stimulus of emotion is lacking the Negro shows little spontaneity and is passive. He waits for what is coming to him and evades what is inconvenient, or adapts himself to it, instead of bravely confronting the obstacles of life and mastering them . The Negro has but few gifts for work which aims for a distant goal and requires tenacity, independence, and foresight. The interest which the African takes in things is not an academic one. They concern him in so far as they are useful to him or can do him harm . . . observation is often superficial; conclusions have been drawn from it in a most uncritical way; and instead of further thought on the matter, word spinning has seemed sufficient . . . knowledge mixed with a child-like play of the imagination. "Within his own circle he is never in a position where he does not know how to behave or what to do . . . work is not specialized in the same way as with us and therefore the non-expert 'layman'... does not exist. The African is able to enlarge with ease on any subject."

#### The Negro In War

Having given a few examples of Negro intelligence tests and tests on the difference between White students and Negro students, what of the Negro's abilities as a soldier? This is particularly worth studying in view of the considerable propaganda to glorify the part played by the Coloured man in fighting for "our Democracy" in the last war.

Again reverting to American sources (of particular value as Negroes and Whites have been brought up in the same environment), American Army records show that Negroes constituted 8% of the armed forces in World War The number who died in action amounted to 900. In contrast, 50,510 White American troops died. Of their conduct in battle, Colonel Allen J. Greer, a White officer in charge of Negro troops of the 92nd division describes their actions during an attack at Argonne on September 26, 1918. "They failed there in all their missions, laid down and sne ked to the rear, until they were withdrawn. Thirty of the Negro officers of this regiment were reported for cowardice."

#### THE MAN EMERGES

A DOLF HITLER was born on April 20, 1889, at Braunau am Inn, Austria, just across the border from Germany. The child had the striking eyes of his mother. His origins were humble: his father was a minor customs official, his forefathers were peasants, and he started off at a village school. His father, a stern authoritative man, wanted him to become a civil servant, but the boy, early revealing an indomitable will, rebelled against this, wanting to become an artist.

His father died when the boy was 13, and his mother moved to Linz. On leaving school in 1905 at the age of 16, after a lung ailment, young Hitler enjoyed the next two or three years, enabled by the support of his family to spend his time as he wished, reading voraciously, pondering seriously, listening enraptured to performances of Wagner at the Linz opera house.

It was then that he became imbued with a sense of mission in life. Kubizek, his intimate friend at the time, has described a striking event of revelation. After attending the opera, Hitler, late one night, silently led him out of the city. "As if propelled by an invisible force, Adolf climbed to the top of the Freinberg. And only now did I realise that we were no longer in solitude and darkness, for the stars shone brilliantly above us.... Never before and never again have I heard Adolf Hitler speak as he did in that hour .... It was as if another being spoke out of his body, and moved him as much as it did me.... he was talking of a mandate which, one day, he would receive from the people, to lead them out of servitude to the heights of freedom." Years later Hitler declared: "In that hour it began."

After the death of his mother at the end of 1908, Hitler went to Vienna to seek a living, and the four years he stayed there was the period which caused him to become a socialist, in a racial and non-Marxist manner, on top of being a nationalist from his schooldays; and thus emerge as a National Socialist. He knew hunger and hardship as a casual unskilled labourer living in cheap lodgings before later he somewhat improved his lot by working independently as a small artist. He came to know the decadence and destitution of the great city; the feeble fraudulence of the democratic system; the Marxist manipulation of the workers; and the predatory nature and influence of the Jews. In 1913 he moved to Munich in Germany, and at the beginning of the first world war volunteered for a Bavarian regiment and was sent to the front, where he was twice wounded, awarded the Iron Cross for his bravery as a corporal, and, in the last month of the war, temporarily blinded by a British gas attack. In 1917 the Bolshevists had seized power in Russia. The next year their activities increased in Germany, taking advantage of the strains and sufferings of the war, and when, in November, 1918, Germany sued for peace and the Kaiser abdicated, local Bolshevist uprisings took place in various parts of Germany during the remainder of 1918 and during 1919. Hitler, appalled at the condition of his country and the plight of its people, determined to devote his life to their political betterment, and, in September 1919, at the age of 30, joined a tiny organisation in Munich which, a few months later, renamed itself the National Socialist German Workers' Party (NSDAP).

#### THE STRUGGLE FOR POWER

HITLER was enrolled as the seventh member of the party committee comprising all the members. They had no premises, no funds, and hardly any outside attendance at their meetings.

Hitler pressed for bigger and bigger meetings which attracted more and more people, rapidly developing his amazing power as a speaker. On February 24, 1920, he announced the 25 point programme of the party to an audience of 2,000 at the Hofbräuhaus in Munich. Hitler was given full control as Leader in 1921.

The original office was a room in a tavern, pictured above left. Some of the early members, the first faithful few, are pictured above right.

At the end of 1923, with the membership then about 55,000, the NSDAP suffered a severe setback. It tried unsuccessfully to seize power in Munich, and Hitler was sent to prison for six months.

#### THE JEWS

Contrary to a commonly held belief, the Jewish people are not Europeans. Neither are they a pure race, and to speak of a "Jewish Race" or a "Semitic Race" is incorrect. Houston Stewart Chamberlain shows in his Foundations of the Nineteenth Century that the Jewish people are really a nation-even though spread world-wide -composed of interbred elements of many different races, although based primarily on the Hither Asiatic and the Oriental. Due to the effects of Jewish religious and national teaching (the Jews can be said to be the first exponents of apartheid) this interbreeding has gone on for well over two thousand years. The result is that in the Jewish people as a whole there are always similar physical and psychological characteristics recurring that it is easy for the impression of a "Jewish Race" to be formed. Hans Gunther points out, in his Rassenkunde des deutschen Volkes, that through seclusion and inbreeding on a definite selective principle the Jews are however, on the way gradually to becoming a race in themselves.

Within the Jewish nation there are

Europe. At the same time, due to the strangeness of their inherited racial characteristics the Jews have never been really accepted by the European peoples, as historical events long before National Socialist Germany or the Russian pogroms verify. Their influence is exerted not through numbers but through such powerful instruments as finance, banking, literature, the Press, radio and television and internationalist organisations of a social and political nature. It is not this economic preponderance of the Jews which has been solely the cause of the Jewish problem, but rather the influence of the Jewish spirit won through this economic domination. Because of their racial makeup, national thinking, and religious teaching, which inspires them with the belief that they are "God's chosen people," destined to rule the world, their influence has been and always must be internationalist and anti-European. It presents one of the greatest dangers for the life of the European peoples and of the North American people alike. Their influence is so all-pervading, from architecture to music, that it threatens to kill any further development of the bearers of the highest culture of mankind: the European, and particularly the Nordic section. A living example of where this has happened is in the world's largest Jewish populated city, the materialistic, cosmopolitan, soulless jungle of New York. This then is the crux of the British National Party's case against Jewish domination. A case which can have no room for that form of anti-Jewishness based solely on a dislike of the Jews' facial characteristics, his presence in the "local golf club" or the fact that he owns the latest model car. No matter how much our people may be blinded by false humanitarian feelings and the traditional Nordic spirit of "Championing the underdog," Britain and all Europe must be freed from the malaise of Jewishness by the humane departure of these non-European peoples to their own national state of Israel.

When Hitler left prison, the membership had slumped to less than half, the remainder was split into two factions. Reuniting the factions, Hitler re-established the Party at a great meeting in the Hofbräuhaus in Munich in 1925. He was forthwith banned from public speaking for two years during which he concentrated on the internal development and training of the Party.

After the ban expired, Hitler spoke continually, week in, week out, at huge meetings all over Germany, arousing his vast audiences to wild enthusiasm by his magic oratory. The industry, zeal, enterprise and bold militancy of the Party exceeded that of all others.

During 1930 the NSDAP held more than 30,000 public meetings. It gained nearly  $6\frac{1}{2}$  million votes in the September elections; and by the end of the year had 300,000 members.

In 1932 it became the largest party in parliament, gaining 133 million votes in the July elections, during which, on one day alone, Hitler spoke to audiences of 60,000 in Brandenberg, nearly as many in Potsdam, and 120,000 in the Grunewald Stadium in Berlin (with a further 100,000 listening outside to loudspeakers).

On January 30, 1933, President Hindenberg appointed Adolf Hitler as Chancellor of a coalition government. In the elections in March the NSDAP was the victor with over 17 million votes, 44% of the total. By an Enabling Act later that month complete power was voted to Hitler THE FUNDAMENTALS OF and the National Socialists took over the country entirely.

## The Makers of Civilisation

IT IS ON THE QUESTION OF RACE that we are presented with one of the most paradoxical situations of the mid-twentieth century. On the one hand, not a day passes without a further reminder of the most dominant issue of our time: race conflict, whether at home or abroad. On the other, press, radio, television, politicians, clergy and other social figures conduct a non-stop campaign to deny the differences, both mental and physical, between the races of mankind that brings about this conflict. In this series of articles it has not been our purpose to enquire into and expose the sinister influences at work in the organs of propaganda who are conditioning the white races to accept mongrelisation as a natural development, but rather to show the great difference in inherent abilities between the races of mankind and the dire threat that forced intermixture constitutes to the future of our Northern European folk and its civilisation.

We have shown, by scientific evidence, that the difference between the native inhabitants of these islands and Negroid immigrants goes far beyond mere pigmentation of the skin and includes all manner of mental and physical differences and no matter how much we may play with words to try to keep in line with "popular" thought the fact is that the European is undoubtedly the higher being. That eminent men of science are fully aware of this fact but are too "genteel" to say so, is borne out by the following editorial extract from "Nature", 9.12.61, the world's leading scientific publication : "The whole future of the race is at stake in such matters as the uncontrolled expansion of its numbers in the 'population explosion', .or the decline in its quality brought about by the genetic effects of advances in modern medicine in combination with our present-day casual breeding patterns ".

our arguments by contending that what is happening in Britain and other parts of the world today has already occurred before in history, and that in any case the people of Britain and the other Northern European lands were crude barbarians living in wattle huts when civilisation was being laid in Babylon, Persia, Egypt, Greece and then Rome. Let us examine this argument, for it

is the kingpin of their case; knock it away and the case for racial mongrelisation falls flat.

Scandinavia, with a section breaking off to go down into Greece to form her great civilisation. (See Professor L. A. Wadell's "The Makers of Civilisation".)

These Nordic ancestors invariably ruled over large populations of different race. Significant of the racial disparity between rulers and ruled is the phrase used in both ancient Sumeria and even ancient China, where the subjects were referred to as the "black-haired people", showing that the rulers were conscious of their racial difference in being the only human race with really fair hair.

A visit to the British Museum will show the startling fact that in nearly al! reliefs depicting Sumerian, Hittite and other early Middle Eastern rulers and soldiers (such as the Hittite relief from Carchemish) they show a European type of face and figure.

Even up to the 7th century B.C., the ancient Persians - Who were akin to those Indo Aryans who invaded India and established the ancient Hindu culture — were still fully Nordic, like the early Greeks and they are described as being 'nearly all f ir and ruddy like the Greeks'. The Ajanta cave paintings in India portray the Persian embassy as being of a classic Nordic-Greek type in appearance.

Later, when Alexander the Great brought his Nordic troops from Macedonia. (Northern Greece) marching across Persia, he had to defeat an Empire which had become a mere shell of the original Persian warrior and noble class. The sarcophagus of Sidon shows the Persians of this period as still having light eyes and fair, reddish moustaches, with Nordic noses and features. Greeks Were Nordic

#### Death Through Inter-breeding

However, the most important lesson to be gained for Europe of today from these early civilisations is not so much that they were founded by Europeans of Nordic and Mediterranean stock, but that they were terminated when their founders passed from history through the combined effects of fratricidal warfare (always a failing of the Nordic) and above all, racial intermixture with the subject peoples.

The same story evolves throughout European history, The Roman Empirebrough down not only through the interbreeding of the original patrician stock with immigrant slaves from Asia and Africa but through depravity and the domination of usury, as in Britain today, the power of 16th and 17th century Spain, the Italian Renaissance, the culture of France under Louis XIVth and her armed valour from Charlemagne to Napoleon, were all part of the Nordic genius that has passed its peak with the dying off of the race through incessant warfare in which they always led and through intermixture with other races.

#### The American Lesson

We began this brief synopsis of Nordic

We have also shown that even among

the European peoples as a whole there are again considerable differences, as the Europeans, or Caucasians as they are sometimes called, are sub-divided amongst themselves, Nordic, Mediterranean, Alpine, etc., and it is the varying compositions of these European races within the state that gives each country its national character.

#### The Real Race-Haters

Those who are unconcerned with, or even hostile to, the preservation of, our racial stock — and they are the real "race-haters" — will attempt to negate

As pointed out in the first article of this series, prior to the nineteenth century all previous invaders and immigrants to these shores were of predominantly Nordic stock, whether they were Angles, Saxons, Jutes, Vikings, Normans, (Norsemen) Flemish weavers, French Hugenots, (France then was still mainly Nordic), etc. Therefore, what is happening today with coloured immigration has no precedent in Britain.

#### The Founders of Civilisation

Who were the makers of the early civilisations of the Middle East and of Ancient Greece? They were not the brown men who inhabit those lands today, but men of Nordic and Mediterranean stock: the Aryan who gave his language as the basis of all Indo-European languages of today (Iran, the old word for Persia, means "Aryan"). The birthplace of these people — and our own Northern European ancestors-was in the area of the Caucasian mountains, and hence the term "Caucasian" for European stock. From here, one group swept down into Persia and the Middle East and the other went Northwards

One has only to look at the reproductions of Greek busts and statues that abound in our museums to see the visual proof that the leaders of ancient Greece were Nordic and far removed from the modern concept of the "oily Greek". Throughout the Homeric poems the figures of the human world - not just the Greek Gods - are featured as being light-skinned and bright-eyed; thus Achilles, Meleagros, Briseis, Agamede, Penelope, Hermione, Aphrodite, are on several occasions described in the Iliad and Odyssey as blond and light-eyed. In fact, among Homeric references to mortal girls and women, dark hair is completely lacking.

A Grecian word, which by itself alone reperesents an important assertion about the racial nature of the Greek, is the word "iris" for the iris of the

and European race history in the heart of the old world; let us finish with a lesson to be drawn from the new.

The South American continent is roughly the same size as the North American continent. Both cover extreme areas of climate; both contain vast mineral wealth, adequate water, forest areas and desert areas. Yet in spite of the fact that Europeans, mainly Spanish and Portuguese, began settling in the South American continent, and also Central America, at least a hundred years before other Europeans settled in the United States and Canada, the North American peoples of today leave the South and Central Americans far behind in all forms of human progress. The only answer to this great difference of achievement must lie in the peoples who inhabit the two continents of the new world, i.e. in racial differences. And here the moral is clear.

In South and Central American the -Spanish and Portuguese settlers married and bred indiscriminantly with aboriginal Indians and descendants of imported Negro slaves, with the result that apart from Argentina, Chile and the southern part of Brazil, the South and

## A NATIONAL EDUCATIONAL SYSTEM

THE PRESENT Democratic educational system is one of the main factors responsible for contemporary decline because it effectively serves to produce young citizens who are at the best oblivious and at the worst hostile to the cause of our race and nation.


It is claimed that Democratic education does not indoctrinate children, and instead confines itself to purely factual knowledge, devoloping the capacity to utilise this, and in all controversial matters observing strict impartiality, leaving the children to form their own opinions uninfluenced.

Such uncontrolled free development of children's minds never does and never can exist. At school-as also at home and in the world outside—children are ceaselessly shaped in one way or another by deliberate adult influence in favour of certain habits of thought and deed as against others; and this constitutes positive indoctrination. In the schools of Democratic Britain, while the pupils are not normally subjected to any appreciable degree of deliberate explicit propaganda in favour of a particular political party and its precise policy, they are universally and intensively subjected to influence and propaganda in favour of the political creed of Democracy. In the first place, the teachers themselves are almost entirely ardent Democrats who, if and where they do not consciously strive to propagate the Democratic viewpoint explicitly, nevertheless subconsciously -exert a Democratic influence. In the second place, these Democratic teachers are encouraged and in fact required by the local education authorities and the Ministry of Education to enforce a strictly Democratic atmosphere in the schools, and to inculcate-through direct exhortation, indirect suggestion, and the rigid exclusion of contrary ideasthe Democratic ideology of racial indifference and interfusion, global coordination, decision by head-counting and administration by commit tee, the freedom of the press to make propaganda against the interests of race and nation, and the liberty of the individual to mate and reproduce regardless of eugenics. A debased and perverted form of Christianity is made use of to impart a religious sanction to the indoctrination, and instil an abject deference towards the Jews.

and gatherings will be arranged to develop European youth solidarity. The older boys and girls will be given eugenic instruction to encourage racial betterment in marriage since the improvement of the human stock is the most effective way of improving Britain. A period of some form of national service will conclude the training.

Thus shall we take our children out of the hands of our enemies, and win them—and thereby the future for Racial Nationalism.

Central American republics have the most mixed-up populations in the world. In contrast, the Europeans — who until the turn of the century were predominantly Anglo-Saxon—of North America have with few exceptions bred amongst themselves, although the results of the current forced integration in the United States will alter this position within a few years.

Here then we come to the most important lesson to be drawn from these notes on the fundamentals of race. Whether it be in history or in the present day example of the Americas, overwhelming evidence warns us of the irreparable harm of racial intermixture. we in Britain and the other lands of the European ignore this message at our peril.

Adolf Hitler says, in MEIN KAMPF, "Anyone who fights for forty years for a so-called idea without being able to bring about even the slightest success, in fact, without having prevented the victory of the opposite, has, with forty years of activity, provided proof of his own incapacity." Hitler was referring to Germany's equivalent of our "Conservatives", who then, as now, would rather talk than fight.

Disillusion and disappointment with so-called Conservative organizations who made up most of the Right Wing, have awakened thousands to the Number One political fact in America: to smash the growing Communist and Negro Revolution, what is needed is a Counter - revolution! Conservatives cannot provide this desperately needed leadership.

While the Communist offensive gains momentum, most Conservative groups are still trying to combat it with outmoded, old-fashioned methods. While red-agitated Negroes burn cities, destroy and kill Whites, most Conservatives gnash their teeth--safe at home. While young Communist zealots believe so strongly in their traitorous cause that they actually burn themselves, most Conservatives are not even willing to go to jail for their beliefs.

In America today only National Socialism has the revolutionary power to

- (2) Therefore, the most important factor in the affairs of men is Race.
- (3) Mixing of higher races with lower races not only destroys races---it also destroys civilizations.
- (4) Therefore, the first duty of a state is to preserve, protect and better the race that created it.

National Socialists, therefore, are racists and view all of the affairs of men and nations from the viewpoint of Race. It is for this reason that Nazis take stands on issues, many times differing from the rest of the Right Wing. For instance, the American Nazi Party fights race-mixing in this country, but also opposes the policy of segregation. The reason is that segregation does not stop race-mixing--it merely aggravates the problem of

## Ideological Principles of our Movement --NATIONALISM

NATIONALISM is the strongest and most natural sentiment in any healthy society, being the spontaneous expression of its people's consciousness as a group, and their instinct to manifest that consciousness in many and diverse outward forms in keeping with the racial character.

The instinct of Nationalism can in fact be observed to operate in almost every form of living creature; not only the human. Everywhere where the species exist, the life-instinct impels them to think, feel, and act "tribally." Even in the most primitive forms of animal life, one can see the tribal instinct asserting itself, and this instinct being translated into crude forms of organisation, roughly corresponding to the "nations" into which the human species are divided, and each with its respective "leader," emergent as the strongest-willed of the group.

In all natural and healthy forms of creation, the group or tribal instinct and will supercedes any so-called spiritual concept of "Right" - as relating to life generally. That which serves the tribe, the nation, the race, is "right." That which acts against it is "wrong." In the battle for "rights," strength and capability alone prevail. There is no "divine right" accorded to every tribe or nation. Rights must be fought for and won in nature's struggle. Thus is evolution served, and thus do the species attain ever higher forms.

whole species, but in the clear-sighted and determined consolidation of its own power. In this way have the truly great nations of this earth, including our own, evolved to supremacy.

Only in periods of sickness and old-age do nations abandon this instinct, lose their consciousness of nationality, and become the slaves of ideologies that react against the spirit of Nationalism. Such nations that become permanently afflicted by this condition can reckon to be in the twilight of their existence.

In the renewal of Britain, we must seek to stimulate everywhere a full-blooded and uncompromising spirit of nationality, based upon a consciousness of our distinctness as a nation, of our great history, and of our supreme place in the achievements of mankind. This spirit of nationality must not be confined to embracing only those in our European island, but must encompass in totality the world-wide dispersion of the British Folk, and the mighty lands that it has conquered, pioneered, and settled. Every aim of political policy must be directed towards the unification of this folk, not for reasons of economic welfare, or of service to any so-called higher universal ethic, but purely and solely in keeping with nature's will that one folk should maintain a union of polity that is representative of its singular existence as a racial group, and which best serves the maintenance of its own life and culture in a continually evolving planet. To the young men and women of Britain we therefore preach this principle : "Forget the welter of internationalist and pacifist rubbish that an age of false values has foisted upon you. Seek the most basic wisdom by recapturing the instinct of family, nation, and race. By the exercise of that instinct, your forefathers built a civilisation in which you are glad to live. Reject it, and that civilisation will be lost !"

In the human species, the same natural law prevails, although unhappily it is not always faithfully observed. The strong and healthy national group, in the flower of its vigour, and in the upward and outward thrust of its creative achievement, staunchly and aggressively asserts its "nationhood," not hypnotising itself by prattle about the "rights" of other nations, but recognising and pursuing only its own right. It sees its way to strength, security, and happiness, not in appeals to a nebulous "brotherhood" of the

## Some Social Achievements of the Third Reich

ONE of the greatest social experiments of our century was successfully conducted in Germany only thirty-one years ago. It was nothing short of a complete revolution in relationships between state, employer, and employee, which had hitherto culminated only in misery and slump.

The social philosophy of National Socialism, so largely responsible for its resounding triumphs, was summarised in Mein Kampf as follows :

"Social policy is not intended to grant favours, but to establish rights." With these words, Hitler acknowledged the duty of the community to the individual. He also emphasised the reciprocal duties of the individual to the State, realising that only through national unity could national strength be restored. Those elements who fomented and encouraged national disunity and class-warfare justly incurred the enmity of the nation whose existence they threatened.




#### NEW DEAL FOR LABOUR



The philosophy of the is based on racial Nazis nationalism.

Racial nationalism is a comprehensive political creed combining racialism and nationalism to provide an answer to the crucial questions of the day, and the only alternative to both the quick death of white civilisation at the hands of Asiatic communism, and its slow death through the degeneration of Western democracy.

Its nationalism is not the old blind, hysterical aggressive nationalism of the last century and a half. This was too often the froth on the lips of big business in its scramble for world markets; a blood-shot nationalism whose pulse was feverishly unhealthy. Its national unity was superficial since its trumpeters although eager to advance the military reputation and colonial expansion of the state, were not concerned to show their patriotism in the deeper and truer ways of radical internal reform for the social and economic welfare of the people as a whole. This old nationalism let great portions of the nation rot in slums, or sent them to die in unnecessary wars, while it babbled of love of country and nation. The old nationalism was usually racially indiscriminate, and often racially destructive. It tended to ignore the realities of race inside the country, and, disregarding racial considerations

#### between countries, to set brothernation against brother-nation in fratricidal conflict.

In its internal inadequacy and external blindness the old nationalism played into the hands of communism and the Jews. Economic injustice resulted in class warfare and the spread of communism. The Jews thrived on both finance-capitalism and the communism it bred, for their simple concern was the power which either system provides them with. The strife between states, like the strife between classes, benefited the international power of Jewry, and favoured the expansion of communism.

Today, White civilization is under attack from within and withoutfrom the forces of disruption in its midst, and from the forces of destruetion on the outside—and desperately needs a system which will provide unity within the nation and unity within the race in defence of that civilisation. That system is racial nationalism. Its nationalism stands for the corporate, racial, social and economic welfare of the nation. It puts the nation above the class, clique and individual in the spirit of "all for the nation, and the nation for all." It believes in private ownership within a framework of national regulation to ensure fair wages, fair conditions, fair prices, fair standards-that is economic nationalism.

RACIAL NATIONALISM

Its racialism is complementary to its nationalism. In one aspect it is the racialism of the nation, giving unity a foundation of kinship, binding man to man with a blood connection, seeking the preservation and improvement of the racial heritage. In its second aspect it is the nationalism of the race, seeking the greater service of the part in the service of the whole, recognising the race as the larger nation and seeking its unity. For racial nationalism there is no essential conflict between the interests of nation and race. Instead, the interests of the one are to be sought in the interests of the other. We can look back to a racial unity of the Nordic peoples pre-dating the division and coagulation into nation-states in order to acquire the vision to look forward to a community of brotherstates of the race in the future, for it is imperative that we stand together as one family if we are to have the strength to survive and maintain our civilisation.

racial nationalists seek our closest association in a community of the Northern European folk, we visualise it as part of a white world community and outside this we face with good will the peoples of other races who are prepared to live as good neighbours.

In our racial nationalist creed of kinship we have, contrary to the old nationalism, a creed which creatively makes for peace between nations, firstly because it draws together the nations of our race, and secondly because it does not want to absorb or dominate other races, but instead merely wishes to live separately in

of all who contribute to it. As a revolutionary measure of national regulation we shall establish a minimum and maximum income, allowing a reasonable range between them to correspond to the considerable differences in service to the community, but ruling out the possibility of inordinate wealth at the expense of poverty, and guaranteeing a good standard of living to all in the nation who work well for the nation.

In conjunction with this we shall create a guild system for industry which will incorporate all the desirable functions of trade unions, ensuring fair wages and conditions for the workers, and fair prices and

standards for the consumers as well, and which furthermore will give all the workers a share in the profits and permanent representation in the management of all firms.

Finance must become the true handmaid of industry instead of its tyrant. Hence we shall establish

" AMERICA FOR THE WHITES" is not only a matter of racial preservation, and of the racial ownership of our land and its property. It is at the same time no less a matter of revolutionary economic reform and social betterment within that land and regarding that property.

accordingly we condemn both the snobbery of the bourgeoisie towards manual work and the snobbery of the proletariat towards mental work. Productive work in all its forms is our basis of economic value. The enemy of the worker by brain and hand alike is the parasite of all kinds, and especially the Jewish financier. Service to the folk community is for us the highest motivation.

The Nazi rejects both Capitalism and Communism, which are both class conceptions based on class warfare and consequent injustice. It rejects not only their practices but the whole scheme of thought and scale of values behind them. Class warfare is civil war in the economic sphere. It is a civil war which has been studiously promoted by the Jew on the principle of divide and conquer. It ultimately matters little to the Jew

In the National Socialist state only White people are recognized as citizens and therefore all jobs are res\_rved for Whites. The National Socialist government looks out for the welfare of it's working people. Q: How would National Socialism benefit the White Working People of America?

A: Under the present system in America, White working people are forced into competition with the non-White people living in America. These non White people are numerous and will work for lower wages thereby forcing Whites to take lower wages for their own work.

White men are responsible for

Under National Socialism, with all citizens contributing to the total output, White people would work shorter hours and still be able to retire at 40 or 50 instead of 65.

Q: What did National Socialist Germany do for the Working people? A: Everything was done to make the life of the working people more enjoyable. High wages were paid and the state planned low cost recreation. Free vacation trips were planned for the working people to foreign countries. In three years alone twenty two million Germans went on free overseas vacations. Free operas, concerts, movies and libraries were provided. Other similar facilities were provided at low cost. The working people were well looked after in Nazi Germany because the state and the people regarded each other as one big family UNITED BY RACE, culture and religion. White people reaped the rewards of their labor and non-White parasites were not allowed to leech off the sweat and toil of the German working people.

Respect was shown for women and special ceremonies were held for women having eight children. Special medals were given to them for the contribution and sacrifices they made to their race and nation. NON WHITES AND NATIONAL SOCIALISM

Q: Does National Socialism preach hatred of non White peoples? A: No. National Socialism preaches the separation of the races into their own countries or geographical areas. What National Socialists oppose is the artificial mixing of races. We believe that each race has it's own racial, cultural, and spiritual foundation and that one race should not try to force it's way of life on another. The National Socialist policy on race has been arrived at through a thorough study of anthropology, archeology and the history of civilizations. All major civilizations that have mixed with non-Whites have become morally decayed from within and have finally been conquered by their enemies from without. National Socialists base their belief not on hate but rather on racial understanding. We know and admit the difference in races and develop a policy based on knowledge and truth not utopian fantasy. Q: Should White people force their racial, medical and cultural achievements on other races? A: National Socialists believe that each race should develop along it's own lines without interference

most of the inventions (labor saving) in America and yet non citizens (non-Whites) are receiving the most benefit. In many cases non Whites are too lazy to take jobs in line with their mental ability and therefore become burdens on the taxpayers. White men are forced to work longer hours and pay high taxes in order to exist. In many cases both the husband and wife are forced to work so that non Whites can live on welfare.

National Socialism would remove non Whites from America. This would take cheap labor off the market and reduce the taxes being paid by Whites. White people would have a chance to enjoy some of the benefits of their labor.

Q: Under National Socialism would White people have more leisure time?

## NATIONAL SOCIALISM AND THE FAMILY

Q: What was the position of National Socialism regarding large families?

A: In National Socialist Germany, the people were encouraged to have large families.

Q: How does this differ from the present democratic system in Europe and America?

A: In Europe today White people

A: Yes. The age we live in is known as the machine age because of the advanced progress being made on labor saving machines.

In a National Socialist state every <u>capable</u> citizen does his or her part to make life more pleasant for all citizens.

Whenever machines can be used to replace human labor they will be used.

This will enable the working time of every citizen to be reduced in accordance with the increase in machine labor. The average worker will receive the same income he normally enjoys, but his hours of work will be reduced to give him more time for family and recreation.

Under the present Democratic-Marxist system the White working people are, on the average, the only ones with enough intelligence to run and service complicated machinery. Thus, most of the unskilled labor is non White and these non Whites produce nothing of value for the Nation as a whole. As more machines are used, these non Whites become totally unemployable and live on welfare --- off the taxes of those working. They receive money and food for NOT working while increasing their numbers through their rabbit like sex activities. The White people are forced to run the machines to prevent a breakdown of society but do not get reduced hours of work. To the contrary, because of the numerical increase of the non Whites they are forced to work even longer hours. The non Whites benefit from the labor of Whites under the present system. Page 14

are encouraged to use methods of birth control so that they will have families consisting of only one or two children at the most. At the same time jews and non-Communist Marxists are bringing excessive industry into White European countries. Because of the planned birth control, this creates a shortage of labor and consequently, foreign labor must be imported. This foreign labor usually consists of Asians, Africans and Southern Europeans most whom do NOT bring their women with them. This provides them with ample chance to meet and marry good race type European women and to produce non productive mongrel children.

The Democratic insanity in Europe today advocates birth control because of over population and then brings in non White labor because of excessive industrialization. The object is to mongrelize the White race and to restrict the size of White families. Q: What was National Socialist Germany's policy concerning this? A: Instead of bringing in non-White labor to Germany, non White labor was exported back to the country of origin. Official government policy was to encourage citizens to have large families.

from other races.

Whatever Whitemen invent should be used exclusively for the benefit of the White Race. If the other races are smart enough to invent the same machinery, well and good, but it should be on their own.

We believe that each race should develop along it's own religious lines. If the negroes in Africa want to believe in Voodoo or the Chinese in Buddhism good and well, because these religious attiutes are in harmony with their mental, spiritual and cultural heritage.

We believe that White men should NOT try to educate non Whites. The non Whites should be left alone to develop their own means of education. Missionaries going into non White countries have turned peaceable happy go lucky negroes into White hating savages.

Q: How did National Socialism encourage large families?

A: Low cost housing was provided for working people at a cost of One Thousand Reichmarks. A loan was given to newly married couples INTEREST FREE to buy these houses and for every child that was born twenty five per cent of the loan was cancelled. 9

Without the meddling of White men in Africa non Whites would be no menace to the White race.

When a negro is educated he becomes envious of the White man and covets his women and his possessions.

Missionaries went into China and brought Opium with them and this has resulted in the present Communist regime in China. Meddling in the affairs of other races leads to bitterness and hatred.

Q: Did any non-whites fight for Nazi Germany in WW II?

A: Yes. There were foreign volunteers fighting alongside the Germans in WW II. They came from the fol-

(Cont. from page 14) loving countries: India, Mongolia, Tibet, Turkey, Egypt, etc. Q: Why did non-Whites fight for Nazi Germany?

A: Because they knew that the Nazis believed in letting them rule their own countries, believe in their own religion, have their own culture and develop along their own lines without interference from outside races. Most of the non White countries have been occupied by Whites who have no understanding of their way of life and who try to force the Whiteman's way of life on them. National Socialism would liberate them from foreign domination and let them run their own affairs.

Businessmen have no interest whatsoever in the well being of their race and community and their whole lives are pre-occupied with making as much money as possible. Money and material gain become their sole objective in life and greed their God.

Instead of earning money they seek to "make" money by usurous schemes like the stock market, loan companies, etc.

In Capitalism, dishonesty is a virtue and honest business deal-

Q: What is the difference between National Socialists and Conservatives?

A: The conservative theory is based on Capitalism and it's continuance. FARMERS AND NATIONAL SOCIALISM

Q: What was the policy of National Socialist Germany towards the farmers?

A: In 1932, because of the mistakes made by the German Weimar Republic German farmers were in a state of financial disaster. Many small farms had been taken over by large farm owners and many farmers had left their farms for the cities because they were not able to earn enough money to support themselves at home.

When Hitler came to power in 1933, the official policy of the National Socialist party was to encourage farmers to return to their farms and desert the mammonism of the cities. National Socialism realized that special consideration must be given to the farmers and their problems. Special laws especially suited for farmers were enacted and all debts against them were abolished. A new credit system geared to the farm economy was created to help them. No debts could be made against the farm from that time on and under no circumstances could the farmers property be taken away from him for indebtedness. It was also made impossible for him to lose his property through forclosure. To insure that the farms stayed in good hands, the property could not be sold to anyone outside of the family and upon death the property was inherited by the next of kin. The government required the farmer to cultivate the land to good advantage and not to contract long term indebtedness. If the farm was not used to good advantage the next of kin in the line of inheritance would receive the property after a thorough investigation by farm authorities to prove negligence.

In Russia the Czar and Royalty were absolute capitalists. They gathered all the wealth together for themselves and their small circle and almost completely overlooked the misfortune of the peasants.

The jews, under the pretext of Communism, put forth an appealing program of "share the wealth" to the non-jewish peasants of Russia and met with an eager response. The British, like the Germans, are by nature a military race, and have a magnificent military tradition. This tradition, elevated as it should be in the minds of the public, can form the breeding ground for a true military morality in the people and can at the same time form the pillar of an unshakable nationalist spirit.

#### RELIGION

Where does religion stand in the folkstate? First we must realise that the persecution of a religion only serves to strengthen it. Therefore even in an ordered authoritarian state religious freedom should not be suppressed. History offers enough examples-not least in our own country-of the futility of trying to stamp out a religious idea by force. The only way to combat a religious idea is to offer a better idea in its place. It is clear that whatever the basic origins of the Christian faith, the church today, in all denomiations, is corrupt and hostile to the state. Stern measures should therefore be introduced to ensure that the church does not interfere in ANY secular matters. Other than that the church should be allowed to practise its faith as it wishes. Let us conclude with this slogan-All for the State, none outside the State. The state is the nation. The nation is the state. We, the coming generation of Britons have the opportunity to build a state mightier and more enduring than our forefathers ever dreamed. By paying lip-service to the principles that have guided the state of old, however, we can never succeed.We must cast into the fire the aged shibboleth of Liberal Democracy. We must stamp mercilessly on the senile dogmas of the old establishment.

When we examine the Democratic theory of state, as outlined above, we can see that in essence the state is, to the Democrat, an evil neccessity. His whole outlook seems to indicate that the state is desirable only because of the imperfections and anti-social tendencies of man, and the resultant need for some sort of an institution that will control them. The existence of any higher spiritual force welding people together in one unit 'is completely denied. The state exists purely for man-because he is imperfect. were he perfect the state would not be desirable. Surely, stripped of all but its bare essentials, this point of view is, ideologically speaking, worthy of only one description-Anarchist. Our task is to weld a new and revolutionary conception of state, giving it not merely raison d'etre, but a real spiritual substance and consequently a fusion of real, enduring life.

The folk-state must foster the cult of heroism among its citizens-particularly the young. It must be founded on the belief that man's ultimate purpose in living is not just his own physical existence on earth but rather the fulfillment of his mission as an individual serving the divine destiny of the nation. The characteristic of the citizen in the folk-state must be that of the warrior rather than the shopkeeper. In the fundamental task of strengthening itself physically and morally the state will be dutifully bound to foster the healthy growth and promotion of the best elements in its population, to harden them for the school of life, and to ensure their alliegance to nation and race.

#### CULTURE-STATE

Similarly the state must strive to maintain and promote the cultural welfare of our community. Cultural purity is an essential object in the task of preserving the cleanliness of the body politic. Alien forms of culture must be judged not according to the appeal they may have for the baser tendencies of the individual, but from the standpoint of the health of the folk. The complete acceptance by a people of alien cultural standards undermines its faith in its own powers of cultural creation. With these things in mind we might as well call the folk-state the "culturestate". It would basically mean the same thing. It is essential to recognise that in our state of the future, political, social, and cultural life are so completely interwoven as to form what is really one organic whole. Culture must never be taken to mean something in which the individual indulges for pleasure when he is not occupied in commercial or other pursuits. Culture is an end. All economic and commercial activity, all production of physical matter must be recognised in the ultimate analysis as a means of promoting

Ours is tomorrow! The world belongs to youth! The world belongs to the ideologies of youth! The new order is on the march!

The state, as conceived in the future, far from being merely "the sum total of individuals" must be recognised as an eternal living organism, having its roots in history, and stemming outwards and upwards in the form of varying cultural expressions of the soul of the nation and race. Its prime task will be not to serve man, as an individual unit, but its own historical continuance and survival in the cosmic world-order. In this way the state is not the servant of the individual but the individual first and foremost a servant of the state. Therefore the relation of individual and state will be based first on duty and only secondly on right. This is not to assert that man has no rights, but that for the maintenance of his rights he is dependent upon the state ---without whose existence such rights will disappear. Therefore "right" as such is only the reward of duty.

generally useless when it came to facing the enemy.

Man is not inherently bad. Rather is he inherently weak. Unless given strong guidance, he sinks in the social scale down to the level of something which is only a grade upwards from the animal. Therefore it is essential in any healthy state that "individual freedom" instead of being an end in itself, is but a means. The freedom of the individual should be promoted to the extent the individual can be relied upon to use his freedom not against but for the good of the community.

#### THE FOLK

When we speak of the "Folk-State", we recognise the "Folk" as the only true concept upon which the state is founded. A community which comprises of different types of folk, different races, is a community with no unified social structure and no unified culture, and therefore is not a state but an agglomeration of states. A state is dependent upon the herd instinct of its members-the instinct which compels them to act together at all times in face of danger from outside. Therefore the organic health and permanent existence of a state can only be ensured if its human components are all of one race, one culture, one nation. The fate of the Holy Roman and Hapsburg Empires have shown the futility of trying to maintain a state not built upon a racial, folkish foundation. The political structure of any organically sound state is essentially authoritarian. The democratic principle, by dividing the body-politic into warring parties and social interests, brings the people into conflict with each other and enables them to be undermined and subsequently ruled by alien forces from outside. The essential feature of authoritarianism is unitynot to be confused with standardisation-and order. Without unity there herent anti-Social tendencies in man, can be no order. With the democratic

Culture must not be taken to mean only the arts. Rather it embraces all spheres of human activity. Sport is a form of culture-physical culture, social etiquette is as well.

Foremost among the noble cults is the cult of militarism. Militarism is that which takes young boys from the arms of their mothers, and moulds them into MEN. In the folk-state military training must never be neglected—even in times of apparent national security. Not only the known hardships of military life go to make a cult of militarism, but the entire substance of the military tradition is a highly desirable influence in the life of the folk. Military chivalry, military history, the military code of morals must be given the place they so rightly warrant in the scale of social values. Militarism is closely linked with Nationalism. For by its record of

For Conservatism, however, there is no definition. No two Conservatives can give the same viewpoint on all issues. Unlike National Socialism. which is a philosophy of life, Conservatism is only reactionary and many times contradicts itself. For instance, Conservatives say they are not racists. They say they are for States Rights. Yet they would all recoil in horror if, say, New York State exercised all the rights that Mississippi and Alabama might, because New York is controlled by Jews, Negroes and other assorted aliens and subversives.

Consider another example. Conservatives are great advocates of individual liberty, in greater and greater amounts. They continue to advocate this, even while the entire nation is exploding into a state of outright anarchy, which the Conservatives also say they oppose.

taken up by members of the Nazi Party and the money was used to purchase food, clothes and furniture for the poor. Once every week citizens were urged to make up a meal from leftovers and the money saved from this meal was to be used to help raise the living standards of the poor.

Q: How was Capitalism and Communism defined in Nazi Germany? A: "Capitalism required liberalism, under which the I or ego side of life was elevated to a position of commanding importance. In its wake capitalism brought parliamentarianism, materialism, mammonism. It promoted the idea of each against all, the revolt against nature involved in the simultaneous disintegration of father rights and the institution of the family. It crowded people into cities, broke up all sense of community feeling, destroyed the natural hierarcy of duties and responsibilities, reduced all to a socially undifferentiated mass of rootless, senseless, despairing people, and opened wide the gates to the degrading philosophy of bolshevism. "And bolshevism, is the logical descendant of liberalism and capitalism. It takes those which are good among the ideas of individualism and socialism & perverts them to the despotic equalitarianism of the Orient. The Jew Ricardo perverted the otherwise sound economics of Adam Smith; the doctrine of the jew Marx triumphed over those of the German blooded Robert Owen. The two great enemies then, are capitalism and Bolshevism. Capitalism is the jewish oriental perversion of the doctrine of individual initiative and the institution of private property. Bolshevism is the lowest common point; it is seen as the sum of all the perversions of all the great social values geard to the idea that the lowest elements of society shall force the equality of their inferior talents on all graduations of ability." (Neuadel aus Blut and Boden, by Walter Darre, 1934) Q: Who are the greatest allies of the National Socialist Party? A: The working people. "Without the people, a party is nothing. The bourgeois comes and goes, he gives himself when all goes well and wets his trousers when things start to go badly. Then he takes off, with a wet behind. The real tough ones, the ones that hold good through thick and thin because their attachment is not subordinated to the protection of material goods, are the people. Either you have the people with you, or you have nothing with you." (Leon Degrelle, Rexist Movement, Belgian National Socialist)

that the man's world is the state, his struggle, his preparation for solidarity, then one may perhaps say that the woman's world is a smaller one--her world is her husband, her family, her children, and her home .... what would become of the greater world, if there were no one to tend to and care for the smaller one? The greater world is built upon the very foundation of this smaller world. The two worlds are not antagonistic -they complement one another, they belong together just as husband and wife belong together.

"The women of the future will be at home in her kingdom, will not torment herself with fruitless worry about equality, will learn to find happiness in the accomplishments of her man, and will not disdain to support him by her bravery, her willingness to sacrifice, and her diligence in the field of life alloted to her." (Hitler's speech before the Women's Congress at Nurenberg, Sept. 1934) "The German woman, as we see her, must, when the exigencies of the Race require it, give up luxury and pleasure; she must be physically and spiritually able to work and she must be able, out of the harsh severe existence that we are forced to live, to make a good, sweet life. She must be inately aware of the need and dangers that beset her Race and she must gladly do all that is expected of her. She must, in a word, be able to think politically .... so that she feels with, sacrifices with, the entire people in self assured and proud support." ("Weg and Aufgabe der Nationalsozialistche Frauenbewegung" by F. Scholtz-Klink) Q: What type of training was given to young German women? A: An organization called the Women's Labor Service was established and young girls were given six months of training for their future life. Most of the girls went to rural camps where they lived in large houses and assisted farmers in their work. For six hours a day they would help the farmer harvest his crops or help the housewife with her chores. After this they would spend the rest of the day in camps hearing lectures, singing, playing theatricals, and dancing folk dances. The lectures they received were on race and the nec essary things they had to know to become good wives. Some of the girls were also trained in household work and did six hours of social work in the homes of indigent families. A program was also set up where housewives would be given a free month vacation every year at resorts to give them a change from their normal household duties. In these cases, girls from the WLS took care of the housewives children and work for the month. The object of these programs was to train young women how to be good wives, how to take care of their children and to get to know how life was outside the cities. It was an attempt to get women out of the professional world and back into their natural world of

## being good wives and mothers. Q: Why are National Socialists opposed to the jews?

A: Each race must have it's own racial and cultural heritage. In most cases each country considers itself a racial unit. In National Socialist Germany the German people wanted to govern their own affairs free from outside interferance.

During WW I, the jews made a deal with England to bring America into the war on the side of England. This was called the Balfour declaration. Due to this situation Germany lost the first World War and the German people suffered because of it.

After the war the jews under the leadership of Rosa Luxemburg and Eisner, (jews) tried to set up a Communist state in Germany. Alien jews, who were a minority, tried to impose their Communist state upon the majority of the German people as they did in Russia.

Jews became influential in Germany and used their money to try to force Communism upon the German people.

The National Socialists in Germany stopped Communism and set forth a plan for the survival of the Aryan people.

Q: Are jews a race?

A: The jews are not an original ... race but a race created through centuries of mongrelization. The greatest majority of today's jews are descended from Khazars, a asiatic people.

The jewish racial type we

know today is a result of this mongrelized race trying to stem the downward trend of mongrelization among their people. The jews realized that if they continued to marry with negroes and asiatics they would become more negroid and lose all identity. In an effort to stem this they started segregating themselves from other races into ghettos. This resulted in close interbreeding, inter-family marriages and the formation of an artificial but distinct jewish racial type. (kinky hair, bulgey eyes, Kulla Bear expression of the face, bowl legs, thick neck, hooked Armenian type nose, large ears, weak eyes and obnoxious voice.) Q: Are jews a religion? A: Over the centuries this jewish racial type developed a type of religion called "judaism". Being made up as it is of mysticism, metaphysics, occultism, racism, dietary laws, laws on sex and business practices. This religion is one that is in keeping with the jewish racial and cultural background. Real jews are a race with a religion of the same name. In this case jews would be jews by both race and religion. Non religious members of this racial community are also known as jews and identify with the jewsih people. A small community of nonracial jews have also been converted over to the jewish religion causing some confusion among non aware people.

THE POSITION OF WOMEN

Q: What was the Nazi policy for women?

A: In National Socialist Germany the place of women was in the home careing for their families. We get our quotes on the role of women and their importance to the nation as a whole from official National Socialist sources: "When one says

Q: Communists are athiests, how can jews be Communists?

A: Since most jews are jews by race as well as religion some of them, in order to promote their own social and ideological theories, would rather drop the religous title of "jew" and pass themselves off as Russians, Hungarians, Letts, etc. in order to promote Communism. Communism itself was founded by a non-religious racial jew, Karl Marx.

However, since Communism is an invention of the jewish mentality and has been promoted and financed by jews, it is to the benefit of some racial jews to openly renounce judaism and to identify with the theory of Communism. Though jews become "Communists", most of them still identify with the jewish race and promote it whenever possible. Q: If Communism is founded and controlled by jews, then why are the Communists against Israel? A: Communism is an atheist religion based on false economic theories promoting class warfare and denying the existence of race. While jews control most improtant positions in Communist governments and push the Communist theory of equality and class war, they also have non jewish Communists around them. Communists supposedly have only one loyalty Communism. They do not tolerate the dual loyalty of any of their citizens to foreign governments.

Therefore, any racial jews that come out in favor of Israel would be considered to be dividing their loyalty between their respective Communist country and Israel. The non jewish Communists would then consider the jews to be traitors for their dual loyalty. So in Russia the Communist jews are, by necessity, forced to go along with non jews in stopping Zionist jews from supporting Israel. It is either stop the Zionists or be purged for treason.

However, the whole Communist philosophy is based on the insane jewish theory of racial equality and oneness.

Q: Are jews loyal to the country they live in?

A: Most jews are either Zionists or Communists. The Zionists have been working for centuries towards building a jewish super state for themselves. However, the jewish state is not to be an end in itself but rather a base from which they can operate in co-ordinating the activities of other jews living outside Israel. Israel is the brain center for the world Zionist organization. From this safety zone they can give orders to their co-conspirators in other countries, who, if challenged in any country, can then run to Israel and receive complete protection from the legal authorities of non-jewish countries.

Jews live in non-jewish countries and at the same time support the Zionist idea of the jewish super state. Non-jewish citizens of non-jewish nations are not allowed to hold dual loyalty to any other nation or they are convicted of being foreign agents, but jews claim that they can be loyal to Israel and the United States at the same time. They, therefore, send unlimited amounts of money to Israel and are not challenged by the Government.

Jews are not loyal to the countries in which they live, but rather, use them as a base for promoting their world state and it's ideals.

Q: Why are jews disliked by National Socialists?


A: Mainly because they are not loyal to the United States but to Israel, and they do not work in the interest of the majority of Americans.

Most jews came to America as refugees and were granted refuge and allowed to become citizens.

The founders of the U.S. were White Northern Europeans who came here and founded the greatest nation in the world. With them they brought certain racial and cultural values which had been passed down to them through the generations by their forefathers.



A: Passed laws taking away therights of citizenship of the jews and to curb their influence in the nation's destiny. Laws were passed forbidding mixture. the marriage of jews and non-jews.

WITH the objective vision of genius, Adolf Hitler contemplated the condition of the White civilisation of the present against the background of the rise and fall of past civilisations in the cycles of human endeavour. He recognised that there is never a truly static society, but instead there is always, as with the life of the individual, a neverending struggle between the forces of decay and death and those of life and renewal. He analysed the advancing disease of modern society with piercing clarity, and, with prophetic insight and iron logic, declared the principles of radical regeneration without which White civilisation is doomed.

Sweeping aside the whole enfeebling democratic philosophy of the equality of everything human, whether individuals or peoples, he replaced it with one based on the qualitative differences between them.

In the world at large he distinguished the White (or Aryan) peoples as a superior type of humanity, responsible for creating the highest order of civilisation. The preservation of this racial stock is therefore a paramount purpose of the state. The nation is accordingly conceived as a racial community, citizenship restricted to those of Aryan blood, and

ind expressed this as no statesman had ever done before. He saw the White peoples of this earth surrounded by a rising tide of Colour, and he believed that only if they inited, and rejuvenated themselves by his principles of National Socialism, could they survive.

Especially, he sought the friendship of Britain, her people substantially of Germanic origin, constantly declaring his wish for a close alliance between the two great brother-nations as the core of a

Racial unity enjoins a true brotherhood transcending econo--mic class, and hence effective economic regulation to ensure justice for all and co-operative prosperity for the nation.

Since the quality of individuals differs within the race, as it does BY FRANK BRITTON between the races, it is a fundamental duty of the state to encourage the reproduction of the higher types of man, and thus improve the race and nation; and to provide for nation in all fields and at all levels by this true aristocracy.

#### NATIONAL SOCIALISM AND BANKING

When Hitler was appointed chancellor, *le*gally I might add, there were a great many problems in the economic sphere.

With no gold, no foreign exchange, six million unemployed, and starving farmers, she determined to go back to the fundamental principles of economics which have been lost sight of by the financiers of other countries. One thing she was determined on. Not to go into the world financial market and borrow money ever again.

The fundamental principle is that wealth is the product of labor applied to raw materials to make articles of utility Labor may be employed to make goods for immediate consumption or to increase capital values by carrying out work which will enable more articles of utility to be produced at a lower cost. The building of motor roads is an excellent example of the second application of labor, as it facilitates and cheapens the transport of goods. The German government decided to introduce a new method of measuring the value of the mark, discarding gold and making the mark represent a labor unit. [reviewer's italics-editor] Taking the total output of labor in the country, the number of marks in circulation is limited to the output, and so prices are kept very level, only small fluctuations taking place. . . . They also proceeded to make a very bold experiment by creating credit through the state to set everyone to work on some useful employment. They were under no delusion as to this fictitious capital. They realized it would have to be replaced by the only real capital, savings from the product of labor, and they took care that every penny was utilized as far as possible to increase the capital wealth of the country. . . .

And this same Churchill was the man who, in one of his sober moments, said of Hitler: "If our country were defeated, I hope we should find a champion as indomitable to restore our courage and lead us back to our place among the nations."<sup>31</sup> But we need not stop with Winston; there were even more interesting remarks passed about Hitler's financial system by other highly placed plutocrats. For example, the late, unlamented Bernard Baruch, American representative of high finance and "unofficial adviser" to our presidents, made some very illuminating remarks on this subject.

In May, 1944, Mr. Baruch received a gold medal at the annual dinner of the National Institute of Social Sciences, in New York City. General George C. Marshall made the presentation, and, as an instance of Mr. Baruch's foresight, the General revealed that in 1938 the financier told him: "We are going to lick that fellow Hitler. He isn't going to get away with it."<sup>32</sup> **HHSHIFTSHIFTSHIFTSHIFT** ADOLF HITLER with some of the Aryan children he loved.




She knows the real labor value of her goods in marks, and going to a foreign country she proceeds to barter an exchange of goods for goods which is advantageous to both sides in the bargain. To do this she had obviously to arrange the exchange for a period of several years and give the other country credit to the extent of her immediate purchase of raw materials to be paid in manufactured goods. She has therefore brought trade to its ultimate real basis and cut out the complications of varying currencies.<sup>29</sup> In September, 1939, just after the war began, Baruch said:

If we keep our prices down, there is no reason why we shouldn't get the customers from the belligerent nations that they have had to drop because of the war. In that event, Germany's barter system will be destroyed.<sup>33</sup> [reviewer's italics—editor]






In capsule form, this was the economic system which National Socialism instituted. A very brief examination of the reaction of bankers and finance-capitalists to it will demonstrate that it had a great deal of responsibility for the outbreak of war in 1939. An acute observer will quickly grasp the difference in reactions of the bankers when faced with National Socialism and with Marxism, which ostensibly is the direct antithesis of capitalism, according to the apologists for the latter system.

In November of that year (1936) General Robert E. Wood lunched with Churchill in London, and, testifying before a Senate committee later, the General informed it that Churchill said: "Germany is getting too strong and we must smash her."

For what reason? The bloodless conquests had not begun. The Sudeten question and Munich were still far off. There could be only one reason for Churchill's determination to smash Germany, and that was that she had shown the world that a state could make a success of the barter system and dispense with foreign loans.



For most of my life, I thought Nazis were criminals and murderers, like a lot of people still do. Then I found out Nazis are people who believe in RACE, - like most Americans, PATRIOTISM like most Americans, ANTI-COMMUNISM like most Americans, and Christian Civilization, - like most Americans do. It gives men the one cause left in the world today that can inspire them to rise above their own selfish interests and to sacrifice for something greater than themselves. National Socialists are not reactionaries, conservatives, or politicians-they are Revolutionaries, inspired with a Holy fire to fight to the death if necessary for the Salvation of their Race, Nation, and White, Christian civilization.

Not Conservatives, but Adolf Hitler's National Socialists smashed Communism's terroristic grip on Germany thirty years ago. Just as in Germany then, the Communizes are seizing control in America today.
