VENTILATIONS

by Wilmot Robertson

*The author of **The Dispossessed Majority** firms up and expands some of his key ideas.*

Letting his mind range freely over the Slough of Despond known as current history, Robertson first replies to readers of **The Dispossessed Majority** who have taken him to task for his pronouncements on religion and the Soviet Union. He clarifies his attitude toward Christianity by throwing some light on the little discussed but important cause-and-effect relationship between race and religion. He amplifies his prognosis of increasing anti-Semitism and nationalism in Russia by a wealth of new evidence both from within and without the Soviet Union.

One of Robertson's most interesting pieces is a blow-by-blow description of the attempted suppression of **The Dispossessed Majority** by a conspiracy of silence in which the John Birch Society's **American Opinion**, William Buckley's **National Review** and Thomas Winter's **Human Events** joined hands with the **Daily Kent Stater** and the fargone students on the radical left. Not only did these champions of free speech refuse to review **The Dispossessed Majority**. They even refused to accept advertising for it!

Robertson writes intelligently and bitingly of Watergate and the fall of Nixon, which he defines as the high tide of media absolutism and as a liberal-minority purge of the ideological bankrupts who call themselves moderate conservatives. He comments at length on the nauseating apotheosis of Henry Kissinger, who has a special flare for coming out second best in negotiations with Russia and who won the Nobel peace prize for "ending" a war in which Vietnamese soldiers continue to die at the rate of 50,000 a year.

To raise the morale and race consciousness of Majority college students, whose apathy is one of the chief causes of America's drift into mindlessness, the author outlines in four separate essays how they can participate actively and productively in this stage of the racial confrontation. He takes particular pains to spell out the limitations of what can be accomplished now and warns of the frustrations that come from believing that great changes are just around the corner.

A prediction by a Dutch reader of **The Dispossessed Majority** that America will soon be engulfed in a race war provokes a wide-ranging response from the author, who comments at length on the proposition that the discovery of America drained European nations of the energies they

needed to repulse aggressors from the East. He also examines the suggestion that the U.S. should trade its black population for South Africa's 3,500,000 whites.

Ventilations contains a stimulating evaluation of the half-forgotten dictator, Kemal Ataturk, who snatched Turkey from total dissolution after World War I. A blond, blue-eyed Macedonian, Ataturk was willing to surrender huge slices of Turkish territory to achieve his goal of racial consolidation. Robertson compares him to other statesmen, including his Turkish successors, who were less anxious to put race above real estate, and explains why a future American dictator should act more like an Ataturk than a Stalin or Hitler.

Women must play a vital role in the revival of the Majority or there will be no revival. Some conservatives hope to keep women in their place. Some liberals want to turn them into men. In one of his most perceptive essays, Robertson points out that the status of women, due to technological advances, has been irrevocably altered and that they should be encouraged to use their newly acquired freedom to become full-time partners with men in the salvation of their race.

The penultimate essay in **Ventilations** is an idealistic leapfrog into the future. In answer to those who felt **The Dispossessed Majority** contained too much carping criticism, but not enough solutions, Robertson projects a 21st century America of separated and insulated population groups, where the Unassimilable Minorities live apart in obligatory self-sufficiency and where a resuscitated Majority is once again in control of its culture and its political and economic destiny.

Morality as a tool for gulling the citizenry is nothing new in politics. But in contemporary America it has become a mania that defies all criticism. The antidote, according to the final essay in **Ventilations**, is not to attack liberals and minority racists for their perversion of morality, but to accent the morality of the Majority's cause. Majority members should abandon the illusion they are a superior people fallen on evil times. The fact is they have become a persecuted race and should defend themselves by every means in their power. Most important, Robertson presents a host of reasons why Majority members should stop being too proud to turn classical moral arguments against discrimination and persecution to their own profit.

Sometimes a great new book or a great old book is published or reprinted by a big publishing firm yet dies on the vine. The publisher may not have the heart to promote a controversial book and the media may refuse to mention it. As far as the general public is concerned, the book might as well have remained unpub-

lished. To shine some light in these dark holes of indirect censorship, Howard Allen, although a publisher in its own right, has made arrangements to distribute, at the regular retail price, a few landmark books of other publishers. Each is a scholarly blockbuster that has been studiously ignored by the one-eyed media.

Race by Dr. John R. Baker. A world-renowned Oxford biologist has written the definitive work on racial differences. Almost all the available physiological and historical evidence has been assembled to prove once and for all that there are important and measurable intellectual as well as physical disparities between the races. Now, whenever Negro backwardness is blamed on environment and oppression, the argument can be easily refuted by citing chapter and verse from Dr. Baker's encyclopedic study. A Fellow of the Royal Society—in England the nearest thing to a Nobel prize—Dr. Baker has produced an inexhaustible reservoir of documentation which provides a solid scientific foundation for the ideas of Arthur Jensen and William Shockley. A New Theory of Human Evolution by Sir Arthur Keith. The greatest modern anthropologist is almost unknown to the American reading public, and the media monopolists are unabashed. This is Keith's major work and contains the principal threads of all his ideas about evolution and the constructive role played by nationalism and prejudice in race building and genetic progress. No book by any author offers a more penetrating rebuttal to the Boas school of anthropology, whose perverse and unfounded assertions about racial equality have dominated Western thought for most of this century. Eye Color, Sex and Race by Dr. Morgan Worthy. A young psychologist on the faculty of Georgia State University has written a fascinating summary of experiments demonstrating that people with light eyes literally "see" the world differently than people with dark eyes. Eye color seems to be the key to varying patterns of human and animal behavior. Dark-eyed individuals are overly reactive. Light-eyed persons are self-pacing and their inhibitions give them time for reflection. There is an intriguing section on glandular stimulation by the wavelengths of light favored by different eye pigmentation. Published in 1974 by Droke House.

A New Morality from Science by Dr. Raymond B. Cattell. An internationally prominent psychologist, who has authored 30 technical books and more than 300 research articles, Professor Cattell rejects liberalism and racial leveling in a profound and challenging work that searches for new ethical values from the domain of science. A great mind dares to come to grips with the most controversial issues of the age. His eminently sensible proposals for a new evolutionary ethics based on behavior genetics rather than on religious, liberal or Marxist dogma have so enraged the book reviewing establishment that hardly a mention of his work is to be found in any influential newspaper. A SEMINAL STUDY IN PHILOSOPHICAL ANTHROPOLOGY

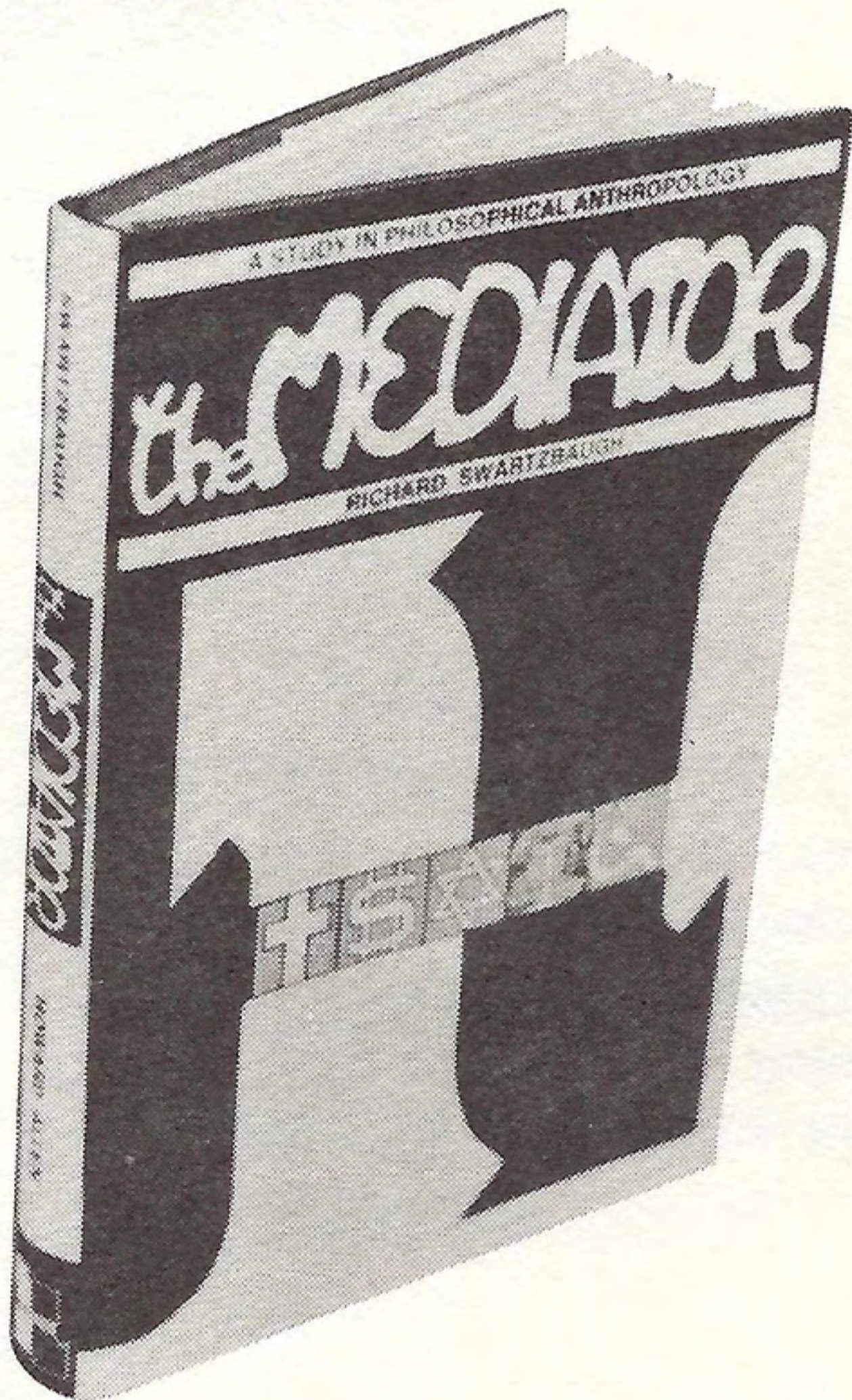
The mediators and go-betweens who abound in America exert great influence. Yet it took an anthropologist, not a politician or journalist, to discover the shadowy mediative castes who are making a special power play for control of the United States. The mediator is a paradox. In standing **between** factions, he cannot be **of** them. His outside status, reinforced in part by social and psychological ostracism, is both his weakness and strength.

The advocate of a distinctive social philosophy, the mediator asserts that human social bonds, as opposed to the relations of animals, are fundamentally abstract or mediated through language. Consequently, his ideas are more than objective assertions about reality. **They are modes of human relationships**—and as such are leverage for the acquisition of political and economic power.

Dr. Swartzbaugh gives the institutionalized forms of this leverage their scholarly due—the church, Jewry, the legal profession, the liberal and Marxist intelligentsia and the money interests. He compares today's mediating intellectual, the descendant of the ancient priest and scribe, to a tightrope walker who only manages to stay aloft under certain conditions. In his insightful conclusion, the author describes how the winds of change are now causing the tightrope and its teetering occupants to sway dangerously.

About the Author

Richard Swartzbaugh (born 1939) is a denizen of the Midwest. He obtained his three degrees from Ohio State (Ph. D. in anthropology in 1969) and taught at the University of Mississippi before taking on his present assignment at Eastern Illinois University. The author of many hackle-raising articles in a Scottish anthropological journal, he did his field work in Mexico. His philosophical urge was born while tramping through the Black Forest when he was a graduate student at Tübingen. His hulking frame (6'6") and his poetic assault on the social sciences have caused his growing band of disciples to describe him as the Thomas Wolfe of anthropology.

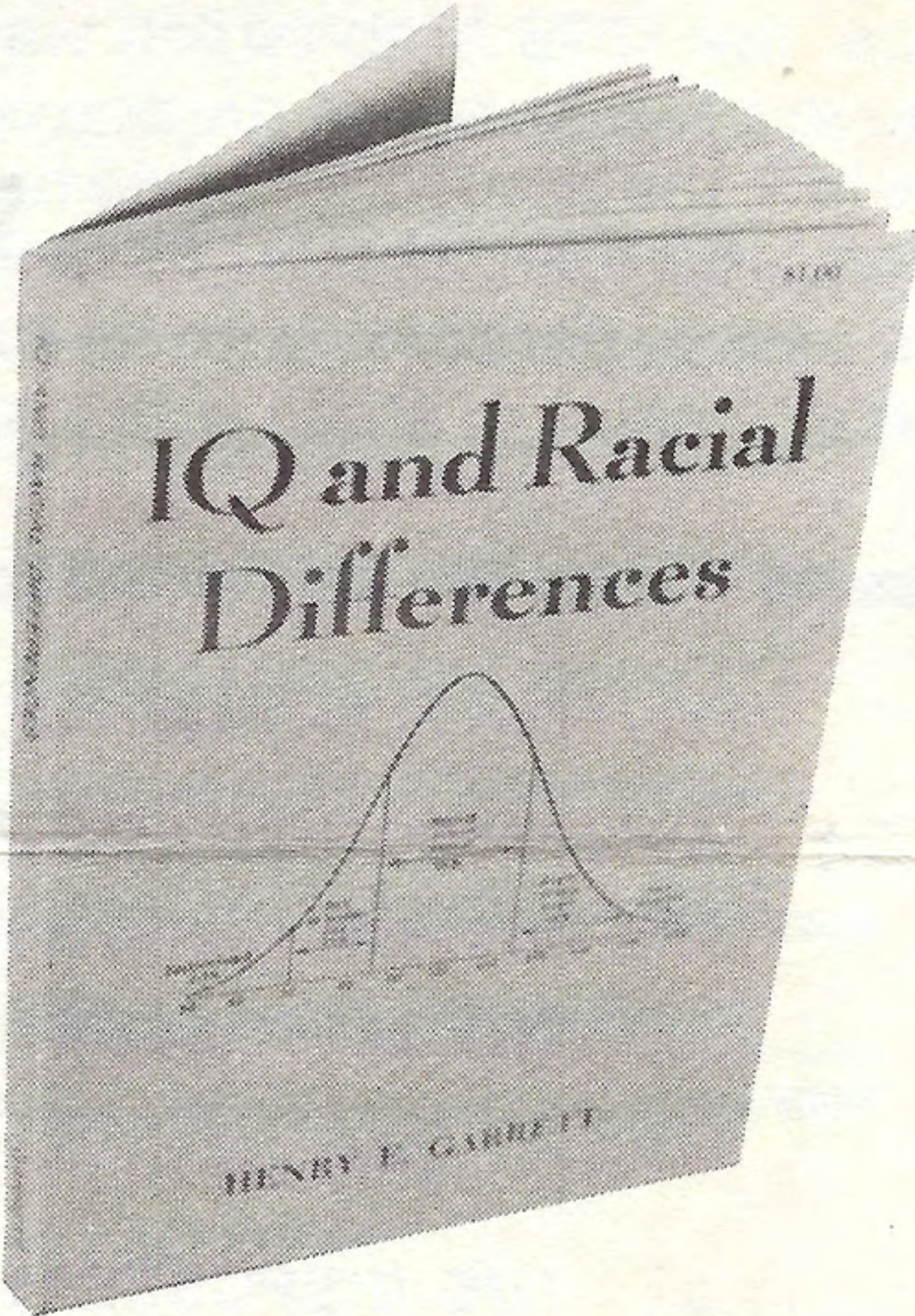


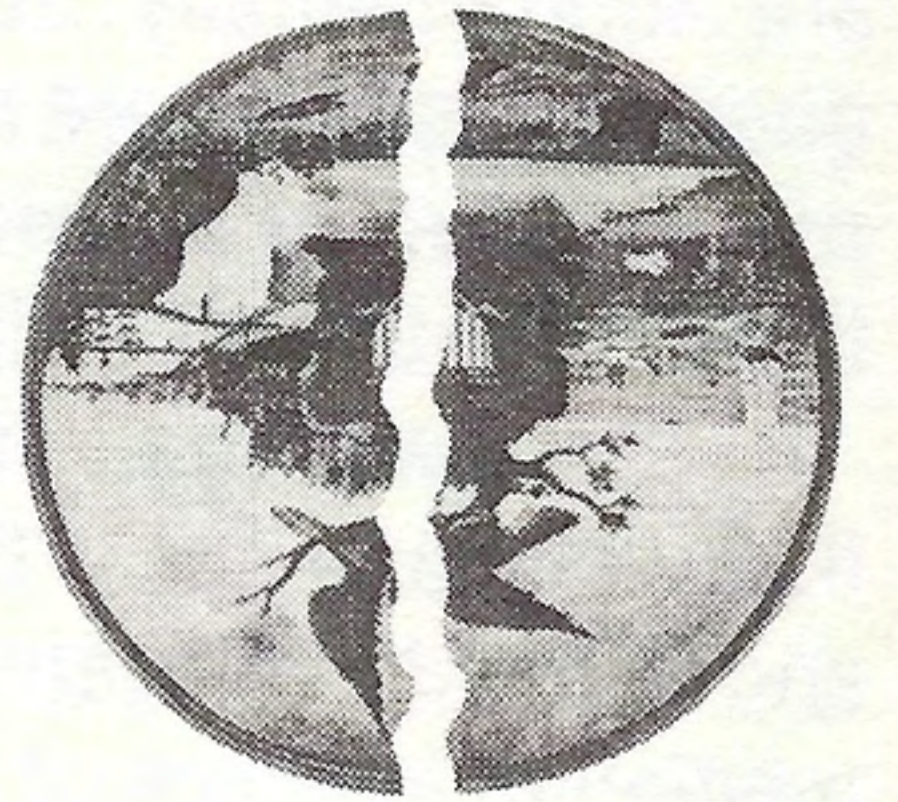
