Los Angeles National Socialists Urge Busing Boycott

The Los Angeles Unit is presently conducting a campaign which urges White parents and students to boycott busing. This is the first year that Los Angeles area schools have been forced to undergo the busing ordeal. As in other areas of the country, Los Angeles Whites are fighting the forced busing integration scheme tooth and nail.

Unlike other areas of the country, though, a sizable number of middle-class Jews are being affected by the busing plans. As a result, most of the grass-roots anti-busing groups which have sprung up are run by Jews. Consequently, these kosher-controlled organizations have been issuing such ridiculous pronouncements as: "We aren't against integration or Blacks, we're just against busing."

To counter this insane state of affairs, members of the Los Angeles Unit have been attending anti-busing rallies organized by these groups and distributing literature which gives the National Socialist position on busing. A special leaflet has been produced by the unit which calls for Whites to boycott busing when it begins in September.

Further details of the L.A. Unit's anti-busing campaign will appear in the *Bulletin* as they occur.

Blacks Plan March on Midwest Party Headquarters

A group of Black militants, calling themselves the "Martin Luther King Jr. Movement" have announced that they plan to stage a march to protest the presence of the Party's Midwest Regional Headquarters in Cicero, Ill. The Blacks are also protesting the fact that Cicero is an all-White community.

Midwest Regional Leader Cedric Syrdahl has indicated that the Party is prepared to take whatever action necessary to defend the headquarters. An estimated 500 Blacks are supposed to take part in the march, which is scheduled for 16 Sept.

Reproduced on page 3 is a newsclipping giving some background information on the proposed march. The outcome of the march will be covered in an upcoming *Bulletin*.

Minneapolis, Milwaukee Troopers March on Reds

The Minneapolis Unit was joined by Milwaukee Unit I on 13 August for a full day of National Socialist activism in Minneapolis. In all, three uniformed activities were held by the combined units.

The first activity held was the picketing of a "conference on racist unemployment" which was organized by the Progressive Labor Party under the auspices of its front group, the Committee Against Racism. Two teams of ST men and a team of NSYM members demonstrated outside of the building where the meeting was being held, carrying signs reading: "CAR Is Anti-White," "A Good Red Is A Dead Red" and "White Power." The National Socialists also chanted "What do we want?—DEAD REDS!" as they picketed. Although the neighborhood is a notorious hangout for leftists, creeps, dopers, queers, non-White scum and other assorted riff-raff, the brave "revolutionaries" of the PLP and CAR could not summon the courage to venture forth from their meeting place to do battle with Matt Koehl's Stormtroopers. After a half-hour of picketing, the men moved on to another target.

The second activity was the picketing of a Socialist Worker's Party bookstore, in still another trashy neighborhood of Minneapolis. Once again, there were no incidents, except for the usual obscene remarks from anti-White elements.

The final public activity for the day was a newspaper and leaflet distribution in downtown Minneapolis. The ST and NSYM handed out copies of WHITE POWER and Menachem Begin leaflets to passersby. The National Socialists also had the opportunity to speak





with a number of Whites who were interested in the Party.

After the activity, the men retired to a local supporter's home where they feasted on fried chicken and other goodies prepared by local members of the National Socialist Women's Organization. That evening, the ST, NSYM and NSWOW members were able to watch their first picket of the PLP on television, as it was shown two times each on KSTP and KMSP news.

Second Chicago Unit Formed

Because of the rapid organizational growth experienced by the Party in Chicago in recent months, the Chicago Unit has been split into two units: Chicago Unit I and Chicago Unit II. Both of these Units operate out of the Midwest Regional Headquarters in Cicero, but have separate mailing addresses. (See below for the addresses.)

Chicago Unit II's first uniformed activity took place on 12 August. Eight unit members drove through various Chicago suburbs in the Unit II sound truck, broadcasting pro-National Socialist messages to the public through the truck's sound system. The only disturbance occurred when a handful of Reds made an unsuccessful attempt to storm the truck. The attack was repulsed by vigorous countermeasures on the part of the truck's crew.

On 13 August, members of the newly-formed probationary unit led White citizens in a highly successful attack on a Progressive Labor Party march. The PLPers were trying to march through the all-White suburb of Berwyn. Their end goal was to be to heckle a demonstration called by local Jewish "Nazi" Frank Collin/Cohn. White citizens outraged at the presence of Communists parading through their streets, flying Red banners and carrying pro-communist placards, were swiftly mobilized by plainclothes members of Chicago Unit II.

The 40 or so PLP members were quickly set upon by White workers, veterans and students, who beat them into the ground. Numerous Communist banners were captured—of which one was set afire—and within minutes the Reds were sent scurrying to safety behind police lines.

The crowd of Whites, along with members of the unit, proceeded to the rally being held by Frank Collin/Cohn. The small crowd which had already gathered to watch the side-show was in a good mood, tossing beer cans and rotten fruit at Collin/Cohn, along with taunts concerning his Jewish ancestry.

About 20 minutes after the members of Chicago Unit II arrived at the location, members of the Jewish Defense League began to infiltrate the crowd. A brief scuffle soon broke out between members of the unit and the JDL'ers. Two National Socialists—Unit Organizer Steve Lynch and unit member Sean O'Toole—were arrested, along with three JDL members.

Comrade Lynch was thrown into a paddy wagon with his hands handcuffed behind his back by a Black police officer. Also present were the three JDL members—whose handcuffs had not been properly fastened. Sensing their advantage, the Jews began to threaten Comrade Lynch's life. After he explained to them in no uncertain terms what sort of retaliation they could expect from him if they tried anything, they decided to sit back and behave themselves.

Comrade O'Toole was not as fortunate. While being transferred from the jail where he was booked to the courthouse where he was arraigned, he was brutally beaten—while handcuffed—by three Jewish sheriff's deputies.

Organizer Lynch now faces charges of battery and disorderly conduct. Comrade O'Toole was charged only with disorderly conduct. Further developments in their case will be reported in the *Bulletin* as they occur.

As a result of the day's activities, Chicago Unit II received extensive media coverage, including radio, television and newspaper reports, some of which showed dramatic footage or gave graphic description of the unit's successful attack on the PLP.

Blacks ask Cicero for parade permit

A BLACK organization in Chicago is asking Cicero for a parade permit to protest segregated housing in Cicero and to protest the presence of neo-Nazis based in the town.

The leader of the Martin Luther King Jr. Movement, the Rev. Calvin Turner, estimated 500 marchers would participate in the demonstration, planned for Sept. 16. The parade would follow Cicero Avenue from the Chicago border to the Cicero Town Hall, Cicero Avenue and 25th Street, where speakers would address the crowd.

Turner was to meet with Town President Christy Berkos late this week to discuss his plans. Berkos said the information he would garner from what he expected to be a "nice and quiet discussion" might be presented to the town board Monday.

TURNER SAID his purpose is to point out that the "thousands" of Chicago blacks who work in Cicero, mostly in factories, "should have the right, if they want, to live in Cicero, any part of Cicero, like they can in Chicago."

He also wants "to dramatize the neo-Nazi

group that has made its home in Cicero." Turner said members of the National Socialist White Peoples Party, which maintains headquarters at 2442 Central Av., "are more dangerous and more organized than Collin."

Frank Collin's much-publicized chapter in Chicago of the National Socialist Party of America is not affiliated with the Cicero Nazi organization.

"WE WANT blacks to be able to live where they want without the fear of reprisals and bombings," Turner said. "They can work there [in Cicero], but they cannot live there. This is 1978. Housing should be open to blacks."

Though the King Movement's proposed parade would center attention on the lack of open housing in Cicero, Turner said, his organization is concerned with segregation throughout Illinois.

Turner said he has called for a meeting for Monday at 39th Street and Drexel Road in Chicago to announce his plans and as "a show of strength." He emphasized his organization is nonviolent in the tradition of the

civil rights leader for which it is named.

IF THE PARADE comes off, "we anticipate no violence, and just like the police protected Collin, we expect the same protection," he said. "I hope the people of Cicero understand that we're not trying to run them out of their homes."

The town initially received the request from Turner by letter in June. The town board postponed action on the permit pending the submission of further information on the parade.

Berkos thought that if the permit is approved, the confrontations that took place during the civil rights marches of the mid-1960s would not resurface.

FOURTEEN PEOPLE were hurt and 39 arrested in September, 1966, when rocks, bottles, and firecrackers were thrown from a crowd of 7,000 whites as 200 blacks marched through Cicero to press for open housing. More than 3,400 police and National Guardsmen quelled the disturbance. Martin Luther King Jr. did not follow through on a planned

march into town during that same year for fear of violence.

The media and the beating death of Jerome Huey, 17, a black, on a Cicero street corner in May, 1965, helped to fuel the angry mood during those times, Berkos indicated. Things were "bad" and "different" then, he said.

"We're not getting too excited. Marches are passe. People don't get excited about them and don't really care.

"IT SERVES absolutely no purpose whatsoever. If he wants to go through with the march, I have no objections. The least bit of notoriety and attention would be the best way to handle it."

The town would limit the crowd size, allowing hundreds but not a couple thousand marchers, Berkos said. "The best way would be to get you in and out in a half hour. Set a good pace and keep moving."

Cicero has been under fire by special interest groups as well as black leaders for its housing practices and lack of low and moderate-income housing.

Rights group seeks Cicero march okay

A black civil rights group has requested a permit from Cicero town officials to conduct a march next fall through portions of Cicero and Chicago's West Side to protest alleged housing discrimination and Nazism.

The request, which reached Town Hall Wednesday, told of plans by the Martin Luther King Jr. Movement Inc., 2408 E. 75th st., Chicago, to conduct a "non-violent" march on Sept. 16, by no more than 1,000 participants.

The letter, signed by the Rev. Calvin H. Turner, president of the King Jr. Movement, indicated the civil rights activists plan to assem-

ble along Roosevelt Road just outside of Cicero and march to Town Hall, then continue on to Nazi Party Headquarters at 4030 S. Rockwell, Chicago.

THE REV. TURNER also requested protection by Cicero police while members of his group parade through portions of Cicero.

Town President Christy Berkos acknowledged receipt of the letter Thursday but said it was still too early to say what action will be taken by the town.

"As usual, we will follow the law," Berkos said. "There's a lot of time before this (march) takes place. It will require long and lengthy study."

Party Blitzes Northern New Jersey

Morristown is a quiet little community located in the northern portion of New Jersey, about an hour's drive from New York City. During the Revolutionary War, it served as headquarters for George Washington and his troops temporarily. That was 200 years ago. Today it's a different story.

Morristown is no longer a homogeneous White community. Its population is roughly one-third Jewish, one-third Black—and only one-third White. Morristown now houses the largest rabbinical college in the Western Hemisphere—the second largest in the world.

When local Party activists began activities there, they knew they had their work cut out for them.

After a few night-time literature distributions and private meetings, they decided to expand their activities in such a way as would draw attention from the news media. This, they calculated, would bring the Party into the public eye, and inform all area Whites that an organization was now in existence that would fight for their rights.

Local activist Thomas Vetere, a probationary Party member, took out the necessary permit from city hall which would allow the open distribution of Party literature. At the same time, he requested information on local picketing regulations and whether or not it was legal to wear the ST uniform in a public city council meeting.

Shortly afterwards, a newspaper reporter got wind of the comrade's plans, and the fat was on the fire!

Outraged and terrified at the prospect of a Party unit being formed in the largely kosherized Morristown—in fact, right in the shadow of New York City, the Jewish capital of the world—the local news media poured a stream of publicity (mostly

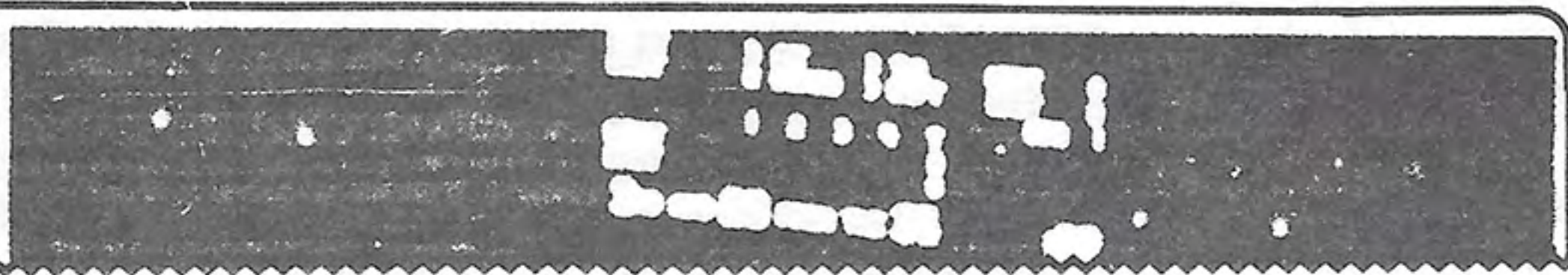

Jewish Defense League Mobilizes In Rockaway Twp.

ROCKAWAY TWP. — Jewish Defense League members last night vowed to stem a new tide of neo-Nazism by patrolling White Meadow Lake and the Rabbinical College in Morristown; establishing a self-defense program, and enlisting community support from blacks and non-Jews.

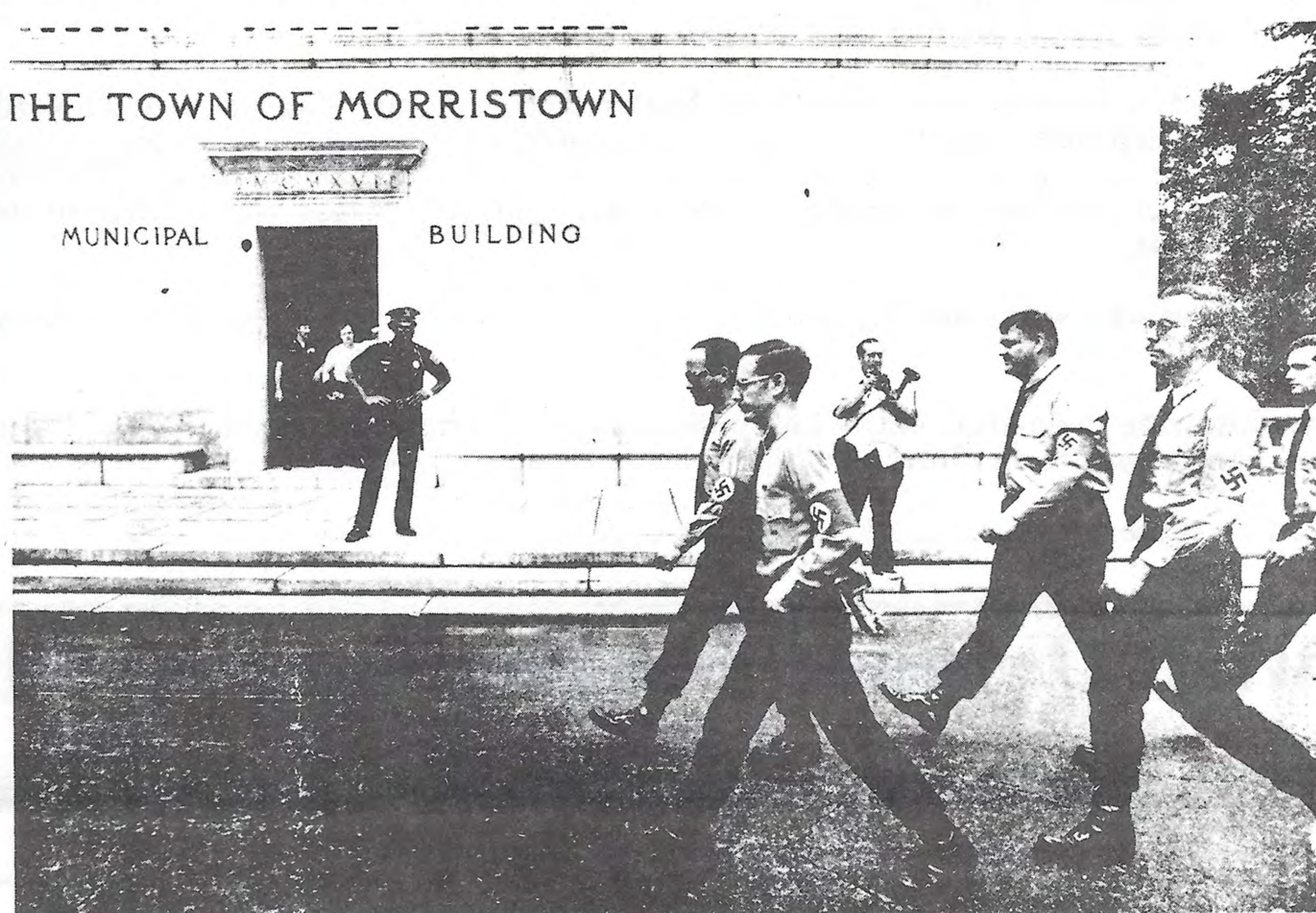
"The Nazi party has risen in America," declared Clifford Meth, high school senior and local acting chairman, at the militant organization's first meeting at VFW Post 9238.

Meth told a crowd of about 80 persons that the League plans to march Monday in Morristown, where a week ago seven

Nazis Checked With Cops Before March

MORRISTOWN — To ensure they were proceeding within the legal framework, Nazi leaders first checked in with police before finalizing preparations for their march here yesterday.

Martin Kerr, 26, the National Socialist White People's Party acting organizational secretary, described the day's plans to the officer on duty this way: "We just want to walk on the sidewalks and distribute literature, just like other Americans. We want to show people that we don't have horns or carry pitchforks."

Acknowledging there was nothing police could do to stop the demonstration, the officer later reflected on having to deal with a controversial situation. "They've got their rights," he said. "I may not like it, but I'd go to war to defend those rights."

A former resident of the Westfield area, Kerr drove into town yesterday to organize supporters for the march. Car problems delayed his projected arrival until midafternoon, and apparent difficulty in convincing other Nazi backers to go public put a further crimp in the original schedule.

Though Kerr had projected a dozen marchers, only seven, plus a woman supporter bearing a camera, actually participated. He and Operational Officer Fred Verduin both came here from party headquarters in Arlington, Va. Probationary party member Thomas Vetere Jr. of Morristown also attended, as did four others from throughout Morris County.

Kerr declined to release the names and addresses of the four, arguing that such publicity would have a "detrimental affect on their lifestyles" because they had families to support and could not risk losing their jobs. Vetere, who intends to change his last name to Ferriss because of family opposition to his political beliefs, has already lost his job as a painter and wallpaper hanger.

It was Vetere who obtained the town permit to distribute literature on the party's behalf.

Interviewed at the Howard Johnson's motel in Whippany where he was staying, Kerr said his organization is eyeing the Chatham and Madison as places where "feelers" would be put out to investigate local laws so as to plan for future activities.

While the use of Morristown as an operational base in northern New Jersey is under consideration, he said, he conceded a town with "alot of non-whites and Jews" means a sizeable amount of the population would not be receptive to joining the party.

"Alot of hard work has to be done before anything substantial is built up," Kerr said. He said he would like to see the Morristown-Morris Township Joint Free Public Library keep the party newspaper "White Power" on hand so it can be read.

Kerr said he had intended to vis-

it Morristown in October or November to survey political opportunities, but came earlier because phone calls and letters to headquarters from this area backing the party philosophy had indicated his schedule should be advanced.

A target of the Nazi calls for "No More Pornography" was the adult bookstore and giftshop on Mount Kemble Avenue. When the Nazis arrived there, Kerr told the female shop clerk, "We don't appreciate this kind of filth around." The clerk responded, "I don't appreciate you being here." She then immediately telephoned her

supervisor as the Nazis abruptly left the store.

The clerk, who declined to give her name, said later, "The whole Nazi concept, all that degradation, is more than anything they'll find in this store."

Mayor Donald Cresitello, contacted last night, commended "the people of Morristown for exercising good judgment in not overreacting." He also said he was sure the Nazis would not get support here and expressed a hope "this will be the last time this kind of thing will be happening in this municipality."

Vetere Defends His Party's Goals

To the editor:

Some letters I've read in your paper recently have said we National Socialists are uneducated fools, mentally ill, etc. Nothing could be further from the truth. We are, in fact, nothing more than average, everyday white people who believe in our race.

Nazi Reaction

Jewish Defense League Moves Into Rockaway Twp.

The New York headquarters of the militant Jewish Defense League has sanctioned a new chapter in Rockaway Township as a result of Nazi activities in this area.

A public meeting in White Meadow Lake and a march in Morristown are scheduled for later this month.

Meanwhile, the National Socialist White Peoples Party, whose members are commonly known as Nazis, has made inquiries in Chatham regarding permit requirements for distributing literature door to door. There are also reports that similar inquiries may be made in Chatham Township and Madison.

Clifford Meth, chairman of the Rockaway JDL chapter, yesterday extended an

open invitation to anyone wishing to attend the meeting at 8 p.m., Aug. 22 at the Veterans of Foreign Wars building on Pawnee Road in White Meadow Lake. There will be guest speakers at the meeting, which is also designed to "build an effective chapter to combat the Nazis," he said.

The chapter already has close to 50 members, Meth said. He said the meeting will also serve to finalize plans for the march in Morristown, now scheduled for Aug. 28.

The march, which will start at town hall and proceed around the Green, was originally planned for the same day as the meeting, but was postponed so as to allow more time for organization, he said.

Meth said the JDL attempts to begin

chapters in different areas where it is believed they will be effective. He said the organization has known about Nazi activities in this area for some time through the use of informants, "but we didn't expect the Nazis to rise as quickly as they did."

As a result, he said, "we're pushing our people to get going." The feedback received from Morristown indicates "we're welcomed with open arms," he said.

Asked to describe the nature of the JDL, Meth said: "The answers the JDL proposes may not be the most appealing but are certainly the most effective. We admit our solutions are not based on traditional Jewish intellectualizing and philosophizing. Rather, they're just plain common sense."

"The greatest tragedy is that Jewish

people who continue to fight their enemies on polite levels can't understand why Jewish blood is perpetually soaking the earth. We cannot fight the enemy on any other level than his own.

"Racists have proven that they're not afraid. The only way of stopping the Jew hater is by deterring him with something he's afraid of. Each time the Nazis attempt to march or assemble, the only time they're stopped is when a crowd is on hand to tear them apart. The JDL is that crowd."

Chatham Borough Administrator Peter Raynor said yesterday that an inquiry was made about the requirements for a permit, which costs \$5 per day, to distribute National Socialist White People's Party literature. He said the police chief has the discretion to issue a permit, and does so providing the applicants are peaceful, unabrasive and "of generally good character."

Officials in Chatham Township and Madison, targeted by Nazi leaders as other potential sites for literature distribution, said they have not yet received any inquiries.

negative) onto the Party. This, of course, was what the local comrades had expected.

Organizational progress proceeded at such a pace that it was possible to begin uniformed activities in the city less than a month after the first newspaper article had been printed.

On 13 August, acting Organizational Secretary Martin Kerr, accompanied by TL Fred Verduin, drove to the area to assist local comrades in their first demonstration. Seven ST men marched through the Morristown business district, while others followed along inconspicuously on foot, or shadowed the marchers in their cars, in case of trouble. The troopers chanted "White Power!" and distributed copies of the Party newspaper. They interrupted their march long enough to stop in at a pornographic bookstore and pay their disrespects.

Although the Jews who witnessed the march were visibly upset, they contented themselves with shouting obscenities at a safe distance.

In the days following the march, anti-White politicians, anti-White clergymen and the Jewish Defense League all hopped on an anti-"Nazi" bandwagon in an effort to whip up hatred against the Party.

Jewish Defense League Cancels Plans To March

MORRISTOWN — Encouraged by the positive steps taken to repudiate the doctrines of Nazism, the Jewish Defense League decided to postpone yesterday's planned march here.

Clifford Meth, chairman of the Rockaway Township League chapter, said the decision by the national organization's executives to hold off on the march was primarily based on three factors — the efforts of local religious leaders, a request from the mayor, and the council's attempt to implement regulations governing the distribution of hate literature.

There was also a feeling that any march or demonstration could be detrimental to both the organization and the "good job" being done by religious leaders and the local government, Meth said. "Nobody there is pro-Nazi," Meth said. "They're doing the best they can."

However, he said, should these efforts fail, "there will be a demonstration — and more." He said there is no intent to "harrass" or "push" the community while it appears to be seeking ways to counteract Nazi activities.

"We don't want to antagonize anybody," Meth said.

Meth warned that should the Nazis "ever try something as foolish as marching again, they will be stopped immediately." He said "hundreds" of people, some arriving on buses from New York, had planned to participate in the march.

Mayor Donald Cresitello said he has been seeking to discourage the march because he did not think that "anybody should march anymore." The march was scheduled on the heels of a weekend sponsored by the Morristown Area Clergy Council designed to reaffirm community solidarity and brotherhood.

Meanwhile, the King Street Association, fearful of the potential problems caused by a League march in the neighborhood, asked police to barricade the home of Thomas Vetere Jr., a probationary member of the National Socialist White People's Party. Association spokesman Albert Kelly said the residents had planned to sign complaints against "anyone causing any trouble."

The marchers were to begin at town hall, circle the Green and end up at Vetere's house. Kelly said the residents also sought to have additional police on hand because "we did envision danger."

Skokie relaxes

Jewish rights appear stronger to some

SKOKIE, Ill. — Residents of this suburb just north of Chicago breathed a collective sigh of relief yesterday because an 18-month threat of a march by American Nazis here was canceled.

"There is no story here now," a motel clerk told a reporter. "Why don't you go back home? Frank Collin called the Nazi march off yesterday."

But one Jewish spiritual leader in Skokie, 40% of whose 70,000 residents are Jewish, told the reporter he is not as skeptical as the motel clerk about the presence of a story.

Rabbi Harold I. Stern said the past 18 months have convinced him that Nazis could never take over the United States, as they did in Germany prior to World War II.

He also indicated that Chicago area Jews probably are not finished with their conflicts with the Nazis, and suggested that Jews are likely to join blacks to fight an attempt by the Nazis to demonstrate in Chicago next month.

"The real story of Skokie is that Jews

are safe in the United States," said Rabbi Stern, head of the Conservative Temple, Bnai Emunah.

He said that he and the leaders of the 15 other Jewish congregations here have received thousands of letters from all over the nation in support of Jewish opposition to the march.

"I have not received one anti-Semitic letter or phone call," Rabbi Stern said. "That is unusual because some anti-Semitism does exist in the United States. But it is not violent and capable of the death and destruction wrought upon Jews by Hitler."

He said he believes the position of Jews in the United States has been strengthened by the Skokie episode, and that he is convinced that the constitutional freedom for Jews will always be guaranteed.

"The Christian community and political leaders proved by their reactions that they would never stand for a holocaust here like the one that occurred in Germany," he said.

When the Nazis first proposed the march last year, Rabbi Stern said that he

and most other rabbis here thought the demonstration should be permitted without Jewish objections so that it would not gain the Chicago Nazis any undue attention.

But, he said, many of the 7,000 Jewish survivors of the German death camps who live here felt they could not tolerate the hated Nazi swastika and threats of death for Jews.

As a result, Skokie officials fought the march in the courts, but unsuccessfully.

Collin, the Nazi leader, called off the march Thursday after the Supreme Court cleared the way for it to be held. He said he would demonstrate July 9 in Chicago's Marquette Park, near his headquarters, and also a predominantly black neighborhood.

Black leaders here have said that they will oppose that demonstration because the Nazi rhetoric is as much anti-black as it is anti-Jewish.

Rabbi Stern said the approximately 250,000 Jews in Greater Chicago are prepared to stand with blacks to oppose the Chicago march.

Nazis in City Draw Crowd and Police

It was the first time anyone could recall ever seeing them here.

There were seven of them Saturday, wearing stern faces and storm trooper's boots and swastikas wrapped around their arms.

Chicago's problem, Skokie's problem, Milwaukee's problem, had come to Waukesha — The Nazis were in town.

Stationed at opposite corners of Five Points, their strident shouts of "White Power" cut through the balmy early afternoon air, attracting the attention of shoppers and passers-by cruising the Main Street-Broadway area.

Actually they were selling their newspaper, a tabloid published in Arlington, Va., where anyone interested could call for information about joining the National Socialist White Peoples' Party, as they call themselves. The phone number was stamped on the front page.

There were four of them on one corner, three on the other, about 1

p.m., striking various military poses ranging from not-quite-at ease to something resembling attention.

Most were young, in their mid-to-late 20s. One appeared close to 40; another, wearing a riot helmet, was clearly in his 50s.

They had come over from Milwaukee, the oldest one said.

At first their manner appeared amiable, if aggressive, as they engaged mostly curious youngsters in conversation.

It was the usual Nazi rhetoric about Jewish conspiracies, blacks bent on destroying the country for "white Americans," repeated denials about concentration camps and the millions who died there during World War II: "Most of them just starved to death at the end of the war," one of them told a girl of high school age.

But quickly the mood turned threatening.

The crowd that had gathered in front of Estberg Jewelers, at 301 W. Main St., began hurling taunts.

Someone hurled an egg that missed its target and hit the side of the build-

ing. Clearly most people were angered and offended by the presence of Nazis in the city. The Nazis, sensing the increased tension, grew defensive and defiant.

The police appeared about 1:15. There was some question over selling on the streets without a permit, and the Nazis were "invited" down to the station, as one officer put it, to talk things over. Other than the errant egg, there had been no incident.

After a behind-closed-doors meeting that lasted no longer than 15 minutes, they left — the station and town as well.

"We were asked to leave," one of the young Nazis said, as they got into their cars and drove off.

"We had a friendly discussion, and they decided they were going to leave," Sgt. Frank Hemauer said Saturday.

Noting the presence of American Legionnaires in town for the statewide convention, he added, "For the

'It was a most unusual reunion'

To the Editor of The Standard-Times

Despite all the World War II hate propaganda books and films we have been subjected to for the past 30 or so years, I was pleased when I read a Jack Anderson column recently about U.S. and German veterans meeting to honor their war dead.

It was a most unusual reunion. Eighty members of the U.S. 70th Division traveled to Europe to meet with German soldiers from the SS Sixth Mountain Division, whom they had fought against in World War II. The SS, an "elite guard," was a military formation which fought on the side of the Third Reich during the war. It was composed not only of Germans but of Aryans (whites) from every European country and even included some Americans and Canadians.

The two groups of veterans met in Epinal, France, to lay a wreath on U.S. war graves. Then they crossed the border to Bucholz, West Germany, to

honor a graveyard of SS troops there. The U.S. Army provided a military band, which played funeral music, and a chaplain who pronounced an invocation. The former enemies then attended a dinner-dance together in Bucholz, and the fratricidal war of 30 years ago no longer seemed to matter.

It is unfortunate that Hollywood chose to ignore this event and others that have shown compassion on both sides. But instead it insists on making movies like "Holocaust" that only instill more hatred in people, and then they have the nerve to insist we "never forget" when there are many who fought and want to be friends.

It really makes me wonder what kind of minds are making these pornography and hate films they are forcing on us these days. Maybe this "Begelman scandal" in Hollywood sheds some light on the kind of morals they have.

well-being of everybody concerned, including them, we thought it would be best if they would cease and desist...."

John Bacska, the first officer on the scene, agreed it was "a touchy situation with the legionnaires in town.

My biggest concern was, 'Let's not spread ourselves too thin.' There was a crowd forming out there, with much dislike for what's going on. For the public safety, I figured it was best

they be removed."

No charges were filed, Inspector Robert Wedyck said today, and it appears there is no ordinance that would have prohibited the Nazis' presence or their conduct here.

Assistant City Attorney Joseph Melendes was consulted Saturday, and he told police that a permit is not needed to sell newspapers on city streets, Wedyck said.

Dale Enders, a spokesman for the Nazis, was told his group was creating a public nuisance and it would be in their interest to leave, according to

Wedyck. "It wasn't very difficult to persuade them."

Sgt. Hemauer, a 19-year police veteran, said it was the first time he had seen Nazis in Waukesha. "They have their rights," he said.

Frank Czajkowski doesn't agree. The manager of Estberg Jewelers had watched as the Nazis hawked their papers in front of his store.

"I don't like it," he said. "Anybody who preaches racism or hate, I'm against. I have a strong feeling

against Nazis because I'm of Polish descent and I know what they did to the Poles and other people.

"Anybody who incites hatred is not a true American."

Doug Ranger, who manages The Waukeshop across the street, had more ambivalent feelings:

"I think it's a real test for Americans," he said. "Do we really have freedom of speech? I certainly don't agree with them. I think they're a bunch of animals. But as long as we

allow them to say what's on their minds, we have freedom of speech."

Mayor Joseph LaPorte said today, "I'm sure 99 per cent of the population would like to discriminate on a matter such as this....I don't think these kids today know what Naziism is."

LaPorte said he would ask Melendes to research the city's ordinances and see whether there is a legal way to keep the Nazis out of town.

"If we don't have, we will," LaPorte said. "I don't want 'em here."
