# FORGE THE REVOLUTIONARY HARD CORE !

The Ninth Party Congress was held in the Arlington area over the Labor Day weekend, 2 & 3 September.

Because the Ninth Congress dealt largely with matters which must by their very nature be kept strictly confidential, it was closed to all but Party members and a handful of Official Supporters who have proven their dedication to the Movement over the years. Likewise, much of what was discussed at the Congress cannot be disclosed here. We can, however, allow the readers of the NS BULLETIN to have a glimpse of some of the less-restricted highlights of this year's Congress.

## THE CONGRESS THEME

The theme of the Congress—*Forge the Revolutionary Hard Core!*—was the keynote for all that was accomplished. Over and over, it was stressed that the Party at this stage of its development must strive to embody a small but highly motivated group of capable individuals who are fanatically dedicated to seeing a National Socialist victory. As much as we might like it to be otherwise, we must rule out the support of the masses of White people at this time, as they neither understand nor want the National Socialist solutions to the problems which beset them. The time for the masses will come in the future— but it is not here now.

That is one reason why the Congress this year was markedly smaller than previous congresses. Only those who have proven themselves, again and again, were allowed to attend. Similarly, in keeping with the completely internal nature of the gathering, there was no public demonstration held in conjunction with the Congress.

## THE OPENING OF THE CONGRESS

While Party officers completed last minute Congress arrangements on the morning of 2 September, a hearty and delicious outdoor brunch was served to the delegates. The meal was prepared by members of the National Socialist Women's Organization.

Comrade Cedric Syrdahl, President of the Party's National Council, officially opened the Congress that afternoon at a meeting hall in Arlington. After his welcoming remarks, reports were given by local organizers describing the efforts made on behalf of the Party in their areas since the last Congress.

Among the areas reporting to the Congress delegates were Arlington (Comrade Fred Verduin), Southern California (Ivars Kugrens), Chicago (John Logan), Northern California (Robert Haake), Minneapolis (Steve Martinson), Milwaukee (Rick Rumpel), New Jersey (Eugene Palensar), Arizona (Dominic Lewitzke) and Baltimore (Al Sostrin).




### **Black March on Midwest Headquarters Fizzles**

As we reported in NS BULLETIN No. 245, a Black integrationist group calling itself the "Martin Luther King Movement" had announced plans to march on the Party's Midwest Regional Headquarters in Cicero on 16 September. At the last minute, the Blacks decided to cancel their march.

On hand to defend the headquarters in case the Blacks did decide to go ahead with their march was a Stormtroop contingent under the command of ST Chief of Staff Cedric Syrdahl, made up of ST men from Chicago Unit I, Chicago Unit II and Milwaukee Unit I.

Although the march never took place, the comrades used the occasion to raise the Swastika banner over the headquarters for the first time.

### **Marines Discharge Two Party Activists**

Two Party Marine activists, Dominic Lewitzke and Dale McKissick, were discharged from the Marine Corps in September after an interview they had given appeared in a local newspaper. The two National Socialists were stationed at the Marine Corps Air Station in Yuma, Arizona. The interview, which was published in the *Yuma Daily Sun*, dealt with basic NS ideology.

Comrade Lewitzke specifically criticized President Carter for his dealings with Menachem Begin, the terrorist prime minister of Israel.

Two days after the interview was printed, the Marine Corps announced that it was discharging the National Socialists for "substandard performance." They did not specify what exactly was "substandard" about the way that the two performed their assigned duties, other than to say that they were "openly advocating racial and social policies inconsistent with the performance of their proper military duty".

Which is another way of saying that the Marine Corps didn't feel that Comrades Lewitzke and McKissick would be politically reliable if the decision is made to send the Marines to die in the Middle East to protect the Jews.

### **Steve Lynch's Case Continued**

As was reported in NS BULLETIN No. 245, Comrade Steve Lynch, organizer for Chicago Unit II, was arrested on 13 August on charges which stemmed from a scuffle between some plainclothes ST men and Jewish Defense League members which took place on that date.

On 22 September, Comrade Lynch, accompanied by other Stormtroopers out of uniform, appeared in Cook County circuit court to stand trial on those charges. Because numerous threats of violence had been received, the ST men arrived at the courthouse prepared for a confrontation. Also called upon to stand trial that day were the three JDL members who were arrested at the same time as Comrade Lynch.

When the troopers entered the courtroom, they found it packed with JDL members, who had evidently expected Organizer Lynch to appear alone. When they saw the contingent of ST men accompanying Comrade Lynch, the fearless punks of Judah pleaded with the Cook County sheriffs for protection against the "Nazis"—whom they outnumbered two-to-one. The police complied, and the already jammed courtroom was packed with even more sheriff's deputies.

When Organizer Lynch was called before the judge, the Party's attorney asked that his case be separated from that of the JDLers because of the carnival-like atmosphere which the trial was assuming. The judge readily agreed, and a new trial date was fixed for 6 October. There were no incidents as the National Socialists left the courtroom.

## Nazis

### Racist group makes bid for political legitimacy here

Nazis, or at least the Nazis interested in making Yuma the model Nazi community, are in the midst of a new phase: a phase intended to pour their philosophies into a platform for a legitimate political party.

But while the phase may be new, the belief of white racial supremacy, the conviction of the "parasitic" nature of Jews and repulsion at the "pollution" of the white race by the non-white races is still the cement that binds the Nazi, or, formally, the National Socialist White People's Party.

Dominic Lewitzke, 27, and Dale McKissick, 29, both of MCAS, have started a "tooler" campaign in Yuma to attract new party members. Flyers scattered throughout Yuma, claiming "race-mixing" stunts and decrying the supposed role of Jews in the pornography business, have brought "light but encouraging" responses, Lewitzke said.

To boost that response, the budding Yuma Nazi Party's strategy is to appeal to a worry of Yumans that also conveniently falls in a niche in the Nazi book of causes: illegals.

"While the problem of illegals here is not as great as it is in other parts of the country, we want to draw people to the alien problem. Yuma is a conservative town, there's a fever here for this town."

"I feel we could do something here. Yuma could be a model town for us."

It was in fourth grade, while reading about Hitler that Lewitzke says he became aware of a "certain feeling" a feeling he said has struck every Nazi he has met. "Sometimes it was when they were small, sometimes it didn't happen until they were middle-aged."

He was attracted to Hitler, admired the way Hitler accomplished with the German people what he also became increasingly "repulsed" by the manner of non-whites. He is firmly convinced and claims there is irrefutable proof that the murder of six

million Jews by the Hitler regime was a "hoax." But regardless of whether the attempted extermination of Jews happened or not, "I just don't care," Lewitzke said.

Lewitzke, a short, slight man with apparently more to say than he ever has time for, describes himself as the product of a middle-class Catholic upbringing. His father was "not really a bigot," his mother "just a strict Catholic." He claims his fight for white racial supremacy has no roots in any personal feelings of inadequacy.

Though he tried to avoid derogatory expressions while speaking, some still sneaked out. The literature he left is filled with hate terms that have become almost synonymous with Nazism. Though outwardly controlled and rational, an expression of contempt, almost a sneer, flashed on his face whenever he discussed his "enemies."

"I've met blacks that I considered better than me, better in basketball for instance. And I may have met a couple of Mexicans I thought were smarter than me. But overall, the white race is obviously superior," Lewitzke said.

McKissick, secretary of the Yuma party, was all but mute throughout the interview.


"I've been in the Marine Corps," Lewitzke said. "I felt I was a patriotic young man, then in 1975, I heard about the Nazis. When the Nazis had their convention in Washington, D.C., I just jumped on a plane and went."

In Chicago, Lewitzke became a street activist, picketing pornography shops and Communist Party meetings. He was "swooped up" into the Marines when a friend enlisted.

When in high school, Lewitzke was considered the school's Nazi. He wore armbands and some Nazi regalia, an outward display he now scorns as fit only for Hollywood Nazis.

"If you saw a bunch of us in a room, and we weren't discussing politics, we'd look just like any group of young, Christian Americans," Lewitzke said.

Lewitzke said as he grew older "and smarter" he began to study the writings of George Lincoln Rockwell, the founder and longtime leader of the American Nazi Party.

"I began seeing the Jewish involvement in communism. The Jews on Wall Street push war so they can make money while whites kill whites. Jews disguise themselves behind religion when actually they are a parasite on the white race, sucking out our vitality and life. Jews are the number one enemy."

On the heels of Jews on the Nazis' list of enemies are all non-whites.

"Whites of northern European descent made America what it is today, and a Jew or a colored behind every social ill."

Standing up for the white race is a precept the Nazis, Lewitzke said, developed into a strong enough philosophy to form a political party "just like the Democrats and Republicans."

So far, as the recruitment of how many Nazis there are in Yuma, Lewitzke said, "I march down 34th Avenue. But that sort of thing is too strong a tactic."

"We're going to do a campaign for it at the border. We demand they close the border and we have a rally at the border demanding it be closed somehow," Lewitzke said.

In keeping with the goal of political respectability, the party rejects violence. Lewitzke said the original Nazi march in predominately Jewish Skokie, Ill., was masterminded by a man the Nazis now claim is of Jewish descent. The party has even offered a \$10,000 reward to anyone who can prove he is not Jewish.

Our party maintains that nothing would be accomplished by marching in Skokie. We march to recruit. We're not going to recruit too many in Skokie.

But the ultimate goal of Nazism is for an all-white America, a plan Lewitzke said is entirely feasible.

"All the colored would be repatriated back to their country of origin. The blacks, for instance, would be sent back to Africa where we'd help them set up a country. I don't think they could do it on their own — but after a couple of years, we would cut off aid. We would also cut off foreign aid to any communist or non-white country."

To expedite the irradiation of Jews and non-whites from the United States, Lewitzke said the death penalty would be imposed on convicted "murderers, rapists, kidnappers and traitors." By the Nazi definition of treason, President Carter could be convicted on the basis of his summit meeting this week with Israeli Prime Minister Menachem Begin.

"Quite a few Jews would be done away with this way," Lewitzke said.

The government under Nazism would be autocratic, a country led by a "strong, charismatic leader."

Lewitzke said Nazism is "kind of like Christianity. Hitler 'like a Christ'."


His motivation, he said, comes not from his hatred of Jews and non-whites, but from his "deep love for the white race." He can't understand people's interest in purebred dogs and their apparent lack of concern in "building a purebred race."

The whites' destiny has been wrenched "out of our hands."

Except for the Nazis' staunch stand on race and Jews, their creed — doing away with shackles on small businesses, returning farms to family operations and strong support of free enterprise — resembles that of any conservative.

"But we're different than conservatives who just sit around, drink beer and complain," Lewitzke said. "We're going to do something about it."

## 'Nazi' organizer is discharged here

Marine Dominic Lewitzke, who earlier this month announced his intention to turn Yuma into a "model Nazi community," returned to Yuma from leave Friday and Saturday was discharged from the Marine Corps, according to Maj. Gordon Pirtle.

Lewitzke and Dale McKissick were featured in a Sept. 4 story in The Sun and announced their intentions to form a Nazi party here.

McKissick was discharged Sept. 5. The two were kicked out of the Marines due to what MCAS said was "sub-standard personal performance" and "openly advocating racial and social policies inconsistent with the proper military duty."

Following the local reports, various Party auxiliary reports were given. NSW National Organizer Loretta Syrdahl gave the NSW report, ST Administrative Secretary John Logan gave the Stormtroop report, and National Socialist Youth Movement National Secretary Bruce Mathews gave the NSYM report. WHITE POWER editor Martin Kerr then explained why there have been some delays in recent months in the publication of the Party paper and bulletin. He went on to say that those difficulties should be cleared up by the first of the year. Comrade Kerr also noted that since the first issue of WHITE POWER was published by Lincoln Rockwell in 1967, over *one million* copies had been printed and distributed.

### COMMANDER'S STATE OF THE PARTY ADDRESS

After a short break, the Congress was re-convened to hear the Commander's yearly State of the Party Address. The Commander outlined the problems which have been hindering the development of the Movement in recent years, and gave his solutions as to how these problems may best be overcome. The Commander went on to say that the greatest difficulty the Party now faces is the lack of capable people who are willing to work full-time for the Party. Personnel are badly needed both at National Headquarters and at the Midwest Regional Headquarters in Chicago.


The Commander also gave an overview of the Party's accomplishments over the last year. Of particular note was the success of the Three-Year Plan, which raised over \$90,000 for Party building purposes. This is an accomplishment, the Commander said, that every National Socialist may take pride in.

### MEMBERSHIP ASSEMBLY


Following the State of the Party Address, Comrade Syrdahl gave a confidential talk which was restricted to Party members. Among other things, he told the members that they must personally be the driving force which animates the Party. The Commander can only do just so much by himself, he explained; the rest is up to us. If we truly wish to see a National Socialist victory, then we must rededicate ourselves to the ideals of Adolf Hitler, and redouble our efforts to make his Movement triumphant.

## THE SECOND DAY: GUNSTON HALL

Whereas the first day's sessions of the Congress were held in a local meeting hall in Arlington, the second day's sessions were held in historic Gunston Hall, also located in Northern Virginia. Gunston Hall is the manor of the great founding father of our country, George Mason. Mason was one of the leaders of the American Revolution in the South, and one of the signers of the Declaration of Independence. The site of the Congress thus dramatically reinforced the great spiritual link between the leaders of the American Revolution of 1776 and today's National Socialist revolutionary leaders.

### WORKSHOPS

The first event of the day was a series of workshops on the practical aspects of building the movement. The most notable of these was the workshop on propaganda, given by Comrade Kerr. Comrade Kerr explained the two main principles of propaganda as outlined in *Mein Kampf*, simplicity and repetition. He also told how those principles should be applied in presenting the Party as an acceptable alternative to today's Jewish-Liberal System.

He concluded by listing some propaganda campaigns the Party has planned for the upcoming year beginning with WHITE PRIDE DAY in November.

### SPECIAL ANNOUNCEMENTS

Following another delicious meal prepared for the delegates by the NSWO, a special session of the Congress was held in which the Commander made several announcements, which cannot be revealed here in detail. The most important result of these announcements was the raising of nearly \$30,000 in pledges to finance the purchase of 88 acres of land for a Party center in the Midwest. Also at this time, the Commander announced that NS Publications was being relocated to the Midwest Regional Headquarters. This centrally situated location will help NS Publications provide swifter and more efficient service to its customers, the Commander explained.

### CONCLUDING CEREMONIES

The Congress ended that night with the Commander's keynote address and spectacular National Socialist ceremonies. In the ceremonies, the Commander made special awards and presentations to those who have helped advance the Movement over the last year. In a special presentation, the Commander officially authorized the Minneapolis Probationary Unit as a full Party Unit, and Organizer Steve Martinson as Unit Leader. The Commander also designated the newly authorized unit the *Richard Biederman Unit*. Comrade Biederman was born and raised in Minnesota.




## Danish National Socialists Face Legal Charges

As was reported in full in WHITE POWER No. 87, Povl H. Riis-Knudsen was arrested on 12 September. Comrade Riis-Knudsen is the national leader of the Danish National Socialist Union, and the European Deputy for the World Union of National Socialists. He was charged with violating a paragraph of the Danish penal code which prohibits "insulting, threatening or debasing any group of people on the basis of their race, religion, color or ethnic origin." Arrested at the same time as Comrade Riis-Knudsen was Dr. Hans Christian Krog Pedersen, secretary of the DNSU.

As was noted in WHITE POWER, this case is not just a Danish affair, but a trial case for the legality of the Movement's operations in Europe. Contributions are vitally needed by the Danish comrades if they are to win this important case. Trial costs are expected to run \$10,000.

## Nazi Hopeful Arrested

MORRISTOWN — Thomas Vetere Jr., a probationary member of the National Socialist White People's Party, was arrested last night and charged with possession of a dangerous weapon.

The arrest took place on Early Street, where Vetere was observed distributing Nazi literature on porches of homes at 8:20 p.m. The weapon subsequently discovered was a 10½-inch knife with a six inch blade.

According to the police report filed by Sgt. Melvin Dumas, who made the arrest, Vetere was asked for identification and replied that he had a permit to distribute the literature.

As Vetere began checking his person for the permit and other identification papers, police observed him attempting to conceal something on the left side of his waist. Asked by police to lift his shirt, the handle of a large silver and black knife in a black holder came into view.

Vetere, 28, of 1 King Place, was then placed under arrest and taken to headquarters, where he told police that he was ordered to distribute literature and carried the knife for protection.

## New Jersey Activist Framed

New Jersey activist Thomas Vetere, who has been instrumental in the recent upsurge of NS activity in Morristown, N.J., was arrested on 16 September after he had been set upon by an anti-Party police lieutenant and a Black patrolman.

Comrade Vetere was arrested by the Black patrolman while distributing copies of WHITE POWER door-to-door. The patrolman stopped Comrade Vetere and asked to see his permit to distribute literature. Since such a permit is required in his town, Comrade Vetere had obtained one. After seeing the permit, the officer conducted an illegal search of Comrade Vetere and found a hunting knife. After spending the night in jail, he was bailed out by other local comrades. Comrade Vetere had earlier asked the police lieutenant if it was legal to carry such a knife. The lieutenant told him it was—which was false.

All activists should take note of this case. If you have any questions regarding the legality of any type of weapon in your state or city, you should research the matter thoroughly on your own, and not rely on the word of a police officer who may harbor anti-NS sentiments. Only if you are unable to find the information you seek in a public library or elsewhere, should you consult the police. Even then, this should be done in person (not by phone) in the presence of at least one impartial witness (such as a reporter). Furthermore, you should get the officer's name and badge number in case you need to identify him at a later date.

### Minneapolis Comrades Back White Prisoners

The Richard Biederman Unit conducted a "Support White Prisoners" demonstration outside of the Minnesota state prison at Stillwater on 23 September. ST men and NS youths carried an American flag and signs reading "Support White Prisoners!" Although the high stone walls prevented any of the incarcerated Whites from witnessing the demonstration themselves, numerous Whites driving to and from the prison to visit friends and relatives saw the National Socialists. The response from these Whites was almost 100 percent pro-Party, and some of them even stopped to talk with the Party organizers and take copies of WHITE POWER.

### Comrades Place Ads for Party

One of the chief ways which any company or political organization gets its message to the public is through advertising in the mass media. As the media is about 95 percent Jew-controlled and 100 percent anti-Party, this major avenue of solicitation has been closed to the Party throughout the years.

Now, however, a growing feeling of respect and toleration—if not acceptance—for the Party has made it possible to place ads on the Party's behalf in some publications. Over the past six months the Party has been advertising by placing classified ads in various national magazines. This has greatly increased the number of people writing to the Party for the first time.

Other comrades have placed display ads, either for the Party or for WHITE POWER, in local publications. Reproduced here are two ads which appeared in local papers in Minnesota and North Carolina.

## ACTIVITIES IN BRIEF

● Members of the Los Angeles Unit distributed *Boycott Busing!* leaflets at an anti-busing rally in Canoga Park, Calif., on 11 September. The newsmedia reported that the next day—which was the first day of school—the White absentee rate for the area was 65 percent.

● Activists of the Richard Biederman Unit in Minneapolis report distributing more copies of WHITE POWER during September than any other unit. Nearly 1,700 copies of WHITE POWER were distributed by the unit during the month. Additionally, Minneapolis NSYM activists handed out 175 leaflets in downtown Minneapolis on two separate occasions.
