Charges Dropped Against Steve Lynch!

A Cook County circuit court judge dismissed the charges which were pending against Chicago Unit II organizer Steve Lynch on 6 October. Comrade Lynch was arrested in August when he and other plainclothes ST men scuffled with some members of the Jewish Defense League (see *NS Bulletins* 245 and 246).

At the 6 October trial, the state's attorney admitted to the circuit court judge (who was Jewish) that his office did not have sufficient evidence to prosecute Comrade Lynch. The judge then had no choice but to formally drop the charges and order the case dismissed.

This was a significant legal victory for the Party. The Cook County sheriff (a Jew named Elrod) and the local Jewish community had exerted great pressure in an effort to force a conviction—but were unsuccessful. In contrast, the three JDL members who were arrested at the same time as Comrade Lynch were all found guilty of battery and mob action. They were given heavy fines and court supervised parole.

Nazi-protest mod Danmark

Utilfreds med fængsling i Århus

WASHINGTON (Politiken) — Amerikanske ny-nazisters demonstration foran det danske konsulat i Chicago har vakt en vis opsigt i den midt-vestlige amerikanske by. Men både på konsulatet og på den danske ambassade i Washington tager man 'affæren' meget aislappet.

Seks amerikanske ny-nazister i brunskjorter og skrædderhar afleveret en protestnote i forbindelse med fængslingen af to århusianske nazister, H. Riis Knudsen og Hans Chr. Krog Pedersen. Forinden havde ny-nazisterne arrangeret en mikroskopisk demonstration foran Chicago-konsulatet.

— Vi sidder på 20. etage, så vi var ikke klar over, hvad der foregik nede på gaden, siger

vicekonsulen i Chicago.

— Det hele foregik meget roligt. Det eneste, der undrer os er, at de lokale dagblade og radiostationer beskæftiger sig med en sådan sag. Men ny-nazisterne må jo have underrettet dem på forhånd, siger en talsmand for ambassaden i Washington.

Fordelingscentral

De amerikanske nynazister demonstrerede til fordel for lederne af Danmarks Nationalsocialistiske Ungdom, læge Hans Chr. Krog Pedersen og adjunkt H. Riis Knudsen. De blev begge anholdt for en måned siden i forbindelse med ransagningen af organisations forlag i Århus.

De fik begge lov til at gå efter knap to timers forhør og var hverken fængslet, mens de

ventede eller under sagen i øvrigt, siger politinspektør Jørgen Iversen, Århus.

DNSU's forlag og organisationen selv mistænkes for at være fordelingscentral for nazistisk propaganda i Nordeuropa, og anklagemyndigheden undersøger i øjeblikket, om der kan rejses tiltale for race-diskrimination og overtrædelse af postloven.

Konsulatet i Minneapolis modtog tidligere på måneden en tilsvarende protest fra National Socialist White People's Party, men den var affattet i en sådan form, at den landede i papirkurven.

Den nye protest er lidt mildere formuleret. Efter overvejelse vil det nu blive afgjort, om den skal samne vej, eller om den skal nævnes i et par linier hjem til Udenrigsministeriet i København.

Discrimination Against the Klans

Your editorial "The Klan in the Schools" (Oct. 20) is a typical example of the liberal anti-white bias so prevalent in the media these days. It seems to me that your objection to the activities of a particular Klan group in the area schools is not because it is a

Klan organization but because it is trying to organize whites, period. I would imagine that it would be a rare school or college which does not have a plethora of non-white student clubs and organizations, some of which are no

doubt funded by such groups as the NAACP or the Jewish B'nai B'rith.

Your generalized statements about "Klan violence" are in dire need of substantiation; which "Klan" do you refer to? There were and are now over 20 different Ku Klux Klan organizations in this country, none of which is in any way connected with any other! I am sure that those Klans (and their respective members) which have never engaged in this wanton violence you seem so up on would appreciate you not making libelous statements against them.

What your editorial is saying is that it is fine for any racial minority to form clubs in schools but not OK for whites. Since your editorial carried no byline, it is hard to know if its author was in public schools during the past 15 years of wonderful integration. Whoever you are, you need to pull your head out

from under all that liberal sand; it is not possible for any Klan group to "incite impressionable young whites to disrupt the racial harmony of the schools," since, as a matter of fact, there is no racial harmony!

Your editorial stands as a testament to the fact that it is possible for every ethnic herd in America to scream for and demand its "rights" and to organize racially exclusive clubs, fraternities and political organs, all with your approval, yet if white people attempt to do the same thing, you cry "Racism!" And you are right! It is racism; only when the minorities do it, you call it by some meaningless phrase like "civil rights" or "equal rights." I will say one thing for your editorial, however; it certainly gives us a clear example of what democracy means: minority rule!

Ex-Marines Continue Party Activism

Party comrades Dominic Lewitzke and Dale McKissick, the two Marines who were honorably discharged from the service because of their activism with the Party have continued that activism as civilians.

Party member Lewitzke has relocated to National Headquarters in Arlington, where he now serves as the Party's Corresponding Secretary. Comrade McKissick has joined Milwaukee Unit II, and is taking an active part in the unit's program of activities.

Marines boot Orlandoan after Nazi stand

Dale R. McKissick, a 20-year-old Marine lance corporal from Orlando, was discharged from the service one day after he and a fellow Marine announced plans to start an American Nazi Party recruiting drive in Yuma, Ariz.

The other Marine, Lance Cpl. Dominic G. Lewitzke, 19, of Cicero, Ill., will be discharged when he returns to the Yuma Marine Corps Air Station from Illinois, where he is currently on leave.

McKissick and Lewitzke were quoted Monday afternoon in the Yuma Daily Sun as saying they wanted to turn Yuma into a model Nazi community.

About 24 hours after the interview appeared, McKissick was given an honorable discharge and left the base, a Marine spokesman said. A friend in McKissick's barracks, Pvt. Michael D. Bargas, said McKissick had returned to Orlando.

McKissick's father, George L. McKissick Jr., 2912 Sanka Drive, said Thursday he has not heard from his son in more than a month.

He said his son attended Colonial High School where, as a B and C student, he was just "spinning his wheels, biding his time, waiting to graduate."

He said McKissick seemed to lack direction and had no plans before graduating from high school in June 1976.

The elder McKissick said he did not know his son had joined the American Nazi Party. As far as he knew, George McKissick said, his son held no political views whatsoever when he joined the Marines in January 1977.

"I don't know what he got into in the service or who he met up with," said McKissick's father.

McKissick and Lewitzke apparently met during a four-month stay at Fort Bliss, Texas, where both were stationed before their

transfer to the Yuma base in September 1977.

Lewitzke told the Yuma newspaper he became attracted to Adolf Hitler while in the fourth grade and admired Hitler for what he accomplished with the German economy.

Lewitzke said he was the leader of the Yuma American Nazi Party and McKissick identified himself as the party's secretary.

Before their discharge, McKissick and Lewitzke had been passing out flyers in Yuma that said, "Race mixing stinks."

The two Marines were trying to recruit community members for

the American Nazi Party by capitalizing on the problems Yuma has had with an influx of illegal Mexican aliens, the Yuma article said.

They had prepared other flyers urging a boycott of businesses that hire illegal aliens.

A Marine spokesman, Staff Sgt. Ralph E. Rose, said McKissick and Lewitzke were discharged because of "substandard personal performance."

"They weren't discharged because of membership in the (Nazi) organization, but because of their conduct," Rose said.

Minneapolis National Socialists Picket Carter and Mondale

Members of the Richard Biederman Unit, under the command of Unit Leader Steve Martinson, picketed President Jimmy Carter and Vice President Walter Mondale in Minneapolis on 21 October. Carter and Mondale were appearing at the Minneapolis auditorium. The National Socialists were picketing the pair to call attention to Carter's thinly disguised efforts to get the United States involved in an upcoming war in the Mideast.

Stormtroopers and members of the National Socialist Youth Movement participated in the activity, carrying signs such as "No More Jew Wars," "America Out of Israel," and "Dump Israel." Additionally, an extra-large sign with a Swastika encircled by the words "I Have Been Born Again!" was carried for the benefit of re-born Jimmy Carter.

Although there were also some 200 members of the Iranian Student Union protesting the "fascist Shah" a short distance from the NS demonstrators, there was no violence. The activity was blacked out in the local press, which is currently giving the Minneapolis comrades the "silent treatment."

North Carolina Organizer Gets Top-Grade Publicity

North Carolina Party organizer John Norman received top-grade news coverage for the Party on two separate occasions in October. An interview with Comrade Norman appeared in the *Greensboro Daily News* on 12 October, and an article written by him defending the rights of White racialists appeared in the *Winston-Salem Sentinel* on 30 October.

In the *Greensboro Daily News* interview Comrade Norman disabused the "hatemonger" image of the Party which the Jewish-controlled mass media has fed the public for the last 45 years. Concerning the military defeat of National Socialist Germany in 1945, he told the interviewer, "An army was defeated, not an idea."

In the article which appeared in the *Sentinel*, Comrade Norman defended the right of White racialists to organize in public schools. Previously, the paper had attacked the right of the Ku Klux Klan to recruit students at a local high school. The right of non-White groups to recruit was not criticized by the paper, however, and Comrade Norman used this opportunity to expose the general anti-White bias of the news media. The *Sentinel* was apparently so embarrassed by the accuracy of his charges that it printed Comrade Norman's article in an attempt to prove that it was not anti-White as he charged.

Car Salesman Wants Nazis On Local Election Ticket

REIDSVILLE — This small town in rural America is an unlikely spot for a unit of the Nazi Party to spring up — a place away from the strife and rebellion of the nation's tempestuous big cities. But if John Norman has his way, the white-supremacist organization will take roots here.

The Reidsville used car salesman doesn't hedge about his ideas for organizing a Rockingham County unit of the National Socialist White Peoples Party.

He already has opened a Nazi information outlet and says someday the organization may run candidates for local offices.

The National Socialist White Peoples Party won't have candidates on the ballot this November, but Norman claims he is trying to build an active political organization for future election years.

The NSWPP is headquartered in Arlington, Va. National party officials claim the group is the only direct descendant of the American Nazi Party founded in this country in 1959 by George Lincoln Rockwell.

There are 12 NSWPP organizations in the United States, according to Rick Cooper, business manager at national headquarters. Some of the 12 are information outlets and others are local units. Norman is directing the only official NSWPP information post in North Carolina.

Norman, 32, said he has been interested in national socialism since childhood

and claims he became a follower of Nazi principles upon reading "Mein Kampf" by Adolf Hitler as a teenager. Despite the meager support the Nazi party has received in this and other countries since World War II, Norman argues that the principles of the Third Reich did not die at the end of World War II. "An army was defeated, not an idea," he said.

Norman cites "political power" as the ultimate goal of the NSWPP. But he says the party will try to reach that goal through the "constitutional process" by electing its members into political office.

The pro-white organization is, he says, a logical outgrowth of recent political history. America's two major parties (Democratic and Republican) have become so similar that they have "cheated" the American people, according to Norman. He sees the development and rise to power of a third party as the natural solution to that situation.

Quiet and soft-spoken, Norman says a world run by national socialists would be a classless society (composed mainly of Protestants and Roman Catholics) where all white people are equal. To solve the racial and religious dilemmas created by the idea, Norman favors repatriating blacks to Africa and Jews to Israel by purchasing land especially for that purpose.

He says his party does not go in for violent or harassing tactics. According to Norman, NSWPP officials decry some of the methods used by other Nazi groups.

Norman, who said he also has been af-

filiated with the Ku Klux Klan, says organizations like his are misrepresented in the news media as "hate-mongers."

"It's not true," he declares. "The people I've come to meet are very decent, clean-cut people interested in their state and nation — basically, family people interested in children and the future of their country."

Right now Norman is the only official NSWPP supporter in the county. In an effort to change that, he is financing newspaper ads, a local telephone and a post-office box out of his own pocket. These expenses are in addition to the monthly party dues he pays. Norman sees them as part of his contribution to the work of NSWPP.

Working in his spare time, Norman now gets between five and six calls a night. He explains party principles and mails out leaflets and pamphlets when callers request them.

One thing he would like to do is to purchase a van equipped with swastikas and a public address system. And he would like to begin a "storm trooper" unit. He explained that storm troopers are auxiliary party groups whose members are not always official party members. The troopers wear uniforms, but they do not carry arms. Norman says they are responsible for marches, public demonstrations and protecting party property and members.

But his major goal is building a local group with "good, hard-core, fanatical" members, he said.

ACTIVITIES IN BRIEF

- Members of the Maine Unit report distributing more *WHITE POWERS* during October than any other unit. Some 1,880 papers were distributed by the Maine comrades during the month.
- Milwaukee Unit I conducted two uniformed *WHITE POWER* distributions during October. Teams of uniformed Stormtroopers positioned themselves on busy street corners in downtown Milwaukee and handed out copies of the paper to interested passersby. Additionally, a door-to-door literature distribution was held by the unit on 28 October.
- Other units and areas which report conducting *WHITE POWER* distributions during October include Chicago, Massachusetts, Minneapolis, New Jersey, Orange County (Calif.), and San Diego.
- The Cleveland Unit reports having an especially active month. In addition to the two demonstrations held in support of our Danish comrades, the unit conducted three uniformed paper sales, and attended school board and city council meetings in uniform on four occasions. This last activity in particular has given the unit a modest amount of television, newspaper and radio coverage.
- Party Comrade Richard Lundburg, of Rockford, wrote a letter to the editor of the *Rockford Morning Star*, which was printed on 4 October. Comrade Lundburg blasted the Six Million Lie in his letter, and included the NHQ mailing address. As a result, several inquiries were received by NS Publications from White people who wished to know more about the Party's stand on the "Holocaust."
- Party Comrade Arthur Jones, of the Midwest Regional Headquarters, also had a letter to the editor of the *Cicero Life* published on 29 October. In his letter, Comrade Jones took to task a columnist for the paper who had somehow managed to connect a survey of the drinking habits of local students' parents with a revival of the "Hitler Youth" in the Berwyn school system.
- Members of the Richard Biederman Unit held a 24-hour fast on 16 October, in commemoration of the 11 Nuremberg Martyrs, who were brutally murdered on 16 October 1946 by the Marxists and their democratic allies.
- Minneapolis Party leader Steve Martinson, accompanied by another Party comrade paid a visit to the vice principal of North High School in that city. NSYM comrades who attend the school have been the victims of consistent harassment by the authorities there. Comrade Martinson informed the vice principal that if the harassment did not cease immediately, he would have uniformed Stormtroopers passing out literature in front of the racially tense school. To date, there has been no further harassment.
