Bloomington March Honors Birth of Lincoln Rockwell

The Party held its yearly march and wreath-laying ceremony in Bloomington, Ill., on 10 March. The activity pays homage to the Party's founder and first Commander, George Lincoln Rockwell, who was born in Bloomington on 9 March 1918.

The day's events began with a dramatic march through downtown Bloomington by a large contingent of ST men, led by Commander Koehl. The troopers carried signs reading "Rockwell Lives!" as well as a huge banner which read "Bloomington—Birthplace of George Lincoln Rockwell." The march led to the hospital where Commander Rockwell was born. Commander Koehl, assisted by an ST honor guard, laid a wreath at the front entrance to the hospital, in a simple but moving ceremony.

Upon returning to the Midwest Regional Headquarters in Cicero, the troopers warmed up briefly and then went off for another demonstration in downtown Chicago. Commander Koehl led the ST men in a march demanding "Human Rights for Rudolf Hess." An eight-foot tall picture of Comrade Hess was carried the entire length of the march. The activity, which was witnessed by hundreds of people, was completely blacked out by the Chicago area news media, which at present has banned all mention of the NSWPP and its activities.

The day's activities concluded with a meeting at the Cicero HQ. The secretary for Chicago Unit I reports the meeting was extremely well attended.

ST Men Attend Anti-Busing Rally

A team of uniformed ST men from the Los Angeles Unit attended a meeting of the kosher-conservative anti-busing group Bus Stop on 1 March. Also present at the meeting was Jewish California State Senator Allen Robbins. Robbins led an unsuccessful effort in the California senate last year to have public display of the Swastika declared illegal.

ST man William Walker gave this account of what happened at the meeting:

We entered with jackets covering our uniforms, went to the front row, sat down and waited for the proceedings to begin. Nobody knew who we were. The meeting began with the Pledge of Allegiance. At this time, we stood up and took off our jackets, and saluted NS-style through the pledge. The Jew Robbins almost fell off the stage when he saw us! After the initial shock he refused to look in our direction, despite the fact that we were sitting right in front of him.

The deputy district attorney was sitting next to Robbins. He had more guts, and attempted to stare us down, but finally gave up.

After the meeting we distributed a large number of papers and leaflets to the audience. Robbins didn't hang around to mingle with the crowd, but left somewhat early. Actually, there were only about 250 people at the meeting. Bus Stop has lost most of their former backing due to their empty promises.

Chicago Comrades Protest 'Anne Frank' Hoax

Comrades from the Midwest Regional Headquarters in Cicero joined with local comrades in Elk Grove, Ill., to protest a high school production of the play *The Diary of Anne Frank*. The comrades handed out specially-produced leaflets exposing the supposedly "true-life drama" as a fraud.

The National Socialist protest was received warmly by those attending the student production of the play.

The play the National Socialists were protesting is based upon a book entitled *The Diary of Anne Frank*. The so-called "diary" purports to be a document actually written by a young Dutch Jewess, Anne Frank, while in hiding with her family from the awful "Nazis." Eventually, or so the story goes, the Frank family was discovered, and young Anne was shipped off to an "extermination camp" where she was "gassed."

The true story is somewhat different: like thousands of other European Jews, the Franks were interned during the Second World War for security purposes. At some point during their internment, Anne Frank died—most likely from typhus. In any event, after the war, her father had the simple little diary she kept re-written by Meyer Levin, a professional Jewish novelist. Levin took the account of the young Jewess and turned it into a masterpiece of tear-jerking Jewish propaganda, designed especially to arouse pro-Jewish sentiments in women and youngsters.

The Diary of Anne Frank is a classic example of the Jewish "Big Lie" technique, and specifically its application to the "Holocaust" hoax.

National Socialists protest 'Anne Frank' play

In protest of what Mr. Arthur Jones called "A classic example of the Jewish propaganda machine in action," he and two other members of the National Socialist White People's Party distributed literature at the February 22 EGHS production of *The Diary of Anne Frank*.

Mr. Jones, Mr. Frank Clemente and Mr. James Clendennen were dressed in "White Power" wind-breakers and Swastika armbands and stood outside the front entrance, but did not enter the building.

On February 21, Mr. Jones contacted Mr. Donald Fyfe, principal, and expressed an interest in attending the play which is a story dealing with the persecution of Jews during World

War II. Mr. Fyfe was advised by District 214 attorneys that the organization had every right to come on the property, and he said that "They could come to the play, but they could not disrupt it."

One of the main claims of the party, which was founded in 1959 and stretches all over the country, is that the World War II holocaust never actually took place. Mr. Jones called it "A psychological weapon of intimidation" that has been used to extort \$23 billion from West Germany. If not for the payments, Mr. Jones said that "Israel would have fallen apart a long time ago."

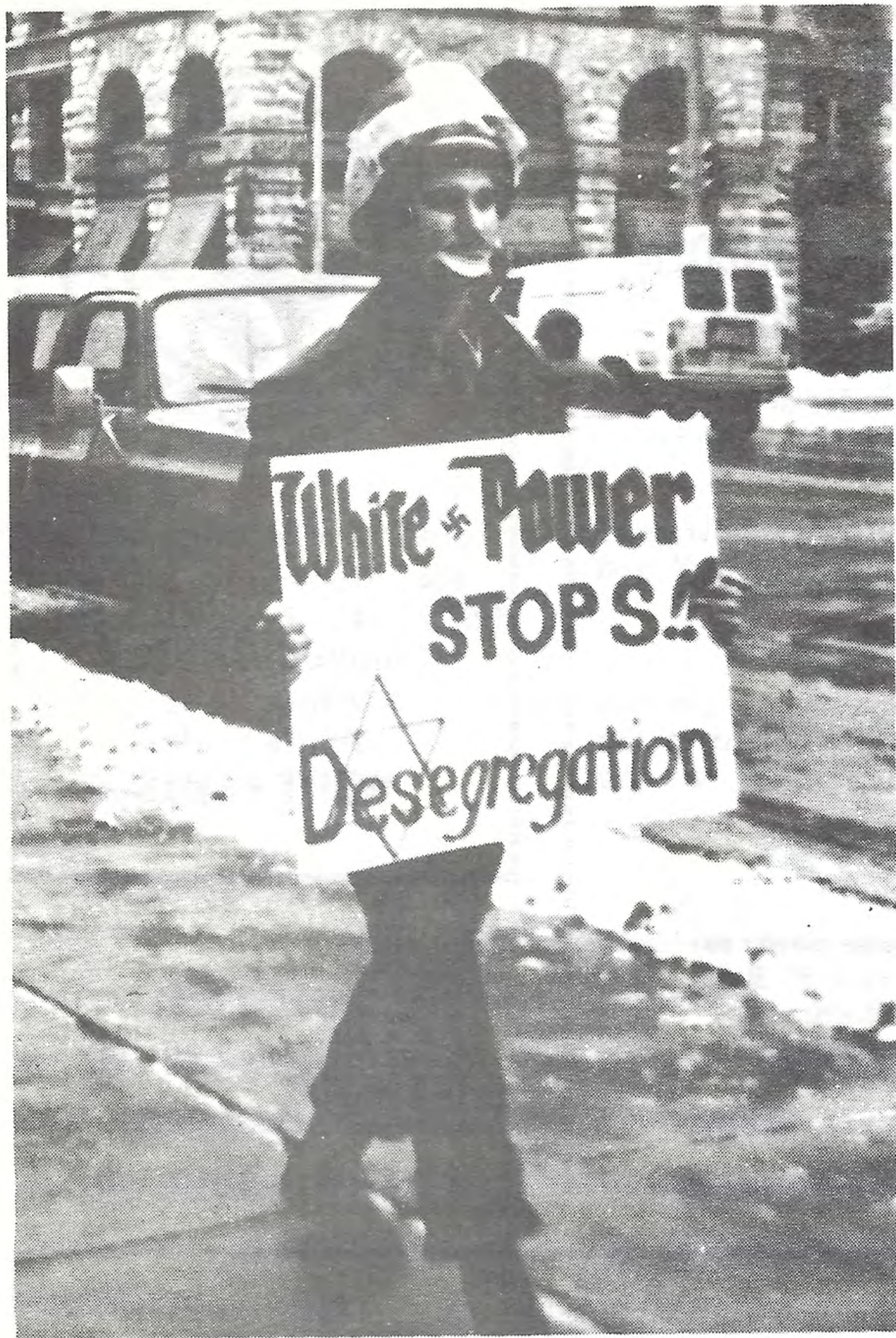
The controversy involving *The Diary of Anne Frank* is that the National Socialists claim that the

dialogue was actually written by American Jewish novelist Meyer Levin. The claim is supported by a New York Supreme Court decision that led to the payment of \$50,000 to Mr. Levin by Anne Frank's father, Mr. Otto Frank. Though the authenticity of the diary is not known, the party claims that most of the people who died in the German concentration camps suffered from typhoid fever contracted after the camps went into Allied hands. They were without food and other necessities due to war destruction.

Mr. Jones, who himself ran in the Milwaukee, Wis. mayoral race in 1976, sees a tremendous growth in the party which "in ten years could conceivably be in power." He cited

the "Two party—Jew party system" of politics, the Jewish created drug and rock music craze and the undermining of Christianity as some of the reasons for the decline of the American society.

The group is labeled as "Pro-American," "Pro-Christian" and "Pro-white." With the National Socialists control, Mr. Jones sees a country where "schools really prepare students for the future," the elderly would be respected, there would be a regulated form of media and a freedom of religion. There would be no blacks or other minorities and the role of the woman would be "To stay home and raise the kids."

Resident Arrested On Assault Count

After allegedly beating his neighbor with a piece of rubber hose, a 29-year-old Oroville man was taken into custody last night.

Joseph M. Tomlinson, 4199 Oro Dam Blvd., No. 1, was booked at the Butte County Jail on a charge of assault with a deadly weapon.

According to the victim of the assault, Perry B. Warthan, the beating was unprovoked.

Warthan went to Tomlinson's apartment at 8:40 p.m. He said Tomlinson opened the door and

attacked him, beating him with his fist and kicking him and using the rubber hose on him.

Warthan reportedly retreated to his apartment and was followed by Tomlinson. The alleged assailant then pounded on the door and threatened to "tear Warthan's head off," it was reported.

Deputy Dennis Brewer, who along with two other sheriff's officers responded to the report of a fight in progress, said the beating was probably the result of an earlier incident.

Milwaukee Activists Protest Forced Busing

A joint action by ST men and the National Socialist Women's Organization took place on 26 March. The scene of the activity was the Federal Building in downtown Milwaukee, where a public hearing was taking place on a proposal to forcibly integrate area schools by busing White schoolchildren into predominantly Black schools and Black schoolchildren into White schools.

While the ST men picketed outside in opposition to this scheme, NSWO organizer Sandra Ostvatic addressed the hearing, giving the reasons for the Party's anti-busing stand. There were no incidents.

Special Notice

Party Activist Attacked

Party activist Red Warthan was attacked by an anti-National Socialist White creep on 3 March. The creep, Joseph M. Tomlinson (see article for address), assaulted Comrade Warthan without provocation, beating and kicking him after first knocking him down with a length of hose. Tomlinson later told police that he attacked Comrade Warthan because he was a "Nazi." Tomlinson was arrested by the police and charged with assault with a deadly weapon. Comrade Warthan reports that he was not seriously injured, and that the attack will in no way deter him from continuing his activities on behalf of the Party.

National Socialist GI Writes

National Headquarters recently received an activity report from an Official Supporter who is stationed with the U.S. occupation forces in West Germany. His activities are typical of those of Party supporters serving with the armed forces abroad:

I have spoken with my company commander about the severe problem of anti-White hostilities in my unit, and throughout the entire U.S. Army. I pointed out to him that the Army ignores anti-White actions but makes a big deal of "White racism."

I have gone all over this city (Darmstadt) tearing down Red propaganda and putting up NS stickers, mainly "Free Rudolf Hess!" and "We Are Back!" I have also put up stickers in Heidelberg and Frankfurt. In addition, I have pasted up "Free Hess" leaflets and left them in various public places.

I've made contact with [European WUNS deputy] Povl H. Riis-Knudsen and plan to visit him in the near future. He has expressed gratitude for the actions the Party has taken on his behalf.

NS High School Student Spreads National Socialism

The following is the March activity report of Comrade CC, a high school student in Phoenix, Ariz.:

During the past few months I have been very busy on behalf of the Party in regard to the alleged "holocaust." I have written and turned in a 62-page report on the "holocaust," proving that it was a huge Zionist-Communist lie. The teacher of the class (on the history of World War II) is very pleased with me. I often act as an "NS conscience" for the class, dispelling Jewish lies about our great and immortal leader, Adolf Hitler.

I have been threatened by local yids, but the Jews don't scare me.

The local chapter of the Anti-Defamation League of B'nai B'rith is sending a rabbi to speak to the class, and I expect to have quite a confrontation with him. After the Jew has lied to the class, I have been granted permission to present to the class a counter view, and I also plan to give a slide presentation to the class...

Ex-Stocktonian a Nazi Official in Virginia

Rickey E. Cooper, 32, calls himself a "racial idealist."

He is a Nazi. Unmarried. Teetotaler. Nonsmoker. He works 12 hours a day, six days a week, for the National Socialist White People's Party at its Arlington, Va., headquarters as business manager.

"It isn't toil or labor," he says.

On the seventh day he sleeps in late; then — if the weather is good — he goes running, a hobby he has maintained since his days on the cross country track team at Lincoln High School in Stockton during the early 1960s.

"If you go into seven days per week (working), you risk your psychological self," he explains.

He is pleasant. Articulate. Former teachers and employers who remember him often recall liking him. But some do not want their names linked with his — a Nazi, Jew-hating racist, racial "idealist" or otherwise.

He was born in Stockton. What he calls his "upper-middle class" family still lives here. Cooper does not involve them in his politics. Not all his relatives agree with him, he says.

Cooper was graduated from Lincoln High School in 1964. He entered the Air Force, and served in Viet-

nam.

That, he contends, is when Rickey Cooper became a racist.

"We have a saying, once a Nazi, always a Nazi. Nazis can't be brainwashed. Their convictions are so strong, they don't sell out."

"You reach a point in your maturity where you discard what you decide is not true — like the Easter Bunny and Santa Claus."

He disagreed with things he saw: with United States aid to foreign countries, and with welfare.

"Not only do parasites in this country receive something they don't work for," he says, "but in other countries they don't appreciate our aid."

He returned to Stockton and earned his associate in arts degree at Delta College, then went to Fresno State and received a bachelor's degree in mathematics.

While at Fresno in 1971, he journeyed to Los Angeles to attend a meeting of the National States Rights Party ("what we call the 'sneaky Nazis'," he says). He ended up at a NSWPP meeting with a man he met.

He realized, he says, that he knew more than many of those at the meeting. He had already been reading Adolf Hitler's "Mein Kampf."

"I'm a racial idealist," he says. "White racial idealism is not based

on hate."

He also realized, he says, that he "matured faster than most people."

"I found out most people don't think," he says. "The masses of people live by blind faith."

Then in 1972 he mailed his first \$5 to the party and became an "official supporter," receiving the party's White Power newspaper, NS (National Socialist) Bulletin and an identification card.

Upon graduating at Fresno in 1973, he returned to Stockton — and joined the Tracy unit in its activities.

The unit leader was Paul Raymond. His brother, Wayne Frank Raymond, was a party member then (now in Idaho, Cooper thinks) and owned a 1952 GMC flatbed truck that the group of seven or eight used in demonstrations.

During this time, Cooper initiated phone numbers offering taped messages in Fresno, Stockton and Tracy.

On July 1, 1973, he wore his first uniform, and, with seven others, went to Los Angeles to demonstrate against the inauguration of Mayor Tom Bradley, a black.

On Jan. 8, 1974, the group went to San Francisco to a school board meeting on integrating the city's schools. A fight began and, Cooper says proudly, his picture ended up on the front page of the San Francisco

Examiner.

"I was the one who threw the first punch," he remembers. "That was because some guy grabbed me from behind, so I stood up and socked this Jew guy in the face."

During this time, he worked quietly as a bartender at the Rare Steer and Pete's Place in Stockton. In March, 1974, he went to work for Stockton State Hospital in the medical records division as a clerk-typist II. He stayed there until August, 1978, except for six months between January and July, 1976, when he was in Sacramento supervising four employees in the billing unit of the state's Division of Substance Abuse.

Just before the end of his six-month probationary period, his party affiliation was discovered. He did not receive permanent assignment and returned to his old job at Stockton State Hospital.

He received a letter of recommendation from his former supervisor, Carl Dahl, describing Cooper while he was in Sacramento as a "diligent, industrious and a hardworking young man, who put in many extra hours of work on his own time in order to learn the job."

When Matt Koehl called Cooper in August to come to the national headquarters, he was ready. He has never looked back, he says.

ACTIVITIES IN BRIEF

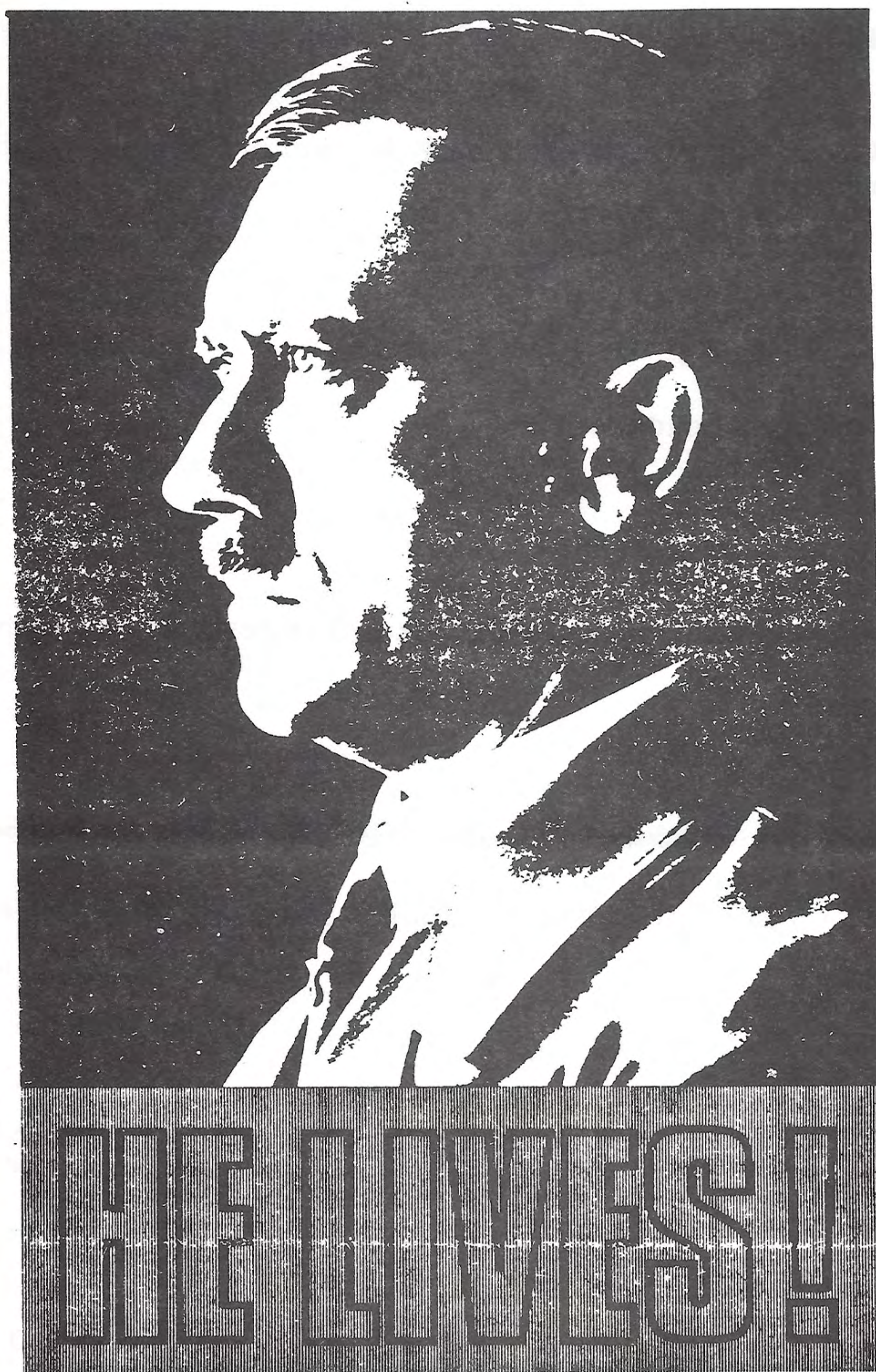
- Two uniformed paper sales were held by the Richard Biederman Unit in Minneapolis during March, which raised over \$16.00 for the unit treasury and put 47 copies of WHITE POWER into the hands of interested Whites. A paper sale was also held in the Marquette Park section of Chicago on 31 March.
- Chicago Unit I reports distributing the greatest number of copies of WHITE POWER during March. Organized distributions were also held by local units in Milwaukee, Minneapolis and North Carolina.
- Other distributions were carried out by comrades not connected with any local unit. Distributions of this sort reported in March included 377 WHITE POWERS distributed door-to-door by two comrades stationed at McGuire Air Force Base in Southern New Jersey, 200 papers distributed by activists in Michigan and 50 leaflets distributed by a woman comrade in Danville, Va.
- WHITE POWER editor Martin Kerr spoke to a class of high school students in Alexandria, Va., on the Party and its beliefs on 14 March. Copies of the Party newspaper were distributed to each student at the conclusion of the class.
- Comrade RM gave an interview to *Better Times*, published in Terre Haute, Ind., on 26 March, on the Party's view of the "holocaust" myth. Also appearing in the paper was the "touching, true-life" story of a Jewess who "narrowly escaped" being gassed in Auschwitz. Comrade M's interview is reproduced here in part.

Nazism at Home: Local Nazi Speaks

B.T.: What do you think about the Germans reaction to Holocaust?

NAZI: The German people have a right to be mad. It's all a damn lie! Germans are being accused of crimes that I know

Germans are not capable of doing. I know many Germans and they are fine decent people, not murders.

There is no real proof that the holocaust ever took place. All the death camps were in Poland or Russia. At the Nuremberg trials all the information we had came from the damn Soviets. The West didn't

see the death camps until 1954. The Soviets had plenty of time to construct them.

Germany had concentration camps much like the U.S. had on the east coast for the Japanese. Concentration camps for those we didn't trust. Few died in concentration camps. Death camps yes, but those were Soviet controlled not German.

Check the records after the war. Germany never did control an area that contained six million Jews. Less than one million Jews died from all reasons, like battlefield deaths and the like.

The Holocaust is just a Jewish hustle, to get payments from the German government and to hold the worlds sympathy. Israel was established on "blood money".

I know a Jewish guy that received money for his mother's death. She died in the 1950's supposedly from war time emotional anguish. The guy thought it was funny to be getting the money.

In the last few years several European historians have published books punching holes in the holocaust stories. A French historian, Paul Rassinier, was in Buchenwald and says it was not a death camp as claimed.

Young Germans have a right to be angry about the lies they've been told about their fathers. I'm surprised there wasn't more anger and outrage. It's just apart of the Jews "Big Lie."

B.T.: Why do you feel that National Socialism would appeal to the American voters?

NAZI: Part of National Socialism's appeal to Americans is that it truly represents the working man. The trouble with America is that we've never had a viable alternative political movement. Look, Illinois Senator Adali Stevenson III has said he believes that the U.S. may need a third party to really represent the average citizen.

We've had the Grange Party, the Progressive Party, the Socialists but they've become too narrow in their beliefs, too narrow in political base, and they've failed.

We believe the state, the government is an organism. We are against the working class struggle with management. Under capitalism, unions squeeze management and management squeezes the unions. It's wasteful, it's inefficient, it doesn't make sense. In America workers and owners are not allies. We want the worker protected. Our government protects selected big unions and big corporations. Most unions are corrupt and so are most corporations and they corrupt the government.

In Nazi Germany unions were organized into the Labor Front and the Labor Front was apart of the government. It was in on all government decisions. The sources of capital (land, factories, etc.) were controlled by the government and the Labor Front as a part of the government. It's an efficient way to run things.

B.T.: How do you see the welfare system?

NAZI: A hell of alot of the welfare problem is minority groups and old people without social security. Negroes, the Hispanic and other non-white groups will be repatriated to their own countries. There's plenty of room in Mexico for Mexicans and in Africa for Negroes. Over here they take our jobs, if they work, or overload our welfare system if they don't. If it's necessary we'll give them a part of America for their own. But we won't be as hard on minorities as the Israelis are on the Arabs.

The fact is that most Negroes or Latins can't cope with living in a modern society.

Unions and management have a similar problem. Unions have to accept minorities. Management now has job quotas for the number of non-whites they must hire.

Many people on welfare are old workers with little or no company pensions. National Socialism will have guaranteed pensions for all workers. It angers me that older people never have enough to live on.

Non-employed mothers will get a pension. The most important thing one generation does for another is to raise them well. You must have a good home life for a good society.

B.T.: That sounds like racism to us.

NAZI: In the working situations I've been in, the whites all consider the Negroes to be inferior and many whites are anti-Jewish. White people speaking privately, talk about how bad Negroes and Jews are. National Socialists just say it out loud. National Socialists have always been up front about their true feelings. No other political parties are.

Racism is a bad word when it's applied to whites. But when Jessie Jackson says "Blacks must stick together," its fine. We want whites to be proud of being white, to be unified as whites. Whites let others pick them apart. National Socialism wants to stop it.

Blacks and Jews have a tremendous sense of unity. U.S. Jews are allied with Jews everywhere in the world.

Whites should be too. Whites be proud! We are the leaders of America, we are the workers of America.

Everything in America that is worthwhile, good and beautiful is a creation of the white race.

Victory Certificates

In order to finance the purchase of 88 acres of land in the Midwest to house a permanent Party congress site, the Party has asked its members, supporters and sympathizers to obtain specially-issued Victory Certificates. The cost of each certificate is \$888.
