The appearance of Young in St. Paul Thursday was protested by three local Nazi Party members, who stood across the street from the museum and held up a banner proclaiming that the ambassador is "anti-white."

Three St. Paul Police squad cars were called to the scene and officers watched warily as the protesters, dressed in full Nazi uniform and helmets, stood peaceably with their banner.

The protesters appeared about 7 p.m. as Young was inside speaking before the DFL Feminist Caucus. As he left the museum and saw them, he said he wished they had come inside so he could talk to them.

"I'M SORRY THEY didn't come in and I didn't have time to talk to them," he said. "I'm sorry they have those opinions but I respect their right to have those convictions and those opinions."

He said the last time he had seen Nazi protesters was when President Carter, then the Georgia governor, put up a picture of Martin Luther King inside the state Capitol.

The three protesters identified themselves as Michael Rumble, 23, of Minneapolis; Arne Hesson, 28, of Minneapolis; and Mark Conway, 16, of Minneapolis.

"We don't hear (Young) talking about whites in Rhodesia," said Rumble, explaining the reason for the protest.

Rumble said the organization, which he called the National Socialist White People's Party, has been organizing a St. Paul chapter for the past three months. He refused to say how many members are in the chapter.

New Party Unit Blasts Andrew Young

The rapid growth experienced by the Richard Biederman Unit in Minneapolis has led to the formation of a second unit in the Twin Cities area. The new unit is based in St. Paul, Minn.

The first activity of the unit brought major newsmedia coverage for the Party on 31 May. Three uniformed National Socialists protested the appearance of Andrew Young, the Black ambassador to the United Nations appointed by Jimmy Carter. Young was in St. Paul to receive a "Human Rights" award. He is well-known for his hatred of White people in general, and especially the Whites in the southern portion of Africa.

Thus it was only fitting that he should be greeted by National Socialists carrying a banner 12 feet long and three feet high, mounted on eight-foot two-by-fours, which read "YOUNG IS ANTI-WHITE!"

Young emerged briefly from the meeting hall he was speaking in to observe the National Socialists. A plainclothes comrade who was standing near Young while he watched the demonstration reports that he muttered to his companions "I ain't anti-White, I ain't anti-White." But then, his public words and actions speak for themselves.

Young later told reporters that he would have welcomed an opportunity to speak to the National Socialists personally, but he somehow never managed to convey this message to the demonstrating comrades.

The demonstration received major news coverage, including a picture in the *St. Paul Pioneer Press*, which included the unit's address.

Los Angeles National Socialists Hold Anti-Zionist Picket

Los Angeles Unit Leader Dan Stewart led a picket of L.A. and Orange County unit comrades at the Federal Building in East Los Angeles on 26 May. The National Socialists were demanding an end to U.S. aid to Israel. The operation attracted the attention of the Los Angeles Police, L.A. County Sheriffs, the California Highway Patrol and Federal Marshals.

A crowd of some forty to fifty individuals, many of whom were hostile, gathered to watch the demonstration. As the troopers were leaving, some of the punks in the crowd attacked the ST column from behind. Orange County Unit Secretary Orwin Zuiderweg gave this account of the fight:

"About 3:00 p.m. UL Dan Stewart notified the L.A. County Sheriffs that we were going to leave. This seems to have started things going. Two creeps attacked TL Gregg Hummer, hitting him in the jaw and trying to rip off his armband. TL Hummer punched the creep who hit him in the mouth twice in the stomach, and the other creep scurried off. TL Rick Harp was engaged in a shoving match with another attacker who kicked him in the leg, but he managed to stay in formation anyway. Two other creeps were tear-gassed when they attempted to assault the column, and Comrade Richard Bloomquist had a creep who attacked him from behind arrested."

Comrade Zuiderweg reports that all of the comrades attending the activity found it enjoyable and rewarding.

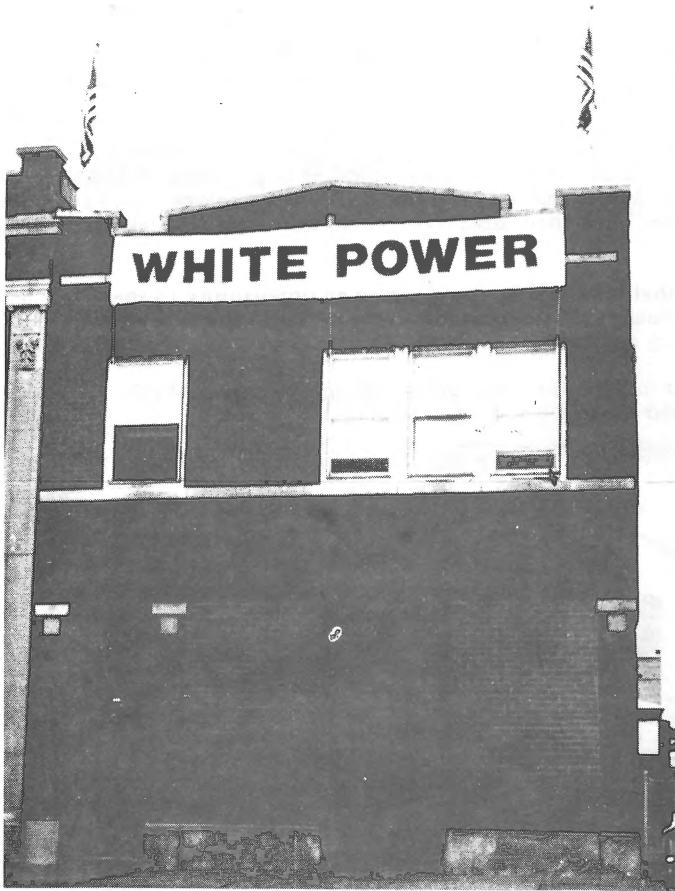
ST Men Defend Midwest Headquarters

Five ST men defended the Midwest Regional Headquarters in Cicero from damage on 26 May, when 25 members of a street gang attempted to attack the building. The gang members had been attending a nearby wedding reception and had been drinking heavily when they first approached the headquarters. When they inadvertently set off one of the security alarms to the building, five ST men went outside to investigate, and discovered the gang members.

At first the National Socialists engaged the gang members in friendly conversation, but a couple of the gang members were extremely hostile to the Party and soon provoked an incident. When they tried to climb over the front fence to the headquarters, the senior duty officer ordered that the area in front of the building be cleared of the assailants. This was quickly done.

Almost immediately, the gang members returned with reinforcements. Armed only with nightsticks, the five ST men defended themselves against some 25 attackers, armed with tire irons, jack handles, beer bottles, belt buckles and baseball bats. The fight was broken up by the police, who had been summoned by White residents of the neighborhood friendly to the Party.

The police responded in a restrained and professional manner. One trooper received a head wound which required seven stitches, and all were bruised and battered. The gang, however, suffered even more casualties. There was no damage to the headquarters.

ACTIVITIES IN BRIEF

- Commander Koehl led a "Free Rudolf Hess!" vigil in Washington, D.C., on 12 May, marking the 38th anniversary of Hess' flight to Great Britain in his attempt to end war between that nation and Germany.
- NS Publications Manager Randy Shirk indicated in a special report to the Commander that the Party's mail-order department sold a total of 16,858 books and pamphlets during the five-year period March, 1974, through February, 1979.
- Door-to-door WHITE POWER distributions were reported by Chicago Unit I, Milwaukee Unit I and the Richard Biederman Unit during May. The comrades in Chicago and Minneapolis were tied for first place, distributing 800 papers each.
- Milwaukee Unit I also reports holding two uniformed WHITE POWER distributions on 19 May, in Milwaukee. There were no incidents.
- Two uniformed National Socialists distributed some 75 copies of WHITE POWER to interested White persons in Manchester, N.H., also on 19 May, according to area organizer Douglass Knight.
- A "Smash Black Crime!" demonstration was held outside of the Hennepin County Courthouse by the Richard Biederman Unit on 20 May, in response to a recent wave of anti-White atrocities committed by Blacks in that area.
- On 14 May, Comrade Art Jones of the Midwest Regional Headquarters represented the Party on The Warren Freiburg Show, broadcast over WLNK-Radio in Lansing, Mich. The Party received numerous inquiries from interested White people as a result of this show, which has a wide listenership in Chicago and Indiana, as well as Michigan.
- WHITE POWER Editor Martin Kerr spoke to a high school class in Darien, Conn., by way of a telephone hook-up on 15 May.
- During May L.A. Unit Leader Dan Stewart gave interviews to a reporter from Cypress College (on 14 May) and from California State University/Fullerton (18 May).

- Northern California comrades leafleted the cars parked outside of a hearing called to determine whether or not the Oroville Elementary School District is segregated, on 30 May. Some newsmedia coverage of the distribution was received.

No Segregation Found In Local Grade Schools

At a hearing held by Oroville Elementary School District trustees last night, it was determined none of the campuses in the district are segregated.

The hearing and subsequent findings are part of a mandated process. The board set a quota of 25 percent as a basis for segregation in the schools.

Jim Hill, board president, said Wyandotte Avenue School has the highest quotient with 19 percent minority students. With the possible closure of Eastside School because of a lack in attendance, Wyandotte's percentage of minorities may be reduced by an influx of white students.

About eight adults and 11 students attended last night's hearing and did not voice objections to the school district's policy regarding the segregation quotient, Hill said.

Following the meeting, those in attendance were dismayed to find National Socialist White People's Party literature on the windshields of their cars. The anti-black literature is apparently disseminated through the party's nearest local office in the San Joaquin Valley town of Tracy.

Oroville police received several calls from persons who attended the meeting and expressed concerns about future repercussions related to the people's party. The incident is under investigation.

Letters to the Editor

One of the most effective (and the least expensive!) ways to spread our message to large numbers of concerned White people is by writing letters to the editors of newspapers and magazines. Most periodicals will print pro-National Socialist letters, provided they meet certain basic guidelines. They are as follows:

1. The letter should be typed (or neatly printed).
2. It should be double-spaced, and written on only one side of the paper.
3. It should be short: About one page in length is perfect; never exceed two pages.
4. It should deal with a single topic.
5. It should be free of any racial invective (such as "kike," "nigger," and so forth).
6. It should include a telephone number and an address where the editor can reach you in case there are any questions or problems. Anonymous letters are seldom printed, but you can always request that your real name and home address be withheld.
7. Make sure your letter is free of mistakes in spelling, grammar and punctuation.

A good way to write letters-to-the-editor is to take a short article (or a few paragraphs from a longer article) from **WHITE POWER** and put it into a letter format. Some comrades do this on a regular basis, with amazing results. Reproduced here is an article from "The News In Brief" page of a recent **WHITE POWER**, and the same article as it appeared in the *Oroville (Calif.) Mercury* as a letter-to-the-editor.

One final point: whenever possible, include the Party's mailing address in the body of the letter. Frequently the address will be censored, but sometimes it will be printed. This always results in a number of interested persons writing in for more information—and some of these people will join the Party.

The best way to include the address is to put it in a separate paragraph which appears in the middle or near the end of the letter (but never at the very end). It should read something like this:

"Anyone who doubts what I am saying can write to NS Publications, Box 50360, Cicero, Illinois 60650, for a copy of the true story on

or

"Anyone wishing further details about _____ may obtain them from the National Socialist White People's Party, Box 5505, Arlington, Virginia 22205."

Usually it takes a week to 10 days from the time a letter is mailed until the time it is printed, and occasionally it takes longer. Also, do not become discouraged if your first letter, or first several letters, are not printed. Keep at it, and eventually you will be successful.

ATTEMPT AT SWASTIKA BAN FIZZLES—A major Jewish pressure group failed in February to get toy manufacturers from voluntarily eliminating Swastika decals that come with plastic models of aircraft used by National Socialist Germany. The American Jewish Congress said it was trying to "safeguard" children from possible psychic damage that would result from owning models with Swastikas on them. Such damage would occur, the congress said, because the "Nazis" supposedly murdered six million Jews during the Second World War. The AJC did not, however, ask toy manufacturers to keep Communist symbols off of models of Russian airplanes, nor did they demand that no Jewish symbols be allowed on models of planes used by the Israelis—planes responsible for bombing civilian refugee camps and burning to death Arab women and children as recently as 1978.

ABOUT REWRITING OF HISTORY

Acting like big brother in Orwells 1984, the American Jewish Congress has gotten Mattel Inc. to remove Swastika symbols from historical model kits. The AJC says this is to "safeguard" children from possible psychic damage.

This damage would occur, they claim because the Nazis supposedly killed six million Jews during WW II.

The JDC, however, did not request Mattel to keep Communist symbols off of Russian and other Communist models. Nor did they demand the removal of Jewish symbols allowed on models of planes used by the nation of Israel — whose planes are responsible for the bombing of civilian refugee camps and the burning to death of Arab women and children as late as 1978.

The news of the Swastika removal order was received with joy by the Communists who printed the announcement in their latest issue of Challenge.
