CHARGES DROPPED AGAINST RIIS-KNUDSEN!

The charges brought against Povl H. Riis-Knudsen, World Union of National Socialists deputy for Europe and leader of the Movement in Denmark, were dropped in December. All of the materials which were seized from the WUNS office in Aarhus, Denmark, have been returned to our comrades there.

Comrade Riis-Knudsen and another Danish comrade were arrested on 12 September 1978 and charged with violating the infamous paragraph 266b of the Danish penal code, which in effect attempts to prohibit any criticism of non-Aryans. Among the materials seized at the time of the arrests were Martin Luther's booklet, *The Jews and Their Lies*, and another booklet containing excerpts from the *Talmud*, the grotesque and obscene book of Jewish religious law.

Party comrades throughout the U.S. waged a vigorous campaign to bring pressure on the Danish government to drop the spurious charges.

Wanted: One National Socialist Willing to Travel

Comrade Riis-Knudsen has indicated that with the legal charges against him dropped, he wishes to expand the Movement's operations in Europe. The one thing preventing us from doing this, however, is the lack of *one key person* to work at the Aarhus headquarters. Since the Movement has had difficulty in finding someone from Denmark to fill this position, Comrade Riis-Knudsen is willing to consider someone from outside his country, provided they meet the following qualifications:

Anyone applying for the job should have an excellent knowledge of the English language.

He should be willing to learn Danish, if he does not already speak that language.

He should preferably have a working knowledge of another language as well.

He should be willing to get his hands dirty.

He should be able to handle correspondence.

He will be expected to stay in Aarhus *at least one year*.

He should be able to qualify as a student for visa purposes.

Although the pay for this position is minimal, free living quarters will be provided, along with modest food arrangements.

Fall Building Campaign Final Total Announced

Nearly \$2,000 was received towards the 1979 Fall Building Campaign after the official deadline, making the campaign one of the most successful in Party history. Some \$1,995 was donated to the FBC during January. Added to the funds raised in November and December, this gives us a total of \$13,026.12—more than 30 percent *above* our \$10,000 goal!

The final tally showed that National Socialists in 37 states, the District of Columbia, three Canadian provinces and three foreign countries gave to the campaign.

In Arlington, Two-Year Plan Coordinator Martin Kerr said that the overwhelming success of the campaign would help insure the success of the Two-Year Plan. "This gives us a solid financial base to launch the Plan with," commented Comrade Kerr. "But beyond that," he added, "the raising of this much money in such a short period of time is an accomplishment every National Socialist can be proud of."

Party Policy

The 'Need-to-Know' Policy

The Party is a revolutionary organization, which ultimately aims to overthrow the present system which rules the North American continent. The fact that we have chosen legal, peaceful means to effect our revolution does not mean that we are any less revolutionary than groups which advocate the *violent* overthrow of the system.

It would be foolish for us to expect the System to sit back calmly and allow us to go about our job of preparing for a National Socialist revolution (whether peaceful and legal or not) without taking any measures to defend itself. Just as it is the function of revolutionaries to overthrow the System by any means necessary, it is the function of the System to maintain itself and its power at all costs. Even though we have chosen to wage our struggle peacefully and legally, we should not expect the System to limit its attacks against us in the same manner.

Thus we find a wide variety of governmental and non-governmental organizations which seek to disrupt, hinder and ultimately destroy the Party. In the past, we have experienced serious harassment, both of a quasi-legal and illegal nature, from the Federal Bureau of Investigation, the Anti-Defamation League of B'nai B'rith, and numerous local police forces—just to name a few who have used "dirty tricks" against the Movement. Additionally, numerous groups outside the System have waged war against us, for various ideological reasons. Some of these groups have been the Jewish Defence League, the Progressive Labor Party, and the Revolutionary Communist Party—just to name a few.

One of the chief methods used to harass and hinder Party operations is the use of informers, popularly known as "snitches," "agents," or "spies." Briefly, an informer is someone within the Party who passes on information to organizations who are hostile to the Party. Another type of "spy" within the Movement is the *agent provocateur*. Such agents do not merely collect and pass on information, they also try to stir up trouble. Some methods they use include the spreading of rumors designed to shake the faith of rank-and-file members and supporters in the Party leadership, encouraging members and supporters to commit illegal acts and generally causing dissension and disruption.

Besides the use of informers and agent provocateurs, the System also uses telephone taps and mail surveillance in order to gain information on the inner workings of the Movement.

Without the information supplied by infiltrators and electronic eavesdropping, our enemies would be virtually powerless to harass us except by using overtly violent means, which they are unwilling to use at this time, except in extraordinary instances (such as the assassination of Commander Rockwell).

Thus it is in the interests of the Movement to restrict the flow

of information on some Party matters. In general, the method we have employed to accomplish this has been the "need-to-know" policy. This means that certain Party information is kept confidentially. Such information is divulged only to those Party comrades who *need to know* this information in order to perform their duties.

Such information includes the number of persons who are Party Members or official supporters; details concerning Party income and expenses; the location of the Midwest Congress site (at this time); personal information on Party personnel (street addresses, telephone numbers, places of employment, information on relatives and so forth) and details on the Commander's personal schedule. Also, information concerning upcoming activities (such as demonstrations) is also very often classified as *need-to-know*.

The *need-to-know* policy extends from National Headquarters down to each individual Party comrade. All Party comrades are expected to follow this policy in their dealings both with other comrades and persons outside of the Movement. This applies especially—but not exclusively—to comrades active with local units.

Before you divulge any information to someone else, ask yourself these questions: Does this person *need to know* this information to perform his or her duties? If this information fell into the hands of Party enemies, could they somehow use it against us?

If someone needs to know the information in order to accomplish his assigned tasks, then by all means he should have it. If not, then he should not have it. Party activists should take special care in considering what they say over a telephone or in a letter. Remember, even if the person who you are communicating with is someone who needs to know, there may be persons listening whom you are not aware of. Whenever possible, transfer need-to-know information in person, and not by phone or mail.

Do not supply Party enemies with the information they seek in order to destroy us. Do not disclose classified information, and do not ask other comrades to supply you with classified information which you do not need. Certainly, no comrade should feel offended if security-sensitive information he does not need is withheld from him.

In a revolutionary organization such as ours, security is every comrade's business. This does not mean that we should let ourselves be paralyzed by needless paranoia. It means we should be careful. Don't use sensitive Party information as a topic for gossip. Think before you speak. Accept and practice the *need-to-know* policy, and encourage other comrades to do the same.

Party Filing to See FBI Files

The Party is currently in the process of applying to see the files which are kept on it by the Federal Bureau of Investigation. Under the Freedom of Information and Privacy Act, all U.S. citizens and organizations have the right to see any files which a federal, state or local government keeps on them. (There are, however, certain restrictions on what information the government is forced to give out under the FOIPA. For example, the government does not have to divulge information which would indicate the identity of an informant, nor information which would jeopardize "national security." The FBI, in particular, uses these two clauses to withhold a great deal of information which they feel would be damaging to them if it were made public.)

The files the Party is interested in seeing are the personal files on Commander Koehl and George Lincoln Rockwell, and the general file on the Party itself.

It will very likely ^{be} take between two and three years before these files are released. Once we have them, however, the Party may have the solid evidence it needs to bring suit against the FBI. We have known for years that the FBI, in conjunction with a certain notorious nationwide Jewish dirty-tricks outfit, has engaged in illegal activities to hinder the Party's growth and hamper its development. In fact, the FBI has obliquely admitted as much in court cases brought against it by other organizations.

In addition to being lengthy, retrieving these three FBI files will be very expensive. Each page the FBI releases will cost the Party \$.10 for photocopying. The FBI has estimated that it has in the vicinity of 2,500 pages—or \$250—on Commander Koehl alone. The total cost for all three files will easily run over \$1,000, and may run as high as \$2,000.

What You Can Do to Help

Comrades interested in assisting the Party in its fight to obtain the FBI files can donate money to help defray the cost of photocopying which the Party must pay.

Additionally, those comrades who have been active with the Party for a while may wish to obtain their personal FBI files. Information might be contained in them which could prove helpful when we are ready to prepare our legal case against the government.

You will need to include your full name and your exact date and place of birth. Also, you should have your signature to the letter notarized by a notary public, as this will be required of you at some point in your efforts to obtain your file.

Those comrades who apply to see their files should keep National Headquarters informed of their progress.

Where There's a Will There's a Way

One sure sign of an idealist is that he (or she) fights for something that may not come to pass in his lifetime. The concern about the future of the Aryan race—both the distant future and the immediate future—is the hallmark of the National Socialist as a racial idealist.

One way every National Socialist can continue to keep fighting for his race after his physical death is to remember the Party in his or her will. In the past, the Party has benefitted from thoughtful comrades who remembered the Party in this manner. In addition to monetary bequests, and bequests of real estate and other valuable items, some comrades may wish to bequeath their personal libraries or collection of NS mementos.

New Zealand National Socialist Loses Appeal

The New Zealand Court of Appeals has upheld the November, 1979, conviction of New Zealand National Socialist leader Colin King-Ansell. In a case similar to that of Comrade Riis-Knudsen in Denmark, Comrade King-Ansell was charged with "publishing a pamphlet likely to incite ill-will against Jews on the grounds of their ethnic origins."

Comrade King-Ansell, national leader of the National Socialist Party of New Zealand, published and distributed a leaflet with quotations on it from the New Testament which New Zealand Jews claimed they found "offensive". Under the repressive, anti-White "Race Relations Act" passed by the New Zealand parliament, offending Jews in this manner is a criminal offense.

Also as in the case of Comrade Riis-Knudsen, American National Socialists demonstrated in protest of the persecution of the Movement in New Zealand.

Staff Personnel Shortage Affecting Party Operations

By now all comrades should have noticed that Party publications (including the NS BULLETIN) have been coming out late. This is just one of the detrimental side effects of the chronic personnel shortage that has plagued the Party over the last two years. Commander Koehl has stated that the lack of qualified National Socialists willing to devote their full time to advancing our Cause has been and remains the most serious obstacle in the Movement's path.

Unlike other businesses, the Party cannot simply hire people off the street. Those persons who work full time or part time for the Party must have a high degree of commitment to the Movement and a good working knowledge of National Socialism. Beyond that they must possess certain basic skills which the Party is in need of, in particular (but not exclusively) office skills.

Party members, and to a lesser degree probationary Party members, are expected to have that high degree of commitment and the good working knowledge of National Socialism mentioned above. Every Party member should be willing to relocate to either the National Headquarters area or the Midwest Regional Headquarters area to work full or part time for the Movement if called upon to do so by the Commander.

The Commander has indicated that as one of the Two-Year Plan goals, salaries for Party workers will be raised to the level where they will be roughly 80 percent of those paid for work of a similar nature in regular businesses.

ACTIVITIES IN BRIEF

- Staff members from the Midwest Regional Headquarters in Cicero shoveled sidewalks for neighbors of the headquarters on 31 January, following a snow storm. The entire block was shoveled, and Party business cards were left at each house.
- National Socialists from Chicago Units I and II picketed a YMCA on the North Side of Chicago on 20 January. The "Y" was being used by the Socialist Labor Party (an insignificant and benign Red group) for a meeting and lecture that day. The Party had previously been denied access to the very same facilities as the Reds were using. Midwest Chief of Operations Steve Martinson led more than a dozen Party comrades in protesting the "Y's" blatant hypocrisy. The demonstration was followed by a White Power message calling on Whites to boycott the "Y". A letter writing and telephone complaint operation against the "Y" was also conducted by area National Socialists.
- Milwaukee Unit II reports it is distributing copies of **WHITE POWER** by leaving them in the waiting rooms of doctor's offices and other businesses, putting the Party paper side by side with *Time*, *Ladies Home Journal* and *Business Week*.
- Chicago Unit I, Merrimack Valley (N.H.) Unit, Milwaukee Unit I and Northern New Jersey also report conducting organized literature distributions during January, as did comrades in Cleveland, Louisiana and Northern California.
- Comrade Paul Gardner of the Indianapolis Unit was interviewed on 13 January over WNDE radio. Comrade Gardner reports that although he did not do as well as he had hoped to during the interview, the unit nonetheless received a number of positive responses from individuals wishing to join the Party.
- A meeting of Party comrades in the Portland-Vancouver, Wash., area was attended by a reporter from *The Columbian*, a local newspaper. An objective, unbiased account of the meeting (including the local Party post office box) subsequently appeared in the paper.
- A White Power message broadcast from the Midwest Regional Headquarters denouncing homosexuals and homosexuality as "symptoms of a sick society" was printed in a Chicago area weekly paper—*Gay Life*. A number of predictably perverse phone calls were received by Regional Headquarters from hysterical queers upset with the Party's condemnation of their sickness, following the printing of the WPM.

'White People's Party' decries 'queer-ism'

"Free-loading faggots will get the same preferential treatment as non-whites get"

The following is a transcription of a recorded telephone message, obtained by calling 863-8878 last week.

"Hello, this is Paul Stevenson of the National Socialist White People's Party, located at 2442 S. Central Avenue in Cicero. We're open from 9 to 9, Saturdays and Sundays.

"One of the symptoms of a sick society is the rise of homosexuality and other forms of sexual perversion. All across America, you can see the signs of decay and degeneracy. Queers are openly holding parades and running for political office. The queers are even questioning Presidential candidates for their view on gay rights. And, like stray dogs fighting over a bone, the politicians are more than willing to put aside any pretense of decency to gain the votes of their faggot constituents.

"Right now in the City of Chicago there is legislation pending in the City Council that would introduce non-discriminatory clauses for gays in the city codes. In other words, the queers would be given the same preferential treatment that non-whites get. This means the City would be forced to hire queer policemen, queer firemen, queer teachers, queer ambulance drivers, and just queers in general. It's bad enough that the system uses your tax dollars for minority welfare; now they want to give free-loading faggots first place in the job lines.

"But where does all this 'queer-ism' come from? Who is pushing this perversion onto our nation? For centuries, Jews have been involved with all kinds of degeneracy, but now they're coming out into the open. Most Jews have homosexual tendencies anyway, and there are at least forty openly gay rabbis in the United States. They are even

establishing gay synagogues across the country. One local Chicago Jew was arrested last week for taking indecent liberties with young boys.

"However, it's not only the Jews that are mixed up in 'queer-ism.' A number of Christian churches are presently ordaining gay ministers. No, the sickness spawned by democracy will not be eliminated by any existing institutions. Only with National Socialism will the morals of our people be restored to a natural state. In Hitler's Germany, queers were either put into labor camps — or shot. That's not such a bad idea. "White Power."

TWO-YEAR PLAN NOTES

ON THE VIRTUE OF PURGING MENTAL DEFECTIVES

The basic goal of the Two-Year Plan is to upgrade the overall quality of the Party's members and supporters. There are two methods we can employ to accomplish this. The first method is to recruit more high-caliber persons into the Party. The second is to weed out those who are unsuitable, and prevent such types from affiliating with the Movement in the future.

As the Leader writes in *Mein Kampf* (II,11):

"... The organization embraces within its scope only those who do not threaten on psychological grounds to become a brake on the further dissemination of the Idea."

Thus I am always somewhat surprised when I hear criticism of the Two-Year Plan from Party comrades who feel that we need every single warm body we can get, no matter what psychological problems such types may suffer from and no matter what way these problems may manifest themselves. "No one should be purged simply for being a mental defective," they tell me. "There is a place in the Movement for everyone."

As the Party's Corresponding Secretary, not only do I have the pleasure of corresponding with a number of sincere, dedicated, high-quality National Socialists, but I must also unfortunately deal with a wide variety of odd-balls, social misfits, mental defectives and just plain turkeys who write to the Party.

To be sure, these undesirable make up only a small fraction of the Movement, and are far out-numbered by the high-caliber comrades I have just mentioned. But we are burdened with a certain number of losers, and their presence in our ranks is a problem we must solve, not ignore. For one thing, their high visibility in local units causes them to have a detrimental influence completely out of proportion of their actual numbers. One mental defective can undo all of the good done by a half-dozen genuine National Socialists.

I have been a street activist in various parts of the country and Party organizer at my (former) Marine base at Yuma, Ariz. For awhile I was the local organizer for the National Headquarters area. So when it comes to "nuts, weirdos, zanies, and zombies" (to quote another comrade) I know whereof I speak.

Without exception, I think the current Two-Year Plan policy towards these hopeless losers is the best: Have nothing to do with them at all. Period.

Our Movement attracts many souls who, because of some

personality defect or another, are unable to function in the "real world." Unfortunately, the same defects which prevent them from fitting into society also prevent them from fitting into a revolutionary National Socialist organization.

Party growth is slow and often discouraging, especially with new local units. In the past, some local units have been so desperate for funds and manpower that they were willing to take in any humanoid form that managed to stumble through the doorway, provided that it could be marginally described as "White." This is a gross error!

By accepting people with serious personality defects, into the Movement, we may help fill our treasuries and swell our numerically slim ranks a bit, but we are dooming ourselves to perpetual failure.

Any decent, intelligent person who becomes interested in the Movement will be repelled by cretins who find bathing an unpleasant experience, who ramble on obsessively against Jews, Blacks, Communists or whatever but never discuss the positive aspects of National Socialism, or who otherwise exhibit personality traits that indicate deep psychological disturbances.

By accepting losers into our ranks, we forfeit the support of sane, intelligent idealists—the kind of people we wish to attract, not drive away.

It is better to go without the support of losers today (as much as we might imagine we need such support) than to go without the support of WINNERS tomorrow.

The argument that even losers are "racial comrades" or "Party comrades" holds no water. Certainly we should encourage genuine comradeship and a sense of community among all of those true National Socialists who are engaged in our struggle. Yet at the same time, we must remember that the purpose of the Party is to achieve a National Socialist *victory*, not to provide companionship and entertainment for lonely, mentally unbalanced persons who like to think that they are National Socialists.

A simple rule of thumb for dealing with marginal types: If they do more potential harm than good, out they go!
