Lincoln Rockwell's Birth Commemorated

A large contingent of National Socialists, led by Commander Matt Koehl, held a special march and wreath-laying ceremony in Bloomington, Ill., on 8 March to commemorate the birth of the Party's founder and first commander, Lincoln Rockwell. The NS column, including some 28 uniformed ST personnel, marched through downtown Bloomington to the Mennonite hospital where Commander Rockwell was born. At the hospital, Commander Koehl gave a brief oration on the significance of Lincoln Rockwell's life and work, calling him one of America's greatest sons. He then laid a special wreath at the entrance to the building.

This is the seventh year that the Party has honored the birth of Commander Rockwell by a march and ceremony in Bloomington. Although a late winter snowstorm kept many comrades away this year who would have liked to attend the event, a delegation of National Socialists from the East Coast joined with the Commander and Midwest comrades in this activity for the first time.

That evening, a formal Party meeting presided over by the Commander was held in the Midwest Regional Headquarters in Cicero. In his address, the Commander stressed the Party is a revolutionary organization whose aim is to overthrow the present decadent, Jewish-dominated, liberal-democratic, finance-capitalist System, and replace it with a National Socialist New Order. It is not our goal to merely reform the present System, but to utterly smash it and build a society in its place which will be responsive to the needs and aspirations of the Aryan race, the Commander said.

National Socialists Honor Bob Miles

A special dinner to welcome the Rev. Bob Miles back from prison was held in Cicero on 9 March. Bob Miles was held as a political prisoner by the federal government for nearly six years for a crime the government knew he did not commit.

Some 30 comrades attended the dinner to honor Rev. Miles, for which they each paid a small fee, which was given to the Miles family to help them get back on their feet financially after Bob's lengthy imprisonment.

Although prevented by federal order from making a speech, Comrade Miles did rise at the end of the dinner to thank the assembled National Socialists for the moral and material support they gave him while he was held as a captive of the System. In answer to questions put to him by the gathering, Rev. Miles told of the horrific conditions he discovered in the federal prison system.

He stressed that the whole prison system was corrupt and rotten, and founded on false premises. He stated that it should be completely abolished, and a new, more effective penal system be established that would rehabilitate those convicts who are able to be rehabilitated, and dispose of the rest.

Rev. Miles went on to say that the end of the present System is drawing closer day by day, and that White people must prepare for the time when there will be a total breakdown of law and order, and they will have to look after themselves.

It is also the duty of White racist groups, such as the Party, to prepare themselves for this period of anarchy, so that they will be able to take advantage of a revolutionary situation when one arises.

In connection with the notice in NS BULLETIN number 263 regarding wills, I wish to point out another way in which Party comrades can help the cause after their physical death: There is often a provision for *savings accounts* called "pay on death" or p.o.d. Under this provision, in the event of the death of the person holding the account, the money in the account can be paid to whomever is named as trustee. Many comrades may wish to take advantage of this provision, as it involves absolutely *no* red tape. Normally, all that you have to do to put this into effect is to notify the bank that you want this provision.

Latest Word on FBI Files: 54,000 Pages!

In the last NS BULLETIN we reported that the FBI had informed Comrade Scott Mosby of Milwaukee that it has a total of 37,000 pages of files on the Party. Since that time the Party has received a letter from FBI headquarters in Washington, D.C., indicating that they actually maintain some 54,000 pages of information on the NSWPP. No explanation was given as to where the additional 17,000 pages came from.

A letter from the FBI has also been received which shows that they have a mere 800 pages on Commander Rockwell.

The following is a summary of the quantity of FBI records on the Party and its commanders:

File on the Party itself:	54,000 pages*
File on Commander Koehl:	2,500 pages
File on Commander Rockwell:	800 pages
Total:	57,300 pages

(*Broken down as follows: Prior to 1 January, 1967: 22,400 pages; Since 1 January, 1967: 31,600 pages.)

We are especially curious to learn why the FBI has "only" 800 pages on Lincoln Rockwell, despite his 20 years in the Navy, eight years of political activity prior to founding the Party and eight years as head of the Party. Why does the FBI have 22,400 pages on the Party prior to 1 January, 1967—and only 800 pages on Commander Rockwell? Has part of Commander Rockwell's file "accidentally" been destroyed? Is the FBI trying to protect itself—or maybe some other organization? Is it trying to cover up something? Perhaps an assassination?

What Is in the FBI Files on the Party?

Some Party comrades are wondering just how the Federal Bureau of Investigation has managed to fill up 54,000 pages of files on a legitimate, legal, law-abiding political party like the NSWPP.

Past experience reveals that the FBI is interested in smashing any organization whatsoever which they feel is a threat or a potential threat to the System. Towards this goal, they amass a wealth of information on such a targeted organization and its adherents, with the aim of using this information to harass its members, subject the organization to all sorts of illegal and quasi-legal "dirty tricks", and generally do everything possible to disrupt its operations.

For example, the FBI has already released information under the Freedom of Information Act which reveals that it did everything it could to force the shut down of the Party's Chicago headquarters in the mid 1960s. The Bureau has also revealed that at the time of the death of Commander Rockwell it had printed up thousands of copies of a newsletter with the Party's name and address on it attacking one of the major Ku Klux Klan factions, with the purpose of deliberately fomenting ill-will and warfare between the NSWPP and the KKK.

The files the FBI has on the Party document these and probably hundreds of other actions taken to hinder the growth of the Movement. Other radical organizations have used information obtained from their files to press massive lawsuits against the FBI. It is highly possible that the Party will be able to do the same.

In 1977, Comrade Martin Kerr, who was then in charge of Party operations in Southern California, received a greatly censored copy of the file the FBI maintains on him. Here are two brief excerpts from it. The first shows that the FBI was engaged in a scheme to charge the Party with a violation of federal antiriot laws. The second excerpt shows that the FBI was conducting an investigation—based

solely on a single anonymous telephone call—to determine whether Comrade Kerr could be prosecuted for threatening or plotting to kill President Gerald Ford.

It is interesting to note that charges were never filed against the Party or Comrade Kerr in either case.

From an FBI report dated January 10, 1974:

This investigation is based on information which indicates that the National Socialist White People's Party (NSWPP) is engaged in activities which could involve a violation of Title 18, United States Code, Sections 235 (b) (3), Chapter 102, 2101-2102, and Chapter 12, 231-233, (Antiriot laws) or 241 (Civil Rights Act of 1968).

David Martin Kerr, who resides at the Headquarters of the NSWPP in El Monte, California, has been identified as the District Organizer of the Party. He has attended NSWPP meetings and participated in NSWPP demonstrations.

(Rest of report censored)

From a report dated 10/2/75:

MARTIN KERR, 4375 North Peck Road, was advised of his rights as they appear on an FBI Interrogation; Advice of Rights form. He was advised of the nature of the investigation. KERR denied being involved in any type of plot to assassinate the President of the United States. He said he knew of no one who was involved in such a plot. He said that he never made any remarks that could be construed as a threat to the President of the United States or for that matter any public official. KERR said that the National Socialist White People's Party (NSWPP) ideology does not espouse violence or assassinations and he feels that the allegations made against him were probably made by some former NSWPP member who was trying to get him into trouble.

Such reports as these may seem to many comrades to be harmless in themselves, but it must be remembered that they are merely used as "fishing expeditions" to discover information the FBI seeks and to provide a legal pretext for illegal and semi-legal harassment of the Party. How would you like a couple of FBI agents to visit your employer, parents, neighbors, etc., stating that they were conducting an investigation to determine if you were involved in a plot to kill the president?

ACTIVITIES IN BRIEF

- National Organizer Martin Kerr was interviewed on a talk show on KAYO radio on 9 March. After a brief formal interview, Comrade Kerr fielded questions from the listening audience for nearly two hours.
- Comrades in Watertown, N.Y., caused quite a stir in their community with a series of routine door-step literature distributions and sticker postings. An unusually unbiased article describing the Party literature distributed—and reproducing the Party address numerous times—subsequently appeared in the *Watertown Daily News*. - Cleveland comrades have been especially active recently. Activists there report distributing 960 back issues of **WHITE POWER**, 50 Say No to the Draft leaflets and 250 index cards with a local Party address and White Power Message number stamped on them. Additionally, 375 mini-stickers and 30 Save Gas—Ban Forced Busing stickers were posted. Cleveland National Socialists have also contributed to the John Demjanjuk Defense Fund. (Mr. Demjanjuk is another alleged “war criminal” who is presently the victim of a Jewish-instigated witchhunt.)
- Comrades in Chicago, Milwaukee and Northern New Jersey also report conducting organized literature distributions during March.
