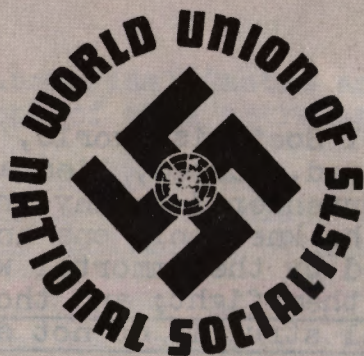

GEORGE LINCOLN ROCKWELL: National Socialist Martyr

(1918-1967)

"I knew I would not live to see the victory which I would make possible. But I would not die before I had made that victory certain."

--Commander Rockwell, This Time the World, Chap. XIII

"Der Mann kann fallen, die Fahne nie!" --Hermann Göring

When that cowardly assassin pulled the trigger on that tragic, black Friday, 25 August 1967, he probably thought that he was ending the political career of the greatest National Socialist and greatest champion of Aryan humanity since Adolf Hitler. And in a certain sense he was right.

Yet in another sense this foul creature, acting on behalf of world Jewry and international Marxism, was deluding himself. For the historical personality of Commander Rockwell did not cease to exist on that fateful day last summer. "George Lincoln Rockwell: Temporal Political Leader" has simply assumed his new role as "George Lincoln Rockwell: Eternal Martyr." Through his heroic death, Commander Rockwell now takes his place beside our immortal Führer himself as the greatest of National Socialist martyrs. And just as he gave us needed guidance when he stood in our midst, so his living memory now provides us with an undying, all-powerful inspiration to fight the great battle which must be fought, and to do the mighty work which must be done.

Martyrdom can never kill an idea or destroy a movement. Martyrdom is, in fact, essential for the victory of every earth-shaking, revolutionary idea. It is a confirmation of the seriousness of our purpose. It represents the culminating act of hate and hostility by our enemies, and is the highest tribute that can be paid to our dedication and commitment to the National Socialist Idea.

Nietzsche once declared: "The more determinant a being is for the future, the greater are its sufferings." Commander Rockwell himself wrote in This Time the World on page 306: "One does not win a whole new world with ordinary sorrows and agonies, but only after enduring and surmounting the utmost tragedies and Olympian agonies."

In his struggle for a National Socialist world, George Lincoln Rockwell was jailed, beaten, smeared, cursed, lied about and reviled by his enemies. But he never surrendered to any pressure, no matter how great. For every attack he knew only one answer: counterattack. Through it all, he was guided by the immortal words of Adolf Hitler: "Those who want to live, let them fight; and those who do not want to fight in this world of eternal struggle do not deserve to live."

George Lincoln Rockwell fought, and he died. And yet he is not really dead, for he built a movement and spread an idea. And the enemies of Aryan Man are badly mistaken if they think they can destroy that movement or kill that idea with a bullet. As long as that movement remains and that idea continues to fill the hearts and minds of men, the spirit of Commander Rockwell lives on!

John Patler

The Liberal press has pushed the line that John Patler killed Commander Rockwell in an internal NS dispute, and that Patler was in fact, a bona fide National Socialist. This line has been repeated so consistently, that even some good National Socialist comrades have been deceived by it. That basic ideological issues may have been involved in the assassination is deliberately ignored.

The fact is that John Patler (John Patsalos) was expelled from the NSWPP on 4 April of this year following his persistent attempts to push a "Racial Bolshevik" line within the movement. His hateful references to lighter members of the Party as "blue-eyed devils" are well known. They reveal a malignant attitude which caused considerable dissension prior to his expulsion. Patler had made repeated attacks on the Party's "Aryanism" and "racial chauvinism"-- both verbally and in writing--in no way substantially different from similar attacks by the most rabid Communists. ?

As all National Socialists recognize, race is at the center of our entire philosophy. Any attempt to belittle its fundamental importance, or to deny basic Aryan racial values, is contrary to everything that National Socialism stands for, and cannot be tolerated within the movement.

Patler's deviation from National Socialism became apparent in another way. While claiming to be for racial unity, he regularly preached and practiced a form of Marxist class war. In a Marxist mania for "equality" he regularly attacked the Aryan concept of private property which did not conform to his "proletarian" concepts.

For those who had known Patler well, this action came as no surprise. His favorite reading material had been the pro-Peking Communist monthly, "PROGRESSIVE LABOR," to which he was a regular subscriber. Among the Marxist "heroes" for whom he expressed open admiration

were the Cuban dictator Fidel Castro and Che Guevara, the late darling of the Left, both of whom he regarded as "true revolutionaries."

This then is the man whom Commander Rockwell ordered expelled from the Party. There simply was no place for the disruptive activity and deviation of this individual within the National Socialist movement. *Why not expelled sooner?*

At this time it cannot be stated conclusively whether Patler was directly involved with a certain Communist or Jewish organization at the time of the assassination. However, the NSWPP does have some information which tends to suggest such a connection. One thing is certain: Patler could not have acted alone in any plot against the Commander.

UNITED STATES

Milwaukee March In its first major public activity since the assassination of Commander Rockwell, the NSWPP held a White Power march into the Negro section of Milwaukee, Wisconsin on 23 September. The march, led by Capt Chris Vidnjevich of the Party's Chicago headquarters and Lt Frank Drager the Party's General Organizer, added a new dimension to the racial struggle in Milwaukee. The march followed a Party rally in a local park the previous evening; and came in response to successive Black marches into Milwaukee's White neighborhoods. Until the appearance of the National Socialists, all other groups claiming to represent the White people had confined their demonstrations to the safer White areas of the city.

Leftist Demonstrations Attacked American National Socialists clashed with pro-Viet Cong "peace" demonstrators in two separate actions in Washington, D.C. on 21 October. An NS infiltration team comprised of Capt Vidnjevich, Lt Drager, SL William Kirstein and GL Spencer Redfield, stormed through a Red security cordon and demolished the speaker's platform at the Lincoln Memorial as Clive Jenkins, Leftist British MP, was about to speak. The disruption halted the demonstration for almost a half hour. Capt Vidnjevich and SL Kirstein were arrested in the assault, but were later released under \$500 bond each.

Later, Matt Koehl led a National Socialist contingent into the middle of several thousand "peace creeps" at the Pentagon with gigantic signs spelling out, "Bomb Hanoi" and "Gas the Viet Cong." Out-numbered 100-to-1, the National Socialists fought a brief, bloody skirmish as they broke out of their encirclement. They later seized and destroyed hundreds of Leftist placards and captured a number of Viet Cong flags.

Australian Exchange Member Eric R. Wenberg, who joined the NSWPP Headquarters Staff under a special U.S.-Australian NS exchange program, was released from the Washington, D.C. Jail on 28 September under \$5,000 cash bond. He had been ordered deported earlier in the month; and had previously served a 10-day sentence in the Arlington County (Virginia) Jail for "contempt of court" after he lunged at John Patler during a hearing 28 August, shouting, "You filthy assassin!" Wenberg is currently out pending appeal of his case. He formerly served as a Staff Member of the National Socialist Party of Australia in Sydney.

"WHITE POWER" Newspaper "WHITE POWER" was launched 20 August under the personal aegis of Commander Rockwell as the first mass-circulation newspaper of the NSWPP. Thousands of copies have already been sold and distributed in America's major cities. The second issue of the paper for October contains an account of the Commander's life and career, as well as a description of the event at Culpeper, Virginia, during the attempt to hold funeral ceremonies of 29 August.

NSWPP Leadership

The responsibilities of Party leadership following the assassination of Commander Rockwell were assumed by Matt Koehl, the Party's senior officer who had served as National and External Secretary. The new National Leader also assumes command of the Party's Stormtroops.

The Party succession was carried out according to the organization chain-of-command which Commander Rockwell had established, and was subsequently reaffirmed by personal expressions of loyalty and support by all officers of the Party throughout the United States.

Mr. Koehl has also assumed the role of Acting Commander of the WORLD UNION OF NATIONAL SOCIALISTS following Commander Rockwell's death.

White Power

At the time of the assassination, Commander Rockwell had just been in the process of completing a new book, White Power, which analyzes the racial crisis in America and throughout the world, and points the way to National Socialism and an Aryan revolution. It was originally scheduled for release 1 September, but because of the tragic events, publication was postponed. CANADA

John Beattie, Leader of the Canadian National Socialist Party, was released from prison 9 October, and is currently in the process of reactivating the movement in Canada.

The CNSP held its first public activity since Beattie's release when it staged a protest against Leftist "peace" demonstrators in Toronto on 21 October.

Meanwhile, Martin K. Weiche, the Party's former National Chairman, has been expelled for gross incompetence and inactivity during Beattie's imprisonment.

CHILE

Chilean National Socialists paid tribute to Commander Rockwell 3 September in special ceremonies following a march to the Santiago cemetery where there is a memorial to the 58 National Socialists killed in that country in 1938.

Franz Pfeiffer, Leader of the Partido Nacional-Socialista Obrero, reports that the Chilean section has been holding regular rallies in Santiago and Valparaiso. He also reports that a new headquarters has been opened up on Concepcion, where PNSO members recently clashed with pro-Viet Cong demonstrators.

Meanwhile, the PNSO is planning a mass nation-wide march for 1-3 December to be followed by a rally in San Felipe, near its stronghold of Putaendo, to protest Marxist subversion.

BRITAIN

Jordan Plight Dramatized On 24 June, Robert Relf, 40, a member of the National Socialist Movement, dramatized the plight of his leader, Colin Jordan, by hanging a huge banner reading, "Free Speech?" on a construction crane jib (boom) 250 feet above street-level in Coventry's crowded Precinct. For almost seven hours Relf, an ex-Marine commando, remained aloft, calling attention to the unjust imprisonment of the British Leader. At the end of his airborne vigil, he scattered leaflets to the huge crowd below, and calmly climbed back down.

Relf last year climbed the spire of the Coventry Cathedral to dramatize the struggle against Jewish tyranny in Britain. Attempts at that time by both the police and fire departments to bring him down failed.

Meanwhile, all WUNS sections and affiliates are urged to make a special effort during the approaching Yuletide season to show their solidarity with this comrade in his period of confinement. Jordan was sentenced to 18 months' imprisonment 25 January on a trumped-up charge involving his criticism of Jews and Negroes. The British Leader was the first person to be jailed under the grossly anti-Aryan Race Relations Act of 1965. A subsequent appeal to obtain a writ of habeas corpus was turned down.

AUSTRALIA

Australian National Socialists are working in two areas to reestablish the National Socialist Party of Australia. The mailing address of one group, under Arthur Smith, is: P. O. On 22 October NS Stormtroops, using high-powered fire hose, sprayed more than 300 marchers with red dye during a pro-Viet Cong "peace" demonstration in Sydney. For hours after the march, the only sight to be seen was "peace creeps" and other assorted riff-raff running around with red hair, red faces and red clothes! The suddenness of the attack caught the 4,000 marchers by surprise, and only the fact that the National Socialists ran out of dye prevented the entire 4,000 from receiving a thorough dousing. Large numbers of Swastika-bedecked posters were also distributed among a sympathetic watching crowd.

NEW ZEALAND

New Zealand National Socialists are currently in the process of laying the foundation for the movement in their country.

SWEDEN

"NORDISK KAMP," organ of the Nordiska Rikspartiet, the WUNS affiliate in Sweden, has devoted a special memorial issue to the American National Socialist leader, George Lincoln Rockwell.

NORWAY

A very effective pro-NS publication printed in Norway is "FOLK OG LAND," edited by Odd Melsom. Mailing address of the paper is: Boks 3214--Oslo 4. Subscription rates outside Norway are 50 kr (\$7; 2 Pounds/10s.) for one year, or 25 kr (\$3.50; 1 Pound/5s.) for a half year.

GERMANY

Pvt William D. Whitmeyer, who had been with an armored unit in West Germany, was sentenced to three months' hard labor for allegedly disobeying the order of a Jewish officer to stop "propagandizing" among the troops. Whitmeyer was charged after giving a buddy a Swastika pin he had ordered from ANP-Dallas. The sentence was subsequently suspended, and he has been transferred to a unit in the United States. PFC Larry M. McIntyre, who was in the same company as Whitmeyer, has also been transferred back to the United States for political reasons.

Meanwhile, Sp/4 Bobby Lee Pace, who had interested himself in the Whitmeyer case, gave an excellent interview to "OVERSEAS WEEKLY,"

the publication for American GI's in western Europe. Pace is currently stationed near Augsburg in south Germany. As a result of the interview and the publicity surrounding the unjust treatment of Party Comrade Whitmeyer, the NSWPP headquarters in Arlington has been deluged with inquiries from scores of White GI's in West Germany, many of whom have indicated a strong desire to join the Party.

FRANCE

Dr. Paul Rassinier, controversial author of Le Mensonge d'Ulysse (Die Lüge des Odysseus), Le Drame des Juifs (Was Nun, Odysseus?) as well as La Véritable Procès Eichmann (Was Ist die Wahrheit zum Eichmann-Prozess?), died on 28 July.

A pacifist and former Communist, Rassinier had attracted considerable attention because of his exposure of the lies concerning the internment centers in National Socialist Germany, to which he himself had been deported because of his wartime Resistance activities. In 1965 he was barred from West Germany, where he was to have appeared as a witness for the defense at the Auschwitz show-trials.

Commemorative Dates

- 16 October 1946 -- Ten of the Nuremberg Martyrs are murdered at Landsberg Prison
- 9 November 1923 -- The Munich Revolt; 16 Stormtroopers give their lives for the National Socialist Cause
- 12 November 1893 -- Birthday of Dr. Fritz Clausen, who in 1932 founded Denmark's National Socialistiske Arbejder Parti, which has since become the Danish section of WUNS (Clausen died in a democratic prison in 1947.)

Hess Release Urged

The American and British judges who took part in the postwar crimes at Nuremberg in 1946 on 10 October called for the release of the "Prisoner of Peace," Rudolf Hess.

Francis Biddle, who was U.S. representative on the four-power tribunal, released a statement after consultation with Lord Oaksey, the British presiding officer of the Nuremberg lynch-trial, saying: "Both Lord Oaksey and I think that Hess has served long enough, and that he should now be released."

Biddle's statement was issued in response to an appeal by Hess' son, Wolf Rüdiger Hess, of Mainz, West Germany. The latter had called the continued imprisonment of Hess "a flagrant defiance of human feelings."

The Führer's former Deputy in 1941 made a dramatic solo flight to Scotland in an attempt to end the hostilities between Great Britain and Germany. For his heroic efforts he was sentenced to life imprisonment at Nuremberg. Since last October he has been the lone inmate at Spandau Prison in West Berlin. Throughout his long years in prison--longer than those ever spent by any other National Socialist--Hess has steadfastly refused to renounce his loyalty to Adolf Hitler and National Socialism.

Biddle and Oaksey have apparently had some belated qualms about their dispicable roles in sentencing this guiltless man in the first place. Despite this, Biddle still went through the typical democratic pretenses. He claimed that in any change of the Nuremberg sentence, the Soviet Union would have to concur with the other occupying powers of postwar Germany, something the Russians have refused to do. That this is a sham is shown by the fact that each of the other powers--Britain, France and the United States--have it in their power to release Rudolf Hess whenever their troops assume the monthly guard, announcing the results to the obstinate Russians as a fait accompli. In addition, the Bonn government could cause Hess to be released by simply refusing to pay the \$280,000 (100,000 Pounds) it costs to maintain the Spandau Prison each year.

As a gesture of defiance against the cruel and inhuman treatment being accorded Rudolf Hess, National Socialist comrades around the world may wish to send Yuletide greetings to him. These should be addressed as follows:

As all incoming mail at the prison passes through each of the Four-Power censors, senders may wish to exercise discretion in disclosing their names and addresses in some instances.
