ANATOMY OF A SMEAR by Drew Pearson

n January 17th, 1959, Drew Pearson wrote the column printed below about what he calls the "most vicious hatenest in the USA. The cause of his outburst was a petition gotten up by a charming and patriotic Arlington housewife, Mrs. Marion Gatterman to impeach the Governor of Virginia for his gross violation of his Constitutional oaths and his dishonoring his pledge to the people to absolutely prevent integration in Virginia, -on which he was elected.

Mrs Gatterman, with astounding courage and devotion to Constitutional law and the traditions of our American Republic, braved the wrath of the ignorant and comardly to accomplish this laudable task and enlisted the help of Commander Rockwell to print her petitions. She was and is having so much success in this

effort that the Jewish forces which have constantly promoted Communism and integration were forced to use their maximum efforts to scare people away from this petition.

Drew Pearson, with his usual subservience to the Jewswho dominate our Nation and its press, was called upon to smear this patriotic effort by Mrs. Gatterman, by lying that it was the work of Commander Rockwell. For this lie, Pearson is being sued by Mrs. Gatterman. The idea is to convince Virginians who are signing the petitions by the thousands, that by doing so, they become part of Rock-well's all-out anti-Jewish effort.

Below we have shown you, in minute detail, the documented proof of the utterly false nature of this entire Jew-Pearson smear.

DREW PEARSON'S CONSCIOUS JEWISH LIES

Mr. Pearson NEVER applies the smearword "hate" to the vicious material of the Communists, who have caused more inter-racial hate than any group in his-tory, but only to those who reveal the facts his master's must hide to survive. The Jews don't want you to know, for instance, that it is a Jew, Arthur Spingarn, not a Negro, who heads the Jew-Commun-ist-controlled NAACP, and that it was a JEWISH organization which filed the am-icus curie brief which won integration from the Supreme Court.

This is indeed true, but it is also a violation of the postal laws as to privacy of the mails, especially registered mail, --YOUR mail. Appropriate charges have been filed with the Postmaster General.

On the back of this sheet is a much reduced replica of Commander Rockwell's exact letter to Colonel Nasser, which has been made available to Pearson and the Jewish newspapers. They won't print it. They dare not. Read it yourself and see why.

Colton and Hansel were listed on the Post Office forms as references, as the records will show, --they did not "sign", and did not even know their names were used until they read it in Mr. Pearson's "imaginative" article.

On Feb, 6 a registered letter was mailed to Nasser from George Lincoln Rockwell, the Arlington, Va., hate-monger who is circulating thousands of copies of petitions calling for the impeachment of Gov. Almond. Simultaneously, Rockwell's picture appeared on the front page of Nasser's newspaper El Aharan, though in denial of reports that Nasser had anything to do that Nasser had anything to do

with the American hate-nest.
The group, which recently has
assumed the name of "The Virginia Committee to Impeach Governor Almond," gives its mailing headquarters as P. O. Box 1352 in Arlington.

The box was rented on February 3 by Floyd Fleming, grizruary s by Frond Fremma, griz-zled old hate agitator and side-kick of rabble rouser John Kas-per. The Seaboard White Citi-zens Council was built around them. Two of Fleming's hench-men, Eugene Colton and H. Cary Hansel also signed the rental papers for the box. How "guilty" can you GET! Any grocery clerk in Atlanta might have had with those being "investigated" in "con-nection with" the synagogue bombings! Or so might any one of you who read this!

This is a CRIMINAL charge. Commander Rockwell is not registered with the Justice Department as a foreign agent, and if he had ever taken a PENNY from the Arabs, Mr. Nathan Lenvin, the Jewish head of the section in the Justice Department which handles these affairs, has assured him he would be very properly thrown in prison. If Mr. Pear son has any facts in evidence of this criminal charge, he himself is an accessry if he fails to deliver them to Mr. Lenvin. He Won't He is LYING. We DARE him to sue us for calling him a lying Jewish lick-spittle. If he doesn't, you will know he IS a liar.

This, of course, is the purpose of the whole nasty piece; -to promote the smear that Commander Rockwell's Hitlerite movement is masquerading as Mrs. Gatterman's petition group, and thus scare people away from signing the petition. Mrs. Gatterman is suing Pearson for this damaging lie.

The group operates largely from Rockwell's home at 6512 Williamsburg Blvd. Rockwell 'is the son of the prewar radio comedian and rocking chair philosopher "Old Doc" Rockwell whose squeaky voice was once familiar to millions of listeners. The younger Rockwell, whose philosophy has taken a bizarre twist from the horse sense preached by his famous father, stayed as a house guest last May in the home of Mrs. Helen Lane, member of the Arlington School board. His baggage included a printing press on which he printing has been proposed in Mrs. propaganda in Mrs. Lane's basement.

Rockwell's letters to Wallace Allen, a crippled printing salesman, were picked up by Atlanta police during their investigation

Mrs. Lane has strongly disapproved of Commander Rockwell's activities, and would nev-er permit the printing of any "Hate propaganda" in her basement. This is a rotten attempt at the "guilt-by-association" which Pearson so much deplores, -- when the shoe is on the other foot, -- the RED one.

One letter also spoke of a "factat financier" who turned out to be Harold Noel Arrowsmith Jr., son of the late canon of Baltimore's Episcopal Cathedral. Arrowsmith took offense at dral. Arrowsmith took offense at the "fatcat" reference, apparent-ly thinking Rockwell was ridicul-ing his physical plumpness.

Rockwell boasted to associates that "Ike the Kike" signs, used in picketing the White House, are now in Cairo. What apparently happened, however, is that snapshots of the picketing were forwarded to Cairo. Rockweil also told associates that Arrowsmith had contacts in the "Arab Secret Service."

It appears to be true that Arrowsmith was in touch with Saleen Bader, who runs what he calls the Arab - Asian Institute. em Bader, who runs what he calls the Arab - Asian Institute. Bader registered as a foreign agent in 1957 and listed contributions from Saudi Arabia of \$500 on March 18, 1957, and another \$150 on April 8, 1957. His registration form also listed two \$50 payments to Lou' Russell on Jan. 7 and 17, 1958; plus payments to a Reë Van Fosson, 12303 Dewey Rd., Silver Spring Md. Van Fosson received \$25 on Jan. 27, \$50 on Feb. 29, \$50 on Feb. 25, \$27 on March 28 and a final \$27 on April 21 - all in 1958.

Much of the hate-nest across the Potomac was financed by the wealthy preacher's son from Baltimore, Arrowsmith, until he broke with Rockwell. He made the first payment on Rockwell's headquarters' and is reported to have poured about \$20,000 into the operation, plus about \$6,000 for the Rockwell printing press.

Arrowsmith describes himself variously as an anthropologist, biologist and zoologist. He has studied at Harvard, Cornell, Johns Hopkins and the University of California. At the University of Mainz in Germany, he studied races. His reported objectives

Arrowsmith and Rockwell are reported to have developed a system of code words for their telephone conversations, because they were convinced the phones

a system of code words for their telephone conversations, because they were convinced the phones were tapped. "Eskimo" was the code word for Jew. "Eskimo Land" meant Israel. "Eskimo conquest of Russia" was the phrase for the Red revolution. This "Eskimo' talk probably was Rockwell's idea. He re-entered the Navy during the Korean war and was assigned to Iceland, which was about the time he became obsessed with the great Jewish conspiracy. In Iceland, he read Mein Kampf for the first time and has re-read it 12 times. He also married the niece of the Icelandic ambassador to the United States and took her to Berchtesgaden for their honeymoon.

Lately, Rockwell has been supplying literature to James Madole who was cited in 1954 by the House Un-American Activities Committee as the would-be Fuebrer of the Nazi-style National Renaissance Party, which attempts to maintain a uniformed "elite "uard" in the Hitler tradition.
