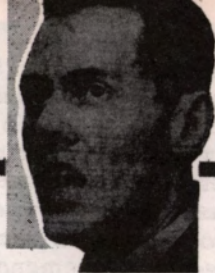

THE FIGHT GOES ON!

Our sincere thanks go to all members and supporters who have expressed their condolences following the tragic blow which has befallen not only this Party, but also the National Socialist movement and the White Race throughout the world, with the cowardly assassination of Commander Rockwell.

Needless to say, the loss which we have suffered has been enormous. A man like Commander Rockwell can never be replaced; he can only be emulated. Everyone of us, furthermore, has a sacred obligation to see that his death has not been in vain and that his work is not destroyed. The blood sacrifice of this greatest of National Socialist martyrs must now serve to inspire the victory of the Cause of Adolf Hitler and Aryan Man. Commander Rockwell has given his life in this struggle; he would now expect only one tribute: that we selflessly serve the National Socialist Cause with intensified dedication and determination.

The Party faces a period of general consolidation in the wake of recent events. While we anticipate no basic changes in Party objectives, there must in some instances necessarily be a redirection of our energies and resources. Before his death, the Commander had outlined a number of organizational plans, as part of a new phase of the National Socialist struggle. He was especially anxious to put the Party on a sound professional footing--so that it could effectively meet the challenges of the decisive years ahead. It is now our job to build an efficient, disciplined, professional party organization,

which will be truly combat-ready in the inevitable battles ahead.

Coupled with this organizational development, Commander Rockwell envisioned the expanded ideological development of the movement. Toward this end, he had just written a book called White Power, which he intended as an important weapon in the revolutionary struggle of our race. He recognized that to properly do our job as National Socialists, we must first possess a clear-cut knowledge of the ideological and moral soundness of the great world-view we are fighting for.

We fully intend to carry out the Commander's plans to the best of our ability and in the spirit he would have wanted. We realize that there will be attempts to sabotage and disrupt the work of the movement by enemies who will spread vicious rumors and lies and who will insidiously try to obstruct our success. But these enemies will not prevail, nor will they be able to stop the National Socialist movement or kill the National Socialist idea.

In his book, This Time the World, Commander Rockwell has given us this assurance:

"I knew that I would not live to see the victory which I would make possible. But I would not die before I had made that victory certain."

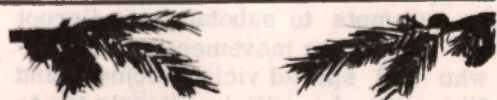
It is ironic that so much of what Commander Rockwell started during his lifetime is just now beginning to show signs of success. In recent weeks the Party has experienced un-



N.S. Confront Federal Troops

Following the assassination of Commander Rockwell, the Party attempted to secure a burial site at Arlington National Cemetery. The Commander was a veteran of nearly 20 years' service in the U. S. Navy, had led three fighter squadrons and had earned nine decorations.

However, Party officials were told by the Defense Department that new regulations made the Commander ineligible for burial at Arlington. An alternate gravesite was chosen at the military cemetery in Culpeper, Va.

During conversations with the Pentagon, National Headquarters emphasized repeatedly that National Socialist funeral rites would be accorded the Commander. At the time, the Pentagon voiced no objections.

However, that was before Jewish pressure groups swung into action. As the press was announcing that the funeral services would include an honor guard of Stormtroopers, and National Socialist ceremonies, Party Headquarters received late word that no swastikas would be permitted inside the cemetery.

The decision was made to proceed as planned. The following morning a cortege of 60 cars left Arlington for the quiet town of Culpeper. At the same time, a cordon



of armed troops was set-up around the cemetery to block the mourners.

The cortege was met at the gates of the cemetery by Major General Turner, who was flanked by MP bodyguards. Turner growled that no swastikas would be permitted beyond the gates of Culpeper. National Leader Matt Koehl replied that the National Socialist mourners were within their legal rights. He also stated that the Party insignia would not be removed under any circumstances.



Thus began a day-long confrontation during which the bantam brass-hat constantly scurried to telephones to consult with the Pentagon wire-pullers.

At one point, Captain Chris Vidnjevič of the Party's Chicago headquarters jumped on the roof of the hearse and exhorted the assembled mourners to break through the line of troops. He then hurled himself into the assembled MP's, only to be arrested. Trooper Mike Steward was also arrested as he attempted to force himself into the cemetery, and was brutally manhandled by hulking MP's as he was dragged away.



Pvt. James G. DeWitt was also arrested on "suspicion" of participating in a public demonstration while in uniform, and also "suspicion" of being AWOL. The charges stemmed from the fact that he had the temerity to mourn his fallen Commander. The AWOL charges were later dismissed, although it took the Army a full week to determine if DeWitt had been AWOL.





Late that afternoon, the Army informed National Leader Koehl that permission for the Commander's burial had been withdrawn, and that the Party would have to make a new application.



The cortege returned to Arlington, where Party officers gathered for further talks. Efforts to obtain a burial plot in private cemeteries were unsuccessful. By this time, the agents of Jewry had been busily at work.

SPOTSYLVANIA SITE

In Spotsylvania County, Virginia, there survives the rugged pioneer stock that made this country great. The people there still do things in the "old ways"; this includes taming local Blacks, as well as burying loved ones nearby on family property.

The Party owns a five-acre tract of land in Spotsylvania, on which the printing plant is located. Before his death, the Commander had spent many hours there, meeting local people and enjoying the rugged countryside. It seemed appropriate that this locale should be his final resting place.

Accordingly, the Party decided to follow local tradition and inter the Commander on its land there. A local funeral director offered to make final arrangements for the burial.

Final preparations were in progress when Headquarters was informed that certain groups, presumably the Jewish War Veterans, were moving to place injunctions against the planned burial.

At the same time, acting under Jewish pressure, Arlington County officials threatened to seize the Commander's remains.

Faced with the possibility of losing the Commander's remains and having them desecrated, the Party decided that cremation was the only alternative.

On August 30, the Commander's ashes were returned to Party Headquarters where a moving memorial service was conducted by Matt Koehl.

GEORGE LINCOLN ROCKWELL

National Socialist Comrades! Fellow White Americans! Today we take upon ourselves the sorrowful task of laying to rest the mortal remains of our beloved Commander, Lincoln Rockwell, martyred by the bullet of a cowardly assassin. To those of us who worked with him everyday, to those Party comrades all over America, and to dedicated National Socialists throughout the world the staggering loss imposed by his death will only be fully felt in the days and years of struggle which lie ahead of us all. His inspiration and his will, the depth of his wisdom and the heroism of his spirit--these are the things which gave us the motivation and the guidance we sorely needed to keep up the fight on so many dark days in years past.

The stunning suddenness of his departure and the ensuing turmoil of the last few days have kept us from yet assessing the magnitude of our loss. But even harder to bear than this perhaps, has been the utterly shabby--the despicably shameful--treatment of our fallen Commander by a government of the nation he served so faithfully throughout all the years of his manhood. George Lincoln Rockwell gave his life in the struggle against Bolshevism at a time when thousands of other American fighting men on the other side of the world are also falling victims to that same Bolshevism--and yet an American government has denied his request to be laid to rest in the place of his choice.

George Lincoln Rockwell served America for over twenty years and through two wars, risking his life again and again in defense of the land and the people he loved so well. He was no armchair soldier, but chose of his own will that soldierly profession demanding the very highest order of courage and skill: he was a fighter pilot. His dedication to duty, his daring, his proficiency led him from the rank of Seaman to that of Naval Commander, gave him the leadership of three fighter squadrons, and earned him nine decorations. And an American government does not hold him fit to be buried beside his fellow fighting men.

George Lincoln Rockwell has sacrificed more and fought harder for the things he held dear--his native land, his fellow countrymen, and, above all, his race--than any man now living. He saw his duty and unflinchingly did it, even when that duty led him into opposition to nearly all those around him. He saw further than other men, and he fought harder. Indeed, in this latter regard he cherished the maxim of the great Leader whose philosophy moulded his own thoughts: "Those who want to live, let them fight; and those who do not want to fight in this world of eternal struggle do not deserve to live."

He fought, and he died. And yet Lincoln Rockwell is not really dead, for he built a movement and he spread an idea, and that movement was not destroyed nor that idea silenced by the bullet that struck

him down. And so long as that movement remains and that idea continues to fill the hearts and minds of men, the spirit of Lincoln Rockwell lives on.

The ashes of the martyr lie here before us and we cannot help but be filled with a solemn sense of tragedy. Yet we are not really here to mourn him, but to honor him and to rededicate ourselves to the great Cause which he served. In the times ahead we must redouble our efforts, so that he will not have died in vain. We must let his great sacrifice serve to inspire us onward in our struggle toward victory--the victory of our people, of our great White race, over the disease which now afflicts it and the enemies who now oppress it. Indeed, at this moment we must bear in mind that old saying which the Commander paraphrased for us: "The stones and mortar of our movement are the bones and blood of its martyrs." It is this aspect of his death that he would now want us to keep uppermost in mind, forgetting our sorrow and filling ourselves with pride at the knowledge we followed such a leader.

For it was he, Lincoln Rockwell, who again picked up the torch which fell to earth twenty-two years ago. Adolf Hitler founded our great movement and will forever fill a unique position in the sagas of our race; but had it not been for Lincoln Rockwell, Adolf Hitler's mighty work might well have been in vain. It was Lincoln Rockwell who set us once again on the upward path when we had faltered and wanted to go back again. It was his example which inspired us to do what we knew we should do rather than that which was easiest to do. It was his hand which led us out of the maze of defeat and degeneration and despair, and pointed the way toward higher things; and his voice which reminded us over and over again that we must continue the struggle for the future of our race.

As we lay to rest the mortal remains of Lincoln Rockwell, it is appropriate to read once again that passage from the Leader's book which he loved best. I shall read from chapter 12 of the first volume of the Commander's personal copy of Mein Kampf:

"When human hearts break and human souls despair, the great vanquishers of distress and care, of shame and misery, of intellectual unfreedom and physical duress look down upon them from the twilight of the past, and hold out their eternal hands to faint-hearted mortals. Woe to the people that is ashamed to grasp them!"

MEIN KAMPF still best seller

The book that Adolf Hitler wrote while in prison 43 years ago is enjoying a resurgence much to the displeasure of the West German government. Despite all efforts of the Bonn regime to put a "freeze" on further publication of Mein Kampf, the book remains a worldwide bestseller, second only to the Bible. The Houghton Mifflin Company of Boston, which has held sole publishing rights in the United States since 1933, reports that 17,000 copies were sold in this country alone last year. Houghton Mifflin's 19 printings have sold well over a million copies.

After Adolf Hitler's death in 1945, publishing rights to Mein Kampf reverted to the Bavarian government. Ever since, Bavaria--backed by Bonn--has tried to stifle

publication and sales of the book. Houghton Mifflin, which owns the U. S. copyright, has continued to publish the book, however.

Other publishing houses, unprotected by legalities, have also published "pirate editions", after having been refused permission to re-print Mein Kampf. Recently a Spanish edition appeared. The book has also been printed in French, Greek, Arabic, Japanese, Portuguese and Danish since the war.

The Danish publisher applied for a license after the book had been printed, only to have its application refused by Bavaria. The refusal came too late, however, for the entire edition had already been sold out.

NAZI PROGRESS



SWEDEN

"NORDISK KAMP", organ of the Nordiska Rikspartiet, the WUNS affiliate in Sweden, has devoted a special memorial issue to the American National Socialist leader, Commander Rockwell. The publication is a tribute to the career and work of the late Commander.

NORWAY

A very effective pro-NS publication printed in Norway is "FOLK OG LAND", edited by Odd Melsom. Mailing address of the paper is: Boks 3214--Oslo 4. Subscription rates are 50 kr (\$7) for one year, or 25 kr (\$3.50) for a half year.

GERMANY

Pvt. William D. Whitmeyer, who had been with an armored unit in West Germany, was sentenced to three months' hard labor for allegedly disobeying the order of a Jewish officer to stop "propagandizing" among the troops. Whitmeyer was charged after giving a buddy a Swastika pin he had ordered from ANP-Dallas. The sentence was subsequently suspended, and he has been transferred to a unit in the United States. PFC Larry M. McIntyre, who was in the same company as Whitmeyer, has also been transferred back to the United States for political reasons.

Meanwhile, Sp/4 Bobby Lee Pace, who had interested himself in the Whitmeyer case, gave an excellent interview to "OVERSEAS WEEKLY", the publication for American GI's in western Europe. Pace is currently stationed near Ausburg in south Germany. As a result of the interview and the publicity surrounding the unjust treatment of Party Comrade Whitmeyer, the NSWPP headquarters in Arlington has been deluged with inquiries from scores of White GI's in West Germany, many of whom have indicated a strong desire to join the Party.

FRANCE

Dr. Paul Rassinier, controversial author of Le Mensonge d'Ulysse (Die Lüge des Odysseus), Le Drame des Juifs (Was Nun, Odysseus?), as well as La Véritable Procès Eichmann (Was Ist die Wahrheit zum Eichmann-Prozess?), died July 28.

A pacifist and former Communist, Rassinier had attracted considerable attention because of his exposure of the lies concerning the internment centers in National Socialist Germany, to which he himself had been deported because of his wartime Resistance activities. He was barred from West Germany last year where he was to have appeared as a witness for the defense at the Auschwitz show-trials.

BOLZANO, Italy--An Italian judge ruled here recently that persons who painted Swastikas on walls were acting within the law. The judge pointed out that while Italy has laws against Fascism, there were no statutes outlawing National Socialism.

FRANKFURT, Germany--When the Egyptian Tourist Office began distributing travel posters bearing Swastikas, West German authorities moved swiftly. All available posters were seized by police and charges were placed against the "unknown person" guilty of distributing "Nazi" posters.

Actually, German authorities acted prematurely. The head of the travel office explained that the posters had only been designed to commemorate the battle of El Alamein 25 years ago.

NEW ZEALAND

New Zealand National Socialists are currently in the process of laying the foundation for the movement in their country.

Meanwhile, Cecil Solomon, secretary of the Auckland synagogue, complained to newsmen that, with the stepped-up National Socialist activity there, anti-Semitic incidents have been on the increase. They were attributed to the rising public indignation as New Zealanders were

awakened to the Jewish Question.

BRITAIN

On June 24, Robert Relf, 40, a member of the National Socialist Movement, dramatized the plight of his Leader, Colin Jordan, by hanging a huge banner reading, "Free Speech?", on a construction crane boom 250 feet above street-level in Coventry's crowded Precinct. For almost seven hours Relf, an ex-Marine commando, remained aloft, calling attention to the unjust imprisonment of the British Leader. Finally, he scattered leaflets to the huge crowd which had built up below, and calmly climbed back down.

Relf last year climbed the spire of the Coventry Cathedral to dramatize the NSM struggle against Jewish tyranny in Britain. Attempts at that time by both the police and fire departments to bring him down failed.

Meanwhile, all WUNS sections and affiliates are urged to make a special effort during the approaching Yuletide season to show their solidarity with this comrade in his period of confinement. Jordan was sentenced to 18 months' imprisonment January 25 on a trumped-up charge involving his criticism of Jews and Negroes. The British Leader was the first person to be jailed under the grossly anti-Aryan Race Relations Act of 1965. A subsequent appeal to obtain a writ of habeas corpus was turned down.

AUSTRALIA

Australian National Socialists are working in two areas to reestablish the National Socialist Party of Australia. The mailing address of one group, under Arthur Smith, is: P. O. On October 22 NS Stormtroops, using high-powered fire hose, sprayed more than 300 marchers with red dye during a pro-Viet Cong "peace" demonstration in Sydney. For hours after the march, the only sight to be seen was "peace creeps" and other assorted riff-raff running around with red hair, red faces and red clothes! The suddenness of the attack caught the 4,000 marchers by surprise, and only the fact that the National Socialists ran out of dye prevented the entire 4,000 from receiving a thorough dousing. Large numbers of Swastika-bedecked posters were also distributed among a sympathetic watching crowd.

Hess Release Urged

The American and British judges who took part in the postwar crimes at Nuremberg in 1946 on October 10 called for the release of the "Prisoner of Peace", Rudolf Hess.

Francis Biddle, who was U. S. representative on the four-power tribunal, released a statement after consultation with Lord Oaksey, the British presiding officer of the Nuremberg lynch-trial, saying: "Both Lord Oaksey and I think that Hess has served long enough, and that he should now be released."

Biddle's statement was issued in response to an appeal by Hess' son, Wolf Rüdiger Hess, of Mainz, West Germany. The latter had called the continued imprisonment of Hess "a flagrant defiance of human feelings".

The Führer's former Deputy in 1941 made a dramatic solo flight to Scotland in an attempt to end the hostilities between Great Britain and Germany. For his heroic efforts he was sentenced to life imprisonment at Nuremberg. Since last October he has been the lone inmate at Spandau Prison in West Berlin. Throughout his long years in prison--longer than those ever spent by any other National Socialist--Hess has steadfastly refused to renounce his loyalty to Adolf Hitler and National Socialism.

Biddle and Oaksey have apparently had some belated qualms about their despicable roles in sentencing this guiltless man in the first place. Despite this, Biddle still went through the typical democratic pretenses. He claimed that in any change of the Nuremberg sentence, the Soviet Union would have to concur with the other occupying powers of postwar Germany, something the

Russians have refused to do. That this is a sham is shown by the fact that each of the other powers--Britain, France and the United States--have it in their power to release Rudolf Hess whenever their troops assume the monthly guard, announcing the results to the obstinate Russians as a *fait accompli*. In addition, the Bonn government could cause Hess to be released by simply refusing to pay the \$280,000 (100,000 Pounds) it costs to maintain the Spandau Prison each year.

As a gesture of defiance against the cruel and inhuman treatment being accorded Rudolf Hess, National Socialist comrades around the world may wish to send Yuletide greetings to him. These should be addressed as follows:

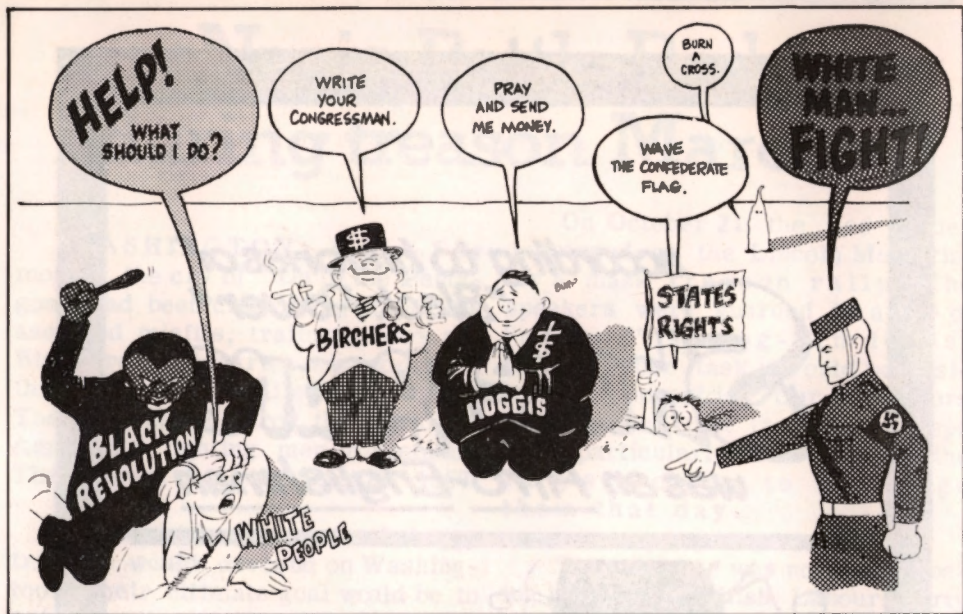

This Christmas Eve our comrade at Spandau will have spent exactly 9,724 days and nights behind democratic prison bars--9,724 days and nights of suffering for the "crime" of trying to bring peace to Aryan mankind during the tragic days of World War II.

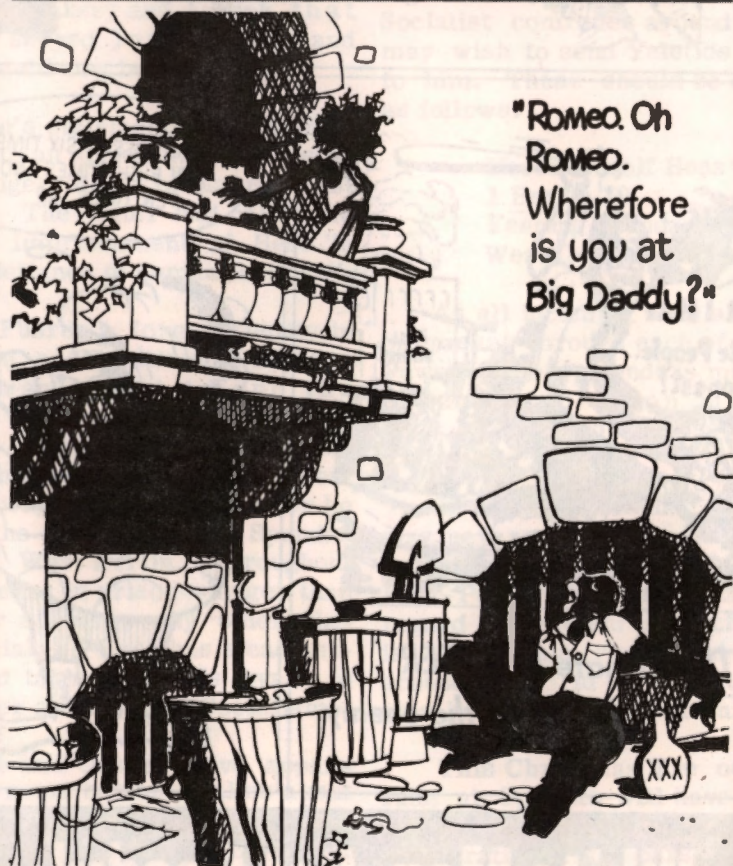

Nazis Battle Reds during treason Marches

WASHINGTON, D.C. -- For months the cry of "On to the Pentagon" had been circulating among the assorted misfits, traitors, Jews and Black revolutionaries who comprise this country's so-called "new Left". Their object: destroy the morale of America's fighting men in Vietnam. Their target date: October 21, 1967.

On that date thousands of shaggy traitors would descend on Washington. Their ultimate goal would be to reinforce the morale of Ho Chi Minh's Viet Cong butchers, although they disguised their purpose with pleas for "peace".

As has been the custom during such affairs, the American "right-wing" would vanish, almost as if by magic. All except one group, that is--the NATIONAL SOCIALIST WHITE PEOPLE'S PARTY.

One week prior to the October 21 target date, the advance Red guard began filtering into Washington. Most of them were hairy and unwashed, a few were the older, hard-line "revolutionaries" who were acting directly for Moscow and Peking.

During that week, the NATIONAL SOCIALIST WHITE PEOPLE'S PARTY began laying final plans for its confrontation with the Marxist rabble. Teams of infiltrators were sent into the Red strongholds in Washington's "hippy" districts. One infiltrator, Stormtrooper Mike Steward, was exposed after he had spent two days in a hippy den. But not before he was able to pick up valuable information and transmit it to Party headquarters by phone during trips to a nearby store "for cigarettes".

On October 21, the Red hordes converged on the Lincoln Memorial for a mass treason rally. The speakers were guarded by a line of "monitors", strong-arm leftist toughs whose task it would be to silence any opposition. Our infiltrators had reported that the peace creeps were particularly concerned with the Party's promise to challenge them that day.

The promise was not long in being kept. As British Labour Party leader, Clive K. Jenkins, launched a verbal attack on our American troops in Vietnam, four National Socialists smashed through the line of monitors. Jenkins went down amid a tangle of microphones and startled bodyguards.

Lt. Frank Drager, the Party's General Organizer, hurled the microphones and sound equipment down the steps of the Lincoln Memorial, then charged down after them into a



mob of fist-swinging peace creeps. In the meantime, SL Bill Kirstein had been tackled and wrestled to the ground by over a dozen burly monitors. Captain Chris Vidnjovich, leader of the Party's Midwest division, who was himself disguised as a monitor, and SL Spencer Redfield jumped into the peace creeps who

were mobbing Kirstein.

Meanwhile, Lt. Drager had scrambled free of his attackers and was on his way up the steps once again, this time to smash the remaining three microphones and Dr. Benjamin Spock, the new left's Jewish baby doctor. Before he could reach his targets, however, he was jumped by a pack of monitors and dragged over to police lines, where he was arrested.

Captain Vidnjevich and SL Kirstein were also arrested, and received ten-day jail sentences each. Lt. Drager was found not guilty of the charges brought against him. SL Redfield managed to avoid arrest in the confusion at the Lincoln Memorial.

As a result of the National Socialist action, the pro-Red treason rally was delayed nearly a half hour as rally officials worked feverishly to repair their damaged sound system. If they thought at the time that this would be the end of their opposition that day, they were badly mistaken.

PENTAGON BLOODLETTING

As one participant said later, "Before we had all left for the Pentagon, we had joked and compared ourselves to the 300 Spartans at Thermopylae. For awhile there it appeared that we might indeed be carried home on our shields!"

Matt Koehl, National Leader of the NSWPP, led a contingent of Stormtroopers and Party regulars to the Pentagon that afternoon to confront the mass of Red traitors. Each man carried a six-foot sign which spelled out two slogans, calculated to send any Communist or Communist-sympathizer into a rabid fury:

"BOMB HANOI!" AND "GAS THE VIET CONG!"

The National Socialist pickets took up positions on the lawn of the Pentagon, directly in the path of the oncoming "peace" march, and waited quietly as the advance guard of Red column began filtering onto the Pentagon grounds.

At first, the Vietnik Reds and Jews seemed stunned by the presence of the National Socialists. The United States Government had handed Washington to them on a platter. There were troops and U. S. Marshals present, but only to guard the Pentagon building itself. The beautiful parks surrounding the military installation had been turned completely over to the peace creeps, to do with as they pleased. They had not reckoned on any kind of opposition.

As the grounds around the Pentagon began filling up with shaggy traitors, their courage became reinforced by their numbers. Once their odds were a safe 100-to-1, they began trying to goad the National Socialist pickets into violence. However, each man demonstrated remarkable discipline and stood quietly as the human waste swarmed around, screaming obscenities and brandishing signs which read "Che GUEVARA LIVES HERE!"



After an hour of this, one peace punk finally worked up the courage to try to pin a flower on Eric Wenberg.

an Australian National Socialist visiting this country on special assignment. Wenberg responded positively to the challenge--he sent the "flower boy" sprawling with a well-aimed punch to the jaw.



Then a near-riot erupted as thousands of Vietnik traitors attacked, screaming "Kill them! Kill them!" Using their picket sticks as clubs, the National Socialists fought their way through the mob as police and Federal troops stood idly by.



Once clear, the bloodied but unbowed Party members regrouped and caught their second wind. It was obvious by this time that law and order had collapsed, and that complete anarchy ruled. National Leader Matt Koehl ordered his men to arm themselves with clubs and counter-attack.



Forming themselves into a flying wedge, the National Socialists demonstrated again that a small, disciplined and dedicated force can always smash an undisciplined mob. Matt Koehl, blood streaming down the side of his face from the earlier combat, led the Party members right into the middle of over 40,000 peace creeps.



At the sight of a Viet Cong banner, the National Leader lunged, beating the bearded carrier to the ground. At the same time, Eric Wenberg hauled the treason rag down. The first trophy of the day had been won!

More were to follow. Hundreds of placards calling for U. S. surrender were destroyed while the traitors who had carried them were left bleeding and stunned. Whenever the enemy showed signs of organizing a defense against the continuous assaults, the National Socialists waited, then attacked in a different area.



Thus began a series of "guerrilla" raids that were to last the rest of the afternoon.

NAZI "COMMANDOES"

On one occasion, the National Socialists "captured" a bridge under which the Red column had to march. The startled marchers ran for cover as rocks, sticks and even their own placards rained down on them from above.

As darkness began to fall over the Pentagon, the National Socialists planned for that night's activities. They had learned that day that it was "open season".

"Commando" squads were hastily organized and dispatched to the Pentagon. The scene there was like a page torn from the history of the Russian Revolution. The Pentagon, ringed by troops, loomed in a darkness dotted by campfires around which the Reds were huddled in the chill air. Thousands of hard-core Communists had settled in for a night-long siege, little realizing that determined National Socialists moved quietly among them.

One peace creep stopped a National Socialist squad to ask directions through military lines. The last thing he remembered was the smack of a fist against his face.

Another peace creep strutted arrogantly along a line of Army

troops. He thought the group of men approaching from the other direction and dressed in old clothes were other demonstrators, and started to wave a greeting. He was left sprawled on the pavement, in full view of the military.

And so it went, one after the other. When the National Socialists retired late that night, the grass around the Pentagon was littered with bruised and bleeding traitors.

The next day, Sunday, another group of Stormtroopers and Party members returned to the Pentagon. The night-long occupation of the grounds by the Jews and Reds was beginning to show. Tons of paper were strewn on the grass, the Pentagon walls were smeared with peace slogans and urine. The peace creeps had even defecated on the footpaths and roadways surrounding the Pentagon.

Once again, the National Socialists began "guerrilla"-style attacks against the assembled traitors. One Party member captured a Viet Cong pennant which had been flaunted by an unwashed Red, and then kicked him to the ground.

Stormtrooper Mike Steward wrestled a Viet Cong banner from a bearded peace creep twice his size, and burned it in full view of hundreds of traitors. Although TV cameras were present, this incident was not reported even in the local press.

MILWAUKEE MARCH

Capt. Chris Vidnjeovich of the Chicago headquarters and Lt. Frank Drager, the Party's General Organizer, added a new dimension to the racial struggle in Milwaukee September 23 when they led the first White march into the city's Negro section. The march followed a Party rally in a local park the previous evening; and came in response to successive Black marches into Milwaukee's White neighborhoods, led by the Red agitator, Father Groppi. Until the appearance of the National Socialists, all other groups claiming to represent the White people had confined their demonstrations to the safer White areas of the city.

In Milwaukee an important lesson was learned. A new phenomenon--finkism--made its appearance, based on the old formula, "If you can't lick 'em, lead 'em!" Since the so-called "White backlash" has now passed the point of no return, and the White masses have been raised to the level of irrepressible race-consciousness, the Jews and their political hacks have adopted the technique of setting up phony "pro-White" protest groups

at the first sign of possible racial confrontation in a local community. These organizations then systematically thwart any spontaneous moves toward White Power, while simultaneously opposing the legitimate efforts of a genuine racist movement. In other words, it is a fink operation from top to bottom in the service of the Jewish System and its anti-White program, and one which we can expect to see used with increasing frequency as the growing racial conflict affects every large American city. Finkism can and will be combated. But first it must be recognized.

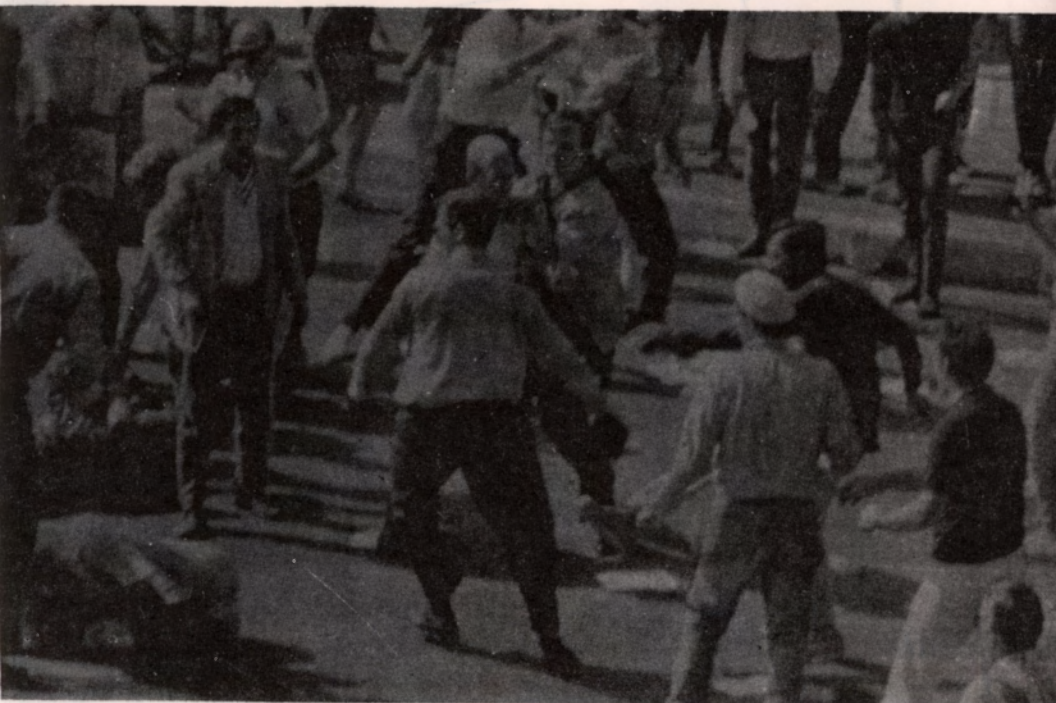
In Milwaukee the fink operation took the form of a Jew-sponsored outfit, called the "White Power Rangers", which--while stealing the concept originated by Commander Rockwell--deliberately attempted to sabotage and disrupt NS efforts at every turn. Thus, by serving as a Fifth Column for Father Groppi's anti-White agitators, this group did more damage to the White Cause in Milwaukee than the Blacks themselves; and constituted virtually the only opposition the National Socialists met there.



The lesson is obvious. Before a successful fight for White Power can be waged, the fink opposition to National Socialism must first be smashed. There is only one path to White Power. That is the path of National Socialism. Anything that obstructs this path, obstructs the achievement of White Power, and must be pushed aside.

CALIFORNIA

NAZIS SMASH CREEPS



As a mob of leftist traitors paraded down Los Angeles' Wilshire Boulevard in August, 30 National Socialists charged into them. Spearheading the attack on the Red column, Captain Ralph Forbes and Lt. Mike Brown charged into the shaggy peace creeps, swinging their fists.

As a sound truck full of Jewish Communists appeared--with banners proclaiming "Down with the United States" and "Black Power"--Captain Forbes leaped into the cab of the truck and ordered it to halt. Other troopers hauled the driver out of the truck and bounced him on the pavement. Meanwhile, Lt. Brown leaped

onto the truck's flatbed and sent the eight club-wielding Jews on board scattering over the sides.

Then, as a battery of jars filled with red paint whistled overhead, to mark out Red targets, a second wave of Stormtroopers ripped into the march. The brown-shirted National Socialists ripped down Viet Cong flags, Red placards and sent hairy Reds screaming for cover.

As a result of this action, Capt. Forbes, ST Robert Walton and PT George Carpenter were arrested and charged with "disturbing the peace" and "rioting". In court Judge Phillip

Newman sentenced Capt. Forbes to 60 days in jail and placed him on three years probation.

Sentenced with Capt. Forbes was ST Robert Walton, who received 30 days and three years probation.

PT George Carpenter was singled out for a mental health attack by the judge because the Red-loving jurist had seen him "kicking people (peace creeps) right and left". Carpenter was placed under psychiatric observation because he had dared oppose treason. This sort of tactic is a familiar Jewish maneuver to silence their opponents.

Nazis Welcomed in DIXIE



SOME OF THE ESTIMATED 1,000 hecklers at last night's open housing march hold up signs distributed a few minutes earlier. Police meanwhile

arrested two members of the American Nazi Party, from Chicago. Police also used tear gas for the third successive night.

Captain Chris Vidnjevic and A/Lt. Fred Catalano, of the Party's Chicago headquarters, appeared in Louisville, Kentucky this summer to organize White resistance to Black "open housing" demonstrators. Thousands of White people, anxious

for leadership in the struggle between the races, flaunted swastikas and "White Power" placards in the faces of screaming Negro demonstrators.

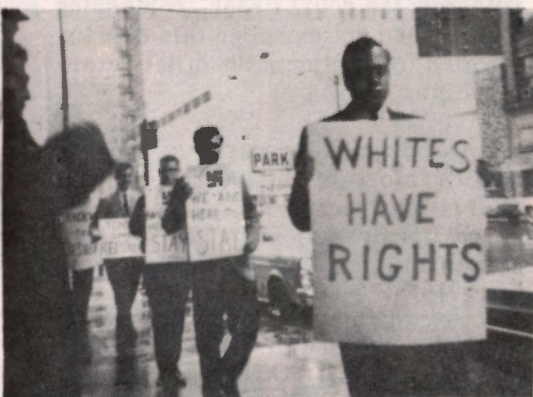
Black mobs had ruled the streets

for days prior to the appearance of Captain Vidnjevich and a contingent of Chicago National Socialists. However, an army of angry White people immediately rallied to the swastika and staged counter-demonstrations against the Black "open-housing" invaders.

Police harassment was obvious during the National Socialist campaign. Both Capt. Vidnjevich and Lt. Catalano were arrested as they led a White Power demonstration. The two were charged with "disorderly conduct" and "criminal syndicalism" --a charge involving treason against the State of Kentucky. If convicted, they face up to 21 years in prison and a \$10,000 fine.

Later, police also arrested Party Member Russ Frauenhoffer while he was showering in his hotel room, and charged him with "disorderly conduct". Apparently it is a crime to be clean in Louisville.

Reacting to illegal police pressure, angry Whites pelted police and Black demonstrators with rocks and bottles, and overturned a police cruiser.



Lt. DRAGER not GUILTY

SPOTSYLVANIA, Va. --Lt. Frank Drager, Jr., leader of the Party's Spotsylvania unit was arrested here recently after he had purchased a package of cigarettes at a local store. He was charged by police with violating a court order prohibiting him from entering the store, which had been the scene of a racial incident in mid-August.



The court order had been issued by Spotsylvania County Judge A. Nelson Waller in the wake of a disturbance at the W. A. Brooks Store between local Whites and Negroes. A group of drunken Blacks had entered the store and began using profane language when they saw a Confederate flag on display there. After they began throwing punches, they were escorted from the store in the best Southern tradition.

However, the Black trouble-makers returned later and assaulted two White men in their fifties.

The Negro toughs later claimed that they had not started the trouble.

A/Lt. Fred Catalano, of the Chicago Headquarters, leads an NS picket to protest a Jew Communist anti-Nazi meeting seeking to keep National Socialists from exercising their freedom.

Their tale went something like this: after a hard day in the cotton patch, they had gone to the store for some gas. They were told there that Black trade was not welcomed. Several White men then supposedly attacked them with soft drink bottles.

Later that evening, another Negro courageously returned to buy beer. He claimed that he had been called abusive names and that he had retaliated by sitting a White youth on top of a soft-drink box. After this display of heroism, he supposedly marched triumphantly out to his car where he was assaulted by two fifty-year-old White men. He, of course, manfully fought them off (they were armed with knives, naturally) with his bare hands.

Somewhere during all this, Lt. Drager was supposed to have wall-poled a Negro with a fence post, while another White man, Bill Murphy, allegedly beat another Black unmercifully with a "Nazi flag".



CHARGE DROPPED

At a later trial, Judge Waller dismissed 11 charges resulting from the incident, including those brought against Lt. Drager. However, Waller issued a court order forbidding Lt. Drager and all other Party Members from ever entering the Brooks store.

Lt. Drager announced that he would test the legality of Waller's order. He contended that, since he

had been convicted of no offense, the court order was illegal. He also pointed out that since the Brooks was the closest to the Party printing plant, the order would cause unusual hardships.

Lt. Drager informed Waller by letter that he would appear at the store to make a purchase and was prepared to go to jail, if necessary, to ensure that the rights of National Socialists were not violated.

On Friday, September 15, Lt. Drager entered the store in full Stormtrooper uniform and bought a package of cigarettes. Sheriff's deputies were on hand to inform him that the illegal court order was still in force. The deputies later secured a warrant for Lt. Drager's arrest on charges of "contempt of court", and took him into custody. Bail was set at \$300 but after one night in jail, Lt. Drager was released in his own recognizance.

WALLER BACKS DOWN

Final victory was attained on the day of Lt. Drager's trial on "contempt" charges. Realizing that he faced a false arrest suit, Waller fined Lt. Drager a nominal \$2 and withdrew the court order, remarking that he had not expected this demonstration of National Socialist determination.

When Lt. Drager returned to Brooks store on the afternoon of his trial he was met by a cheering crowd of local residents, who congratulated him on still another National Socialist victory.

Although most of the activities of the NATIONAL SOCIALIST WHITE PEOPLE'S PARTY were "blacked-out" that day, at least one substantial segment of the population knew that National Socialists had been there--the Reds, Jews and Black revolutionaries who had come to "close down" the Pentagon.

NAZIS CONVICTED

Three National Socialists were convicted of "disorderly conduct" in the U. S. Commissioner's Court recently. The convictions resulted from their roles in trying to break through military lines during the Commander's funeral attempt at Culpeper.

Captain Chris Vidnjovich, leader of the Party's Chicago unit, had jumped atop the roof of the hearse, and then had attempted to crash through a line of MP's.

Stormtrooper Mike Steward and Party Member Douglas Niles, who had followed Captain Vidnjovich, were also convicted.

The three National Socialists received suspended sentences.

IOWA N. S. ACTIVITY

Immediately following the assassination of Commander Rockwell, National Socialists in Clinton, Iowa expressed their feelings by lowering an American flag to half mast in a public park.

Clinton police are reportedly concerned over an increase in Party activity there in recent weeks. Swastika banners, stickers and Party literature have been found on display throughout the city.

NAZI rights denied

SPOTSYLVANIA, Va. --An application by the Spotsylvania unit of the NATIONAL SOCIALIST WHITE PEOPLE'S PARTY for a booth at the local agricultural fair was refused for political reasons.

Lt. Frank Drager reported that at first fair president Emory Payne claimed that all booths had been rented. However, when an "unidentified" caller representing a "British trade association" applied for a booth, Payne did a complete about-face and offered to provide a booth.

When Lt. Drager confronted Payne with his lie, he was forced to admit that the application had been rejected on political grounds.

Lt. Drager reports that he is still considering whether to bring suit against Payne.

ELIZABETH, N. J. --New Jersey Party sympathizers demonstrated their support for National Socialism when they raised the Swastika banner



Nazi Flag Up, Down

Nazi flag was discovered today flying from flagpole at the Masonic Temple, 668 N. Broad St., Elizabeth. Leroy Jastram, custodian, noticed it when he reported for work. Police, who took it to headquarters, theorize that a prankster used fire escape to get to the pole on building's roof.

Police are looking for the person or persons who are believed to have lowered the flag to half mast Friday afternoon, apparently by followers of Nazi leader George Rockwell who had been slain a few hours earlier. A former follower is held in detention, Va., for the murder.

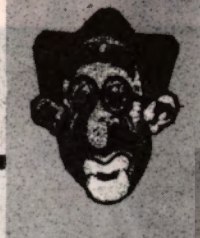

Courtroom Hysteria

An uneasy silence dominated the Arlington County Courthouse moments before the accused assassin of Commander Rockwell was to appear there.

Police were keeping a cautious eye on a delegation of National Socialists who had filed into the room earlier.

Arlington County Judge Embry entered and the judicial ritual began. The sneering Judas was led before the bench, surrounded by a small army of police and special guards. Suddenly, the tense stillness was broken. Eric Wenberg, visiting the United States on special assignment from the National Socialist Party of Australia, lunged at Patler, shouting "You filthy assassin! You Communist swine!"

Before Wenberg was able to reach Patler, however, he was tackled by police and wrestled to the floor. As he was dragged from the courtroom, Wenberg cried, "Long live the American Nazi Party! Long live Matt Koehl!"

The courtroom had erupted into general bedlam. People were on their feet, milling around. Somewhere a woman screamed. Frightened curiosity-seekers hurried to the exit. But Patler was unaware of the commotion--at the first sign of

trouble, he had fainted. As police hustled him from the room, he hung limply in their arms.

Minutes later, Wenberg appeared before Judge Embry on "contempt" charges and was sentenced to 10 days in jail and fined \$50.

DEPORTATION ORDERED

The U. S. Immigration authorities, acting under political pressure, immediately announced that they had begun deportation proceedings against Wenberg. However, Wenberg's record since arriving in this country was spotless and the authorities were forced to some digging before finding grounds to order his deportation. It was learned that Wenberg had worked for a short time in Arlington, Virginia and it was on this basis that his deportation was ordered.

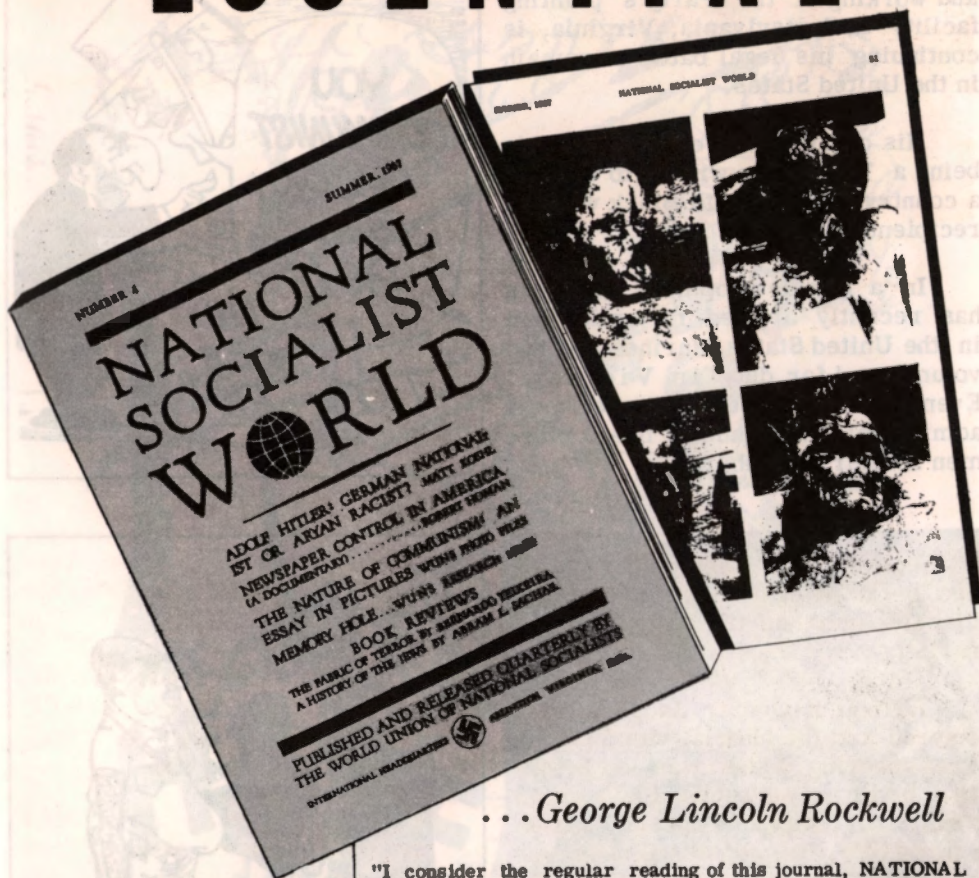
From his jail cell, Wenberg appointed Lt. Frank Drager, NSWPP General Organizer, his legal representative.

At Wenberg's first hearing, bond was denied. After Lt. Drager filed appeal, bond was set at \$5,000. All attempts to have this fantastically high figure reduced were rebuffed by the Immigration authorities.

In order to protest his harsh treatment by a supposedly "liberty-loving" government, Wenberg went on a hunger-strike that was to last two weeks. At the end of that time, he collapsed and was taken to the prison hospital where he still refused food, vowing to eat only when he had been released. Hospital authorities, however, force-fed Wenberg.

When a dedicated National Socialist learned of Wenberg's plight, he provided the \$5,000 needed to secure the Australian National Socialist's release.

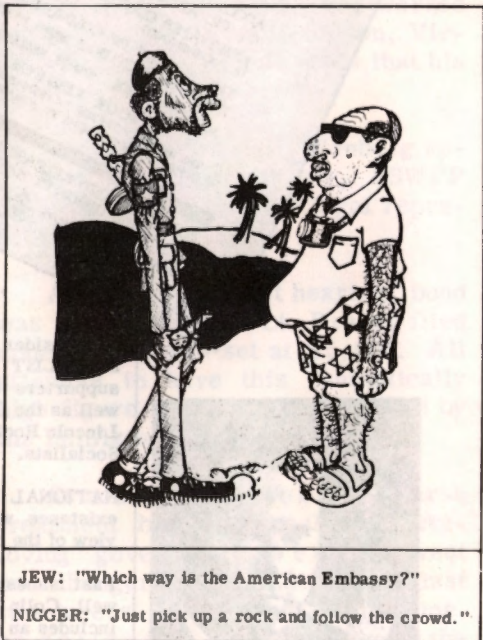
Wenberg, currently free on bond and working at the Party's printing facility in Spotsylvania, Virginia, is continuing his legal battle to remain in the United States.

His only crime apparently is being a White man willing to work in a country infested with Black welfare recipients.

In a late development, Wenberg has recently applied for enlistment in the United States Marines and has volunteered for duty in Vietnam. Even the disinterested observer must admit that this country needs more men like Eric Wenberg.



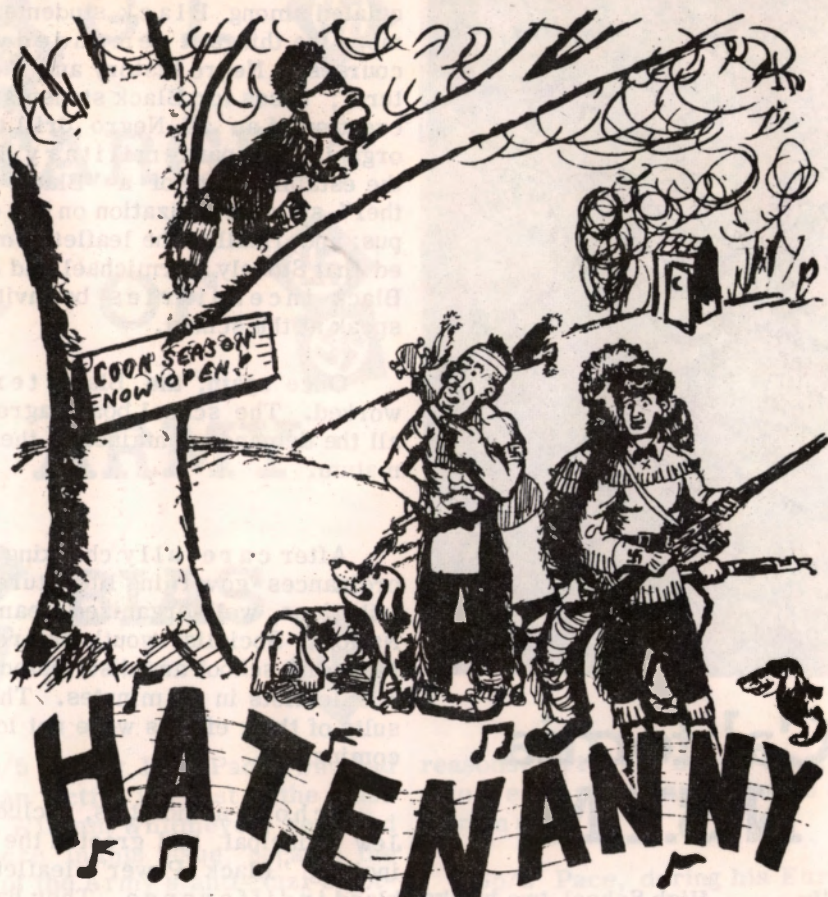

G. I. TARGET OF ARMY BIAS



Sp/5 Bobby Lee Pace, who had taken an active interest in the case of Pvt. William Whitmeyer, reported elsewhere in this issue, became the target of the Army's anti-Nazi bigotry himself. On November 26, he suddenly received orders transferring him back to the United States from his unit in West Germany.

The Army was reportedly acting on the orders of West Germany's Bonn regime because Pace's alleged National Socialist activities were a "source of embarrassment" to the Bonn puppets. However, Pace's battalion officer, Major Charles Graves, said of him, "He's a straight troop. I wish I had a battalion of men like him."

Apparently, upper-echelon brass who are closer to the sources of Jewish influence, did not agree. They ordered Pace's transfer state-side, but declined to give any official

reasons. At the same time, they also relieved Major Graves of his command.

Sp/5 Pace, during his European tour, carefully avoided violating codes of military conduct. His behavior can only be described as exemplary--he is a credit to the Army, his country and the Party.

The Army's action, although not surprising in view of its anti-White programs, is completely groundless. This is demonstrated by the fact that Pace has had no charges placed against him, nor has he lost his rank.

Because of the obvious suppression of free speech, Pace says he plans to refrain from further political activity until his discharge in six months, at which time he will devote himself full-time to the struggle for White Power.

but they admit they have no grounds for prosecution. None of the material distributed was obscene, nor did it advocate the overthrow of the government. Moreover, our NSYM organizer had the foresight to study laws governing literature distribution in schools, and carefully avoided breaking them.

NIGGERS Flunk Draft

President Johnson's report on the status of the Negro American was printed in the November 14, 1967 issue of the Congressional Record (page S. 16415).

The report is the joint work of the Bureau of the Census and Bureau of Labor Statistics. Herman K. Miller of the Bureau of the Census and Dorothy K. Newman of the Bureau of Labor Statistics directed the project and prepared the text. It is a statistical report about the social and economic condition of the Negro population of the United States. Virtually all of the statistics are from the census or from Federal Government studies designed and conducted by technical experts. We quote:

"Six years ago, nonwhite young men averaged two years less schooling than white young men. Negroes are completing high school and going into college in increasing proportions.

"Despite the gains in 'years of education attained', the only data available that deal with the 'level of achievement' show a major gap: Negro students test out at substantially lower levels than white youths; up to three years less in the twelfth grade. Further, about 43% of Negro youths are rejected for military service because of 'mental' reasons,

compared with an 8% rate for white youth."

This same report gives the proportion of Negroes in each of the following 10 cities for 1950, 1960 and estimated 1965:

U.S. Nazis in the Armed Forces

Pvt. James DeWitt (pictured) was arrested at Culpeper National Cemetery because he dared mourn his fallen Commander. He was charged with "participating in a political action".

Pvt. DeWitt has long been a National Socialist. He is a friend of many of the officers and men at National Headquarters, and had the privilege of meeting the Commander on several occasions.

As a result of his appearance at Culpeper, Pvt. DeWitt has been given 45 days extra duty and restriction by military authorities after being found guilty of trumped up charges. He has also been reduced in rank from PFC to Private. If anything, however, these hardships have only stiffened Pvt. DeWitt's determination to continue the struggle for a National Socialist victory.



Below is Pvt. DeWitt's personal account of his time in the United States Army, written before his name and photo appeared in countless papers across the nation.

EDITOR

During July 1965 I enlisted in the United States Army with the uppermost intention of serving and defending these great United States of America. After considerable training I was assigned to the position of Small Arms Repairman.

Prior to my enlistment I was a supporter of the American Nazi Party and as such was highly concerned with the present race problem in America. However, in my middle-class environment at home in Michigan, I never had any real contact with Negroes and had never been taught to hate or even to dislike them. I had therefore never been prejudiced on the matter. My racism was purely academic!

But the Army fixed that! They forced me to live with stupid, drunk-

en, filthy and horribly immoral niggers. The issue became personal, and for the first time I really witnessed the brutal savagery that I had learned so much about from books and pamphlets. On the first of April 1967 I joined the American Nazi Party and the ranks of Commander Rockwell. The Army finally made up my mind for me.

From the very beginning at Fort Knox, where our unit suffered scores of Detroit "spear-chuckers" (under a Jewish C.O.), to this very day, I have been forced to live with, work with and take orders from black jungle coons (which is what I regard all of them now, regardless of rank).

Every Army facility, places of work, entertainment, housing (even private housing off post) is integrated

to the utmost. To me, the Army seems to be the best promoter of Black Power.

The military is the blueprint for a mongrelized slave America. The United States Army, fantastically low on morale, since there can never be a true comradeship between alien races, is an active force for racial ruination here and in the sadly occupied nations where we unleash our Negroid troops, drooling with lust.

I have found that the ranks of the United States Army is filled with good White men that are sympathetic to the American Nazi Party, many of whom are members and others who have recently become or will become members shortly. Most of them feel exactly the same way as I do about the race-mixing Army but each of us are loyal Americans and loyal White racists that will fight for America to the end.

In his last days, the Fuhrer himself declared that "it certainly will be America" that would again raise the swastika banner. Now the last roll call is sounding for the White Race in this nation and this world, and as a member of the National Socialist White People's Party, I am not fearful, even in the shadow of prison bars, to proclaim that my first loyalty is to my great White Race!

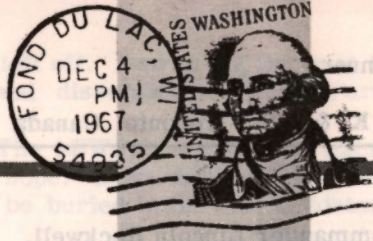
Vast numbers of men in the military have been joining the ranks of the Party lately and there has been an ever increasing rise in support among men in uniform.

NAZI YOUTH

The existence of a National Socialist youth group in Oyster Bay, Long Island, reportedly has Jewish

leaders in "near panic", and school authorities, police and pink clergymen are scrambling aboard the Jewish anti-Nazi bandwagon.

Richard Nodell, the Jew-loving principal of the Oyster Bay High School, is said to have dragged 15 members of the National Socialist youth unit onto the carpet. All 15 refused to disavow their admiration for Commander Lincoln Rockwell, or refute their National Socialist faith. Nodell said of his unsuccessful confrontation, "This group has real mean vein to it".

One local left-leaning clergyman even called in the Jewish Defamation League, after 50 Jew adults visited him and offered to help fight the National Socialist teens. The clergyman, Paul Bowles of the Oyster Bay Methodist church, said he summoned the ADL because "They're experienced in this sort of thing, and we aren't".

Bowles also made the fantastic claim that the 30 or so members of the National Socialist youth group met regularly in a wooded area to "drill and plan attacks on Jews and Negroes".

A school social worker, doubtlessly the product of "progressive" education, added his own embellishments to the "threat" of violence: "Many of the known members possess a gun." And, of course, the story has its usual Jewish hero, in this case a high school "athlete" who alleged that he had been "threatened".

Despite pressure from Oyster Bay's leftwing establishment, the National Socialist young people are determined to continue their activity.

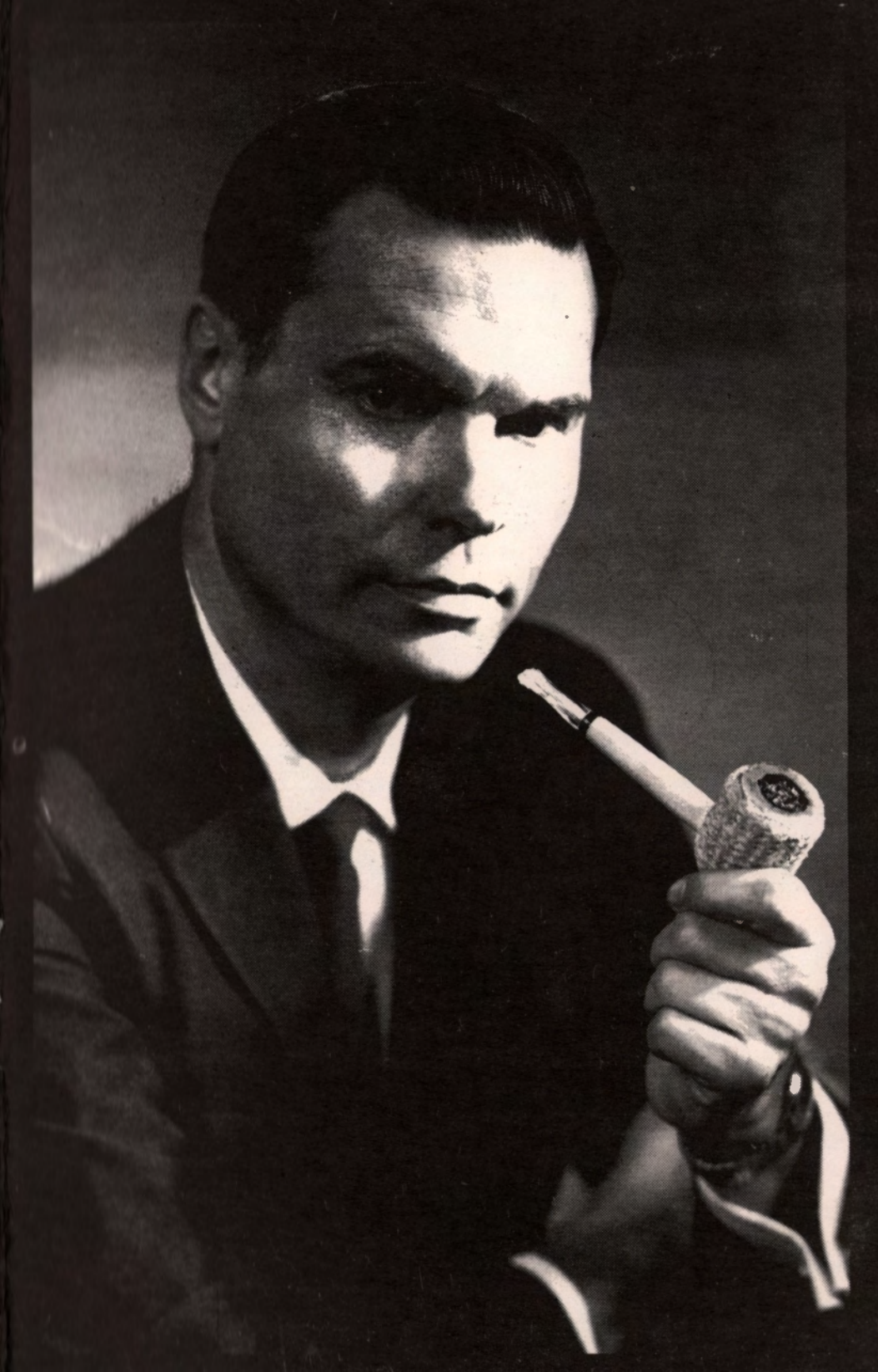
