## A Spark of Hope in South Africa

On May 31st, 15,000 White racialists gathered at the Voortrekkers Monument in Pretoria for a political rally. The vast majority were Afrikaners and most came to hear Eugene Terre Blanche, leader of the Afrikaner Resistance Movement (AWB), despite the fact that the meeting was jointly sponsored by the Conservative Party, the Reconstituted National Party and the AWB. The Afrikaner Resistance Movement is by far the most radical of the three, and the smallest though that seems to be changing very rapidly.

Two weeks prior to the Voortrekker Monument rally, 3000 of Terre Blanche's supporters stormed the hall where President P.W. Botha was to address a congress of the ruling National Party. Terre Blanche and his activists broke through the

cordon of National Party security guards and took the stage completely disrupting the congress and preventing Botha from speaking. This daring raid made Terre Blanche a national celebrity and hero to Afrikaner nationalists who see the National Party as selling out to the multiracialists. The National Party came to power in 1948 as a White nationalist political force. It created the system of Apartheid by which the colored races would be used to serve the White race and would be prevented from exercising any substantial political power. It was and is essentially a system of racial wage slavery. Apartheid, like all slavery, contained the seeds of its own destruction. It began as a compromise between the true racialists who wanted a White

## Divide and Conquer: The Death Knell of the Family Farm

In the past five years hundreds of thousands of farmers have been forced out of business. In 1985 5% of all farmers (approximately 100,000) were forced to give up farming and it is estimated that another 100,000 will fall out in 1986. It is not the agribusinessman or the small part-time or tenant farmer that is suffering the destruction of his hopes, dreams, and hard work, rather it is primarily the medium sized farm that is under

the axe - the family farm. At five percent a year it will not be long before the family farm goes the way of the mom and pop store - extinction is only a matter of time.

One of the most interesting aspects of this tragedy is how it is being handled by the capitalist press. The press paints the farmer in trouble as being inefficient and/or greedy, implying that this is a healthy weeding out process. All sorts of capitalist economists,

who have been wrong in their theories and predictions for years now, are trotted out to tell us how wonderful it is to get rid of this economic deadweight. And the press completely ignores the social consequences of this latest assault on small business.

So it is time to place things in context and to see what the truth really is. It is not the marginal or inefficient farmer that is now

# The Best of the Farmers Are Dying

in trouble, rather it is the most successful small farmers of the late 1970s who are now going down the tubes. How can this be? Six to ten years ago when land values and inflation were high, government advisors from the Agriculture Department, private financial experts and banks were all encouraging farmers to invest soundly - in land. But the banks would not lend to just anyone, rather they restricted their lending according to standard practice to those who were good risks. The large agribusiness firms were lent money and the middle level family farmers with proven track records were lent money. The rest, to their good fortune, were denied loans for land purchases. Those with good track records were the farmers who had been in farming for many years and had made a high percentage profit, and who had managed well and saved such that they had enough money for a substantial downpayment (as the banks would only lend up to 80% of the value of the land). It was the best of the small farmers who got loans.

Well, guess what? The government

advisors, the expert private economists, the bankers, and the farmers who believed them were all wrong. For a number of reasons which had nothing to do with how hard or how efficiently the American farmer was working, the market for food collapsed. So who now is paying the price? The government advisors? The "expert" private economists? The bankers? The national policy makers who launched the futile grain embargo against the Soviets, or the ones who concocted the greatest recession since the Great Depression in order to cut inflation, or the ones who have done nothing to protect not only our foreign markets but even our domestic markets from subsidized foreign competition? (In May the U.S. actually imported more food than it exported which illustrates how absurd our policy has become). Few of the above will suffer for their ineptitude. No, it is the family farmer who borrowed to buy land that is now worth little that will pay the price. The ones who after 10, 20 or 30 years of successful farming have suddenly become "inefficient dead-

weight" that must be threshed from the system.

The family farmer is the latest in a long line of small businessmen who have fallen prey to capitalist market manipulation, and to orchestrated press campaigns that push capitalist mythology in order to prevent grass roots political support from forming around the target. The capitalist strategy is to isolate the group under present attack by convincing similar groups and consumers that their interests are either divergent or in direct conflict.

For example, consumers are told that farmers want more government subsidies or higher prices. Which would result in either higher food prices or higher taxes. What they are not told is that the bulk of government subsidies now go to the large farm operations and agribusinesses that have the money to contribute large sums to the coffers of politicians in order to buy special tax breaks, irrigation projects and direct supports. What they are not told is that as small businessmen are driven out of an industry, and it becomes concentrated in the hands of a few major firms, price fixing inevitably results such that prices rise rather than fall. This happens because the major firms realize that price wars are self-destructive, and that they can make more money by just accepting their portion of the market and following the price increases of the leader. Once the leader or leaders realize that a market discipline has been established they raise prices until a substantial part of the market balks. Then they open discount stores in order to prevent renewed competition from small business.

Large chain department stores are supposedly more efficient than small retailers, at least that is what we have been told since the turn of the century when the large capitalist retailers decided to establish national chains and eat the competition. So why does Wards lose hundreds of millions of dollars every year? So why is Sears desperately trying to diversify its operations away from retail sales?

Why do almost all major retailers now have budget divisions where they sell goods cheaply? We thought they were selling their goods as cheaply as they could reasonably be sold. The fact is that the huge retailers exploited their monopolistic position so far and raised prices so high that a large portion of the American public has balked.

Exactly the same process occurred in the case of the mom and pop grocery store. The grocery chains claimed that they could sell food cheaper than the small grocery store and for a while they did - just until the small stores were driven out of business, and then it was the same old capitalist story. Price manipulation began as soon as a market discipline was imposed by the demise of small business. Prices got so high that entrepreneurs began opening discount food warehouses which were then bought out by the major grocery chains.

## Leaders have a duty to govern for the benefit of the nation

---

Is the mom and pop store really inefficient? How many corporations can get their employees to work 12 hours a day 6-7 days a week, month after month, year after year? Yet that is what the small businessman does as a matter of course - and for very little money. According to the Small Business Administration the average small business owner averages \$25,000 a year. It is the small businessman who has the entrepreneurial spirit - who uses his imagination and takes the risks, not the careerist corporate executive. It is the small businessman who is close to the action and close to the customer and so it is he who can make the important market adjustments, not the ivory tower vice-president.

So why is it that our small businessmen cannot stand before a concerted capitalist attack? Because in a situation were everybody loses money, the deep pockets prevail. The big capitalists are masters of the squeeze scenario. They will either lower prices to the point where no competitor in the

market can make money or they increase their advertising budgets to such an extent that everyone loses money. The small businessman cannot afford to take losses as his resources are small to begin with and he must feed his family, so before long he is out of the game even though his operation ran more efficiently, provided better service, and lost less in terms of percentage on gross sales than did his capitalist competitor.

The big capitalists have other advantages which also have nothing to do with economic efficiency. They have the resources to buy the politicians and lawyers they need to get special tax breaks and governmental benefits and subsidies. They also get discounts for buying in bulk from suppliers - this is an anti-trust violation, but one which the government almost never enforces.

In sum, the plan of the capitalists is divide and conquer. They are determined to concentrate ever-increasing wealth and power in their own hands, and to do this they isolate and attack the farmer, the worker, and the small businessman each in his turn. What they fear most is a Nationalist because only Nationalism can unite the farmer, the worker and the small businessman against the wealthy ruling class which rules not for the benefit of the People, but for the benefit of itself. Leaders have a duty to govern for the benefit of the Nation - those that do not forfeit their right to lead. The plutocrats are in forfeit - now it is up to us, the People, to take their power from them. It will be a long and hard struggle against an entrenched and powerful system, but in the end we will be successful if we can get the farmers, the small businessmen, the workers of the hand and the workers of the mind to set aside their selfish schemes, to reject the Self-Interest ethic of capitalism, and to unite behind the National Democratic Front which is the only political force in America that is dedicated to the interests of the Nation as a whole. If White Americans do not abandon self-interest then the capitalists will be completely successful in their exploitation of our People and Nation - and we will deserve our doom. GG

## Beyond 1984

Big Brother is alive and well this year as marketers are using the Universal Product Code to look over your shoulder and into your grocery bag. Research firms can now monitor shoppers through a spyglass at the check-out counter via the scanner panel which determines the size, brand, and price from the series of black bars on the label known as the UPC. In approximately 20 cities, grocery stores have kindly volunteered to be equipped with the special scanners. Through them records of all the shoppers' purchases are provided to the producers. Because this system gives data for every item available in the store, the marketing firm can not only find out what we buy, but what alternatives shoppers have.

In the hands of Test Marketing Group or its competitor, Information Resources Inc., every choice made by "participating" consumers provides an encyclopedia to what sells and why. Their clients, like General Foods, Pepsi, and Proctor & Gamble, want to know how manipulable we are, and pry into our grocery list to devise the best methods of selling and advertising. Manufacturers especially want to know how well consumers respond to their televised persuasion, and have taken the current UPC marketing services into the privacy of the home.

Big producers are hiring the TMG and IRI groups to set yet another spy loose amongst consumers through TV ads. Monitors in the homes of participating shoppers with cable TV check the television every five seconds to see if the set is tuned in and to what station. These new networks are also used to collect "psychographic" data - characteristics of a population describing not only demographic facts but consumers' values and lifestyles.

Electronic wands attached to TV sets are being tested with which a shopper would scan the UPCs of groceries unpacked at home. Any magazines, newspapers, or books bought could also be recorded, so they know not only what you eat but what you read. Although every researcher in this field admits the Orwellian implications of such in-

# The Revenge of Johann Sebastian Bach

Washington, D.C.: Most Americans know their nation's capital only from the picture-postcard image of it which appears in their living rooms nightly on the video screen. They are shown the halls of power: the White House, with its well-manicured lawns; Congress, with its imposing white dome; the Supreme Court, with its impressive neo-classical architecture. They are shown monuments to the authentic heroes of days gone by: Washington, Jefferson, Lincoln, and others.

But what most Americans don't see of Washington is the grim reality: like every other U.S. city, it is a dirty, dangerous, disgusting sinkhole of racial decay and corruption. It is pimps and prostitutes; dealers and junkies; legions of homeless bums of both sexes sleeping on steam-grates in the dead of winter. It is endless square blocks of urban squalor: teeming ghetto tenements full of angry and sullen Blacks, unemployed and unemployable. It is race-mixing; it is White degeneracy; it is Levantine merchants with bargain-basements filled to overflowing with shoddy goods.

It is the spawning ground for every social evil and toxin. Washington, D.C., is, if you will, a miniature New York City. It is what the Jews and plutocrats would like to see the whole country become: a hideous Third World nightmare; the rotting corpse of Western decadence; the death of our Race.

Basic wisdom: If you're White, stay away from the cities; there is nothing for you there any more, except infection-- spiritual, racial and sexual.

A few summers back I found myself trapped in Washington during the daily rush-hour gridlock. I was stuck in traffic on 14th Street, Northwest-- a major thoroughfare which is also an open sewer of racial pollution. It was just after 5:00 p.m., the time when most of the denizens of Washington's night streets first stir, and then stagger, blinking, into the smog-shrouded late-afternoon light, to

begin whatever hustle or scam they are involved in to keep themselves alive from one day to the next.

Although I was only three blocks from the White House, I was surrounded as far as I could see by porno shops, hookers, drug addicts and similar by-products of urban civilization and capitalism. Now and then a rodent-like federal bureaucrat with his briefcase would scurry by, his eyes fixed on the pavement in front of him, never looking up or around at the ugly reality of which he was a part.

Washington in the summer is unearthly hot and humid, with the air thick and stifling. Partly as a defense against that, and partly to shut out the general unpleasantness, I had the windows of my car rolled up and the air conditioner turned on. To help drown out the unavoidable cacaphony of city noises, I had my stereo tuned to the local classical music station.

The spot at which the following incident occurred was only a few steps away from the site where a luckless French tourist had been stabbed to death during a robbery

by a drug-crazed Black a few nights earlier. The unfortunate visitor to our shores had doubtlessly perished under the misconception that he was safe walking alone on a well-lit busy street at night, for, after all, he was in the capital city of the most powerful country in the world, and he was less than a half-mile from the official residence of the chief executive of that country. Poor misled bastard, I mused to myself.

I waited impatiently for the traffic ahead of me to free up so that I could escape this hellish scene. The light changed, and then changed again. Still no movement. In front of me a 300 pound Negress exchanged obscenities with the Pakistani driver of the cab from which she had just exited. An anorexic Puerto Rican whore lounged listlessly in the doorway of a fast food joint.

On the corner next to me stood a mulatto with an over-sized ghetto-blasters affixed to his shoulder, blaring out the latest pop hit by Michael Jackson or Prince or some equally objectionable darling of

the entertainment media. As one would expect, he had the volume turned up well past the point of distortion, so that the obnoxious rhythms and screechings of his radio penetrated even my little temperature modulated capsule of sanity. As he shuffled on down the street, mercifully passing out of earshot, I decided that the time had come for a counterattack. It would be no more than a token gesture of defiance, I realized, but at least it would afford me the personal satisfaction of cathartic release. I switched off my air conditioner, rolled down all of my windows, and cranked my stereo up as loud as I could stand it. Instantly the filthy steel and concrete urban canyon was filled with the intricate and vaulting baroque harmonies of the Brandenburg Concert No. 2 in D Major by Johann Sebastian Bach.

As I expected, the raceless sludge occupying the sidewalks was

stunned by the sudden turn of events. A light-complexioned Black, who I assumed from his manner of dress was some sort of pimp, cupped his hands over his ears and retreated into the sanctuary of an X-rated bookstore. Slowly the sidewalk emptied, as the street people drifted away in pain and confusion from this audio intrusion into their fetid world.

A lone Negro/Hispanic hybrid, dressed in a synthetic flowered shirt unbuttoned to his navel, braved Bach's exalted testament to Aryan genius. His eyes scanned the suddenly-vacant sidewalk and the congested roadway in a frantic effort to discern the source of the agony which was assaulting him. Our gazes met: my face was set in what I imagine was a slight smirk of self-satisfaction; his was contorted in revulsion and hatred at the horrible sound which he found so-- so alien. **MMC**

society and the capitalists who wanted cheap labor. But as in every pluto-democratic political system money talks and soon the capitalists were able to consolidate their control of the National Party and drive out the idealists. Then as the internal political situation became more volatile and strikes arose, and as foreign economic sanctions came into effect the leaders of the National Party began to feel that dreaded pinch in their pocketbooks. So they began down the road to racial oblivion called compromise.

But this was the inevitable consequence of Apartheid. It just moved to its logical conclusion more quickly than with most slave systems. In a slave society hard work is looked down upon as dirty and degrading, and that is the beginning of a psychological degeneration that destroys the will of the people to sacrifice. The people need their slaves to maintain their artificially high standard of living and to avoid manual labor. They become so addicted to material comfort that they refuse to accept a decline in their pros-

perity to save their race and nation.

Moreover, those with a sense of social justice are rightly repelled by the exploitation of slavery and become wrongly sympathetic toward the enemies of their race. This tendency is particularly pronounced in the English community. The English are mired in the prejudices of classical liberalism which is a complex of self-seeking individualism and guilt. The English feel guilty because they are so self-centered and selfish, and they confuse this guilt with moral impulse. The Afrikaners, on the other hand, are still a basically nationalistic people, despite English influence and despite the self-seeking corruption of their plutocratic leaders. The social order of the Afrikaners is still strong and it would take several generations of corrupt leadership to change that. Most Afrikaners are still willing to sacrifice their own welfare for the sake of their nation or "volk", hence they see themselves as a noble people and feel none of the guilt of the English individualists.

The AWP wants to establish an Afrikaner nation in South Africa which would exclude the Coloreds and exclude the English. Though we

wish to see all of the White peoples of the world eventually united in one great nation, we recognize that that day cannot come until Whites are much more culturally homogeneous and until they speak the same language. Until then their differences will appear more important than their similarities and they will not be able to identify with each other as part of one White nation. Only a nation has the unity to act purposively and powerfully. The English (40% of the White population) and the Afrikaners (60% of the White population) are too different in terms of culture, philosophy, and language to act as one nation. This is the reality of South Africa and we must accept it.

Terre Blanche is right in fighting for an Afrikaner nation. The English will run without a fight just as they did in Rhodesia. They will go to England, or to Australia, or to Canada, or to America where the peoples are deracinated and denationalized, and where English individualism reigns supreme. There they will be comfortable, but in South Africa they are fish out of water. Neither the Blacks nor the Afrikaners can tolerate them

formation gathering, they are thus far consoled by the fact that limited participation remains essentially voluntary.

However, there is no telling if such monitoring has been covertly expanded beyond the admitted test sites. If not, then chances are that manufacturers, enamored with the ability of these surveillance techniques, will call for nationwide installation of UPC scanners at the store and at home. Already, the well-known Neilson Group apparently prefers the TV monitor device to current rating systems. With it they would no longer receive approximate reports of anonymous viewer time on each station, but keep precise records of individual and family preferences.

If these commercialized snooping devices do not conjure up scenes of thought police and "Ministry of Love" interrogation chambers, rest assured the System and the manufacturers will continue to to their best to imitate Big Brother's Oceania. Then there will be no doubts left in our minds as to who holds the power over life and death. Meanwhile, the consumer herds are ready to use TV wands to respond to research questions and viewer polls, while even better methods lie in wait.

Monitors could be equipped with an electronic eye that would peer into the room, recognize each individual, and register his or her presence. Even skin implants that could be read by the wand have been suggested. With our own built-in UPC bars just how different will we be from the packaged goods on the shelves? Needless to say any qualms on our part will be quietly soothed with talk of "progress" and "efficiency".

Not too long ago the plutocrats and their media henchmen assured us that 1984 had been safely avoided, and we were left to go on buying and dying for the System. They pretend Big Brother remains in safe keeping. On the other hand, we realize that while Orwell's tale has not yet become a complete reality, it has merely been postponed. When the System feels threatened by us it will show its true colors. MM

Editor - the following letter was submitted by a reader of **The Nationalist** to the university newspaper of the Virginia Polytechnic Institute and it was published therein. We encourage all of our readers to get their views published in local publications and to send us copies of the printed letter. This is an excellent way to spread National Democratic ideas.

Dear Editor:

I went to the journalism forum, held May 13th, on the Middle East, between an Israeli and Lebanese reporter. I was expecting some revelations about our own country's coverage of the Middle East over the past 30 years or so.

Both Mr. Grenot and Mr. Mishlawi were very tame and other than sharing some interesting experiences in their own journalism careers, failed to delve into any controversial topics.

Furthermore, I found during the discussion, Israel's openness in the news media was highly overrated and any comment about Israel's own pressure upon U.S. reporting was carefully sidestepped.

Only in the most recent years, with the 1982 invasion of Lebanon and other sensitive issues like the Jonathan Pollard spy case, has the bias towards Israel lessened and educated criticism grown.

Even today, however, most incidents are played down if not ignored entirely. A case in point is the interrogation and torture of an American citizen in Lebanon at the hands of Lebanese militia men and an Israeli officer this past March.

While particular terrorist incidents were given front page headlines and attributed to certain Arab nations without complete proof of the perpetrators, the fully documented assault upon this American at the hands of an Israeli was consigned to a small blurb at the bottom of the page of **The Washington Post**.

It would be a lie to say that Israel's flagrant criminal activities, including massacres of civilians and violations of the Geneva Convention, have gone unreported. Unfortunately, you have to be willing to hunt through library stacks and microfiche to find the hard evidence.

A student at Virginia Tech has little research time on his hands to use our library to dig through all this material, so how is the average working person expected to do the same?

The attacks and killings of American soldiers and officials, the blackmailing and spying by the Israeli Mossad (Intelligence), and blatant theft of military parts and

secrets by Israel have been covered up or downplayed while Arab misdeeds receive the greatest attention. Few would claim Muammar Khadafy had nothing to do with the criminal acts by terrorists in recent months and he is not a threat to our own security.

Likewise our retaliation last month under the recent circumstances seems warranted. However, perhaps one should ask, what if Israel went on a killing spree against U.S. servicemen, and how would we react to it?

In 1967 an American communications vessel, the **USS Liberty**, sailing off the Sinai coast in international waters was attacked by Israeli high performance jets. Those attacks were followed by torpedo boats and the napalming of the ship's deck by the aircraft.

The assault lasted for two hours, killing 34 Americans and wounding 171 others. When the **USS Liberty** failed to sink quickly, the Israelis machine-gunned her life rafts and sent in troop-carrying helicopters to finish the job. Although the **USS Liberty's** crew called for help from the 6th Fleet whose aircraft were just 10 minutes away, White House intervention prevented anyone from going to their aid.

The U.S. government accepted the flimsy excuse by Israel that her forces had mistaken the ship for an Egyptian freighter even though it was revealed that the identification of the ship was known in the Israeli War Room several hours before the attack, and its position recorded on a map.

Journal article, a "cover-up of the circumstances of the attack was ordered by President Johnson" who "could ill afford a confrontation with Israel... A "news lid" was placed on the survivors of the attack by the military to ensure Israel's clean image.

Testimony in a Court of Inquiry shortly afterwards by the USS Liberty's crewmen revealed that the attack was most likely "deliberate, but all such evidence was withheld from the public." The Journal article goes on to explain how the "American public was given a distorted version of the attack," but unfortunately not why.

Can there be any doubt someone has been playing Big Brother with the news and it has been detrimental to our involvement in terms of lives and material?

Perhaps it is time for people to ask who really are our friends and enemies in the Middle East and begin their own search beyond the limited horizons allowed by our media.
