Scandals Expose Nature of Judicial Corruption

There is so much judicial corruption in America, both legal and illegal, that it is now regularly percolating to the surface. It seems that every week the newspapers are reporting a new judicial scandal. We will look at two of the most recent cases to illustrate how the judicial system works behind closed doors.

Bess Myerson, the first Jewish Miss America and the former New York City cultural affairs commissioner, is now on trial along with her boyfriend, Andy Capasso, for bribing Judge Hortense Gabel. Judge Gabel was handling the divorce case of Andy and Nancy Capasso. Myerson hired Gabel's daughter, Sukhreet, while her boyfriend's divorce case was still ongoing. Soon after Sukhreet was put on the City's payroll, Hortense reduced Nancy Capasso's alimony from \$1500/week to \$500/week. Just a coincidence no doubt.

But the case gets even more interesting because Judge Gabel's former legal secretary, Howard Leventhal, disclosed in his testimony that "Raoul Felder [Nancy Capasso's lawyer] was using his connections with the Sol Goldman family [a New York landlord] to help obtain an apartment for Sukhreet." Felder obtained the apartment for Sukhreet when the motion

for temporary alimony was pending, and shortly thereafter Hortense awarded Nancy Capasso \$1500/week in temporary alimony. Later it was reduced to \$500 per week after Myerson hired Sukhreet. So both sides were vying for the favor of Judge Gabel.

TWISTED PERSONALITIES

The story gets even seamier when you get into some of the personalities involved. For example, Leventhal testified that Nancy Capasso was more interested in getting a Mercedes for herself than support for her children, and that she petitioned the court three times for exclusive use of a Mercedes. Andy Capasso's British housekeeper, Shirley Harrod, testified that getting the alimony reduced was a major topic of conversation between Andy and Bess, even though both are extraordinarily wealthy. Harrod said that Capasso once asked Myerson to do something to get the alimony reduced. These are very rich and very petty people, but Sukhreet is something else. She is testifying for the prosecution against her mother while playing to the media which is fascinated with her obviously twisted personality. This case makes the New York degeneracy of Tom Wolfe's *Bonfire of the Vanities* look tame by comparison.

But before we dismiss this tale as being peculiarly New Yorkian, we should recognize that the process whereby judges and lawyers become buddy-buddy with one another is the same all over the country. Both judges and lawyers attend bar association functions, where great quantities of alcohol are often consumed, in order to establish friendships that will be mutually advantageous. The judges need the good will and financial support of lawyers in order to advance their judicial careers (see Jun87 *Nationalist* - "Justice Drowns in a Pool of Legal Corruption"). The attorneys are seeking psychological influence with judges. Do judges withdraw from a case when a friend is an attorney for one side or the

other? No where in the country does this take place! The sort of influence buying that occurred in the Myerson case is atypical only in that it is slightly more blatant and direct than the norm. The same sort of back-scratching takes place every day in every court in the United States albeit somewhat more subtly.

JUDICIAL COVERUP

On Thursday night, August 18th, Judge Gary Little blew his brains out in the hall outside of his courtroom in Seattle, Washington. The tragedy is not in his suicide, but in the fact that the state did not execute him years earlier for Judge Little was a homosexual, child molester. He committed suicide only when he learned that the press was going to blow the whistle on him. He used his position as a Juvenile Court judge to force male children to have sex with him. What is most revealing about this case is that Little's predilections were well known to the Commission on Judicial Conduct as early as 1981. Yet, the Commission was so intent on protecting its own that Little's reputation in the community re-

mained solid until the day he died.

The Commission admonished Little for out-of-court contacts with juveniles in 1981, but took no further action even when further contacts were complained of in 1984 and 1985. The Superior Court removed Little from juvenile work in 1981, but then reinstated him to it in 1982. In 1985, he was permanently barred from Juvenile Court, yet no further action was taken against him. A long Commission report on Little's out of court contact with juveniles was kept secret.

MEDIA KILLS THE STORY

The role of the press in this affair was no more noble. Reporters for both KING-TV and the *Seattle Times* had the necessary facts in 1985, yet both news organizations killed the story. And the reporters who had the story did not try to market it privately to other newspapers. So Little continued to molest trapped kids for another three years.

Don McGaffin, one of the KING-TV reporters, wrote after the suicide that Little was spared in 1985 partly because reporters thought of

him as "brilliant, sophisticated and wonderfully worldly", and because they often depended on him as news source. Little also had powerful political and business friends.

McGaffin wrote that the worst offenders were the managements of KING-TV and the *Seattle Times* who "have to live with the knowledge that they had evidence that Little might inflict himself on boys in county custody. And neither reported the story."

Well, maybe. But we should remember that the Commission on Judicial Conduct, and the Superior Court, and the lawyers who defended juveniles knew what was going on as early as 1981, and none of them did anything to bring this animal to justice. Why? Because he was one of their own. And that is all you need to know about the ethics of American lawyers and judges. GG

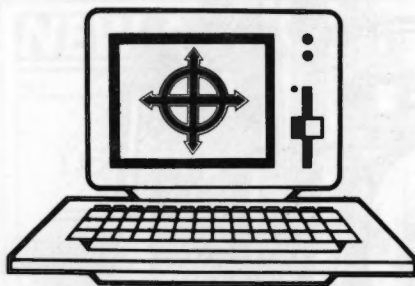

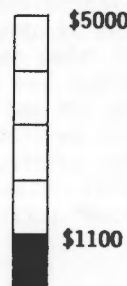

US Patent Law Must be Reformed

Genetically altered animals have thrown the patent law into a state of confusion. The U.S. Patent Office has decided that genetic alteration can be patented, but who owns the offspring of genetically altered animals? Genetic inventors claim that they do, and the farmers who purchased the new animals claim that they own the offspring. Actually, the inventors only want to prevent farmers from marketing the animals to other farmers as that deprives the inventors of their primary market. Obviously, the present patent law is unable to cope with this situation.

LONGSTANDING PROBLEMS

This is not the only problem with U.S. patent law. The purpose of patenting is to encourage invention, and it does this at present by providing an inventor with a certain period of time to market his new idea free from competition. But the process has not been successful in helping small inventors, who are our greatest source of scientific creativity, for several reasons. The small inventor must first find a private patent attorney who will not steal the idea. Theft of new ideas is astonishingly common in the patent world and is a matter of great concern to inventors.

But the greatest source of anxiety is what occurs once the idea is patented. At that point the inventor must get a manufacturer interested in producing his product. This is no easy matter. For example, the American inventor of the video cassette recorder (VCR) was unable to get any U.S. company to manufacture the product. The Japanese company Sony came across the idea in one of its regular searches of U.S. patents, and fortunately, it decided to create a market for the VCR.

Once a company does decide to produce an new invention, it can usually take the product from the inventor for a fraction of its real value. This is because the inventor has no business expertise or capi-

tal resources and cannot get into the manufacture and distribution process himself. Basically, he gets whatever is offered him. Often, if an inventor is stubborn and holds out for a good price, he finds that one of the companies he has dealt with comes out with a very similar product. It is different enough to obtain its own patent, but is substantially the same product. In other words, the patent process is often nothing more than organized theft of the have nots by the haves. And inventors who have been around awhile know this all too well.

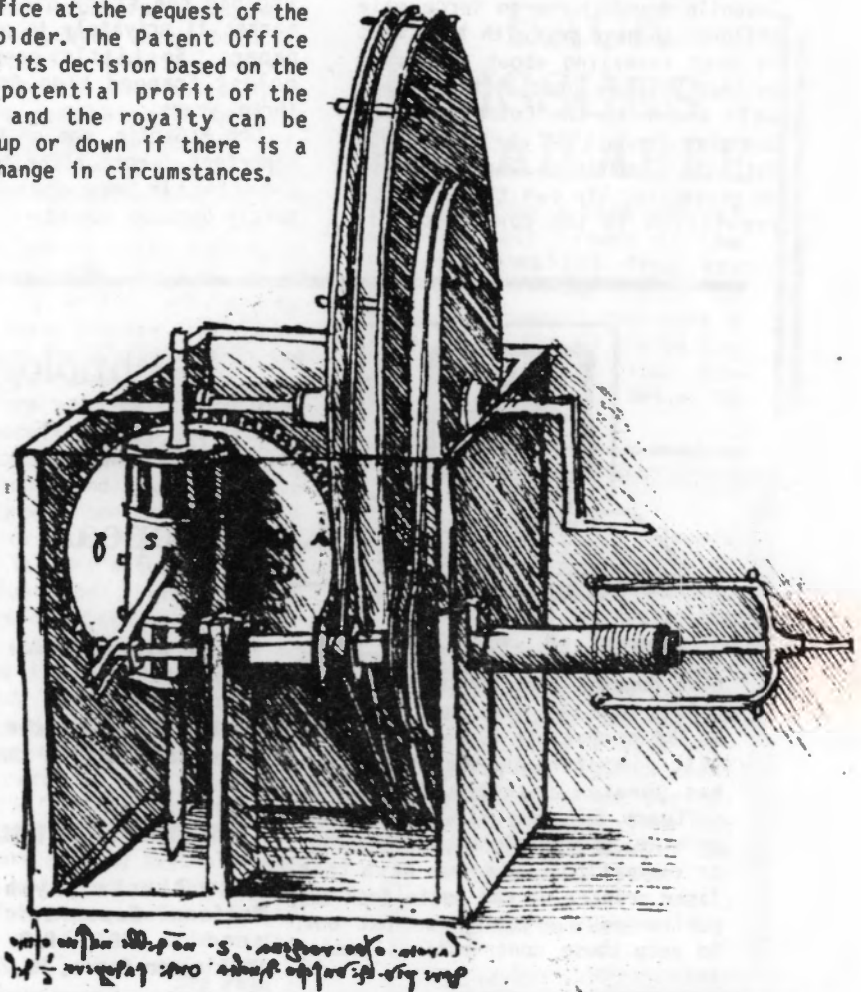
A NEW SOLUTION

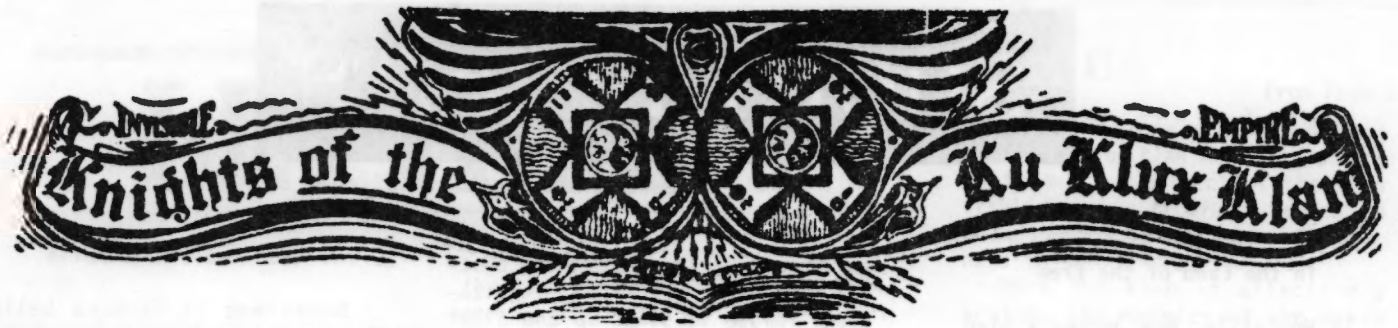
There is another approach to patent law that resolves many of these problems: once a new idea has been patented, it will be immediately available to anyone's use, however any company that does utilize the idea must pay royalties to the patent holder for a certain period of time. The amount of royalties will be decided upon by the Patent Office at the request of the patent holder. The Patent Office will make its decision based on the real and potential profit of the company, and the royalty can be adjusted up or down if there is a drastic change in circumstances.

Moreover, patent attorneys will be eliminated. An inventor will deal directly with the patent office, and patent bureaucrats will guide him through the process and advise him.

The advantages of this system are enormous. The inventor no longer has to worry about his invention being stolen, and he gets rewarded according to how many of his products are sold. Moreover, the nation no longer has to wait years while inventor and marketers haggle over contracts. No company is given a monopoly, so many different firms can immediately rush into production. This competition will both drive down prices for the consumer, and will create greater volume in the market thus benefiting the inventor.

The Japanese now patent almost as many products as Americans, yet they are far from being a truly creative people. Ours is a structural problem. We need drastic patent reform to help revive natural American inventiveness. GG





Two More Ku Klux Klans Hit by Lawsuits

On January 17, 1987, the Southern Christian Leadership Conference led by Hosea Williams held a civil rights march in all-White Forsythe County, Georgia. They were met by counter-protestors led by the Ku Klux Klan. Some of the counter-protestors began to throw rocks and bottles at the Blacks and forced them to give up the march.

Fifty-three of the civil rights marchers filed suit against the Southern White Knights led by Dave Holland, the Invisible Empire led by J.W. Farrands, and twelve individuals. The marchers were represented by Morris Dees of the Southern Poverty Law Center. Dees pre-

viously filed successful suits against the White Patriot Party and the United Klans of America (UKA). The White Patriot Party was broken, and the UKA suffered an \$8 million judgement which it failed to appeal for some unexplained reason. The UKA, which was the largest Klan in America, lost its million dollar headquarters and other properties. The Invisible Empire, which is the next largest Klan, and the Southern White Knights now face a similar fate as a result of the verdict which came down on the Forsythe case on October 25th.

The jury found that the Klans and eleven of the twelve indivi-

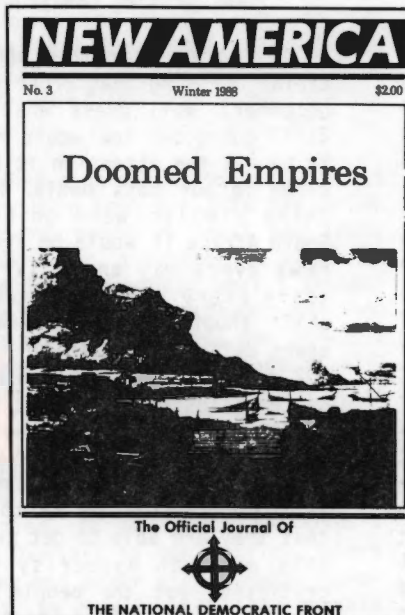
duals conspired to do violence against the civil rights marchers. Each Klan was fined \$400,000 in punitive damages, and individual fines ranged from \$50,000 (against Dave Holland) to \$1000. The defendants will appeal the verdict.

STRATEGY OF ATTRITION

For years the very wealthy Southern Poverty Law Center has been following a strategy of attempting to break the Ku Klux Klan through court action. The Klan is an easy target because of its reputation for random and senseless violence. Juries are easily led to

In the Land of the Free

In Montville, New Jersey a high school Spanish teacher, Giovanni Pinto, has been suspended for casting doubt on the veracity of the Holocaust tale in class. Pinto now faces trial by an administrative board which will determine whether or not he should be fired. This has been the fate of schoolteachers worldwide (in the so-called "free" countries) who refuse to kowtow to Jewish lies. The list of the courageous grows ever longer.

Never Forgive, Never Forget

Boleslav Maikovskis, 84, was arrested in West Germany on October 18th for alleged war crimes committed in 1941 and 1942 while serving with the pro-German Latvian police force. He fled to West Germany because he was one of the thousands being hounded by the Office of Special Investigations led by the Jew Neal Sher. The OSI investigates only "Nazi" war crimes. The Jews, through the OSI, are raping the Eastern European community once again, just as their Bolshevik blood-brothers did before and after

the Second World War. Yet the Eastern European political organizations refuse to stand up and fight their ancient enemy. At least men like Maikovskis had the guts to commit to the struggle when their time came. If the present generation of Eastern Europeans in America had that strength of character then we would be well on our way to ridding ourselves of the Jews. But no, they prefer to argue amongst themselves on religious and cultural matters - anything but confront the real enemy.

Mistrial for Wickstrom

Pittsburgh Federal District Court Judge Glenn Mencer declared a mistrial in the case of James P. Wickstrom, a top Posse Comitatus leader. Wickstrom is being charged with possession with intent to distribute \$100,000 in counterfeit money. The Judge had previously declared that he was not going to allow politics into the trial. Assistant U.S. Attorney Brad Barbin asked BATF Agent Ralph King whether agents questioned Wickstrom about what he was going to do with the money, and what Wickstrom said. King replied, "He responded by saying he was taking the money to a meeting of the Aryan Nations in July," and added, "I understand that to be a conservative, right-wing, paramilitary organization." That description of Aryan Nations won Wickstrom a mistrial. His new trial begins in November. But the real point of all this is why did Wickstrom say anything to these agents? Have we not learned by now that we must never talk to the enemy about anything, that we must remain silent under all circumstances when being questioned by a governmental authority. If the pressure of the interrogation is getting to you then insist on having an attorney present, and then he can refuse to answer on your behalf. **Silence is Golden.**

U.S. Deals with Mafia

Sometimes it is hard believe that reporters in major newspapers are not writing tongue-in-cheek. Take for example this **Los Angeles Times** story written by Ronald Ostrow and Robert Jackson which starts:

"Federal prosecutors have quietly scored a significant breakthrough in their efforts to rid the Teamsters Union of alleged corruption by obtaining court-approved agreements from 10 reputed Mafia leaders to avoid any future dealings with the union, it was learned yesterday."

Now let us get this straight, the Feds are relying on these Mafia chieftains to keep their word, right? And this is a breakthrough? No doubt these guys will abide by the letter of the agreement out of fear of being found in contempt of court. Are the Feds not working with a full deck or is there something else going on here?

The Uprising Continues

Does anyone remember the Palestinian Uprising that broke out last December? Well guess what? It is still going on. You would not know it by all the attention it has been given in our mass media. If something similar were going on in South Africa it would be front page news every day and a TV feature story every night. The Jews are still shooting unarmed Arab teenagers daily. The death toll reached 302 on October 10th. Nothing could better illustrate the fact that our media organizations are but propaganda organs. The Jews have such a lock on all aspects of the media, from publishing to TV to films, that they are able to get away with this mammoth hypocrisy without criticism. Dear Gary,

Another student in my high school has died, the sixth in two years and the third in six weeks. He died of asphyxiation while on drugs in his garage. Another committed suicide with a gun. One was stabbed during a drug deal. Yet another wanted see how his friend's new sports car handled turns at high speed. He crashed into a tree. I don't remember how they all died, but I know that three were suicides, two were senseless accidents, and at least three were drug related. Five were White.

All should be living today. This affects me greatly because I have been in suicidal depression before and I could easily have been a forgotten youth.

Many ideas go through your mind when you are "on the edge". What do you have to look forward to? A government where the superrich exploit the lower and middle classes? A drug-filled racial battleground at a school where learning is impossible? An economic system in which money is worshipped and which is dominated by evil, Jewish tyrants? Who cares about the working people? "No one person can make a difference." Why not block life out on drugs, or better yet, why not end it all?

When a person stops caring about everything then his life has ended. Everyone needs at least one thing to care for, a purpose to continue. When I asked myself what I thought were my final questions only one idea came to my mind, the solution to the problems which face us all: the revolution of the NDF. It is too bad that suicide victims have not heard of the National Democratic Front.

The NDF saved my life in my hour of need. It gave me a purpose. I look forward to New America, where money and power are no longer synonyms. In New America the people will have the power to elect a Leader who will take charge, end civil conflict, and help us all.

The standard of living will increase and jobs will be plentiful. The races will not be forced to mix. School will be for learning. The working class will no longer be exploited. Drugs will disappear because there will be no need to "block life out", and the police will have the authority and resources to stop drugs completely. "No one person can make a difference," but we all can as members and active supporters of the NDF.

When I look back on my thoughts of suicide, I feel foolish. Along with the hope of a "New America", I now have many other wonderful experiences to look forward to, and many other purposes which I did not see when I had a knife in my hand. I only wish everyone could hear of the NDF; I believe the suicide rate would drop sharply, along with the senseless accidents that our youth fall victim to each day. The divorce rate would probably drop too because National Revolutionaries should practice chivalry, thus lessening household argument.

believe that any act of violence carried out by Klan members resulted from a conspiracy of the Klan itself. Little proof is needed in this regard because the Klan is held in such disrepute.

Once the Klan is effectively broken, the enemies of the White Race will pick other targets in the racist movement for similar treatment. The media will cooperate by attempting to criminalize every racial nationalist organization. Every racist will become a terrorist. They will try to make the two words synonymous in the minds of the people through constant media repetition.

The people may reject this propaganda. Already they are saying in polls that they are sick and tired of Jewish Holocaust propaganda, even though they do not yet know the truth on this subject. The overkill may backfire. Or we may be able to get our message out as our resources grow.

PRUDENT PREPARATIONS

But if we are not able to defeat the System's attempt to criminalize us, then we must be prepared to operate underground as secret organizations just as the Bolsheviks did in Czarist Russia, and just as the National Socialists are now doing in capitalist West Germany and communist East Germany. All racial nationalist organizations should begin now to prepare for such a possibility.

Links with foreign White Nationalist movements are very important in this regard. They are as eager for these contacts and joint operations as we should be. American White Nationalists must shed their isolationist mentality and welcome the friendship of our comrades across the sea.

The NDF has already made considerable progress in this regard, and we intend to develop joint projects with our Third Way comrades over the coming years in order to consolidate our friendships. Plant Closings Create Revolutionary Opportunities

Avtex Fibers Inc., the world's largest rayon manufacturing plant will close down in November throwing 1300 employees (almost all of whom are White) out of work in Front Royal, Virginia. Why should the National Democratic Front take note of such an event? Because each plant closing is a potential opportunity to preach and practice Democratic Nationalism.

Two hundred angry Avtex workers met on the evening of November 2nd, in their union hall, to demand that the company help them find new work or at least pay them some termination benefits. But that is not what these workers should have demanded. They should have met to discuss how to buy out the plant and turn it into a workers cooperative. They should be determined to turn Avtex Fibers into a new Weirton Steel (see Mar86 **Nationalist** - "Worker Owned Weirton Steel Prospers").

thousands of White plant closings just like Avtex and we will be there to preach and to organize worker-owned cooperatives as this what our Program calls for. The union will not advocate worker-ownership because there is no place for a union in such a company. Both union and management will betray the worker. The White worker will have only the NDF to look to for help as the System comes crashing down from its own incompetence. We look forward to such revolutionary opportunities to prove ourselves to the White worker. GG

WEIRTON POINTS THE WAY

In 1984, the workers of the Weirton Steel factory in Weirton, West Virginia purchased the bankrupt company. They quickly turned it into one of the ten most profitable steel factories in the country. In the first full year, 1985, worker-owned Weirton posted a \$61 million profit.

What the workers of Avtex lack is vision and the knowledge that there are laws now on the books that can help them achieve worker ownership. The federal employee-stock-ownership plan (ESOP) was used effectively by the determined Weirton workforce to take control of the company. There are more than 5000 ESOPs now operating in the U.S., though most are very small.

THE FUTURE IS OURS

At the moment, the NDF does not have the cadre strength to go to Front Royal and attempt to organize Avtex workers to save themselves. But in the future there will be
