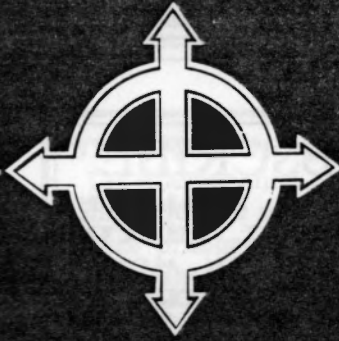

New Book Exposes U.S. Death Camps

In Canada a book has just been published that will shake the foundations of the capitalist System. The book is entitled **Other Losses** and is written by former publisher James Bacque with the assistance of U.S. Army historian Col. Ernest Fisher. The thesis of the work is clearly stated in Fisher's foreword: "Starting in April 1945, The United States Army and the French Army casually annihilated about one million men,

most of them in American camps... Eisenhower's hatred, passed through the lens of a compliant military bureaucracy, produced the horror of death camps unequalled by anything in American military history ... an enormous war crime." Bacque stumbled onto the story in 1986 while doing research on the French Resistance in World War II. One French Resistance leader saved a number of Germans from their

deadly incarceration after the war by offering them work. One of the Germans described the conditions in his camp where 25% of the German soldiers died of starvation and exposure. Such stories had circulated before, but had always been dismissed as isolated incidents. To his credit, Bacque determinedly tracked down the truth which had been systematically covered up by governments, media and "humanitarian institutions" (such as the Red Cross) alike for more than forty years.

THE MORGENTHAU PLAN

After Germany capitulated on May 8, 1945, millions of German soldiers moved west to surrender to the Western Allies rather than turn themselves over to the Communists. It was German policy to shift as much as possible of the army west while still holding off the Soviets. In the end, the Western Allies controlled about 7,000,000 German prisoners of war, while the Soviets captured only about 3,000,000. The Germans thought that the capitalist countries would treat their soldiers better than the communist countries as the Soviets refused to recognize the Geneva Convention. They were mistaken. The capitalists turned out to be just as proficient at mass

murder of the helpless as the communists. Before he died in early 1945, Roosevelt adopted the Morgenthau Plan and ordered that it be kept secret as he feared most Americans would not approve. The Plan was designed to destroy Germany as an industrial state and to convert it to a pastoral land, causing the death through starvation of millions of people because Germany could not feed itself at its normal population. The U.S. State Department and the British Foreign Office estimated that 20 million German civilians would die after the war if the Morgenthau Plan was imposed. In spite of this, or perhaps because of this, Roosevelt and Churchill secretly agreed to implement Morgenthau's program of mass murder.

Henry Morgenthau was Roosevelt's Treasury Secretary, so at first it might seem odd that he would be the one to plan U.S. postwar foreign policy, until one understands that Morgenthau was a Jew who represented the Jewish view in the Administration. And the Jewish view carried enormous weight with Roosevelt, who depended on the Jews (especially their money and media) to become governor of New York and President of the U.S. As David Irving's new biography of Churchill demonstrates, the British Prime Minister was also in the pocket of the Jews. After Churchill went bankrupt for the second time in 1938 (following the inane financial advice of the Jewish financier Bernard Baruch), the Jews stepped in with a secret deal: if Churchill would continue his crusade in Parliament against Hitler's Germany, the "Focus Group", as it was called, would guarantee his personal finances so he would not have to retire from politics to make money. Churchill accepted and the Jews had him.

RAW JEWISH HATE

The Jews hated (and still hate) the Germans because they embraced National Socialism. The Jewish motto as expressed by Jewish Nobel Peace Prize Winner Elie Wiesel is "Never forgive, never forget." In chapter 12 of his book *Legends of Our Time*, Wiesel states, "Every Jew, somewhere in his being, should set apart a zone of hate - healthy, virile hate - for what the German personifies and for what persists in the German." Those great lovers of mankind were determined to punish the Germans - to murder as many as they could and to destroy Germany as a nation. And they justified their macabre Jewish urges by building a body of lies called the Holocaust. As reported in past issues of *The Nationalist*, the Holocaust has been exposed by Revisionist historians as a great historical lie - a lie needed by the communists, capitalists and Jews to mask and cover their own very real crimes against humanity. Now two System historians, Bacque and Fisher, have provided that the final important pieces of the puzzle so that we may understand who the real criminals are. Finally, the whole picture makes sense.

The extermination of German prisoners of war dovetailed neatly with the Morgenthau Plan which was aimed at German civilians. The Plan was in effect for two years after the war and was abandoned only when it became obvious to President Truman that "Uncle Joe" Stalin (as the Jewish media referred to the greatest mass murderer in history) was not playing ball. Fear of Communism caused the Western Allies to reconstitute West Germany as a nation to be used against the Soviet Union in the likely event of war. Some historians have estimated that more than 2,000,000 West German civi-

lians died as a result of the Morgenthau Plan. The maximum rations allotted to German civilians by the U.S. amounted to 1100 calories per day; the British gave 1500 per day, and the French 800 per day in their zone. Starvation begins at under 2000 calories a day. U.S. soldiers were allotted 4000 calories a day.

BY WINKS AND NODS

The extermination of more than a million German soldiers in U.S. and French prisoner of war camps was accomplished by lies, winks and nods according to Bacque, but nevertheless, he was able to detect the trail in the official records. While the U.S. claimed to be abiding by the Geneva Convention, Eisenhower changed the status of millions of the Germans from "prisoners of war" to "disarmed enemy forces" (DEF), and this was done with the approval of the Combined Chiefs of Staff.

Once the U.S. recovered the 2,000,000 Allied prisoners (who were in perfect health) from the Germans, it immediately ordered that prisoner food rations for the Germans held in North America be cut. Eisenhower also slashed prisoner of war rations in Europe to a slow starvation level, but those millions classified as DEF were given even smaller rations. Moreover, the Germans, including tens of thousands of women and children who were also held in the camps for unexplained reasons, were forced to live in open barbed-wire enclosures without fuel for fire and without shelter of any kind even though wood for construction and tents were readily available. Some survived such treatment for two years, but a considerable proportion died before they were released. The mortality rate was more than 30% per year in the camps. The dead were described as "other losses" in official records to mask the fact that they were dying from starvation and exposure. This was explained to Bacque by Col. Philip Lauben in 1987. Lauben had been Eisenhower's Chief of German Affairs, and he further told Bacque that "The Vosges was just one big death camp.... I was appalled at the condition of the prisoners [in the French and American camps there.]" All

Bacque had to do at that point was tally up the "other losses" in Army records to find that the U.S. Army alone killed more than 750,000 captured Germans, all the while claiming they were protected by the Geneva Convention.

ASTONISHING CRUELTY

One German prisoner who later became a U.S. Army historian, Charles von Lutichau, described the camp he was in as follows:

We were kept in crowded barbed wire cages in the open with scarcely any food. The latrines were just logs flung over ditches next to the barbed wire fences. To sleep, all we could do was dig out a hole in the ground with our hands, then cling together in the hole. We were crowded very close together. Because of illness, the men had to defecate on the ground. Soon, many of us were too weak to take off our trousers first. So our clothing was infected, and so was the mud where we had to walk and sit and lie down. There was no water at all at first, except the rain, then after a couple of weeks we could get a little water from a standpipe. But most of us had nothing to carry it in, so we could get only a few mouthfuls after hours of lining up, sometimes even through the night.... More than half the days we had rain. More than half the days we had no food at all. On the rest we got a little K ration. I could see from the package that they were giving us one tenth of the rations that they issued to their own men. So in the end we got perhaps 5% of a normal U.S. Army ration. I complained to the American camp commander that he was breaking the Geneva Convention, but he just said, "Forget the Convention. You haven't any rights." Within a few days, some of the men who had gone healthy into the camp were dead. I saw our men dragging dead bodies to the gate of the

camp, where they were thrown loose on top of each other onto trucks which took them away.

The U.S. Army had vast mountains of food in its depots and warehouses in Europe (as much as 139 days surplus for its 5,000,000 troops.) The Red Cross also had trainloads of food that it wanted to distribute to the camps. But Eisenhower refused to let the Red Cross (which was allowed into all German concentration camps throughout the war) to distribute or even visit the camps. The Red Cross sent two trainloads of food from Switzerland for the camps, but they were turned back by the U.S. Army which explained that its warehouses were

already full. At the same time Eisenhower complained to the press and in official documents that the "World Food Shortage" was hampering his efforts to properly feed the German prisoners and civilian population.

The State Department cooperated with Eisenhower in this homicidal deception by denying prisoners of war mail rights. Thus the Red Cross and other relief agencies could not mail food to the imprisoned Germans, and the prisoners could not mail out pleas for help.

It should be said that not all of America's generals complied with the genocidal policy of the U.S. government. General George Patton, for example, released German prisoners of war almost as soon as he captured them after the capitulation on May 8th. For his treatment of the Germans, Patton was dismissed from his command by Eisenhower and ordered back to the States. But he never made it back to America as he died mysteriously in what the Army called an accident shortly after his dismissal. General Mark Clark, commander of American forces in Italy, also refused to recognize the "winks and nods". The half-million Germans under Clark were treated according to the Rules of Land Warfare. Eisenhower could not relieve Clark as he was in a separate command, and Washington apparently chose to leave well enough alone, especially after the Patton incident.

REVENGE AS POLICY

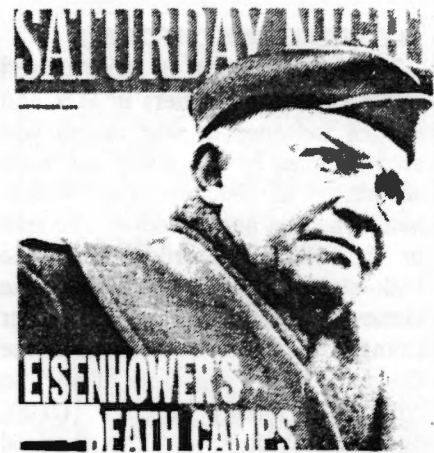
What was the purpose of holding German prisoners after they had been disarmed and identified? Sixty per cent of Wehrmacht prisoners were still in prison camps in January of 1946. There can be only two reasons. One was to use them as slave labor, and this was done by all

of the Allies - at the same time they were hypocritically charging the Nazis with the war crime of using forced labor. Nazi Labor Minister Sauckel was executed for this by the Nuremberg courts. The second reason was to punish the Germans. Since starved prisoners make very poor laborers, we can only conclude that blind hate, originating from the Jews who dominated Washington, and magnified by the White race traitors (particularly Eisenhower) who chose to execute their cruel will, was the primary reason that Germans were held in these death camps for up to two years after the end of the war. Eisenhower hated the Germans, but he was also a master careerist who would not do anything that might displease his superiors. It was most likely Eisenhower's political sense rather than his hatred which compelled him to murder with such enthusiasm.

Jewish power and hatred combined with cynical military careerism explain why and how this holocaust occurred. But how was it covered up for forty years. Where was the "free press?" What about the Red Cross? Why did it not publicly protest? And what of the prisoners and guards in the camps - why did they not speak out when they got home. Bacque provides the answers.

A LONE VOICE

One conscientious Red Cross official did speak out at the time, but he received no support from his superiors. Jean-Pierre Pradervand was the chief delegate of the Red Cross in France. He went to the newspaper *Le Figaro* with the story. The article caused a very short-lived international furor. Eisenhower denied and dissembled, and with the collusion of top journalists, he was able to get away with it. The *New York Times* asked it's



star war correspondent, Drew Middleton, to investigate Pradervand's charges. Middleton filed a report in which he claimed to have visited some camps and in which he claimed to have interviewed hundreds of people, including many "reliable sources." His report said that the *Le Figaro* story was false, which certainly must have pleased the Jewish owners of the *New York Times*, as Middleton certainly knew it would. Winks and nods.

In 1988, Bacque interviewed Middleton. At first Middleton tried to dissemble, but when confronted with the evidence, Middleton said that he had not really visited the camps. And he admitted that he did not interview Pradervand, the source of the charges. Bacque concludes:

Why was there such aversion to continuing this major story with its truly unimpeachable source [Pradervand]? Unless the journalists are willing to say, like Hitler's Germans, "we didn't know," there can only be two reasons. They did not care. Or they approved.

Germans who told the truth were not believed. Americans such as Col. Lauben kept their mouths shut. Most records of the U.S. camps were destroyed in the late '40s. But the cover up was sealed with the cooperation of the the West German government and the Red Cross.

Especially noxious were the puppet politicians of West Germany. They knew the truth, but betrayed their own people to please their U.S. masters and further their careers. The West German government determined that 1,700,000 German soldiers who were alive at the end of the war never returned home. The Allies claimed that the Soviets killed them. The West German government played along. The West German Foreign Office under Willy Brandt subsidized books which denied U.S. atrocities (as the stories kept appearing in the right-wing German press.) When approached by Bacque, Willy Brandt refused to discuss his role in censoring and subsidizing books that hid U.S. crimes against captured German soldiers.

The Red Cross refused to release documents on the U.S. and French camps to Bacque and Fisher, and claimed no knowledge of Pradervand who was their chief delegate in

France. Yet the Red Cross admitted two other researchers into their archives who were investigating Nazi camps from an exterminationist perspective. (The Red Cross has consistently denied revisionist Holocaust historians access to their records.) The Red Cross flushed Pradervand and the the U.S. atrocities down the Memory Hole, but in doing so it sacrificed its honor, integrity and credibility. It became an integral part of the corrupt capitalist system that won the war in the West.

THE EVIL TWINS

Other Losses has received excellent initial reviews from Canada's conventional press, including partial serialization in **Saturday Night**, one of Canada's most popular magazines. The largest publisher in Germany, Ullstein Verlag, will shortly publish the German translation. Bacque tried to get his book published in the U.S., but 50 publishing houses refused him. The Canadian

B'nai B'rith was caught with its pants down. The Jews are now attacking the book, but the genie cannot be stuffed back into the bottle. Communism is collapsing, and its evil twin Capitalism is rejoining - but prematurely. The capitalist plutocracies will suffer the same fate as their communist brethren nations. The people have already lost faith in capitalist "democracy." Once they come to understand its true nature, it will only take a spark to burst the whole putrid structure into flame. **Other Losses** and revisionist Holocaust history are setting the stage for the world reformation to come. The truth will give birth to a noble, new White Nationalist order just as it buries the decadent, dishonorable old order of the capitalists, communists and Jews. GG

Ed.- The following letter was published in *The Christian News*, a conservative Lutheran newspaper, edited by Rev. Herman Otten. Rev. Otten is unusual in his trade as he is fair-minded and attempts to air all sides of an issue in his publication. *The Christian News* (P.O. Box 168, New Haven, MO 63068) is the only Christian publication with the courage to doubt Jewish lies in regard to the so-called Holocaust. For this it has been branded as an anti-Semitic publication by the Jewish Anti-Defamation League of B'nai B'rith. The Jews also get very irritated when Rev. Otten reproduces pages of the Talmud in his newspaper. Once read, the Talmud can only produce revulsion for Jews on the part of White people as we are of a very different nature:

Dear Rev. Otten:

I was pleased to see that the Oct. 9th Christian News reprinted our article on Robert Faurisson which was first published in our monthly newsletter **The Nationalist**; but I was unhappy to see our Movement characterized as "right-wing", implying that we have something in common with capitalist conservatives. We are not of the Right, nor of the Left.

The three pillars of Democratic Nationalism (which is the ideology of the NDF) are 1) Racial Freedom, 2) Social Justice, and 3) Noble Leadership. Is it right-wing or left-wing to love one's own kind, to desire to see one's race survive, and

to demand self-determination for one's people? Is it right-wing or left-wing to demand the redistribution of the wealth and the sharing of the power that controls and creates that wealth? Is it right-wing or left-wing to demand a system that meritocratically selects, educates and empowers brilliant, honest leaders who are willing to sacrifice for their people rather than demand sacrifice from them while continuing to live in luxury? Clearly the old labels do not apply to the new White Nationalist movement. Those who wish to read the truth about White Nationalism can write the National Democratic Front at the address below, which I hope you will publish since you intentionally failed to provide the address of **The Nationalist** when you reprinted the Faurisson article from it.

Just For Fun Ten

Black girls, aged 13 to 15, were arrested in New York City on November 3rd for stabbing 39 White women with pins. The White women thought they had been stabbed with hypodermic needles and fear of AIDS spread through the Upper West Side of Manhattan. According to police, the Blacks used ordinary pins, and confessed they had been doing it "for fun." So far these attacks have not been condemned by the New York press as "racist." Apparently, only White on Black crime can be "racist" in the land of the free.

Multiracial Steering

The Chicago Tribune is applauding the formation of the Community Leadership for Fair Housing Committee which is an association of realtors committed to steering Blacks away from racially-mixed neighborhoods in south Chicago to all-White communities in the southwest section of the city. The System will not rest until every White neighborhood in America is made non-White, until every city resembles that great multiracial paradise known as New York City.

Just What Poland Needs

Lech Walesa is in the West begging for more loans for Poland. That is just what Poland needs - even more indebtedness to the capitalists and Jews - as if it is not already creaking under its present \$40 billion of international debt. No, it is not what Poland needs, but it is what the present Solidarity government needs to keep it propped up. The

Jews who run Solidarity (Michnik, Kuron, Geremek, etc.) set up Walesa's tour and made certain he said all the right things. He met with the leaders of Jewish-run unions, particularly those of the AFL-CIO which subsidized Solidarity for 10 years, and he met with rich Jewish capitalists in New York City. When asked by a reporter why he was not meeting with Polish workers in the Greenpoint area of Brooklyn instead of "intellectuals" [i.e. Jews] in Manhattan, Walesa replied that he was in America on a mission. At the Manhattan meeting with 80 Jewish leaders, Walesa claimed that Cardinal Josef Glemp (who defended the Carmelite nuns in the Auschwitz controversy) did not represent the views of the Polish people. Walesa is a stooge and/or a traitor to his own kind, and in the years to come he will be recognized as such by his people and by the Polish Americans who are presently deceived by the controlled press. Already, Solidarity has lost more than half the strength it had in 1980, and its decline will continue as it bungles Poland's present problems.

The Nature of Capitalism

On Nov. 16th, IBM finally admitted wrongdoing in its handling of government contracts. Since the end of the Second World War, every major defense contractor has been caught by the federal government in some sort of fraud or abuse. Such is the nature of capitalism. One of the most recent charges against IBM is that it supplied old equipment to the government, pretending that it was new. These are the people we rely

on in wartime. These crooks we trust with lives of our sons in battle. Is it any wonder, that so much American military equipment fails to work in wartime? In World War II, 50% of our torpedoes failed to explode when they hit their targets. Since 1960, the U.S. Air Force has tried four times to launch an ICBM from its silo - in only one test (the last one) did the missile succeed in leaving the silo. In the Falklands War, the Argentinian Air Force laid iron bombs on half of Britain's combat ships. Unfortunately for the Argentinians, the iron bombs were American made and 70% failed to explode. Can we really tolerate the corruption inherent in capitalism when it comes to lives of our children - and the life of the nation itself?

College Corruption

Dr. Allen Sack, a professor of sociology at the University of New Haven, has conducted a survey he terms the first "systematic study of the underground economy of college sport." Sack, through the NFL Players Association, mailed questionnaires to 1700 active players and 1800 retired players, and received 1182 responses. One third of the respondents admitted accepting illegal payments while playing college football. Most of this money came from alumni rather than coaches. One player reported that he received \$80,000 while in college, but most got small sums of money plus clothing, meals, and/or the use of a car. The corruption of college sports is just a reflection of the extraordinary decadence of the society at large.

Capitalism Causes Millions To Despair

The following letter was published in September of 1989 by the Knoxville News-Sentinel. It speaks volumes about the evil nature of the capitalist system and the need for a system based on the principles of social justice:

Editor, The News-Sentinel:

Before my husband had his stroke, I worked and he had his Social Security. Our combined income was almost \$1000 a month. We had a good life. Everything we needed and money in the bank. I took care of him for almost a year before I lost my health. Now he is in a nursing home and I am no longer able to work. Nursing homes rob you blind. Now there is nothing left but the house valued at \$3600 and a car that won't run. I have \$167 a month from my husband's Social Security and still the nursing home wants all that. God knows I have tried to hold things together. I have been everywhere I know to get help and all I get is red tape and I'm treated like I am some kind of an


inferior human being. I tried to get the house fixed through the city's HUD rehab program. I'm not in their target area. I tried CAC. That was over a year ago and nothing's happened yet. My car is torn up. It will take a new motor for it. I applied for my SSL. First they turned me down and I applied again. Now they send me a lot of papers I don't know how to fill out. I applied for food stamps and was told it will be 30 days or more before they can get to me because I make \$17 too much. I tried the Adult Protective Service with DHS. I tried Catholic Social Service. They turned me down. I just can't live as a street person. It would be too degrading to be left to live like that. I just can't. I worked as a cashier all my life but now I can't stand on my feet anymore and I don't know how to work sitting down. At my age nobody wants to hire you. Even with food stamps, which only allows you 33 cents to 78 cents a meal, there is no way you can live like a human being with only \$167 a month. I could go on and on but I have learned

that nobody cares what happens to the people who try to live and be somebody in this world. This is why people give up and become the "homeless of America." I wanted somebody to know what happens to the people in this country when you get down and out. If you are homeless people will feed you and give you a place to sleep but if you try to hold on to what you have worked for all your life, nobody cares. I'm sorry I just can't become one of the homeless. I can't see life worth living dirty and nasty and hungry with no place to sleep.

Such is the cutthroat nature of capitalism where everyone is taught the self-interest ethic, or "Look after number one," as the cynical popular expression puts it. Individualism serves only the rich.
