Bankers and Politicians Plundered S&Ls

Charles Keating, Jr. was the owner of California-based Lincoln Savings & Loan, which bank was recently closed by the federal government (due to its insolvency) at a cost of \$2.5 billion to the taxpayer. In fact, Keating's S&L had been insolvent for two years, but through influence-peddling, Keating was able to stave off the regulators. If it had been closed two years ago, it would have cost the federal government less than \$1 billion. In that period Keating continued to plunder the bank, sending millions into hidden accounts and false companies in Switzerland and elsewhere. The Keating story is important because it illustrates so clearly how the U.S. System really works.

In school we are all taught the myth that the U.S. is a "free democracy" which is run by the people for the people. The reality is that it is a system run by the rich for the rich - a plutocracy, not a democracy. The people of America are so frustrated by their inability to change things that fewer than 38% of them turn out to vote

in Congressional elections. And those that do vote are the wealthiest one-third of the populace who have vested interests to protect. In the U.S., only the rich are free.

BRAZEN BUYING

Keating is a real estate developer and banker who long ago came to understand how the System works. Over the years he has donated millions of dollars to politicians. And he is one of the few who are brazen enough to admit that "patriotism" has nothing to do with it. At a press conference after Lincoln was seized, Keating stated, "**One question, among the many others raised in recent weeks, had to do with whether my financial support in any way influenced several political figures to take up my cause. I want to say in the most forceful way I can: I certainly hope so.**"

What did Keating's contributions buy? At least five U.S. Senators, the Arthur Young accounting firm, and Alan Greenspan the Jewish chief of our privately run central banking system known as the Federal Reserve Board (the Jews do like to keep their fingers on the purse strings.) Keating gave \$1.4 million in legal contributions to the five U.S. Senators: Cranston, Riegle, DeCon-

cini, Glenn and McCain. He was not afraid to call in his favors when he needed them, and each of the Senators cooperated though to different degrees. Keating asked the Senators to get the Home Loan Bank Board (the federal regulators of S&Ls) off his back, and they did it, stalling the closing of Lincoln for two years.

PRESSURE APPLIED

In an unusual meeting called by Riegle (but which he did not attend), the other four Senators met

with the head of the Home Loan Bank Board, Edwin Gray. DeConcini browbeat Gray at the meeting and demanded that a regulation that adversely affected Lincoln (dealing

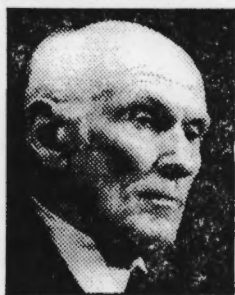
with direct investments) not be applied, even though the matter was already in court. The other Senators agreed with DeConcini. Gray felt they were trying to subvert the regulatory process for the benefit of a contributor, but he did not tell them to bug off. Instead, he set up a meeting between the five Senators

and the regulatory staff in San Francisco which was handling the Lincoln case.

At this meeting the Senators were told that criminal charges would shortly be filed against Linclon S&L and Keating. Gray left office about two months later and was replaced by Danny Wall. Gray blames Wall for not closing Lincoln immediately, and Wall blames Gray for not telling him that the matter was a top priority item. It is not clear exactly why Lincoln was allowed to slide for two more years.

Senators Glenn and McCain (who are the only Senators talking about the affair) say that they withdrew from the matter after criminal charges were mentioned by the regulators. What Riegle and Deconcini did is not yet clear, but Senator Cranston continued on a number of occasions to

pressure the regulators to let Lincoln off the hook. At the same time, Cranston was soliciting Keating for hundreds of thou-

sands of dollars for his political action committees, one of which was run by Cranston's son. Further, Keating offered Edwin Gray a job, and when that failed he asked and got the Reagan Administration to appoint a banker of Keating's choosing to the Home Loan Bank Board. Gray has said before that he was under constant pressure from Don Regan (Reagan's chief of staff) to resign, for reasons that were not clear to him. But Gray suspected that it was because he was coming down hard on some very wealthy and influential bankers.

APPARENT IMPROPRIETY?

On the David Brinkley television program, Senator McCain claimed that he was just trying to protect a constituent (apparently Keating was a constituent in several states.) He said that he regretted his actions, but only because they appeared improper. Neither McCain nor Glenn would admit that their intervention was wrong. Glenn claimed that he acted only because Arthur Young and Alan Greenspan pleaded Keating's case and made sound economic and financial arguments. (The SEC has charged the Young accounting firm with hindering its investigation of Keating.) What Glenn failed to mention, while protesting his integrity, was that both Arthur Young and Greenspan were working for Keating at the time. Glenn either knew this, or intentionally failed to ask, knowing what the answer would be. Obviously, these people just did not pop around to discuss the weather. They were sent by Keating. Moreover, Keating was definitely not a resident of Ohio, so why did Glenn get involved?

Glenn says it was not the \$200,000 that Keating gave him, but rather he was concerned about governmental abuse of a citizens's

right to fair treatment. So the next time you are being treated unfairly by the IRS, Social Security Administration, etc. just call Senator Glenn. No doubt he will jump right on the case, even if you are not one of his constituents or contributors. Clearly, the \$200,000 had no effect on the honest and upright senator from Ohio.

LEGALIZED CORRUPTION

When McCain and Glenn say that they did nothing illegal and nothing unethical, they speak the truth, at least in a sense. Their actions do not violate the present laws and Congressional rules of ethics, and that is the real

tragedy. The System is institutionally corrupt: it has legalized corruption and made it a part of everyday political life for the benefit of both puppets (the politicians) and puppeteers (the wealthy.) Even the **Washington Post** admitted as much in reporting the story:

“The inquiries [by Congress into the Keating Affair] are unusual because they deal with one of the facts of political life in Washington: the actions congressmen take for contributors.”

It is now estimated that the Savings & Loan scandal will cost the American taxpayers an incredible \$200 billion. Hand and glove co-operation between the rich bankers and their puppet politicians to gut the regulatory process caused this disaster, but of course they will not pay for it.

These five Senators are just the tip of the iceberg in such influence-peddling. The House of Representatives is just as guilty as the Senate. For example, Congressman John Duncan (R-TN) just recently settled

a case brought against him and other directors for plundering the S&L that he and his family owned in Knoxville. The directors had to pay \$500,000 in the settlement, yet the House has failed to launch an ethics investigation against Duncan to see exactly what his role was in this shameful affair.

This system of government we call pluralism is corrupt and decadent by its very nature. It must be eradicated and replaced with a form of government that is designed to act for the nation as a whole, and not for the wealthiest and most powerful special interests. Pluralism is a system of welfare for the rich that must come to an end.

The NDF has provided the necessary nationalistic structure to replace it in our Program of Democratic Nationalism. Our new way will create a unified and dynamic political order based upon amity, cooperation, honor and honesty. It will not be long before the people see the truth and embrace the Third Way beyond Capitalism and Communism - the way of White Nationalism. GG

Educational Decline Made Plain from A Small World Long Gone

Perhaps the most compelling evidence of declining educational standards comes from the recently published memoirs of Avis Carlson entitled **Small World Long Gone: A Family Record of an Era**. She explains that she was educated in a one room school in rural Kansas. In 1907 she took the compulsory county achievement test to graduate from the eighth grade. The test is remarkable (by today's standards) in the amount and kind of knowledge it required:

“The orthography quiz ... asked us to spell twenty words, including ‘abbreviated,’ ‘ob-

scene,’ ‘elucidated,’ ‘assassination,’ and ‘animosity.’ We were also required to ‘make a table’ showing the different sounds of all the vowels.... Among the other eight questions (each subject had ten questions) was one which asked us to ‘divide into syllables and mark diacritically the words ‘profuse,’ ‘retrieve,’ ‘rigidity,’ ‘defiance,’ ‘priority,’ ‘remittance,’ and ‘propagate.’

“Two of Arithmetic’s ten questions asked us to find the interest on an 8 percent note for \$900 running for two years, two months, six days; and also

to reduce three pecks, five quarts, one pint to bushels.

In Reading we were required to tell what we knew of the writings of Thomas Jefferson.”

Now, of course, the System wants to tell you in its duplicitous textbooks what Jefferson wrote because if you read his writings yourself you would find out that he was a racist, that he despised the Constitution, and that he felt the Supreme Court had usurped enormous powers to itself which it was not given by the Constitution. Yes, reading the real stuff can be very dangerous.

Carlson goes on:

"Another question required us to indicate the pronunciation and give the meaning of the following words: zenith, deviated, colosseum, misconception, panegyric, Spartan, talisman, eyrie, triton, crypt...."

"In Geography: name two countries producing large quantities of wheat, two of cotton,

two of coal and two of tea. Name three important rivers of the U.S., three of Europe, three of Asia, three of South America, and three of Africa.

"As one of Physiology's ten we were asked to write '200 words on the evil effects of alcoholic beverages.' Another directed us to define boards of health and tell what their duties

were.

"In Grammar's ten were two directing us to analyze and diagram: 'There is a tide in the affairs of men, which, taken at the flood, leads on to fortune.' And then to parse tide, which, taken, and leads.

"In History we were to give a brief account of the colleges, printing and religion in the colonies prior to the American Revolution,' to name the principal campaigns and military leaders of the Civil War, and to name the principal political questions which have been advocated since the Civil War and the party which advocated each."

This is what eighth graders were required to know 83 years ago. How many of our high school seniors could pass this exam? Our beautiful White children have been stripped of their racial and cultural identity by the multiracialists, and are now just individuals, alone in the world without a sense of community and without motivation. Is it any wonder that they have little desire to learn and achieve? GG

Reasons for Panama Invasion Still a Mystery

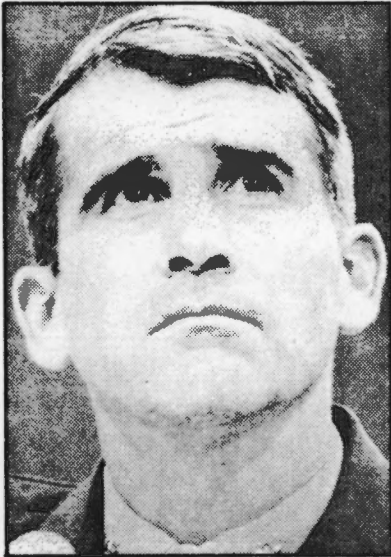
It is still difficult to figure out why the Bush Administration invaded Panama. Noriega never threatened to close down the Canal, and even if he had, his 4500 man Panamanian Defense Force would have found it hard going against the 14,000 U.S. troops stationed there. Bush claimed it was because Noriega was a drug runner, but Bush also claims that Castro is a drug runner and he did not invade Cuba. Moreover, nobody claims that the invasion will in any way affect the availability of drugs in

the U.S. - because it will not. Yes, Noriega was involved in drug running along with his CIA and Mossad partners. In fact, former U.S. Ambassador Moss (1978-82) predicted on television that Noriega would not be tried because of this embarrassing connection. This still may be turn out to be correct.

Panama is not the only place that the CIA runs drugs. Col. Bo Gritz was sent to Southeast Asia four years ago under the auspices of the U.S. government to find MIAs from

the Vietnam War. He did not find any Missing-in-Action, but he did find that the CIA was acting as middleman in the drug traffic out of the Golden Triangle. The media has all but ignored Gritz for reasons that are hard to fathom. Perhaps because he took his story to a "right-wing" weekly, **The Spotlight**, which is considered anti-Semitic by the Jewish Anti-Defamation League.

Apparently, the profits from the drug traffic are used to fund various CIA rogue operations. Since there is

no traceable money flow these activities avoid Congressional, and sometimes even Presidential, oversight. The CIA supposedly closed down its rogue operations after the 1975 Church Investigation in the Senate. But the Iran-Contra Scandal revealed that the CIA still runs such nefarious activities, but through

“private contractors” such as General Secord (who has just plead guilty to lying to Congress in the Iran-Contra Hearings.)

Indeed, Noriega is now claiming that the reason behind his falling out with the U.S. is his refusal to allow Contra forces to be based in Panama. This request came from Lt. Col. Oliver North. Noriega claims that Bush was involved in this Contra business, and no doubt there is truth in that, but something still seems to be missing. Perhaps Bush wanted to rid himself of his wimp image, he wanted to become a hero like his predecessors: the Hero of Grenada and the Hero of the Maya-quez. The Organization of American States (our Allies) failed to see the heroism in knocking off another little Latin American government and labeled it traditional Yankee imperialism. But Bush’s ratings went up in the polls so he apparently got what he wanted, and since it was not his blood that was spilled, only that

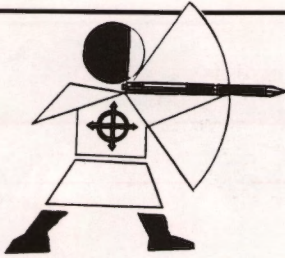

Jew Heads East Germany

According to the **Washington Jewish Week**, the new head of the Communist Party in East Germany is a Jew. His name is Gregor Gysi and he naturally enough has gone on the warpath against the rise of neo-Nazi activism since the imposition of the Communist-led coalition government in East Germany. Gysi wants to reinstate the despised Stasi (State Security Office) to destroy the new neo-Nazi movement that is demanding immediate German reunification, but the other three parties threatened to quit the coalition if the Stasi were allowed to continue to operate. The three plutocratic parties also want laws against Nazism such as those on the books in the "free country" of West Germany, but they do not want to see the Stasi back in action. In the most recent development, the East Germans learned that the Stasi was still operating secretly (as befits a secret service) at a reduced level. This triggered an attack on the headquarters of the Stasi in Berlin. When the mob sacked the HQ it found gourmet foods and wines stockpiled in the basement. More evidence of the utterly corrupt nature of Communist rule in the "workers' paradise."

Dole Plays with Fire

What to make of Senator Bob Dole's (R-KS) remarkable suggestion that aid to Israel be cut by 5% in order to help "fledgling democracies" in Eastern Europe? This may seem like a perfectly reasonable and proportionate idea, but Dole knows better. The Jews immediately jum-

ped all over him. If he persists, the real power in Congress will send him the way of former Senator William Fulbright, former Senator Charles Percy, former Congressmen Paul Findley, etc. Those who get the Jews upset do not last long in Congress, and Dole is very well aware of this. Maybe he is just tired of being a lap dog and wants out.

Pro-Drug Campaign

In the last issue of **The Nationalist** (Jan90) we predicted that the media was beginning a campaign to legalize drugs in America. Shortly after publication, George Shultz appeared on the **MacNeil Lehrer News Hour** and explained why he thought drugs should be legalized. Briefly, he said that the drug traffic could not be stopped, so it should be made legal to bring it under control. If the System is so corrupt and inept that it cannot stop the illegal drug traffic which is opiating our people, then the logical conclusion is revolution, not legalization of evil. But, of course, the capitalist leaders will never admit to that. They would rather see our people and nation dead and buried than give up their power, position and profit. After all, they can always transfer their money elsewhere when this country goes down the tubes, just as did the British capitalists earlier in this century.

On January 21st, the **Scripps Howard News Service** published an inane article on how wonderful Holland is now that drugs have been legalized. It seems that there are now less addicts in Amsterdam than

previously. No doubt that is true since heroin and cocaine are now readily available and tolerated throughout the country there is no longer any need for addicts to go to Amsterdam, which city is still one of the most bizarre and degenerate in Europe. Marijuana use is also down amongst teenagers according to the article, which failed to mention usage rates for other drugs such as crack cocaine. It also failed to discuss the nature of life for the addicts and their families, or the productivity of those who use drugs regularly. It seems that this present media propaganda campaign will be filled with the same sorts of lies and distortions which have characterized other media campaigns, such as those for multiracialism and feminism.

Blacks Want Out of Britain

According to a poll by **The Sun**, a popular London tabloid, seven out of ten Blacks are in favor of repatriating immigrants who want to go home. The newspaper also reported that 63% of Whites are willing to give government subsidies to those who wish to be repatriated.

Blacks Move South

In 1900 about 90% of all Blacks lived in the South. Over the next 80 years they migrated north until only 52% of Blacks lived in the South. But since 1980, Blacks have again been migrating south particularly to the cities. Richmond, Raleigh-Durham, Atlanta, Montgomery, Memphis, Nashville, etc., etc., Now 56% of Blacks live in the South. Knoxville is the only White city left - for now.

An Open Letter

To Harry Moskos and The Knoxville News-Sentinel

Harry Moskos is the owner and editor of the Knoxville News-Sentinel. On January 14, 1990 his newspaper published a vicious and lying article about the National Democratic Front and its leader, Gary Gallo. This was followed by a malicious and hate-filled editorial on January 17th. Moskos, that great champion of free speech, has refused to publish the NDF's letter of rebuttal which follows:

Dear Editor,

There are so many lies and distortions packed into your short article on me and the National Democratic Front that it is hard to know where to begin. We are not White Supremacists, we are White Nationalists. We do not want colored slaves, or colored wage-slaves as the capitalists do. Rather, we want nations for each race in order to protect their cultural and biological purity. Our Program states: "Under a National Democratic government each race will be granted its own completely independent nation on the soil of America, as every people should have the power of self-determination. Each such state will receive an amount of land in proportion to the size of its population. Further, those who preach multiracialism will be given a multiracial state to live in."

White Nationalism is a complete philosophy of life based on service to and sacrifice for our people. Its three pillars are Racial Freedom, Social Justice and Noble Leadership. We seek to share the wealth of this richest of all lands, but we are opposed to socialism (government ownership of the means of production) as it is inherently oppressive. We stand against both Capitalism and Communism and support an alternative economic system (called Sharism) which is based on real free enterprise and redistribution of the wealth. Moreover, under the NDF we will have brilliant, honest leaders who are willing to sacrifice for their people rather than demand sacrifice from them while continuing to live in luxury. Certainly, your readers would be interested in how this is to be done, but you gave them no way to contact us.

The Census Bureau study cited in our literature says that Whites will become a minority in America by the year 2060, not 2010 as stated in your article. Glenn Miller never urged the members of the White Patriot Party to join the NDF (though many did anyway after the WPP folded.) The Hitler and Ho Chi Minh quote obtained from the Jewish ADL was taken out of context. The quote attributed to me about "revolution, secularism and socialism" is a total fabrication, no doubt also gotten from the ADL. Which goes to show the absurdity of reporters relying upon the Jews for information about White Nationalists. The Jews are opposed to all racial nationalisms except their own - Zionism. They hypocritically attack White racialists while they defend the apartheid structure of Israel which exploits the Arabs as wage-slaves, and which tortures and murders the Palestinian children who rise up in justifiable revolt. As a U.N. General Assembly resolution said in 1975, "Zionism is racism." Indeed, it is a dishonest and parasitical form of racism based on hatred rather than love of one's own kind.

Your newspaper claims to believe in free speech, but in fact it seeks to control information in order to stifle real political debate. That is why your newspaper distorted our views and refused to print our address. You fear that people will like our message and will want to get in touch with us. And you are right. We are the only real alternative to the rotten and corrupt System that is destroying America, and the people are coming to see that. And we will get our message out to the people despite the machinations of the controlled media.
