Huge White Rallies in South Africa 20,000 White Nationalists March in Pretoria

The largest White political rally in the history of South Africa took place in Pretoria on February 15th in response to the release of Nelson Mandela and the legalization of the South African Communist Party (CP) and the communist-led African National Congress (ANC). The rally was sponsored by the Afrikaner Resistance Movement (AWB) led by Eugene Terreblanche and the Conservative Party led by Andreis Treurnicht. The AWB is a social movement which supports the Conservative Party in elections. The AWB is rooted in the Afrikaner lower middle class and poor which the U.S. media pretends does not exist. AWB soup kitchens and welfare programs take care of the White poverty-stricken workers while the capitalist leadership of South Africa hire Blacks for ever-cheaper labor.


The U.S. media also pretends that the Conservatives are conservative and want to reinstate Apartheid. They do not. The Conservative Party advocates self-determination, i.e. completely independent and separate nations for the various peoples of South Africa. They want a pure White nation in which Whites do their own menial labor. An experimental city called Morgenton has been set up in the Transvaal along

these lines by the Union of Orange Workers, which is the ideological vanguard of the new White nationalist movement in South Africa. A representative of the Conservative Party tried to explain this White nationalist approach on the television show Nightline, but its Jewish host, Ted Koppel, was not interested, and this vital distinction between nationalism and conservatism was lost on the American audience.

The U.S. and capitalist-controlled South African media lionized Nelson Mandela upon his release while he reaffirmed his commitment to violence and terrorism, and while he continued to support marxist nationalization of major industry. Just last year in the White elections, National Party leader and now President de Klerk attacked the ANC and declared anyone who talked to it a traitor. In the past three months de Klerk has completely turned around, without explanation to his followers, to sell out the White race and cut a deal with the Blacks. The Whites feel as if they have been defrauded, and they are outraged. So why did the National Party do it?

THE SELL-OUT

The capitalists fear the growing

strength of the radical White nationalist movement, especially with its working class and social justice orientation. They realize that they will probably lose power in the next general election in 1994, and so they are determined to complete the sell out before then.

They will try to finalize negotiations as soon as possible with the Blacks on a new constitution which will strip Whites of their political power and force them to live in a multiracial society. But the White capitalists will only make the deal if the ANC is willing to allow them to continue to control the major industries of South Africa. A delegation of big business leaders, led by the Jewish owned firm De Beers (gold and diamond mines), met last year with the ANC to discuss the matter. The U.S. has also encouraged the ANC to cut the deal before it is too late. And apparently, the ANC agreed to serious negotiation, thus the release of Nelson Mandela.

THE ANC IS RED

The ANC is led, in Mandela's absence, by the Black communist Oliver Tambo and the Jewish head

of the South African Communist Party, Joe Slovo. Slovo heads the terror wing of the ANC. He, no doubt, does not want to see Jewishowned DeBeers divested. When the Jewish-dominated marxists took power in Russia in 1917, they worked well with Jewish capitalists such as the House of Loeb, the House of Warburg, and Armand Hammer whose favored status with the Soviet government lasted into the 1980's. Jewish power in the communist movements of the world give Jewish capitalists an unusual security. In

fact, the two supposedly opposite factions often work hand in glove to establish a Jewish dominated society. Russia and the nations of Eastern Europe (which all had Jewish governments after the Second World War) are the best evidence of this special relationship which places the interests of Jewry above those of class. In another example, the Jewish lobby in the U.S. compelled our government to give Romania favored-nation trading rank when the vicious Communist dictator Ceaucescu recognized Israel in the late 1960's. The Jews have been instrumental in forging cooperation between communism and capitalism.

"TRAITOR, TRAITOR!"

Huge White rallies around South Africa followed the march of the 20,000 in Pretoria. Conservative Party leader Treurnicht has charged the National Party government with capitulating to U.S. sanctions, and he pointed to the humiliation of President Bush inviting Mandela and de Klerk to the U.S. at the same time, as if they had equal position.

"How can a man who calls himself an Afrikaner turn a whole volk into a minority group overnight," declared Treurnicht and the crowd responded with "Traitor, traitor!"

The nationalists are trying to force a special election because of de Klerk's mammoth deception in the last campaign. If they cannot do so, then there will likely be a bloody White revolution in South Africa before the signing of the new constitution. The media tells us that the White police force and the White army will not support a White revolution. Well, we'll see. We will also see which side the six million Zulus come down on as they also want their own nation and have been locked in bloody street combat with the ANC for years. GG

Once Again the Polls Lied

Prior to the February 25th elections in Nicaragua all the polls indicated a big victory for communist Daniel Ortega over capitalist Violeta Chamorro. Even American polls taken in Nicaragua predicted a government victory. The Washington Post-ABC News Poll, for example, showed Ortega 16 percentage points ahead of Chamorro just 10 ten days before the vote. But on election day 55% voted for Chamorro. Ortega was stunned, but so were Chammoro and President Bush who channeled \$8.5 into the election through the CIA according to the Washington Post.

THE ACCEPTABLE ANSWER

Why are polls so often wrong? Because people lie to pollsters on politically sensitive or socially embarassing issues. The polled tell the pollsters what they think they are supposed to say, rather than what they really believe. But when they get into a secret voting booth there is no pollster confronting them, and they find the courage to vote their hearts. The people will give the pollster the socially acceptable answer he or she wants to hear. For example, most of the big polling firms in Washington D.C., even

those in the suburbs, are racially skewed toward promoting multiracialism - not for ideological reasons, but for economic reasons. These firms have hundreds of tables with hundreds of phones upon them, each manned by a minimum-wage Black woman who speaks English, more or less, but not in the same accents as the Whites she will poll. Naturally, these "professional and scientific" polling companies find much more support for programs of forced integration than actually exists in the White community.

DUKE AND THE POLLS

In the parish elections in Louisiana last year, "scientific polling" by the Democratic and Republican parties, and by the Jewish ADL, all found that racialist candidate David Duke had the support of only 15% of the electorate in his parish. Yet in the primary, against eight other candidates, he won 33% of the vote and he went on to win the election with 51% of the vote as an astonishing 78% of the people turned out. Now he is running for the U.S. Senate and the pollsters are once again telling us that he has no chance, even though they admit that Duke has a 94% name recognition in



Louisiana. No, in America, most citizens do not yet have the courage to admit to a pollster that they are racialist, but they will vote racialist when given the opportunity and some prospect of victory. The System uses the polls to try to convince people that there is no prospect of victory for the causes they really believe in, which is why so few people vote in the U.S.

DRUG WAR POLLS

Another area in which there is massive polling fraud is the so-called "drug war." The polls have been telling us that since Ronald Reagan was elected in 1980 drug use has steadily decreased. Yet, FBI statistics indicate that there are more drugs coming into the country than ever

before. And the FBI underestimates the problem; it has calculated the yearly drug traffic at \$100 billion, but last year in Los Angeles police discovered one wharehouse with \$20 billion worth of drugs in it. Are we to believe that fully one-fifth of the nation's drug store was kept in just one L.A. wharehouse? If so, then why did the capture of this supply not disrupt drug sales nationwide? It defies belief. Clearly, the drug trade is much larger than anything previously estimated.

Now if the polls are right, fewer

and fewer people are using ever and vastly greater quantities of drugs. Is this believable? Hardly, so why do the authorities put out the line that drug use is decreasing? Because they can get away with it; because our people are taught what to think, not how to think, and so they do not ask basic questions — they can no longer put two and two together. The plutocrats do not want to admit failure in the "War Against Drugs" which began under President Nixon and which reemerged as a campaign issue with Reagan and Bush. They

use the polls to cover their ineptitude. In Nixon's time more kids claimed to use drugs than actually did because it was gutsy, and "cool," and it certainly seemed to be the wave of the future - the way of the "enlightened." But now that bitter experience with mass addiction has stripped away the facade of "healthy drug use," more kids are claiming to abstain than actually do. The polls reflect atmospherics, not facts.

Anyone with a child in school knows that drug use is epidemic amongst the young, and we all know middle-aged drug wrecks. Drugs are now everywhere, and everyone knows it. The polls lie.

BEHIND THE POLLS

The people who seek to control our thoughts and direct our opinions and behavior know the polls lie, and that is why they use them. So the next time you read or hear the results of some poll, do not just take it for granted. Think about who took the poll and why. Most are not innocent collections of data. Think about why they are providing you with the information. And most importantly, think about whether it contradicts or corresponds with other knowledge you have - whether it jibes with reality. It is time to start thinking again. GG

Temple of Greed Goes Bankrupt

Drexel Burnham Lambert, the Jewish-run Wall Street firm that came to epitomize "successful" capitalist greed in the 1980's, has filed for Chapter 11 bankruptcy reorganization, but not before it pulled one last scam.

You will remember that Fred Joseph, the Jewish head of the company gave up his good buddy and fellow Jew Michael Milken to

the Feds in an attempt to try to avoid prosecution of himself. Joseph agreed to testify against Milken, his junk bond chief, on various fraud charges and agreed to Drexel paying a \$600 million fine (approximately one year's profit at the time.) But the prosecution and fine disturbed many of Drexel's clients and its business fell quickly and drastically. Joseph fired hundreds of employees,

but the firm still lost money.

CAPITALIST FAIRY-TALE

Then, in a classic move that would earn Joseph a jail sentence in anything but a capitalist society, he awarded himself and his top officers \$350 million in bonuses. Afterwards, he went to the banks to borrow exactly \$350 million to stave off bankruptcy. When the banks refused

Down, Drexel filed for reorganization. Yes, Drexel may be finished, but its officers will live happily ever after - at least until the NDF takes power.

WORKERS WILL PAY

And what of the millions of junk bonds that were used to finance one bad merger or acquisition after another. They are in the hands of institutional investors such as pension funds, mutual funds and insurance companies, and their value is falling fast. Some bonds have already lost as much as 50% of their value. And many of the newly merged companies are going down the tubes (Campeau being the largest), as the financiers prove themselves to be even more inept at management than the previous crew of executives.

In the 1990's and beyond, millions of American workers are going to find that their pensions exist only on paper. Will the government also bail out the pension funds to the tune of

hundreds of billions of dollars? With what money? The federal government is already in \$3.5 trillion of debt, and the national debt grows every year by another \$100 - \$200 billion. Through the tax "reforms" of

the 1980's, the rich are exempt from fair taxation as the progressive tax has been gutted. Millions are headed toward poverty in their old age. Only revolution now can save them from an ignominious end. GG



Conservative Feminists

The invasion of Panama has apparently convinced First Lady Bush that women should be in combat. She was impressed by the combat leadership of Capt. Linda Bray who was much heralded by the national press and television. Conservative Congressman John Duncan (R-TN) also jumped on the media bandwagon to declare that women should be drafted and should fight in combat: "With rights go certain obligations," "I don't have any objections to women in combat," "Women are just like men - some are more physically fit than others," - words of wisdom from John Dun-

Indeed, it is a fundamental principle of both Communism and Capitalism that men and women are the same intellectually and emotionally, and further that all individuals are the same and that the races are the same. The Communists and Capitalists do not recognize genetic differences as being substantial and this leads them to commit all sorts of crimes against nature, which will undo their systems in the end. Given much less attention by the national. media was the AP report of January 21st about two female soldiers who refused to drive other soldiers into downtown Panama City where fighting was taking place. The two women "feared for their lives," and broke down in tears. The Defense Department is considering charges against them. Crimes against nature.

Thank the AMA

In the late 1970's West Germany had a surplus of physicians and it

tried to make an arrangement with the U.S. which was (and still is) in need of doctors. The American Medical Association (which is dominated by Jewish doctors) took the position that the German physicians were not properly educated because German medical schools were not up to snuff. Hard to believe, but unfortunately it is true, and the Jewish press in New York and Washington cooperated in the effort to denigrate German medical education, which is probably the best in the world.

The real reason the AMA did not want German doctors in America is because it feared the competition. Instead, the AMA arranged for a supply of doctors to come from India, Pakistan, Indonesia and Haiti. We are now beginning to see the effects of that policy. In New York, twenty-two doctors have been arrested for trying to steal Medicaid money for treatment of nonexistent patients. Prosecutor Edward Kuriansky said the accused physicians are part of "an influx of foreign nationals" from such places as Indonesia, Haiti and Pakistan "who have come here principally to rip off the Medicaid system." Last year an Iranian doctor in Pittsburgh was charged with raping and molesting several female patients. He is now safely back in Iran, and of course, the Iranian government refuses to extradite him or prosecute him. And to think, we could have had real doctors.

In the Land of the Free

Purdue University has fired Assistant Professor Donald Hiner, age 50,

for teaching the Revisionist view of the Holocaust to one of his history classes. He was teaching two history classes and one English class for the university when he was terminated. Hail freedom!

DNA and Race

Previously in a Short Burst we discussed the dispute between Emory University and the University of California at Berkeley in regard to DNA and racial differences. The latter claimed that there was no substantial difference between the mitochondrial DNA of the various races of mankind, whereas the former claimed that races could be identified by the differences in their mitochondrial DNA. We predicted that the Jewish-led Berkeley team would likely be the one forced to give up its position because it was either wrong about the evidence or just lying. Now comes geneticist Linda Vigilant from the University of California at Berkeley and her research implicitly confirms the Emory view. She studied the mutational differences in mitochondrial DNA between the races to see which was closest to that of our earliest human ancestors. She found that the Pygmies of central Africa and the Kung of southern Africa are the most primitive of the human races and those most closely linked with pre-man.

Naturally, she was much more careful in her phrasing than that; she said these two are the "deepest branches" on the genetic family tree as they showed the fewest mutational splits from the ancestral human line of mitochondrial DNA.

Children of the Damned

In our children we see the reflection of our society and a vision of its future. We need only to look at our youth to see what is and what will be. Our treatment of them and the standards set for them determine the outcome of all our efforts.

Judging by our children the future looks very bleak. Almost half of the children in the U.S. live in broken homes. More than a million are reported missing every year (compared to just 4000 in Great Britain.) A million are physically or sexually abused every year in what can only be termed an epidemic of perverse behavior. And according to a study by the Vacaville Correctional Center of California, it is the child of a single-parent home who is most likely to be the victim of abuse.

The U.S. has the highest rate of infant mortality in the industrialized world. Even Hong Kong has a lower rate. One out of every 61 babies in the U.S. is born with AIDS, and this number is steadily increasing. The U.S. ranks dead last in education. We are embarassed year after year on international tests of basic knowledge, even by countries that spend much less on education than we do.



Unless we act now this will be our future: Black teachers trying to educate disheartened White children in a colored culture.

Drug abuse and alcoholism run rampant amongst our youth, and these opiates are the greatest causes of automobile accidents, the number one killer of White children. Sadly, suicide is the second leading cause of death for White youth. Our children have become materialistically decadent, morally corrupted, racially degenerate and culturally illiterate in our "brave new world" of capitalism gone amok.

But then again, why shouldn't our children be decadent when the culture as a whole is likewise and offers them nothing different, nothing better. Our wonderful White children are systematically stripped of their racial and cultural identity and are taught to worship individu-

alism instead. The further the U.S. sinks into the abyss of multiracialism, the more it resembles the Third World mixed-race countries of Mexico, Columbia and Brazil. These countries, as well as all other multiracial states, are plagued with corruption, mass impoverishment, illiteracy, disease and violent crime.

Such conditions are spreading rapidly through the U.S. today. One need only to look at our multiracial cities to see the stark evidence of decay. How much different is New York, or Los Angeles or Washington from Third World cities.

What will be the legacy we leave our children, and their children? Will they be the future children of the Third World - the children of the damned?
