Jews Campaign Against German Unity

The Jews have launched a massive anti-German media campaign in a foolish, last gasp effort to prevent the unification of Germany. All it will succeed in doing is arouse the enmity of the Germans toward the Jews once again. Elie Wiesel and

Simon Wiesenthal, the most notable purveyors of the Big Holocaust Lie, are making the TV and radio rounds claiming that all Germans must bear the guilt, and the punishment, for the "crimes" committed against the Jews by the Nazis. The reasoning is

spurious and impossible to follow, but the Jewish desire for eternal revenge is very real.

Jewish Racial Hatred

Such open and vicious racial hatred is allowed to be expressed in the media only in the case of the racial enemies of the Jews, particularly the Germans and Arabs. Robert MacNeil, on the **MacNeil Lehrer News Hour** almost apologetically trapped Wiesenthal in his own hypocrisy by asking him about collective guilt. Wiesenthal denied believing in collective guilt, yet admitted to MacNeil that he wrote, and still believes, that Germans for generations to come would bear the guilt and responsibility for the Holocaust.

The Jewish-owned newspapers such as the **New York Times** and the **Washington Post**, through their Jewish and puppet columnists, have chimed in with a similar theme: **the Germans cannot be trusted**. The Jews have dropped the pretense of being concerned only with Nazism and are now brazenly anti-German in their bombast.

Yellow Journalism

The heights of yellow journalism was reached by Jewish-owned **Time** magazine in its March 26, 1990 issue which featured a cover illustration of East Germans cheering the fall of

Communism on the bottom, and World War II German Wehrmacht (regular army - not Nazi) troops on the top with the caption: "**The Germans - should the world be worried.**"

In a well-worn propaganda technique, **Time** trotted out anti-Germans to make its case so it would not have to say the outrageous itself, it need only "report" it. For example, the long-retired, and powerless, former French Prime Minister Michel Debre was quoted as saying, "We French, who know our neighbors well, how can we not remind all Europeans and the world as a whole of the need to guard against abuses which Germany commits in all areas when it sees an opportunity?" As if the French (architects of the infamous Treaty of Versailles) do not take advantage of opportunities to benefit the interests of their nation, as if the Russians, British, Americans and Jews are not all playing the same game.

Selective Outrage

Time went on to tell us that, "For many Europeans the inhuman crimes of the Third Reich are as vivid as yesterday." Apparently the

inhuman crimes of the Jewish-led Communist movement are not so vivid, or the inhuman crimes of the Zionist movement, committed yesterday and still being committed today, are not so vivid. Certainly they are not for the Jews of **Time** magazine.

History Will Not Repeat

"The very word German can cause a shudder," **Time** tells us, "some are convinced that history could repeat itself." Yes, the Jews would very much like to see history repeat itself - to see White nation fight White nation for the benefit of Jewry. And the Jews think they have the political and propaganda power to pull it off a second time. But they do not think clearly where their own interests are involved. Despite the Jews, Germany will be reunited and young Germans will come to learn why their nationalistic forefathers hated the Jews. They will come to learn that the Holocaust is a another Jewish Big Lie designed to rob the Germans of tens of billions of dollars in reparations and to destroy the reputation of the Germans for all time - that the Jews hate Germans because they are nationalistic and strong.

Historically nationalists give Jews two choices: assimilate or get out, and the Jews wish to do neither. That is why all nationalistic peoples are at war with the Jews inside their borders, and that is why the Jews oppose all nationalisms other than their own - Zionism.

No More Brothers' Wars

Time tells us that the Poles and the French fear German unification, and indeed the Jewish-led Solidarity government of Poland has demanded a role in the negotiations over Germany. Solidarity has helped in building up an anti-German frenzy

in the country which accounts for opinion polls which indicate that 64% of Poles oppose German unification. But in the same article **Time** admits that 68% of those polled in France support unification.

The National Democratic Front is determined that Whites never again kill Whites for the Jews. The Decline of Britain's National Front: Two Views

The National Front was established in 1967 in Britain and quickly became the leading racial nationalist political party in that country. It was led by John Tyndall for most of the 1970's during which period it rose to about 15,000 members. The NF was able to stage huge marches of thousands of members which brought out equally large Red counter-demonstrations. In local elections in 1978 the NF polled 119,000 votes in London alone. The System was in a near-panic and in the 1979 elections Margaret Thatcher promised to end colored immigration. The Tories thereby coopted the NF's big issue and the floor fell out. Support quickly shifted from the NF to the Conservative Party where "the vote would count." Thatcher was lying, of course, but that would only help the NF later.

As the Party disintegrated and debt threatened to overwhelm it, Tyndall demanded greater power saying it was necessary to overcome the dire situation. The NF had always been a revolutionary party run according to a parliamentary constitution. Tyndall's move to

reconstitute the Party along truly revolutionary lines created a major split. The Directorate refused Tyndall, and he resigned to start the New National Front, expecting that the NF would collapse under its debts and factionalism. It survived, however, under the leadership of Martin Webster, forcing Tyndall to rename his party the British National Party.

The Gay Nationalist

Webster was talented and had a flair for political leadership, but he was also well-known as a homosexual, and he built up a gay command structure about himself. This did the NF great harm, and it limped along until the 1983 split in which Webster and his gay comrades were ousted from the Party by a clique of young radicals in collusion with slightly older conservatives.

The NF was immediately given new impetus through the adoption of Third Position ideology, with its emphasis on social justice and the environment, which was then gaining momentum throughout White Nationalist circles in Europe and

around the world in one form or another. Membership jumped from 1000 in 1983 to 3000 in 1986 when the next split occurred.

The radicals, or Third Positionists as they were now calling themselves, split into two factions with the conservatives allying themselves with the smaller faction. The conservatives and the smaller faction of radicals were thrown out of the Party, and they began calling themselves the NF Support Group. The NFSG put out its own newspaper (conservative in content) and its own theoretical magazine (radical in content) in competition with those of the NF. And then the NFSG began calling itself the National Front. Amazingly, the real National Front decided not to challenge this in

court, but instead began to refer to itself as the Official National Front.

The public was thoroughly confused. The Official National Front developed a bizarre, incoherent and incomprehensible ideology which endorsed the ideas of the Libyan leader Muammar Qaddafi and the Iranian Ayatollah Khomeini. The other National Front remained frozen ideologically in a schizophrenic balance between the radicals and the conservatives, where it still remains to this day.

In 1989, the Official National Front split into two groups, one of which left the Party to become Third Position, Internationale while the other abandoned the name National Front altogether to become the Third Way. The former is preaching an anti-Semitic, Catholic-based theology, while the latter has welcomed Jews into its party.

Meanwhile, John Tyndall has quietly built his BNP into the largest racial nationalist party in Britain (approximately 2000 members at this writing) simply by adhering to sound organizational principles. What follows are two views on the death of the National Front from two former NF Directors:

A former Director of the National Front, John MacFarlane gives one view of its decline:

In early 1990 the National Front announced that it would no longer continue to use the name National Front. The decision to drop the use of NF was taken whilst the Party was in the middle of yet another, and this time fatal, split. The demise of the National Front will sadden many of those who for years campaigned and fought for the party since its birth in 1967. It will also anger many others who will point the finger accusingly at those deemed to be

responsible for the murder of one of the most successful White Nationalist movements in post war history.

NF Resurges

I joined the NF in 1981 when the Party was at a very low point in its existence. The Party had been decimated by a number of major splits in 1979 and 1980. Morale and resources were low, but as a new recruit I was filled with optimism and craved activism. Slowly the party pulled itself round from the brink of bankruptcy and membership slowly began to rise.



Many of the new members were skinheads and of these a large number were joining for shock-value or anti-social reasons. A small number of mainly young idealists had also joined, and by 1983 the young radicals were strong enough to oust the then Party big fish Martin Webster. Although Webster's removal caused a little unrest, the majority of members were happy to see the back of the Party's infamous homosexual leader, even if the manner in which he had been removed was less than open and honest.

With the removal of Webster and his homosexual clique, the NF came increasingly under the control of a group of young ideological radicals, though the conservatives were still powerful in the party.

The NF made progress thru '83,

'84, '85, and by 1986 membership had increased from the low of around 1000 members to about 3000 members. By 1986 the new radical NF was again beginning to attract media attention. Morale and activism was on the rise throughout Britain, including even in Ulster where the Party was making a major effort and was gaining a large amount of media coverage and public support from the Loyalist community.

A Timed Split?

As if by magic, the NF was once again thrown into internal disruption at a moment of enormous political opportunity. The timing of the various splits in the long history of the NF has convinced many people of the involvement of State, Zionist and/or Red agents in the disruption of the NF. As a member of the NF National Directorate during the '86 split, I cannot honestly say that I know that such and such a person is an infiltrator, however, I can and do question the motives of a large number of the people involved at Directorate level, and I can say that the real interests of the NF and of racial nationalism in general were not the prime concern of many of the major figures involved in the '86 split.

There was no one reason for the split in 1986, largely however, petty personality clashes played the major role in the breakup, while those who saw a chance to improve their own positions were happy to be provided an opportunity. The way in which so called comrades so quickly turned on each other left me very bitter at those who put more effort into factional infighting than they did into promoting the Party.

In mid-1986 as the split was in progress, I was forced to resign from the NF Directorate due to health

reasons. I remained a member of the Party until February 1987 when I decided to leave the NF because of the direction the Party was heading ideologically, and due to my distrust of the motives of those who came to control the Party.

The Slide

From 1987 the NF went into rapid decline in terms of membership and credibility. The policies of the Party became increasingly unsound and the active membership, which fell to around 125, ceased to take seriously many of the positions which the Party was espousing. Circulation of the Party newspaper **NF News**, fell from around 15,000 in 1986 to 1000 in 1989.

The ideological position of certain leaders continued to confuse and alienate the NF from the mass of nationalist sympathy in Britain. With membership stagnating and with no sign of real progress being made, the leadership once more turned on

each other. Alliances that had been made during the '86 split were broken and once again the NF was compromised not by the actions of our opponents but from within.

In 1989 one faction decided to leave the Party altogether, whilst those in charge of the now pitifully small NF decided to drop the use of the name National Front. The former now calls itself Third Position, Internationale and has relocated its base to France for unfathomable reasons. The latter now calls itself the Third Way.

Both factions involved in the last days of the National Front were unworthy of the once great party they managed to destroy. The reasons given by both factions for their actions were, in my opinion, pathetic and dishonest, and reflected the character of those who were the architects of the death of the NF.

Perhaps the most important factor in the demise of the NF was the refusal or unwillingness of many of

its leaders to adopt a radical or revolutionary constitution with the discipline that is required for a successful nationalist movement. Part of the reason for the founding of the NF was to combat the effect of "Liberalism," yet throughout its history the Party failed to combat the Liberal mentality in its internal make-up.

The demise of the NF does not mean the end of the struggle for racial nationalism in Britain, far from it. Our Cause is too important to allow us to grieve over the death of the National Front, rather we must learn from the lessons of NF history and ensure that those who have been the architects of failure are not allowed to destroy other attempts to build racial nationalism in Britain. **JM**

Grabowski for Congress

Chester Grabowski is the editor of **The Post Eagle** (founded in 1962), an English-language newspaper for Polish-Americans with a paid subscription base of 16,500. He is also a racist and a candidate for Congress in New Jersey's 9th District on the Populist Party ticket for 1990.

Recently, Alan Dershowitz, the rabidly Zionist "civil rights" professor and media star from Harvard, mailed a letter on Harvard stationery to each **Post Eagle** advertiser denouncing Grabowski as an anti-Semite and demanding that each end his advertising or face the consequences. Dershowitz is another great believer in free speech and all our other Constitutional rights and traditions - as long as they serve the Jews. The Jewish Defense League, the leading terrorist organization in America, has threatened Grabowski's life and has threatened his family.

Blacks Smell Blood

You wouldn't know it by the media, but since the release of Nelson Mandela a wave of Black violence, Black on White and Black on Black, has swept over South Africa. The media has given this

violence about as much coverage as it gives the Palestinian Intifada (yes, it is still going on, though the press has stopped reporting the body count.) This sort of propaganda deception practiced by the American media cannot, however, change things on the ground in South Africa where the Afrikaners are growing increasingly restless and angry.

The Blacks think that their victory is near and their true nature is coming out. But they are in for a surprise. The Afrikaners are a very different breed from the degenerate English who relinquished power all over Africa and then fled to more peaceful shores. Much of the Afrikaner leadership is corrupt, but the people are still sound and they will fight.

Black Solidarity

Despite Nelson Mandela's reaffirmation of his commitment to violent struggle and marxism, Black leaders in America are trying to lobby the Bush Administration and Congress to send foreign aid to the African National Congress. Jesse Jackson, Benjamin Hooks, Coretta Scott King and Randall Robinson of Transafrica are the leaders of this effort.

Robinson decided that the best approach was to lie, since the media never calls Blacks to account for their lies, and he said that since the ANC has suspended violence over the past several months it should be treated like a "prodemocracy force" such as the contras - a rather sleazy argument since these people opposed aid to the contras, but one that is designed to impress Bush people,

be they ever so stupid and full of themselves. In fact, ANC violence is hitting new peaks every day in South Africa though this goes largely unreported by our media-masters.

Final Call

Louis Farrakhan's Black Nationalist movement, the Nation of Islam, publishes a newspaper called **Final Call**. The March 21st edition of **Final Call** reprinted without comment the speech given by NDF leader Gary Gallo in Knoxville on December 10, 1990. This speech was first published in the Jan90 edition of **The Nationalist**.

Crime Pays

On April 25th, ex-junk bond king Michael Milken pleaded guilty in federal court to conspiracy to violate securities laws, aiding Ivan Boesky in the breaking of securities laws, and assisting another trader (David Solomon) in filing false income tax returns. Milken plea-bargained in order to avoid prosecution on more serious charges including racketeering and insider trading. He agreed to pay a fine of \$600 million, leaving his personal fortune at well over \$1 billion. He will be sentenced on October 1st.

Like Boesky, Milken will spend a few years in a minimum detention facility and will return to vast wealth and power. It is little wonder that the ordinary American has lost faith in the System. Have you noticed that all of the major players in these financial scandals are Jewish (Levine, Boesky, Joseph, Milken, Solomon, etc.)? Just a coincidence, no doubt.

Time to Put People Before Profit

The following letter was sent to a bankruptcy trustee by a woman whose family farm was being foreclosed upon. The great myth of capitalism is that it is efficient, and therefore the human cost of its cutthroat, self-interested nature is somehow acceptable. In fact, over 90% of America's small businesses fail within five years of start-up. Japan has twice as many small businesses per capita as does the U.S. Why? Because Americans are stupid businessmen? Because the Japanese are more creative, or more daring entrepreneurs? Hardly. Germany and Japan are outcompeting us because their government-directed systems put people before profit. They are united and cooperate with one another while we are divided against one another. They share their wealth while we concentrate ours into the hands of a tiny, immensely powerful minority. Their

systems stem from pre-war nationalisms, while ours is the epitome of a vicious capitalism in which the big prey on the small - and everyone loses from the misery, mistrust and disunity it causes.

Our most industrious and imaginative small farmers and businessmen are being ruthlessly and systematically driven out of business and into poverty by large, mediocre monopolistic firms whose only advantage is size, not efficiency. Through price cutting or enormous advertising these huge companies can force everybody in the market to lose money, and in such a situation the deep pockets always prevail. Except, of course, where they are in competition with other deep pockets, such as the more efficient ones of Japan and Germany whose companies can match American firms dollar for dollar in losses in a trade war. That is why

our foreign debt is so great, and why we have in just ten years fallen from the greatest creditor nation in the world to the greatest debtor nation in the world.

Britain, that other vast capitalist empire, fell from first in Europe to poverty within just 50 years earlier in this century. Will the same happen to the U.S.? Yes, unless there are radical changes soon in the way we think, live, and do things. It is time for industry to serve people rather than for people to serve industry. So the next time you hear someone spouting off about the alleged efficiency of capitalism think about the letter below, think about the decline of the U.K. and the U.S., and think about those nationalistic societies that put people before profit rather than profit before people:

Dear Mr. Yaeger,

I suppose that bankruptcy is supposed to be a "cut and dried" business decision, and in the final analysis perhaps that is the end result. However, with first hand knowledge, I do know there is a far greater involvement, especially the emotional traumas of seeing the upheaval and disposal of a lifetime of very hard work. My husband and I are from farm families of many generations. Except for brief periods of our lives, we have always farmed and know little of any other way of life. Ernie, at 69 years of age, was off the farm during the years of 1939-1945 while he was in service during World War II with 30 months overseas. When he returned in 1945 we were promptly married, having known each other for many years. In early 1946 we bargained for a very run-down piece of land on which we spent \$800 to build a two-room cottage without the amenities of plumbing or electricity on a rural unpaved road. Conditions eventually improved - the road was paved and we did get electricity and running water, but no bath facility for 16 years....

Those years were good because we loved the work of clearing those rolling hills and turning red clay into beautiful green pastures and fields - grabbing up roots and stumps and hauling off endless rocks. It should have mattered that we never had any money at the end of the year, but we always felt the promise and the hope of a better year next year. I worked off the farm at a local bank, an insurance company, a truck line (some of the time at two jobs) along with canning and freezing fruits and vegetables to make ends meet. I sewed for the children and if I needed new curtains or a bedspread, I made them. So much of what we made from the farm went back into the farm, but we didn't require a lot for family living and we simply plowed everything back to the farm.... I am not sure why I am writing you this except that perhaps I need to reaffirm to

myself that our dilemma is not the result of high and riotous living - that we are and always have been a plain, hard-working family....

Actually we were not in bad shape until the years with the terrible interest rates and the grain embargo - it seems in retrospect that was the real beginning of a long, painful decline to this sorry state of affairs....

We are trying to maintain our self-respect and a degree of dignity, trying to get through this most difficult of times with our sanity intact and see what we can do to maintain a livelihood so that we need not resort to public assistance or dependence on our children. At Ernie's age it will be difficult to find work, his knees are worn out; but his social security check of \$296 monthly will help. I was able to get work at a nearby hospital at \$4.10 hourly....

Mr. Yaeger, we are very ignorant about bankruptcy, never having had anyone in either of our families or any of our associates involved in bankruptcy. We believe that when this is over, we will be relieved of all of our holdings and all of our debts in their entirety and we will be left with our household goods and clothing....

Is there any way we can come out of this with even a few hundred dollars? We have nothing. We have acquired and accumulated nothing - with the 40 productive years of our lives down the drain. How long can we remain in the house? Our oldest daughter and her husband own a mobile home into which we will move. This has to be relocated since it now is located on a part of the bankruptcy property. Would it be possible or reasonable to request that we be allowed to live in our house perhaps as long as 60 days...?
