The New World Order: U.S.S.R. Rapes the Baltic States while U.S. Fights to Restore the Al-Sabah Dictatorship

George Bush has announced his determination to establish what he calls a "New World Order," a sort of Pax Capitalistica led by the U.S. or rather by international capitalists headquartered in this country. Bush claims that his new order is based on principle, though what principles these are remains a mystery.

He has no real objections to his new buddies in the Kremlin crushing fledgling democracies in Estonia, Latvia and Lithuania even though the U.S. has always claimed that these countries are not legitimately part of the Soviet Union. Bush has sent no support whatever to the parliaments of the Baltic States beyond lip service. The head of Lithuania, Landsbergis, has demanded action rather than talk from the U.S., but he has gotten nothing but more dissembling. Apparently then, the principle here is to sacrifice the interests and very survival of small democracies where these do not serve the greater benefit of international capitalism.

So what is new about this principle? The U.S. has always followed



this line. It abandoned the Eastern European countries to Bolshevik tyranny after the Second World War, and refused to help each in its turn as each revolted against the vicious Red Terror, making a mockery of Radio Free Europe propaganda. The U.S. has organized the overthrow and sometime murder of each democratically elected leader that opposed its domination in the Third World from Mossadegh in Iran, to Guzman Arbenz in Guatemala to Allende in Chile. Each of these democratically elected governments was replaced by a brutal dictatorship loyal to the U.S. and its money.

The World's Cop

Indeed, though the United States has adopted the role of world policeman since the end of World War II, it has rarely had to resort to war and miltary occupation, relying instead upon the threat of force (military and economic) plus bribery, conspiracy and assassination to enforce its domination. Its so much cleaner that way, more "democratic."

But sometimes force is needed, and as the Third World develops (and some parts of it are developing) the Pax Capitalistica will have to resort to force more and more often, and this is a very dangerous game to play. In fact, the White capitalists can only play it where the Jews assent. In Vietnam the Jewish (capitalist) media decided to join the Jewish-led (communist) anti-war movement and that spelled doom for the WASP-led government.

Burned badly, the White capitalists are now careful to engage only where Jewish support is assured, hence the present war with Iraq. It is not just the Saudis who wish their "White slaves" (as a Saudi prince referred to the American troops) to do their fighting for them, it is the Jews and our White capitalist rulers who are using our boys to protect their interests and enrich themselves. The Al-Sabah family (worth over \$100 billion in foreign accounts alone) will get back its little fiefdom called Kuwait. The Saudis and the Jews will see the destruction of their enemy and the capitalists will get their hands on Iraqi oilfields, and so everyone will be happy, except for the mothers of the "White slaves" whose blood will flow into the sands of the Middle East.

And what will they have died for? For the interests of the Jews and the White capitalist race traitors who wish to see the White race and White culture subsumed into the multiracial mass of the new world order and thereby destroyed, not just in America but everywhere on the planet. That is the agenda of capitalism, and that is the agenda of its ally international Jewry which hates the White people, and indeed all Gentiles for that matter. And that is why we White Nationalists of the NDF oppose this god-forsaken war against Iraq! GG

International Jewry Hunts Professor Trzeciak

In the Aug90 and Sep90 issues of The Nationalist we discussed the adventures in America of Professor Mieczyslaw Trzeciak (pronounced Che-chak) who was visiting this country upon the invitation of the NDF. Prof. Trzeciak is the leader of Grunwald, Poland's largest nationalist organization. Now Prof. Trzeciak is under attack by the powers of international Jewry, not for what he did or said in America (at least not yet), but for a short letter he wrote to the German nationalist magazine Sicg which is based in Austria. Because of this letter that was published in Sieg, Prof. Trzeciak has been charged with anti-Semitism (a serious crime in Poland) and has been stripped of his positions as director of the Social Sciences Institute and head of the Department of Sociology at the Kasmiera Pulaski University of Engineering in Radom.

This incident clearly demonstrates the international power of the Jewish nation and its determination to find and destroy all who oppose its strength in their own countries. The Jewish problem is worldwide. We Americans are not alone in our struggle against Jewry, and the Jews will be finally defeated only when all of the White nationalist forces around the globe unite in this life and death struggle.

The Solidarity government is filled with Jews and this may or may not change under Lech Walesa, but it put Prof. Trzeciak in the unfortunate position of having to appeal his case to a Jewish Minister of Education. Nevertheless, the brave professor pulled no punches. What follows is his letter of appeal:

Prof. Henryk Samsonowicz Minister of Education

Dear Mr. Minister:

The meeting of Kurt Waldheim with Pope Paul II was conceptualized by the world media as a victory for anti-Semitism. As noted by Cardinal Glemp, the global media was and has remained in the hands of the Jews. We can remember how all this touched Poland as indicated by the coverage of [Solidarity's] the **Election Gazette**, directed by the Jew Adam Michnik. It is difficult to speak objectively about such national affairs and especially about the chauvinism of certain Jews who have conditioned society for years with Zionistic lies.

Consequently, in light of this dishonesty, I wrote a few lines to the Austrian publication **Sieg**. Such defended the dignity of Kurt Waldheim and supported his fight - and mine - against world Zionism.

Unfortunately, my letter caused a furor in Jewish-Zionist society and has resulted in my persecution, which is contrary to the principles of pluralistic democracy.

All this began as a result of the efforts of the **Election Gazette**, which directed its lies at me. It was indicated that I support a certain aspect of democratic nationalism and thus also anti-Semitism, despite the fact that I, with all my heart, support Semites, above all the Palestinians who are now fighting Zionism. So the governing body of engineering's higher education in Radom organized a vile campaign of lies against me.

This hate has impregnated my institute of higher learning as for several months material and information was distributed against me. It came mostly from the information conglomerate of Solidarity. From Taduesz Mazowiecki's regime flowed material with all kinds of impli-

The Calculus of War

Now that the Gulf War has begun, we wish to put the news from the conflict into some perspective. After the first day of battle the U.S. high command reported that their bombing was incredibly accurate, that 80% of their targets were successfully hit and that their targets included the Iraqi air force, missile air defense system, and command and communication network as well as chemical and nuclear sites. This left the impression that 80% of these things were destroyed and that our losses were virtually nil. Neither the U.S. military (which should have known better) nor the media could contain its elation, despite its statements to the contrary, and so the Senate unanimously endorsed Bush's war and the stock market rose precipitously.

The euphoria was quickly dissipated first by a missile attack on Israel from Scud missile sites that had supposedly been eliminated, then by rising air losses as the Iraqis adjusted to U.S. tactics and technocations, even pertaining to the presidential elections in this country.

Especially important in this regard, however, was the writing by you, Mr. Minister, which resulted in my being removed from my position as Director of the Institute of Social Sciences, and also as Director of the Department of Philosophy and Sociology. This has deprived me of a substantial sum of money and has caused my family hardship. There is a real possibility of my losing my job because of the **Election Gazette**.

Also connected with this affair is the rejection by the Ministry of Education of a trip abroad and scientific grants. At the same time my family was refused assistance, and I was denied my human rights and freedom particularly in regard to the expression of political views.



logy, then by artillery barrages upon our Marines who are out in the open on the Arabian desert, and then by more realistic damage assessments.

It turns out that the bulk of the Iraqi air force was not destroyed because it is hidden along highways or is in hardened underground bunkers. Indeed, the military admitted by the third day that it could only Sonfirm eight Iraqi planes destroyed in the air and three on the ground. Moreover, the Iraqi command and control network is apparently still in operating order. Worse, it turns out that the Iragis have hundreds more Scuds than previously believed including twice as many mobile launchers than pre-war intelligence had established.

A Soviet defector named Sakharov explained on television that the reason there had been so little effort made by the Iraqi air force is because the Soviets had taught them that it would be suicide to contend with a superior air armada, and that they should wait in their holes for a window of opportunity. Attempts to silence Iraqi long range artillery from the air have also failed thus far. It will not be long before the utter nonsense about In World War II the Western Allies exaggerated German losses by 10:1. In Vietnam the U.S. falsified its public friendly air loss statements by



winning a war soley from the air will no longer be heard from our socalled military experts, and then we will begin the real war - the ground assault.

In regard to losses, it should be remembered that all countries lie in wartime about their losses and that this, plus the fog of war, makes it impossible to accurately establish casualty levels. The U.S. and Britain tend to be two of the worst when it comes to exaggerating enemy losses. 1:2. In other words, if the U.S. claims 10 Allied planes lost, count 20, and if it claims 100 enemy aircraft destroyed, your guess is as good as ours, but we would not count more than 50 at the most. Further, you must add in at least 15% losses for crashes and accidents and another 5% for planes so damaged that they cannot be repaired. In sum, be wary of official statements and estimates as "truth is the first casualty in war."

NDF at the Movies

Dances with Wolves is certainly one of the most spectacular films of 1990. This is actor Kevin Costner's debut as a director, and audiences and critics alike agree that it is an outstanding effort. Yet for White nationalists this is a troubling film, for the messages it sends out are racially ambiguous: there is much here that is admirable, much that is objectionable, and much that is thought-provoking.

An officer in the Union army (Costner), sick of soul from the horrors of the Civil War, requests a post on the frontier. He is sent to an abandoned fort and lives alone there for some time, allowing the solitude and beauty of the prairie to heal his spirit. Before long he makes acquaintance with a nearby tribe of Souix Indians. He becomes increasingly involved in their lives, and they in his, until at length he no longer identifies himself as either a member of the U.S. Army or of the White race.

On the surface, this movie follows the current Hollywood trend of portraying White people (and especially White males) as moral lepers, while casting non-Whites in the most favorable light. Except for the hero, the Whites in **Dances with Wolves** are generally depicted as cruel, vulgar, stupid, insensitive, and lacking any appreciation for the natural order. Indians, on the other hand, are the quintessential noble savages: they are handsome, courageous, intelligent, non-violent (unless attacked), and live in a state of deep and reverent harmony with Nature.

If most Whites are repulsive monsters, is it any wonder that a rare, decent White person -- like the protagonist -- would rather be an Indian? Yet beneath this odious anti-White veneer, the film has several good points to make. The first of these is that a life lived in simple harmony with the natural order has a spiritual dimension that contemporary White society sorely lacks. The slower pace of Indian life contrasts favorably to the frenetic rhythms of urban living. And only someone whose soul is completely dead could deny that their is a stately grandeur in undefiled nature that far outweighs the superficial conveniences of contemporary consumer society, with its accompanying environmental destruction.

More importantly, **Dances with Wolves** has something to say about the fundamental importance of the feelings of identity and belonging. The hero in this movie "goes native" (as another character sneeringly informs him) by assuming an Indian identity. He leaves the cold, impersonal, anonymous White society, epitomized by the Army, in favor of a small, warm, closely-knit group with whom he feels a personal bond. As a member of the tribe he obtains



a sense of personal worth and identity which he could not find in either the Army or in White society in general.

White Nationalists might feel offended that he finds an antidote to his alienation by denying his racial heritage. Unfortunately, there are many White people -- especially teenagers -- who do in real life what this character does only on film. Alienation is a very real problem in contemporary society, and if healthy solutions are not readily available, we should not be surprised if many of our folk turn to those which are unhealthy.

White people have been deliberately stripped of any meaningful sense of personal or group identity. All genuine, organic forms of identity -- racial, ethnic, and cultural -are consistently denied them. The resulting atomization leaves a gaping void in their sense of self.

Providing a viable alternative to the soullessness and rootlessness of contemporary society should be a prime goal of the racialist movment as we head into the next century. The racialist groups which are most successful are those which are not just "organizations" -- stiff, lifeless collections of like-minded individuals -- but rather those which are more like tribes (or families) of White people who have the same values and who share their lives as they struggle for common goals.

Most surprisingly, Dances with Wolves displays a healthy attitude towards race-mixing. It would have been entirely plausible for the hero to marry an Indian woman after joining the tribe. Instead, he marries a White women who has lived with the Souix since they rescued her in childhood. The medicine man's wife tells her husband that the other members of the tribe approve of the match "because it makes sense. They are both White." At the end of the film, the two deracinated White "Indians" ride off to pursue a life apart from their adopted people.

It is to be hoped that White film-goers will see through the offensive racial stereotypes of **Dances with Wolves** and grasp its positive attitudes toward nature and miscegenation. If, additionally, the racialist movement is stimulated to thought and debate concerning the power and appeal of tribal identity to White people in today's fragmented society, this film will indeed have accomplished much. **MMc**

It Speaks for Itself

"The Arlington School Board [in VA] approved continued funding last night for programs designed to improve the performance of black students, although the programs, in effect four years, have not produced improvements in standardized test scores. The board's approval of \$71,023 was unanimous. . . The gap between test scores for black and white students, and the continued decline in black scores have frustrated Arlington parents and officials. 'This is nothing new,' said Robert MacGregor, director of the Arlington County NAACP. 'For the past decade blacks have been 20 points behind white students, and [they] are falling further behind.'... On the Iowa Test of Basic Skills, which tests all subject areas including math, science, social studies and reading, blacks at all grade levels scored below average in every category." -- Washington Post, October 3, 1990.

Land of the Free, Part I: The Police State

Multiple Choice Question: What country has the greatest percentage of its population in prison?

(A) Israel (B) The Soviet Union (C) Iraq (D) South Africa

Answer: (E) None of the Above According to figures recently released by the non-profit Washington Sentencing Project, the United States currently has the highest incarceration rate in the world.

Of every 100,000 Americans, 436 are presently incarcerated. Other countries: South Africa, 333; the Soviet Union 268; Great Britain, 97; Spain, 76: Italy, 60; the Netherlands, 40. The level of imprisonment for Black males, who commit the greatest percentage of violent crime in the U.S., is dramatically higher. In the United States, 3,109 out of every 100,000 adult Black males are incarcerated.

One out of every four adult Black males is currently behind bars, on probation, or on parole. South Africa, whose racist policies are sanctimoniously condemned by the U.S. government, has a rate of incarceration for Black males of 729 per 100,000 -- about one-quarter that of the United States.

Land of the Free, Part II: Artistic Censorship

It may be acceptable for American artists to publically desecrate the flag or display homosexual S&M photographs in museums, but there is one thing they absolutely must not do: offend the Jews. The Simon Wiesenthal Center in Los Angeles, a Jewish institution dedicated to preserving and advancing World War II "Holocaust" mythology, announced in January that it was demanding that Warner Brothers recall the latest album released by rock star Madonna, "Justify My Love." The reason? One track on the CD includes a single line from the Bible which the Jews denounce as "dangerous and an insult."

The line in question is from the Book of Revelations: "And the slander of those who say they are Jews, but they are not, they are of the synagogue of Satan." The verse is cited by Identity Christians as a key justification for their contention that the Jews of today are not the same people as the Israelites of the Biblical era. Although a spokesman for Madonna denied any anti-Jewish intent, the Jews remained unmoved.

Said Rabbi Abraham Cooper, "The notion that an icon of American pop culture should, for whatever reason, zero in on the most anti-Semitic quote in the Bible, is totally unacceptable." Perhaps the Simon Wiesenthal Center should issue a list stating what parts of the Bible used by the Christians are "acceptable" to the Jews and what parts are not, so that such anti-Semitic incidents may be prevented in the future.

Doctors of Greed

Two new studies underline the corruption of the present American medical profession and answer the question of how much the ability to pay affects medical treatment. Jack Hadley, co-director of the Center for Health Policy Studies at Georgetown University School of Medicine, published an article in the Journal of the American Medical Association which stated that hospital patients who lack medical insurance die up to triple the rate of similar patients with health insurance. The study was based on examination of over 600,000 patient records.

Another study found that doctors who have purchased X-ray equipment for their offices recommend X-rays four times as much as doctors who refer out for X-rays. Along with these factors Medicaid, Medicare and insurance fraud have all skyrocketed. U.S. doctors are men of extraordinary wealth and now we are beginning to understand why this is.



Dear Gary:

I am heartened by the way in which the racialist movement has unanimously opposed the Jewish-Capitalist war against Iraq. Everyone -- from the authentic revolutionaries in the NDF to the reactionary racists in some Klan groups, and from Identity skins to Creativity atheists -recognizes that this war is not in the best interests of our Race. If only the racialist movement had been so clear-sighted at the beginning of the Vietnam war, instead of stupidly parrotting the right-wing, pro-war line!

At the same time, however, I think a word of warning should be sounded against those in the movement who see Saddam Hussein as an ally of the White race. Although we may share enemies with him (such as the anti-White U.S. government, the Jewish-controlled news media, and the Jews in general), he is not fundamentally a friend of ours.

The Caucasian race consists of two main families: the Indo-Europeans and the Semites. (There are also other smaller groups such as the Armenids and the Hamites, but they are unimportant at this juncture in history and do not enter into this discussion.) The original homeland of the Indo-Europeans -- also known as the Aryans -- is a matter of controversy, but in historical times they have dwelt in Europe, and they are the creators of all the civilization which comes from this continent.

The Semites originated in the Arabian peninsula, and later spread to North Africa and the Levant. If we take a macro-view of racial history, we see that the Indo-Euro-

peans and the Semites have always been enemies. One segment of our Race after another has found itself locked in a death struggle with this or that Semitic people. The Roman republic fought three long and bloody wars against the Semitic Carthaginians. The Crusaders contended against the Arabs. In this century, it was the German people under the National Socialists who first freed themselves from the Semitic parasitism of the Jews.

Today the Semites are at war with each other in the Middle East: The Jewish Semites fight to supress the nationalism of the Palestinian Semites; the Iraqi Semites seek to dominate the Kuwaiti Semites; the poor Semites seek to overthrow the wealthy, corrupt Semite governments. Previously, the nations of Europe (and the colonies they planted throughout the world) fought war after fratricidal war with one another -- to our own detriment as a race and to the benefit of our racial adversaries. It is inappropriate for us to shed crocodile tears today if our enemies seek to rend each other apart.

White Nationalists, of course, favor national independence and social justice for all peoples of goodwill, whatever their race. But we must not lose sight of the fact that the Semites are racially distinct from us, nor that their values and way of life are in basic opposition to ours. We share enemies with Saddam Hussein, and consequently we share a certain unity with him -- but he is not our friend, and certainly not our savior. If he has done no harm to our Race, it is only because he has not had the opportunity.

As White revolutionaries, our most fervent hope must be that the Gulf war results in massive dissatisfaction and anger against the U.S. government on the part of the White people of America, and that the System's international power, prestige and credibility are significantly weakened. In the long run these are the results which matter to our Race, not whether or not Saddam Hussein stays in power.

I found your article "National Democracy vs. New Monarchy" very interesting. However, your comparison of the Roman and National Socialist forms of government was flawed.

By the first century AD the original founders of the Roman republic were becoming extinct as a race. A large percentage of the slaves you spoke about were non-Whites. Many of these eventually became Roman citizens with all the rights that entailed. With such a population social decay and dissolution was inevitable, as is so obvious in our own era.... The Germans were a homogenous nation and, perhaps, the most civilized people in Europe. There were no non-Whites in Germany who would later pollute the gene pool. THE AMERICAN WAY OF LIFE?

As this issue of **The Nationalist** goes to press, the United States stands poised on the brink of war. The government has promised us a quick and bloodless war -- but no one really knows what will happen once the fighting starts. An attack on Iraq is the opening of a door into the future. No one knows what lies on the other side of this door, but once George Bush opens it for us, we will have to accept whatever we find. It might be that what is on the other side is a quick, relatively bloodless war. Or it might be a hellish nightmare: poison gas and germ warfare, "allies" who betray us when the fight starts, endless rows of body bags, young soldiers (men and women)



with their arms and legs amputated, terrorist attacks against civilian targets here in the U.S., "hysteria, trench confessions, laughter out of dead bellies," the draft, a long and bloody land war.

Before we risk this, we should be clear on why we are fighting. At the heart of Bush's evasive, wishy-washy non-answers to this question is the idea that we are going to war to defend "the American Way of Life." Well, just what, in 1991, does this consist of? (Don't read further if you have a weak stomach, because it isn't what you might like it to be.)

"The American Way of Life" now includes the right of White people to commit racial suicide by marrying outside their race. It includes Jewish domination of the news media, large sectors of the economy and the Congress. It includes brainwashing White schoolchildren into hating their Race. It includes pollution, planned obsolesence of automobiles, and a life in which you are never free of debt. It includes families in which both parents must work to make ends meet, so that children end up being raised by surrogates and not their mothers. It includes alcoholism and drug abuse. It includes suicide as the number-two killer of White teens. It includes cities that have become unliveable hellholes because all the Whites have been driven out. It includes a government headed by mediocre politicians like George Bush, who would do and say anything to further their careers. This is what the "American Way of Life" has become.

It is not worth the cost of a long, bloody war to defend, nor even the cost of a short, bloodless war -- nor even the cost of one drop of blood from

one single White person. The American Dream has become a nightmare. Wake up, while you still can!
