OPPENHEIMER'S RED RECORD TOLD

Jewish Center In Miami Exposed As Communist Front

MIAMI—Another Jewish Cultural Center, the third in eleven months, has been exposed as a Communist propaganda center. The latest case came to light in Florida on April 16th when it was announced that U.S. immigration authorities were bringing deportation proceedings against two officials of Miami's "Jewish Cultural Center", situated at 429 Lenox Ave. An expose, carried on page one of the MIAMI DAILY NEWS, revealed the Center's \$50,000 auditorium and other facilities were utilized strictly for the propagation of Communist ideology among Miami's Jews.

"Evidence was obtained", said the MIAMI DAILY NEWS, "showing the Center was hawking Communist Party prints aimed to agitate along minority lines according to plans of Soviet Communism to overthrow the government of the United States. The Jewish Cultural Center, from organization to operation, fills the bill of particulars in the Communist front pattern as described by FBI director J. Edgar Hoover and other authorities."

DETROIT

This is but the latest of a series of cases wherein Jewish Cultural Centers have been exposed as hotbeds of Communist activity. On February 11th, for instance, the DETROIT TIMES reported that Detroit's Communists were for the first time in many years without a meeting place following the sale by the "Jewish Cultural Association" of the three story red-brick building where the Communist meetings were normally held.

PITTSBURGH

And last July 22nd a raid on the "Jewish Cultural Center" in Pittsburgh, Pa. revealed it to be a Communist training school for western Pennsylvania. A front page story in the PITTSBURGH SUN-TELEGRAPH on that date brought out the fact that the Pittsburgh "Jewish Cultural Cen-

HATE PEDDLING PAPER FLINGS BIG LIE AGAIN

'Nationalist,' Notorious Bigot Mouthpiece, Fabricates 'Facts' To Disparage Patriotism Of American Jews

It is our policy not to engage in controversies with professional anti-Semites or any other kind of hate mongers. The peddlers of hate are either crackpots or else they have discovered that there's big business in bigotry. In either case, they are allergic to the truth. They live on the Big Lie, perfected by the late lamented Adolf (Hitler) Shikelgruber. But sometimes we take the trouble to reply to the slanders and falsehoods of the hucksters of racial and religious hatred, because our aim is to bring the truth to their followers, many of whom are misguided, misled, innocent dues-paying dupes. It is our hope that some of these ill-informed befuddled victims of evil falsehood may see the light.

That explains why we are now taking note of an article in the Oct. 25 issue of "The American Nationalist," one of the most vicious dispensers of un-American ideology in the U.S. The latest attempt of this mouthpiece for bigots to twist an "American Hebrew" story in such a way as to make it appear that American Jews are unpatriotic takes the prize for sheer brazenness and effrontery.

On Nov. 20th of last year the "American Hebrew" launched a vicious smear attack against the AMERICAN NATIONALIST because of a story we carried regarding the strange absence of Jews among the war

prisoners repatriated in "Operation Big Switch". The "American Hebrew" charged, among other things, that we had "fabricated" our facts. The truth of the case is set forth below.

Jews Attack American Nationalist For Exposing Their Role In Korea

SPECIAL—Last October 25th the AMERICAN NATIONALIST carried a front page story which sent New York's AMERICAN HEBREW into a veritable fit of hysteria. Our story concerned the Jewish role in the Korean War, and we remarked upon the strange absence of Jewish war prisoners among those returned in "Operation Big Switch". Basing our story in part upon statements published in the Sept. 25th issue of the AMERICAN HEBREW, we pointed out that only nine Jews were to be found among the 3597 U.S. war prisoners in Korea. This, we submitted, was a ridiculously low figure, since in ratio to their population at least twelve times that many Jews should have been repre-

Need For Bricker Amendment Grows As U.S. Endorses Genocide Treaty

SPECIAL—Indignation is rising over the signing of the "Genocide Treaty" by the U.S. delegate to the U.N., Archibald Carey. Readers of the AMERICAN NATIONALIST will recall our story of last Oct. 25th in which we told of how Carey, a mulatto Negro, had cast the U.S. vote in favor of the Genocide Treaty after Secretary Dulles had assured the U.S. Senate our delegate would oppose the measure. Although the pact has no legal effect in the U.S. until ratified by the Senate, it points up the necessity of an early adoption of the Bricker Amendment, which is specifically designed to protect us against such eventualities. . .

NOTE: The Bricker Amendment is scheduled to come before the Senate again before Congress adjourns. It is imperative that all sincere patriots write their Senators urging the enactment of this measure.

Sabotaged H-Bomb Program As Chief Of U.S. Atom Labs

SPECIAL—No military secret in American history has been more vital to the safety and welfare of the United States than the A-bomb, and no secret was ever so poorly kept. Despite the almost fantastic safeguards thrown around our atomic energy program, it is a proven fact that the Soviets obtained our atomic secrets almost the instant they were discovered. How did they manage this almost superhuman feat? How, in the presence of the most elaborate safety precautions ever imposed on the North American continent, did the Communists manage to reach into the innermost confines of America's atomic laboratories? How were they able to penetrate our security barriers as though they didn't exist?

REDS IN CHARGE

The answer is as simple as it is tragic. The Communists were able to ferret out our topmost atomic secrets because one of their collaborators—the Jew, Robt. Oppenheimer — was placed in charge of the Los Alamos laboratories where the A-bomb was first built. It was he who supervised the A-bomb project from its inception until the first bomb was exploded over Hiroshima in 1945.

TREASON ASSURED

The really startling part of the situation is not that the Communists were able to obtain our atomic secrets—since under the circumstances their success was virtually assured—but rather that the U.S. government should have deliberately and knowingly placed a red with Oppenheimer's record in such a position of trust in the first place. Because the unbelievable part of the story is this: Oppenheimer's Communist record was known at the time he was placed in charge of the Los Alamos installation in 1943, and it is no exaggeration to say that his record at that time was one of the reddest of any official ever employed by the U.S. government. And it should be remembered that

he was allowed to retain a key position in our secret atomic laboratories for eleven years, during which time his Communist-aiding activities continued without interruption. It was not until December of 1953 that Oppenheimer was secretly removed (as a "security risk") as head of the vital "Institute for Advanced Studies"—the very heart center for research on both the A-bomb and the hydrogen bomb.

Since December of 1953 Oppenheimer's case has been under investigation by the Atomic Energy Commission to determine what his future status will be. Concurrently, Oppenheimer and his Jewish cohorts have loudly proclaimed his "innocence", claiming that he is not, and has never been, a card carrying member of the Communist Party. As a matter of fact Oppenheimer's entire defense rests on this thin technicality, because his record is clearly that of a Communist, regardless of whether it can be proved he was, or was not, issued a Party membership card. Here are some of the items which make up Oppenheimer's Communist record:



ROBT. OPPENHEIMER

ITEM: Oppenheimer's wife, Katherine Puening, was a card carrying Communist when he married her.

ITEM: Oppenheimer was introduced to his wife by the notorious, Moscow-trained "Steve Nelson", formerly a top Communist organizer on the west coast, and now in prison for plotting the overthrow of the U.S. government.

ITEM: Oppenheimer's wife was formerly married to a Communist Party official who was killed fighting for the Communists in Spain.

ITEM: Before marrying his present wife, Oppenheimer was engaged to a woman whom he knew to be a card-carrying Communist.

ITEM: Robt. Oppenheimer's brother, Frank, was a Communist Party member previous to his employment at Los Alamos.

ITEM: Brother Frank Oppenheimer's wife, Jackie, was (and may still be) a card-carrying Communist.

ITEM: Oppenheimer has not only belonged to numerous Communist front organizations (such as the "Independent Citizens Committee of the Arts, Science, and Professions" in 1946) but has admitted paying known agents of the Communist Party \$150 monthly out of his earnings up to April of 1942, at which time he began work on the A-bomb.

ITEM: Before, during and after his tenure as head of the Los Alamos project, Oppenheimer continually associated with known Communists, who visited his home and otherwise fraternized with him. These included Wm. Schneiderman, G. R. Lomanitz, David Bohm, Max Friedman and David Weinberg—all known Communists.

ITEM: Oppenheimer was fanatically opposed to the construction of the H-bomb after the war and was one of those instrumental in holding up its production. He did this with the full knowledge that if the Russians developed the H-bomb first, we would be helpless before them.

ITEM: Oppenheimer made persistent attempts to hamstring our long-range bomber program and thereby destroy the Air Force's ability to deliver A-bombs to their target. Had he succeeded, our capacity to meet a Russian atom attack would have been almost non-existent. . .

This, in capsule form, is a summary of Oppenheimer's Communist-aiding background. It is in face of this record that his present denial of Party membership must be judged.

But in order to truly grasp the magnitude of the master plan of Jewish treason of which he was an integral part, it is necessary to briefly review the entire history of our atomic program from its beginning in 1942 to the present.

BACKGROUND

The history of our atomic program and of the treason which accompanied it logically fall into four stages.

STAGE I: MANHATTAN PROJECT

During the war years the U.S. atomic program, designated by the code name, "Manhattan Project", was under the overall supervision of the Army's General Leslie Groves. The actual task of developing the A-bomb (as noted) was carried out at Los Alamos under the direction of Robt. Oppenheimer.

The A-bomb, be it remembered, was originally conceived as a weapon against Germany, whom our Jewish scientists—including Oppenheimer—hated with an almost pathological intensity. The emphasis, therefore, was on completion of the bomb at the earliest possible date. This fervid Jewish enthusiasm lasted up until the capitulation of Germany, by which time the A-bomb was virtually completed.

STAGE II: SABOTAGE OF THE H-BOMB

With the end of World War II, Jewish enthusiasm for the A-bomb waned rapidly. The only possible target for an A-bomb was now Soviet Russia, whom our Jewish atomic scientists favored almost to a man. Hereafter it became the goal of Oppenheimer, Einstein and other highly placed Jews to impede progress on atomic weapon development as much as possible, with special attention given to the prevention of H-bomb production.

The first step in this direction took form in agitation to remove the atom program from the supervision of the Army and place it under civilian control. This was done in 1946 and a five-man board, consisting of three Jews and two Gentiles, was placed at the head of the newly created Atomic Energy Commission (AEC). Chairman of the five man board was David Lilienthal, a Jew with two known Com-

munist front affiliations. Thus, America's mightiest military weapon was taken from the Armed Forces and turned over to a band of Jewish revolutionaries, who now proceeded to sabotage our atomic defenses by holding up production on the hydrogen bomb, then already under way.

Throughout Lilienthal's chairmanship of the AEC the Jewish aim remained centered on the primary object of blocking the H-bomb. As early as 1945 preliminary work had begun on hydrogen bomb experiments, but when Lilienthal and his Jewish board took over the work was stopped, and remained at a standstill, until Lilienthal was forced to resign in Feb. of 1950. In the meantime Russia was engaged in an all-out effort to perfect the H-bomb first. . .

RUSSIANS EXPLODE FIRST A-BOMB

Some of the fruits of the Lilienthal-Oppenheimer-Einstein program of planned sabotage became apparent to the nation on Sept. 23rd of 1949 when Harry Truman announced to a shocked world that the Russians had exploded their first atom bomb—3 years ahead of schedule.

But the beginning of the end came for Lilienthal on Feb. 3rd, 1950 when British authorities announced the arrest of Klaus Fuchs as an atom spy. Fuchs gave information which subsequently broke the famous Rosenberg spy case. But even more important than that, Fuchs revealed that the Communists had obtained American H-bomb secrets. The Fuchs case signaled a revolutionary change in America's atomic program.

STAGE IV: THE H-BOMB RACE

The hydrogen bomb race got under way with a series of events which are best understood if presented in chronological order, as follows:



THE ROSENBERGS

ON JANUARY 31, 1950, Harry Truman, obviously acting with advance knowledge that the Fuchs case was about to break, hastily announced the U.S. definitely would resume work on the H-bomb.

FEBRUARY 3, 1950: Seventy-two hours later the Fuchs case broke into headlines following months of investigation by a combined team of FBI and British Intelligence agents. J. Edgar Hoover indicated other arrests in the U.S. would follow.

FEBRUARY 5, 1950: General Leslie Groves, wartime head of the Manhattan Project, told a Joint Congressional Committee that Fuchs almost certainly passed vital H-bomb secrets to Russia.

FEBRUARY 12, 1950: With bald-faced arrogance the three highest officials in the Atomic Energy Commission, all Jews, appeared on Eleanor Roosevelt's TV program to voice opposition to the building of the H-bomb. They were (1) David Lilienthal, chairman of the AEC, (2) Robt. Oppenheimer, director of the vital "Institute for Advanced Studies", (3) Albert Einstein, staff member of the Institute and one of its moving spirits. (The Institute for Advanced Studies, honeycombed with Jews, is, as previously noted, the nerve center for original atomic and H-bomb research.) It should be noted that this last feverish Jewish attempt to sabotage the hydrogen bomb occurred TWO WEEKS AFTER Truman had announced that work would proceed with all haste on the H-bomb—an important point to remember because Oppenheimer now denies he opposed the H-bomb after Truman ordered production to actually begin.

FEBRUARY 15, 1950: Three days after the above-mentioned broadcast Harry Truman announced the resignation of David Lilienthal. Gordon Dean, a Gentile, was appointed head of the AEC and the deadly H-bomb race was under way. On its outcome rested the fate of this nation, because whichever country perfected it first would be in a position to issue an ultimatum of surrender to the other. . .

THE ATOM-SPY TRIALS

The Fuchs case not only spurred the U.S. into a belated effort to overtake the Communists in the H-bomb race, but it also broke America's most infamous spy case, the Rosenberg ring. Acting on information given by Fuchs, the FBI rounded up nine spy suspects, all of whom were subsequently convicted. Significantly, eight of the nine were Jews. . .

Teen-Age Dope Linked to Race Mixing

Interracial Schools Spread Dope and Vice

SPECIAL—The question of whether or not American school children will be compelled to attend interracial schools will be decided some time this year when the Supreme Court renders its decision on school segregation. To the nation's parents, already plagued by a sky-rocketing juvenile delinquency rate, the question is of vital import because whether they know it or not the interracial school has probably done more to spread the more vicious forms of crime among our youth than any other single factor.

DEGENERATION

Proof that interracial schools have already had a profound and degenerative effect upon the moral fibre of our youth is not hard to find. There was a time, for instance, when parents reared their children in the righteous hope they would take up neither smoking nor drinking. But nowadays (in many parts of the country at least) parents are fervently and even desperately hoping that smoking and drinking will be the ONLY vices their offspring acquire. . .

DOPE ADDICTION

The thing many parents are learning to fear more than anything else is dope addiction, which is sweeping through some school districts like wildfire. In certain cosmopolitan areas—and most especially in sections with large colored populations—the narcotics traffic, with its handmaidens of thievery and prostitution, has become the number one police problem among juveniles.

INTERRACIAL SCHOOLS

There is no question but that white teen-age students are being introduced to the dope habit through their association with Negro and other non-white students in racially integrated schools. The prevalence of the dope habit among Negroes is clearly indicated in the FBI "Uniform Crime Report" for 1949, which shows that in ratio to their population, Negroes are convicted of narcotic violations six times more frequently than are whites. That's another way of saying that, on a population basis, the use of narcotics is only 1/6th as prevalent among whites as among Negroes.

As would be expected, the starry-eyed advocates of racial mongrelization attempt to offset these facts—or at least obscure them—by arguing that the teen-age dope problem affects all races, and that the drug habit is being taken up by youths from the best and wealthiest families. Hence, they argue, the situation cannot be blamed on any particular racial group but must be regarded as a universal problem affecting all races, colors, creeds, etc. etc. . .

Habit Cuts Across General Population

From the sociological standpoint, the report also noted that Los Angeles County was unusual in another respect—in other states, new addiction is "found to be 85 per cent colored." In California it cuts across the population generally. . . In other words, there is no class, race, or creed problem among addicts, particularly new addicts, are cropping up in every segment of the population, in the same proportion as those segments occupy in the total population.

Those who champion non-segregated schools should be interested in a story which appeared in the April 19th issue of the LOS ANGELES EXAMINER (above). According to the story, a "Citizen's Advisory Committee" investigating dope addiction among California teen-agers has come up with the startling proposal that the state set up "low cost narcotic stations where incurable but harmless dope addicts can get the 'shots' their bodies demand, without turning to criminal sources".

BLACK BELT INFLUENCE

All of this is true up to a point, but it is necessary to go a step further to understand why it is true. Actually, the whole problem, as it affects our white youth, can be reduced to terms of cause and effect. It is fairly obvious, for example, that if refined and intelligent white children of tender age are thrown into interracial schools where they must associate daily with the scum of the black belt, they cannot help being affected by the experience. The supposition that white school children, no matter how well trained at home, can come under the daily influence of aggressive, oversized, over-sexed, jazz-crazy Negroes day after day and remain uncontaminated is not only absurd, but contrary to all reason. The fact of the matter is plain and inescapable: if white children from good homes are falling into dope addiction and similar vices it is only because they are daily thrown into an environment where dope addiction and other vices

geles, where all races, classes and creeds are equally affected by the problem. The Committee did not mention the very significant fact, however, that for many years the school children of Los Angeles have been obliged to attend interracial schools, where they come under the daily influence of Negro and other aggressive minority groups.

It is worth noting that although California's teen-age dope problem has its origin in the non-segregated public school system, the "Citizen's Advisory Committee", in typical bleeding-heart fashion, proposes to "solve" the problem not by resort to segregation, but by setting up state operated narcotic stations to satisfy the cravings of those who become addicts! Truly a worthy

common to the black belt are in vogue. To expose our impressionable young people to such an environment is more than foolhardy—it is criminal.

SIGNIFICANCE: The narcotic problem among our youth cannot be dealt with adequately without taking two basic facts into consideration. The first of these is that teen-age dope and vice have been, until quite recently, largely confined to the non-white population groups, and still are for the most part.

Secondly, it should be remembered that Negroes are spreading the dope habit and other criminal practices among white students through intimate contact with them in non-segregated schools. Keep in mind that the school is second only to the home in its influence on the minds and character of our youth. For that reason there is no more justification for a public school to force white children into association with the denizens of the black belt than there would be justification for a parent to invite dope addicts into the child's nursery. The principle is precisely the same,

solution.

Parents concerned over sending their children to non-segregated schools can take comfort in one of the Committee's recommendations, anyway: if their children should by chance acquire the dope habit in school they will be well provided for—at a state operated narcotic station. And California's parents can also rejoice in the fact that their children will grow up without any trace of racial prejudice or bias or other harmful ideologies. They may, it is true, become dope addicts, prostitutes or thieves, but you may rest assured they will be well indoctrinated against all forms of racial "intolerance", since "bigotry" is not tolerated here. . .

and so is the eventual result.

The answer then, clearly calls for the complete segregation of Negroes and whites in our schools. In no other way can we protect our youth against the criminal and demoralizing influence of the black tide which threatens to engulf many of our schools.

In view of this, the forthcoming Supreme Court decision on school segregation becomes a matter of vital interest to millions of U.S. parents. In many areas, at least, it will determine whether parents will be privileged to rear their children in the traditional American manner, or whether they will be compelled by law to intrust their tender offspring to the jungle environment of the non-segregated school. . .

For our part, we prefer the customs of our fore-fathers, who for 330 years have educated their children in white, segregated schools without any noticeable ill effects to those concerned. . .

JEWISH "CULTURE"

Instructions on the use and manufacture of bombs were also a part of the Center's "cultural" activities, according to testimony given before a Senate investigating committee last year. Thus is the pattern revealed. . .

SIGNIFICANCE: The exposure of a single Jewish "cultural center" as a Communist training school would not, in itself, be of any more significance than would a similar exposure involving say, a French or an Italian cultural center. But when three such Jewish "cultural centers" are exposed as Communist headquarters in less than a year, and when this fact is correlated with a mountain of collateral evidence, then the situation definitely does assume significance. The conclusion we draw from these facts is that American Jewry should either alter its "cultural" activities, or else carry them on somewhere else—in Palestine, for example. . .

sented among the repatriates.

"There are a number of possible explanations", we wrote, "as to why only nine Jews were to be found among the 3597 returning G.I.s. One is that Jews almost invariably avoid front line duty by wangling rear echelon jobs in the medical corps, in the quarter master corps and in other similar jobs. This would partly explain the almost total absence of Jewish personnel in Korea, but it is probably not the only explanation. Also to be considered is the well known fact that Jews manage to avoid military service far more frequently than do Gentiles. . ."

Press Report

WASHINGTON—An attempt by the Jew, Rep. Jacob Javits, to have "anti-Semitic" literature banned from the mails has failed. Javits brought the matter before the House Post Office and Civil Service Committee in an effort to have all anti-Jewish literature declared "obscene", and therefore unfit for mailing. Organized Jewry has repeatedly tried to have anti-Jewish material barred from the U.S. mails on one pretense or another, since such a ban would amount to a virtual censorship over the press. . .

NEW YORK—Representatives of the Jewish War Veterans and the American Jewish Congress have established a special "Bronx Committee to Combat McCarthyism and Preserve Civil Liberties", which held its first "community rally" last month. Principal speaker at the rally was Jesse Moss, past national commander of the Jewish War Veterans, who urged his Jewish audience to continue the fight against McCarthyism . . . "until we know it is destroyed".

NEW YORK—The New York HERALD TRIBUNE on April 9th reported the dismissal of 15 school teachers and a school clerk as 5th Amendment Communists. Those discharged were: Irving Adler, Minna Finkelstein, Morris Lipshitz, Leo Auerbach, Benjamin Barnofsky, H. Danielowitz, C. Eckstat, Stella Eliashow, M. Grossman, Esther Hirschfeld, P. Horowitz, M. GREENBELT, MD.—Jewish newspapers from coast to coast are aroused over the pitiful plight of five Jewish residents of Greenbelt, Md., who were recently discharged as "security risks" by the Navy's Hydrographic Office. The Jewish Telegraph Agency (JTA) claims "anti-Semitism" is behind the discharges. "There are", wailed the JTA, "but five members of the Jewish faith who are or were Greenbelt residents and employees of the Navy Hydrographic Office. There are at least eight Gentiles who are both residents of Greenbelt and employees of the Hydrographic Office. All five of the Jews have been charged as security risks. All the Gentiles remain undisturbed. In the absence of a statement of reasons for the government's action it may well be believed that the proceedings which led to that decision were tainted with anti-Semitism" . . . In other words, the five Jews who live in Greenbelt were all found to be loyalty risks and were discharged, while the eight Gentiles were found to be loyal Americans and were retained by the Navy. This, according to Jewish reasoning, is "anti-Semitism" . . . To our way of thinking it constitutes one of the most stinging indictments of Jewish treason we have ever witnessed.

TRUTH IS OUT

Last month (April 9th), almost five months after it headlined the "Big Lie" story, the AMERICAN HEBREW ran another story on the role of the Jew in Korea, entitled: "They Fought For Freedom: A Gallery of Jewish Heroes in Korea". In that article the names of all the Jews known to have been repatriated in "Operation Big Switch" were listed, along with their addresses. There were

ten names, and only ten names, on the list. . .

SIGNIFICANCE: During "Operation Big Switch" the U.S. war prisoners were screened as they returned to American custody and Jewish chaplains (as well as Catholic and Protestant chaplains) were on hand to greet each man. Present at the Inchon Processing Center and Freedom Village respectively were two Jewish chaplains by the name of Norman Goldberg and Murray Rothman. They originally reported to the Bureau of War Records of the National Jewish Welfare Board that nine Jews were among the returnees, and that was the figure reported by the AMERICAN NATIONALIST at the time.

Apparently this list has now been revised to include one additional name—making for a total of ten. . .

This means that the AMERICAN HEBREW'S hysterical allegations against the AMERICAN NATIONALIST were totally without foundation because, despite its rantings, it is still unable to produce the names of more than ten Jewish PWs who were returned in "Operation Big Switch".

Thus, as so often happens in such cases, it was the Jew hurling the "Big Lie" charge who was in fact doing the lying. . .

As for us, we still feel that the shameful absence of Jews in the front lines of Korea is a national disgrace, and we think the Jewish record in Korea should be made known to the American people in its entirety.

The most prominent members of the ring, of course, were Ethel and Julius Rosenberg, who received the death sentence for stealing atomic secrets from Los Alamos. Other members of the ring were Harry Gold, David Greenglass, Abraham Brothman, Morton Sobell, Miriam Moscovitz and Alfred D. Slack (the latter presumed to be Gentile). Also convicted of perjury in the case was Sidney Weinbaum.

MORE TO COME

Thus does the story of Jewish treason unfold. And it is safe to guess that it is a story only partly told, because our atomic laboratories are still infested with large numbers of treacherous, Russian-loving Jews of the Lillenthal-Oppenheimer-Einstein stripe.

NOTE: In this connection, the suspension of Robt. Oppenheimer after 11 years of treason should not be taken as an indication that the AEC will be rid of its Jews. On the contrary, Mr. Eisenhower was very careful to appoint another Jew, L. L. Strauss, as chairman of the AEC (replacing the Gentile, Gordon Dean) before suspending Oppenheimer.

It is significant that Oppenheimer's suspension as a security risk was withheld from the newspapers for three months (until Oppenheimer broke the story himself) in order to "protect his privacy." This would seem to indicate the Jew-ridden AEC is more solicitous of Mr. Oppenheimer's "privacy" than it is of this nation's welfare. . .
