The KKK Grand Dragon of California received 11, 007 votes in a race for the District Board of Supervisors in San Diego, California. Many liberal political analysts were shocked to learn that an open Klan leader won over ten percent of the vote (10.9%). What was even more amazing than the vote percentage was the cost-per-vote tally.

Mr. Metzger spent only \$500.00 after qualifying fees. His opponents spent over \$100,000 - 200 times as much as the Grand Dragon. For every dollar he spent campaigning, he received 22 times the number of votes his opponents received for each dollar they spent. In the Soviet Union during the 1930s Stalin murdered twenty-to-thirty million people, the most grisly exercise in mass murder ever perpetrated. During the height of the killing, the Kremlin conducted massive show trials to give the murders an air of legitimacy.

The U.S. Supreme Court just completed a "show trial" of its own, the Bakke case and decision. Many Americans are aware of the across-the-board discrimination exercised against qualified White people in opportunities of employment, promotions, scholarships and college entrance. The Ku Klux Klan has led the fight against these programs, and the Klan Grand Wizard in hundreds of radio and televison appearances has relentlessly informed White people about their newly acquired second-class citizenship. Last year, the Klan filed an amicus curiae brief in the Bakke case. Bakke is an applicant to the University of California Medical School who was refused admittance in deference to blacks who scored only one-third as well in the entrance testing. Because of the obvious unfairness of the discrimination against Bakke, it became necessary for the liberalminority coalition to throw the White

majority a psychological scrap. Something had to be done to allay majority fears about anti-White discrimination, while still keeping it intact. Hence, a show trial was instigated, American style.

The decision admitted Bakke to medical school, and slightly limited strict quota systems, but it affirmed racial discrimination against White people, assuring the same results as quotas.

The Supreme Court said that strict quotas were passe' except in cases where "past discrimination" can be shown. Past discrimination, as defined by the court, can simply mean a company has a smaller percentage of black empolyees than is represented in the population. Past discrimination can also be defined as failing to hire a few black individuals. Many liberals agree that past discrimination can be legally maintained simply by the fact that many of the ancestors of blacks were once slaves.

The Klan is painted by the mass media as an organization composed of bigoted Southern illiterates, yet, consider these things:


1. Mr. Metzger ran in a high income district.

The Supreme Court threw out the quota system at the University of California Medical School, but praised the affirmative action system at Harvard University.

The court said that it is not only permissible to consider race as a factor in admitting minority students, but it is commendable and should be encouraged. Harvard does not formally set aside a certain number of seats for minorities, it simply sets minority "goals," and then discriminates against better qualified White students until those goals are reached. As a result, the minority percentage at Harvard is the same as at the University of California Medical School.



The boycott has successfully brought about a 25% reduction in their Memphis area plant's production, and Schlitz is quickly becoming as unpopular as the Edsel.

By undertaking this media blitz without compromising their anti-White policies, the Joseph Schlitz Co. has demonstrated their total disregard for the principles and intelligence of the White consumer.

The battlelines have been drawn. We must now make Schlitz submit or face the realization that the rights of White employees can be trampled under, not just by Schlitz, but by every anti-White commercial enterprize, without fear of reprisal.

We must intensify this boycott and be satisfied only when there is a 50 - 60%reduction in Schlitz production. We must make the Joseph Schlitz Co. pay dearly for their anti-White actions. And we must make an example of them, not quitting until they are as fearful of White consumer reprisals as they are of negro consumer reprisals. Only until we bring them to their knees will we rest. HEW wasted and misspent over \$6.2 billion dollars! And that doesn't include the salaries of those 1,144,000 people that are employed by HEW, who, in the opinion of the *Crusader* are considered waste. When a racialist government comes to power we will dispose of HEW and all of it's mismanagement and put those people presently in its employ back to doing honest work, not sponging off the blood, sweat, and tears of the White taxpayer.

Colby Calls Mexico Bigger Threat

Former CIA Director William E. Colby has declared that the greatest threat to the United States is the "have not" nations of the world, such as Mexico, rather than from the Soviet Union.

"The greatest danger of violence and difficulty in the world is between the "haves" and the "have nots" — them against us." Colby said in an interview with the *Times*.

Sambo Gets the Runaround

The executive director of the Connecticut branch of the National Association for the Advancement of Colored People, Ben Andrews, is asking the "Sambo's" restaurant chain to change the name of its restaurants in Connecticut.

Andrews, in a letter to the chain's headquarters in Santa Barbara, California, said that opening a store in Connecticut with that particular name would inflame racial passions.

The Black Rat Race

A White man, Bill Henderson, denied help from so-called charity and Christian organizations, has been forced to keep an all night vigil, armed with a rifle, to protect his family from an infestation of rats.

Henderson said he found it difficult getting aid for his family during their flight from the rodent-infested West side Chicago apartment and believes some groups discriminated against him because he is White.

He said he went to the Gospel League Home for stranded women and families to seek refuge for his wife and three children (aged 1 to 4). "They were all black," he said. "The Gospel League lady saw we were White and tried to close the door on us. She said, "We can't help you!" As a result of being denied help by the Gospel League, the Salvation Army and others, Mr. Henderson was forced to take his family back to the rat infested apartment. There he held a lonely, all-night vigil, armed with a rifle, protecting his wife and children from rats the size of cats. Rats strutted across the room snarled at anything that moved, chewed woodwork and eyed Henderson's children, according to a news reporter who visited them. At last report, the Henderson's were relocated by the Chicago Housing Authority, but not before this injustice was exposed by the Southwest Times Record, June 4, 1978.

qualified Whites have been discriminated against by AT&T in an effort to meet federal guidelines.

The Supreme Court ruled that the anti-White quotas should stand because blacks in general (not the current black applicants) faced discrimination in the past.

Not only will this decision affect thousands of White workers at AT&T, it will affect millions of other White workers. Ultimately, it will also result in higher consumer prices caused by the employment of less qualified and less productive workers.

The black attorney who is head of the Civil Rights Division of the Justice Department said after the Bakke decision, "We should be able to adapt to the new rules without affecting the overall minority affirmative action programs in the slightest." Benjamin Hooks, president of the NAACP and advocate of anti-White discrimination, said that he was going to use the Bakke decision in favor of affirmative action to begin a new push for minorities in the nation's major industries. In one way the Bakke decision was a victory, as it made millions of Americans graphically aware of the anti-White discrimination going on. Inspite of all the foot shuffling of the Supreme Court, White Americans are beginning to learn of their dispossession. The Supreme Court may have done a masterful job of cosmetic surgery, but the same old ugły whore of minority racism

still lurks behind the mask, more hatefilled and powerful than ever before.

The Bakke decision was simply an attempt to take a racially discriminatory, anti-White program called affirmative action, and couch it in terms that camouflage its racist foundation.

The White people of this country aren't going to buy it, and we're not going to forget it. We've just begun to fight!


"Who Runs the Media" is often reprinted ? for the benefit of new readers.

These cartoons accurately depict the controlling party of the most powerful medium in the world: American television.




Many observant Americans have noted

fortunately, such is not the case. Today, more than half the daily newspaper circulation in America is controlled directly, and the remainder indirectly, by Jews, a minority group which makes up only 2.9 per cent of the total population. This extraordinary and dangerous situation has resulted in the press in America becoming for all practical purposes, an instrument of Jewish policy. The use of the press by the Jewish minority to set the policies which affect the lives of all Americans could hardly be better illustrated than by the examples of the nation's two most prestigious and influential newspapers: the New York Times and the Washington Post. The New York Times is the unofficial social, fashion, entertainment, political, and cultural guide of the nation. Its influence and ideas reach into every stratum of American life. It is sold in virtually every community in the United States. It is owned by the Jewish Sulzberger family. A close second to the New York Times in national influence is the Washington Post, which, by establishing its "leaks" in most governmental agencies in Washington, has an inside track on news involving the Federal government. The Washington Post is presently run by Katharine Meyer Graham, Eugene Meyer's daughter, who is the principal stockholder and board chairman of the Washington Post Co., and Larry H. Israel, who is the president and chief operating officer. The Washington Post Co. also owns Newsweek magazine and a number of radio and television broadcasting stations. And the situation is even worse - if that is possible – in the motion-picture industry and other media. Jews, with an uncanny instinct for power, insinuated themselves into every nook and cranny of the communications industries decades before the profound influence of the media on public opinion and the democratic political process was generally recognized. Coordinating their business interests with their political interests, they have not only profited financially from their control of the media but they have used that control like a ring in America's nose to build a power base for themselves which few dare oppose. They can make Congressmen and Presidents and - as Watergate has so clearly shown - break them at their pleasure. This Jewish control of the American mass media is the single most important fact of life, not just in America, but in the whole world today. And there is nothing - famine, inflation, fuel crisis, war - more dangerous to the future of our people.




hidden monopoly control of the mass media. The enormous power of America's mass media to control public opinion is secretly concentrated in the hands of a very small number of people — all members of the same tightly organized minority group with special, group interests differing from those of the American people.

Consider, for example, the TV-news broadcasting industry. This is probably the single most influential mass medium.

Virtually all national and international TV news in the U.S. is filmed, edited and broadcast by just three corporations: American Broadcasting Companies, Inc. (ABC), Columbia Broadcasting System, Inc. (CBS), and National Broadcasting Company (NBC). The last is not an independent corporation, but is a subsidiary of Radio Corporation of America (RCA). The president and chief executive officer of ABC is Leonard Goldenson. The general manager of ABC News is Martin Rubenstein, and under Mr. Rubenstein, as executive producer of ABC's TV-news programs, is Avram Westin.

The top man at CBS is Chairman of the Board William S. Paley. The CBS News subsidiary is run by President Richard S. Salant.

Robert Sarnoff is president, chief executive officer, and chairman of the board of RCA. The president and chief operating officer of NBC itself is Fred Silverman. Under Silverman, as president of NBC News, is Lester Crystal. The major broadcasting corporations employ hundreds of persons in executive positions, but the eight men named above are at the key control points. They are the ones who have the ultimate decisionmaking authority. They dictate what 210 million Americans shall learn of what has happened in the nation and in the world each day. All eight of them - Goldenson, Rubenstein, Westin, Paley, Salant, Sarnoff, Silverman and Crystal - are Jews.

After television, daily newspapers are the most influential mass medium in America. Sixty-two million of them are sold (and, presumably, read) each day.

Those 62,000,000 copies are divided between some 1,700 different publications. One might guess that the sheer number of different newspapers would in itself provide a guarantee against minority control of this important medium. Un-

Gone With the Film

There are obvious parallels between the films Gone with the Wind and D. W. Griffith's The Birth of a Nation (Crusader, No. 30). Both films present the Civil War and Reconstruction era from the viewpoint of White Southerners. Each in its time set a precedent in the scale of its production and magnitude of its boxoffice success.

The two screen epics of the South are also linked by the circumstance that a sharklike minority manipulator, Louis B. Mayer, profited hugely from both. A Russian immigrant and onetime ragpicker, Mayer in 1915 bought the rights to dis-



thought it may be, Gone with the Wind does offer some impressive scenes of Majority elan and these are powerful, albeit implicit affirmations of a racial spirit. And over all, the film is by Hollywood's standards a very good one, its strong points being some fine acting and the superb pace of Margaret Mitchell's narrative.

Ironically enough, a Hollywood project now under way, certain to be an exercise in defaming the White South, is a movie sequel to Gone with the Wind. The 1939 film is the most enduringly popular picture of all time (NBC drew a record audience for its first television showing in late 1976) and Hollywood promoters, from Selznick on, have drooled at the commercial possibilities of a follow-up. While she was alive, Margaret Mitchell refused to write or permit the making of any kind of sequel. For many years following her death in 1949, her brother, serving as literary executor, honored her wishes. But two years ago he made a deal with Hollywood, observing with resignation, "I figured I might as well let them have a go at it." We have been given a foretaste of the new movie's perspective on race by its scriptwriter, one James Goldman, who says: "The blacks in the book and movie would not be acceptable now. Not so much because they would make us angry but for the fact that they were not true portraits." Judging by this, Goldman's mentor on race and Reconstruction is Alex Haley; and we can expect the new movie to be both a travesty of Margaret Mitchell and yet another venomous perversion of our history. How will Majority viewers respond to the latest libel of their race? Some will not respond at all. Others will wallow in feelings of guilt. And those who feel a vague resentment stirring in the blood will decide to think about it tomorrow, for tomorrow is another day.

tribute The Birth of a Nation in New England. By filing understated reports of grosses with Griffith's company and appropriating to himself much of the producers' share of the profits, Mayer was able to amass his first million dollars. He used the money to launch himself as a movie producer and within a decade he was the studio head of Metro-Goldwyn-Mayer and the mightiest of the minority despots who turned American filmmaking into a anti-creative factory system in which Majority geniuses like Griffith could not function. (The Mayer story is told with bite and relish by Bosley Crowther in Hollywood Rajah, a 1960 biography that depicts its subject as predatory and infantile. The character of an equally primitive mongul, Harry Cohn of Columbia Pictures, was summed up by writer Bob Thomas in the punning title of 1967 biography, King Cohn.)

Mayer had two sons-in-law. He set up one as a partner in a rival film company and conferred an MGM earldom on the other, David O. Selznick, the son of a Jewish immigrant from Kiev whose overextended movie empire had collapsed in the 1920s. The younger Selznick spent a few depression years at Mayer's studio as a \$4,000-a-week executive — the situation inspiring the acid comment, "The son-inlaw also rises." He then began a career as an independent producer and in 1936, on the advice of a Majority female associate, he bought the film rights to the newly published Gone with the Wind, a 1,037page novel by an Atlanta woman, Margaret Mitchell.

with Scarlett a frigid bitch in the bargain. But both are also possessed of some biologically admirable traits, among them the drive, resourcefulness and cunning which enable the two to survive and prosper in an Atlanta devastated by the war and Reconstruction. Margaret Mitchell infuses the pair with such vitality that they have become archetypes in the collective American imagination, largerthan-life figures who make their Southern ambiance real and credible. Reader involvement with the fortunes of Scarlett and Rhett was from the first intense and proprietary, so much so that the projected movie version of Gone with the Wind became a topic of national debate in the late 1930s. The people's choice, in one instance, carried a high price tag for producer Selznick. The overwhelming favorite for the role of Rhett Butler was Clark Gable, an actor under contract to MGM. To get him, Selznick had to deal with Louis B. Mayer. The old mogul - perhaps reasoning that he had done enough already for his son-in-law drove a bargain which can only be described as extortionate. For Gable's services, Selznick had to give MGM a 50% interest in the film. Another imperative was a faithful screen adaptation. "People seem to be simply passionate about the details of the book," Selznick wrote to minorityite Sidney Howard, the first of several writers to work on the screenplay. Outright changes, the producer went on, "may give us some improvements, but there will be five or ten million readers on our heads for them." So Selznick had his writers adhere to Margaret Mitchell's text - except when minority interests were at stake. Then he did not hesitate to order "improvements." He told Howard that references to the Ku Klux Klan should be "cut out entirely" so as to avoid "an unintentional advertisement for intolerant societies in these fascist-ridden times." He had "no desire to produce any anti-Negro film either." "In our picture," he wrote, "I think we have to be awfully careful that the Negroes come out decidedly on the right

side of the ledger." Accordingly, the novel's sequence in which Scarlett is assaulted by a Negro and the Klan stages a bloody reprisal raid becomes in the film an attack by a White man that is avenged off-screen by an *ad hoc* group of Scarlett's friends and relations.

Such changes and omissions make for a film which sympathetically portrays the South's struggle to overcome the blight of Reconstruction while studiously avoiding any reference to the racial clash. This is roughly equivalent to doing a movie tribute to Walter Reed's conquest of yellow fever without once identifying the *Aedes aegypti* mosquito as the transmitter of the virus. Yet color-blind

Within six months the book sold a million copies. Most of its readers, then and now, have found it a totally engrossing experience. Literary purists deem the book, fairly enough, a middlebrow historical novel of no great profundity that owes some rather conspicuous debts to Vanity Fair. But they have also been quick to acknowledge the remarkable vigor and power of its narrative and char-



acterization.

An early and admiring reader was Thomas Dixon, whose fiction had served as the basis for *The Birth of a Nation*. He sent the author a complimentary letter and she replied with a humorous account of her "dramatization" at age 11 of his book *The Traitor*. Part of Dixon's approval stemmed no doubt from the fact that *Gone with the Wind* echoes many of his views on Reconstruction. For example, in the chapters she devotes to black-White conflict, Margaret Mitchell is in tacit accord with Dixon on the compelling need for White sovereignty.

In her novel the racial theme is a secondary one and, as most of us know, the focus is centered on the relations of the characters Scarlett O'Hara and Rhett Butler. Each is a pragmatic self-seeker,

Why Conservatives Can't Win

Some of my best friends are conservatives. I sincerely like them and I admire them for their genuine virtues: for their sense of propriety and personal integrity in an age of corruption, for their independent spirit and their willingness to stand on their own feet in an increasingly paternalistic society.

Therefore, I hope my conservative friends will forgive me for what I am about to write.

A Tragic Choice

There is not the least doubt in my mind that if I were forced to cast my lot with either American conservatism or with the left - old or new - I would choose conservatism.

Never-Never Land

The conservative's goals may seem reasonable enough — and attainable. The leftist's goals, on the other hand, lie in a never-never land far beyond the horizon of reality. And that is precisely what gives the advantage to the left.

When the conservative makes some minor gain - getting a "constructionist" on the Supreme Court or a Republican in the White House — he is likely to act as if he had just won the whole war. He sees the achievement of his aims just around the corner, he lowers his guard, and he settles back to enjoy the fruits of his imagined victory. But the leftist is never satisfied, regardless of what concessions are made to his side, for his goals always remain as remote as before. The conservative works in fits and spurts. He reacts with alarm to new depredations from the left, but is satisfied if he is able to fall back, regroup his wagons, and establish a new line of defense. The leftist keeps on pushing, probing, advancing, taking a step back now and then, but only to be able to take three steps forward later.

The Constitution no longer exists, except as a scrap of paper in the National Archives. Its relevance became nil when it was no longer able to serve the purpose its authors intended for it.

Fanatics Needed

The left can find plenty of misguided young fanatics willing to set themselves afire or blow up a police station in order to further the cause of "equality" or "peace." But the idea of young men and women assembling bombs in candle-lit cellars to put an end to the progressive income tax or social-security deductions is simply ridiculous.

Until conservatives can offer something more inspiring, not many young Americans will rally to their standard.

Conservatism's two principle failings, lack of a spirit of aggressive activism and lack of any clearly defined ideological basis, go hand in hand. The one cannot be had without the other.

But, fortunately, none of us is faced with such a limited choice. It would be tragic in the great sense, in the Spenglerian sense. We would be making the choice of Spengler's Roman soldier whose bones were found in front of a door in Pompeii - who, during the eruption of Vesuvius, died at his post because they forgot to relieve him. We would be choosing what is right and honorable and in accord with the traditions of our race — and certain to fail.

For conservatives cannot possibly emerge victorious from the life-or-death struggle in which they are presently engaged. Although their opponents on the radical left may not attain their own goals — indeed, cannot attain them, because they are based on an erroneous conception of man and nature — conservatives have proved themselves utterly incapable of preventing the destruction of their own world by those same radical leftists.

Defeat by Halves

If the leftist makes new demands — for example, for the forced racial integration of schools or housing — the conservative will oppose them with a plea to maintain "neighborhood" schools and "freedom of association." When the smoke clears, the leftist will have won perhaps half what he demanded, and the conservative will have lost half what he tried to preserve. But then the conservative will accept the new status quo, as if things had always been that way, and prepare to defend it against fresh attacks from the left with the same ineptitude he displayed in defending the old position. Insuring domestic tranquility and promoting the general welfare are quite different undertakings today than they were 200 years ago. Even such a fundamental portion of the Constitution as its ironclad guarantee of the right to keep and bear arms has proved to be as worthless as the paper it was written on. Nor has the Constitution's explicit ban against legislators who give aid and comfort to our enemies served to prevent the United States Senate from becoming a hotbed of treason.

Free-Enterprise Pitfall

How about rescuing the American freeenterprise system from the evil machination of Big Government?

As a matter of fact, the free-enterprise system was still relatively intact during the period when alien forces subverted our government and took over our country, and it cannot be said that free enterprise slowed them down even one little bit. The people who gained control of our biggest newspapers and our motionpicture industry and our radio and TV networks did so with the aid of free enterprise, rather than in spite of it.

Ultimate Goals

In the words of an outstanding anticommunist leader: "Thé lack of a great, creative idea always signifies a limitation of fighting ability. A firm conviction of the right to use each and any weapon is always bound up with a fanatical belief in the necessity of the victory of a revolutionary new order on this earth.

"A movement which is not fighting for such ultimate goals and ideals will never seize upon the ultimate weapon"... and, needless to say, will never emerge victorious from a struggle with an opponent who is so motivated.

Revolutionary vs. Revolutionary

Though conservatism cannot win against the left, a new revolutionary force, with the spiritual basis that conservatism lacks and advancing with even more boldness and determination than the forces of the left, can win!

Revolutionary Advantage

Conservatives cannot win because the enemy to which they are opposed is a revolutionary enemy — an enemy with revolutionary goals and guided by a revolutionary view of life.

The advantage has always lain — and always will lie — on the side of the countender who is prepared to take the offensive, rather than maintaining a defensive position only. And the elementary natures of the conservative and the revolutionary determine that the one shall always play an essentially defensive role and the other an offensive role.

Besieged vs. Besieger

This defensive-offensive dichotomy does not apply absolutely to tactics, of course, but it does to strategy. The conservative may launch brief counterattacks — he may sally forth from his fortress to harry his revolutionary besieger — but in the long run he is always the besieged and the revolutionary the besieger. The goal of the conservative is to protect what is, or, at the extreme, to restore what recently was. The goal of the revolutionary is to radically transform what is, or to do away with it altogether, so that it can be replaced by something entirely different.

Evil Ideology

This continually shifting position is almost as great a disadvantage to the conservative as is his chronic inability to grasp the initiative. The revolutionary left has an ideology, evil and unnatural though it may be, and from this ideology come the unity and the continuity of purpose which are indispensable prerequisites for victory.

What can conservatives, on the other hand, look to as a fighting credo, an immutable principle for which they are willing to sacrifice all? They have been retreating so rapidly during the last 50 years or so that they have completely lost sight of the earlier ground on which they stood. It has simply receded over the ideological horizon.

More than Economics

These comments should not be considered a condemnation of free enterprise per se, nor a belittling of the importance of economic problems in general; more than one nation has gone to ruin through economic mismanagement. The point is that America's problems today go far deeper than any constitutional or economic mismanagement. The point is that America's problems today go far deeper than any constitutional or economic reforms can hope to cure or even substantially ameliorate.

The youth of America are smart enough to recognize these things for themselves, and, consequently, are not to be blamed for having few tears to shed for the demise of either the Constitution That new revolutionary force is being built now. Its ranks are being filled with disciplined, idealistic young Americans.

A New Order

They are fighting for a new order in American life, based not on the fads and whims of the moment, but on the fundamental values of race and personality values which once led Western man to the mastery of the earth and which can yet regain that mastery for him and lead him on to the conquest of the universe.

They know that the time is long past when conservative rhetoric or conservative votes might have saved the day. They understand that America's salvation must now come from young men and women of revolutionary spirit and outlook who are through talking and voting and instead are working toward the day when our race can fulfill its God-given potential unfettered by aliens.

Raceless Nirvana

Thus, the conservative talks of "restoring the constitution," of halting crime in the streets, of keeping down taxes, of fighting the spread of drugs and pornography, of keeping Big Government in check. And the leftist strives for a utopia in which there shall be no war, no "re-



Why do the White people need an organization to work for their interests?

Every race on this planet has particular values, economic interests, political objectives, and a unique heritage and culture. In America every sizable minority has many organizations unabashedly working for its particular interests.

The American media is happy for blacks to form organizations working for their cultural and economic interests. The National Association for the Advancement of Colored People is lauded even when it advocates massive discrimination against better qualified White people. When the Mexicans in "La Raza" work to preserve and advance their culture and race, the media doesn't even bother to inform Americans that "La Raza" means literally "the race". Jews have more private organizations to preserve their heritage, to guard their racial fabric (to prevent intermarriage), and to advance their political, social, and economic interests than any other people on earth. Through military aggression, Jews have driven millions of non-Jews from their homes in Palestine, refused to grant non-Jews political rights, and refer to themselves as the "chosen people," the elite people of the world. Yet, they get the most positive press in the world. Of course, that's not too hard to understand

when you understand exactly who dominates the press.

The minority racists have so much power today that no White politician can dare challenge them without encountering the triple knockout punches of: one to the stomach (a bare campaign treasury), one to the head (newsmedia crucifixion), and one to the knee caps (an opposing minority block vote).

You are either going to live in a society reflecting the interests, values, and culture of your people, or you will live in one that is alien to what you love.

More importantly, if the aliens continue their skyrocketing birth rates and massive immigration into White countries, and if race-mixing continues to increase while we White people dutifully practice birth control and sterilization, you won't have to worry about your descendants living in an alien world, for your kind of life on the planet will be extinct.


Rhodesians pick up the remains of raped and murdered missionaries. Some of the same missionaries who were killed believed that black rule would bring love and peace.

It should be made clear that the Klan does not endorse genocide, slavery or any God made a mistake?



The KKK has fought for White rights in the courts by filing suits against anti-White discrimination. For instance, an amicus curiae brief (friend of the court brief) was filed by our Movement in the Bakke Case before the Supreme Court.

The KKK has organized heavily in the military and is working effectively against black favoritism and minority abuses of White soldiers. We filed a suit on behalf of White Marines at Camp Pendelton.

The KKK also has filed suits protecting the rights of White activists and White organizations. They have included a winning suit to insure the right of Klansmen to be prison guards in New York state, and a suit that is pending concerning the right of the Klan to rent public facilities for meetings.

The KKK maintains an extensive watch for illegal aliens along the Mexican-American border. Many illegals have been apprehended by the U.S. Border Patrol because of our efforts, and we have increased public awareness of the flood of non-Whites entering our country.

The KKK has picketed, marched, and demonstrated continuously against communist and anti-White groups and programs.

The KKK leadership has appeared on hundreds of TV and radio programs and in thousands of newspaper and magazine articles capably informing the American public about integration, busing, anti-White discrimination, and Jewish domination in media and government.

ciples of brotherhood, honor, duty, courage, and love.

The highest motivation of our fraternity is love: love of our people's unique heritage and character, love of freedom, and love of our fraternal brothers and sisters who are the vanguard fighters for a new era for our people. If we are to restore the unity and brotherhood of our people, we must first restore it within our own hearts and ranks.

3. Our unity and purpose begins with the rituals of our order. In them we dedicate our minds, hearts, and lives to each other in service of the ideals we fight for: the higher development of civilization and a more beautiful and talented people.

4. We believe that our race and all others should have the right to determine their own destiny through self-determination and rule. We believe that abundant differences between the cultures, nations, and races of man give them the natural right to work toward their own ideals and interests with the least possible interference from others.

5. We believe that all races should have the freedom to associate in their own communities.

Forced integration of the races and accompanying discrimination, injustice, decay, hatred and violence must be ended.

9. We endorse the principle of Majority rule for America. America should have the right to orient its domestic and foreign policy in the interests of its founding White majority. Within this framework there should be an opportunity for minority rights and self-rule, but not the exploitive minority rule over White people exercised today in the mass media and government policy. The government's pro-Israel, anti-American policy in the Middle East is a good illustration of a policy favoring the interests of a tiny, Jewish minority and hurting Americans economically by alienating the oil nations and pushing them toward the communist orbit of influence. Today, the Jewish, minority domination of the media and government is the most important political fact of life which must be recognized if it is to be corrected.

10. Just as we say all races should have a right to secure their own heritage and cultures, we Klansmen are strongly devoted to our own White race, its preservation and enrichment. We believe that our racial heritage is our most precious possession. If we lose it, we will lose our Western Culture and its freedoms. Our task, though, is not to preserve things as they are, but to increase man's knowledge, his understanding, his intelligence, and his power. We want to strive toward God making each generation a step upward toward a continually higher concept of perfection. We see our home as not just the earth but the universe. We see the stars not as twinking lights, but as steps to our ultimate destiny.

The Ku Klux Klan came into existence at the end of the War Between the States in a period called "Black Reconstruction." During that period, most White people had lost the right to vote. Illiterate blacks, with no history of democratic government, became the bulk of the voting population resulting in tremendous crime, violence, and corruption against White Southerners. At the darkest hour, the Klan arose and restored the governments of the South back to the Southern people, and as Woodrow Wilson said, it saved civilization on this continent.

Since that time, the KKK has been the target of incessant hatred from anti-White, prominority forces in the mass media, who, because they oppose the Klan's ideals and recognize its powerful appeal, have endeavored to defame its leadership, its membership, its history, and its ideals. Hundreds of books, movies, and television programs are produced each year attacking the Klan, but no arguments sympathetic to the Klan are permitted in the

The KKK has been more active with young people than any other patriotic American organization. For instance, the Klan is active on many college campuses, and Grand Wizard David Duke has made a large number of university speeches to overflow audiences.

It is an Organizational Asset.

The Klan name and symbols insure the quality and dedication of our membership. Our uncompromising name and principles weed out cowards and hypocrites, and it elicits a high level of dedication and activity on the part of our membership. Our historical continuity, record of victory, martyrs, and rituals evoke a religious-like magnetism and strength. Great revolutions are made by irresistible emotional waves, rather than by mathematical equations.

It is a Tactical Asset.

The controversial nature of the KKK attracts tremendous interest. No one can respond to a Movement if he has never heard about it. Those who may be inclined to suggest that we change our name, should note that, directly or indirectly, they probably wouldn't be reading these lines right now if not for our Klan name.

Act Now!

With the advent of forced integration, all academic standards had to be reduced or discarded rather than blatantly reveal the inequality between the White and black races. Since forced integration has become a ponderous reality, the quality of education has deteriorated dramatically, and the culturalracial clash in schools has produced increasing hatred and violence.

6. We want an end to discrimination against the White majority. We believe that the White people of America have become an oppressed majority. Our people suffer from discrimination in the awarding of employment, promotions, scholarships, and college entrances. There is an inequitable tax structure that militates against the interests of the White majority. Culturally, the White people are victims of massive race-hate propaganda in the mass media. The media and educational establishment often attacks the character, history, abilities, conduct, artistry, and moral fiber of the White race. Anti-White propaganda is presented that encourages minorities to harbor envy and hatred against the White race and that instills false guilt in millions of White people. Pro-White counter-presentations are suppressed by the media and educational establishment. Correlated with the anti-White propaganda and the bending of the governmental and legal establishment toward minority interests is perhaps the worst form of oppression of all: physical attacks. Racially motivated murders, robberies, rapes, and assaults against White people are reaching epidemic proportions. It is time we ended the racial discrimination and oppression against White people, and our government made truly an instrument of the majority spirit.

Media Lies and Misrepresentations

The true Klan is not anti-Catholic in any fashion; both Catholics and Protestants rode with Nathan Bedford Forrest, the Klan founder.

The fiery cross is an ancient symbol of White racial victory against tyranny. Also, it is an ancient Christian symbol. One can, for instance, find candles in the shape of the fiery cross in many churches. The fiery cross symbolizes lighting up the cross, not destroying it.

The original meaning of the robe and hood comes from ancient European rituals meaning fraternal brotherhood and anonomity in doing good works. It is true that in "Black Reconstruction" it shielded the identity of Klan patriots from the tyrannical rulers of the South. We wear the robe and hood in our ceremonies in honor of our traditions. Our robe is no more improper or out of place in our rituals today than judges' robes in modern courts, or masons' aprons within their lodges.



Buffalo Situation: Explosive

The racial situation in Buffalo has become highly explosive.

Blacks, unwilling to accept the decision of White people to elect a mayor, James D. Griffin, that represents their interests, have united with radical leftists in an effort to pressure Buffalo councilmen to head a recall of last years election.

This has been worsened by threats by supposedly responsible black leaders, who have been calling for a return to 1960 style violence unless Griffin capitulates.

In addition, Mayor Griffin has defied these irresponsibles, and instead has informally met with Western New York Klan leader, Titan Robert Karnath. Mr Karnath has been doing an excellent job in that area, and reports that if the blacks carry out their threat to initiate violence, then Klan forces will join the police to aid them in maintaining law and order. The enemies of the White race should not take Klansman Karnath's promise lightly. Mr. Karnath is an American Veteran of World War II, a labor activist, and the Buffalo organization has proven on many occasions their courage in meeting our enemies head-on, and often-times, on their own turf. Mr. Karnath is ably assisted by Klan Scribe, Tim Straw, formerly a coordinator of the Klan Youth Corps. Klansman Straw currently acts as the secretary of the regional organization and editor of their local newsletter, the Racial Observer.

Klan Alerts Parents

The California Klan has successfully alerted parents in Fallbrook, California, to the scheduled return of a repeated sex offender to their neighborhood.

In 1963 Joseph Larroque raped the teenage sister of his former wife. He was declared "cured" and then released back into society in 1971.

Three years later Larroque lured his 14-year-old nextdoor neighboor into his garage. There he bound her, put her in the trunk of his car, and then drove her to a secluded area where he raped her repeatedly and forced her to commit the most perverted sex acts. He kept her in a box similar to a dog house for several days, and whenever he desired her he would return to the area, where he again made her submit to his depravity. Tom Metzger, California's Grand Dragon, a resident of Fallbrook, and a concerned parent of four children, wasted no time in alerting his neighbors to this man's scheduled return and the implications that it had toward the safety of neighborhood children. In a leaflet blasting the California Criminal Justice system as a "motel" for this "beast," and others like him that "prey on little children," Klansman Metzger called on Fallbrook parents to resist this man (sic) from returning to their neighborhood.

Tennessee Gains


The Ku Klux Klan in Tennessee has been making steady gains of late.

In April, David Duke appeared on six radio and television shows in the Memphis area, netting hundreds of resNew Jersey State Organizer, Raymond Stankunas, has announced in the Jersey Journal, that he will begin an organizing effort in the Rockland County area soon.

In addition, Klansman Stankunas reports an increase in all forms of activity across the state. "Klan" Phamphlet Distributed At D-B High School

"White students . . . Fight for White power by becoming a member of the Klan Youth Corps," exhorts the lettering on the front of a handbill found on the windshields of some cars parked in the Dobyns-Bennett High School parking lot yesterday afternoon.

"At first I thought it was a joke," said Beth Kirby, a student at Dobyns-Bennett, who found one of the four-page broadrides illustrated with a drawing of a muscular man breaking his wrist shackles.

Then Beth "got mad" and called the Times-News to describe some of the inflamatory language used in soliciting membership in the Klan Youth Corps, billed as "an affiliate of the Knights of the Ku Klux Klan (America's oldest, racialist fraternal order)."

A Klan Reply

To the Editor:

Now that some of the more hysterical elements in our society have been allowed the time to cool off. I would like to comment on some of the remarks made earlier this month in regard to our recruiting of high school students into our Klan Youth Corps. In particular, these remarks generated around our distribution of literature in Kingsport area high schools, the **Dobyns-Bennett High School receiving** the most attention.

In a letter to your Readers Forum, a black reader registered his "concern" over our recruiting efforts. In a letter laced with the arsenical terms of civil rights and human rights, he presented his own brand of racism, a very one sided racism.

Don't get us wrong, we believe in racism wholeheartedly, if it is a racism that is exemplified by love of one's heritage, culture and civilization. But his racism is a type that any honest man, regardless of political persuasion, would find hard to stomach. It can only be described as egocentric, where one man would tell an entire race to "do as I say, not as I do." We find it interesting to note that the likes of this reader never are "concerned" over reverse discrimination, only "discrimination." Nor are they "frightened" when blacks, Indians, and Puerto Ricans organize along racial lines. Nor are they "outraged" when blacks arrogantly praise "majority rule" for Africa. Nor does the promotion of minority organizations and culture in our schools "upset" or "shock" them. No, they save all of this emotion, along with their hypocrisies and distorted images of justice for the White majority. The Knights of the Ku Klux Klan represent the embodied hope of the White race, but the fight before us is not so much a fight of black against White, but of truth against the world.

Tom Metzger is hardly the consummate master of tact and diplomacy that one usually ascribes to the skilled politician.

He has an indelicate, straightforward, often irreverent way of describing his views on political issues and will not hesitate to remind his listeners of that fact.

His plain speaking, self-proclaimed racism and affiliation with the Ku Klux Klan have lent him a celebrity status of sorts in the four-way race for the Fifth District supervisorial seat.

In what can be described as a generally lackluster campaign, Tom Metzger has provided an oasis of dynamism and spontaneity. (Opponent Paul Eckert admits that without Metzger, the supervisorial race would be dull indeed.)

In any other candidate, the bluntness and candor of Metzger's remarks would be considered foolhardy. But then the 40-year-old Metzger is not your conventional candidate.

For one thing, he is financing most of his own campaign and so far has spent little more than \$1,000, compared to the several thousands of dollars raised by his three opponents.

"Bill Dominguez is supported by banking interests so he's got the money to spend," says Metzger. "Paul Eckert has a nice large business so I'm sure he can afford it. Mrs. (Lorraine) Boyce is doing pretty well, she's married to a doctor, and anyone who's got a doctor for a husband has got to be rich.")

"I'm pleasantly surprised at the support I'm getting throughout the district," he boasts. "People are recognizing that I'm the no-fun-and-games candidate. I don't hedge on the issues."

One of those issues is Proposition 13 which Metzger describes as a useful way of gaining taxpayer control over the bureaucracy. He dismisses predictions that passage of the measure will cause financial hardships for cities and districts as simply bureaucratic scare tactics.

"The bureaucrats should be scared," he said. "If they don't have the money, we will - in our pockets, where it belongs. If there's inefficiency in the fire districts, get rid of the people who are inefficient. There's a tremendous amount of fat in social services. I've offered to work for 20 grand instead of the \$33,000 (supervisorial salary)."

His contempt for bureaucracy also is tied to his position favoring the abolishment of the Comprehensive Planning Organization which represents the 14 cities and the county. He calls it "unelected government" and therefore it is a dangerous concept, he says. "I vote no on CPO and support the (State Sen. James) Mills bill to abolish it," he said. The cities have a lot of power collectively when it comes to pressuring the county. I don't buy the idea of Mrs. Boyce that it will weaken government by abolishing it." An admitted skeptic of government, Metzger said he is distrustful of the government's efforts to manage growth in the county areas. Such a growth management plan should be drafted by private consultants, he suggested, free of the vested interests he claims are bound up in government studies. He compares the influx of population into North County to a "big boom town in a gold rush." The only way to slow that growth is for the electorate to defeat all bond issues, forcing growth to move elsewhere, reasons Metzger. As state director of the Ku Klux Klan, Metzger makes no effort to conceal his ethnic biases. For too long, he claims, White politicians have promoted the interests of the minorities, failing to look out for their own people. The KKK attempts to fill the needs of what Metzger describes as the White dispossessed majority which is "swiftly becoming a minority." "One thing I'll resist are affirmative action programs," declares Metzger. "They're racist and discriminate in a reverse manner against Caucasian people. There's no way I can force upon the citizens of this country the guilt or nonguilt of something that happened hundreds of years ago." On low-cost housing: "It's nothing but a euphemism for bringing welfare people into the communities, in many cases, minorities. It is a back door to integration. All you have to do is look at the areas that are highly integrated." Welfare, he says, is "bribery – we'll give you money if you don't riot. It promotes people to be on the dole." Many of the Mexicans living in Metzger's neighborhood are illegal aliens on welfare, he alleges.

The handbill makes such statements as:

- "Have you 'had it' with blacks following you home to beat you up, or pushing your head in the toilet when you go to the john, or 'holding' your lunch money for you?

- "Are you really 'uptight' because White girls have to submit to being molested by crowds of grinning blacks?"

It goes on to suggest, among other things, "Conditions in schools have become so rotten that trying to get an education has become a laugh. Who can learn anything caged up with a bunch of cannibals?"

As stated in the handbill, the aims and objectives of the Klan Youth Corps follow the standard KKK line - warning that integration leads to racial strife and miscegenation.

"Racial separation, preferably through black repatriation to Africa, is the final and only desirable solution to America's racial problem," in the opinion of the Klan and its Youth Corps.

The back page contains a membership application, to be mailed along with "a minimum of \$6" dues, to a Louisiana address. Also printed on the cover is a Kingsport post office box number for the

Metzger also says he refuses to "litter the countryside" with placards and billboards, preferring to rely on his already established name identification and public appearances for publicity.

And then, of course, there is Metzger's very quotable campaign rhetoric.

For instance: "Everyone's a racist; it just depends on what race you're working for. I'm proud as hell of being a racist."

Or, "When people come before the supervisors looking for a handout, I'm going to throw the bums out."

Of the undocumented aliens crossing the border from the south, Metzger says, "Today they carry knives and transport narcotics. I say, get rid of them and send 'em back to Mexico."

Still much of what the KKK leader stands for encompasses the sorts of issues and views many Americans hold dear. While courting the far right of the political spectrum, Metzger, a small businessman himself, claims his strength lies with the working people, the disenchanted voters. Welfare, he believes, is bribery, affirmative action programs are a consumer fraud, taxes are way too high and growth pressures within the country must be tamed. These are the types of positions, Metzger says, that are drawing a greater following of supporters to his candidacy. Metzger discussed his campaign during a recent interview at his Fallbrook home where he lives with his wife and four children. It is a modest house, typically middle class suburban. Inside, a closed circuit television keeps a watchful eye over his TV repair business downstairs. Above another TV set hangs a painting of the "Spirit of '76" depicting the Sons of Liberty ("I'm very patriotic - an extreme nationalist.") Metzger says he was led into the Fifth District race when he discovered there was an absence of candidates he felt could adequately represent North County.

Klansman from Old South

Probably one of the most controversial organizations ever to exist in the United States is the Ku Klux Klan.

For years it stood as a living symbol of racial hatred, prejudice and discrimination of the worst kind.

But today, none of that is true. At least according to the Klan's newest "Grand Wizard," David Duke.

A 27-year-old college graduate, Duke has been receiving national prominence in recent months on network talk shows.

"Tom Snyder thought he was getting a backwoods-type idiot - but instead he got someone who could out-argue him," Duke said in a recent interview in The Post-Journal newsroom.

He borrowed from the Bible again on the subject of gun control. "Christ said that 'if a man does not own a sword, he should sell his cloak and purchase one.' He believed men should be armed," Duke said.

Because of the Klan's traditionally Southern background and the Southern character of President Jimmy Carter, Duke was asked if he thought the Klan might find a little more sympathy in the White House than it has in the past.

His reply was quick and to the point: "Carter is a totally unscrupulous politician ready to do anything for political power."

Sex Offender Shunned

Ku Klux Klan members are waging a door-to-door campaign to turn a Fallbrook neighborhood against a twiceconvicted kidnapper and sex offender who is coming home from prison today.

Society - or more precisely, the California Community Release Board says Joseph Henry Larroque has paid his debt for the 1974 kidnap and sexual assault of a 14-year-old girl.

But his possible neighbors-to-be in Fallbrook, incited by a KKK leaflet delivered to their homes, say something else.

They say Larroque, 54, should have served the maximum 25-year term the law allowed. They say they are afraid for the safety of their children. And they say that even if Larroque is released, they want him to settle anywhere but on their block. The stirring of feelings against Larroque's return may already have insured that he will not resettle in Fallbrook. Last night, Larroque's stepdaughter tearfully said that Klan leader Tom Metzger had destroyed the lives of her mother and Larroque. The stepdaughter, who asked not to be named, fought back tears as she said Larroque now probably would not be coming back. "They've made it too difficult for him to come back," she said. "I don't know why they've done this. He's [Larroque] a good man. He made a mistake, but he's paid for it; he's been rehabilitated." It is precisely the fear that Larroque may not have been rehabilitated at all that sparked neighbors' emotions. In 1966, he was released from Atascadero State Hospital after doctors there pronounced him cured. He had been convicted in 1963 of raping a teenage sister of his former wife in 1963. Sentenced as a mentally disordered sex offender, Larroque's felony conviction was "terminated" in 1971 by a prison system that ruled his incarceration and treatment successful.

That was before the leaflet circulated by Metzger to Larroque's neighbors on Tanya Lane.

The flier, also left by Metzger at the Larroque home, refers to Larroque as "a beast who preys on little children," and urges neighbors to "express your anger at this terrible miscarriage of justice and danger it presents to all our local children."

The memo left at the Larroque door struck at least one neighbor as a bit heavyhanded. But she, like two others interviewed, agreed that she did not want Larroque to live near her family.

"I have a daughter, and it doesn't make me too happy," she said, adding that the people she has talked to have said they "are going to keep a closer eye on their kids and not let 'em wander." This neighbor also mentioned that Mrs. Larroque's two little granddaughters are also living at the home. The woman said she was concerned whether they would be safe from Larroque. "Some people said at first, 'Hey, give the guy a chance,' but when we heard he had a prior conviction for the same thing that was different," the neighbor said. When asked if she considered it possible that Larroque was cured, the woman spoke for many of her neighbors with a simple "nope." Another Tanya Lane resident spoke highly of Mrs. Larroque, a hospital bookkeeper, but was adamant in his opposition to Larroque living nearby. "We're very upset about it," he said. The neighbor said Larroque's wife is a shy but friendly and devoutly religious woman. "It seems totally incongruous that she would be married to a man like that," said the neighbor. Asked where he would have Larroque go to live, the neighbor replied, "Argentina. Anywhere else but here."

The soft-spoken, slightly-built Duke looks more like a second-year law student than a leader of a mysterious organization of men who wear white sheets, burn crosses and on occasion have been known to conduct a lynching or two.

"That image is wrong," Duke said, "and the purpose of my cross-country tour is to let Americans know, from our own lips, what our organization is all about."

Duke said that the Klan is an organization working for the White race. "The blacks have the NAACP, the Mexicans have La Raza, the White people have nothing but the Klan."

And the White race needs all the help it can get, according to Duke. "We're an endangered species," he observed, noting that the White population of this country at present has more deaths than births, while the minorities "are reproducing at a fantastic pace."

According to reports, Klan membership in this country is on the upswing, and Duke willingly agrees with this. But he is reluctant to give any figures.

He had nothing good to say about United States Ambassador to the United Nations Andrew Young either. "In Africa, Young insists that blacks should run the government because they are in the majority. Then he comes right back to the United States and becomes defensive about a White majority society."

Duke sees members of the White race as "victims" of today's society. "We have an illusion of freedom, but that is all."

He said he doesn't blame people for being liberal, because they are "being programmed for that through the media."

The media, he claims, are being used as a tool of the Jewish race to manipulate the American people.

"All three major television networks have Jews as heads and they also dominate the movie industry. And of the 56 largest newspapers in this country, 38 are owned by Jews and many others are controlled by them," Duke claimed.

He blames this "manipulation" of the media as the sole reason that America is involved in the Middle East with a pro-Israeli stand.

Metzger, who started the furor, said yesterday that this was the sentiment he

"We traditionally do not give out our membership numbers or the names of our members," he said, noting that he plans to work in the future to remove at least some of the secrecy involving the Klan.

When asked how many members of the Klan live locally, he would say only that there are "a pretty vibrant number of dens in this area."

At one point in the interview, Duke insisted that the Klan has nothing against the blacks in this country. He does believe, though, that for the black and White races to develop to their fullest potential, there has to be a "complete, but voluntary," separation of the races.

This would eventually mean, according to Duke, the establishment of a separate nation for blacks, "perferably in their native Africa, but in the United States as a last resort."

The money to get them started would come from all the welfare money which Duke said is now being spent on blacks in this country. "Whether or not they could maintain a country or not, I don't know."

Although he is soft-spoken, he is never at a loss for words. What did he think of the multi-part television movie "Roots" based on the book by Alex Haley?

"Government policy in the Middle East is critical because of the energy crisis," he said, "we need oil, and yet our policies are pushing the Arabs right into Russia's hands."

Duke blames the integration of schools in this country, at least partially, for the declining scores observed in recent years in college entrance exams.

The violence in school systems across the country is also a result of integration, according to Duke. "Our schools have become battlegrounds since integration," he said.

He insists that since 1954, which marked the beginning of integration in this country, violence has increased thousands of percentage points. "Last year there were 400,000 serious assaults and 9,000 rapes in public schools," he claimed.

He said he does not advocate "forcing" people to attend all-black or all-White schools, but believes that if given the choice most people will do this on their own.

But three years after his release, Larroque lured his 14-year-old nextdoor neighbor into his garage.

There, he proceeded to re-enact his previous crime. He bound the girl hand and foot, placed her in the trunk of his car and drove to a secluded place and forced her to perform and submit to sex acts.

A sexual perversion charge against him was dropped in return for his pleading guilty of kidnapping in the 1974 incident, parole board records show.

Larroque was sentenced in 1974 under the state's old indeterminate sentencing law, which called for 1 to 25 years in prison. He was given credit for three months served in jail, and was eligible for parole in December 1974.

He was not granted parole immediately, but after amassing a record of good conduct and good work habits, the Community Release Board this year set a release date.

Larroque had studied gardening for more than 2,000 hours while he was in prison, and reportedly planned to open a landscape firm in Fallbrook.

was trying to foster.

"We would hope to create enough interest in the community that he'll have to go elsewhere," Metzger said. "We don't feel good about making some other community having to accept him, but maybe they'll do the same thing, and he'll have to keep on the move. . .

"He's proved himself not to be a part of civilization."

In Sacramento, where parole board officials are getting used to such reactions when convicts are released, executive director Gary McComber predicted that the vehemence directed against Larroque will hurt him.

"It looks from his record like he's made every effort. His report says he was involved in several programs, he was discipline-free, he was quiet, mature, shows respect for authority," McComber read from the report. "Now he wants to phase back into society, and this is not going to help him."

But one official involved in the treatment of Larroque and other prisoners commented, "Sex offenders of his type tend to be model everything in prison. If he was at Atascadero before, they thought they cured him. But if he went back [to prison], obviously they didn't."

"It was a vicious slap in the face of every White man. It should have been called "Weeds" or "Alex in Wonderland."

Duke said the book and the movie were historically inaccurate. "Even liberal historians agree," he said, "that the Whites had little to do with the slaves. Their black brothers were the overseers who administered beatings and it was other blacks who rounded up slaves in Africa, not White men."

The Klan, according to Duke, is a patriotic movement promoting the ideals of Western Christian Civilization. And at several points in the interview, he called upon the Bible to back him up on points.

Duke said that while he does not advocate slavery, Jesus Christ did. He claims

Switching to the Klan itself, Duke said they still hold rallies where crosses are burned and members wear white robes. None is planned for this area, however.

Only White, non-Jewish American citizens are eligible to join the Klan. And Catholics, Duke said, may become Klan members.

Duke does not deny that in the past Klansmen have been involved in violent acts. But, he insists that the Klan tells its members not to do anything illegal.

"We will not initiate any violence," he said, "but we are ready to defend ourselves at all times."

The Phil Donahue Show is one of the most popular talk shows on national television. When they finally invited me to appear on the show, they did so with strings attached. Because of all of the press Frank Collin and his proposed Nazi march through Skokie, Illinois, received, they wanted him on the show too. I was faced with the difficult decision of whether to appear on the show with him or simply not to appear on the program. On the understanding that it would be clearly stated that Collin and I represented completely different organizations and ideas, I consented to appear on the show. I am glad I did. For although the forum was not ideal and although the program was perhaps only one-tenth as effective as it could have been had I appeared alone, important ideas on race were discussed before millions. Frankly, I do not believe that I lost a single debating point during the entire show.

We are already receiving hundreds of favorable letters from all over the nation, and I expect to receive a total of four to five thousand.

Below is a listing of many of the cities that program has yet to appear in. Check your local TV sections for the time of the program. In Washington, D. C. black employees at a television station were so frustrated by the pro-White effectiveness of the show that they sabotaged it by cutting it off in the middle of its showing. So many calls poured into the station protesting the cut-off that the station was forced to air the rest of the show at a later time.




