## Forgotten Feminist

In the American twilight of the 20th century, the annals of history are painstakingly raked over and then flyspecked to uncover nonwhite accomplishments. A mulatto draftsman employed by Thomas Edison is now being touted as an inventor. (Edison is a great annoyance to equalitarians.) On July 4 a commentator explains with rhapsodies of joy that *Porgy and Bess* is the archetypal piece of American music. Why not? After all, it is Jewish music about Negroes. What could be more American?

Despite the maniacal mantras about blacks, Jews, Hispanics, Asians, gays and left-handed Buddhists that are thought to be indispensable components of that great smorgasbord of "diversity," women seem to be falling out of favor unless they possess a second property—color or sexual "status." Ordinarily what used to be called "notable" women are of declining interest, especially if they "happen to be white," as the expression so pleasantly goes. (How people "happen to be white" must perplex those leftists who deny any importance to genetics. Must be more bad environment and poor social consciousness on the part of white parents.) Nonwhite "two-fer" are applauded, but white females are increasingly less celebrated in the modern pecking order. The Burke's Peerage of Bolshevism is, like Stalinist purge lists, always under revision. After all, it would only be expected that as we progress towards Nirvana, enlightenment will permit us to strip away old preconceptions dating back, say, a week ago.

Unfortunately white women do represent an important portion of the minority coalition. (They are really a "two fer" since every white woman voting or acting mud really counts twice—one less white vote and one more for the forces of darkness.) But the white woman who acts and thinks in the best interests of her race is consigned to the Pluto of leftist cosmology—if she's lucky. If mentioned at all, she can be expected to be excoriated by the present guardians of official history.

Consequently it is no surprise to see a female "who happens to be a honky" play a role in history and then drop from the Pantheon. Most Instaurationists are probably familiar with the fall from grace of Margaret Sanger. Her sensible views on race have caused nonwhites to demand that she be sent down the memory hole. Total subservience and conformity in any important matter are the price of praise in today's diverse intellectual academy.

If her enemies are successful, Sanger is doomed to the same historical oblivion accorded Rebecca Latimer Felton (1835-1930). Who? Mrs. William H. Felton. Still no flicker of recognition? How about Senator Rebecca Latimer Felton, the first woman to serve as a U.S. Senator? She was appointed by Governor Hardwick to represent Georgia after the death in 1923 of the great populist, Thomas E. Watson. While Mrs. Felton only served for a few days, she led a long and active political career in Georgia. Her husband, William H. Felton, helped lead the independent/proto-populist revolt in the state for some years and served in Congress from 1874 to 1880 representing Northwest Georgia. Mrs. Felton was widely seen as the "second congressman" from that district as she and her husband fought a brutal campaign against the entrenched "Bourbon" Democratic party which dispatched money and legions of Confederate heroes, such as General John B. Gordon, to war against them.

Among the issues that interested and engaged Mrs. Felton were prohibition, women's suffrage, honest and limited government, public education, cleaning up the corrupt, political Methodist Augean stables and prison reform. She was very forceful in her political writings. Her enemies (she did not have rivals, only enemies) opened the newspapers with trepidation to find one of her scathing articles flaying the skin from their political hides.

When she was appointed Senator, although she was 88 years old, photographs revealed a youthful twinkle in her eye and a vigorous, grandmotherly aspect in her dress and appearance. After her brief term in the Senate, she went on to write books and newspaper articles, expand her business concerns and sit on the boards of foundations and schools she had helped found. She actively campaigned for Alfred E. Smith (a Catholic, drinker and Yankee) rather than see worshipers of Woodrow Wilson, such as Georgia-born William McAdoo, get the Democratic nomination. She was opposed to the League of Nations and American intervention in European wars.

In her 93rd year Mrs. Felton was involved in a car wreck. To everyone's amazement, she made a complete recovery. Her doctor announced she would regain perfect health, if she would just stop talking! Nine months later, in December 1929, she was in the news once more when

she took a ride in a blimp.

In January 1930, having come down with a cold, she insisted on riding a bus to Atlanta from her home in Cartersville to attend a board meeting of her Girls Training School. (Her frugal soul rebelled at the extravagance of the railroad fare.) The cold worsened and she finally succumbed a week later at age 94. The U.S. Senate adjourned in her honor. Her estate was valued at \$250,000—in the Depression. The money had been earned bit by bit in writing, farming and prudent investment.

All in all, Mrs. Felton was a remarkable woman. She rode the first train out of Atlanta as a young girl. She authored scores upon scores of newspaper and magazine articles and three books. Her fictionalized life was the central character in a best-selling novel of the time, *The Co-Citizens*. Yet today few even in her native Georgia know about her. Try her name in the circles of knowledgeable feminists. Look in vain for her visage on postage stamps.

Readers of *Instauration* doubtless suspect the reason the media enshrouded Mrs. Felton with silence. She was a daughter of Dixie. The race question is the great issue that provided the political poison to tear the nation apart from 1860-1865 and haunts it to this day. Rebecca Latimer Felton had no truck with race-mixers or equalitarians. Indeed the presence of the dusky-hued electors was cited in her suffragette speeches as one of the reasons that white women needed the vote. She and her husband were slave holders and had first-hand contact with Negroes. That close and personal experience, unlike that of the distant New England abolitionists, led Mrs. Felton to very decided opinions on the capacities and therefore the appropriate role of the black in the post-Civil War South.<sup>1</sup> When Mrs. Felton fixed her mind on a subject, she was not hesitant to express herself. No questions of "insensitivity" troubled her mind or blunted her speech.

In her school days (about 1850) young Rebecca Latimer wrote:

In no respect is improvement more apparent than in the intellectual world. After a slumber of ages the mind of man has awakened to a realization of its power. This is especially true of the Anglo-Saxon race, for the mental powers of the Eastern nations are still folded in the Lethean slumber of ages.<sup>2</sup>

Strong racial consciousness was to permeate all of Mrs. Felton's life. Her temperance speeches were peppered with the proposition that permitting Negroes to consume alcohol only increased their criminal behavior and even precipitated attacks on white women. The need to control Negro rapists played a major part in her most controversial advocacy: lynching as a preventative to anti-social African behavior. In one of her writings she flatly stated that so long as Negro crime continued, lynching must continue. In a speech before the State Agricultural Society in 1897, she explained that women left alone in

isolated farm houses faced a grave danger from roving Negro rapists and murderers. The men of Georgia, she insisted, needed to protect their wives and daughters. Since religion and law could not put a stop to Negro "wildings," the white men must lynch these "ravaging beasts a thousand times a week if necessary."<sup>3</sup>

This widely reported speech stirred the Holy North to righteous rage at the bestial South. Mrs. Felton engaged in a newspaper war with the *Boston Transcript* in her usual direct and forceful language. Her biographer summarized her position as follows:

Bluntly she charged the Northern newspapers with encouraging those crimes that made lynching necessary. Their maudlin sympathy for the Southern Negro had made him restless and unruly. If Boston wanted mixed marriages, that was its business but it might as well understand that in the South a Negro who laid hands on a white woman was going to die. Of course, she had rather see the brute hanged legally, but if he confessed to a mob, then he stood condemned by civilization, with the possible exception of Boston."<sup>4</sup>

A Negro editor in Wilmington (NC) fired off an incendiary response to Mrs. Felton. He cynically commented that the poorer classes of white women were entirely too free with clandestine meetings with black men—just as white men were with colored women. The black scribe advised white people to begin at the fountainhead to purify the stream. In November 1898, the Republican administration of Wilmington departed office and the sage African immediately decamped for New Jersey's more salubrious climes before a mob sacked the newspaper office and 11 other Negroes perished in the riots that followed.

Mrs. Felton continued to promote lynching as a means of controlling feckless Negro criminal conduct. Even the self-confessed liberal author of Mrs. Felton's biography was forced to admit that "from 1890 on into the first of the 20th century there was an alarming outburst of Negro violence and white reprisals, both of which were probably brought on by the white man's efforts to curtail the political and social advances made by the Negro."<sup>5</sup>

It did not occur to him—or he thought it less than discreet to articulate it—that the reverse of the proposition was more likely true. The behavior of Negroes drove the Southerners to curtail their privileged status in post-Reconstruction society. Many Southerners, particularly prominent newspaperman Henry Grady, were willing to put race aside if it were shown to be workable and good for business. When experience proved otherwise, the Jim Crow laws were born.<sup>6</sup>

While Mrs. Felton considered herself a devout Christian, she did not hesitate to open fire on the clerics of the day whom she suspected were but corrupt timeservers.

Dr. J. B. Hawthorne of the Southern Baptists entered the fray by criticizing Mrs. Felton for her remarks about lynching. Hawthorne had crossed swords with her previ-

ously over Prohibition and women's suffrage. Hawthorne was quoted as stating she represented "humanity verging toward the animal and the fiend" in a sermon pompously titled, "Christianity and Mob Law."<sup>7</sup>

Never one to back down, Mrs. Felton retorted that Hawthorne was but a "slick-haired, slick-tongued Peck-sniffian blatherskite." She claimed that lynch law had curtailed the level of black-on-white crime. (When is the last time any public figure took umbrage at black-on-white crime?) In the next exchange of fire, Hawthorne responded that he only sought to correct the bad press and bad reputation Georgia was getting in the Northern media. (Could be bad for business, you know.) As a proud Southerner, Mrs. Felton replied that Hawthorne was truckling to the Yankees to get a higher salaried job. It was later revealed that he was paid to endorse patent medicine cures. An early Jim Bakker?

Not long after the exposure of Hawthorne, a Negro outrage occurred in Coweta County, south of Atlanta. A darky by the name of Sam Horse murdered a white farmer, then raped his wife while forcing her to lie next to her dead husband's body. Horse then took to his heels as posses combed middle Georgia in pursuit.

Mrs. Felton urged the posses to simply shoot Horse down rather than capture him. That would spare the victim the necessity of testifying in open court. After a ten-day search, Horse was captured and jailed in the county seat of Newnan. The next morning, a Sunday, the inevitable occurred. A mob pulled Horse from his cell, emasculated him and burned him alive. The North exploded. Most Southern papers did not comment nor did Mrs. Felton.

Three years later, a self-hating Southerner by the name of Andrew Sledd composed a plea against lynch law. A liberal by the lights of his time, Sledd would be excoriated today by the left. He explained that Negroes were not fit for integration and the North was wrong to attempt to force it on the South. However, the South was wrong to evoke the brutal reprisal of lynching to control black crime. Sledd painted a particularly poignant picture of the perpetrators of Horse's death. All the worst aspects of mob behavior were paraded in print for the reader's revulsion.<sup>8</sup>

Mrs. Felton leapt to the defense of Dixie. She pointed out that Sledd did not bother about the death of the farmer or the sufferings of his wife. The victims of Horse were ignored by the "sniveling ink-slinger" hireling of a Yankee magazine. She advised Sledd to head north to get a job with a Negrophile journal before his fellow Southerners accoutered him with tar and feathers.

As it developed, Sledd was a professor at Emory University, a Methodist school that at the time had some reputation for decency. Mrs. Felton began to agitate against his continued employment until Sledd resigned his professorship. He served his martyrdom by taking the presidency of the University of Florida. After he retired from that post, Emory reappointed him in 1915. His "courage" enabled him to bear up well under this terrible oppression.

As bad as mob rule was and is, Mrs. Felton's point was that the primitive behavior of blacks required the threat of immediate retribution in order to put brakes on their wild actions. We have now escaped the bad old lynching days—or have we? Are whites the victims of lynching today instead of blacks? Studies of crime records make it clear that today whites are the targets of Negro lynch mobs.<sup>9</sup> Instead of condemning them, we are urged to understand the poor, misunderstood "youths" who behave just as their ancestors did a century or more ago.

When the New England abolitionists, spiritualists, phrenologists and transcendentalists idealized the Negro, one could have hoped that time would have modified their optimism. Instead, they have degenerated into liberals and progressives who are clearly impervious to rationality.

The lessons of Rebecca Latimer Felton's life are many. She worked long and unsparingly to the end of her days for the issues and causes that were of most importance to her. She still was able to raise her family and run several businesses. In theory she ought to be one of those "Virginia Slims" female role models who "had it all." She was an outspoken and courageous racist even in a day when most Americans assumed that their country would always be a white country. When her opponents objected to this great fundamental principle, she would rush to the defense of her race. She did not care one whit for the accolades of her enemies. She never compromised. Despite all these characteristics—which modern commentators would advise were guarantees of failure—she was successful. She and her husband were showered with honors. When they each passed away, they were genuinely mourned by the folk for whom they had labored so diligently.

Compare the careers of the "white racialists" of our own times with the career of Mrs. Felton. The pathetic George Wallace comes to mind. Despite his earlier liberal views on race, he became identified as the foremost segregationist of the Southland. His charade of standing in the schoolhouse door was remembered while his instantaneous, arranged departure from the transom was forgotten. If Wallace ever truly believed in segregation, he should have had no apologies for it when integration was tried under every conceivable format and failed. He should have been willing—if not enthusiastically able—to enjoy that great human pleasure of saying: "I told you so." Instead, in his declining days, he lacked the fortitude to be a John Randolph of Roanoke, Cicero, Cato or Demosthenes, to speak out for the dying Republic. Wallace groveled and cowered like a whipped cur as he begged the media to lay off. The psychological prostration was to no avail. He will go down in history as a confused failure—"A man who saw the light too late." Wallace simply lacked character. He did not truly believe in what he did or said when he was in power. His resistance always ceased whenever the cost mounted. He was a symbol of the South's failure to prevent the Second Reconstruction.

In contrast, Rebecca Latimer Felton proved time and

time again that she had the character and moral courage that elevated her to the Pantheon of heroes and heroines of our race.

The Greeks believed that no one actually perished whose name was remembered. We should study the careers of our forebears such as Mrs. Felton. She fought heroically for us. She and many others like her deserve honor and remembrance. Meanwhile we should carry on her work, as she would have us work, for our posterity.

## The attempt to defame Lingbergh

# The Airman or the Carpenter?

"The Lindbergh Baby Kidnapping" (*Instauration*, Feb. 1999) does a service by airing doubts that still fester among members of the Majority as to the justice of Richard Hauptmann's conviction and execution for the crime.

Nevertheless the evidence of Hauptmann's guilt remains overwhelming. Nor can the Majority afford to ignore the evidence that efforts to rehabilitate Hauptmann are part of a larger anti-Majority enterprise to tarnish Charles Lindbergh. Those behind the slanderous move care nothing for the German carpenter. The Lone Eagle is the target because of his life's work for the American Majority and for worldwide white racial betterment and, because by his courage, intelligence, independence and

Nordic demeanor, he personifies everything the haters envy.

Needless to say, Lindbergh's attackers have been unfettered by considerations of decency. One Lindbergh "revisionist," Noel Behn, has argued that Lindbergh was covering up his sister-in-law's murder of the baby.

In *Crime of the Century*, Gregory Ahlgren and Stephen Monier argue that Lindbergh himself killed the child while carrying out a practical joke!

The New York Post's yenta-in-residence, Cindy Adams, has floated the vile rumor that Charles Lindbergh killed his own son for reasons of eugenics.

Majority members who ally themselves with the anti-Lindbergh canaille do so mainly out of sympathy for

Hauptmann (and to a lesser degree, perhaps, out of a predilection for conspiracies, understandable, if not laudable, in a group that is suffering stealthy dispossession). Much of their feeling that Hauptmann was railroaded for the crime is due to a sense of outrage over the crude German-bashing of the press and the chief prosecutor, New Jersey's Jewish attorney general, David Wilentz.

There's no question that the investigation was marred by improprieties, such as Hauptmann's beating by New York City police. The gutter press showed the same bias and invasiveness against Hauptmann that had led to Lindbergh's smoldering anti-media bias. Indeed, had the trial taken place under today's rules, Hauptmann might have walked as insouciantly as O.J. Simpson.

The facts that link Hauptmann to the crime, however, are persuasive. He was caught with nearly \$15,000 from the ransom hidden in his garage in the Bronx. A man tallying with Hauptmann's description had been passing the ransom money in the Bronx and in German neighborhoods of Manhattan for at least a year before Hauptmann's arrest. The various ransom notes had been written in an English heavily influenced by German spelling and grammar. The kidnapper had learned of the eccentric John Condon's offer to serve as a mediator by reading a local Bronx newspaper, and meetings between Condon and the kidnapper took place in the Bronx.

Hauptmann's defenders point to his friendship with an unsavory character by the name of Isidor Fisch. Echoing Hauptmann, they claim it was Fisch who gulled the carpenter into various commodity speculations, then went off to Germany in December 1933, dying there of tuberculosis soon afterwards, leaving Hauptmann in the lurch for about \$5,500. The only consolation, Hauptmann testified, was that the swindler had trustingly left more than \$14,000 of the ransom money, carefully bundled, in Hauptmann's hands, for safekeeping. This explanation the newspapers instantly dubbed the "Fisch story."

It is surprising that members of the Majority who defend Hauptmann's character have not been deterred by his intimate dealings with Fisch or wondered at how, during Germany's "awakening," it was the Jewish *Luftmensch* who found his way to the *Heimat*, while the honest craftsman remained in America speculating in stocks and (of all commodities!) furs. By Hauptmann's own admission, he stopped work as a carpenter a day or two after the Lindbergh ransom was paid, to devote himself entirely to his financial affairs.

Hauptmann may pose less a riddle when his past in Germany is squarely confronted. Despite his defenders' attempts to whittle his criminal record down to a few petty offenses, Hauptmann served nearly four years for burglary, grand larceny and armed robbery in his native country. Shortly after his release in 1923, he was arrested for receiving stolen property, escaped, and entered the U.S. illegally that same year. Hauptmann sentimentalists attempt to exonerate him for robbing, at gunpoint, two Hausfrau wheeling baby carriages—these, they tell us, were carry-

ing groceries, not babies.

More relevant, perhaps, to Hauptmann's criminal career is an incident in 1919, in which he and an accomplice made a daring entry into the home of the burgomaster of Bernbruch at 1:00 a.m., making off with 300 marks and the mayor's watch. They gained access through a second floor window—using a ladder.

Nobody but Hauptmann has ever been persuasively linked to the crime—despite Lindbergh's panicked efforts to enlist the underworld in the attempt to solve the crime by handing gangsters a tracing of the original ransom note.

To be sure, Hauptmann's defenders have pointed to the inevitable imperfections in the state's case—investigative lapses, questionable identifications, changes in testimony—and to such troubling questions as whether Hauptmann's employment records for the day of the kidnapping were falsified.

Even here, however, they fail to convince. For one thing, Hauptmann told the court that he had left work in the morning that fatal day. But even if the records were altered, as seems possible, Hauptmann could have easily enough made it from his workplace in Manhattan by subway to the Bronx and then by car to the Lindberghs' home in Hopewell, New Jersey, within the three-and-a-half-hour time frame.

No skilled carpenter would have made such a ladder? A rung snapped, to be sure, but accidents happen. The ladder was otherwise a skilled contrivance, if not a masterpiece; it was a throwaway, after all. One can be agnostic as to whether the state's expert traced the lumber to Hauptmann's attic or not, but the verdict didn't—and doesn't—depend on it.

With all the best will in the world, it seems impossible to acquit Richard Hauptmann, short of the Johnnie Cochran-style antics that advocates like Behn and the rest resort to. Could he have had accomplices or been set up? If so, we'll likely never know, for Hauptmann kept his silence to the grave. It is even possible to retain a certain admiration for a guilty Hauptmann—assuming the Lindbergh baby died by accident.

Arguably several American presidents in the years since the kidnapping have been viler men and done more wrong than Richard Hauptmann. A hard, brave veteran of some of the most terrible battles in history, Hauptmann took a desperate stab at gaining family wealth, and died rather than confess and shame himself in the eyes of his wife and son.

Who killed the Lindbergh baby? If the choice is to be between the Airman and the Carpenter, as current circumstances surely dictate that it is, we must choose Charles Lindbergh. In death, Hauptmann has become the pawn of our enemies. In the desperate end game in which we of the American Majority find ourselves, we can't afford to exchange a pawn for a knight.

## Who Caused Integration?

Is it reasonable, at this late date, to ask who caused America to suffer the agony of race-mixing in the 1950s and 1960s? One answer might be the power and influence of Wall Street. Back in the postwar 1940s the New York money market was enthralled with the prospects of huge profits to be acquired in replacing British and French colonial states with American-style commercial hegemony. One inhibition to that prospect was America's deep and abiding segregationist tradition. After all, how could Wall Street's emissaries square the provincialism of segregated bathrooms with the new modernist view of race held by the dark-skinned "statesmen" of Third World politics who were then in control of the newly emerging countries of Latin America, Africa and Asia? How could one talk about trade with these dusky leaders when America's own racial outlook was so anachronistic? With Wall Street's offshore investment prospects in the balance, it is not unthinkable that the nation's financial leaders concluded that matters at home must be put in order.

By the early 1950s a nation that had been solidly behind segregation was waking up to find its political, spiritual and educational leaders suddenly in lockstep about integration. A Democratic Party that had historically represented Southern white interests now was openly insulting Dixiecrats. A Republican Party that had only laughed at its own romantic rhetoric regarding "Negro rights" was now pushing for racial integration at the end of a National Guardsman's bayonet. As America's preachers, teachers and poets were speaking about the great moral urgency of race-mixing, Wall Street itself was taking positions favoring integration, both individually and through the powerful voice of nonprofit foundations.

While coincidence does not necessarily imply causality, the lineup of events has a suspicious ring. As the nation moved toward race-blindness, exports soared and Wall Street boomed. As American exports multiplied, so too did imports of automobiles, consumer appliances and clothing.

American industry would soon be transformed into a rust belt of economic decline.

In the 1940s, America's race problem was viewed essentially as a Southern matter. In the 1950s, with the introduction of the automatic cotton picker to Southern agriculture, millions of blacks, finding themselves unemployed, began streaming northward in long bus caravans toward the "freedoms" offered by generous Northern welfare checks. The worm of race had turned. Wall Street's Faustian bargain with exports would become a painful experience for the nation as a whole.

Economic history is replete with references to the evils of Wall Street, traditionally an easy target for political radicals. Rarely, however, had Wall Street been accused of supporting racial integration. But what was to prevent Wall Street from concluding that the racial peccadilloes of the underclass would be a hindrance to its vision of world conquest? Wall Street had the motive, the ability and the will to orchestrate a national sea change on race.

Clearly, Wall Street was not alone. The entire American middle class quickly fell in line behind the decision to integrate. Only blue-collar whites fought until the battle was lost. With National Guardsmen on one side and state troopers on the other, the prole revolt on race in the 1950s was doomed from the start. Blue-collar Americans fought because they knew the stakes involved their jobs, neighborhoods, schools and, even in some cases, their lives.

The middle class was only to learn years later that people don't survive race-mixing. They endure it until escape becomes absolutely necessary. The middle class fled the cities in droves in the 1960s and beyond. Ethnic whites found themselves trapped between a wall of rising housing values on the one hand and declining job opportunities on the other. Wall Street, the great beneficiary of all this, carted away its profits, while allowing the rest of America to foot the bill.

# The Party Isn't Over

Once upon a time Jews and Communists were practically synonymous in Hollywood. Anyone who believes this statement to be overblown should shell out \$25 for *Hollywood Party: How Communism Seduced the American Film Industry in the 1930s and 1940s* by Kenneth Lloyd Billingsley. Most of the early Communist efforts to influence Hollywood centered around labor union organizing. This was an astute move, as labor unions came to control practically all day-to-day production in Hollywood. The first Communist labor organizer there was Jeff Kibre, whose plan was to organize many separate unions into an umbrella organization. His efforts were taken over by Herbert K. Sorrell, who later headed the Communist-dominated Conference of Studio Unions (CSU).

Much of Billingsley's book deals with Sorrell, his crippling strikes and his antagonism to his chief opponent, Roy Brewer, a lifelong New Dealer, who was originally sent to Hollywood to straighten out a jurisdictional dispute between the CSU and the Inter-Alliance of Theatrical Stage Employees. Brewer quickly became aware of the vast Communist clout in the Hollywood unions and moved vigorously to combat it. He emerges as one of the true heroes of the fight against the Hollywood Reds. The 1945 CSU strike against Warner Brothers reads like a horror story of Communist-inspired union hooliganism in downtown Burbank.

*Hollywood Party* recites in abundance the incredibly long but, alas, by no means complete list of Hollywood stars and writers infected with the Communist virus. Betsy Blair, wife of Gene Kelly (*Singin' in the Rain*), wanted to join the Party, but was turned down on the grounds that such an affiliation might harm her husband's public image. Katharine Hepburn frequently appeared at public meetings of the Communist front organization, Progressive Citizens of America, where she read speeches written for her, word-for-word, by CP member Dalton Trumbo. Nor were these isolated examples. Screenwriter Douglas Ogden Stewart, who scripted *The Philadelphia Story*, was an ardent Red, as was his wife, Ellen Winter, the first wife of muckraker Lincoln Steffens. The most influential Holly-

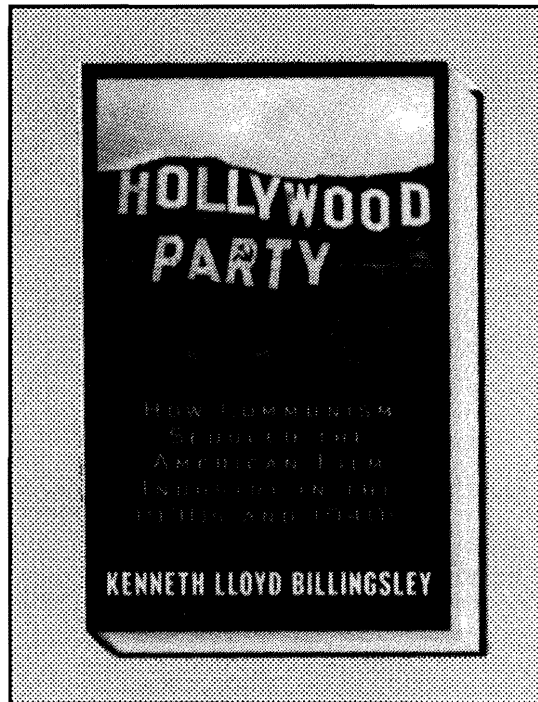
woodians outside of the CSU were the screenwriters, in particular those that came to be known as the Hollywood Ten. They included among their rank Adrian Scott, Albert Maltz, Dalton Trumbo, Ring Lardner Jr. and Lester Cole.

These worthy gentlemen became experts at inserting

Communist propaganda into the movies they worked on. Their technique was never to write movies openly espousing communism. Instead they sought to insert key ideas in a few lines of dialogue, preferably shot in scenes with high-priced stars so that it would be too expensive for the studios to do any reshooting. These Marxists were indeed very talented, such as the mystery novel writer Rex Stout of Nero Wolfe fame. They scripted many "patriotic" WWII films which many older readers may remember. Dalton Trumbo wrote *A Guy Named Joe* and *Thirty Seconds Over Tokyo*. John Howard Lawson, another member of the Hollywood Ten and the party's chief literary enforcer, wrote *Action in the North Atlantic*, *Sahara* and *Counterattack*. Albert Maltz contributed *Pride of the Marines* and *Destination Tokyo*. Al-

vah Bessie and Lester Cole collaborated on *Objective Burma*. In those days the Party line and the anti-Hitler crusade known as WWII meshed quite nicely.

Communism in Hollywood finally came under official investigation in October 1947 when the House un-American Activities Committee, chaired by Parnell Thomas convened. The so-called "unfriendly witnesses" who included the Hollywood Ten, made a mockery of the proceedings as they draped themselves in the First Amendment. They refused to answer questions and belligerently predicted "concentration camps" if the proceedings were allowed to continue. Actor and later director John Houston led a delegation of liberal stars to Washington to protest the persecution of the unfriendly witnesses, but later admitted that he had been badly duped. The congressional investigation resumed in 1951 with HUAC, chaired by Georgia Congressman John Wood, a former member of the 1947 committee. One stool pigeon after another squealed on his Party comrades, leading to repeated use of the Fifth Amendment, including the "diminished" Fifth and the "augmented" Fifth. (The former referred to the "I'm not a Communist now, but I refuse to



say about other times." The latter to "I'm not a Communist now, but I won't say about the past.)

It would be unfair to liberals who for so long have been accurately accused of being the accessories of communism, not to mention that some of the honest variety did stand up to the Hollywood Communists. The director, Elia Kazan, who once belonged to the Party and who trained in the New Deal Communist-front theater of the 1930s, finally left the Communists in the 1950s. His famous *On the Waterfront*, with its dilemma of conscience in "ratting on the boss," was frankly recognized by the Hollywood Communist Party for what it was—a defense of the stool pigeons. Like Roy Brewer, Elia Kazan, a Greek, was one leftist who knew when to draw the line.

The Hollywood Communist Party began to disintegrate during Stalin's purges in Eastern Europe and the revelations by Khrushchev following Uncle Joe's death. Author Billingsley frankly concedes that the liquidation of the Jewish commissars in the Soviet satellite states deeply perturbed Jewish Reds, in and out of Hollywood.

The Hollywood Ten made quite a comeback in the

1960s. Dalton Trumbo authored the script of *Spartacus* and he later worked with Otto Preminger on *Exodus*, two of the chief blockbusters of the time. Ring Lardner Jr. "returned" to script the movie, *Mash*. Albert Maltz wrote *Two Mules for Sister Sara*, starring Clint Eastwood and Shirley MaLaine. As Billingsley correctly points out, the Ten worked steadily under assumed names all the while they were supposedly being blacklisted. They kept their lavish salaries and luxuriant lifestyles. It was those who "ratted" on them who suffered calumny and joblessness.

Billingsley is well aware of the implications of his revelations. He both opens and closes his book by noting that the official Hollywood mythology of the HUAC hearings is precisely that, mythology. Yet Hollywood in films like Woody Allen's *The Front* and Irwin Winkler's *Guilty By Suspicion* continue to preach the increasingly discredited line that innocent men were victims of a witch-hunt. As Elia Kazan's wife, Molly, noted, the comparison was invalid and invidious.

At this time in our history it makes absolutely no sense for us to maintain a military presence in Europe. Bosnia alone is costing us \$3 billion a year.

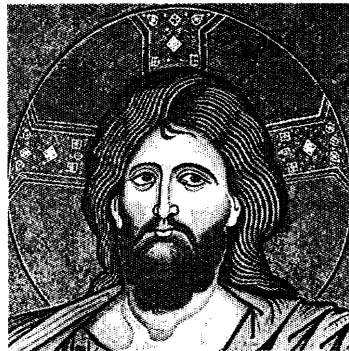

# Plagiarism in the New Testament

Is the story of Jesus historical fact? Should the accounts in the four Gospels be taken literally? For many it is thought to be blasphemy to ask such questions. To question the Holy Bible, the "Divine Word of God," is tantamount to questioning Jehovah's supreme authority. But would it not honor Jehovah, this God of both the Jews and the Christians, if his servants, before accepting his emanating holiness as their God, used their intelligence, with which they claimed He endowed them, to become intellectually conscious of His so-called truths? By doing so they will recognize that His "teachings" are true—rather than to ignorantly and blindly accept for truth the so-called "Divine Word" as written by those fallible hands of its scribes. Questions are thoughts that arise from provoked intelligence. It is ignorance and passive acceptance that numbs the mind. Goulder's book makes this point clear enough. But what about the fascinating story of Jesus? Are the Gospels the literal accounts of the life and death of a Christ? The encyclopedia of early Christianity states: "The life of Jesus is difficult to construct, because the four Gospels are not biographies, but rather documents of faith." What should have been written in the encyclopedia was: "The Gospels are Jewish attempts to interpret in a Jewish way, the life and death of a Jewish man in whom the transcendence of 'God' was believed to have been made manifest." These interpretations were not exact descriptions of what happened historically, not what Jesus actually said or did.



Were His words echoes from the past?

*Liberating the Gospels* by Bishop John Spong explains what Jesus supposedly did and said as embellishments of retold stories of old Jewish tribal heroes. But not, of course, without a divine rationale. Writes Spong:

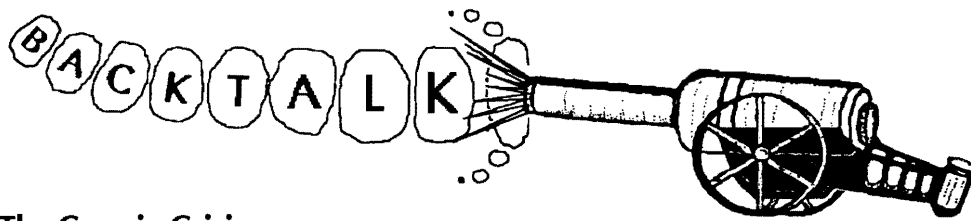
[S]tories about heroes of the Jewish past were heightened and retold, again and again, about heroes of the present moment; not because those same events actually occurred, but because the reality of God revealed in those moments was like the reality of God known in the past.

Putting aside Spong's rationalization for the Gospels' plagiarism, we see hints that the importance of Jesus was described by first-century Jews according to the midrashic principle and followed the liturgical year. He makes clear that the Jewish scribes who wrote the Gospels saw Jesus as an expression of God. In an attempt to heighten His divinity and power, Spong retold older stories of other Jewish heroes, attributing them to the embellished "Christ."

This can easily be confirmed by studying the first five books of the Hebrew bible (the Torah) in contrast to the four Gospels. In Luke one can discover Torah readings of Genesis in his birth narrative. In Zechariah and Elisabeth, the parents of John the Baptist, we find echoes of Abraham and Sarah. Both sets of parents were called Righteous (Gen. 26:5, Luke 1:6). Both Sarah and Elisabeth were barren (Gen. 11:30, Luke 1:7). Both were advanced in age (Gen. 18:11, Luke 1:7). In both stories the angelic annunciation came to a disbelieving father (Gen. 18:11-13, Luke 1:11). Both fathers were assured nothing was impossible with God (Gen. 18:14, Luke 1:37).

The cry from the cross: "My God, my God, why have you forsaken me?" mentioned only in Mark and in Matthew, comes straight out of Psalms 22:1. This piercing appeal to God was probably omitted in the later Gospels of Luke and John because it was thought to violate the enhanced divine status increasingly being attributed to Jesus. Psalms 22:7, 15-18 and Psalms 69:21 provide much more of the material for the crucifixion scene, including the mocking, the vinegar given Jesus to drink, the dividing of the garments and the casting of lots. Another source for the crucifixion events came from Isaiah's so-called suffering servant (Is. 53:3-6).

There are too many examples to list in this short essay. Enough, however, has been said to show that there is much that is not original in the New Testament.



## The Cosmic Crisis

I keep seeing dangerous political myopia in letters and even articles sent to Our Favorite Magazine. I have tried in two former articles to dispel some of this. Lest we get lost in insignificant but amusing sideshows such as the impeachment process, I want to state the danger in such a way that we are forced to face it head on.

Present political trends have called not only the destiny of our people but the future of life itself into question. If these trends run their course, they will endanger all the progress nature has ever made with sapience on earth. For the first time in the history of the planet, a group of living creatures has turned against the most basic evolutionary drives and embraced those that tend toward degeneration, death and extinction.

It is of crucial importance that while we note the ephemeral and sordid events of our present situation we never lose sight of the long view. Liberalism, which energizes this death quest and tries to appear to be of only present social significance, represents a fundamental peril of worldwide proportions. It has the potential to preempt our future choices and terminate the experiment made with sapience and all that goes with it.

We Instaurationists have a pretty good idea of what liberalism means in the short run. We have been far too silent about the horror of its long-term consequences. We talk about our political dispossession becoming complete in the first half of the coming century. But what about our fate over the millennia that follow? Is the time frame so extended or our destiny so macabre as to lie beyond our power to face it?

Let us look at Spengler. His hypothesis was a bombshell, capping centuries of technological and academic progress and introducing to the world the concept of cultures as organic entities with births, periods of development, fulfillment and death. He proposed that laws apply to cultures, analogous to those that govern other aspects of nature, which explain the stages in a culture's life and may be used to predict in a general manner the course a particular culture will take. He saw trends indicative of cultural disease and described the diseases as well as the conditions that might cause them.

Spengler's exhaustively documented *Decline of the*

West spawned controversy that continues to this day. Some, perhaps moved by his pessimism, have set out to disprove him. Others, with agendas that include misdirecting the culture's attention away from knowledge of factors that might lead to its recovery, have done likewise, but for less honest reasons. We are all aware of these people and their mischief.

I am proposing that not only cultures but planets themselves obey a set of laws such as Spengler prescribed. Such a proposal is harder to make with only our one planet to consider. It is as though we were studying a single species of organism, all of whose individuals live together and are not dispersed over different landscapes. In such a setting genetic change will occur over time, but this change will be homogenized throughout the population and will therefore never lead to the evolution of separate races. This does not mean that the dynamics that form races and ultimately separate species is lacking. I only mean that because it does not operate on separate groups we will not be able to see it and can only guess as to its nature or even existence. If we had at least two such groups, each genetically separate, the quiet dynamics of genetic change would work its evolution within each—and races and ultimately species could evolve.

So it may be with planets and the life they support. Because we have only this one planet to study, and even then must force our common sense and creative intellect past the prevarications of academic pirates such as the Boas school of anthropology and its progeny, we are apt to lose sight of the likelihood that laws analogous to those of Spengler govern the painstaking evolution of planets from their most primitive stages through the level ours has attained and on into the destinies that the general laws of the universe make possible; laws that someone able to observe many planets, each with sapient life, might well be able to articulate.

I further propose that such laws will also address diseases that instead of afflicting a high culture will engulf and consume, at least for eons and possibly forever, the life force of an entire planet, rendering impossible, or at least very remote, the chance that natural progress will once again begin to direct the planet's evolution toward the more complex forms it has always pursued.

As planets evolve, certain geological "crises," processes of fairly short duration that result in worldwide cataclysmic change, are known to occur. The "Iron Crisis," whereby the early earth, condensing out of gas clouds orbiting the sun, reached a critical temperature at which iron liquefied and percolated downward toward the center. Another is the "Oxygen Crisis," which changed the nature of the atmosphere to one of oxygen and nitrogen, resulting in the formation of the Silurian "red beds" that are colored by



iron oxide. I am predicting that a crisis of equal proportions is unfolding in line with this simple scenario: sapience evolves to a point where complex societies appear which develop various social and political doctrines often at odds with each other. As the most advanced representatives of any evolutionary feature are invariably in the minority, any factor that will increase their strength runs the risk of conflict with the perceived interests of their more numerous inferiors. In a society in which the majority's wishes are weighed so heavily as to prevail in such conflicts, further evolutionary progress will be retarded or even stopped. Progress will slow and finally cease, reaching a limit beyond which nothing further can evolve. During this process resources amassed since the creation are squandered and unavailable for future crises or opportunities. A microcosm of this horror, in which village lands are overgrazed to the point of uselessness, has been aptly labeled by Garrett Hardin as the "Tragedy of the Commons." A possible reason why we have been unable to detect any signal of intelligent alien life in the universe is that other planets have fallen victim to this same process and are now silent. I believe that what we are witnessing today exemplifies this process. I name it the "Crisis of Liberalism."

As we are discovering, unless some means are found to reduce the social strength of the ordinary "many" relative to the superior "few," the crisis will deepen. If we had a reasonable sample of other planets with sapient denizens to study, we might be able to determine if this phenomenon is the planetary analog of one of Spengler's culture diseases, suggesting policies we should advance and those we should avoid.

But we are denied this course. We are consequently forced into either acting solely on our inductive techniques and educated guesses, born of skeptical and discerning minds willing to face hard truths, or letting the Crisis of Liberalism, through its agents of necrotic change assign to us a destiny of its own choosing. We are already witnessing the beginnings of such a destiny.

We all know liberalism's heritage. It has claimed at least a hundred million lives in this century. Such bloodbaths bode well to be a mere drop in the bucket compared to its potential harvest in the centuries to come. Proponents of this doctrine do not waste their time agonizing over whether or not they are playing God. They implement their social policies by the threat of the Gulag and the point of the bayonet.

Bloodbaths, however, are not liberalism's greatest danger. They are only its most obvious byproduct. If bloodless, liberalism would be even more insidious. It would quietly and gradually derail the rightful destiny of this planet by dulling the evolutionary edge of our species by "racial blending" and "diversity" while sacrificing our irre-

placeable resources for the pointless and increasingly destructive purpose of increasing the human biomass.

Spengler described a culture's final stages as dominated first by economics and then by matters of blood. By the time that economics ceases to drive the culture, enough damage has usually been done so that the blood "cures" that follow are usually too late. As the technical power of Western culture comes to dominate the entire globe, the cultural dynamics becomes applicable to the globe as well, taking Spengler's laws into the realm of cosmology. If we Instaurationists can do nothing else, we must at least fashion a refuge for our best specimens, sacrosanct from the forces of the crisis, until we can emerge and reclaim our lost heritage.

The evolution of living things relies on the will or drive of each individual organism to live, to move forward and to fight against any threat. Even an old tree, pressed to the ground by a storm, sends up living shoots as death envelops it. To lose the will to fight for life is to deserve to die. When the individuals of a race lose their collective will to live, that race is finished. Nature will quickly move such an abomination out of the way and into the peaceful haven of nonexistence. Liberalism, a sinking ship, is proving to have that precise effect on us. It behooves us to swim for our lives lest we be sucked down into the depths. Its effect on our particular race is moving beyond genocide to the even more ghoulish result of geocide.

It is therefore proper for us—indeed, it is our duty—to fight with every ounce of strength we can muster, from propaganda to political strategy to outright physical restraint if so constrained, to assert our right to exist and provide a future for our children and their progeny, as far down the corridor of time as our efforts will reach.

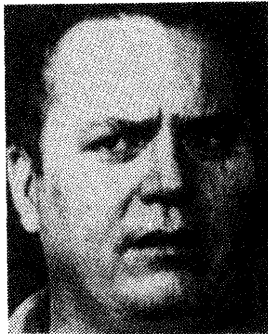
If only bodies going fast

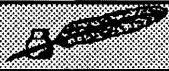

(It was believed that he was in jail, which had become more or less his permanent residence.) Furious, he slashed Gayle Bowman, one of the office workers, in the throat with a butcher knife. He then stabbed office manager William Moore in the forehead and hand. McGee's racial affiliation was not given in the news report, but Instauration would bet a sack of shekels he was black.

Washington's epicanthic-folded governor **Gary Locke** will mobilize 3,000 National Guard troops on December 31, 1999—just in case.

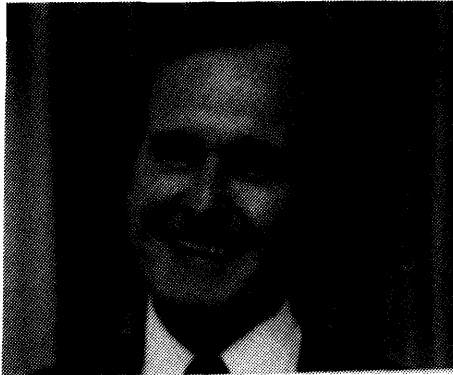

# Notes from the Sceptred Isle—John Nobull

It would be difficult to find a more effective champion for revisionism than David Irving. He gave us an accurate picture of the massive bombing raids on what eventually became the open cities of Germany during WWII. From him we learnt the true scale of the massacre of enormous numbers of refugees at Dresden in 1945, again by British and American bombers. He gave us a clear view of the Hungarian revolution of 1956: the role played by Jews and the way the revolution was exacerbated by the Voice of America, then betrayed by the American government, which invited the Russians to return and crush it.

Irving's biographies of Churchill and the Nazi leaders are both revealing and fascinating. But there is one of his books that worries me: his biography of Joseph Goebbels. It is filled with a personal animus which is the reverse of objective. The actions and thoughts of Josef Goebbels are faithfully recorded, and there is the usual Irvingian attention to diaries and people who had personal contact with the Propaganda Minister. The defect of the biography lies in its extreme animus against Goebbels, which comes out in various ways.

Unlike some revisionists, Irving is legally adept. When he is banned from visiting a particular country (Austria, Australia), he brings a legal action against his banners, usually with some success, though the enemy is always well-funded and ready to renew the litigation. At the moment, Irving is engaged in a battle against the enemies of revisionism, who always defame in order to dominate and destroy. The last I heard of the case, the Board of Deputies of British Jews had been driven into a corner for the time being and was actually pleading poverty to get off the hook! But Irving will need a lot more financial help if he is to win.

Why the animus against Goebbels? I don't think it is just a question of Irving's desire to distance himself from his subject under present circumstances. It goes much further than that. To begin with, Goebbels was an intellectual. This word has little to do with intellect. On the contrary, it means someone who seeks emotional solutions to intellectual problems. Irving is a careful and meticulous historian who usually allows the facts to speak for themselves. But where Goebbels is concerned, he goes out of his way to belittle and denigrate him. The fact remains that the Nazi *Machtergreifung* would never have been possible on the basis of an objective assessment. Even more important than the key part played by Goering in winning over the Prussian upper class was the brilliant exploitation by

Goebbels of the murder by Communists of young Horst Wessel. The haunting melody of the *Horst Wessel Lied* was a major influence in bringing Hitler to power. The Poles claim the tune as their own (rightly it seems), but it was Goebbels who saw its enormous political possibilities.

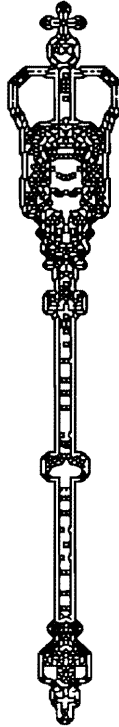
Another obvious reason for the bad chemistry between Irving and Goebbels is that Goebbels was what the British *class dirigeante* call a "squinge": a small and unprepossessing person. There is little or no attention given to his winning ways. Diana Mosley found him "very clever" and loved his wife, Magda. Tellingly, Goebbels preferred the company of a Czech film actress, who was much less attractive than Magda but perhaps had more oomph. It was Hitler who put the kibosh on Goebbels' desire to be divorced.

Back in the 1920s, William Sheldon showed us that physical and mental characteristics have a strong tendency to go together. Irving is a fine figure of a man, with a marked preference for pretty ladies. His present companion is a beautiful Dane, whose family strongly disapprove of her paramour's political stance. The only mystery is how he manages to write so much. He probably uses Napoleon's argument. "Ask of me anything but time." What matters most of all is that he has children and is fond of them. A good life is the best revenge.

Irving has made many copies of a photograph showing his father, also a fine figure of a man, standing between the big guns of the ship he commanded on the dangerous Murmansk convoys. Irving frequently uses the imagery of torpedoes to underline his (well justified) self-identification with his father.

Hitler came to power because he made best use of the human material at hand. It would be hard to imagine a greater contrast than that between Goering and Goebbels. They disliked each other heartily and it was Goebbels who won out by becoming, for a few hours, Chancellor of the Reich. (When Goering, down in southern Germany, had tried to claim the same position, Hitler [ineffectually] ordered his arrest as a traitor.) He did the same when Himmler was about to try it.

The most telling argument against Irving's animus towards Goebbels is the fact that *Doctor Goebbels*, published in 1960 by two Jews called Manvell and Frankel, presents a much fairer assessment of Goebbels' achievement than Irving's. But their praise of Goebbels is at the expense of other Nazis, including the brave woman flyer, Hanna Reitsch

And what were their harrowing tails of temptation “all” about? Sainly Simeon Stylites sat for 40 years atop a 70-foot-high pillar near Antioch (now there’s a phallic symbol for you!).

D.H. Lawrence is cited as another of the “greats” of 20th-century literature. So what is *Lady Chatterly’s Lover* “all” about? *Sons and Lovers*? *Women in Love*? (Read his story, *The Horse Dealer’s Daughter*, if Freudian novels are not your subconscious taste.)

Since brevity is supposed to be the soul of wit, let’s

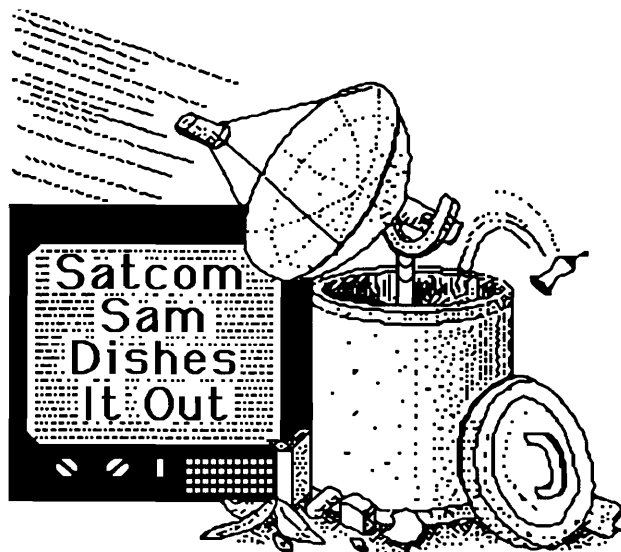

Morris Seligman Dees's supersnooping Southern Poverty Law Center declaims that there are now more than 250 hate groups on the Internet. Maybe so. The question is, when are these self-appointed monitors going to be sued for invasion of privacy? Dees and the ADL keep screaming about hate, but aren't they themselves the loudest haters?

PBS received four stars for its fawning documentary on the life of Paul Robeson, not a fellow traveler but an unreconstructed member of the Communist Party. Robeson had a great voice, but he hardly deserved the encomia PBS bestowed upon him. Basically a shoddy character, Robeson expended much of his energy chasing white women, the whiter the better. Frequently succumbing to bouts of paranoia, he ended his life by suicide. His son was as conspiracy minded as Mrs. Clinton, claiming that his father was fed LSD-type drugs by "intelligence agents."

The Federal Communications Commission, so far unsuccessfully, has been trying to get Congress to approve a measure to force advertisers to buy more time on minority radio stations. According to William Kennard, Negro head of the FCC, minority stations get a disproportionate 29% less of "all-race" radio's advertising dollar.

In the last three months of 1998 six shows were the choices of both races: *ER*, *60 Minutes*, *Monday Night Football*, *Touched By an Angel*, *NYPD Blue* and the *CBS Sunday Movie*.

It's getting more gooey every minute. The *Ally McBeal* show features a lot of black and white romancing. Lingering interracial smooching is commonplace. *From a Canadian Subscriber.* Even if you don't watch a lot of television, you have probably become aware of the ever-increasing denigration of the Majority male in TV commercials. Whether these 30-second blurbs are trying to sell drain cleaners, lawn mowers or computers, they invariably depict a ham-fisted, bumbling, incompetent white male who cannot deal with the problem at hand until a totally-in-control female comes along to show him which buttons to press.

It is always the white male who is the stooge. Never do we see any dopey white females or, God forbid, any displays of black, Oriental or Hispanic female stupidity. The message—it's never a subtle one—is always the same: men are idiots; women know exactly what they are doing. The number of TV ads running down white males is in direct proportion to the number of diehard feminists employed by any given advertising agency.

Men in movies are shown as weak, indecisive, mental basketcases who constantly look for a woman to turn to or a shoulder to cry on. Compare these weak-kneed ninnys to the characters once played by Gable, Peck, Cooper and Burt Lancaster. You will see how we have devolved into this present-day feminized state. Where once that lone cowboy up on the silver screen rode out to wreak vengeance on the villains who had gunned down his best friend, he would now be escorted to a room filled with grief counselors urging him to let it all hang out. **Canada.** *From a subscriber.* In a culmination of events that began in 1993, Canadian Jews have finally had Doug Collins convicted under British Columbia's infamous censorship law. In February the B.C. Human Rights Commission fined the retired columnist and his former employer, Vancouver's North Shore News, \$2,000 for "exposing Jewish people to hatred or contempt." A similar charge by the Canadian Jewish Congress was leveled at Collins in 1997, together with a string of invective from the commission. Surprisingly there was no conviction. The litigation, however, did cost the defendants a cool \$200,000 (Canadian) legal bill.

The new charge concerned not only Collins' famous "Swindler's List" column from the earlier complaint, but three other columns. A one-man tribunal ruled that individually the mordant essays did not violate the law. But taken together,

they convey notions that Jews conspire to manipulate society's most important institutions for their own gain; and that, through control of the media, they have perpetrated a massive fraud to exaggerate their suffering during the Holocaust. The Jews are portrayed as selfish, greedy and manipulative.

The commission ordered the \$2,000 to be paid to the complainant, B'nai B'rith Harry Abrams. The inquisitors did not address Abrams' other grievance, in which he asserted that right-wing extremists were keeping him under surveillance and recording his conversations.

The defendants boycotted the proceedings, which Collins described accurately as a "kangaroo court" where truth is no defense, normal rules of evidence don't apply and impressions count more than fact. All the legal folderol derived from British Columbia's Bill 33, enacted with Collins in mind. So far he is the only individual convicted under this muzzling law.

The tribunal also ordered the North Shore News to print a summary of the judgment and barred the paper and Collins from publishing any further statements that may upset Jews.

Collins, needless to say, is unrepentant. He adamantly insists that he would write the same columns again: "I would do so under the principle that freedom of speech is important and we should be able to criticize anyone or anything."

The tribunal's decision also appears to ban Collins' recently published collection

of columns, "Here We Go Again." For the time being at least, it's available for \$15 plus \$5 shipping and handling from Doug Collins, P.O. Box 91831, West Vancouver, B.C., Canada V7V 4S1.

In an interview (Feb. 21, 1999) with CBC-Radio's Michael Enright, black poet George Eliot MacDonald opined, after condemning white resistance to colored immigrants, that the newcomers have made a great contribution to Canadian culture. MacDonald went on: "In fact, the most intelligent and sophisticated men in Canada today are black men!" No important public figure dared contradict this egregious efflux of Negro racism.

Each AIDS case in Canada costs taxpayers \$18,000 a year. The government has finally said it will review its policy of welcoming into the country every full-blown sufferer of the lethal and highly contagious disease. Can any sane person doubt that liberalism is some form of madness? The darkening of Canada is now so advanced even the torpid masses are murmuring—in private, of course.

**Britain.** Britain is staging its first war crimes trial. The defendant is the disabled Anthony Sowoniuk, 77, who is accused of murdering four Jews 56 years ago in what is now Belarus. The Holocaust lobby has succeed in corrupting what was once the world's least unjust legal system.

Jews represent about 0.5% of the population of the Sceptred Isle, yet the Jewish component of contemporary British culture is enormous. The latest evidence of this is *Kosher Sex*, a book written by American Rabbi Shmuley Boteach. The work, now in its 7th printing in England, has been recently published in the U.S. Rabbi Boteach is notorious for promoting "dirty sex." In spite of his tendentious sleaze, he has lots of boosters. The most prominent is the Jewish religious potentate, Chief Rabbi Jonathan Sacks, who glowingly endorsed the book, which is one more Jewish attack on the very fabric of Western civilization.

*The Worship Book* for British Methodists has as an alternate invocation, "Our Father and Mother and God."

Speaking of God, British churches are now displaying a portrait of the late Marxist insurrectionist, Che Guevara, wearing

a crown of thorns instead of his trademarked beret. Some churches in Britain are getting so permissive that they are making room for dyed-in-the-wool atheists.

Two of the five law lords in the panel that approved the extradition to Spain of Chile's ex-president, General Augusto Pinochet, were by no means impartial. One, Lord Hoffman, was deeply involved with Amnesty, the organization that pressed hardest for Pinochet's extradition. Lord Steyn, the other Jewish law lord, is chairman of Britain's Race Relations Committee. Both these appointed milords came from South Africa. Now that apartheid, which they hated so much, has been ended, why don't they return to whence they came?

Conservative papers made such a row about the biases of Hoffman and Steyn that the panel was dismissed and a new tribunal impaneled.

Home Secretary Jack Straw bears the ultimate responsibility for General Pinochet's fate. If he so chooses, he can overrule the decision of the law lords. Brits who want to let Pinochet return to Chile unscathed should keep their fingers crossed. Straw has some Chosenite genes.

Britain's prominent Amery family was ideologically divided. Leopold wrote the Balfour Declaration, which provided for the establishment of a Jewish homeland in Palestine and triggered unending violence that could possibly culminate in WWII. John, Leopold's son, was infatuated with Nazism and moved to Germany. After WWII the British arrested him and hanged him for treason. Julian, the other son, was, like his father, a leading Churchillian warmonger.

The Amery family was recently in the news when William Rubinstein, a professor of modern history at the University of Wales, digging in dusty, moldering documents, discovered that Leopold's mother was a Hungarian Jewess. Britain's Jewish establishment made much of the fact that a "secret Jew" had been all his life in the highest echelons of the British government.

**Holland.** When an Israeli jumbo jet crashed into a populous area of Amsterdam in 1992, killing 43, a typical Zionist coverup moved into high gear. As the wreckage was still smoldering and emitting poisonous fumes, Israeli agents appeared in protective clothing and practically took over the site. That's probably the reason the voice recorder was never found, along with some important docu-



ments. Dutch authorities cooperated wholeheartedly with the Israelis, even while the people in the neighborhood were exposed to all kinds of lethal diseases, some of which Dutch doctors still don't know how to treat. Ten years later the suppressed story is leaking out in the Dutch press. Had the people been informed about the cargo, some of which was the stuff of which nerve gas is made, many more lives would have been saved. Everyone would have been cleared from the contaminated area immediately.

**France.** Ira Einhorn, the Jewish subhuman who murdered a pretty young blonde from Texas and kept her body in a trunk in his closet for 18 months, will be allowed to be extradited to the U.S., according to a ruling of the French court. Meanwhile, French authorities are letting him go free, a rather risky privilege for someone who has already jumped bail back in the States and who has vowed he will never serve time behind bars. In return for granting extradition, the French court demanded that American prosecutors give Einhorn a new trial. (He was convicted in absentia in Philadelphia.) The French legal beagles also demanded that if found guilty he would not receive the death penalty. The case is under appeal.

In the inner turmoil now plaguing the Front National, one of Le Pen's three daughters has sided with Bruno Mégret, the erstwhile second-in-command who wants to be first-in-command. Of the four cities controlled by the Front, two have stuck with Le Pen and two have drifted to Mégret's rump party. So far Le Pen seems to be weathering the storm.

**Germany.** Latest Holocaust howler! In his documentary, *The Last Days*, Steven (Schindler's List) Spielberg has collected the personal reminiscences of five concentration camp graduates. One, a Jewish lady, recounts how she saved her diamonds by swallowing them at night and retrieving them in the latrine the next day. Of all the Holocaust tales, this is certainly the smelliest.

Germany's new chancellor, Gerhard Schröder, has introduced legislation that would allow millions of Turkish and other immigrants to have dual nationality and hence become German citizens. The proposal caused such a political backlash

that it had to be withdrawn. A German continues to be defined as a person born of German parents.

**Italy.** Erich Priebke, the SS officer in charge of killing 335 Italian civilians in retaliation for a partisan attack that murdered 77 German soldiers, has finally been released from jail and placed under house arrest. Priebke was first cleared of war crimes by an Italian military court, which inspired Italian lawmen to resort to double jeopardy by hauling him into a civil court, where he was found guilty. Having been in one jail or another for ages, it's not surprising that the 86-year-old man is ailing. Priebke is not likely to enjoy his limited freedom for long.

Italian lawmakers have idiotically ruled that a woman who wears tight jeans cannot be raped unless she herself helps to remove them. Otherwise, if her attacker persists, the Levi look-alikes glued to her body would provide so much armor that any potential rapist would have great trouble in achieving his goal. Italian female pols are so incensed at the ruling that they have promised to wear jeans at all legislative sessions until the law is changed.

**Kosovo.** From a correspondent. News reports tell us that President Clinton is considering deploying 4,000 U.S. troops as part of a NATO contingent in Kosovo. Anyone who reads the history of the German army in Yugoslavia in WWII would think twice before committing ground forces there.

The Yugoslavian resistance movement in WWII was a medley of Communists, Catholics, Protestants, Muslims and liberal agnostics. Although the Germans officially occupied the country, they never subdued it. At one point there were nine German divisions and six Italian divisions attacking the partisans. The mountainous and heavily wooded terrain was ideal for guerrilla warfare. The partisans eventually triumphed and the Axis forces departed, suffering heavy casualties.

Serbianians have been fighting with their Balkan neighbors for generations. As a result, many are seasoned soldiers. Pitting feminized, politically correct U.S. troops against a tough, savvy guerrilla force will be far different than what Americans have been facing in Iraq, where the Iraqi infantry is a joke and superior U.S. air power monopolizes the skies.

**Russia.** The big news in Russia continues to focus on General Albert Makashov, the Communist Party delegate who has been saying unkindly things about Jews. All kinds of ways have been proposed to punish Makashov, such as arresting him or expelling him from the Duma. But the plans have been scuttled by the reluctance of the Communists to join the crusade.

A recent speech by Makashov proposed that the Jewish participation in government, business and the media be proportional to the Jewish share of the population. The very thought drives Jews up the wall.

A public opinion poll (1,509 respondents) on the Jewish question found 15% approved Makashov's statements; and 51% opposed. Some 34% would limit the number of Jews in top-level jobs; 54% opposed; 23% did not deign to answer. Close to one-quarter reacted positively when asked how they would feel if Russia had a Jewish president; 64% reacted negatively.

Russian ambassador to Israel, Mikhail Bogdanov, stated: "We asked Israel to help us stop the smuggling of prostitutes . . . To our regret, we have not met with much response." He admitted that Israel treats Russian women badly, especially those with fair hair.

The Union of Councils for Soviet Jews, which monitors human rights in Russia, is due to receive \$535 million from the U.S. State Dept.

**Israel.** Those truth-tellers who dare say that Israel is a safe house for Jewish criminals from all parts of the world are automatically put down as anti-Semites. So what about Samuel Sheinbein, who murdered and dismembered a young Hispanic in Maryland, then took off for Israel? The Israeli Supreme Court has now ruled he cannot be extradited because his father is an Israeli citizen, which makes him one, although Sam has never lived in Israel. Israelis claim that Sheinbein will be given a fair trial. But will he? The mother of the young Hispanic murdered by Sheinbein is demanding some action from the U.S. government. Fat chance!

Against all entreaties and appeals of U.S. diplomatic authorities, Israel continues to pirate U.S. intellectual property in the form of software, music and compact discs. The International Intellectual Property Alliance, which lobbies for copyright protection, this week asked U.S. Trade



Representative Charlene Barshefsky (they're everywhere) to name Israel a "priority foreign country," a provision which would give Israel six months to take action or face sanctions. According to the Business Software Alliance, nearly 70% of all software installed on computers in Israeli businesses in 1996 was illegal. Even Deborah Schwartz (they're everywhere), economic affairs counselor at the U.S. Embassy in Tel Aviv, calls what is taking place in Israel plain burglary. However, given Israel's past economic trade record and the fact that U.S. policy toward Israel is heavily influenced by American Zionists, Israel can be expected to continue along its deceitful way.

Israeli "folk hero" Ehud Tannenbaum, 19, and four younger defendants have been indicted in Israel for vandalizing Pentagon and U.S. Army Internet websites. Using the code name "Analyzer," the hacker successfully broke into U.S. military computer systems and inserted unauthorized software, damaging the sites. Prime Minister Netanyahu has called the Jewish thieves' exploits impressive.

Unconfirmed but recurrent reports state that the Biological Institute in Nes Tziyona, an Israeli germ warfare research center, is trying to develop an "ethnic bomb" capable of killing members of races that do not have specifically Jewish genes. Converts to Judaism would not be spared. Since many Jews and Arabs stem from similar Semitic origins, the identification problem would not always be easy. Many modern Jews are actually not even of Semitic origin, but rather are descendants of Turkic, Slavic and European ancestors. So Jewish biologists have their work cut out for them.

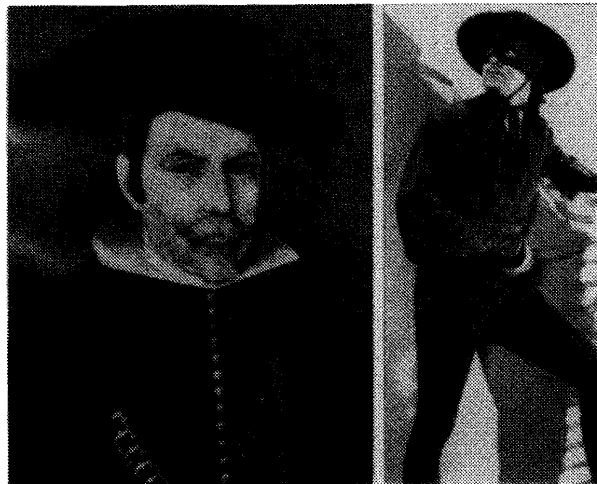

In South Africa a ten-man gang of blacks robbed 19 Americans as they were watching a play in a pre-school. They were forced to give up their passports, jewelry and cameras. White colonialism and apartheid were the glue that held most of Africa together. Without them there is creeping chaos and lawlessness. Large numbers of whites are racing to get out. Conrad's "The horror" is becoming more horrible than ever.

**Mexico.** Zorro, the slapdash hero of many a movie and folk tale, is generally

portrayed as a Spanish aristocrat, a sort of upscale Robin Hood, who fights for the downtrodden. Recent historical researchers in the Vatican archives have discovered that the real Zorro was actually a bearded, red-haired Irishman named William Lamport, who was sentenced to be burned alive in Mexico City in 1659. At the last moment he foiled his jailors by strangling himself with the rope destined to tie him to the stake.

**Panama.** Even though a government spokesman has attempted to reassure Americans that the surrender of the Panama Canal to Panamanians later this year is not a matter of great concern because it is no longer vital to U.S. interests, most Americans who graduated from high school before 1970 remain unconvinced. No piece of American real estate is more closely associated with Manifest Destiny. Unlike other less glorious achievements of the day, the Canal showed the world the good sense, the industrial might and the determination of the American people. If the Canal, as government spokesmen say, is no longer crucial, why do countries, like Nicaragua, consider building their own trans-isthmus canal? Why are so imminently ambitious plans afloat to convert the Panama Canal Zone into another Singapore, another banking emporium? The Canal should never have been surrendered to local *bandidos*.
