Chicago Mayor's Race Gauges White Racism In America

With a record turnout of 1.2 million votes cast Jane Byrne polled 33.5%, Richard Daley, 29.8% and negro Harold Washington won with only 36.3%. Others threatened blacks would burn down Chicago unless Washington won.

Washington won the primary with only 36% of the vote and no Republican had been elected mayor in 52 years. An all out black voter registration drive added over 200,000 blacks to the voting rolls and this provided Washington with his primary victory. Whites who did not want Washington were called "racists" and both the formerly conservative (but not extremely left-wing) Chicago Tribune and Sun-Times endorsed Washington. In the primary 84% of the blacks voted for Washington but according to the media they were not racists. Only Whites who refuse to vote for a black are the racists! This is typical liberal self-hate logic.

Harold Washington has a long criminal record. He was twice disbarred for swindling black clients out of legal fees and failing to perform tasks he was paid for. In 1972 Washington was convicted of not filing his income tax for four years. He was fined \$1,036 and sent to jail for 40 days. Washington has stated he will fire the White police commissioner and replace many other White Chicago city employees. In other words Washington would like to turn this city of three million into a mass White exodus which will quickly result in another Newark, N. J., Gary, Ind., East St. Louis, Ill., or Benton Harbor, Mich. – ALL CITIES WHICH HAVE BEEN TOTALLY DESTROYED BY BLACK POWER RULE.

"Winds of War" took 13 months to film and was the most costly "docudrama" to date costing \$40 million. Jew Herman Wouk wrote the book upon which the film is based. The Producer-Director was the Jew Dan Curtis and it was financed by ABC-TV which is headed by Jew Leonard Goldstein. It should be noted that while Herman Wouk says he hates war he brags that his son Joseph fought in the Israeli navy against Lebanon during the so-called "Peace For Galilee" massacre of thousands of innocent people. One of the so-called "most memorable scenes" in Winds is when the "evil" Germans are trying to separate the Jews from the Gentiles and a Christian says "we are all Jews." (Note: Rev. 

Reagan Mentioned "Jesus" – Brings Down Wrath of Jews Kosher Kitchen Saves Jew Convicts From Dangerous Prisons

Jewish Leaders Denounce Reagan Morality Talk Below from "Jewish Week" March 25 By BEN GALLOB

President Reagan's recent assertion that belief in God should make Americans solidly back his opposition to a nuclear freeze and support his program for a massive military buildup has come under stinging denunciation from leaders of the three major branches of Judaism.

The Jewish religious leaders, in response to a Jewish Telegraphic Agency survey, said the use by the president of moral absolutes <u>"in the name of Jesus" was morally offensive and possibly a violation of his constitutional obligations</u>. They added that castigation of the Soviet Union as the "focus of evil" might unwittingly bring about the catastrophe of a nuclear holocaust and they said that it

implied an attempt to silence opposition to the president's policies, including his strong support of prayer in the public schools. It also threatened the nation's religious pluralism, they said. Jews Attack Pres. Reagan For "Invoking The Name of Jesus"

Attention Rev. Jerry Falwell: Your long held view that Jews sincerely support fundamental Christianity has been dissolved once again. This time the Jews attacked the President of the United States for using the name of Jesus Christ when

Special Federal Prison For Jews

Racially integrated prisons are dangerous places. Murder, homo-rape, beatings, knifings and robbery are common. Whites are most frequently the victims. We have reported cases in both New York City and Miami where Jews, convicted of serious offenses, were granted probation by Jewish judges because incarcerating them in jails which are mostly colored, would be too dangerous.

The organized Jew community in America has far more influence than any and all other groups - combined! Thus special privileges are even granted to convicted Jew felons who have been sentenced to federal prison. Jew leaders have made arrangements to protect their fellow Jews inside prison – a protection system which is not extended to any other racial or ethnic group. Chicago's "Jewish Sentinel" of Feb. 10 carries an extremely revealing article which states that convicted Jews who want a safe prison must request that their "religious requirements" only allows them to eat kosher food. The federal government has installed a kosher kitchen only in the Allenwood, Penn. institution. This is equal distance from New York, Philadelphia and Washington, D.C. and makes easy driving for relatives and business associates. Most important of all, Allenwood is a minimum security, no-fence, no guard or towers prison. Most Gentiles there are good behavior prisoners and ready for release. Thus Allenwood is one of the safest such places in the country because most prisoners do not wish trouble just prior to release. BUT, LONG TERM JEW PRISONERS ARE HELD HERE BECAUSE THEY WANT THE SAFETY THE PLACE AFFORDS. Some 75 Jews are currently serving time in Allenwood. The Jewish Sentinel quotes inmate Stephen M as explaining:

one another. Men who had never gone to A (synagogue) in their lives attend. We try to get the best jobs in the camp for one another and run an 'old boys' network. Without the kosher kitchen some would face harsher incarceration. With this in mind there is always a drive to keep the kosher kitchen. We have a dining room (Jews are served their kosher meals separately), a conference room and a gym. At the last seder over 100 people attended including families."

Rabbi Alexander Schindler, president of the Union of American Hebrew Congregations, the association of Reform synagogues, said that "the invoking of moral absolutes in the name of Jesus" were "offensive when they are voiced by the President of the United States." He added that they were, "in fact, a violation of his constitutional obligation to be president of all Americans, regardless of religious persuasion."

President invokes Jesus

Reagan made his remarks in a speech March 7 in Orlando to the National Association of Evangelicals, an organization of conservative churches and agencies.

He said "there is sin and evil in the world and we are enjoined by Scripture and the Lord Jesus to oppose it with

all our might." He said Soviet Communism "is the focus of evil in the modern world" and that those favoring a mutual freeze on nuclear weapons were ignoring <u>"the aggres-</u> sive instincts of an evil empire."

Rabbi Arnold Goodman, president of the Rabbinical Assembly, the international association of Conservative rabbis, said the nuclear freeze issue stemmed from "a deep concern that the world may be heading for a holocaust of its own making," and that the Jewish tradition, "with its concern for life, obviously has a contribution to make to the overall deliberations" on that overriding issue.

No Similar Protection For White Christians

Why is it that White Christian prisoners cannot demand special minimum security prisons where they can be safe from colored attack? Of course, nothing of the sort would be granted. Since the Jews are allowed this "segregation" and protection from dangerous inmates the least we can demand is separation of the races. Under Segregation of the races we had peace and tranquility both inside and outside of prisons. The Separation of the races is the law of God and nature. The time has come for us to recognize this simple fact of life. If Jew criminals can suddenly become "religious" and have their own special Kosher kitchen "safe" prisons, then special prisons for White Christians should be established. We wonder if Rev. 'We will not be silenced'

Goodman asserted "we will not be silenced and we will join with our fellow clergy here and throughout the free world in continuing to sensitize our society and our political leaders to moral concerns."

He agreed with the president that all Americans must oppose "sin and evil" in the world, a duty "mandated by our Torah and our teachings." But he declared he found it "regrettable" that the president, "who represents all the people," had chosen to "limit his sources of inspiration" for his call to battle sin and evil "to Christian doctrine."

Marshall Wolke, president of the United Synagogue of America, the central agency for Conservative congregations, and Rabbi Benjamin Kreitman, executive vice president, condemned the president for asserting that his opposition to a nuclear freeze "was based on a true interpretation of Christanity" and for his attack on "the liberal religious community, Christian and Jewish, who differed with his point of view on the nuclear proliferation treaties and procedures."

They said "the assumption of authority for the only authentic interpretation of the religious message," which they described as historically "one of the most serious abuses of religion," was an abuse "that strikes at the heart of <u>religious pluralism</u> on which our nation was founded." Wolke and Kreitman declared that the President "had no right to intrude his religious point of view into a discussion of a politically sensitive matter, nor to usurp for himself divine approval of that point of view." They said that, as president of all the people "and of all religious points of view," Reagan "must respect the authenticity of that diversity."

White Lady Ordered To Give Her Business To Blacks!

Rebuffed blacks get beauty shop

The white owner of a downtown Akron beauty parlor has agreed to turn over her business to two black women in an out-ofcourt settlement of a \$150,000 racial discrimination lawsuit.

Kathleen Salyard, operator of Kathleen's at 74 Mill St., also agreed to pay the women \$2,500 in damages.

The beauty parlor is valued at \$5,000, according to an agreement filed Tuesday in U.S. District Judge Sam Bell's court.

The two women said they left with the understanding they would talk the sale over with their husbands. When they called the next day to make an offer, Miss Salyard told them an employee had already bought the business, they said.

The women then complained to the Fair Housing Contact Service of Akron, an agency that investigates racial discrimination charges.

The agency sent two white investigators to the salon. According to earlier testimony in the case, the investigators were told the beauty parlor was still for sale.

Bell had temporarily barred Miss Sal-

Court Takes Business From White Woman And **Gives It to Black Women To Settle Civil Rights Suit**

Akron, Ohio beauty parlor owner Kathleen Salyard enjoyed her popular business for 10 years. Then two black women, Elizabeth Small and Sandra Ivery, sought to buy "Kathleen's Beauty Parlor" when they heard it was for sale. Mrs. Salyard decided to sell the business and use the proceeds of years of hard work for her retirement. Since all her customers are White ladies she told the two black women it was not for sale to them. They went to the state run "Fair Housing Contact Service" which sent two White traitor spies to see if the business was for sale. Unknown to her she had run afoul of the vicious "anti-discrimination laws." This practice has been approved by direct orders of the U.S. Supreme Court. A

civil rights group filed suit against Mrs. Salyard. U.S. Federal Judge Sam Bell found her guilty. She was ordered to pay the two black women \$150,000 in damages. Of course she didn't have the money so the judge ordered her to settle the case by giving the two black woman her business FREE OF CHARGE as "settlement of the case." AND MANY SLEEPING CITIZENS THINK THEY STILL LIVE IN A FREE

The suit filed Feb. 1 by Elizabeth Small of Kent and Sandra Ivery of Akron claimed they were denied the right to buy the beauty parlor because they are black.

Miss Salyard, who operated the business for 10 years, was trying to sell it because she planned to retire, according to her attorney, Lee Davies.

ACCORDING to Mrs. Small, she and Mrs. Ivery made an appointment with Miss Salyard after seeing the business advertised in the newspaper. In a Jan. 10 meeting, Miss Salyard told them the beauty parlor's equipment was for sale for \$5,000, Mrs. Small said.



CHOMSKY SAID THAT "As long as the United States and Israel pursue a rejectionist position there is a near guarantee . . . of more wars for Isreel (in order) to prevent other countriess from invading it. These wars are dangerous in terms of superpower confrontation."

"My primary concern in U.S. policy is how it can be improved and its impact on other people . . . Israel has chosen the course of a parasite state. This is a dangerous path," he said.

CHOMSKY CONSIDERED remarks like "You are not doing anything to protect the Jewish people" as racist comments. "I am concerned with the right of human beings . . . The PLO has the same legitimacy as the state of Israel," he noted.

Chomsky said he has "no love for the state of Israel or for any other state. States are violent and Israel is no exception.








The first of these incorrect assumptions is: 'All democracies, by their nature, are good for Jews and all dictatorships are anti-Semitic.' While I personally favor democracy, the fact is that the above assumption is not true. Democracies reflect the common will of the majority of the citizens of a nation, and majorities are not always right, moral or tolerant. One need only recall that Hitler was elected in a democratic election, Dreyfus was tried and found guilty during the French Third Republic, and the Klan is allowed to live in the freedom offered it by the United States.







Miami Riots Now Played Down Miami has so many riots now that it is no longer considered "national news." On March 13, local black residents in the Liberty City area complained they could not sleep because of a street disco party. When police arrived to check out the complaint they were attacked by the mob. The disco was given by local drug dealers and the party goers went wild. Rocks and bottles smashed through police car windows. Then some 500 young blacks began to loot local stores and overturn cars — as is usual during negro protest demonstrations in Miami. The rioting went on for two days. Miami's Overtown area was the scene of severe rioting Dec. 28 with two people killed, 26 injured, dozens of businesses looted and burned during three days of rioting. Large numbers were in Miami was in May 1980 when 18 were killed, hundreds arrested in four days of rioting which resulted in over \$100 million in property damages. Overturned burned car after Miami racket.



Negroes Attack Police At Funeral

Montgomery, Ala. police officers were pursuing a suspect when he ran into an area where a negro funeral had just taken place. The mourners suddenly attacked the police! Officer Les Brown was shot twice and for a time was in critical condition. Officer E. B. Spivey had his throat slashed from ear to ear requiring 135 stitches to save his life. The officers were held, beaten and tortured until rescued by police reinforcements.

The FBI is now investigating whether or not the civil rights of 11 black "mourners" were violated by the arrests. In the meantime, Judge Craig Miller released seven of the black defendants for "lack of evidence." All were from Ohio or Michigan. Still charged with attempted murder are Willie Taylor, Sr., 47, and Larry Gene Hill, 27, of Pontiac, Mich., along with Worrie Taylor, 49, and Elbert Taylor, 50, of Warren, Ohio. Some of the blacks were still wearing their choir robes when they attacked the police. Worrie Taylor has confessed he shot Officer Brown as he was trying to flee. **Blacks Acted Like** "Wild Animals"



ADL Hate Laws Threaten Freedom In America

The Jewish Anti-Defamation League has drawn up what they describe as a "model law" which will make such acts as "racism," anti-Semitism, and vandalism felonies instead of misdemeanors. In most states a youth under age 18 (the group police state commit most such acts) would be subject to 5 years in prison and a \$5,000 fine. Presently the penalty is up to 1 year in prison and a \$1,000 fine is not recorded as a felony on the youth's record.

Those who read the ADL's model law will find that any type of graffiti or even what the Jews refer to as "verbal anti-Semitism" is covered by the "Anti-Hate Laws." The ADL stated that their findings indicate a 15% drop in "anti-Semitic" incidents since 1981. They listed 829 in-




cidents of which only 197 were directed against synagogues, Jew Community Centers and other similar buildings. The public and legislators are led to believe that the 197 buildings were bombed or burned, etc. That is Jewish propaganda the ADL is talking about such as graffiti smearings and broken windows where damage was negligible.

Atlanta ADL head, Stu Lewengrub recently let the cat out of the bag when he quietly revealed that a total of 829 "anti-Semitic" incidents (phone calls and the like) were made to Jewish agencies nationwide. In other words, when you protest the senseless murder of innocent civilians in Palestinian refugee camps in Lebanon by calling some Jew group listed in the phone book to declare "Jews must stop killing Gentiles in Lebanon," the Jew listening marks down "another vicious anti-Semitic phone call." At the end of the month the ADL collects such data and this is what makes up the vast majority of the so-called anti-Semitic incidents in their highly publicized 829 figure.

Anti-Hate Laws Not Needed

We already have laws on the books dealing with vandalism and since such acts are committed by children they should not be made subject to felony convictions. Note on this page the photo of the campaign poster "Larry Smith For Congress." He was elected, unfortunately, because most of the Broward County, Fla. (Ft. Lauderdale -Hollywood area) voters did not know he was a Jew. Some courageous local patriots took upon themselves the task of trying to reach the people with the truth. They sprayed all of Larry Smith's campaign signs with the star of David to identify him as a Jew. posed to protect all groups but in fact mainly are used to grant the locally powerful Jews minority special police protection. In New York City painting a star of David or a' Swastika on a synagogue is treated as serious as a murder or armed robbery.

Jew Mayor Koch issued Interim Order No. 40 on Dec. 31, 1980. This established the "Hate Squad" headed by Capt. Paul Donnelly, 50, with 28 years on the force. He has a staff of 10 detectives divided into three squads which operate from 10 A.M. to 1 A.M. and are on call 24 hours a day. Capt. Donnelly says they investigate, "criminal incidents and acts which may be racially and religiously motivated. Smearing a Swastika on a synagogue receives as much attention as a murder case!" Capt. Donnelly's full time staff is located on the 13th floor of the police headquarters. This is the first city to have a full time police squad to investigate "hate." Of course, Orwell's 1984 is still a year off, so this may not spread to other cities until next year. Donnelly says that one mother of a 16 year old complained, "I don't know why you're making such a big stink; it's only graffiti." Donnelly said his squad spent "several days" on the case ringing every doorbell in the neighborhood and quizzing all the children before the youth finally surrendered. The words "Jews Out" were sprayed on the all Jew Forest Park Cooperative in Woodhaven in Aug. 1981. The Hate Squad got to the scene of the crime within 15 minutes. Soon at least 8 detectives and ranking officers arrived. A week later they arrested a 19 year old girl and two younger boys and charged




