National Socialists Attack Leftist Demonstrators

"Communist treason cannot go unchallenged!" With this thought in mind, Party Regulars and Stormtroops confronted pro-Viet Cong "peace" demonstrators in two separate actions in the nation's capital on 21 October.

An NS infiltration team, comprised of Capt. Chris Vidnjevich, Lt. Frank Drager, SL William Kirstein and GL Spencer Redfield, began operations by storming through a Red security cordon and demolishing the speaker's platform at the Lincoln Memorial--microphones, speaker and all! The disruption halted the treasonous display for almost a half hour. Capt. Vidnjevich and SL Kirstein were arrested in the assault, but were later released under \$500 bond each.

Later, the National Leader led a National Socialist contingent into the middle of several thousand peace creeps at the Pentagon with gigantic signs spelling out, "Bomb Hanoi" and "Gas the Viet Cong". With the contingent surrounded, and the odds 100-to-1 in their favor, the courage of the creeps rose and they abandoned "non-violence". After a short, bloody skirmish, the National Socialists fought their way out of the encirclement. Changing their tactics, they then became a roving "guerrilla" band, attacking small groups of Reds, seizing and destroying hundreds of Leftist placards, capturing a number of Viet Cong flags, and generally doing everything possible to discourage treason.

It was later discovered that the NSWPP was not the only patriotic organization taking part in the day's activities. While all the fighting was going on, representatives from several rightwing groups were on hand to "observe" the action!

Capt. Forbes Sentenced

Capt. Ralph P. Forbes of the Los Angeles Headquarters was sentenced to 60 days' imprisonment 13 October, and placed on probation for three years. He was con-

victed of "disturbing the peace" and "rioting" by a Jew judge 6 October in connection with the 6 August NS assault on Red "peace" marchers in Hollywood. Forbes is currently appealing the conviction.

Sentenced along with Capt. Forbes were ST Robert Walton, who received a 30-day sentence and three-years' probation, and PT George Carpenter, who was ordered examined by a Jewish headshrinker.

Surprise NS Appearance

Capt. Forbes "raised quite a few eyebrows" when he suddenly appeared on a Los Angeles afternoon discussion show 19 October. Dropping in unexpectedly on the KHJ-TV Channel 9 "Tempo II" program, Forbes told the viewing audience, "The Black people are a problem to the United States. The only way we're going to solve this problem is to let them have their own country." At the close of the show, the moderator asked, "Are you a spokesman for the White people?", to which Capt. Forbes replied simply, "I think I am".

Chicago Building Case

Capt. Chris Vidnjevich is to appear in court 8 November to "show just cause" why the Party should not be evicted from its Chicago premises. The attorney retained to handle the case earlier double-crossed Party officials by conveniently "forgetting" to file certain necessary appeal papers on time.

Chicago National Socialists are planning to locate a new headquarters site, should they lose the present building.

Louisville "Syndicalism" Case

Capt. Vidnjevich and A/Lt. Fred Catalano are scheduled to appear in a Louisville (Ky.) court 10 November to face outlandish "criminal syndicalism" charges. Also scheduled to appear is Party Supporter Russell Frauenhoffer, who is charged with "disorderly conduct".

The charges stem from an NS White Power demonstration called to protest "open-housing" marches in Louisville last April, in which hundreds of Whites took part. The case has been postponed four times. If convicted, Vidnjevich and Catalano could each receive a 21-year prison sentence.

Executive Officer Appointed

On 22 October the National Leader named Robert A. Lloyd, III Executive Officer of National Headquarters. In this capacity, Mr. Lloyd will assist in the daily administration of Party affairs, as well as in matters of personnel and public relations.

Indoctrination Officer Named

Dr. William L. Pierce, editor of the WUNS review, NATIONAL SOCIALIST WORLD, was named Director of Indoctrination for the Party on 22 October. In creating the new post, recognition is given to the tremendous importance of the National Socialist world-view for a sustained and consistent struggle of our

movement, as well as to the need to ensure the integrity and straight-line development of the National Socialist idea as the proper guide to action. In his new role, Dr. Pierce will be in charge of everything relating to ideological matters, including the preparation of suitable NS instruction material.

ST Promotions

Effective 22 October Lt. Frank Drager, who was recently named General Organizer of the Party, was promoted to the rank of First Lieutenant in the Stormtroops.

GL Spencer Redfield was promoted to the rank of Storm Leader on 22 October.

NSYM Fall Membership Drive

Student Directories Still Needed

Members and supporters living in a community where there is a college or university are urged to procure a copy of the current (1967-68) student directory for this Headquarters. Activity of the Month

Four to ten requests for a given title within the period of a week or two can give the impression of a sizable public demand for it.

There has been a slight delay in releasing the book, which was scheduled for 15 October. However, it has already been printed and is currently being bound, and will be ready for shipment within the next 10 days.

The Politics of John Patler

The Jew-controlled press has pushed the line that John Patler killed Commander Rockwell in an internal NS dispute, and that Patler was, in fact, a bonafide National Socialist. This line has been repeated so consistently, that even some good Party members and supporters have been taken in by it. That basic ideological differences may have been involved in the assassination is deliberately ignored.

The fact is that John Patler (John Patsalos) was expelled from the NSWPP on 4 April following his persistent attempts to push a "Racial Bolshevik" line within the movement. His hateful references to lighter members of the Party as "blue-eyed devils" are well known. They reveal a malignant attitude which caused considerable dissension prior to his expulsion. Patler had made repeated attacks on the Party's "Aryanism" and "racial chauvinism"--both verbally and in

writing--in no way substantially different from similar attacks in the rabid Communist publication, "PROGRESSIVE LABOR", to which he subscribed, and which he regarded as his favorite reading.

As all National Socialists realize, race is at the center of our entire philosophy. Any attempt to belittle its fundamental importance, or to deny basic Aryan racial values, is contrary to everything that National Socialism stands for, and cannot be tolerated within the movement.

Patler's deviation from National Socialism became apparent in another way. While claiming to be for the unity of our people, he regularly preached and practiced Marxist class war. His personal relationships were largely affected by class considerations, despite the fact that National Socialism does not recognize class distinctions. In a Marxist mania for "equality", he attacked the Aryan concept of private property, which did not conform to his "proletarian" concepts.

After he left the NSWPP, Patler formed a political action committee to put his ideas to work. He promptly appointed as secretary of the group an active member of the Trotskyite International Workers of the World in Chicago!

For those who had known Patler well, this action came as no surprise. Among the Marxist "heroes" whom he openly admired were the Cuban dictator, Fidel Castro, and Che Guevara, the late darling of the Left, both of whom he regarded as "true revolutionaries".

This, then, is the man Commander Rockwell ordered expelled from the Party. There simply was no place for the disruptive activity and deviation of this individual within the National Socialist movement.

In the light of what has happened since, there is possibly an even more sinister note in Patler's strange relationship with one Jacquelyn Linden. It remains to be seen whether the role played by this known Jewish agent will come to light in the upcoming trial. The Linden woman, posing as a post-graduate psychology major, tried to approach the various Party headquarters on a number of occasions. After she was barred from National Headquarters premises by order of the Commander, Patler continued to meet with this agent. What transpired during these "rendezvous" has not been determined. However, it is known that in addition to a remarkable intelligence, the Linden woman possessed an almost pathological hatred for the Commander. It is conceivable that the influence such a person, using all her feminine wiles, could exercise over an unstable Racial Bolshevik could be quite considerable.

At this time we are unable to state conclusively whether Patler was directly involved with a certain Communist or Jewish organization at the time of the assassination. However, one thing is certain: Patler could not have acted alone in any plot against the Commander.
