National Leader Addresses 3,000 Students

National Leader Matt Koehl spoke to some 3,000 students at Washburn University in Topeka, Kansas on 16 November in his first major address since assuming leadership of the Party. Afterwards he answered questions on National Socialism at a special forum.

The National Leader explained that National Socialism is a world view based on racial idealism, rather than economic materialism--on a love of our own White Aryan race, rather than a mere hatred of Jews and Negroes. He contrasted true National Socialism from the Hollywood "Nazi" stereotypes of "mindless monsters with jackboots and monocles."

The National Leader later appeared on a local television panel to discuss the Party's program and philosophy. He was accompanied on the trip by Lt Alvis Gray and Frank Niles of the Dallas Unit.

Capt Vidnjevlch Fined

Capt Chris Vidnjevlch of the Chicago Headquarters was let off 11 December with a \$100 fine in connection with his role in storming a speakers platform during a pro-Red "peace" demonstration in Washington on 21 October.

Charges against another participant, SL William Kirstein, were dropped.

Associate Editor Named

George T. Parker, the Party's General Correspondent, was named Associate Editor of the Party newspaper, WHITE POWER, on 5 December.

Production Schedule

Threats in Patler Trial

Two witnesses in the trial of John Patler for the murder of Commander Rockwell disclosed that they and their families were threatened after they had testified at an earlier hearing that Patler was definitely the man they saw running away from the murder scene.

Meanwhile, the Patler defense is counting on two things to win its case: (1) perjured testimony in regard to Patler's possession of the murder weapon and his alibi; and (2) extremely technical rulings by a very liberal judge against much of the pertinent evidence tending to link Patler to the crime.

The trial, which has gone into its third week, is expected to conclude shortly.

New Membership Policies

Effective 1 January 1968 only persons who have been Stormtroopers, Official Supporters or NSYM members for at least six months will be eligible for membership in the National Socialist White People's Party, subject to the normal admission requirements. This does not effect present candidates for Party membership.

At the same time, a new dues policy will go into effect for all Party and NSYM members, as well as Stormtroopers. The membership of those who let their dues lapse for a period of four months will be automatically suspended. If no attempt is made to get caught up or to provide extenuating circumstances after six months, membership will be terminated.

It is very important to keep your dues current. If for any reason you should fall behind, or encounter financial difficulty effecting your ability to maintain your regular dues, please do not fail to notify this office of your situation.

Activity of the Month

During December we ask that each Member take some kind of individual action to call to public attention the fate of two National Socialist political prisoners who will be spending their Christ-

mas in jail: Rudolf Hess and Colin Jordan.

Rudolf Hess has spent almost 27 years in prison, during which time he has never once seen his wife or son. He is currently languishing as the only prisoner in West Berlin's grim Spandau Fortress. This Christmas Eve Hess will have spent exactly 9,724 days and nights behind democratic prison bars for the "crime" of having tried to bring peace to Aryan mankind during the tragic days of World War II.

Colin Jordan was sentenced to 18 months' imprisonment 25 January on a trumped-up charge involving his criticism of Jews and Negroes. The British Leader was the first person to be jailed under the grossly anti-Aryan "Race Relations Act." He has been kept in virtual isolation at Exter after an appeal to obtain a writ of habeas corpus was turned down.

Among the forms of action one may take are picket demonstrations, letters to the editors of local newspapers, and telephone protests to all those directly or indirectly associated with the imprisonment of these men. In the case of Rudolf Hess, attention should be focused on U. S. State Department offices, as well as the consulates and official agencies of Great Britain, France, the Soviet Union and West Germany. In the case of Colin Jordan, the targets should include all British offices and agencies in this country, official or otherwise.
