NS BULLETIN to Appear Twice Monthly

Starting this month, the *NS Bulletin* will appear two times each month--on or around the 1st and the 15th.

It will thus serve to keep all National Socialists better informed of intra-Party affairs and developments and provide for more effective internal communication, in accordance with the Phase Two objectives of the movement.

Capt Vidnjevich Acquitted

Capt Chris Vidnjevich was acquitted by an Ellsworth, Maine, jury 24 April of a charge of *assault with intent to kill* a Boston mobster. Conviction under this charge would have carried 20-years' imprisonment.

However, the Captain was convicted of a lesser charge of *assault with a deadly weapon*, apparently because the jury thought he had fired *too many* bullets in self-defense against the gangster. (Police counted seventy-eight bullet holes in the gangster's car.)

Capt Vidnjevich was charged following a gunfight 17 March with the Boston underworld character, after checking out certain details in connection with Commander Rockwell's assassination. He was released from jail 8 April on \$10,000 bond.

The judge, obviously displeased with the verdict, spent half an hour berating the perjured testimony of the mobster before imposing sentence, as required by law. However, he handed down the very lightest sentence for this charge--a \$1,000 fine--and urged Vidnjevich to appeal the conviction. (The Captain could have received a five-year prison sentence on this charge.)

We are deeply grateful to all those who contributed toward Capt Vidnjevich's bond. We are now applying these contributions toward the purchase of essential new equipment for the Party. We are also grateful to those who helped out by lending money for the Vidnjevich bail. Within the next week all such loans will be repaid.

Gauss Gun Case Dropped

The *machine gun* charge against National Headquarters Staff Member Michael J. Gauss was dropped by a D.C. court 17 April.

Gauss had been out of jail prior to his trial on a \$1,000 bond raised by the Party.

Hitler Birthday Celebration

Fifty-some National Headquarters Staff members and their guests celebrated the 79th anniversary of Adolf Hitler's Birth around a traditional bonfire in Spotsylvania 20 April. A cold buffet supper was served by the womenfolk, preceded by a pistol and shotgun competition among the men. Slides of NS activity were viewed later in the evening, in place of a showing of the film, *Triumph of the Will*, which could not be obtained in time for the celebration. (This film will be acquired, however, in approximately six weeks for viewing by Party members and supporters, at which time an announcement will be made.)

Chicago National Socialists Attack

On 26 April 23 National Socialists in the Windy City made repeated attacks on a Red *peace* column, pummeling the marchers and tearing up their treasonous signs. Police made no arrests.

King Demise Celebrated

One NS activist in Lake Forest, Illinois has described how he celebrated the good news of Martin Luther King's passing:

I'm having a field day up here raising all the flags to full mast. Today I raised the flag at the high school twice, plus the ones at the city hall and the American Legion.

Last night I made a dummy of MLK and hung it at half mast at the city hall. The police came over to my house and inquired about it and were completely baffled. I have more plans for this town.

NS Youth Strike in Wisconsin

In a remarkable display of the revolutionary spirit which will carry the National Socialist movement to victory, 15 members of the National Socialist Youth Movement on 9 April challenged the Liberal, Jewish lie at the high school in Palmyra, Wisconsin. The morning bell that day was a signal for them to begin the open distribution of the newspaper, *White Power*, and other Party materials to students and teachers alike. One young participant reported:

. . . By afternoon the faculty and school administration were up in arms against such a flagrant and determined struggle by such a small group that a number of us were immediately hauled in before the principal.

. . . He talked about 'freedom of speech' (although we were apparently entitled to none) and of our American heritage (neglecting to mention that it was the White Man who built this country and made it great). In no uncertain terms we told him this: 'Negroes must be repatriated to a suitable homeland. America must be purged of Jews and Communists and other disruptive elements; that there must be a National Socialist political, social, spiritual and moral revolution throughout the country.' We repeated our demand for freedom of speech, and told him that we would do everything we possibly could so as to make the students of our high school sufficiently aware of what the NSWPP and National Socialism is trying to do. He told us that he 'would do anything he could to stop us.'

We are supposed to graduate June 2nd. Regardless, we are continuing our campaign directed at the students of our school. We struggle for White Power and an end to modern, liberalized, Jew-infested education.

California NSYM Members Defy Jew System

Seven members of the National Socialist Youth Movement defied the Liberal-Jewish System 19 April by marching into class at a San Francisco Bay area high school wearing Swastika insignia. Five of the youths were suspended and two reprimanded by school authorities.

The group, however, is planning to contest in court this arbitrary action by school officials, inasmuch as the Leftists and Pacifists are allowed to wear political insignia in classrooms. The National Socialists demand the same right.

Further Consolidation in Greater Washington Area

During the last several weeks the Party has taken further steps to consolidate its operations in the Arlington-Washington area. All central functions of the Party, including publishing, are now performed in this area.

Activity of the Month

Twenty-seven years ago--on 10 May 1941 --Hitler's Deputy, Rudolf Hess, made his courageous solo flight to Scotland in a last desperate bid to bring about a conciliation between Germany and Great Britain, which would lead to an early end to the hostilities of World War II. Had he been successful, the United States would never have been dragged into that conflict, and 250,000 Aryan Americans would not have died to make the world a better place for Communists, Jews and Negroes.

Today, as a reward for his heroic efforts, Rudolf Hess sits alone--the *only* prisoner in West Berlin's forbidding Spandau Prison--guarded by companies of French, British, Russian and American troops. He has been doomed never again to see beyond the stark, grim walls of his dungeon-like cell.

The plight of Rudolf Hess exposes the utter hypocrisy of all the Liberal, Jewish talk about *freedom* and *justice*. Freedom and *justice* for convicted murderers and perverts--yes. Freedom and *justice* for Communist traitors and subversives --yes. Freedom and *justice* for Blacks who rape, burn and loot--yes. But *no* freedom and justice for any dauntless Aryan who dares to work for the good of his race! That is the Liberal-Jewish concept.

Rudolf Hess has not only been held political prisoner longer than any other National Socialist, but longer than any other person in modern history, as well. For 27 years now he has remained true and steadfast to the ideals of National Socialism.

We National Socialists accordingly owe it to this man as a comrade to renew our demands for his release. Let us work to make sure that every year, every month, every week, every day, every hour, every minute and every second that he is held prisoner we press the attack against the Jewish System by exposing its outrageous treatment of this comrade.

As the activity for this month we urge each Member to focus fresh attention on the plight of Rudolf Hess--in letters-to-the-editor, in speeches, in term papers, in class essays, in public gatherings, in picket demonstrations, in organized protests.

All activity should be directed to the attention of the public in general, and to French, British, Soviet, West German and State Department officials in particular.
