# National Socialists Oppose Peace Creeps in Los Angeles

On 10 July, members of the NSWPP from Los Angeles were led by Howard W. Ely in a demonstration against Communist "peace" agitators in downtown L.A. The demonstration ended when National Socialists seized several Communist flags. In one scuffle, party member Joe Tomassi was arrested by Los Angeles police, but when they saw his uniform and realized he was against the reds, and that his only crime was ripping down Communist Viet Cong flags, they gave him a ticket for jay walking and let him go (with flag).

Howard Ely gave several interviews to the newspapers and radio stations covering the demonstration and received an invitation to appear on a long TV show to discuss Party program.

On 22 July, D.C. radio station W. OP had an hour long program devoted to discussion of the Party's White Power Message. The message being played at that time dealt with the new gun registration law in the District of Columbia and urged White residents to disobey the gun control law by hiding all guns and ammunition. The entire message was read to the radio audience and calls were taken from people expressing their reactions to the message. To the radio announcer's surprise, the overwhelming majority of the callers agreed with the Party's stand and endorsed the NSWPP proposal for hiding guns until race war requires their use. Some callers even said they would like to join and become Party supporters!

Two days later, the Washington Evening Star ran the following article giving the Party's viewpoint unprecedented publicity:

As a result of this flood of publicity, local support has nearly doubled. Two new supporters have pledged the necessary monthly funds for two more message sets, which have already been installed. This has doubled the Party's capacity for reaching residents in the Washington area with our message. # National Socialists Join Area Residents in Opposing Gun Control

On 17 July nine NSWPP members distributed leaflets to residents of Fairfax County (ajacent to Arlington) attending a meeting of area citizens who sought measures to curb gun control in Northern Virginia. State and local lawmakers have been unsuccessful in forcing through new gun control laws so far. NS efforts to block the passage of new laws designed to disarm Whites will be continued into the fall.

A new NSWPP leaflet opposing gun control and urging Whites to arm themselves will soon be available from NS Publications. Watch for announcement of this leaflet and plan to distribute quantities in your area.

## NS Arms: New Party Subsidiary

The National Socialist White People's Party has launched a companion operation to NS Publications: NS Arms, which will sell Negro control devices like riot guns, carbines, and chemical mace to White people who are not yet armed. As soon as NS Arms has acquired a stock of guns and ammunition from manufacturers, Party members and supporters will receive a list of weapons which will be available. #### Activity of the Month

In August Party members and supporters are urged to propagandize against government gun control. Two ways of promoting NS ideas are suggested: letters to the editor of your local newpapers, and a call to any radio program in your area which permits people to telephone their opinions in a live broadcast. While there is always a chance that a letter to the editor will not be published, radio "talk" shows present a splendid opportunity for blasting gun restrictions.

When explaining the National Socialist viewpoint on gun control, it is essential to point out that the real issue is not just the protection of the rights of hunters and sportsmen. The real issue is not even the sanctity of the Second Amendment to the Constitution, which protects Americans' right to keep and bear arms, although both of these issues are critically important. The real issue over gun control is whether or not White Americans will be able to defend themselves against an uncontrolable, well-armed Black army as soon as the summer riots turn into all-out race war. Police forces, National Guard and even the Army will be powerless against twenty million bloodthirsty Blacks who'll have a free hand to burn and murder unless the White Man is armed and ready to fight. Without guns and plenty of ammunition, Whites face widespread massacre in every city and rural community in America. Emphasize the fact that Whites must get their guns and ammunition and hide them now, before gun sales are entirely outlawed.

# The Enemy Within

# An Analysis of Jewish Anti-Party Activity

Jews have seldom done their own fighting in the ages-long war they have been waging against Aryan Man. There are always goyim who can either be bought or tricked into doing the Jews' rough and dirty work for them.

In Alexandria, Virginia, just south of Arlington, there is a small group—none of them Jews—who call themselves the "White Party of America." Their boss is a shady and elusive character named Karl Rogers Allen, Jr. Allen is a smooth talker and a good practical psychologist who has learned that a little mock humility and false sincerity will go a long way. The average citizen, conditioned by Hollywood spy stories, would never see an agent of the Anti-Defamation League of B'nai B'rith in Mr. Allen.

One of their numbers is John Patler, alias John Patsalos, the sneak murderer of Lincoln Rockwell.

Another is the "Reverend" James Konrad Warner, a mail-order shark who specializes in stealing and reselling right-wing mailing lists. He has never been very choosey about his customers, as long as the price was right, and he even supplied one homosexual group with a mailing list. He changes the name of the game the way a snake changes its skin and has jumped from one group to another as fast as he could milk a new list of mail-order suckers. One day he may be seen posing pompously in Hollywood "Nazi" regalia, and the next he may be muttering incantations as the "Hofgod" of a religious cult.

Another in this choice group is Mrs. Mary Surrey, who also uses the names "Max Amann" and "Al Gray," and who, sad to say, once managed the order department of the Dallas unit of the NSWPP. Mr. Allen, by appealing to her female vanity and her materialistic instinct, convinced her that her talents were being wasted in the NSWPP and that she could turn a faster buck in his organization. Being a "practical" woman and no "fuzzy-headed idealist," Mrs. Surrey delivered the mailing list accumulated during her work for the NSWPP in Dallas over to Allen and Warner in return for a franchise on the fund-raising operation in the new group.

Allen then convinced his new business partners that if their new enterprise was really to thrive, the first thing to do was to knock out the "competition"—namely the NSWPP. Since the murder of Commander Rockwell had failed to accomplish this, Allen & Co. tried more devious methods. A series of poison-pen letters was mailed out to a number of Party members and supporters in an attempt to undermine morale and encourage defeatism; "the Party is dying," was their refrain. When the Party not only failed to die but made one major accomplishment after another under National Leader Koehl's guidance, Allen changes his tactics again. One killing had been arranged; perhaps another could be provoked. So, out went another poison-pen mailing, this time wildly charging Matt Koehl with the murder of Lincoln Rockwell! Posters, like the one reproduced here, were also mailed out.



The way the ADL looks at it, it doesn't make much difference whether they provoke some simple and unstable citizen into shooting one of the Party leaders, or whether they provoke a Party member into taking a shot at one of their hirelings and getting caught; the Jews win either way.

Unfortunately, Virginia has no criminal libel statutes under which such blatantly provocative liars can be prosecuted, and they are taking full advantage of this oversight on the part of the Virginia legislature. One means of dealing with criminals of this sort is public exposure. Their activities can not tolerate the bright light of day. The next issue of the Bulletin, therefore, will carry a special feature: The Karl R. Allen Story. This documented expose of the way the Jews employ agents provocateurs in their underhanded fight against our Race will be a real eye-opener.

Meanwhile, however, the Jews are flailing out desperately in an attempt to halt the increasing influence of the Party in the Washington area—an influence largely due to the Party's hugely successful White Power Message service, now reaching 20,000 callers a week. Last week, a gang of Allen's thugs jumped two Party members as they were leaving an Arlington grocery store. One of them, Michael Gauss, was struck from behind and knocked unconscious. Only the heroism of his companion, Gary Hansen, in holding the goons at bay with a tear-gas pistol until police arrived, kept Gauss from being stomped to death as he lay on the pavement. As it was, he suffered a brain concussion.

The newspapers, of course, treat such an attack as a clash between "rival racist groups." As a matter of fact, it is not that at all, but another skirmish in the long war between Jew and Aryan—even though degraded Aryans take the place of the Jews on one side. Every National Socialist must thoroughly understand this difference, for there are many sincere but misled peacemakers who cloud the issue with their efforts toward reconciliation. With genuine rivals there can always be reconciliation—but with the Jew or his conscious agents, never! To think otherwise is suicidal folly.
