More Success for White Power Message

A flood of publicity about the Party's *White Power Message* in the Washington, D.C., newspapers has increased, again, the number of persons in the local area who call our weekly messages. For five days in a row, leading Washington papers carried headlines about the service after the recording of an especially stirring message about the necessity of Whites being armed for the coming race war. The message also informed the public of the existence of NS Arms. The next morning, the following article appeared in a large Washington daily: **Nazis Sending Guns To Suburbia-Whites Told To Buy Arms** This has resulted in more sales to NS Arms than can be immediately handled.

CHANGING TAPES

Dial 528-4361 For White Number

"Wake up, America," the recorded voice on the phone said, "Recognize your enemies. Arm yourselves."

This is the most recent message of the National Socialist White People's Party, a right wing group formed last year following the death of George Lincoln Rockwell and the disintegration of his American Nazi Party.

2-MINUTE CHATS

Since last summer, the new party has put out two-minute phone messages with a militant right wing tone. The messages can be heard by dialing 528-4361.

The current message is highly topical, keyed to the recent manslaughter conviction of Huey Newton, the San Francisco Black Panther whom the voice refers to as "that smirking black murderer."

The message says the public has "lost its moral bearings" partly due to a "massive campaign of deliberate moral disintegration" by the nation's press.

KILL OR ...

It adds that forces in the country are "hell bent on destroying the white race," and then issues the call to arms.

"Either we kill them or they kill us," the voice says.

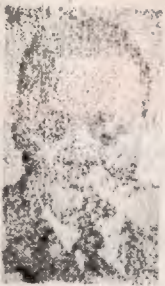
The recording says, "This is another in a weekly series of white power messages," adding that brochures on weapons can be obtained from the offices of the party, 2807 N. Franklin Road, Arlington.

The deliverer of the message identified himself as Dr. Franklin Pierce, whom Arlington police confirmed was a member of the organization. Mathew Coles, who succeeded Mr. Rockwell as head of the American Nazi Party, is the leader of the white people's party.

You Don't Have to Dial Telephone Hate Talks

OVER THE PAST two months I must have received 60 phone calls and letters from people who have been shocked by the contents of a recorded telephone message.

The usually want to know: (1) Have I heard the message? (2) Why haven't I written anything about it, and (3) What can be done, legally, to put a stop to this sort of thing.

Up to now, I have answered: (1) Yes; (2) For what? and (3) Nothing.

I'm writing about it now because the frequency of the calls and letters has increased over the past several days. The other answers remain the same.

The messages referred to are a variety of hate-inspired misinformation, ranging from attacks on the Rev. Ralph David Abernathy and Supreme Court Justice Abe Fortas to exhortations to write people to arm themselves against blacks.

They are sponsored by several right-wing groups, including one called Let Freedom Ring. Most of the recent calls, however, have been concerned about the weekly messages sponsored

by the National Socialist White People's Party (formerly George Lincoln Rockwell's American Nazi Party).

THE MESSAGES are almost always vicious racist attacks, sometimes consisting of half-truths, sometimes of outright lies. The lines, interestingly enough, are almost always busy.

Those who call or write to talk about the messages are consistently indignant. "How can they get away with that sort of thing?" they want to know. "Isn't there some kind of legal action that can be taken against them? Can't the Government stop the telephone company from helping to spread those hate messages?"

The messages are offensive, no question of it. What the complainants forget is that they have to cooperate—that they, in fact, must take the initiative—to be offended.

They must dial the number, endure the inconvenience of repeated busy signals and then listen to the diatribe. They can hang up whenever they please, although most seem to listen to the end.

It's a little like buying a ticket to see what friends have told you is a particularly obscene burlesque show, then shrieking, "My God, how sinful!"

THIS POINT never quite comes across, and people keep encouraging their friends to call and be offended. And they keep calling me to ask what can be done about it.

Suppose that instead of a recorded message there was on the other end of the line a live person who could be counted on to say nasty, obscene things about Negroes or Jews or Catholics. Can you imagine taking the time to call that person and listen to his nonsense? Or giving his phone number to your friends so they could call and be insulted? Or calling a newspaper to see how you could stop him from saying such things?

Under the circumstances, it seems to me that no legal action at all is called for. All that is needed is for those who are offended by the messages to stop dialing the number and stop passing it on to their friends.

That's why you will find neither the message nor the phone number here.

The fantastic amount of publicity given the Party in recent weeks has brought in new local supporters who have pledged funds for the installation of another line for the *White Power Message*. This increases our capacity to 25,000 calls each week.

Members and supporters are urged to set up additional *White Power Message* units in their local areas. Write to National Headquarters for details on setting up these units.

Party Files Civil Rights Complaint

On 13 September, an obscene, threatening letter was received by the NSWPP from a Washington, D.C., Negro who was angry about the *White Power Message* on race war. In the letter the Black stated that he was going to kill Dr. William L. Pierce, the Party's ideological spokesman, who recorded the message.

Likemost threatening letters received by the Party, this Black had not signed his name, *but* he did write his return address on the envelope. The address appears to be authentic.

A complaint was immediately lodged by Dr. Pierce with the F.B.I., which is charged with the responsibility for investigating and making the arrest of persons who use the mails to threaten and intimidate others.

At this time we are awaiting word on the results of their investigation.

It will be interesting to see whether the Justice Department will prosecute this case. So far no Jew or Negro has ever been prosecuted under the Civil Rights Act, despite the thousands of violations of White people's civil rights each year.

It is the F.B.I. which enforces the Civil Rights Act and its amendments. There is one section of the recently passed Civil Rights Act of which Party Members and supporters should be aware: The Civil Rights Act of 1968, among other things, makes it a federal offense to violate a person's civil rights by impeding his ability to use any public road or public accommodation facility because of his race, creed or national origins. This is spelled out in Public Law No. 90-284, Section 245. This means that if a Negro or a Jew attempts to prohibit any National Socialist from demonstrating on public property (because of his *creed*), he is guilty of violating the above law, and a complaint should be filed with your local F.B.I. without delay. If the F.B.I. will not act on your complaint, the newspapers in your area should be informed.

Similarly, if any Jew or Negro prevents or impedes your use of any public street or sidewalk or any public facility, e.g., a store, school or restaurant, because you are White or because you are a National Socialist, you should get all possible information about the person (name, physical description, address or license number) and demand action by the F.B.I. In addition, if any local law has been violated, a complaint should be made to your police department and a warrant sworn out whenever possible.

Do not forget this information! You will have more and more opportunity to make use of it in the years ahead.

Keep us informed at National Headquarters whenever you have an opportunity to make a civil rights complaint.

A Statement to the Party Membership from the National Leader

When the responsibilities of Party leadership were thrust upon me following the tragic assassination of Commander Rockwell last year, I quietly made a resolution: I solemnly resolved that the mission of the National Socialist movement—to which Commander Rockwell had devoted his life—would continue at all costs.

The first task was to survive. The second task was to demonstrate organizational growth. I am happy to report that we have been able to accomplish both of these goals.

Ideologically, I have tried to steer the Movement along a straight-line National Socialist course, reinforcing the integrity and vitality of our mighty, race-saving Idea.

Strategically, I decided upon a very simple, but effective, formula: Just as Commander Rockwell had divided our National Socialist struggle into three separate and distinct phases, I recognized that it was further necessary to subdivide our Second Phase objectives into a sequence of priorities, and then—one at a time—to concentrate Party energies and resources on each priority, accomplishing it to the exclusion of every other consideration.

First priority was assigned to securing a new National Headquarters. By focusing on this one, single objective—often at the expense of other relatively less important ones—we were successful. Today—in spite of strenuous attempts by hostile elements to wreck our efforts—that Headquarters is a tangible reality. Not only does it stand as a monument to the inherent strength of the Movement, but it is at the same time a source of rightful pride and inspiration for every National Socialist, and a reassurance that with will and determination we can accomplish any task set before us.

It has now been just over one year since I assumed office as National Leader of the Party. I am currently in the process of drawing up plans for a number of new and important projects designed to advance the Party substantially during the crucial period immediately ahead. Among other things, I want to announce a new priority for the Movement within the next few weeks.

I hesitate to make any announcement along these lines, however, unless I know that I can count on the absolute, wholehearted support of the membership and of the Movement generally, which the fulfillment of these tasks will require. It would be presumptuous and futile on my part to proceed without the solid backing of the entire Party.

Therefore, I am appealing for your pledge of support at this time. I am asking, in effect, for a “vote of confidence” from all those who have stood loyally by the Party during this past year. If I am given this “vote of confidence,” I shall then immediately undertake the projects mentioned above. If I am unable to obtain such support, I will consider it my duty to step aside.

I hereby ask that all members in good standing make their position known in this matter during this next week. Your “vote” should be postmarked no later than 5 October 1968. I shall faithfully abide by the decision of the membership—one way or another. *the*
