Yippies Gassed

During the first week of October, the House Committee on Un-American Activities was repeatedly insulted and harassed by a gang of despicable Jewish "Yippies" who had been subpoenaed to give testimony about their conspiracy in staging the August Chicago riots. By the fourth day of the hearings, a group of Washington area National Socialists had had enough of their Jewish arrogance and went to the Congressional Hotel, where the Yippies were staying (at government expense), to teach them some manners.

When the first National Socialists arrived in the lobby, the Yippies immediately dispersed and could not be found. The following newspaper article gives a rough idea of what followed:

Rubin Gassed**Says Yippie Leader Urged
Revolution 'Like in Russia'**

WASHINGTON (AP)—An undercover Chicago police officer quoted Yippie leader Jerry Rubin Thursday as saying during the Democratic National Convention that the antiwar demonstrators there should keep the disorders going "until we take over the government just like in Russia."

Robert L. Pierson, who said he infiltrated a motorcycle gang in Chicago, supplied the quotation in testimony before the House Committee on Un-American Activities which is probing the bloody street fighting in Chicago in August.

Pierson told the committee that Rubin's remarks were made in Lincoln Park on the

afternoon of Aug. 27, a day after the first big confrontation between antiwar demonstrators including Yippies (members of the Youth International Party) and police.

Rubin was quoted as saying the demonstrators should keep up the disorders through the November election. "We've got to create little Chicagos in cities all over the country," Rubin allegedly said.

Pierson, who was assigned by the demonstrators to be the Yippie leader's bodyguard, said Rubin told him, "whenever the candidates appear demonstrators must disrupt them."

"He kept up this tirade," Pierson said, then quoted Rubin as declaring: "We must take

the country away from the Johnsons, the Humphreys, the Nixons and the other imperialists."

Rubin charged today his hotel room on Capital Hill had been tear-gassed by American Nazis.

Rubin, dressed in guerrilla garb, told an impromptu news conference before the start of the third day of hearings before the subcommittee that a mysterious telephone caller threatened to get him.

Bearded, bare-chested Rubin said he returned to his room in the Congressional Hotel next to a House office building Thursday night to find the room clouded with tear gas.

Rubin said on the door was a

small white card with a Nazi insignia, the words "National Socialist White People's Party" and an advertisement for dialing a "White Power" message by telephone.

Rubin said that after police came, his hotel telephone rang and a caller asked him to come outside. When he balked Rubin quoted the caller as saying, "If we don't get you tonight, we'll get you tomorrow."

The subcommittee chairman, Rep. Richard Ichord, D-Mo., says he has heard testimony that at least 21 Communists were involved in the bloody clashes between demonstrators and police at the Democratic convention in Chicago.

Later that evening, Rubin and other Yippies checked out of the Congressional Hotel under police protection.

Attack on Interracial Couple

An interesting breach of the civil rights of an interracial couple occurred in one midwestern town: The first school dance of the season was attended by several Black bucks with White female companions. The event had just broken up, and one of the mixed couples, who had annoyed many of the White students with their particularly suggestive dancing, were walking hand-in-hand under the moonlit sky. Suddenly, someone behind the pair yelled, "Hey, you!" As they looked around, the pair of degenerates was sprayed with a disabling chemical spray which left them sprawled out, crying and gagging, on the ground.

When police found them twenty minutes later, they were still coughing and sobbing, unable to get to their feet.

National Socialist Exposes Jewish Drug Ring

A National Socialist student at the University of Wisconsin was instrumental in exposing a Jewish narcotics ring on that campus recently. On information which he supplied, Madison police arrested 28 drug pushers, almost all Jews.

Close to \$75,000 worth of narcotics were seized in the raid. Police said they suspected that Madison was the distribution point for the Midwest supply of dope to high school and university age users.

Notice to National Socialists

Party Members and supporters are reminded that they cannot be forced to answer the questions of any federal agents, such as FBI, Internal Revenue or Secret Service Agents. In fact, federal agents cannot even come into your home uninvited, unless they have a warrant or similar court order.

This is called to the attention of National Socialists because some Party followers have been harassed in recent weeks by federal agents, mainly from the Alcohol & Tobacco Tax Division of the Internal Revenue Service. One of the main things they are trying to find out are the quantities of guns and ammunition our people have on hand, as part of a general attempt to disarm White people. (This is in marked contrast to the arms build-up among Black militants, which has gone entirely unchecked.)

If visited by federal agents, you don't have to tell them anything. You don't even have to let them in your front door. You *especially* cannot be forced to sign anything. If federal agents do approach you, it is suggested that you call Party headquarters, (703) 524-2175, before answering questions.

One of our members reports how he effectively answered their numerous probing questions—with stony silence.

Wallace's Chief In Valley Fired

SAN ANTONIO — (AP) — The San Antonio Express-News quoted Bard Logan, George Wallace's Texas campaign manager, as saying he fired Vance J. Beaudreau Saturday from his post as district chairman of Wallace's Rio Grande Valley campaign.

Logan's announcement came shortly after an Express-News story appeared Saturday morning saying that Beaudreau was active in American Nazi party activities in Dallas in 1965-66.

THE STORY ALSO said Beaudreau was arrested there for circulating hate literature.

Logan, who appointed Beaudreau to the post he has held for the past five months, said in his announcement: "At

Gov Wallace's directions, I have severed Mr Vance Beaudreau's relations with the American party of Texas in all capacities, which includes his position in the state executive committee and that of district chairman for the Rio Grande Valley area,"

LOGAN ADDED, "This was done immediately upon learning of his possible connections."

Earlier Saturday Dave Robins, state campaign coordinator for Wallace, said, "Gov Wallace does not want the support of any member or affiliate of any American Nazi party or any other Nazi party. Further, he does not want the support of any individual, group or organization which advocates violence."

Classes in National Socialist Ideology

Dr. William L. Pierce, Ideological Officer of the NSWPP recently initiated a weekly series of lectures on National Socialist ideology for Party members and supporters. The series will include such subjects as racial science, racial history, fundamentals of National Socialism, the Jewish Question and Pan-Aryanism.

Special Activity for NSYM Members

The American Civil Liberties Union (ACLU) is a notoriously Jewish organization of left-wing lawyers, with offices in every major city in the country. ACLU lawyers specialize in defending Reds and Blacks (free of charge) whenever a civil rights case is at issue. In order to maintain a liberal complexion and avoid being branded as outright Reds, they will even defend National Socialists in cases where our Constitutional rights have clearly been violated.

The ACLU recently published the following statement: "Students [in high schools] should have the right to picket their schools. . . , invite any speakers of their choosing, publish newspapers without censorship, distribute political materials and wear political buttons.

"Schools should not restrict the appearance of a student's clothing. . . , discipline him without a formal hearing or open his locker without a search warrant."

Naturally, the motive behind the ACLU's taking this position is to prompt Blacks and Jews in public schools to raise mayhem and to destroy the authority of the school to exert any discipline.

The young National Socialist will see a wealth of opportunity before him at this time. He must, however, be willing to take on teachers and school administration alike. But with the ACLU to back him up, an NS student can now propagandize, recruit for the Party, agitate against Reds and publish his own student leaflets. The following tips will be of value to you in planning your activities:

- (1) *Insist on your rights!* Sooner or later you must expect to wind up in the principal's office for the usual long, liberal lecture. You will undoubtedly be told the sad old story about the "6,000,000 dead Jews" and the usual lies about "Nazi atrocities." But you should make it perfectly clear that you have the same Constitutional rights as of free speech any other American citizen, and that you will fight your case as high as the Supreme Court if they are denied you.
- (2) *Always take the offensive.* If Nazis are accused of crimes, counter with an exposition of the crime of Dresden, Hamburg, etc., of Mau-Mau crimes, and the crimes of Blacks, who are burning down our cities right before us, against Whites every day. Also attack with an explanation of the numerous, well-documented Jewish crimes and atrocities to tens of millions of Aryans in the countries the Communists have seized. If your rights are denied you, you can justifiably accuse the school authorities of not believing in the Constitution or free speech.
- (3) *Make an issue of everything they do to try to stop you.* Pass out your own leaflets with the theme of "Whites have rights too!" Let them know that if they try to stop you, they'll create another issue among the White students.
- (4) *As soon as your Constitutional rights have been violated, contact the ACLU in your locality and make an official complaint.* You can find out the address of their local office and get a copy of their new pamphlet "Academic Freedom in the Secondary Schools" by writing to their main office at 156 Fifth Avenue, New York, N.Y., 10010. Do not tell them who you are right away; when they find out, they may try to back out of helping you on a phony pretext. You will undoubtedly have to exert pressure on the ACLU in addition to the school administration.
- (5) *Never let opposition discourage you.* You can expect hostility from other students as well as the faculty and administration. But do not let this discourage you! If you keep pushing your activities, using every opportunity to promote National Socialism, you will inevitably win a sizable following among the student body.
- (6) *Be a model student.* Do not let your grades fall behind so they can slip you out of school or inhibit your activities on the excuse that you are neglecting your work. Maintain a neat appearance. At no time should you ever be a "wise guy". You can be adequately firm without being insolent.
- (7) *Don't be surprised if the school authorities have you examined by a psychiatrist.* Cooperate fully and answer all questions with complete honesty. Try to get a written statement from the doctor as to your mental condition.

As of this time, no U.S. student in a secondary school has taken his school's administration to court to have his rights enforced. If you want to be first, you must start now, while the school session is young, and before the Reds, Yippies and Blacks get the jump on you.
