## **Overwhelming Support for National Leader**

In response to the National Leader's recent call for a vote of confidence, 82.9% of eligible Members wrote in, with 99.1% of those responding giving their unqualified backing to the National Leader. An additional 5.7% of the membership cast late votes, which were not counted, giving 100% support to the National Leader. In addition there were scores of favorable Supporter votes, which were likewise not counted.

The results of this poll are a clear mandate for the policies of the Party which have been carried out under the guidance of the National Leader. They further establish the firmest possible foundation for launching the Party into fresh, new activity.

We sincerely trust that all National Socialists will now give the National Leader their fullest co-operation and loyalty and demonstrate a new solidarity in accomplishing the important tasks at hand. Should there be any who are unprepared to meet these basic requirements, they should submit their resignations at this time. We want to be able to count on the total support of the membership in under taking the Second Priority (which the National Leader will announce separately in a special mailing following the Bulletin), as well as in building the monolithic organization necessary to smash the enemy and bring about a National Socialist victory.

## **Elite Political Organization**

To accomplish the historic, revolutionary goals of National Socialism, the National Leader has given instructions for the creation of a special, elite political corps.

This elite formation, to be known as the *National Socialist Central Organization*, will comprise select, proven Party Members, who must meet higher standards than for any other Party formation. The NSCO will represent the inner hard-core of the Movement, and will complement the existing Member and Supporter categories in an organic National Socialist structure.

We all recognize what the Communists have accomplished through iron discipline and religious dedication to their cause. To think that we can defeat such an enemy and attain our goals by less dedication and discipline, by blasé hobbyism, egoistic individualism, or half-hearted dabbling is utterly asinine and foolish.

We must be *twice* as dedicated, *twice* as disciplined, *twice* as determined, *twice* as fanatic, *twice* as willing to make sacrifices, and *twice* as willing to work and fight for a National Socialist victory. NSCO members will personify this revolutionary spirit. Many have spoken of giving their lives for the Cause; NSCO members will be those who really mean it.

Members of the National Socialist Central Organization will be subject to the most rigid Party requirements. They will be expected to devote their lives to the success of the National Socialist movement. They will be required to give unconditional loyalty to the National Leader, and stand ready to perform any assignment within their capacity upon instruction. Those unable to fulfill a more active role as either full- or part-time members of the Headquarters Staff will be expected to *tithe*, which entails contributing 10% of one's gross monthly income to the Party.

An application form will be mailed with the next *NS Bulletin* to all Party Members in good standing. Those who wish to qualify for the NSCO should complete and return the application as soon as possible. Within three months after the receipt of a properly completed application form and the start of regular tithing,\* a Member will be notified whether or not he has qualified for the NSCO.

A special, distinctive NSCO badge is now being prepared, and it is hoped that the first members of the NSCO can be awarded their badges on 30 January 1969.

\*Heads of a household unable to contribute the full 10% may apply for special consideration by submitting a complete explanation of their situation.

### **Regular Membership**

In addition to the creation of a new elite NS organization, the strict racial and ideological standards for regular membership will be maintained.

Moreover, beginning 1 November all Party membership dues will be uniformly \$5 per month, except in cases of special, temporary hardship situations of which we have been properly advised. The former half-rates for wives of Party Members, students, and unemployed persons is being discontinued.

Application for Party membership can be made after a person has been an Official Supporter or NSYM Member in good standing for at least six months.

### **FBI Intimidation of National Socialist**

On 12 October Party Member Charles H. White of Asheville, North Carolina, led a group of NSWPP members and supporters from his area in a demonstration against Democrat Vice Presidential candidate Muskie at the Asheville airport. As Muskie started to speak, the National Socialists raised their signs which said "Stop Democrats and Riots—White Power". They were thereupon attacked by members of the Asheville Police Department, who threw some of them to the ground, and then kicked, hit and stomped the National Socialists in a brief but savage fray.

White left the airport to swear out warrants for the police who had assaulted him and his comrades. When he arrived at the Sheriff's Office, he was asked if he had been demonstrating at the airport. When he affirmed this, he was bodily thrown out by sheriff's deputies.

White immediately called the FBI to register a complaint against the Asheville Police Department and Sheriff's Office for a breach of his Constitutional rights. Mr. White talked with FBI Special Agent Robert S. Moore. The following sworn affidavit by Mr. White recounts their conversation:

#### **AFFIDAVIT OF CHARLES H. WHITE AND MRS. PAT ENGLE**

On October 12, 1968, at or about 7:30 p.m., Special Agent Robert S. Moore, of the Asheville, North Carolina, office of the Federal Bureau of Investigation, did wilfully and flagrantly violate Title 18, Chapter 13, Section 245 (b) (1) (B), United States Code (as amended by Public Law 90-284, of April 11, 1968). Specifically, the aforementioned Special Agent Robert S. Moore threatened to kill Charles H. White, a citizen of the United States residing at 61 Westwood Place, Asheville, North Carolina, members of his family, and certain of his friends. The threats by Special Agent Robert S. Moore against Charles H. White consisted in the following statements, or very similar statements not differing substantially from the following:

"You sorry son of a bitch. If you try to file a complaint, I will blow all of your group's goddamned brains out. I do not give a goddamn if you write to the President. If you do, I will kill you for sure. If I knew where you were now, I would come blow your brains out. If you come to the (FBI) office (in Asheville), you will not leave the building alive."

These threats were made during the course of a telephone conversation between Robert S. Moore and Charles H. White, as Charles H. White attempted to obtain information from the Asheville, North Carolina, office of the Federal Bureau of Investigation about filing a complaint of violation of his Constitutionally protected rights by local North Carolina law-enforcement officers who had viciously attacked him.

Mrs. Pat Ingle, a United States citizen residing at 76 Dale Street, Asheville, North Carolina, was with Charles H. White during this telephone conversation and heard all the above-mentioned threats.

Charles H. White, in fear for his life because of the above-mentioned threats, now requests the Attorney General of the United States to immediately prosecute Special Agent Robert S. Moore for the illegal act cited above, and he furthermore requests that positive and immediate steps be taken to protect him from injury, intimidation, and further threats of injury by Special Agents of the Federal Bureau of Investigation or other persons.

Having exhausted all possible recourse for local action, Mr. White and his family traveled to Washington, D.C. to register their complaint with the Justice Department and the main office of the Federal Bureau of Investigation. Legal counsel was obtained by Party officials and the foregoing affidavit was immediately filed with the Department of Justice and the FBI.

A period of two weeks will have to elapse before further action can be taken. If, in that time, the offending FBI Agent has not been fired and prosecuted, a suit will be filed in the Federal Courts.

Mr. White's experience points up several principles which should be borne in mind by National Socialists:

- (1) Do not take for granted that all FBI agents will give fair and impartial treatment to National Socialists.
- (2) If any police official or federal agent attempts to usurp or infringe upon your rights, or in any way intimidate you, it is your duty to do everything legally possible to have your rights upheld. With the possibility in mind that you may, at some time, have to seek redress in the courts, you should always have at least one competent witness with you whenever dealing with the police, and especially federal agents.

#### **Swastikas Over Dallas**

Members of the NSWPP unit in Dallas, Texas, recently gave local residents a treat they won't forget for a long time. At the busiest part of Saturday afternoon, two large helium filled balloons bearing enormous Swastika banners were launched near the downtown shoppers' area. In spite of the protests of the Jews, the NS balloons were permitted to drift slowly across the Dallas Skyline, off into the Texas sky.

For a very small investment these National Socialists were able to let many thousands of people for miles in every direction see our mighty, Race-saving symbol. The banners were made of inexpensive colored crepe paper, which is quite satisfactory for this project.

#### **New Personnel**

On 14 October Party Member Robert Homan joined the NSWPP Staff in Arlington. Mr. Homan's field is research and writing. Readers of *NATIONAL SOCIALIST WORLD* will remember Mr. Homan's excellent essay "Newspaper Control in America" which was published in issue number four.

#### **Warning on Ammunition Shortage**

A representative of the NSWPP weapons sales division, NS Arms, was given confidential information by the owner of a large gun and ammunition wholesale business that a serious shortage exists for almost all hand-gun ammunition. This scarcity comes as a result of government pressure on the large American manufacturers to slow down or halt ammunition production and increased restrictions on the importation of foreign made cartridges. The public is just beginning to feel the pinch now that retailers and wholesalers are running out of ammunition without getting new shipments from the factories.

This sneaky, Jewish method of disarming Whites results from the failure of the 91st Congress to pass an all encompassing gun registration act, which would permit the quick and easy confiscation of all privately owned weapons on a moment's notice from the Jews.

In light of this rapidly developing ammunition shortage, National Socialists are urged to buy ammunition for their handguns in whatever quantities they can find it. In addition, you should get a riot gun or similar shotgun if you haven't already. 12 ga. shotgun shells will probably still be available for a while after all other ammunition has been taken off the market.
