FROM BEHIND FEDERAL BARBED WIRE,
GREETINGS AND RACIAL SALUTATIONS:

In exactly one year from today, I should be released from the prison of the Federal Bureaucracy. At that point in time, I will have served five years and ten months and seventeen days in prison for an action to which another has confessed. It has been a long stretch of prison time and one that has been served in the worst prison in America, as far as the Federal System is concerned. For Marion, Illinois is termed the "Devil's Island" of the federal prison system by the federals themselves. There are no "furloughs", "camp privileges", private typewriters, private TV's, golf courses, swimming pools or any of the other much publicized "goodies" for Marion prisoners. That is alright by me. You are a special enemy when they send you here. To be tagged as an enemy of an evil as rotten, corrupted and totally amoral as the Federal Bureaucracy, is an honor to be worn like a medal on a uniform.

During the past years, we have tried every legal means to effect a release. The efforts included appeals to the courts in Detroit. One of these appeals has now been in the courts for almost three years. When Judge Gubow died, who was our judge and jury, the appeal process got mired down in the usual decadent procedural confusions. It is still being untangled. In the meantime, I filed an independent action, which another prisoner and myself drew up, to compel the U.S. Parole Commission to grant me a parole. This is pending before the Court controlling this area, which court is in St. Louis. Since I have met each and every measurement to qualify for parole, and since such measurements are the federals' own guidelines, the fourth denial of parole is not only immoral but illegal. That should not come as a surprise to anyone, for everything that this federal monstrosity has done in our case has been just that. The mark of the federal beast is falsehood for it lies and has lied for many years to its own people and to the world. It is a liar from top to bottom.

During the years in prison, I have maintained a steady flow of correspondence to over 500 individuals. These include members and organizations of varied tactical methods, but all RACIST. Beyond all else, above all else, in spite of all else, I am a RACIST. I believe in the value of the White Race. A pyramid built upon IDENTICAL building blocks is capped by achievers of those blocks alone. In that cause, I have labored even while in prison, (even after working all day in the prison factory), through verse, articles and correspondence; through teaching of teachers inside prisons who will emerge as teachers outside beyond these wires. I have held the station to which I was assigned by our White God.

It has not been easy. Not for me inside, nor my wife and family outside. It has been harder for my wife because she has had to bear the financial burdens of keeping the family intact. She has maintained the family in a manner designed to assure our children a normal family life despite the conditions and apartness involved. The children were only 10 and 14 years old at the time of the infamous 90-man raid of our home. Now our daughter is a young lady of 21 and our son is 17 years old, both grown and in the adult world. My wife of these 32 years of marriage has endured, has striven and found and achieved. She is my Racial Comrade in Arms forever. She gives me strength to be strong within these wires. We have endured. We have kept the Faith. We shall yet prevail.

Thus, Racial Comrades, who are our brothers and sisters in the fullest sense of these terms, we send to you greetings. We tell you that the fight is not lost. We tell you that despite the gates of Hell itself which lie in Washington and Moscow, we shall prevail. TOMORROW BELONGS TO US.
