D.C. Hippies Humiliated

On Saturday, April 5, Members and Supporters of the NSWPP distributing literature to White tourists in Georgetown, the hippy haven of Washington, D.C., were attacked by a mob of hippies which outnumbered them three to one. Fortunately, only a few bruises were suffered by the National Socialists, but they were determined that it would take more than a band of unwashed degenerates to run them out of the nation's capital. Plans were laid for effective resistance to any attacks by the hippies for the following Saturday's distribution.

The next Saturday found the Party's distributors tripled in strength and fortified with Chemical Billy to even up the odds in case of a major attack. The distributors planned to put only four men out in armbands passing out literature to act as bait, while the main group of Party activists mixed with the crowd until the violence started.

After a very short time on the street, the National Socialists were surrounded by fifty or more "flower children" who attacked the small group of Party members with bottles and lengths of plank. At that point, the other activists with tear gas got into the act. The four "decoy" National Socialists were backed up against a brick wall, while the ones in the crowd freely "maced" every bearded creep in sight. A number of hippies who were downed by the chemical spray were accidentally stepped on and hurt rather severely. Meanwhile, a group of Blacks across the street hurled bricks and bottles into the crowd, attempting to strike Party people, but only causing general confusion instead.

Before police could arrive the melee had spread into the street and paralyzed traffic on Wisconsin Avenue, one of the busiest streets in the nation's capital.

Unable to decide when to arrest

Unable to decide whom to arrest, the police took everyone involved to the station and issued subpoenas to all Party personnel as well as the hippy leaders for a hearing in the district attorney's office the following Monday. The purpose of the hearing was to determine which side started the riot and who should be locked up.

The hearing resulted in nothing more than a strong warning that there had better be no more fighting from either side. But, to everyone's surprise, the District Attorney approved the use of chemical sprays for the self-defense of anyone attacked while passing out literature.

The D.A.'s decision not to move for any prosecutions set the stage for a real show-down in Georgetown the following week. Both sides busily mustered their maximum strength to test whether or not the NSWPP could practice freedom of speech in Washington, D.C. The following weekend included the National Headquarters celebration of the Fuehrer's birthday, which some Party Members and Supporters outside the immediate Washington area were coming to attend. This announcement was mailed to all National Socialists on the Eastern Seaboard:

A BIG Weekend is coming up April 19, 20.

April 19: (Saturday) The most important literature distribution of the season is planned for Georgetown. The Hippies have sworn to make trouble for all National Socialists who try to distribute literature in Georgetown, and the D.C. courts have okayed the use of tear gas for defense of those distributing. Nevertheless, WE NEED SOME MUSCLE. Meet at National Headquarters at noon Saturday.

April 20: (Sunday) Commemoration of the 80th Birthday of Adolf Hitler will be observed. A buffet dinner and appropriate celebration will be held in an outdoor location. Bring your guns for a round of target practice before dinner. Meet at headquarters at 12:00 noon.

The hippies, meanwhile, got a permit for a nearby park in which to hold an anti-Nazi rally as a prelude to another attack. Somehow, they obtained and reprinted the above Party announcement along with the NSWPP leaflet passed out the previous week, "The Real Problem in D.C." Together with these, they circulated the following announcement in their community:

We the Black people, Hippies, and other minority groups feel that this type of propaganda should not be tolerated. If your views agree with ours, please support us and come to an anti-Nazi Party Rally. The Rally will be held at Wisconsin Ave. and M Street N.W. at 12:00 noon. Please tell all your friends to come and support us and be there no later than 1:00 p.m. Please read the following two pages of propaganda that was passed out by the American Nazi Party.

THEN THINK!

In addition to the local hippy community, a large number of D.C. Blacks and members of several "outlaw" motorcycle gangs pledged to support the hippies in running the Nazis out of D.C.

By the time Saturday arrived, rumor had it that a terribel fight would result if National Socialists went to Georgetown, and everyone was braced for the worst. Fortunately, a large number of National Socialists had turned up for the event.

In spite of all the build-up, the distribution, which the hippies promised to make "the worst Nazi defeat since '45" was a completely anti-climactic event. The hippies held their rally, and plenty of their fellow flea bags showed up, but, to their bewilderment, only a handful of their Black trouble-makers showed up and their motorcycle supporters "copped out" altogether.

The Party distributors used the same plan as the previous week, using only a dozen men to hand out the literature to passers-by while the majority waited in the crowd for the "fun" to begin. Having experienced these tactics the previous week, the hippies realized that there was more to our group than met the eye. Without their Blacks to do the fighting for them, the cowardly flower children could do no more than gather in a crowd across the street and shout obscenities and threats.

After three hours the Party distributors had passed out all their literature and left for their cars, followed by a huge crowd of irate hippies. In spite of the shortage of police protection, the huge crowd of yellow creeps couldn't muster the courage to do anything but scream threat, and tell us what would happen "next time."

80th Birthday of the Fuehrer Celebrated

On April 20, 84 National Socialists gathered at a rural Virginia setting to mark the 80th birthday of Adolf Hitler. During the morning the weather appeared ominous, but by noon the sky had cleared up completely for a day of perfect "Hitler weather."

The day opened with pistol and rifel shooting competition, and was followed by a delicious buffet including ham, fried chicken, potato salad, rolls and cakes.

At twilight a special ceremony was held. In his address, National Leader Koehl termed April 20, 1889, the most significant date in Aryan history. He described the advent of Adolf Hitler—as creator of the race-saving National Socialist idea and founder of our historic Movement—the dawning of a new era for our race.

In concluding his remarks, the National Leader took up the question: Is Hitler still alive? Noting that the spirit of Adolf Hitler transcends the barriers of time and space, he declared that Adolf Hitler is alive when, among other things, there is a National Socialist party in America today, when a White Power Message reaches thousands of persons each week with the truth, when a small number of National Socialists can thwart an entire Marxist treason demonstration, or when a White man joins the Movement and sacrifices life, limb, and substance so that his children will have a better future. He declared that Adolf Hitler was alive forever in the National Socialist movement of Aryan man, and that, far from being dead, "Hitler is the future!"

To the strains of the Badenweiler March, the Fuehrer's personal march, the traditional bonfire was lit. As the flames leaped upward toward the dark night sky, the Horst Wessel Song was played, followed by the militant anthem, White Men to Arms.

For the month of May, the activity for all Members and Official Supporters will consist of publicizing the plight of our imprisoned comrade Rudolf Hess. The following letter, published in the Washington Evening Star, is an excellent example of what one can do to bring attention to the inhuman treatment of the man who sacrificed himself to try to end the holocaust of World War II.

Rudolf Hess

SIR: Today marks Rudolf Hess' 75th birthday. Imprisoned for almost 30 years now, Hess is the sole inmate of Spandau, a prison built to hold 660 men and maintained at a cost of \$200,000 yearly.

Technically, Hess was condemned to life imprisonment for "war crimes." When he flew to England in May, 1941, his only "crime" was trying to end the war between Britain and Germany. For his gallant attempt he is now languishing in Spandau as a prisoner of peace.

The vagaries of the charges against Hess, as well as the highly questionable ex-post-facto nature of the Nuremberg trial, make Hess' conviction all too clearly one of a victor's "justice" against the defeated.

As Hitler's deputy, Hess could no more have expected to walk out of the Nuremberg trials a free man than Joan of Arc could have relied on the impartiality of her English captors to rescue her from the fiery death that awaited all heretics after they received their "day in court."

Hatred and fear, not justice, determined the fate of Rudolf Hess at Nuremberg. His "crime" lay not in what he did but in who he was. Not only was he the hated infidel who dared to think forbidden thoughts, but he was a leading apostle of the enemy creed.

Hess is now in the twilight of his life. Were it not for Soviet opposition, claims the Allied control commission, Hess would have been released long ago. It's interesting that the Western powers should be hesitant in freeing Hess without Communist approval, especially since the Russians have continuously displayed their contempt for the agreements signed at Yalta and Potsdam regarding Germany and Berlin.

Soviet Russia lays no claim to being a defender of justice. But what about the Western democracies? Will we allow an injustice to continue? The imprisonment of Rudolf Hess is an acid test for democracy. Rudolf Hess' continued imprisonment will be a searing indictment against democracy as being little more than a system which preaches justice and mercy for all but in reality hides its hypocrisy and intolerance under a cloak of hollow, meaningless cliches.

How long will Rudolf Hess remain a "prisoner of peace?"
