"FREE RUDOLF HESS!," "BLACKS HIRED—WHITES FIRED!," "WHITE POWER!" and "NATIONAL SOCIALISM IS FOR THE WHITE MAN!!." Jews Cash In On Right Wing Growth

"Statecraft" is a new newspaper launched by an enterprising Jew, Daniel Paulson, in an effort to cash in on the inevitable growth of pro-White, anti-Black sentiment in America. Although outwardly anti-liberal, "Statecraft" naturally makes no mention of the Jewish degeneracy or Jewish control of America's propaganda. Indeed, "Statecraft" is just another extension of Jewish control of the vital opinion-forming media.

Recently a number of Party members and supporters received in the mail an unsolicited copy of "Statecraft." These same people have from time to time, received mail from a California mail-order patriot named James K. Warner who operates a paperback book business under the name "Sons of Liberty." Warner has a large mailing list which he's compiled over the years by stealing the lists of every organization he could penetrate. He regularly rents his list to anyone, including Jews, who will pay his price. "Statecraft" was Warner's most recent customer.

As America continues to decay from the presence of Jews, hippies and Blacks, there will be an ever-increasing demand for organizations and individuals which offer an alternative to the broad masses of Whites. As this happens, we can anticipate a proliferation of "rightist" groups. Without a doubt, every yellow conservative society down to the militant conspirator-cliques will multiply themselves a hundred times as the Aryan population begins to look for an answer to System politics. Predictably, these groups and individuals will fall into two main categories: (1) those who actually believe they have the right answers or who believe they are endowed with some special capacity for leadership, and (2) those who will cynically "cash in on a good thing." Some groups that come along will probably develop large but temporary followings. Some groups, like "Statecraft," will undoubtedly be well financed by the Jews to give an outward appearance of success and great accomplishments. Others will surely get a king-sized build-up from the press.

Every National Socialist must be vigilant for organizations which in any way might hinder development of the National Socialist Cause.

Epilogue on a Fraud

In November of last year, readers of the Bulletin were cautioned against any dealings with a rejectee from the NSWPP by the name of John R. Bishop. Bishop was dismissed from the Party in 1967 when it was learned that he had failed to make certain important disclosures on his application for membership concerning his police record: he had spent time in a federal prison for mail fraud. After his dismissal from the Party Bishop proclaimed himself "Commander" of the Party and set about making himself and the National Socialist Movement look foolish from his hometown of Davenport, Iowa.

Mr. Bishop's chickens came home to roost last week as federal agents grabbed him and several of his "Party members" for counterfiting. Bishop had big plans for using National Socialists to pass his phony currency for the enrichment of his bank account. The following newspaper stories give details concerning Bishop's arrest, as well as some backgroud on his involvement with mail fraud.

When arrested Wixom said he lived in Hillsboro, Iowa, which is about 25 miles west of Burlington.

Bishop, McGivern and Wixom all were charged with conspiracy in the indictment. Wixom was accused of counterfeiting and Bishop with buying and possessing counterfeit

The indictment says McGivem and Wixom obtained a printing press and set up a Peoria. Ill. The equipment was seized in an April 4 raid. James B. White. 39. of Peoria. was indicted April 2 for passing \$100 notes.

Bishop had been under surveillance in the Davenport area in connection with reports last November that he had succeeded the assassinated George Lincoln Rockwell as national commander of the American Nazi party. He had previously claimed he was lowa commander.

U. S. District Atty Richard Eagleton of the Northern Illinois district, said Bishop told him he planned to have American Nazi party members

> Bishop's involvement with law enforcement dates back to 1943 when he was only 17. As far as Clinton is concerned. Bishop only has a record of traffic violations. A 1949 entry involved use of the mails to defraud.

In 1951, while Bishop was living in Clinton, he announced he would be a candidate for mayor. He later withdrew as a candidate when it was pointed out that in 1949 he had been picked up in connection with a charge of using the mails to defraud. He later moved to Davenport and has headquartered there. More recently he has advertised himself as a mortgage broker

Conspiracy charge

Eagleton said that about \$20,000 in counterfeit money had been recovered.

Each of the three defendants is charged with conspiracy to counterfeit. In addition, McGivern is charged with aiding and abetting the printing of the money, and Wixom and Bishop are each charged with dealing in counterfeit money and possession of counterfeit money.

The conspiracy charge carries a \$10,000 fine and up to 5 years in prison. Aiding and abetting the printing possession both carry \$5,000 fines and up to 15 years in prison. The dealing charge carries a \$5,000 fine and up to 10 years in prison, Eagleton said.

Epilogue on a Fraud

The tragedy concerning Bishop is that he managed to dupe several honest people into signing up with his "Party" before they had any idea what he was going to use them for. Fortunately, none was with him long enough to have any part of his "easy money" scheme.
