On November 10 Fresno, Calif. became the most recent city to have a local White Power Message unit installed. Under the sponsorship of Mr. William G. Kirstein, an active Fresno National Socialist, the message service began broadcasting at full capacity within just a few hours after installation. Mr. Kirstein's Activity Report received a few days after installation states: "Almost no effort in publicizing it and our single line is 'jammed' day and night. We'll have to put in another unit to handle the load of calls within the next week or two."

After the message unit began operation, the inevitable smear came in the local Fresno paper. The article reproduced below from the Fresno Bee of Nov. 19 demonstrates the Jews' dissatisfaction over the White Power Message operation.

**PTT Says It
Cannot Bar
Hate Message**

Freedom of speech is permitting a racial hate recording to be used in Fresno according to telephone company officials.

The recording has received a lot of attention in the community with the number being passed along by word of mouth. A local radio station played it over the air and the message was discussed in at least one high school. A television station commented on it.

Jack E. Oliver, division manager of the Pacific Telephone and Telegraph Co., said free speech rights guaranteed under the First Amendment of the Constitution prevent the firm from taking action against the "dial-a-hate" recording, which blames Negroes for the rising number of violent crimes here.

PUC Ruling

Oliver said State Public Utilities Commission regulations require the company to provide telephone service for any message to anyone who pays for it, on the condition obscene language is not used.

Michael St. Peter, San Francisco counsel for the company, added the only way Pacific Telephone can stop use of the recording is for a law enforcement agency to obtain a court order against its continuance.

The recording, repeated to anyone who dials a certain telephone number, is by a Southern-accented man who says he is "with" the National Socialist White Peoples Party, formerly known as the American Nazi Party.

It offers "free information" to those who write an Arlington, Va., address.

Not Named

The message does not include the name of the local person who placed it, but the telephone company says it has been billed to Jim Scott, an insurance broker with offices at 1220 N. Abby. Scott, a participant in various

ultra right-wing causes and a backer of former Alabama Gov. George Wallace for the presidency last year, declined comment when asked about the recording.

"We are not happy about the fact we must provide service for people to use it in this fashion," said Oliver. "We don't want to be a party to upsetting the serenity of the community."

Dist. Atty. William C. Daly said the use of the recording is a federal matter and his office has not yet been asked to investigate.

"If it is apparent the federal agencies are able to do nothing, my office will consider it," he said.

Asked whether he thought the recording could be considered a violation of incitement-to-riot laws, Daly said he doubted it.

The nearest case he could think of involved the Criminal Syndicalism Act, which he said was recently declared unconstitutional by the Supreme Court. In the case, some militants urged "revolutionary-type" acts of violence. The court held mere words, unaccompanied by commissioning of acts, did not constitute a punishable offense, Daly said.

Position on Vietnam Spelled Out

The enclosed White Power Message was played to callers in the Washington area during the anti-war Moratorium demonstration of November 15. In this recording the Party's position on Vietnam is spelled out in no uncertain terms.

It is important that you have a crystal clear understanding of this issue when explaining the Party's position to others. If you don't, you can easily be caught in the snare of supporting the System's war. Remember, the capitalist policy-makers have determined to keep this war going, in spite of the undeniable ability of the United States to win a victory in just a few weeks of unrestrained warfare. But far too many of the President's chums in the war industries are growing fat and rich from big contracts for materiel and armaments awarded them by the Nixon regime. This, among other reasons, is why Nixon will not push for victory.

Large quantities of literature which explained the Party's position on the Vietnam war were passed ou to non-Jewish participants in the moratorium demonstration. To the great surprise of the National Socialists involved in these distributions, very little hostility was encountered. In fact, a more favorable response was prevalent than is usually received from a cross-section of the average public which is encountered on distributions. When the NS position was fully explained to the young protesters, many expressed a strong interest in the ideas of the Party.

A sample copy of a pamphlet recently produced is enclosed: *To Aryan Youth*, by Walter Gross. This is a remarkably lucid, actually poetic statement of the National Socialist position on race.

Although addressed to the youth of Germany during the 30's, it's message is universal for all Aryan men of the world. In fact, today these words ring even more true than they did thirty years ago.

Position on Local Group Activism

National Socialists in many parts of the country have begun banding together for more effective group activities. Because there has been some misunderstanding among some National Socialists about the role they can most effectively fulfill in building the Movement in their communities, our policy is spelled out: Because of the great task of making our true message known to the public, we urge National Socialists to regularly engage in Party work which will bring them into greatest proximity with the public. In some instances it will be difficult for individuals to engage in activities which might result in publicity. However, the danger of seeing your

name in the headlines as a National Socialist is often exaggerated and this possibility should never be used as an excuse for "ducking out" of activities. The dangers of being "exposed" can be kept to a minimum as long as one sticks to the activities suggested in the Bulletin.

However, if conditions make it impossible for you to participate publicly on a regular basis, you should then contribute funds to permit activism for others. Buying large quantities of newspapers, for instance, is one way that a person who cannot become involved in street activities can support activities in his locality. Whether an individual who works with other National Socialists in his locality contributes money for activities or participates in them, it should be clearly understood that any spreading of defeatism or dissention is considered grounds for his removal from the group. Each National Socialist must make it his personal responsibility to create an atmosphere of enthusiasm for the work of his group. He must also see to it that no defeatism or discord is tolerated within the group. Our task is to create dissention among our racial and national enemies, not among ourselves!
