Latest Issue of Newspaper Out

The latest issue of the Party newspaper WHITE POWER is now in the mail to all subscribers. Many will have received their copies by now.

WHITE POWER readers will immediately be struck by the high-quality appearance and the extra-potent message of this latest issue. Therefore, a longer-than-usual run was made this time to insure wider-than-ever distribution across the country. You are urged to response promptly in ordering quantities for mass distribution in your locality.

In order to make the distribution of WHITE POWER wider than ever, the Party is prepared to ship members and Official Supporters in good standing, any reasonable number of newspapers on consignment for sales in their cities. Any request for papers on consignment must be accompanied by a clearly worded pledge to pay the bulk rate price and shipping costs within a reasonable time. You are also asked to indicate a deadline by which you will send payment for the papers.

Consignment shipping of the Party newspaper will eliminate the impasse of moneyless National Socialists who have been unable to order bulk quantities for selling in their communities. Those who do not have funds immediately available for large purchases can receive shipments and pay for them after they have sold the papers on the streets and door-to-door. It will also be possible for them to make a small profit for either sustaining their own expenses or to contribute to the Party. This is a good opportunity for students and construction workers whose jobs taper off during the winter. Commander Rockwell Still Denied Right to Proper Burial

The U.S. 4th Circuit Court of Appeals has denied Commander Rockwell's right to a proper burial. In a hearing of the case on Nov. 24, the Court held that Commander Rockwell, having served the United States honorably in two wars, was entitled to burial in a national cemetery, but without any National Socialist trappings or ceremony, a right routinely afforded members of "approved" organizations. The NSWPP has kept this matter in litigation for over two years contesting the Army's refusal to permit Commander Rockwell a National Socialist funeral is a violation of the First Amendment to the Constitution.

The Party's stand on this issue is firm: America's greatest martyr will not be given a second-class funeral. Commander Rockwell will be buried only when he can be put to rest in a manner which he would have desired and which would have suited his life's work and his great sacrifice, that is, a ceremony with full National Socialist honors befitting one of the greatest Heroes of the Movement. Before Commander Rockwell is put to rest without a proper ceremony the Pentagon walls can come tumbling down. There will be *no* funeral until the Army reverses its biased stand against this fallen Hero!

Post of Midwest Co-ordinator Vacated

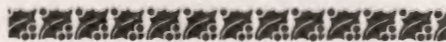

Until that time organizational activity will be carried out under the auspices of National Headquarters. A Yuletide Reminder

Again U.S. main streets are clogged with multitudes of desperate shoppers, most of them White working people, spending hundreds of millions of dollars in Jewish-owned department stores. Much of this hard-earned money is spent on inferior merchandise at ridiculous prices.

It is really sad that this great spending orgy has over-shadowed the true Aryan significance of this season, which was so joyful to our ancestors. This celebration developed over 10,000 years ago as a time for showing reverence and respect to the great powers of Nature. Our Teutonic forebears celebrated the arrival of the shortest day of the year (Winter Solstice, December 21) as the Chief Festival of Yule. To them it meant that the sun would soon return and the days would soon begin growing long and warm again. There was great admiration in their hearts for the power they could depend on to keep their seasons running rhythmically. This season was beheld by them as a time for showing this Divine Power the reverence it deserves, and it also became a tradition to celebrate joyfully with one's family and fellows.

Many of the trappings we associate with this season had their origin in this primeval celebration: the decora-
tion of the green tree, the green holly and mistletoe—symbolic of the return of verdant life—the wassail bowl, the burning of the great Yule log—representing the power of the sun—and displays of gaily colored candles or lights.



Much gift buying during this season is done at the expense of Party contributions. So if the giving of gifts is part of your family's Christmas ritual, it is hoped that you will not leave the Party out.

Activity of the Month

December's Activity of the Month calls for National Socialists to do their part in calling attention to the dreadful injustice of Rudolf Hess' imprisonment. This will be the 27th Christmas of this steadfast National Socialist behind

bars. At this time he is being held in a British military hospital for treatment of his ulcerated stomach. This is the first time in over 24 years he has been outside the walls of the cavernous Spandau prison where he is the sole inmate. In spite of Hess' deteriorating health, his four-power captors will not relent in their persecution of him. They will not relent because Hess will not give them what they have been waiting so long to get from them: a denunciation of Adolf Hitler and National Socialism. With these Hess could, without any doubt, buy his freedom any day.

The following "Letter to the Editor" which appeared in the November 12 edition of the Providence Evening Bulletin sheds much light on Hess' inhumane treatment. It also points up the great mileage in writing letters of this type to the public forum of your local newspaper. Occasionally a well-worded letter will be published in spite of its antagonism to the Jews.

'The World's Most Expensive Prisoner'

On the first of November 1969 a platoon of allied soldiers once again moved into Spandau, West Berlin to begin their month's tour of duty at the prison, one officer and 28 men, not to mention a warden and a medical officer to protect the world's most expensive prisoner, Rudolf Hess.

How much longer is this ritual international changing of the guard to go on?

How much longer the farce of running and staffing an immense prison for one elderly man?

Who's afraid of Rudolf Hess? The Russians apparently.

Many distinguished people have pleaded for his release including Lord Shawcross who led the British prosecuting team at Nuremberg, A. J. P. Taylor, Jean Anouilh, Lord Russell of Liverpool, Andre Francois-Poncet, and the famous German resistance hero Pastor Neimoller. They

have been unsuccessful. Secret four power talks also have failed. The Russians will not give Mr. Hess up, and they will not even consider transferring him to a smaller, less soul and mind destroying institution, and they don't have to since the Western powers are reluctant to make an issue out of it.

The attitude of the Western powers sums up the awkward moral problem the case poses: Mr. Hess is a legal curiosity, and he may be a political pawn.

Men usually identified with humanitarian causes like Senators Kennedy and Fulbright have responded negatively to appeals. Pope Paul VI has not even replied to the appeals of Frauella Hess.

Mr. Hess himself complicates the situation. The appeals infuriate him. When he learned that his wife had written to the Pope, he rebuked her harshly. He recalled the story of Baron von Stein. Banned

from Prussia, by Napoleon, he had dictated a plea for mercy, written by his wife. Historians said Mr. Hess, regretted this stain on the great man's character. "Do you want me to go down in history like that man, with a stain on my character? No, you do not. And so understand: my honor is more precious to me than my freedom."

If, unable to obtain the release of his father, Rudolf Hess, or have him removed to more reasonable quarters, his son Wolf informed me that he, and Mr. Hess' attorney have submitted the following requests to the Spandau administrators:

The removal of book censorship (the books and newspapers he sees are often just faceted words between black penciled-in blocks);

To be allowed a watch;
To extend his afternoon walk in the garden (it is now 30 minutes);

To see his lawyer every

three months, as he has not chosen to see his family;

To have an electric bell in his cell, so that he can call the warden, should he be taken ill during the night;

To receive candy from his family, once a week, as he does not smoke.

To have a radio;
To make tea and coffee,
To let him decide when to turn the light off (it is switched off at 10:00 p.m.);

To let him have his reading glasses before 6:00 a.m. as he likes to read, if he cannot sleep; and finally—

To allow him to bathe daily, instead of weekly.

None of these requests has been met. I, and the many other members of the Freiheit fur Rudolf Hess Movement think that the above petitions should be granted to this great German hero former Reichminister Rudolf Hess.

Letters to the editor are one small way of calling public attention to this cruel injustice. Leaflet distributions, taking signatures on petitions for Hess' amnesty and picketing of public buildings demanding his release are other activities which are encouraged at this time. Enclosed with this issue of the Bulletin are several little stickers with the slogan **FREE RUDOLF HESS**. These will assure *everyone* the opportunity of doing something for Hess during this drive.

A highlight of the free-Hess drive will come during December 22, 23 and 24 when National Headquarters will sponsor an around-the-clock vigil in front of the White House in Washington demanding Hess' amnesty. Vigilers will stand beneath a billboard-type sign which will include a huge picture of Hess with the wording: **FREEDOM FOR RUDOLF HESS — THE PRISONER OF PEACE**. Vigilers will pass out leaflets like the one enclosed which explains the true story of Rudolf Hess' imprisonment.

This vigil offers a rare opportunity for National Socialists to make a contribution to the fight against this scandalous international crime. National Socialists on the Eastern Seaboard are asked to be present if at all possible to stand in the Hess vigil. Students, in particular, are requested to come to Washington to participate in this activity. All who come will be guaranteed a place to stay. Right now, today, Rudolf Hess is making a sacrifice for the ideals of National Socialism. For 27 long years this fine man has lived a nightmare of solitude because of his heroic attempt to put an early end to World War II. For almost that entire period he has been without contact with his family. Hess has become more than a man unjustly imprisoned. He has become a symbol for the self-sacrificing idealism which is part of the National Socialist faith. He has also become a symbol of the double standard applied to National Socialism by communism and liberal-Jewish democracy alike.

Don't let Hess be forgotten. Do something for him this Christmas!

"When the new year comes the mind is turned toward the future; what will it bring? In the evening when the sky is clear Jupiter shines into my cell with a brightness I have never seen before.

"From the chapel comes beautiful music played by Funk; then grammophone records. Beethoven's 3rd Symphony, the Appassionata, and finally Schubert's 'Tod und das Mädchen.'

"My thoughts are with all whom I love, with the living and the dead. . . ."
