Interest in Upcoming NS Congress Grows

Members and supporters across the continent have been showing an unusually large amount of interest in this year's North American Congress over the Labor Day weekend.

The Congress, which will be held 5-7 September in the Arlington area, will feature Party speakers from the U.S. and Canada and is expected to draw a large number of National Socialists. It will be the second such gathering since the Second World War.

All members and supporters in good standing of the National Socialist White People's Party, the World Union of National Socialists, the National Socialist Youth Movement and the National Socialist Liberation Front are invited to attend. To be eligible, make sure your dues or pledges are paid up in advance.

Fight to Use School Auditorium Continues

The Party's fight to use Arlington public school facilities for political rallies entered a new phase on 30 July as the 4th U.S. Circuit Court of Appeals upheld the denial of use of the Yorktown High School auditorium, which the Party had requested for a meeting to celebrate the 81st birthday of the Founder of our Movement, Adolf Hitler.

The decision was reached by a three-judge panel which included Harrison Winer, John Butzner and Nixon's conservative darling, Clement Haynsworth. Completely overlooking the larger constitutional issues, the court based its ruling on totally extraneous, unrelated and irrelevant issues--such as the separate picketing of the home of a local school board official!

The legal battle will now go to the U.S. District Court in Alexandria. The Party had last year sought to use the same Yorktown High School facilities for the North American Congress.

Commander Meets with Ohio National Socialists

Commander Koehl on 9 August met with Northern Ohio National Socialists at the new NS bookstore at 9905 Lorain Avenue in Cleveland. On hand were Party members and supporters from that city and the Akron area.

At the meeting, the Commander officially named Charles Lawrence the Party's Organizer for Northern Ohio. In this capacity, Mr. Lawrence will be responsible for initiating and co-ordinating Party activity in that part of the state, which includes Cleveland, Akron, Youngstown and Toledo.

Mr. Lawrence, who manages the NS Bookstore at 2030 Front Street in Cuyahoga Falls, has been very active in promoting National Socialist activity in the Akron area.

Party Supporter Wins Court Ruling

Cleveland Judge Herbert R. Whiting has ordered that city's police department not to destroy the weapons, Swastika flags and National Socialist literature of Party Supporter Frank Zoretich. The decision was related to another case involving politically-motivated charges of "possession of a machine gun" against Zoretich.

Jew Lawyer Picketed in New Orleans

When William Kunstler, the Marxist Jew lawyer who defended the Chicago 7, arrived to speak at New Orleans' Tulane University on 23 July, he was met by an appropriate NS reception. Kunstler was in town to argue the case of Black extremist H. Rap Brown.

Local National Socialists led by Dave Duke, a student at Louisiana State University, confronted those who showed up for the speech with oversize signs declaring "Kunstler is a Communist Jew" and "Gas the Chicago 7." The largely-Jewish crowd screamed for blood in typical fashion--all of which failed to intimidate Duke and his comrades.

Duke was afterwards interviewed by WNOE, one of the most popular radio stations in New Orleans. The interview was carried every hour all evening and included a good portion of the local White Power Message, along with the telephone number: (504) 522-0743.

The New Orleans WPM went on the air 23 July and has attracted considerable area response. Coupled with local literature distributions in shopping centers and downtown areas, it is helping to make a strong National Socialist presence felt in that city.

NS Youth Recovering from Gunshot Wound

Don Black, an NSYM member from Huntsville, Ala., is in good condition and recovering rapidly from a 25 July shooting incident which left him with a serious lung wound. The incident occurred in Savannah, Ga., where Black had been engaged in local political activity over the summer. For several days he was on the critical list and not expected to live.

Back in Huntsville, the 16-year-old activist has done much to familiarize fellow students and other local persons with the Party through extensive distribution of National Socialist literature and the newspaper White Power.

NSYM Unit Organized by Pennsylvania Youth

Racial comrade Robert C. Evans of North Versailles, Pa., a Pittsburgh suburb, is organizing an ad hoc unit of the National Socialist Youth Movement in his area, called the National Socialist White Students' League. He reports that the response of local high-school students to National Socialism has been very favorable.

NS Activity Up in Los Angeles

From the West Coast, Joe Tommasi reports that interest in the Movement in Los Angeles is stronger than ever. As tangible proof, National Headquarters has noted an upsurge of new inquiries and supporter applications from that area in recent months.

All members and supporters in Southern California are urged to visit the Party bookstore at 4375 N. Peck Road in El Monte, and see for themselves the great things that have been, and are being, accomplished there.

Bond Set for Bill Gould

Bill Gould, the young Los Angeles activist who was arrested on a trumped-up "concealed weapons" charge for carrying Chemical Mace outside the El Monte bookstore, has been released on \$250 bond. Originally, his bail had been set at \$1,250. His trial is set for the 17th of this month, and there is a good possibility that the charge against him will be reduced to a misdemeanor.
