A Baltimore National Socialist Reports

From a comrade in Baltimore comes the following report, which should serve as a model of faith and action for every National Socialist:

"On my way home from work, I stopped off for a beer at a local tavern. Seeing about 10 Special Forces men from the local Army base, I got into a discussion with them about racial policies in the armed forces. Several of them mentioned they admired the elite SS, Germany, and Commander Rockwell, etc.

"After a short while, I told them that I was a member of the NSWPP. This was the first time any of these men had ever run across a real, live National Socialist. The whole mood changed from that of light conversation to fervent political discussion. Other people in the tavern overheard our debate and were drawn into it.

"At first the Green Berets made light of my National Socialist beliefs and didn't take me seriously. But they saw I meant business when I started giving them some Party literature. Then stiff and heated debate really began. I hammered home my National Socialist points, destroying their arguments over and over again until there was only one way left to test my convictions--physical force. Although I knew I didn't stand a chance in a physical encounter with these men, I realized that even here I could do something to bring them around. I challenged them to step outside and test my National Socialist beliefs by knocking me down as many times as they wanted to if what I stood for wasn't also in their hearts as White men.

"After going outside and offering myself for my beliefs and showing them that I was dead serious, only one of the Green Berets still wanted to hit me. But he was prevented from doing so by the others, and he soon left. I was then asked to come back inside by the others, and we continued our conversation with a real feeling of comradeship among us and an admission on their part that they agreed with me on most points."

Cleveland Bookstore Doing Great Despite Attacks

Akron Supporter Framed

Party Supporter Lindon Thompson was driving down an Akron street when he was stopped for a traffic violation. What normally would have amounted to a ticket and small fine became a real ordeal for Thompson when the police officer noticed his official supporter card. On the strength of his Party affiliation, Thompson was arrested on a charge of "malicious destruction" in connection with a Swastika-painting incident at Akron's Garfield High School. Completely ignored was the fact that scores of White students at the racially-troubled school have adopted the Swastika as their symbol of hope and undoubtedly painted the emblem themselves as a gesture of defiance against the school administration's policy of coddling Black terrorists.

And here again, what normally would have been considered a misdemeanor was ruled a felony at an arraignment in municipal court, because the damage to school property was allegedly in excess of \$100! Comrade Thompson is currently out on bond pending trial.

From the Schools

National Socialist activity of all kinds is on the increase in schools throughout the country. Here are some examples:

INDIANA: My U.S. History class presented a play which was supposed to show National Socialism as an evil and the Negroes as equal. Everytime National Socialism was slandered, I would tear their lies down with better arguments. I plan to join the debate team, which should really give me a foothold to present National Socialism to the students. When I graduate I hope to leave behind enough supporters to carry on the struggle in my school.

NEW YORK: I have been wearing daily on campus a White Power button and a "Down with the Jews and the System" button. I have written a number of compositions about National Socialism and my term paper topic for English is entitled: "The Resurrection of Aryan Man" and subtitled "After the Deluge--WE!" I have distributed what back issues of White Power I had lying around and have had two classmates read The Myth of the Six Million. I went to the chairman of the speakers' committee and advised him of the need for students to hear a truly revolutionary movement and shall keep after him. As soon as the next issue of White Power comes out, I am going to set up a table in the campus cafeteria.

WISCONSIN: I have written several themes in school for both my English class and my U.S. History class. In the one for U.S. History, I wrote about how the Jews in colonial America were almost always to be found in business and finance and that they never took up arms in defense of the Colonies. I have talked with students at my high school about National Socialism and so far have gotten a positive reaction from everyone. In a student seminar on the so-called 'radical right,' I got an especially warm response when I handed out copies of "Why Does the System Hate National Socialism" and "Had Enough Whitey."

LOUISIANA: I debated my high-school economics teacher on the subject, "The Jews constitute a state within a state," in front of the class. I also debated a group of students in the same class on "The Myth of the Six Million."

CALIFORNIA: During a special Black Studies week at our high school, I debated a visiting coon from San Jose State College in front of my U.S. Government class. After 10 minutes, he decided he was no longer going to debate--but not before lapsing into the usual profusion of profanities. In our school we have a closed-circuit TV system over which the Black Student Union president from San Jose State was supposed to address the freshmen and sophomores, while the juniors and seniors attended the assembly in person in the auditorium. Being in a TV Production class, I was chosen to help televise the whole event. So just before the speaker arrived, I slipped into the auditorium and "fixed" the microphone so nobody heard a word he said. Then, so the underclassmen couldn't see him on TV, I put up a sign which said "Audio Difficulties." So in effect, they really had no assembly.

I have been requested and have complied with several professors at my school to deliver lectures on NS Germany. I am also involved in debates on the subject of race. These debates have been conducted in front of freshmen and my opponent has been a vile Jew. The Jew had the audacity to stand in front of our largely Christian audience and wave the Bible while screaming that "God is on my side." At the first debate I had a ton of good, solid, factual evidence which he ignored and just shouted about "love" and "brotherhood," while a small group of his kosher friends sat in the audience and applauded him. By the time the next debate rolled around, I decided to start using his tactics and it worked. At each successive discussion I became a little bolder until by the last debate I crushed him. This is what happened: I had 18 of my friends come in to sit in the audience and yell whenever I said something. (Most of them aren't National Socialists, but that didn't prevent them from helping me.) Furthermore, I hid the Jew's Bible when he wasn't looking. You should have seen the look on his face when he went to pick it up and it wasn't where he laid it. Everytime he said anything, I did just like him and deliberately twisted what he said. In the end, I know that most of the people believed me, not because of any proof I presented, but because they hated my kosher opponent. I really owe a debt of gratitude to that slinking serpent for showing me how his kind operates.

PENNSYLVANIA: I have a book review coming out in the next issue of our school newspaper of William L. Shirer's The Rise and Fall of the Third Reich. I am forced to review this book, since whenever I am questioned about National Socialism, I am always asked about this trash. I believe that my review (with lengthy quotes from Mein Kampf) will totally wreck Shirer's clumsily built house of lies and remove, once and for all, this ever-present menace. I have also reviewed Wesley Critz George's "The Biology of the Race Problem," which might appear in the following issue.

On Friday, 16 October, during a Social Studies class discussion in which I blasted the old, rotten order, I brought up the matter of the Anti-Defamation League letter, using this as a good example of how most people speak out of both sides of their mouths. After class, I approached the teacher and handed him a copy of the enclosed letter. I had made about 20 of these letters, so I could save time in informing the different teachers of my willingness to speak before their classes on our Doctrine.

This month in my History class I gave a report on the National Socialist White People's Party. Hanging over the lecture stand was a 3 x 5-foot Swastika banner. I passed out NS leaflets and pointed out that the NSWPP was in the forefront of the White racial battle. The response was almost entirely favorable. It's so easy to stand up for National Socialism if you really try!
