

Vicious Liars Voted Out of NSRP

Attention Friends and Supporters of the NSRP:

The National States Rights Party has just elected a new National Executive Committee. They voted unanimously to fire two former employees for disloyalty. They are Mrs. Dorothy Bickley, a typist, and a janitor named Jerry Ray. These two have illegally occupied the NSRP Headquarters building and we are presently taking legal action to evict these squatters

The NSRP building was paid for in full by you the members and is today worth between \$150,000 and \$200,000. It does not belong to any individual member as ex-acting Chairman Gene Wilson seems to think as he has allowed these troublemakers to use NSRP property including our mailing list. They have stolen our list for a letter-head phony front called the States Rights Voters League made up of Bickley, Ray and a professional slander monger named Jerry Q. Dutton. Their sole purpose is to mail out a vicious, lying, smear sheet they call "Quarterly Report." This does not represent any so-called "split" in the Party because none of these people are members of the NSRP, except Gene Wilson. He allowed these enemies of the NSRP to have full control over our mailing list, office equipment and office building ! Their smear sheet is crammed full of the most outrageous lies we have ever read and much of this came right out of the Jew ADL files

Million Dollar Suit To Be Filed Against The Slanderers !

We are left with no other choice but to file a million dollar libel suit against Jerry Q. Dutton, Mrs. Dorothy Bickley, Jerry Ray and Gene Wilson. Their dastardly brazen lies is a desperate attempt to destroy the life long work of J.B. Stoner and Dr. Fields and all of you in order to put out of operation the most effective anti-Jew organization in the world. As it is impossible to reply to all of their filthy lies I will address the major ones over which the law suit against them will cover. - I hereby swear to the following TRUTHS !

1) I have never been married to anyone named Mildred Henson. The outrageous accusation that I am a "bigamist" is a total bald faced lie. My Attorney informs me this is "libel per se" in which punitive damages for maliciousness can be obtained.

2) I have never been convicted for threatening anyone. In fact I have never - ever - been convicted of any type of crime in my entire life. Once again, this is "libel per se."

3) I have never had any relations with any woman from Germany. This is a common charge often made against people in the public eye - and a very low cheap shot at that !

4) I have never been accused of "embezzlement, tax fraud" or plotting to "assassinate" anyone. These totally unbelievable charges are also "Libel Per Se."

5) I have never lost a libel suit in which any "cash payments" were made. On the contrary I won important libel suits which I was forced to file against Robert Welch of Belmont, Mass., and Stanley Pospisel of Miami Beach for lying smears not nearly as vicious as in this case.

Also, I want it known that the publishing of the names of my innocent children in this vile scandal sheet is the most despicable act I have ever witnessed. Many of my loyal friends have phoned and written me expressing their own personal outrage. Anyone who would stoop to such viciousness is nothing but LOW CLASS TRASH AND SCUM !!!

I have therefore instructed my lawyers to move quickly forward with a libel suit against all those responsible for writing and mailing this anonymous, unsigned, slander sheet.

What We Have Learned About The Plotters

The following four individuals are responsible for conspiring to illegally use our mailing list, for a non-existent group, with no members as a means to malign us, they are:

A) Jerry Ray, a convicted bank robber who spent 10 years in prison. J.B. Stoner felt sorry for him because he could not find a job. J.B. hired him as a janitor just because he is James Earl Ray's brother.

B) Mrs. Dorothy Bickley has been identified as the main individual who infiltrated our office staff as a clerk-typist. She deliberately spread lies behind the backs of Party officers to try and sow disunity. Mrs. Bickley is a Federal Employee in the active Navy Reserve. Federal authorities made an exemption especially for her to join the Navy at age 41. A retired Naval officer told us this is nearly unheard of. She has admitted that Naval Intelligence offered her a position. J.B. Stoner said she was wide open for recruitment as an FBI informer.

Mrs. Bickley has long had a drinking problem and has been forced to borrow money from small loan companies at sky-high interest rates to pay her legal expenses. Still she was able to "loan" Gene Wilson \$3,500 for the first smear letter against Dr. Fields. Party officials warned Gene Wilson over and over again that she was an obvious provocateur and might conspire with known muckraker Jerry Q. Dutton. Instead Gene Wilson placed her in charge of the NSRP office despite Dr. Fields warnings that she displayed all the signs of an agent - informer! J.B. Stoner wrote letter after letter demanding that Bickley be fired but Wilson ignored us.

D) Gene Wilson remained in control of the Party office even after he was voted out as acting Chairman. Despite protests by Jerry Pope, Paul Niswonger, J.B. Stoner and Dr. Fields he allowed the high-security risk full control of Party mailing lists. She, along with the bank robber, Jerry Ray worked hand-in-glove with the scurrilous Dutton to attack the elected officials of the NSRP. J.B. was ridiculed. Robert Bowling was defamed in the most monstrous lie imaginable.

Gene Wilson is equally responsible because he made it possible for these enemies of the Patriotic movement to collaborate right in our own office. Had Wilson fired Bickley and Ray as J.B. Stoner demanded after he discovered their two faced treachery last October these acts of treason would not have been possible.


The Jews are out to destroy all Anti-Jewish organizations world-wide. In Canada and Europe they have simply forced through un-constitutional laws making it a crime to criticize Jews in any way. In some countries it is even a crime to state the true fact that the holocaust is a hoax. Here in America the Jews have initiated out-right frame up cases against such leading Patriotic

leaders as Rev. Bob Miles, J.B. Stoner, the Brazwells, Gerhardt brothers and others. In this case Mrs. Bickley infiltrated our office and worked with Wilson and Jerry Ray to set up a fake front with professional character assassin Jerry Q. Dutton for the sole purpose of destroying the NSRP - the most effective anti-Jewish organization in the entire world.

Who Is Jerry Q. Dutton ?

J.B. Stoner calls Dutton, " the single most dangerous enemy I have! "

In 1977 Dutton met with agents of then Alabama Attorney General Bill Baxley who was seeking indictments against J.B. Stoner at the request of the Jew Anti-Defamation League (ADL). The state cannot offer rewards over \$10,000 for any single case. Still, the Jews wanted to "frame" J.B. Stoner desperately because his vote totals in Georgia were rising each time he ran. Thus "Special Reward" money was offered by the Jew ADL for ANYONE who could give testimony, no matter how insignificant "to get Stoner."

Jerry Dutton has admitted that he met several times with agents of Bill Baxley and they told him that rewards totaling over \$200,000 were available to anyone who would testify against J.B. Stoner in the 16th St., Birmingham bombing case. This is the case in which 4 blacks were killed and Baxley wanted to send J.B. to the electric chair. When this conspiracy collapsed they fell back on the old 1958 bombing in which no one was hurt and with just one witness were able to convict Mr. Stoner. Still Dutton traveled to Georgia seeking someone, anyone, who was interested in the huge Jew reward. Fortunately his mission failed !

In 1978 Jerry Dutton met with a writer for the Jew ADL. Her name is Patsy Sims who wrote the vicious anti-Patriotic book entitled, "The Klan." Dutton provided her with background information for her research into the Patriots who were smeared in her book. The Jews paid Patsy Sims for her nation-wide TV talk show tour promoting the sale of her book. Later the Jew ADL spent large sums of money to place the scurrilous book in every library in the nation.

Jerry Dutton used a similar undercover sabotage operation against David Duke who at the time headed the largest Klan group in America. Using a similar technique Dutton obtained a mailing list stolen from Duke's office to send out another anonymous, unsigned, smear against Duke which was also jam packed with falsehoods. This gravely damaged Duke's organization which at the time was doing the best public relations work on TV and in the press that we have ever witnessed.

Dutton is moving out of New Orleans because Patriots there have caught on to him. His new base of operations will be located in Concord, N.C. Therefore all North Carolina Patriots should be on guard !

Much of the false material from Dutton's pen came right out of the ADL's files including his constant misspelling of my middle name which is not "Reed." A big question is - who paid the thousands of dollars for this First Class Mailing to our entire list ? Last month Mrs. Bickley announced they only had \$19 in their "treasury." Both She and Jerry Ray are now drawing unemployment compensation. DID THE JEW ADL PAY FOR THE PRINTING AND MAILING OF THIS VILE HATE SHEET ?

Mrs. Bickley's paper says she is "known for her absolute honesty and integrity." How can she explain her participation in helping write this slander sheet ?

In the meantime we will ignore these backstabbing traitors and scoundrels and march forward with the urgent business at hand - and that is to expose the Jew subversion of our race and nation. We cannot allow a handful, one ex-member and three disloyal enemies, to destroy an organization which reaches out into every single state in the Union and all free White nations of the world !

The Jews may have succeeded in locking J.B. Stoner away temporarily but it is up to us to keep the NSRP going and growing until he returns. These saboteurs have already failed in that 100% of the phone calls we are receiving express their condemnation of this lying smear sheet. Our friends have expressed their uncompromising support for us. Patriots are saying that the desperation of this scandal sheet is proof that we are indeed doing an effective job : reaching the American people with the truth. I can promise you that our efforts will now be redoubled.

It was decided that whether the courts free J.B. Stoner in the immediate future or not he still can run the National States Rights Party from inside prison. He can issue orders, directives, and suggestions via the mail and through the visitors allowed in each Sunday. J.B. Stoner is a martyr to this cause and we will not allow him to be forgotten. If they can simply lock up our leaders and then hope that the people will quickly forget them the Jews could well declare the battle won. There is no better way to keep the flame of resistance burning than to keep J.B. Stoner at the helm of the Party until he is eventually released.

Jerry Pope Honors Dr. Fields

National Organizer Jerry Pope of Covington, Ky., is a long time Party activist and co-Chairman of the NSRP convention. Mr. Pope presented the annual awards. He presented a beautifully engraved plaque to Harry Bertram as "NSRP Man of The Year." Harry is on the ballot in Ohio and has gained a great deal of local publicity for the cause. He has interested many new people in our work. Jerry Pope also awarded Dr. Fields with a plaque for his service to the Party and having been a member of the National Executive Committee continuously for over 25 years. NSRP Youth Leader Wally Straughn was cited for his public street demonstrations on behalf of the drive to Free J.B. Stoner from imprisonment in Alabama.

Jerry Pope stressed the need for more meetings by NSRP Chapters and supporters who wish to organize the White people who live in their area. Al DeShazo lives near the prison where J.B. Stoner is unjustly held and visits with him nearly every Sunday. He reported on the health of Mr. Stoner and said the doctors found him doing very well. J.B. has regained the weight he lost during the four month period when he "disappeared." Harry Bertram said he found that the best way to reach the masses of the people and quickly find new followers is simply to run for public office. J.B. Stoner proved how true this was in his famous races for Governor and Senator. Paul Niswonger attacked the banking system and how they make traitors out of politicians holding office. Robert Bowling explained how the Jew ADL instigated

the frame-up of J.B. Stoner on a long forgotten 20 year old obscure case. The reason behind this was the ever growing popular vote for Stoner.

All who attended agreed that this was one of our best conventions and such gatherings provide an important opportunity for Patriots to share their experiences and develop new ideas for the building of the movement. The National States Rights Party provides White Patriots with a vehicle by which they can unite people into an effective organization designed to awaken the American people to the danger poised against our freedoms by Jews and their pro-Zionist stooges in political office and in the pulpit.

We Have Been Victims Too !

Right now, at this very moment, we are working hard to rebuild the National States Rights Party. We suffered a great setback last year when one lone pimp infiltrated our leadership & was successful in splitting the Party while our leader, J.B. Stoner, was a fugitive. We are just now recovering from this and to the great dismay of our enemy getting back on our feet. We possess more knowledge than ever before on how to keep traitorous pimps from infiltrating us. The National Convention of the National States Rights Party has elected a slate of officers which are the best in the nation. These men are the "salt of the earth" and can be depended upon through thick and thin. We are right now in need of many things, both large and small. A vast amount of new printing is urgently needed. This includes new stationary, membership cards, platforms, contact cards, etc, etc. We urgently need to hire at least two new full time workers to help us catch up with back work.

Orders for The Thunderbolt have never been stronger than they are today. Our youth activists in Philadelphia have increased their monthly orders for The Thunderbolt to 2,000 copies per month. AND THIS IS JUST IN ONE CITY ! That is the reason why the Jews fear and hate the NSRP. They know our record for street activity is unparalleled in recent history (or since the end of W.W. II.) While we are 100% against race-mixing and mongrelization of the races we fully realize that it is the communist-Zionist Jew who is our real enemy. It is not the negro, Asiatic, Hispanic, etc. Yes, they use these people to dis-unite America and destabilize this White people's Republic but in the final analysis there is no way to avoid pointing the finger of guilt at ORGANIZED JEWRY for most of the serious problems plaguing our White Race and our White Nation.

Great Significance Behind The Greensboro N.C. Trial Victory





J.B.'s final hearing on this matter was recently postponed and will now be heard on May 22nd. The hearing will be in the 11th Circuit Court Building in downtown Atlanta. We will be there to hear the legal arguments and you too are invited to attend. If the three judge panel should rule against us we still can appeal to the entire court as a whole (12 judges) to rule on his case. (The 20 year delay in trying J.B. Stoner violated his Constitutional protection of "due process", the right to a speedy trial, and the statute of limitations!)

J.B. Stoner's Lawyer Dismissed

Gene Wilson of Jacksonville, Fla., obtained the services of his personal friend, Attorney Vic Buttner, to represent Mr. Stoner on his last chance appeal - to the 11th Circuit Federal Court in Atlanta. When the date for the hearing came Mr. Buttner failed to show up. Without prior notification to J.B. Stoner, (or Dr. Fields who brought a crowd down to fill the court room) Buttner sent a last minute letter to the court stating he was sick and could not attend. When Robert Bowling phoned him he scoffed that he didn't feel "up to par" and postponed the hearing thus leaving J.B. Stoner languishing even longer in prison (if they plan to release him.)

Gene Wilson and Vic Buttner assured J.B. Stoner that he could handle this last part of the case for \$5,000. All the research work was completed. Thus all Mr. Buttner had to do was file the remaining briefs with the court (which he did) and then show up in court to represent J.B. Stoner. Instead he sends J.B. a letter demanding \$13,670.00 more and we still did not know if he would find another excuse! Thus J.B. has fired Gene Wilson's "good friend Vic " - they both have their yachts tied up at the same dock together. Right now we desperately need funds to pay the new lawyer Fleming Lee of Washington, D.C. for this final hearing.

This month we are asking that all who can afford it - to give twice ! Our Patriot's Freedom Fund is now down to ZERO. We have no funds at all left to defend anyone! There is no money left in the National States Rights Party account because of the recent internal problems which have now been solved by the election . Still, to get back on our feet, print the Party material urgently required means we desperately need your most generous contribution . We need donations both to rebuild Patriot's Freedom Fund and the NSRP Fund. If you can give only to one, by all means please do so. Decide which you want to support. Better still is any donation you can possibly make to both separate funds. If this is possible then make out two different checks. Thus the crisis created by Wilson, Bickley, Ray and Dutton, leaves us in a desperate position in regards to funds. Anything you can give at this time will mean a great deal to both J.B. & myself ! What you do today can well decide not only J.B.'s fate but also whether or not we will be able to quickly get the NSRP going as an effective organization as it was this time last year.
