Whites Persecuted To Win Reagan Minority Votes

Longest Trial In North Carolina History Families Go Through Great Suffering

China Grove, N.C. is a small community 70 miles from Greensboro. The Klan rented the local Community Center on July 8, 1979 to show the classic movie, "The Birth of A Nation." They were immediately attacked by members of the Communist Workers Party who injured several people. One black communist brazenly burned the Confederate Flag in front of the press. They called the Klansmen and people who came to view the film scum, cowards, etc. The Whites left via a back door with a police escort to avoid any confrontation with the violent communists.

The baiting of the Klansmen continued until the shootout in Greensboro where again the Communists started the violence. Thus five White Christians were indicted and tried for defending themselves against an armed mob of communists. Those tried were Coleman Pridmore, Lawrence Morgan, Jerry Paul Smith, David Mathews, Roland Wood and Jack Fowler, Jr. The trial continued over three months - 96 days - the longest and most costly trial in the history of North Carolina. The trial cost taxpayers millions of dollars.

> State Jury Finds **Patriots Innocent**

After thoroughly going over all of the evidence, taking several days, the jury came back with a verdict of "INNO-CENT!" Appropriately enough the foreman of the jury was an anti-communist Cuban. The exact opposite of Cesar Cauce the dead castroite Cuban who worked to subvert America as a pro-Castro enemy agent. The Cuban who was chosen as foreman in the 1980 trial was Octavio R. Manduley. He fought against Fidel Castro as a member of the "20th of May Organization" which conducted the CIA sponsored Bay of Pigs invasion designed by Pres. Dwight Eisenhower to liberate Cuba. The invasion could have succeeded and driven communism, not only from Cuba, but out of all of Central America. But Pres. John F. Kennedy, at the very last moment, after the invasion forces had landed on Cuba's beaches withheld promised U.S. air and naval support which would have defeated Fidel Castro once and for all.

Mr. Manduley stated it was clear to everyone on the jury that the Klansmen had acted in self-defense. He said it was not right to try the anti-communists and not the communists "for firing pistols." After all the communists began the shootout in the first place.

Reagan's Political Indictment of Patriots

Some three and one-half years after the Greensboro incident U.S. Attorney General for Civil Rights William Bradford Reynolds personally announced, from his high perch overlooking Capitol Hill, that not only had five of the original Greensboro defendants been indicted but four more making a total of nine, were this time indicted for -BELIEVE IT OR NOT - "violating the civil rights of

One of those indicted was Eddie Dawson, a lifetime FBI informer, who is not a North Carolinian. He is from New Jersey and was also an FBI paid pimp while living there also. The Justice Department indicted one of their own to make it appear as if they are washing their own dirty linen in public. Why did they wait three years to reindict the five who have already been tried and found innocent in the same case — THE REASON IS THAT REAGAN IS GO-ING AFTER THE BLACK AND JEWISH VOTE!

Remember, two Jewish medical doctors from New York state died. Thus the 2.5 million Jews, whose bloc vote delivers that state to which every presidential candidate Jew leaders endorse, is on the line. By "avenging" the death of two Jew doctors Reagan's political advantage will be further enhanced in New York.

The Suffering Of The Defendants Families

Your editor (Dr. Fields) personally has met and visited with the wives of several of the defendants in the Greensboro case. This case has hung over their heads now for five years. Some of the men lost their jobs over all the publicity involved. Their constitutional rights have been clearly violated because this second trial is a violation to their right to be protected from "Double Jeopardy" which means being tried twice for the same offense. The Supreme Court has upheld such prosecutions which are only used against White Christians. Has anyone ever heard of the Justice Dept. trying any Commie or non-White for violating our "civil rights?" Also, several of these communists were indicted before the first trial for "felonious assault" against the Klansmen - WHY WERE THEY NOT INDICTED THIS SECOND GO-ROUND FOR



FBI Lie - "Reds Didn't Riot"

(Below from Wire Service reports)

Is The FBI Blind To Communist Violence

FBI Director William Webster issued a report that there were 51 terrorist incidents in the U.S. last year. All were committed by communist and Jew organizations. New York topped the list with 21 incidents follow-'ed by Puerto Rico with 15 incidents. Committing most was the Puerto Rican FALN (Independence for Puerto Rico) next was the Jewish Defense League and finally various communist groups.

When asked about the 27 Nov. riots in Washington, D.C. during which stores were looted and cars overturned in so-called anti-Klan protests Webster replied: "There is no evidence that the violence which erupted after the Ku Klux Klan Washington rally, had been influenced by any outside group." Some 38 people were arrested and 10 policemen were injured in the anti-Klan rally.

The Washington Post reported that communists circulated through Washington's black ghettoes in sound trucks exhorting blacks to take to the streets for a "Death To the Klan" rally. The Post said the organizers of the black mobs included such revolutionary communist groups as the Spartacist League, Progressive Labor Party, the Trotskite Workers World Party and the All-Peoples Congress. They were brought together by "November the Coalition."

With all this information available to the Post why could not the FBI find a communist in the haystack? Why were not these communist leaders arrested for inciting to riot and violating the civil rights of the Klansmen? Can you imagine White people going to Washington for the purpose of creating a riot and not being arrested charged with the most serious offenses the government could dream up. What we have in America is a two tier system of justice. One in which a totally innocent Whiteman can be framed (like J. B. Stoner) but the Jews and coloreds can go out and commit riot and mayhem in the streets in front of the White House with impunity. This is a situation which urgently needs correction.

Why are White people, simply defend themselves, arrested by the FBI, placed under heavy bond and charged with violating the civil rights of communists?

WASHINGTON - Citing an increase in domestic terrorism, FBI Director William Webster said Wednesday he has assigned top priority to the bureau's investigations of terrorist

Webster told a Senate Judiciary subcommittee there were 51 terrorist incidents in the United States in 1982, an increase of nine over the previous year. In addition, there were six more deaths and 22 more injuries than in 1981.

The FBI also released its 1982 analysis of terrorist incidents in the United States, showing that New York topped the list with 21 incidents followed by 15 in Puerto Rico.

Webster said the FBI now defines terrorism as an unlawful act of force or violence to intimidate or coerce a government or civilian population to fur-ther "political or social objectives."

Last December, he noted. anti-nuclear activist Norman Mayer had "the whole country at hostage for hours" as he espoused his views while threatening to blow up the Washington Monument.

Webster also said there is no evidence the violence that erupted last Nov. 27 in a thwarted anti-Ku Klux Klan rally in Washington had been influenced by outside groups. Thirty-eight people were arrested and 10 police officers were in-

Dangerous Communists Killed

Reagan's Justice Dept. **Indicts North Carolinians**

Just Before Elections Greensboro, N.C. was the scene of a "Death To The Klan" rally held by the Communist Workers Party (CWP) on Nov. 3, 1979. For weeks local members of the Klan had been baited by the Reds who called them cowards, yellow bellies, who would not dare to face the CWP. For some still mysterious reason a long time FBI informer and Greensboro police informer, Eddie Dawson, got 40 Klansmen together and told them the communists had to be faced down over these threats. The Greensboro police department knew all about the forthcoming confrontation and City Hall even provided Dawson with the detailed location of the CWP anti-Klan rally.

Dawson led the caravan, driving up to the communists gathering of about 100 and shouted at the Reds, "You wanted to see the Klan, well, here we are." At that moment the communists went for their guns and ballistic experts said the Reds got off five shots before the Klansmen were able to return fire. As it turned out the Klansmen, luckily, were the better marksmen. One Klansmen was wounded as were four communists - the difference was that five other communists died.

Leaders of The Communist Party Killed

It is very strange to see Pres. Reagan on TV pleading for money to send guerrillas behind Nicaraguan lines to kill communists and weapons to El Salvador to kill and drive out communists there. Then, right here in America we have a clear case of White Christian family men being shot at by communists who returned fire in a perfect case of self-defense.

It is of importance to note that those killed included the top leaders of the Communist Workers Party (CWP). The reason is these radicals were in the front une of neas who started shooting straight at the Klan motorcade. The Communists killed included two Jewish medical doctors fron New York City.

"The negro appears to stand on a lower evolutionary plane than the White man, and to be more closely related to the highest anthropoids (Apes.) "Mentally the negro is inferior to the White. The remark of F. Kipling Predicted Danger In Granting Blacks Voting Rights.

Rudyard Kipling Warned Against Negro Voting In

Kipling was one of the most brilliant thinkers and writers the world has ever known. Even back in 1889 he visioned the future and the threat of allowing the negro to vote would cause. Thus he wrote in "American Notes':

"He is untrained, inept. but he will fill the place and draw the pay. (While the White people do the work.) Now, God and his father's fate made him intellectually inferior . . . He is a big, black, vain baby and a man rolled into one.

What will the Americans do with the negro? . . . Every year they are less and less in need of his services. (Note: Thus he has gone on welfare.) He will not disappear. He will continue as a problem. His friends (liberals) will urge that he is as good as the White man.

"The American, once having made them citizens, can-

unmake Newspapers say they ought to be elevated by education. He is trying this, but it is likely to be a long job, because black blood is much more adhesive than White. and throws back with annoying persistence.

"He has been made a citizen with a vote, consequently both political parties play with him. (Note: Oh, how that prediction has come true today!) He is as complete a heavy-footed, uncomprehending, bunglefisted fool as any memsahib in the East ever took into her establishment. But he is according to law a free and independent citizen - consequently above reproof or criticism. (Note: Another prediction come true, any criticism of the negro is branded as "racism.")

Thus brilliant intellectuals of the past warned us about the dire consequences of try-ing to make "equals" out of an obvious inferior race.

FBI Conspiracy To Disbar J.B. Stoner

FBI Conspired
To Have
J.B. Stoner
Disbarred

J. B. Stoner is the best known national leader of our time who represents the struggle for the rights of the White people. As a lawyer he has defended many scores of Patriots and in most cases represented them FREE of charge. Stoner's record of winning cases involving the political persecution of White people is without parallel. It made no difference what organization the persecuted Whites belonged to, be they members of the National States Rights Party, KKK or some other group, or even just individuals Mr. Stoner would still go out and defend them. Many were federal civil rights cases prosecuted by the best lawyers in the federal government with all the money available to the Justice Dept. Still J. B. Stoner won most of the cases. I wish we had room to give a historical breakdown of these cases and perhaps in the future we will cover his big legal victories.

COINTELPRO Conspiracy To Disbar Stoner

During the 1950s and 1960s the Justice Dept. allowed the FBI to develop an illegal operation called the "Counter Intelligence Program' or (COINTELPRO). It was designed to disrupt, sabotage and wreck any organization which the government deemed "con-troversial." This program was discontinued under Pres. Jimmy Carter when its illegal "black bag" break-ins were revealed and caused a great scandal for the FBI and the indictment of top FBI officials. Now, Reagan's U.S. Attorney General, William French Smith, head of the Justice Dept. has given FBI Director William Webster the authority to relaunch what they call a "limited" COINTELPRO starting last March 21. This new persecution program has resulted in the indictment of the Greensboro, N.C. defendants and the other cases outlined in this issue of The Thunderbolt.

J.B. Stoner
Had To Be Stopped
As the most effective and courageous lawyer in America, J. B. Stoner was a thorn in the side of the FBI COINTELPRO Program.

Every time they tried to frame another Patriot there was Stoner on the scene to take charge of the case and

defeat the un-Justice Dept. time and again. Therefore the FBI launched a secret campaign to have Stoner disbarred. Under the Freedom of Information Act we were able to obtain some of the documentation which reveals what went on behind the scenes to bring about the disbarment of J. B. Stoner.

The FBI document reproduced on this page bears the date Dec. 12, 1966 and describes secret meetings with the Georgia Bar Assn. seeking to find some excuse to disbar Stoner from the practice of law. When they failed this didn't mean they had given up. We have another FBI document in which Attorney J. B. Stoner was representing a patriot in Jacksonville, Fla. A special surveillance was placed on Stoner in hopes of entrapping him into "tampering with a jury.' The report said the sole purpose in trying to bring such a charge against Stoner was in order to have him disbarred. Again they failed and STONER WENT ON TO WIN THIS CASE ALSO!

Thus when we read about the FBI coming out of nowhere to indict other Patriots just before the 1984 elections, when both Parties claim they must have the minority vote in order to win - we must take these indictments with tongue in cheek and look for the political motivation lurking in the background. White Christian people are being indicted and tried just because an unscrupulous politician wants to capture the minority vote just to be elected President.

(The documents below were obtained under the Freedom of Information Act. This FBI report is dated Jan. 10, 1967 — revealing the conspiracy to disbar J. B. Stoner.)

With reference to Bureau letter of 12/15/66 concerning J. B. STONER and consideration of action which might cause STONER's disbarment, contact has been made with several Georgia attorneys, without reference to STONER, NSRP, or purpose, concerning past actions in Georgia to disbar members of the Georgia Bar Association. These attorneys could recall only two or three instances, over the past 20 or 25 years, where an attorney was disbarred. In these instances, a serious crime such as fraud or murder was involved. It was the consensus that the Grievance Committee of the Bar Association and individual members are reluctant to take action against a fellow-member.

Based on STONER's past activities, it appears that anyone attempting to institute disbarment action against STONER would be facing a stiff legal battle. For these reasons, Savannah is of the firm opinion that the initiation of such action by anyone at the request of the Bureau would be too fraught with potential embarrassment to the Bureau. Consequently, Savannah does not recommend such action be instituted.

In the near future, Savannah will review all references on J. B. STONER, in the Savannah Office, and attempt to develop some counterintelligence measure against J. B. STONER, acceptable to the Bureau.

In the meantime, it is recommended that the letter from XAVIER be sent, and time given for an appraisal of the results accomplished by that letter.

For the information of Cincinnati, in connection with this program, consideration is being given to mailing a letter ostensibly by XAVIER, missent to NSRP, Dayton, Ohio, which would depict XAVIER as a spy in the NSRP for the Anti-Defamation League. Cincinnati will be advised when the letter is sent.

Without any mention of such to informants, Cincinnati, through its informants in the NSRP at Dayton, Ohio, should be alert for any comments concerning the letter,

A letter was also proposed by the Bureau that will project the image of PETER L. XAVIER, NSRP, Augusta, Ga., as an informant for the Anti-Defamation League and is under consideration.

PENDING COUNTERINTELLIGENCE

NOTE: (Because J. B. Stoner criticized Kennedy and Lyndon Johnson, the FBI made a second attempt to disbar Stone.)

J. B. Stoner, Georgia attorney for the National States Rights Party, an anti-Semitic and anti-Negro group with headquarters in Birmingham, Alabama, has been most vicious in his attacks upon the Director and the Bureau and both the Kennedy and Johnson Administrations. His conduct is certainly against the Code of Ethics of Attorneys, and as a public service, we may be able to confidentially have him disbarred if we can bring his speeches to the attention of the Georgia Bar Association.

1. POTENTIAL COUNTERINTELLIGENCE ACTION

A proposal made by the Bureau that a fictitious order for 20,000 copies of "The Thunderbolt" be sent from New York, giving the return address of the Communist Party, is under consideration.

In connection with the suggestion by the Bureau to order 20,000 copies of "The Thunderbolt", it appears now would be an excellent time for such a technique.

the December issue of "The Thunderbolt", as well as a flyer attached, makes an urgent appeal to supporters of the party for funds, and calls attention to the bad financial situation the party finds itself in at this time. On 11/29/66 a check for \$500 was issued to the Walton Tribune, which prints the paper for the NSRP, and appears to be for the December, 1966, issue.



Justice Dept. Throws **Book at Atlanta Kids**

Atlanta, Ga., Aug. 4, five White youths are arrested by the FBI after an altercation at the Chattahoochee River National Park. It seems that an argument broke out between some blacks and Whites over the use of picnic tables. It is charged that one of the White youths pulled a knife and ordered the blacks out of the park. Arrested were Steve Ramsey, Ricky Ramsey, Kelly Colleen Cato, Tommy Duckett and Richard Spinks.

They have been charged in this minor incident with "violating the civil rights of the blacks." If convicted they face fines of \$10,000 and up to five years in prison. Just a few years ago this would be a state misdemeanor with probably a \$30 fine or 30 days in jail.

This law, promoted by William Bradford Reynolds, eliminates the right of a trial by civil judge and jury for those accused of housing discrimination in refusing to sell or rent to coloreds.
