Reagan Sacrifices Supporters To Capture Minority Vote

The Jimmy Carter Ad-ministration had dropped the investigation into the Greensboro, N.C. shoot-out between Ku Klux Klansmen and the Communist Workers Party. The Reds were in the process of holding a "Death To The Klan" rally when the Klansmen dared to show up. Five Reds were killed and the evidence during the first trial proved the Communists fired first. Thus the jury voted to acquit the Klansmen. This case was reviewed by the Justice Department under Pres. Jimmy Carter and after months of investigation thoughts of further prosecution were forgotten.

When Reagan took office he assigned Assistant Attorney General William Bradford Reynolds to seek out any and all possible cases involving White Patriots who could be tried for violating the civil rights of minorities. Reynolds now brags the Reagan Administration has brought more civil rights cases against White people than any other in U.S. history. Thus, after a five year delay, just like the "Greensboro" trial, these Klansmen are scheduled to be tried just before the November election for the specific purpose of helping, Ronald Reagan win the minority vote.

Reagan Plans Case Against Alabama Patriots

Decatur, Alabama was the scene of a shoot-out between local police and negro civil rights demonstrators on May 26, 1979, when they confronted the Klan mar-chers. Two Whites were shot and three blacks wounded. The local police arrested the blacks for starting the trouble and they were convicted. The innocent Whites who were wounded were never charged. The Jimmy Carter Administration spent four months seeking to find some way in which the Klansmen could be charged with violating the so-called "civil rights" of the blacks but could not. On May 26, 1978 negro Tommy Lee Hines was-arrested and charged with the rape of three White women. He was convicted and this caused a national protest by Marxist and civil rights groups who claimed Tommy Lee Hines was so mentally retarded he was incapable of committing the act of rape. At a later date his conviction was overturned on the grounds that he was mentally unable to understand the charge against him. He has since been sent to a mental institution.

One year later, on the anniverary of Hines' arrest, the SCLC civil rights group obtained a permit for a protest march in Decatur, Ala. The Ku Klux Klan, under Grand Dragon Roger Handley, requested and (Continued on Next Page)

Reagan Reopens Alabama Case

With the 1984 elections approaching and Pres. Reagan actively seeking the black bloc vote, this five year old case has been reopened with civil rights charges now pending against Klan leaders, Roger Handley, Ray Steele and Billy Riccio. Justice Department Civil Rights head William Bradford Reynolds dispatched Craig Schaffer from Washington, D. C. to join Assistant U. S. Attorney Bill L. Barnett in Birmingham, Ala., to try and find some excuse to indict these patriots. In the meantime left-wing Zionist Morris Dees, (who is of Russian descent) and the multimillionaire head of the "Southern Poverty Law Center" in Montgomery, Ala., filed suits against Handley, Steele, Riccio and many others claiming they had somehow conspired to violate SCLC negro Curtis Robinson's civil rights and the other members.

As a part of this suit Morris Dees has taken a wide range of depositions - a total of 191 at last count! He was able to find around 19 people who were frightened by the suit who agreed to testify against Handley, Steele and Riccio. All of the information obtained from these depositions has been turned over to the FBI and U. S. Attorney's Barnett and Schaffer. This aided in their dispicable last minute attempt to invent a case against these Klansmen.

Whites Civil **Rights Violated**

Thus on Nov. 10, 1983 U. S. Attorney, Bill L. Barnett sent Klan leader Roger Handley a letter informing him that he is "one of the subjects of a federal grand jury investigation in this District into the conspiracy to violate and violations of civil rights in Decatur, Ala. on May 26, 1979, the subsequent conspiracy to obstruct and the obstruction of justice, and other matters."

Barnett has since informed Roger Handley's lawyer that toward the end of March, indictments will be handed down which will carry a total of 40 years imprisonment if convictions are obtained on the following four counts. They are: "Conspiracy to violate civil rights, actual violation of civil rights, conspiracy to obstruct justice and actual. obstruction of justice." What is actually alleged is

that the Klansmen, before the march began, talked about stopping the black march and later advised members not to talk with the FBI. The truth is that no one is ever required to answer any question by either the police or the FBI. One of the SCLC demonstrators were convicted by local authorities of actually stopping the Klan march by shooting at them and wounding two Klansmen. None of the Klansmen were ever charged with shooting at the black SCLC marchers as it is believed the police were forced to fire said shots in selfdefense!



Reagan Charges Whites Incited Reds—Black Riot In Washington???

Reagan Blames Whites for Washington Riot?

Reagan attacked the Klan for "allegedly" inciting blacks to riot in Washington during his radio broadcast of Feb. 25. Then again two weeks later, addressing Christians demonstrating for the Constitutional Amendment allowing prayer in schools Reagan charged, "The same law which forbids prayer in public schools allows the Klan to incite riots in Washington."

Reagan, in both instances, dishonestly blamed the Klan while defending the wild blacks and communist organizations which really incited the riots. Reagen left out all of the facts in the case and briefly here they are: The Ku Klux Klan obtained a permit for a march in Washington protesting the King Holiday Bill on Nov. 27, 1982. They had a Constitutional right to march just as the blacks and communists who have all but taken over our nations capital and hold public demonstrations all the time.


Communists groups such as the Progressive Labor Party, Workers World Party, Spartacus League and other groups openly distributed "Death To The Klan" handbills in ghetto neighborhoods. They drove around in sound trucks urging blacks to fill the streets and "Smash the Klan march."

Whites Had **Right To March**

A heavy contingent of police shielded the 30 Klansmen who attended a brief meeting and were secretly escorted out of town. When the communist and blacks discovered they were not going to be able to attack and kill the Klanspeople they turned on the police, began rioting, and looting stores. In all, 12 officers were injured and 19 persons arrested for rioting, assaulting police and looting. A dozen store owners have sued the mayor's office for \$100,000 in damages for not protecting their property. Bob Getz of the Melart Jewelry Store said his windows were smashed and \$6,000 in watches stolen. Mike Sendar of Big Wheel Bikes suffered \$20,000 in damages stating: "I harbor some resentment toward the police. Their response was woefully inadequate."

It should be noted that one of the accused rioters, negro Lawrence McNeall, 40, of 11 46th St., S.E., Washington, believe it or not, is a mail room supervisor for the National Rifle Assn. HE IS STILL **WORKING THERE!**

Columnist Patrick Buchanan rightfully attacked the communist for inciting the blacks to riot. He denounced the left-wing Washington Post for referring to the rioters as "anti-Klan demonstrators when, more than a thousand people smashed windows, hurled rocks, bricks and bottles at mounted and dismounted police, invaded and looted stores of cameras, clothes, bicycles — anything they could lay their criminal hands on.



Buchanan criticized negro Mayor Marion Barry for saying, "It turned out alright — it could have been a lot worse!" Buchanan asked what would have been the response if Black Panthers had obtained a permit to march and a thousand Whites rioted, vandalized and looted. The FBI would have swooped down and arrested all who organized the malay and charged them with violating the civil rights of "the poor blacks." The daily press, Mayor Barry, the National Council of Churches and Jew Anti-Defamation League would be screaming against such a "Resurgence of Hate" and demanding the stiffest possible penalties.

Everyone is familiar with the Merriel Sealift during which over 125,000 Cubans were welcomed to the U.S. by Jimmy Carter. 

Seven Exclusive Jew Diseases

Jewish Genetic Diseases Prove Races Are Different

White Europeans have no diseases which exclusively affect only our own race. Yet, Jews from Poland and Russia, (called Ashkenazic Jews), do have genetic diseases which are only found in the Jewish race. Ashkenazic Jews made up 99 percent of the Jews in America and 82 percent worldwide. The other people who call themselves Jews are the Sephardics from Spain. None of them have these strange diseases which indicates they are not blood related to the Jews from Eastern Europe!

"Jewish Roulette" is what doctors call Jews who marry when both are carriers of the traits of these diseases. All Jewish genetic diseases are incurable and the disease trait is passed on from one generation to the next. Thus far the only disease which can be tested to determine trait carriers is Tay-Sachs. The other diseases cannot be identified until a Jew shows symptoms. By then it is too late to stop its eventual course.

The Incurable Jewish Race Diseases

* Tay-Sachs is a fatal disease. About one out of every 27 Jews is a trait carrier. If two Jews with the trait should marry there is a 25 percent chance their offspring will have the full disease. It affects the nervous system, retards and reverses infant development and results in seizures, blindness, debilitation and eventually death.

* Gaucher's disease trait is carried by one in 25 Jews. It causes bone and joint pain, fractures and impaired blood clotting, but is not fatal.

* Dysautonomia is carried by one in 50 Jews. Victims don't have tears, can't feel pain, have respiratory and swallowing problems, poor motor coordination, stunted growth, speech, drooling and scoliosis (curvature of the spine). Life span is shortened.

*Dystonia trait found in one in every 70 Jews. A mysterious disease of the brain which causes loss of muscle control. Disease is progressive but not fatal.

* Bloom's syndrome results in stunted growth, skin problems, respiratory problems and ear infections. Can be fatal as it increases the risk of cancer. One in 120 Jews carry this trait.

* Neimann Pick disease affects children. There is massive spleen enlargement, emaciation and degeneration of the central nervous sytem and death before age three.

* Musolipidosis IV was only discovered in 1977 as an exclusive Jewish disease. It is not fatal but leads to mental retardation and near blindness.

Other Differences in Jews

Medical writer, Margaret Eisen (a Jewess) issued a report on Feb. 23, 1984 on characteristics which are peculiar to Jews. The following is a summation of her findings:

1) Reaction to pain: Jews are more emotional about pain. Even after pain subsides they continue to worry and question its meaning and consequences. They worry about side effects of treatment and are more apt to consult more than one doctor.

2) Color blindness to red and green colors is nearly 10 percent in Jews and the highest rate of any race in the world.

3) Reaction to milk: In Israel two out of every three Jews are alergic to milk and milk products. This is a genetically transmitted enzyme deficiency. Blacks and Asiatics have a similar high incidence of these allergies. This does not exist in the White race and indicates that Jews from the Kazar area of South Russia have strains of Asiatic blood.


4) Professional ambition: Jews find business dealings less boring, wearisome, tiresome, or monotonous while White Europeans more often succumb to feelings of discouragement. In business dealings Jews have less feelings of guilt and anxiety.

5) Concerns of Jewish women: Jewish women worry more about childbirth, menopause and are less likely to breast feed their children than any other race.

6) Disease susceptibility: Jews more often have inflammatory bowel disease, Hodgkins disease, diabetes and coronary artery disease than non-Jews.

7) Other health problems: Jewish women have the highest risk of breast cancer and suffer from obesity. Jews suffer from a problem of "short thumbs" and have very hairy ears causing them to shave the top of their ears.

These are major and minor health problems of the Jewish race. The chief point in this article is that the race of people who so loudly proclaim their belief in "racial

Israel's Caste System

We Need The Laws of The Caste System

In Israel and much of the far-east various terms have a far different meaning than they do in this country. The term "bastard" means one who is born of a mixed marriage such as a Jewish father and a gentile mother. Thus when the late Moshe Dayan made a speech which was misinterpreted in this country in which he stated: "I am not a bastard." He meant both his mother and father were full blooded Jews. This term has nothing to do with an illegitimate birth. Also, the term adultery to Orthodox Jews and the people of India means having sexual relations outside of your caste or religion - such as between a Hindu and a Moslem. It does not mean "cheating" on your spouse as the term does here.

Thus when the ancient Aryans invaded the north of India they established Segregation laws within their religion to keep the races separate. This worked for hundreds of years. It is called the caste system and is still in effect today. There are some 13 different castes in India ranging from those at the top (the pure White people of Northwest India) to the pure black in the southeast. Here are some of the ancient sayings of the Aryan religion written several thousand years ago but still applicable today within our society.

Laws of Manu - Mixed Castes - "The adultery of dif-

AIDS Started In Africa — Not Haiti

The New England Journal of Medicine reports the findings of Dr. Nathan Clumeck of Belgium and Dr. Guy de The of Paris. They have traced AIDS to Zaire, (formerly the Congo), and black nations of Gabon, Chad, Mali, Rwanda and Burundi. These are some of the most backward and unsanitary countries in the world.

Dr. Clumeck said that it is possible AIDS has always existed in Africa and is just now being recognized. AID is the incurable disease which robs the body of its immune resistance system. Dr. de The said he has traced AIDS to one area of the Congo where Kaposi's sarcoma (cancer) is common and this is closely associated with those having AIDS. Both doctors agree that all of the AIDS cases found in Europe came from negro immigrants from Africa or Whites who had visited Africa engaging in homosexual relations while there.

Haiti is also a black nation with highly unsanitary conditions and has been a vacation resort for homosexuals from America. The disease could have come from Africa to Haiti (or perhaps it has always existed in Haiti also.) This new scourge has infected nonhomosexuals through blood transfusions. The number of AIDS victims doubles every six months and first emerged in the U.S. in 1981. Since that time there have been 3,450 cases reported and 1,498 have died (or 43%). Since the incubation period is five years the Atlanta based Center for Disease Control estimates there are from 20,000 to 30,000 current carriers of the disease. AIDS is spreading so rapidly it could eventually wipe out the U.S. homosexual community.


Outrageous Treatment of Chancellor Kohl In Israel

Germans Insulted After Jews Rude Treatment of Chancellor Kohl

West Germany, along with America, are the only nations in the world which have succumbed to vicious blackmail in giving billions in aid to Israel. Reuters News Service: "Israeli border guards refused to allow some U.S. personnel to cross into Israel from Lebanon because they were traveling in Volkswagens. Those driving in other types of vehicles were waved through the checkpoint. There was no immediate explanation from Jerusalem."

Jewish Week of Jan. 20 carried a large ad panel by the Jewish Mobilization Committee and three other Jew groups. A large headline called for an antiGerman demonstration in front of the German Consulate located at 57th & Park Ave. in New York City. The headline read: "Hitler's Children Are Arming The Arabs With German Weapons To Kill Jews – We Must Not Be Silent."

Los Angeles Daily News, Dec., 1, 1983: "It took a fast shuffle but Los Angeles City Hall welcomed the Hanukkah season in proper style Wednesday. Showdown Hearing On J.B. Stoner's Appeal

Hearing Set On J. B. Stoner's Appeal

J. B. Stoner's case is now pending before the eleventh Circuit Court of Appeals in Atlanta. His case will be heard by a three judge federal panel at 9 a.m. on April 10th. This will be a public hearing with oral arguments presented by Mr. Stoner's lawyer, Vic Buttner and prosecutors representing Alabama Lt. Gov. Bill Baxley and Atty. Gen. Charles Graddick. The court room is in the Old Post Office bldg., in downtown Atlanta. Dr. E. R. Fields will attend and all of J. B. Stoner's friends are welcome.

J. B. Stoner was convicted, under the constant glare of TV coverage in a court room jammed with members of the daily press for allegedly bombing a negro church used as a center for civil rights demonstrators way back in 1958. No one was injured in the blast. It was nearly 20 years later when then Atty. Gen. Bill Baxley had Stoner indicted at the request of the Anti-Defamation Jew League. There was only one serious witness against Stoner and all of Stoner's defense witnesses had died.

Mr. Stoner's appeal was turned down without a hearing by both the Alabama Supreme Court and the U.S. Supreme Court. This sustained the lower trial court's conviction. The state of Alabama asked the 11th Circuit Court not to allow oral argument in the case calling the appeal "frivolous". But, the court in essence ruled his appeal does have merit by granting Stoner oral argu-

ment in open court. The judges must hear the case and hand down a written opinion which all three must sign. How can they get around the three year delay? "Due Process" under the U. S. Constitution means you must be indicted not more than three years after an offense

If this conviction is allowed to stand it means the protection of our statue of limitations are no longer in effect! It means that citizens can be tried for any offense, 20 or 30 years after it occurred. This would mean the beginning of American becoming a Soviet Republic. 
Black City Manager Fires White Miami Police Chief -**Replaces Him With** A New York Jew!

Miami has a negro City Manager, Howard Gary. Because of negro unrest and threats against the police over alleged "police violence" Gary has been seeking an excuse to fire highly respected Chief Kenneth Harms, age 46. On Jan. 27th, Gary acted after Harms promoted six officers who were White. This process has already begun with Americans last year investing \$834 billion overseas while foreign investments in the U.S. dropped to \$665 billion. We live

in a world of false prosperity with investment spending steadily declining. The Association of Business Economists polled its members and 66% said a serious recession is possible in 1985. This would snowball the deficit because the government would be spending even more and taking in less and less.

New Book On Allies' Holocaust

Andrei Vaslo to fight to liberate their homeland from communism. The other three million were civilians, men, women and children trying to escape Stalin's murder machine. Before the program was stopped Britain, France and America had shipped two million people to Stalin's death camps. This real holocaust has been suppressed by the daily press and TV. This mass murder of innocents has been fully documented. Why there not antiare communist movies and TV docudrama's over the fight to the death which many Russians put up before being forced to return? NICHOLAS BETHELL ("A Brutal Exchange," Spectrum, last week) recounts the handing over by British Forces to the Soviet authorities of 39,000 Cossacks during the summer of 1945, des-cribed by Alexander Solzhenitsyn as "the last secret of the Second World War." Lord Bethell further points out that the reason why the Cabinet gave this tragic order, was to ensure the release of many thousand Allied prisoners of war, overrun by the Red Army during the radvance westwards and then in Soviet custody.

The two Cossack Corps were not the only Russian-born troops then in British hands. A Ukrainian division of 12,000 men Ukrainian division of 12,000 men was In a camp in Northern Italy under the guard of the Scottish Horse, in which I was serving. We were informed by our friends in the army in Austria, who had had to carry out the order, of the many suicides that took place before the hand-over was com-plete, and of the belief of the Cossacks that they fared certain death or enslavement (a belief, all too well-founded, as Solzhenit-syn relates). syn relates).

Being unaware of the reasons for the order, we made the strongest possible representations to the authorities that the Ukrainians should not be given a similar fate. In the event the vast majority of them did not return to Russia but were sent to agricultural work in England and Canada. Instead, a Soviet delegation came to the camp to address the men and try to per-suade them to return voluntarily to Soviet Russia, and a few—a very few—did. I very well remem-ber entering the camp with the ber entering the camp with the Soviet delegation and seeing the thousands of Ukrainians, many of whom were boys in their early teens and old men, fleeing in blind terror from the parade ground to avoid the eyes of the three Russian officers who accompanied us.

Your article has raised a doubt in my mind where before none existed. I do not know what were the reasons for sparing the 'Ukrainians, but I should hate to think that representations made by us on humanitarian grounds in any way endangered the life of Allied prisoners of war.—John Falconer, London W4.




