How Sears Roebuck Money Aided Reds

Sears Roebuck Co. was well on its way to becoming the most successful mailorder house in history when it was bought out by Julius Rosenwald in 1896. He amassed one of the greatest fortunes of that time and established "The Rosenwald Fund" with a gift of \$63 million in 1917. This would be a gift worth well over \$1 billion today! The fund was to aid blacks and all the money spent within 25 years (or by 1942).

Rosenwald's money was spent for increasing black influence black YMCA's and to help form black civil rights organizations. In order to make sure that local blacks knew where the money came from - to ensure they would give their thanks and loyalty to the Jews - Rosenwald's picture was distributed by the Fund to tens-of-thousands of blacks throughout the South. It hung on walls along side Booker T. Washington as a "patron saint" for blacks to look up

For some reason Republicans were brainwashed into thinking Rosenwald was a kind of conservative because he gave money to the GOP. He also gave money to aid Jews to immigrate from Russia to the U.S. where

they laid the groundwork for the founding of the U.S. Communist Party. Rosenwald gave money to defend such Marxist radicals as Jane Addams, the Mooney-Billings case and to help convicted bankrobber killers Sacco and Vanzetti. He also financed the publication of a book and articles on the Sacco-Vanzetti case which were distributed to young people for study in schools and colleges nationwide.

This is the story of how one of America's earliest Jew multi-millionaires used Roebuck to lay the groundwork for the birth of not only the civil rights movement but of the U.S. Communist

Jewish Organizations Back Interracial Marriage

The U.S. Supreme Court ruled unanimously on April 25 that a local court has no right to grant child custody to a White parent because his ex-wife is living with her negro boyfriend. This was the first time the high court had involved itself in a child custody case. Even more interesting is the point that two major Jewish organiza-tions filed a brief with the court supporting the interracial couple. They were the Anti-Defamation League and American Jewish Congress.

Florida Judge Morison Buck granted a divorce to Anthony and Linda Sidoti. She obtained custody of their three year old daughter Melanie in 1980. Shortly thereafter the child's father discovered that his ex-wife was living with her negro boy friend. Anthony went back into court and Judge Morison Buck took the White baby girl from her mother and gave custody to the father stating: "The child has a right to protection from the social stigmatization that is sure to come."

Later the negro, Clarence Palmore, married his White mistress Linda. Jew civil rights organizations helped them obtain the services of a clever Jew attorney named Robert Shapiro. He lost the case in the Florida Court of Appeals but still had the financial backing to go all the way to the U.S. Supreme Court.

The Supreme Court was not supposed to rule on the case until July but they acted speedily. On April 25 they ruled unanimously that the interracial couple had a right to the White child (who has since been living happily with her father in Texas). The court ruled that the

Linda and Clarence Palmore seek custody of her white daughter.

Marriage To Black **Gets Jewish Aid**

NEW YORK - Two Jewish organizations have joined with two general organizations in asking the Supreme Court to overrule a Florida court decision that denied a white mother custody of her seven-year-old daughter following her remarriage to a black man. The Anti-Defamation League and the American Jewish Congress joined in an amici curiae brief filed with the high court.

Americans for Democratic Action, a Marxist group rates Jewish Sen. Howard Metzenbaum of Ohio as having the most left-wing voting record in the U.S. Senate! The Jew Hyman Lumer was an editor of the Communist journal "Political Affairs" from 1944 to 1976. Metzenbaum spent millions of his own money to "buy" his Senate seat so that he can promote communism in Washington today.

Goldfarb - Father of "Open Housing"

Buffalo, N.Y. Norman Goldfarb died at age 65 and his obituary told of a life long struggle against White Christians. "The Buffalo News" reported that Goldfarb "played a major role in successful efforts to desegregate public

schools." He also pushed for legislation to force Whites to rent and sell property to coloreds. Goldfarb fought against mandatory lie-detector tests for job applicants and drug-usage tests as employment conditions to aid blacks. He was honored by the NAACP and ACLU. Goldfarb is considered a hero to the Jewish race.



John Tyndall's Analysis of Ray Hill

During the split between several British Nationalist groups in 1980 Ray Hill joined the British National Party (BNP) whose leader is John Tyndall. Hill seemed to be a good active member and rose to the position of "Publicity Officer." He participated in parades, made effective speeches and even wrote a good article for Tyndall's publication.

John Tyndall commented, "Hill's acts of treason and treachery may have been long planned for the objective of subverting the BNP. Hill seemed talented and put on an extremely convincing act."

It is extremely difficult to spot such a mole but Tyndall said he always had doubts about Hill. He suspected Hill had an "innate character flaw." He says

How To Spot Moles and Pimps

John Tyndall wrote, "We cannot possibly grow if we set up an exclusive wall against all comers who do not produce for us a 100% security clearance... The inevitable price for our growth and development is the price of risking that one or two rotten apples got into the basket. If they do get in, do not allow them to infect and destroy the basket as a whole. This involves, in terms of building a party, using careful discretion and discrimination in determining the degrees of initiation and confidence that one will extend to one recruit as against another. Such decisions and appointments must come from the top. Even here there is no absolutely foolproof guarantee

F.B.I. "Stings" Threaten Rights

DeLorean "Sting" A Frameup

Good Luck — John DeLorean

We hope the jury considering the trial of auto manufacturer John DeLorean finds him innocent. This case is a perfect example of how people are illegally "entrapped into acts which they normally would never engage in if they had not been "set up!" John DeLorean was a prominent man in desperate need of financial aid to keep his auto plant functioning in Northern Ireland. The following are illegal actions on the part of the FBI which has made this trial a travesty upon justice.

1) FBI records show DeLorean was targeted for a "sting" one year before his arrest due to the desperate plight of his auto firm

2) FBI agent Benedict Tisa admitted purjured testimony was given to grand jury which claimed DeLorean originally used drug money to help launch his auto company. The truth came out that he had never had any prior link to drugs.

3) DeLorean sought to back out once he discovered the background of the drug conspiracy. The control agent threatened DeLorean's family if he should withdraw

he should withdraw.

4) On Sept. 2, 1982 FBI agents met with Assistant U. S. Atty. James Walsh (the prosecutor against DeLorean), to discover ways to avoid an "entrapment defense" by DeLorean.

5) The Justice Dept. decided that everyone involved in the sting could not be an FBI agent. They had to find some notorious criminal to help them. Thus they chose William Hetrick, a dangerous, big time drug dealer, who is really involved in flooding the nation with cocaine and heroin to deal with DeLorean. Charges were dropped against Hetrick in a serious case in return for his help in framing DeLorean!

6) The FBI tipped off the

6) The FBI tipped off the British government 30 days before DeLorean's arrest and that move precipitated their

foreclosure on his Northern Ireland plant.

7) FBI agent Tisa said elaborate preparations were made for DeLorean's arrest on film to be released for TV showing champaigne toasts over a suitcase of cocaine. They called it "an appealing scenario" to finish off DeLorean, destroy his business and reputation forever—just so the FBI could claim fame in "nailing a big wig."

The DeLorean case poses a threat to the Constitutional rights of every citizen. There is absolutely no difference between this policy, of creating frame-ups of innocent people, than there is between the activities of the secret police in Russia and Israel. The time has come for the Congress to issue strict guidelines which will prevent the FBI from inventing crimes and then seeking to entice otherwise law abiding people into their web. With all the real crime going on one would think this would be enough to keep the FBI busy. Why should they be allowed to spend millions of taxpayers dollars trying to frame people like DeLorean just because he was vulnerable over the desperate straights of his business.

Congress Says FBI
"Sting" Operations
Framing Innocent
People

The House Subcommittee on Civil and Constitutional Rights has just issued a critical report against the FBI's use of "sting opera-tions" (the offering to innocent people suitcases full of money, cocaine, etc.,) and then arresting them if they accept. Rep. Don Edwards of Calif. who is a former FBI agent, heads the committee. They found such FBI schemes "encouraged criminal activity and created victims among people who would not otherwise be so entrapped.'

The Abscam case in which one Senator, six Congressmen, and a number of businessmen were convicted is an example as well as the drug case against auto manufacturer DeLorean. The "sting" operations began in 1977 and grew rapidly to 316 such operations in 1983. The FBI has allotted \$12.5 million for sting traps this year alone! This sum does not count FBI agents' large salaries and general overhead. The House Committee pointed to the highly publicized case of the sting operation against a group of judges in Cleveland. A bailiff told an undercover FBI agent posing as a car thief he could fix such cases. The FBI spent huge sums of money with the bailiff who was supposed to distribute it to judges he claimed were involved. This continued for many months. Later it was discovered that the bailiff had no such influence and was merely pocketing all the FBI money for himself. This left FBI agents with red faces but also cast a cloud over the judges in Cleveland when the story broke that the FBI was investigating "crooked judges!"

Rep. Don Edwards' Committee seeks the enactment of a code of conduct for undercover operations in such areas as permissible disguise and behavior. FBI Assistant Director Bill Baker protested, "this would knock out three-quarters of our undercover investigations." Another safeguard for the public is the suggestion that the FBI take out judicial warrants for "sting" operations but FBI Chief William Webster has objected even to this? The Committee said: "innocent victims lack the awareness or the resources to sue the Government for compensation when they have been damaged by illegal sting operations. The FBI has damaged public institutions, exaggerated the suspected level of corruption and have engaged in unwarranted prosecutions."

How Russian Jews Move To Germany

The London Observer states that reports of Germans living in Russia being allowed to emigrate to West Germany is misleading. We have long known that the Soviets allow a large number of Jews to emigrate to Israel and America and a much smaller number of "Germans" to move back to Germany. The Observer states that many of these "Germans" are actually Jews who before W. W. II lived in Baltic Germany communities and spoke the German language.

These Germans in Xussia who are really Jews amount to nearly 1,000 immigrants to Germany per year. They chose Germany over Israel

because of government compensation and the "more comfortable living" along with financial opportunities. There is a growing Jew population in West Germany which numbers 60,000 instead of the official Bonn Government figure of 30,000. The German press has been warned by the government not to publish news of the Jew immigraion to Germany these shocking facts from arousing anti-Semitism. Most interesting of all is that of the 3,000 Jews living in Communist East Germany many are prominent in the Red government with three serving in the Politburo. This is an important fact concealed from the German people on both sides of the Iron Curtain.

Israeli Front Holds On To Black Supporters

Israeli Lobby Seeks Control of Blacks

The American-Israel Political Action Committee (AIPAC) under the direction of Jew Thomas Dine is working overtime to try and keep control of the NAACP. The Jesse Jackson campaign has driven a wedge between some black and Jew leaders and threatens the coalition which has been the backbone of the Civil Rights movement. The NAACP was originally founded by the wealthy Jewish brothers Joel and Arthur Spingarn along with the communist negro W.E.B. DuBois and others. This caused a split with the NAACP-Legal Defense Fund because it was incorporated separately by Jack Greenberg and now split from the currently black run NAACP.

AIPAC-NAACP Conference

Black and Jewish student activists strengthened Black-Jewish cooperation last week in a conference sponsored by the youth divisions of the American Israel Public Affairs Committee (AIPAC) and the NAACP.

"This conference is not an end in itself, but rather an integral part of the process which keeps channels of communication open between our respective groups, Thomas A. Dine, Executive Director of AIPAC, told the audience of about 200.

The opening evening session was addressed by Dine, Rev. Edward A. Hailes, National Vice President of NAACP, and Rep. Julian Dixon (D-Calif.). Also in attendance was Rep. Mervyn Dymally (D-Calif.). At a second, all-day session 40 students from 30 campuses compared notes, priorities and the interests of their organiza-

The organizers emphasized that the conference was not designed to create a single intended to enable each group to present its agenda to the other. AIPAC's Leadership Development Coordinator Jonathan Kessler described AIPAC's program on campus, its pro-Israel political activities and the activities of anti-Israel groups. William Morton, head of NAACP's Youth and College Division, then presented NAACP's agenda: increasing voter registration, a "Fair Share" program to increase the number of Blacks hired in companies with Black investment, and an intense membership push.

Calls for Cooperation

Dine referred to Black legislative support for measures of concern to Israel and to Jewish support for civil rights legislation and Black candidates for public office.

The 1980's will be years of great political activism," he said. "To maximize our impact, our two communities must identify issues of mutual concern working through the political process to achieve our goals, together whenever possible." He urged students attending the conference to frankly share concerns and attempt to rectify misunderstandings, to recognize common goals in local and national elections, and to find new ways of involving more students in the political process.

Rev. Hailes called for closer Black-Jewish relations and decried past Black-Jewish misunderstandings: "We have to lift ourselves up above our individual concerns to those which lift us up together and that is why we are sharing our agendas.

At the all-day session, Dr. Julius Lester, who teaches Afro-American studies and Judaic studies at the University of Massa chusetts at Amherst, related his own background as a Black activist who later converted to Judaism. He noted the differences in Black and Jewish perceptions of each other, with Blacks expecting better treatment from Jews than from most whites and he explained that differences need not be antagonisms. He urged Blacks to realize that Jews have been oppressed and that anti-Zionism is anti-Semitism. Jews, for their part, must try to understand Black suffering and courage and try to identify

THE KOL NIDRE is a Jewish prayer named, from its opening words, "All vows" (Kol nidre). It is based on the declaration of the Talmud:—

"He who wishes that his vows and oaths shall have no value, stand up at the beginning of the year and say: 'All vows which I shall make during the year shall be of no value.'"

It would be pleasant to be able to declare that this is merely one of the curiosities of the darkness which covers the Talmud, but the fact is that Kol Nidre is not only an ancient curiosity; it is also a modern practice. In the volume of revised Festival Prayers published in 1919 by the Hebrew Publishing Company, New York, the prayer appears in its fullness:—

"All vows, obligations, oaths or anathemas, pledges of all names, which we have vowed, sworn, devoted, or bound ourselves to, from this day of atonement, until the next day of atonement (whose arrival we hope for in happiness) we repent, aforehand, of them all, they shall all be deemed absolved, forgiven, annulled, void and made of no effect; they shall not be binding, nor have any power; the vows shall not be reckoned vows, the obligations shall not be obligatory, nor the oaths considered as oaths."

If this strange statement were something dug out of the misty past, it would scarcely merit attention, but as being part of a revised Jewish prayer book printed in the United States in 1919, and as being one of the high points of the Jewish religious celebration of New Year, it cannot be lightly dismissed after attention has once been called to it.

Thus, Kol Nidre stands condemned by a portion of Jewry itself. The Jewish Encyclopedia, 1904, Vol. VII, page 541, says: "It cannot be denied that according to the usual formula, an unscrupulous man might think that it (Kol Nidre) offers a means of escape from the obligations and promises which he had assumed and made in regard to others."

EXCUSES PERJURY

One of the most important aspects of Kol Nidre is that it suborns or excuses perjury in the Courts in the case Orthodox Jewish witnesses, whose testimony, of course, is rendered worthless by it.

If the prayer were a request for forgiveness for the broken vows of the past, normal human beings could quite understand it. Vows, promises, obligations and pledges are broken, sometimes by weakness of will to perform them, sometimes by reason of forgetfulness, sometimes by sheer inability to do the thing we thought we could do. Human experience is neither Jew nor Gentile in that respect.

But the Kol Nidre prayer is a holy advance notice, given in the secrecy of the synagogue, that no promise whatever shall be binding, and more than not being binding is there and then violated before it is ever made!

The scope of the prayer is "from this day of atonement, until the next day of atone-

The prayer looks wholly to the future, "we repent, aforehand, of them all."

The prayer breaks down the common ground of confidence between men—"the vows shall not be reckoned vows; the obligations shall not be obligatory, nor the oaths considered oaths."

It requires no argument to show that if this prayer be really the rule of faith and conduct for the Jew who utters it, the ordinary social and business relations are impossible to maintain with him.

It should be observed that there is no likeness here with so-called Christian "hypocrisy." Christian "hypocrisy" arises mostly from men holding higher ideals than they are able to attain to, and verbally extolling higher principles than their conduct illustrates. That is, to use Browning's figure, the man's reach exceeds his grasp; as it always does, where man is more than a clod.

BABYLONIAN CHARACTER OF JUDAISM

But the Kol Nidre is in the opposite direction. It recognizes by inference that in the common world of men, in the common morality of the street and the mart, a promise passes current as a promise, a pledge as a pledge, an obligation as an obligation — that there is a certain social currency given to the individual's mere word on the assumption that its quality is kept good by straight moral intention. In straight Christian morality, a man's word is expected to be as good as his bond. But the inference of the Kol Nidre is that man should make provision to drop below that level of morality.

How did the Kol Nidre come into existence? Is it the cause or the effect of that untrustworthiness with which the Jew has been charged for centuries?

tts origin is not from the Bible, but from Babylon, and the mark of Babylon is more strongly impressed on the Jew than is the mark of the Bible. Indeed the Talmud

is openly praised and revered as being Babylonian. And Kol Nidre is Babylonian Talmudic, finding its place among many other and similar dark things within that many-volumed and burdensome invention. If the Kol Nidre ever was a backward look over the failures of the previous year, it very early became a forward look to the deliberate deceptions of the coming year. Many explanations have been made in an attempt to account for this. Each explanation is denied and disproved by those who favor some other explanation. The commonest explanation of all is this, and it rings in the over-worked note of "persecution." The Jews were so bounded and harried by the bloodthirsty Christians.

"Many learned men want to have it understood that the Kol Nidre dates from the Spanish Inquisition, it having become necessary on account of all sorts of persecution and inflictions to adopt the Christian religion for appearances' sake. Then the Jews in Spain, gathering in cellars to celebrate the Dav of Atonement and pardon, composed a prayer that declared of no value all vows and oaths that they would be forced to make during the year..."

"The learned men say, moreover, that in remembrance of those days when hundreds and thousands of Maranos (secret Jews) were dragged out of the cellars and were tortured with all kinds of torment, the Jews in all parts of the world have adopted the Kol Nidre as a token of faithfulness to the faith and as self-sacrifice

Father Coughlin Led Anti-Communist Fight In 1930s

Royal Oak, Mich. was the location of a small Catholic Church called "The Shrine of The Little Flower." The pastor was Father Charles E. Coughlin. During the 1930s most people had no idea what communism was all about. 
> **Jews Called For Destruction Of Germany** In 1934 - Five Years Before W. W. II

Israel's founder of the Irgun terrorist organization, Vladimir Jabotinsky, wrote in the Jewish magazine Natcha Retch in 1934:

Andre said WOMP, to his knowledge, has never backed off from any controversy but explained that "the timing is not right"

He said that the beliefs, background and affiliations of a candidate for political office should be made known to the public, and what a candidate stands for is important for the electorate to make a responsible choice.

Missouri Has New NSRP Leader

Henry L. Hamilton is the National States Rights Party candidate for Sheriff of Harrison County, Missouri. Mr. Hamilton has been an active member for some time and obtained far more than the number of signatures required to place his name on the November ballot. 


