Waldheim Victorious Over World Jewish Congress

Waldheim Wins Despite World Jewish Congress Austria gave Kurt Waldheim a great vote of confidence for President. The World Jewish Congress (WJC) pulled every dirty trick in the book seeking to defeat Waldheim by calling him a "Nazi war criminal." This vicious smear campaign was conjured up by one of the richest Jews in the world, Edgar M. Bronfman. He heads the WJC. It is now called the "Second Bitburg" as Bronfman demanded that Secy. of State George Shultz ban Waldheim from ever visiting America again. (They tried to block Pres. Kurt Waldheim served with distinction as Secretary General of the United Nations for two terms from 1972 to 1982. In Austria he is highly respected and represents the conservative Austrian People's Party. The WJC joined in a vicious smear conspiracy with the Yugoslavia Communist Party in releasing forged documents seeking to brand Waldheim as "yet another war criminal".

The Austrian People's Party newspaper, "Volksblatt" charged that the investigations demanded should be aimed at Israel's terrorist leaders such as Foreign Minister Shamir. He ordered the assassination of British Lord Moyne in Egypt and Sweden's U.N. peace negotiator Count Folk Bernadotte. They added; "many Israeli leading politicians were simply terrorists ex-Prime Minister Begin ordered the bombing of the King David Hotel in 1946 killing nearly 100 British soldiers and civilians."

Volksblatt published British "wanted posters" from that era with a price on the heads of Begin and Shamir. It added, "the feverish archive-rummaging of the WJC people has inspired us to also poke around in archives and we find a bloody trail of Jewish terror. The blood-red stains are on the vest of many an Israeli politician!"

South Carolina Jew Initiated Slander

Southerners will be surprised to learn that the Jew "researcher" who came up with the communist doctored "evidence" against Waldheim is Robert E. Herzstein. He is a professor of history at the University of South Carolina in Columbia and on the payroll of the WJC. Herzstein also authored a vicious smear book against the German people for "Time-Life Books" called The Nazies.

The documents come from Communist Yugoslavia's "War Crimes Commission." (Note: This is not a very impartial source!) The Belgrade, Yugoslavia paper "Vecernje Novosti" states Waldheim is "wanted in connection with the murder, slaughter, shooting of hostages and ravaging of property by burning of settlements." Waldheim (age 67) responded that the allegations are "absurd and pure lies."

Artukovic Secretly Handed To Reds

Justice Dept. Betrays Patriot

Secy. of State George Shultz signed the extradition papers against Artukovic, at the request of the Jew Neal Sher, head of the Justice Depts' "Office of Special Investigations (OSI)." This unit was established by a bill authored by former Brooklyn Congresswoman Elizabeth Holtzman. It was especially designed to deport anti-communists to Communist countries and Israel for show case trials.

In the middle of the night, Andrija Artukovic, 86, was secretly hauled aboard Yugoslavia Air Lines by U.S. Marshals. Mr. Artukovic is blind, has had two heart attacks, a stroke, has Alzheimer's and Parkinson's diseases. Still the U.S. government went through the obscene action of turning this man over to the communists so that he can be hanged before he has a chance to die a natural death.

Jews In Vulgar Celebration

Elizabeth Holtzman wrote in The Jewish Press, "this is really good news," adding there are "hundreds of other Nazi war criminals which must be traced down." Both the Los Angeles based Simon Wiesenthal Holocaust Center and the New York "World Jewish Congress" immediately expressed their gratitude to the Justice Dept., and the State Dept.

Attending the trial representing world Jewry is Martin Mendelsohn who today has a private law practice in Washington D.C. He formerly was with the OSI and helped them strip Artukovic of his citizenship. He also has worked with the professional holocaust survivor, Simon Wiesenthal, who has made his life's work the tormenting of elderly anti-communists from the W.W. II era. Mendelsohn said: "That little old man claims senility but he is as bad as you can get. This is a humane trial and should help the Yugoslavs extradite other residents from the U.S., Canada and Australia."

Charged With Being Anti-Communist

Croatia and Serbia constitute two of the several ethnic nations which today make up communist ruled Yugoslavia. Croatia is strongly anti-communist and welcomed the German invasion of Yugoslavia. Germany in turn granted Croatia independence in 1941. A new government was formed which enjoyed popular support. Andrija Artukovic served as Minister of the Interior from 1941 to 1945. They joined with the Germans in fighting against Tito's communist guerrillas.

A brutal civil war was waged. Artukovic is today charged with killing 231,000 communists, Jews and Gypsies. He flatly denies the charge and has proven in one case he personally went to the scene of fighting between Croats and Serbs to mediate an armistice.

On the Serbian side was Gen. Draga Mihailovitch who headed the "Chetniks." They fought both the Germans and Tito's communists. For several years he was favored by the British to take over as head of an anti-communist Yugoslavia. They air dropped supplies to his forces. But, when Stalin invaded the country he installed Tito in power. There was to be no room for ANY anti-communists.

Tito fought a bloody civil war with both the Croats and the Chetniks. This fighting went on until the end of 1946. TITO EXECUTED ALL PRISONERS INCLUDING GEN. MIHAILOVITCH! Historians place the number of anticommunists murdered and tortured to death at over one million! In fact, it is estimated that Tito killed more people than all of the other massacres which took place in the other countries which fell under Stalin's control.

It is unbelievable that today, some 40 years after the end of W.W. II, we are sending elderly anti-communists to the brutal regime of the late Tito for "fair trials!" Artukovic Trial A Farce

The communists have labeled the poor aged Artukovic "the butcher of the Balkans" when in truth that title belongs to the mass murderer Tito. Still the communist Prosecutor Ivanka Pintar-Gajer told the court: "here is one of the greatest and most notorious war criminals alive." Artukovic is held in a glass box exactly like the one the Jews plan for John Demjanjuk's trial in Israel.

The Son Protests

Upon learning that his father had been secretly flown to Yugoslavia in a move the OSI knows is tantamount to execution, Rad Artukovic said: "Oh, poor dad! I'm not surprised. They made a mockery out of our judicial system, and our government helped the communists do it. How could the U.S. government turn a political prisoner over to a communist country?

It contradicts the Reds' account that Artukovic ordered his execution for communist guerrilla activities.

The Los Angeles Times of April 28, 1986 quotes the Jew head of the OSI, Neal Sher, as stating his policy is to settle cases out of court when the defendant, "is considered to be in poor health," and allow them to remain in the U.S.

Of Artukovic Dear Editor,

I am very pleased that Andrija Artukovic, the highest ranking Nazi war criminal known to have entered the United States, has been extradited to Yugoslavia to face trial on mass murder charges.

I have worked for his expulsion from the United States since 1974 - this is really good news. Artukovic, as Minister of Interior and Minister of Justice in the Nazi puppet state of Croatia, was responsible for the deaths of hundreds of thousands of Jews in Yogoslavia during World War II. Yet for 37 years he was allowed to live in freedom in the United States. with the knowledge of our government.

Sher explained that the U.S. does not criminally prosecute war criminals. "Our aim is to kick them out of the country. They have no right to live in this country, or breathe the same air we breathe.

Sher noted that the work of his office is sometimes frustrating and time consum-

We have to turn allegations into evidence from events that happened 35 to 40 years ago. People want to forget, or they die." The average age of those involved in these cases is 70

However, he asserted that there is no statute of limitations for moving against war criminals.

"As Simon Wiesenthal once said, there is only a biological statute of limitations.

Wiesenthal, the famed Nazi hunter, works closely with Sher and his office of 50 lawyers, investigators, historians and paralegals

He also works closely with the Israeli overnment, which has a section of their national police working exclusively on investigating war criminals. He said the West German government is

"officially" extremely cooperative, but what they think in their hearts, I don't know.

Sher promised even more litigation by OSI under his leadership, and praised sup-port by the Reagan administration and Congress of his efforts.

One of his main efforts is to make sure there is enough on the record to dispute organizations who claim that the Holocaust was a hoax.

Sacrifice Stirs People

About 700 Metro-area Croatians crowded into the lobby of Wellesley Hospital yesterday afternoon to honor a com-patriot who set himself ablaze last month in front of the U.S. Consulate.

The solemn crowd of men, women and children held a religious service and said prayers for Markos Djukic, 63, of London, Ont. Djukic is in critical condition in the hospital's burn unit with third-degree burns to 20% of his body inside and out.

Their 21/2-hour stay in the lobby was quiet and without incident.

Djukic was one of a group of Croatians at the consulate Feb. 12 to protest the U.S. extradition of Andrija

Mato Djukic, the burned man's brother, said Markos told him, "he hopes his actions will open the eyes of all Croatians.

"He had to choose the most horrible kind of death," Mato added. "I'm so proud he had so much courage and strength to follow it through."

Josip Janulin, president of the Croatian Committee of Human Rights, who has visited Djukic every day in hospital, said similar services were held yesterday by Croatians living in the U.S., Australia and the Ukraine.

"Five to 10 people are keeping a 24-hour vigil out-side the hospital," Janulin said.

"He did it to attract the attention of the media and fellow Croatians around the world to the struggle," said Janulin's wife, Vivian. "There is a constant smear cam-paign against Croatians. The Croatian people are prepared to sacrifice themselves for freedom and truth."

"We are just coming to visit a Croatian hero," said Myle Bosnjak, 47, of Northland Ave. "He sacrificed him-self for Croatian people who are slaves in Yugoslavia."

Many of the Croatians later went to the U.S. Consulate where they laid wreaths.

Croatians Demand Justice

Yelling "Long live Croatia," a man set himself on fire in front of the U.S. Consulate in Toronto yesterday during a demonstration by more than 2,000 supporters of Croatian Solidarity.

Marko Djukic, 63, of London, Ont., set himself on fire without warning. Several people threw themselves on to the burning man in an attempt to smother the flames.

Many of the demonstrators were carrying placards reading "Artukovic is inno-cent" and "Stop Hate Mongering."

At a news conference after the demonstration, organizers said they firmly believe Mr. Artukovic was set up by the U.S. Government and described his extradition last week to Yugoslavia as a scandalous

Yugoslav authorities said Mr. Artukovic, who is in failing health, will be tried on war crimes charges that carry the death penal-

ty. Dr. Josip Gamulin, one of the organizers of the protest march, said Croatians have become fed up with what he described as "extremist elements" in the United States and Canada who are pushing for the extradition of alleged Nazi war criminals.

Dr. Gamulin said that individuals and groups who are leading the fight to have "Romanians, Latvians, Estonians, Ukrai-nians and others" extradited "are extremist by their behavior and trightening by the power they have."

be cloned in Canada."

Dr. Gamulin said Croatian Canadians will never allow any of their compatriots to be extradited from Canada. "If they believe someone has committed a war crime, he should be tried in Canada."

Dr. Gamulin said the Deschenes Commission investigation into the presence of Nazi war criminals in Canada is driving a dangerous wedge between many East European communities and the Jewish community.

"We feel the commission is very threatening. We are being accused of phony crimes and our people are being deported to countries where there is no justice.

Dr. Gamulin said he finds it "incomprehensible" that Sol Littman, the Canadian representative of the Los Angeles-based Simon Wiesenthal Centre, has "smeared all the communities of Eastern Europe and yet he is still a member of the Committee for Racial Harmony."

Dr. Gamulin also criticized the news media for giving "more news space to smear campaigns than on the contribution that these communities have made to Canada."

Waldheim's Real War Record

Kurt Waldheim was drafted into the German Army in 1939. He fought on the Russian front and received a serious leg wound in 1941. After months in the hospital he returned to service in the fight against communist leader Tito's guerrillas in Yugoslavia. Waldheim was made a lieutenant on the intelligence staff of the 45th Infantry Division. Being an expert in Italian he became the interpreter of messages passing back and forth between Italian and German officers.

Waldheim served under Gen. Alexander Loehr who after the war was handed over to Tito who had him shot as a "war criminal." This was a dastardly act on the part of the Allies. Now today the Jews claim this proves that Waldheim must be a war criminal too. They note that Waldheim was given the Croatian military decoration, "The Order of the Crown of King Zvonimir". WHAT IS WRONG WITH THIS? Croatia was the main nation fighting against the communists at the side of the Germans in Yugoslavia!

Recent polls show only 2% of the Austrian people believe the JWC charges against Waldheim. Elan Steinberg, director of the WJC says, "one should remember that the 500,000 Austrians who were in the German Army committed 40% of all war crimes. Both Adolf Hitler and Adolf Eichman were Austrians."

Yugoslavian Reds Forged "Evidence" Against Waldheim

VIENNA-An aide to Austrian presidential candidate Kurt Waldheim charged Friday that documents linking the former U.N. secretary general to Nazi war crimes were altered before they were leaked to news organizations.

Michael Graff, secretary general of the Austrian Peoples Party, released two documents allegedly doctored to indicate that Waldheim knew Greek Jews were being deported to death camps and about Nazi retaliation against Yugoslav partisans.

"There is no doubt that documents used in the entire Waldheim campaign were manipulated. Graff told a news conference.

Among the alleged alterations were deletions and additions of names and information and the use of a different typewriter to alter an original report, he said.

The allegations about Waldheim,

surfaced a month ago in the weekly Austrian magazine Profil and the New York Times and in documents publicized by the World Jewish Congress.

Waldheim has denied the allegations and charged they were politically motivated.

A Profil representative attended the news conference and said his magazine did not know the documents had been altered and promised a correction in the next issue.

One document used by Profil was a report, marked "secret" and dated July 15, 1944, that listed "enemy" actions in Nikaria, actions in Nikaria, Greece.

A second section of the report stated: "End of July 1944. The deportation of Jews who have no Turkish citizenship has started on order of the Supreme Command of Army Group E, IC-AO." Waldheim was a member of that unit.

Graff said different typewriters must have been used to type the two sections because the letter "R" key was not printing correctly on the first page but was functioning on the other page.

He also noted reference in the past tense to deportations at the end of July, although the document was dated July 15, and said the

Graff said the name of the chief writer of a daily report on army activities along the Eastern Front was deleted at the bottom and only the name "Waldheim" was left.

This was an attempt to portray Waldheim as the author of the intelligence report when his duty was actually to confirm that it was correctly typed, Graff said.



Israel's President Adresses **Communist Party**

The Communist Party of Israel held its convention last Dec. 5-7 in Haifa. The General Secretary of the Party, Meir Vilner, said they had made great progress in recruiting young Jews as members. He said that 40% of those attending were under the age of 30 and that, membership had increased by 30% since the 1981 congress. One of the chief items on the agenda were attacks on South Africa and calling for a trade boycott by Israel. As of today Israel imports South Africa's diamonds for this Jewish monopolized market. 

Probers Rejected Report That Moscow Coached Witnesses Against Accused Ex-Nazis in America

By ROBERT GILLETTE, Times Staff Writer

WASHINGTON-In January, 1980, when the United States was angrily imposing economic and diplomatic sanctions on the Soviet Union for the invasion of Afghanistan, representatives of the U.S. Justice Department were quietly negotiating an unprecedented agreement for cooperation with their counterparts in Moscow.

In three days of amicable talks, the Justice Department reached an agreement with Alexander M. Rekunkov, now the Soviet Union's highest legal officer. The agreement called for Moscow to assist the United States in prosecuting Soviet refugees who had fled at the end of World War II and who were now, as naturalized Americans, suspected of murdering or persecuting civilians during the Nazi occupation.

Under terms set largely by the Soviet side, Soviet judicial authorities agreed to supply documents and eyewitness testimony to the Justice Department's newly created Office of Special Investigations. The office's mission was to ferret out suspected war criminals and persuade the courts to revoke their citizenship and deport them. But, to accomplish this, the bulk of evidence would have to come from the Soviet Union

"Winning the cooperation of the Soviet Union was a critical step in our plans for OSI," its former director, Alan A. Ryan Jr., ob-served in his 1984 book, "Quiet Neighbors." Almost all the refugees now under suspicion of war crimes had come from the Soviet Union. Captured German documents bearing on their ties to the Nazi occupiers were held in Soviet archives.

"We also needed witnesses to atrocities: bystanders, colleagues, victims, neighbors," Ryan said. "Some of these, particularly vic-tims, we might find in America or Israel or Canada or elsewhere in the world. But most of the neighbors and bystanders had never left home. . . . If we were to have their testimony, we needed the permission of their government."

Nothing in Writing

To ensure a proper atmosphere for the talks, the Justice Department representatives ignored a State Department request to register Washington's strong disapproval of the Afghan invasion. 'To the Justice Department's surprise, the Soviets asked nothing in return for supplying the evidence the Americans wanted. But there was to be no formal written agreement, only an oral understanding, making this a unique arrangement between the superpowers at a time when relations in every other neid were rapidly deteriorating.

It was to be, as Ryan observed, a "wildly improbable marriage" between the judicial authorities of a democracy and those of a "totali-

tarian regime." who evinced "no hint that they understood what we were talking about" when the Americans tried to explain the basic concepts of due process that Westerners consider essential to a fair trial.

Just how improbable the mar-

riage-and how nettlesome the legal issues raised by the U.S.-Soviet agreement-has become clear since.

Six years later, the Office of Special Investigations has won broad public approval for its aggressive pursuit of alleged war criminals. According to the agency's figures, 19 naturalized Americans have been stripped of their citizenship and nine deported-one so far to the Soviet Union-while another 35 cases are currently in the courts and 300 investigations are under way.

Soviet evidence has played a major role in these cases, often with little corroborating evidence from other sources.

Bitter Protests

Ethnic organizations of Baltic and Ukrainian nationalities, joined by some conservative political groups, have bitterly protested the use of this evidence, condemning it as inherently untrustworthy.

The Office of Special Investigations, strongly supported by the American Jewish community, dismisses such criticism as reflexive anti-communism tinged with anti-Semitism and motivated by a thinly veiled desire to protect war criminals.

"No American judge has concluded that any documentary evi-dence obtained from the Soviet Union was fabricated," the Anti-Defamation League of B'nai B'rith said in a 40-page defense of the OSI published last June. "Nor has any witness made available by the Soviet Union been found to have lied in connection with his or her testimony."

Over the last three years, however, largely without public notice, a number of federal court jurists and defense lawyers have voiced serious misgivings about the use of Soviet evidence, especially witness testimony, in American courts.

Although in the majority of cases federal courts have accepted it as valid, there are at least four cases in which judges have rejected Soviet testimony entirely or in part as seemingly coerced or invented, or for other reasons "not worthy of belief," as one appellate opinion phrased it.

In addition, a committee of the American Bar Assn. has considered a recommendation to organize a formal study of the problems raised by the use of Soviet evidence but so far has taken no action on the proposal.

Reliability Question

As the critics in the legal community see it, the troubling feature of the OSI's war crimes cases is not distant in time and place, and deal with the highly emotional question of complicity in the Holocaust, but that they rest to a major degree on the acceptance by American courts of evidence compiled by the Soviet KGB security and intelligence agency and selectively supplied to the Justice Department.

They question whether the U.S. government, and, more important, the courts, can reasonably expect to use such evidence to tell the guilty from the innocent. As a

memorandum circulated in recent months in the American Bar Assn.'s committee on law and national security said: "Is the evidence made available by the Soviet Union reliable, and does the getting and use of such evidence conform to due process standards?'

The American Bar Assn. memo drew no conclusions but recommended that a blue-ribbon panel be convened to study these and related questions.

Concerns expressed in a number of federal court opinions, and by individual lawyers in a series of interviews, are both political and procedural.

They note, for example, the Soviet Union's long history of bending justice and inventing evidence to suit its political aims, from the theatrical show trials of old Bolsheviks in the 1930s to the trials of the recently freed Anatoly Shcharansky and other human rights activists in the 1970s and 1980s.

In the case of accused war criminals living in the United States, the critics believe, the Soviet aim is not only to bring a small number of bona fide murderers to justice but to tar traditionally an--communist emigre communities in the United States as broadly as possible with the same brush. The Soviets, the critics say, want to stir dissension among emigre groups

opinion in the case of Serge Kowalchuk, 65, a Ukrainian-born emigre stripped of his citizenship for working as a clerk in a Nazi-controlled police unit during World War II, Chief Judge Ruggero J. Aldisert of the 3rd Circuit Court of Appeals wrote last September:

The government's case is based on evidence procured by the KGB to effectuate its political ends. Congruence between that purpose and individual justice has yet to be established."

Few if any critics in the legal community suggest that all Soviet evidence is tainted. The problem, they say, is to distinguish between testimony that is genuine, embellished or simply invented, and to recognize when documents have been selected from the archives, omitting those that might exonerate a defendant or mitigate the charges against him.

Denial of Access

Under the terms of the 1980 agreement, this has not been an easy task. The Soviets have refused to give prosecutors or defense attorneys from the Office of Special Investigations access to wartime archives to search for other evidence that might bear on a defendant's guilt or innocence. Lawyers, and some federal courts, have objected that these restrictions make it almost impossible to guarantee a defendant's due process right to a meaningful defense.

In addition, the Soviets strictly control the Americans' access to witnesses.

Their testimony is videotaped for use in American courts, U.S. defense lawyers have the right to cross-examine the witnesses, and OSI will even pay the lawyers' travel expenses to the Soviet Union. But, in all cases, Soviet prosecutors supervise the taking of depositions, frequently seek to restrict cross-examinations and often urge the witnesses to adhere to written summaries or "protocols" of their earlier interrogations by the KGB.

Despite the OSI's initial hopes in 1980, no Soviet witness in a war crimes case has yet appeared in an American court, although some have traveled to West Germany to testify in other cases.

By contrast, Poland, where most of the Nazi extermination camps were located, has imposed no such restrictions on access to official archives or witnesses.

However, the OSI's cases have led the agency to depend far more heavily on Soviet evidence than on Polish. It has taken testimony, for instance, from fewer than half a dozen Polish witnesses since 1980, but in the same period has interviewed more than 100 Soviet witnesses



In its appeal, OSI accused U.S. District Judge Dickinson R. Debevoise of injecting "political bias" into his decision and went on to assert:

"While the Soviet Union may act with impunity in legal proceedings confined to its own borders, it cannot do so in cases under the scrutiny of foreign judges, lawyers and witnesses."

Successful fraud by the Soviet Union in these matters, the OSI argued in its appeal, "is beyond its capabilities" and in any case would be "inevitably doomed to exposure.'

Asked in an interview whether this was not, in effect, an assertion of infallibility on the part of the American judicial system, Sher said it was not. "It is just an assertion of complete faith in the ability of our courts to ascertain the truth," Sher said.

ence, the control-to create staged cases," John Rogers Carroll, a Philadelphia trial lawyer, said in a recent interview. Carroll defended Kowalchuk, a Philadelphia tailor who now faces deportation to the Soviet Union.

While the role of eyewitness testimony varies among OSI's cases, it dominates the Kowalchuk case, where, as a district court noted, "there is . . . not one scrap of documentary evidence relating to the pertinent events."

Carroll said his experience in two evidentiary hearings in the Soviet Union in 1981 and 1983 convinced him that cross-examination of witnesses under Soviet control "has little effect on someone who knows that all he has to do is stick to his story and he won't get into trouble.'

"He (a witness) knows I can't go into his story, investigate the de-tails," Carroll said. "He won't be prosecuted for perjury. He knows that none of the normal sanctions (against false or misleading testimony) apply here."

Between 1983 and last year, at least four federal district and appeals courts have rejected such testimony as seemingly coerced, as prejudiced by the remarks of Soviet prosecutors or for other reasons as untrustworthy. In other casesnotably Kowalchuk's-dissenting opinions have voiced grave concern that the use of unverifiable Soviet evidence jeopardizes a de-fendant's constitutional right to due process.

In May, 1984, a federal district court in New York cited concerns about coerced testimony in dismissing an OSI suit to revoke the citizenship of Elmars Sprogis, a former Latvian police officer the Soviets accused of having murdered and persecuted Jews during the German occupation. The accusation depended heavily on the videotaped testimony of two Soviet witnesses, whose behavior, according to Judge Frank X. Altimari, suggested coercion.

At one point, Altimari noted, a key witness, when offered an opportunity to rest during his testimony, inexplicably began to cry.

"Whether it be due to coercion, discomfort, fear, old age or other factors, (it) counsels in favor of cautious acceptance of his testimony," Altimari wrote in his decision. In May, 1985, the 2nd Circuit Court of Appeals upheld the dismissal of the case, noting that Altimari had acted properly in rejecting the Soviet testimony as "potentially coerced" and "unworthy of belief."

criminals" or "neo-Nazies" live in a "zone of danger" and must be on guard. Still, through this date, the FBI has yet to arrest one single Jewish terrorist. This is astounding considering the fact that the FBI states Jewish organizations have committed more acts of terrorism in the U.S. during 1985 than all other groups COMBINED!

Four months later, on Sept. 6, Sprogis, 70, narrowly escaped injury when a bomb exploded at his home in Brentwood, N.Y. The Federal Bureau of Investigation has said that this, and a similar bombing three weeks earlier in Paterson, N.J.-which killed a naturalized Ukrainian who had been cleared by the OSI-may have been carried out by the militant Jewish Defense League.

The similar case of Edgars Laipenieks, a former professor of physical education at the University of Denver, illustrates the important role a judge's subjective impressions and instinct play in gauging the credibility of Soviet witnesses from a videotape. In Laipenieks' case, these impressions varied greatly from one court to another.

A local police chief in Nazi-occupied Latvia, Laipenieks was ac-cused not of complicity in the Holocaust but of beating Communist prisoners in his jail. In 1981, the OSI sought to deport him to the Soviet Union.

The government's case turned on the testimony of nine Soviet witnesses. An immigration court judge rejected it as untrustworthy, citing what he called an intimidating atmosphere highlighted by a Soviet prosecutor who curtailed cross-examination of the witnesses and repeatedly described Laipenieks in front of them as "the Nazi war criminal."

The Board of Immigration Appeals, however, found the testimony sufficiently valid to reverse the decision and order Laipenieks deported. Then in January, 1985, the 9th Circuit Court of Appeals reversed the appeals board's decision, saying it was troubled by the board's "tacit acceptance" of Soviet evidence that appeared untrustworthy.

Moreover, the court said, the Latvian police had valid reasons for jailing some of the Communists. who were suspected of having collaborated with the Soviet Union in its annexation of independent Latvia in 1940 under a treaty with Moscow's ally from 1939-41, Nazi Germany.

A key witness who claimed that Laipenieks had beaten him, the court noted, had in fact been suspected in 1941 of helping Soviet occupation forces a year earlier draw up lists of thousands of Jews and other Latvian civilians for deportation to Siberia.

The sharpest rebuke the Office of, Special Investigations has yet reeived from a federal court came in 1983 in the case of Juozas Kungys, the former Lithuanian policeman. In an acidly worded decision, Judge Debevoise dismissed the government's case with the observation that the Soviet authorities had a clear political interest in pinning the blame for wartime atrocities on American defendants-namely to discredit anti-Soviet emigre communities.

"If the government deputizes a totalitarian state to obtain for it evidence to be used in a United States court, the government must take whatever steps are necessary to ensure that the evidence was not coerced or otherwise tainted by

improper pressures," Debevoise wrote, and added that the government had failed to fulfill its responsibilities in this case.

Not only did the witness testify in an intimidating atmosphere, the judge said, but OSI attorneys contributed to this atmosphere by what he called their "extreme deference" to the presiding Soviet prosecutor, "who was nothing more than their partner in the prosecution of this case."

Debevoise gave particular weight to testimony by a former Soviet prosecutor, now living in the United States, who explained how witnesses are commonly manipulated in Soviet courts.

The former prosecutor, Frederick Neznansky, acknowledged that many witnesses are truthful and that many investigations are honestly conducted. But he said that when the evidence fails to support the desired result, there is intense pressure from prosecutors and judges alike to remold it. "The way it's explained to a

witness is often very lofty," Nez-nansky said. "The accused is a criminal against the Communist Party, against the state, and is probably a parasite and an enemy of the people. So it is the civic duty of the witness to testify in the appropriate way."

Failing this, he said, "sometimes they (witnesses) are threatened. Not in a serious way, but people could be told they will be fired (from their jobs) if their testimony is not appropriate."

Similarly, a former officer in the Latvian KGB who defected to the United States in 1978, Imants Lesinskis, said he found that witnesses in war crimes cases with which he dealt as a propaganda officer were often totally compliant.

"They had been in Soviet (labor) camps for many years and they were afraid to go back. So if you asked them the right questions, they confirmed all," Lesinskis said.

While these cases focused mainly on the trustworthiness of Soviet evidence, a dissenting opinion in the widely publicized Kowalchuk case stressed the issue of a defendant's right to due process in the face of Soviet controls on access to evidence.

The OSI sought to revoke Kowalchuk's citizenship on the ground that he had concealed membership in a Nazi-controlled police force in the Ukraine that would have made him ineligible for a visa, and also that he took part in the murder of Jews in the town of Lubomyl.

A district court was skeptical of Soviet evidence that Kowalchuk took part in persecutions and atrocities, but ruled that his citizenship was nevertheless obtained by Iraud and ordered it revoked.

A three-judge panel of the 3rd Circuit Court reversed this ruling on a vote of 2 to 1; then the full 3rd Circuit, on its own motion, reviewed the case again en banc.

Last Sept. 23, the full court decided 8 to 4 to revoke Kowalchuk's citizenship after all. This February, the Supreme Court turned down his request for review, opening the way to Kowalchuk's eventual deportation to the Soviet Union.

Jurists Express Doubts on Soviet Evidence in U.S. Cases

In rejecting Kowalchuk's argument that Soviet restrictions denied him access to archives and possible witnesses, the majority noted that "Soviet Russia also imposed the same limitations upon government counsel."

In any case, it said, whether or not Kowalchuk took part in persecutions, he had given "voluntary assistance to enemy forces" by working as a local police clerk and was therefore ineligible for U.S. citizenship.

In a sharply worded dissenting opinion, Chief Judge Aldisert wrote that, in fact, a "compelling" violation of Kowalchuk's right to due process lay at the heart of the case.

"For reasons I refuse to regard as altruistic, the Soviet KGB has singled out American citizen Serge Kowalchuk for immediate attention by our government, in a stream of extravagant accusations subsequently not proved in district court," Aldisert wrote in an opinion joined wholly or in part by three other judges.

Soviet restrictions, he said, effectively "denied Kowalchuk the opportunity to conduct even a primitive preparation of a defense, . . . the most basic of due process rights."

The Justice Department, he concluded, thus placed itself in the "uncomfortable position of arguing allegations which it has not had the opportunity to verify and which it, in all conscience, must view as suspect."

Entirely apart from questions of due process and the trustworthiness of Soviet evidence, a number of defense lawyers maintain that their clients are also disadvantaged by a fluke of American law that requires them to be tried in civil, not criminal, proceedings, even though the consequences—loss of citizenship and deportation—can be as severe as many criminal penalties.

Standards of evidence are less rigorous than in criminal cases. And because these are civil cases, the defendants do not qualify for public defenders. Most are blue-collar pensioners with modest savings, but defense costs have run as high as several hundred thousand dollars, which private law firms must absorb on a *pro bono* or charitable basis.

"You end up running these people right into the ground," said a Midwestern attorney who asked that his name not be used. Like several others, he said his law firm had received anonymous threats after it had defended an accused war criminal.

Moreover, federal civil procedures require defendants who lose in district court to find any exculpatory evidence and file an appeal within one year, even though the only conceivable source may be the Soviet Union.

"Unfortunately, what most of them do is turn to the neighborhood lawyer who may be a drunk, incompetent or both, and he immediately loses," said a Baltimore attorney who also asked not to be identified. "Then, at five minutes to midnight, before the appeal deadline, they change lawyers. By then it's too late."

A third factor is that in civil cases, the government is not required to give the defense any material in its possession that might be beneficial to its case; in criminal cases, this is required by the so-called Brady rule.

Most important, some defense lawyers believe, is the overpowering emotional context of the Holocaust that pervades these cases, regardless of how strong or weak the linkage may be between defendants and atrocities.

"We are, in a way, the victims of hydraulic pressures, of a wave of public sentiment that causes us to lose sight of certain realities," Carroll said, in a reference to special difficulties of verifying Soviet evidence.

"We tend to overlook this because we see that a terrible crime has been committed—the Holocaust—and we perceive that the OSI is finding the guilty and punishing them."

"The typical judge is just as impressed as anyone by the implications of this (Soviet) testimony," Carroll said. "But it occurs to me that our judicial procedures are not made for this kind of case."

Next: Do the Soviets manufacture evidence?

WASHINGTON—A Soviet official, in an apparent act of conscience, warned the United States nearly three years ago that Moscow was trying to deceive the U.S. Justice Department through evidence it has supplied against alleged Nazi war criminals now living in the United States.

According to informed government sources, the official confided to an American diplomat that some Soviet witnesses were being coached in their testimony for days before being allowed to give depositions to U.S: prosecutors, apparently to make their testimony more credible and incriminating

credible and incriminating. The sources, who asked not to be identified by name or agency, said this information was relayed immediately to the Justice Department's Office of Special Investigations in the summer of 1983.

However, the Office of Special Investigations, whose mission is to ferret out and deport suspected war criminals, dismissed the warning as insignificant and without substance and suggested that the official was merely "disgruntled."

U.S. prosecutors have continued to accept Soviet and captured Ger-

man documents as authentic evidence and to travel to the Soviet Union to collect eyewitness testimony.

In an interview, one government source with direct knowledge of the incident expressed dismay that the Justice Department had ignored the Soviet official's warning and failed even to disclose it to the defense lawyer involved in the specific case in which it arose.

The source said there was no reason to doubt the accuracy of the information or the sincerity of the Soviet official, who took a personal risk in passing it privately to a U.S. diplomat based in Moscow.

In doing so, the informant was said to have asked the diplomat in disbelief, "How could you Americans be taken in like this?"

Since 1980, the Office of Special Investigations has worked under a unique agreement with Soviet judi-



cial authorities in its investigation of wartime refugees who are suspected of having persecuted Jews, Communist Party members and other civilians in Nazi-occupied areas of the Soviet Union and Eastern Europe.

In the process, Justice Department attorneys and U.S. courts have relied partly on the product of investigations in the Soviet Union by the KGB security and intelligence agency.

The Office of Special Investigations continues to assert its faith in the underlying trustworthiness of evidence the Soviets have supplied against hundreds of alleged war criminals who came to the United States among an estimated 400,000 "displaced persons," as they were formally designated, at the end of the war.

Most of these refugees, who later became naturalized American citizens, fled from the Soviet Union in the closing months of the war.

In nearly seven years of operation, the Office of Special Investigations has succeeded in revoking the citizenship of 19 emigres from the Soviet-controlled Baltic states and the Ukraine. Fourteen have been ordered deported, and nine have actually been expelled from the United States, according to figures supplied by the Justice Department agency.

Returned to Soviets

One deportee, Feodor Fedorenko, who acknowledged having been a guard at the Treblinka extermination camp in Poland but claimed he was forced to work there, voluntarily returned to his family in the Soviet Union last year and has since lost contact with his American lawyer. Several other alleged war criminals currently face possible deportation to the Soviet Union.

Investigations of about 600 others have been dropped for insufficient evidence, or because of the deaths of witnesses or the suspects themselves. The Office of Special Investigations is currently investigating another 300 former refugees, most of them from the Soviet Union, while about 35 cases are currently in the courts, according to the agency's director, Neil M. Sher.

Since 1980, agency attorneys have taken testimony from about 100 Soviet witnesses. The agency acknowledges, as one of its annual reports put it, that these videotaped depositions, along with copies of hundreds of wartime documents supplied by the Soviets, have played a "crucial" role in its pursuit of suspected war criminals. Often, captured German documents supplied by the Soviets show that defendants worked for a local, German-controlled police force, for example, but fall short of showing that they actually took part in persecuting civilians. Witnesses are then produced to link them to atrocities.

The importance of Soviet evidence stems from the fact that persecutions and atrocities at the core of these cases took place largely in occupied Soviet territory, and little or no corroborating evidence is available from any other source.

Some defendants have admitted serving as concentration camp guards but maintain that they were forced by the Germans to choose between being guards or prisoners. Others have admitted that they worked in local police units controlled by Nazi occupation forces, usually as clerks, but insist they took no part in persecuting or killing civilians.

Despite the agency's repeated expressions of confidence in the reliability of Soviet evidence, its use against naturalized Americans has spawned a bitter controversy in recent years that has sharply divided American ethnic communities whose roots are in the Soviet Union.

On one side of the controversy, Baltic, Ukrainian and some Polish groups have accused the Justice Department of naively lending itself to the political aims of the Soviet regime, which has long tried to sow dissension among traditionally anti-Communist emigre groups in the West, and to discredit them in the eyes of Soviet citizens.

In turn, the American Jewish community, spearheaded by the Anti-Defamation League of B'nai B'rith and joined by some Polish-American groups, has staunchly defended the Justice Department and accused its critics of anti-Semitic motivations.

In a report published in June, 1985, the Anti-Defamation League dismissed the critics' fears of fraudulent Soviet evidence as no more than a "smoke screen" designed to conceal their real purpose, which it said is "to hamper and frustrate the OSI—and eventually to kill it."

Similarly, Sher said in a recent interview that while some of his agency's critics seem driven by reflexive anti-communism, "there is something more to this: They want to close us down."

The controversy took a violent turn last year, with twin bomb attacks—one of them fatal—on two former Soviet refugees who had been cleared of war crimes charges. A spokesman for the FBI in Washington, Lane Bonner, said the bureau is continuing an intensive investigation into the two bombings and believes that the militant Jewish Defense League may have been responsible.

Last Aug. 15, Tscherim Soobzokov, 67, whom the Office of Special Investigations had sought unsuccessfully to deport, was lured out of his home in Paterson, N.J., at 4:30 a.m. by a ruse—a fire set in his car—and suffered massive injuries to his lower body as a bomb exploded at his doorstep. His wife, daughter, 4-year-old grandson and a neighbor were also injured.

Accused by the Office of Special Investigations of having served in

the German Waffen SS, the combat arm of Hitler's elite security force, Soobzokov had been a target of protests by the Jewish Defense League after the Justice Department dropped its charges for lack of evidence. Friends of the Soobzokov family have explained that he belonged to a small, persecuted ethnic minority and accepted a Waffen SS uniform as a ploy to escape the Soviet Union with retreating German forces.

Another Bomb Blast

Then on Sept. 6, the day Soobzokov died, a similar bomb detonated at 4:30 a.m. in the Long Island community of Brentwood, N.Y., damaged the home of Elmars Sprogis, 70, a retired construction worker exonerated by a federal appeals court in 1984 of persecuting Jews in his native Latvia. Sprogis was not hurt, but a passer-by, who apparently was attracted by a fire set in Sprogis' car as a lure, was seriously injured.

Shortly after the explosion, the Long Island newspaper Newsday received a telephone call in which an apparently recorded voice reportedly said: "Listen carefully. Jewish Defense League. Nazi war criminal. Bomb. Never again."

The FBI has since warned defense attorneys involved in war crimes cases to be alert to the possibility of further violence and to urge their clients to take precautions against reprisals.

In public statements, both the Office of Special Investigations and Jewish organizations have stressed the lack of concrete proof that the Soviets have actually falsified evidence in war crimes cases.

In its report last June, for example, the Anti-Defamation League said, in a passage underlined for emphasis: "For all their claims and charges, the emigre activists have been unable to document a single instance, over the past 40 years, of forged evidence or perjured testimony being obtained from the Soviet Union for use in Western trials of accused Nazi war criminals."

The 40-page report did not mention that several U.S. district and appeals courts in the last three years have cited troubling indications that some Soviet testimony supplied to the government has been falsified. These courts have expressed concern that Soviet authorities may have engaged in a broad practice of tailoring evidence to suit OSI's needs.

In a May, 1984, speech to the Anti-Defamation League that has become the OSI's standard reply to its critics, Sher said: "There is today a concerted and extremely vigorous campaign by segments of the Eastern European emigre community questioning the appropriateness of our methods. . . . Their claim in a nutshell: OSI and the Justice Department have become the dupes of the KGB.

"The charge of knowing use of false evidence is the most serious allegation that can be leveled against a prosecutor. It accuses him of abuse of office and a perversion of the entire system of justice.

"These accusations are simply untrue," Sher said. "Our evidence is in fact legitimate and . . . the charges against us are not valid."

Evidence Emerges

According to the government sources, however, direct evidence of manipulated testimony emerged in July, 1983, during a session in the Ukrainian city of Cherkassy in which OSI attorneys took depositions from five Soviet citizens.

The case concerned a retired, 75-year-old Ukrainian-born factory worker now living in the eastern United States whom the Soviets accused of taking part in a massacre of Jews in the Ukraine in 1942.

The defendant was not present at the hearing but, in keeping with a standard practice accepted by the Soviets, his attorney was present to cross-examine the witnesses. In addition, a Soviet prosecutor presided over the videotaped hearing.

The attorney, John Rogers Carroll of Philadelphia, asked that his client not be identified by name in view of the two bomb attacks last year.

The sources said the two OSI attorneys at the Cherkassy hearing were delighted with what the prosecutors called the "high quality of the Soviet witnesses, whose recall of events seemed remarkably clear despite the passage of 40 years."

Carroll, however, said he remembered the witnesses—one in particular—as some of the least

convincing he had encountered in a long career of trial practice. The main witness, who claimed to have survived the massacre as a child, was a "joke," Carroll said in a telephone interview.

"He was as absurd a witness as I have ever heard testify. He was so bad, and the KGB guy sitting next to him was so embarrassed by his oratory—he sounded like someone at a Soviet trade union congress that he told the guy to pipe down and just answer the questions."

Carroll said that only one of the five witnesses was asked to identify his client from photographs, producing an equivocal response.

"One has to wonder why," Carroll said. "They were witness to atrocities by someone in that village, but they were never asked to establish who. It left a substantial evidentiary gap."

Carroll said he left Cherkassy as soon as the depositions were completed, partly to escape what he called an "unbearably oppressive atmosphere."

"The Soviets kept referring to me as the 'private advocate of the Nazi murderer,'" he said. "Defense attorneys are not made to feel welcome."

The day after Carroll left, however, a Soviet official involved in the hearing approached an American diplomat who was serving as a liaison between the team from the Office of Special Investigations and local authorities.

Speaking privately and with some emotion, one source said, the official disclosed that the five witnesses had not been brought to Cherkassy the day before the hearing began, as the Americans had been told, but had been confined in the town for well over a week of intensive coaching and rehearsals of their testimony.

Tailoring the Testimony

This source, who was fully informed of the incident that summer, said the official was unable to specify to what extent their testimony was actually perjured—that is, false or misleading. But the official made it clear that the Soviet aim in drilling the witnesses on their stories was to tailor them to the needs of the American prosecutors, making the testimony as incriminating as possible.

It was in this context that the official asked in disbelief how the Americans could allow themselves to be "taken in" by what was, in fact, a staged performance.

"Don't you people know that we remember what we are told to remember, that we say what we are told to say?" the informant was reported to have said. He reportedly went on to describe Moscow's purpose in essentially the same political terms used by OSI's critics in the United States.

"This is the way the (Soviet) regime tries to legitimize itself in the eyes of Ukrainians, by discrediting the emigres," the official was quoted as saying.

The U.S. Embassy in Moscow promptly reported the incident to the Justice Department. Several weeks later, the American diplomat was flown to Finland, where representatives of the Office of Special Investigations—among them the current director, Sher spent about 90 minutes debriefing him in the security of the U.S. Embassy in Helsinki.

In ar interview with The Times in January in which this incident was not mentioned, Sher said there was no evidence that the Soviets have ever dictated how witnesses were to testify to OSI attorneys or in any similar war crimes cases.

"There is no indication that the Soviets have said (to witnesses), 'You have to say this or you have to say that,'" Sher said. He added that if at any time the KGB had "spoon-fed a witness," then this "would show up on cross-examination. . . . Our system provides the means to detect it."

Asked in a more recent interview how he reconciled this with the Soviet official's statement in Cherkassy, Sher acknowledged that he had debriefed the American diplomat in whom the Soviet official had confided but said the OSI concluded the incident had no significance.

"We looked at it very carefully," Sher said. "It was clear to us that there was no hard evidence about anything, that these witnesses were not compromised."

He said that he did not recall any reference to the coaching of witnesses. "It was clear to us that what was said was an offhand remark, nothing hard to it, a comment by someone who may have been disgruntled," he said.

However, a U.S. diplomat who served in Moscow and was familiar with the incident said this characterization was not correct. He said that although any Soviet official who would dare to make such a disclosure would be disgruntled almost by definition, this did not impugn the accuracy of remarks that seemed carefully considered, informed and sincere.

The official's point, the diplomat said, "was to let us know we were being misled."

Out of Court Settlement

Sher said the case was later settled out of court, not because of concern about compromised testimony but out of consideration for the defendant's poor health.

Carroll, the defense attorney in the case, said he was never told about the incident, although it would have substantially affected his handling of the case. "As for telling me anything about the coaching of witnesses—never," Carroll said in a telephone conversation. "Why would they? I was the other side."

He said the case lay dormant on the docket of U.S. District Judge E. Mac Troutman of the Eastern District of Pennsylvania for more than two years, from 1983 until last October. Then Troutman, impatient with the Justice Lepartment's lack of action, prodded the Office of Special Investigations to settle it out of court. To his amazement, Carroll said, OSI agreed to settle without trial, but offered no plausible reason for its action.

"I keep close track of these things, but this was one of only two cases I had ever heard of in which they agreed to settle," he said. "They said they did it out of consideration for the guy's health, but that's patently false. They never do anything for anyone's health."

He noted that the Justice Department deported 86-year-old Andrija Artukovic to Yugoslavia last December on a stretcher to stand trial on charges of directing the execution of thousands of civilians during World War II.

Other attorneys have complained that OSI continued prosecuting two other suspected war criminals even though they were hospitalized with terminal cancer and closed the cases only on receipt of death certificates and photographs of the bodies.

Under the settlement offered by the Office of Special Investigations, Carroll said his client agreed to surrender his American citizenship in return for permission to continue living in the United States as a stateless person, in effect, a man without a country.

Carroll said the man maintains his innocence and wanted to clear his name in a trial, but his family persuaded him that his history of heart disease made it unlikely that he could withstand the stress.

Apart from the implications of the Soviet official's statement for other cases, Carroll said it might have substantially changed the outcome of this one, had the Justice Department told him about it.

"I thought all along that they (OSI) were holding off because they perceived some weakness. This might have been the straw that broke the camel's back," he said.

At a minimum, he said, he would have obtained a deposition from the diplomat involved in the Cherkassy matter that "would have directly impeached the testimony."

And, he added, "I certainly would not have advised my client to hand over his certificate of naturalization."

1944 was the year Stalin, Churchill, Roosevelt and DeGaulle agreed to a secret operation, code named "Keelhaul." They certainly knew this name was applicable to what they had planned-THE COLD BLOODED MURDER OF MILLIONS **OF EAST EUROPEANS!**

After the battle of Moscow one of Russia's leading generals, Andrei Vlasov, was captured and switched over to the German side. From prisoners of war he gathered together an army of over one million men to fight in German uniform to liberate their homeland from the inhumanities of communism.

Allied planes flew over what was left of German military positions in 1945 dropping millions of "safe conduct passess" urging all to surrender. The leaflets especially singled out the Russians with a promise they would NOT be returned to the Soviets.

Even German prisoners of war captured by Stalin's forces were illegally held 10 years, until 1955. Hundreds of thousands perished from brutal treatment and those who did return were in very poor health.

Other East Europeans, (outside the Vlasov Army,) included 600,000 in German Army volunteer divisions, 60,000 in the navy and 15,000 in the air force. They were also shipped back to Russia and to fiendish deaths.

Croatians Returned To Death

The Croation Army, along with 250,000 men, women and children civilians, marched north into Austria to surrender to the British. Marshal Harold Alexander spoke to the Croatian Chief of Staff at Bleiburg in the Alps. He stated: "All Croatian troops are to surrender and return to Yugoslavia." He promised that Tito would treat them as prisoners-of-war under the protection of the Geneva convention. This ultimatum was given AFTER the Croatians laid down their arms. Once all weapons were collected Alexander gave the order to repatriate them and should they resist; "British tanks and airplanes will open fire."

"Many Cossacks threw themselves under British tanks. Along the Drau River from Lienz to Oberdrauburg, a real battle was waged. Those who tried to escape to the mountains were shot by British soldiers. Untold numbers of men, woman and children drowned in the river."

Gorbachev, in Paris for a four-day visit, said on French television: "The Jewish population represents 0.69 per cent of our total population but they represent 10 to 20 per cent of those (playing an active role) in the political and cultural process.'

"There is no country in the world except mine where people are so free," Zvezdin boasted. "There are a lot of synagogues in the Soviet Union. We publish more Yiddish literature than any other country, including Israel. All people in the USSR are equal."

As I mentioned in my article "Jews in the Soviet Union," there are 92 active synagogues in the USSR today. Each one has the prescribed number of scrolls of the Torah, as well, as collections of religious literature, the ritual mikvah, shops selling kosher meat and akeries that make matzo.

Every year the Moscow Central Synagogue prints large editions of the illustrated religious pocket calendar. The synagogue also published for wide distribution the prayer book edited by the late Rabbi Jehuda Leib Levin.

The Moscow Central Synagogue, which is regarded as the national center of Judaism, runs a Yeshiva to train rabbis.

All told, in the postwar period, that is the past 32 years, about 136,000 Soviet Jews, including children up to 16 years of age, left the Soviet Union for Israel and other countries. That is about 6 percent of the entire Jewish population of the USSR.

At the same time the number of applications from former Soviet citizens of Jewish nationality for permission to return to the Soviet Union is growing. As of January 1, the Ministry of Interior Affairs had received 2,000 requests.

What To Do With Demjanjuk?

The press in Israel has featured every aspect of the case, from his arrival after extradition, to pictures and stories about the cell he is to occupy, its furnishing, and its round-the-clock guard.

Survivors of Treblinka (and there are not many) are already, speaking out and recalling the brutality of the Nazi who had been nicknamed "Ivan the Terrible."

Undoubtedly there will be some sort of national hysteria as the prosecution presents its witnesses and its documentary evidence. But what if the evidence does not stand up in court? What if Demjanjuk's reiteration of his innocence is not broken? After all, it is extremely difficult to identify a man positively after 40 years. His defense attorney will be skillful. And the question is being asked: What if, after all this, the court finds Demjanjuk innocent (perhaps for lack of suitable convincing evidence) and sets him free?
