Commander Interviewed by WOUB

On 23 November Commander Koehl was interviewed by Bob Pondillo on WOUB, the radio outlet of Ohio State University, Athens, Ohio.

In discussing the subject "alternatives to racial violence," the Commander pointed out that the only effective solution to Black violence and the ever-skyrocketing Black crime rate would be the repatriation of Negroes to their native homeland in Africa. "Furthermore," he said, "the White working man cannot continue to support such multibillion-dollar extortion programs as Black welfare, Black capitalism, urban renewal, etc."

The interview, recorded on tape, will be heard sometime early next year.

Stormtroopers Expose Soviet 'Anti-Semitism' Fraud

On 12 December, two teams of Stormtroopers from the Washington-Baltimore area led by TL Richard Biederman held a counter-demonstration in Lafayette Park as a few hundred motly Hebrews awaited a "Freedom for Soviet Jewry" bus that had come across the country from Seattle. The purpose of the Jewish rally was to protest alleged Soviet anti-Semitism.

As the Jews' bus pulled up across from the White House, it received a sorry welcome. Many of the Jews ignored it, preferring to heckle our men instead who were carrying signs reading "Gas Jew Communists!" "No More Jewish Wars" and "40 Million Christians Killed by Red Jews".

As the demonstration continued, a number of JDL hebes tried to push a group of younger Jews into our men to provoke a fight. They were quickly subdued by police who made sure that no Jewish skulls would be broken. There were no incidents despite the Jewish threats and the Troopers left the scene after about an hour.

The Jews apparently knew better than to pick a fight with our men as they had seen what happened at the launching of the Jew bus in Seattle some months ago and did not wish to repeat it.

Student Suspended for Distributing 'Hate'

It's sickening enough when System leaders refuse to do anything about forced busing and other crimes against our race. But when these same creeps harass young idealists who try to do something about it, it is even more disgusting.

One young comrade who has honorably earned the hatred of this rotten "respectable" Establishment is Scott Mosby, a student at Whitefish Bay High in Milwaukee. Mr. Mosby reports:

"As I stated in my last report, my principal threatened to suspend me if I continued distributing literature. Doubting his authority to take action, I contacted the ACLU who told me that if I were suspended, it would be a violation of my civil liberties. So I continued . . . and was suspended.

"Several days later, the ACLU said they wouldn't back me in court! I later found out, after returning to school, that one of the parents demanding my expulsion was a lawyer with the ACLU!

"I'm now pressuring the principal to clearly define 'hate.' In the meantime, I fully intend to exercise all my rights under the first amendment to the Constitution."

Here are some suggestions for high school activists:

1. For open distributions, secure permission from an instructor. Usually a non-Jewish liberal who claims to be for free speech is your best bet. Otherwise, leaflets can "get lost" in lockers and school library books.

- 2. Always insist on the same rights leftist students get. Be courteous, but firm.
- 3. If you have any further questions, contact National Headquarters.

Danbury racial tension fueled by Nazi mailings

DANBURY — Racial tensions here that sparked violence at Danbury High School a week ago were fueled through a mail campaign conducted by a fledgling group of American Nazi Party supporters, it has been learned. The group, unofficially headed by 21-year-old Bill Bingel of Danbury, who says he's a member of the Nazi Party, two weeks ago sent virulent anti-black anti-lewish leaflets through the mail to a yet undetermined number of area

One such leaflet, titled "Boating — Not Busing," asks readers to abandon the two-party political system in the U.S., and join in the Nazi effort to return blacks to Africa, or at least to a black enclave to be established in

The leaflet is peppered with implied threats of violence such as:

-"... should we do some killing? Should we cut off, root and branch, the satante Jews and all their lackies who are stirring up the niggers against

— "There might be school buses going up in smoke all over the country. There might be shotgun blasts into the guts of 'mixmaster' (integrationist) principals and superintendents. There might even be hand grenades lobbed

ight the smelly chambers of the Supreme Court as the nine old swine go through their obscene legal hocus-pocus."

Some white citizens who received the leaflets — like Mrs. Lianne Migiano of Danbury — were shocked and disheartened by them and turned them over to police and postal authorities here. Several of the leaflets were duplicated by shocked recipients and have been circulating in Danbury's black community.

The Rev. W. D. Cleveland, the black candidate for mayor in last Tuesday's elections, called the leaflets "a substantial contributing factor to the racial tension in our community."

The leaflets were picked up by Bingel at the NS (National Socialist) Bookstore in Bridgeport. The store is claimed by Nazi Party headquarters in Arlington, Va., as "our official outlet in Connecticut," according to a duty officer at the headquarters.



A Note on the ST

With the ever-increasing number of Party victories under Commander Koehl's leadership, more and more two-fisted young idealists have been asking about the requirements for joining the fighting Stormtroops of the National Socialist White People's Party. Below are a few guidelines.

- 1. Any Aryan male at least 18 years of age who is dedicated to the aims and goals of the Party may become a Probationary Trooper (PT).
- 2. The PT must undergo a probationary period of not less than three months, during which he must be fully active and participate in all local NS activities. A PT has active status if he is able to participate regularly in Party activities sponsored by an organized unit of the Party in his area. Any PT who is not able to participate regularly in Party activities or who lives far from an organized unit holds reserve status and is expected to participate whenever possible.
- 3. The PT must have a complete and proper ST uniform. Details on the uniform are available from National Headquarters on request.
- 4. Upon completion of the probationary period (provided the PT has successfully fulfilled all the requirements), the active status PT may be sworn into the ranks of the Stormtroops (ST). Further promotions in the ST depend chiefly on the following:
 - a) Loyalty
 - b)Time in grade
 - c) Ability

All who qualify and think they can measure up to the standards required of an ST man should contact Capt. Kirstein for an ST application form and further details. Send all inquiries to National Headquarters.
