Commander Addresses Chicago Meeting

In the Party's first public meeting there since the famous demonstrations led by Lincoln Rockwell in the summer of 1966, Chicago-area National Socialists and White people heard Commander Koehl speak on January 14.

In his remarks, the Commander pointed out that the present System is not representative of the interests and aspirations of White people. Far from being "democratic," it is oppressive to the very majority it should be representing. "In every case, whether it be issues as inflation, unemployment, high taxes, forced busing, Black welfare and crime, or no-win wars in Vietnam or Israel, the interests of the White majority are being betrayed!" He further stated that it was time to rid ourselves of the Rosenwalds, Sterns, Lehmans, Guggenheims, Sviridoffs, Ribicoffs and other kosher bigwigs responsible for forced race-mixing and crimes of racial genocide against White people. In opposition to this very real dictatorship, the Commander stated that the National Socialist White People's Party demands a system truly representative of the will of our people.

Concerning the Blacks, the Commander said, "We are asked how we can afford to ship those niggers back. And my answer again and again is how can we afford not to? With all the billions and billions we've wasted on Black welfare, Black crime, Black capitalism and Black urban renewal, we could have shipped our Black population back to Africa a dozen times over already. Once they get over there, I don't care if they practice voodoo, eat each other or swing from trees – we've just got to get them on those boats!"

Other speakers at the meeting included Richard Biedermann and Michael Szipronat who discussed upcoming local activities and emphasized that the only way for America's future – a White future – was with the National Socialist White People's Party.

A good number of White Chicagoans braved the record sub-zero weather to attend the meeting, including a number of recent recruits and interested area residents.

L.A. National Socialists Win in Court, Plan Suits

Two court cases involving Party activity in the Los Angeles-area community of Monrovia have been won. The first case, involving troopers distributing leaflets outside a high school plagued with Black terrorism, was dismissed. The second case, involving a White Power demonstration in front of the city hall (see NSB no. 99), was also dismissed for lack of evidence. Plans have been made to sue the city for false arrest.

Meanwhile, El Monte city bureaucrats - cowards that they are - have been holding meetings with the Jewish Defense League in which they admittedly formed an alliance with the intention of conspiring to "rid the city of the Nazi facilities." One of their 'courageous' acts was to grant the Jews a permit for a demonstration in front of the headquarters 30 January, an act they are now trying to welch out of.

The city is further attempting to use city laws on zoning to condemn the property altogether. All this, of course, constitutes conspiracy to deprive our men of their civil rights, a criminal offense which could very well land these pompous idiots behind bars.

A recent report from Lt. Tommasi summed up his feelings on the Party's position:

"... Another suit in the making! We have them where we want them!"



EL MONTE-Members of the militant Jewish Defense League Tuesday night convinced city councilmen to form an alliance with them to force the Nazl headquarters out of El Monte.

About 50 members of the Los Angeles chapter of the JDL were present at the City Council meeting, along with representa-tives of Bible Light, a Christian organization, protesting the location of the Southern California headquarters of the American Nazi Party in El Monte.

On a motion by Councilman Jack Crippen, the council voted unanimously to instruct the city staff to continue their efforts to remove the Nazis from the city under the city's property maintenance ordinance and by taking the matter to the courts if necessary.

Even if the effort is success-ful, however, the proceedings would probably continue for eight or ten months before the action becomes final.

City staff members encouraged continuing the alliance be-tween the JDL and the city for the task, possibly including petitioning the state legislature to take action against the group.

The National Socialist White People's Party, as members refer to the group, is based at 4375 N. Peck Rd. in El Monte in a white house plastered with large red and black swastikas, Nazi flags and slogans.

Nazi leader Joe Tommasi told The Tribune Tuesday his group plans to open yet another fice" within the next two weeks in West Covina. He gave no ad-dress, although he said it would be somewhere along the San Bernardino Freeway.

HEADQUARTERED IN VALLEY

City councilmen for the most part agreed with JDL spokesmen on the need to remove the group from the city. It has been in El Monte for about five years since it left Glendale after assorted demonstrations there. According to City Atty. James

Nicklin, the city has worked toward removing the group from El Monte since its arrival.

However, their "unpleasant-ness has not yet been declared unlawful," Nicklin told the JDL.

unlawful," Nicklin told the JDL. City Administrator Kenneth Botts told the group "we agree totally" with the JDL's interest. However, he said after a meeting Monday in his office with leaders of the JDL and Bible Light, they "agreed to dis-agree on the methods" of trying to accomplish this common accomplish this common to goal.

The Rev. Paul Peterson of Burbank, national coordinator and field director of Bible Light, was the first to address coun-cilmen. He was active in the effort to oust the Nazis from Glendale before their move to El Monte.

He told councilmen his group realizes efforts have been taken to rid the city of the Nazis, al-though he said "up to this time the steps taken have been in-effective."

"It is time that the City Council face the fact that the Nazi Party is making disturbing and provocative excursions into various parts of Southern Galiprovocative fornia and retreating to its safe haven here in El Monte," he said

He told councilmen a "mas-sive demonstration" is still planned for 1 p.m. Jan. 30 in front of the headquarters where both "the Jewish and Black communities" are expected to rally.

"The hated sign of the swastika stands for all the senseless, murderous hatred heaped upon the Jewish people. These white extremists now dare to display that sign as a symbol of their ultimate intention of exterminating not only Jews, but Negroes and every other non-Aryan race," he said.

He backed up his claims by reading from a copy of George Lincoln Rockwell's "In Hoc Sig-no Vinces" or "In This Sign We Conquer." Peterson said he pur-chased the book at the Peck Bood hecksuncture Road headquarters.

Irv Rubin of Northridge, west coast coordinator of the JDL, told councilmen ."I cannot guarantee that violence will not oc-cur if they (the Nazis) are allowed to remain." Shirley Okin, women's coordinator of the JDL, said the group is conspiring to commit murder.

"In this lovely city of El "In this lovely city of Er Monte there is a blight which I know each and every citizen is aware of," she said. Attorney for the JDL Jess Nathan of Los Angeles, a World

War II veteran and a survivor of a German concentration camp, said he abhors violence along with the city councilmen. "But without the rule of law

there can be no rule of peace and gentlemen, you are the embodiment of the rule of law," he said.

Police detectives were plentiful Tuesday night, although there were no incidents. Nazi leader Tommasi told The Tribune early Tuesday he expected to have a delegation at the meeting, although only three men there were identified by police as Nazis.

They entered a brief shouting encounter with JDL members after the meeting before seeking refuge in the lobby of the near-

by police department. A small picket line with about a dozen placard-carriers circled in front of City Hall before the meeting. "Never again," the meeting. "Never again," the J D L slogan, was displayed along with others such as "Nazi mentality must die" and "The new Jew stands up and fights."

National Organizer Stirs Area High School

On 13 January, Capt. William Kirstein spoke before a major part of the student body at Annandale High School in Northern Virginia.

Originally slated to speak before one or two government classes, student interest mushroomed after the first speech and students began cutting classes to attend. By that afternoon, so many students jammed the hallways to get in that school officials suspended classes and convened a meeting in the auditorium. In his speeches, the Captain pointed out that America was a White man's country and not some obscene conglomeration of the very best with the lowest spawn. "This White majority is being exploited and used by the rotten System running things for Jewish and nigger interests," he said. "Your duty will be to join this movement and help build a new order reaffirming this country's racial foundations – White Power!"

Large quantities of literature were distributed. Students were very attentive, and at one point even shouted down a number of loud-mouthed Jews trying to disrupt the Captain's presentation. Many inquiries have been coming in from Annandale as a result of this speech.

Cleveland Unit Forges Ahead

The Cleveland unit has reported stepped-up activity in recent weeks, including literature distributions and media appearances.

On 20 January, Organizer Casey Kalemba and Youth Coordinator Frank Spisak appeared on WDOR radio in Ashtabula. The Party's White Power program and Back-to-Africa policies were discussed as well as future plans for the growth of the Party in the Cleveland area. The two were invited to return at the end of the program. Invitations for Party spokesmen have been received from WKYC radio and Chagrin High School.

Several days later, a leaflet distribution was held in front of city hall where the issue of low-income housing for Blacks in White neighborhoods was being discussed. Five police cars were on hand during a few tense moments when creeps looked like they'd start trouble — but the confrontation and fight on 9 November had taught them their lesson (see NSB no. 98)!

Young NS Activist Scores Publicity at School

John Sedlak, a young Stormtrooper with the Detroit unit and a student at Wayne State University has been very active in getting the word out, especially recently. Some of the fruits of his labors are reproduced below.

Two unidentified students were seen handing out leaflets on the Mall Friday afternoon.

White man and Black man beware! The jew dominated system is attempting to destroy your racial integrity as well as your own free choice.
