ST Pickets White House, Demands Freedom for Hess

14 May — Despite heavy spring rain, four teams of Stormtroopers led by GL Wolfgang Schrodt conducted a picket in front of the White House on behalf of imprisoned Party comrade Rudolf Hess. The demonstrators brought it to the attention of the public that the aged Hess remains incarcerated in Berlin's Spandau prison even though he has committed no crime.

Accused and convicted at the Nuremberg kangaroo trials after World War Two of taking part in "crimes against peace", Hess flew heroically to Britain in 1941 with a generous offer of peace. The British, however, refused to even hear Hess's proposals and threw him in jail, where he has been ever since. As pointed out by Commander Koehl in a recent radio program, Hess remains in prison solely because he flatly refuses to denounce Adolf Hitler and National Socialism. Hess reportedly said in reaction to "making deals" for his freedom, "I would rather die in prison an honest man than live in freedom as a scoundrel."

The demonstration was conducted peacefully, except for a few tense moments when members of the Jewish Defense League arrived on the scene to taunt the troopers. They were quickly surprised, however, and left upon a few harsh words in support of our men from passers-by. This picket represented yet another in a continuing series of worldwide public events calculated to dramatize the plight of the imprisoned comrade.

Commander Koehl Visits Florida

6 May — Commander Koehl spoke to a gathering of nearly fifty people in the Tampa area on the topic "The White Man and the 1972 Elections." He emphasized that this year's elections are not significantly different from those staged in years past — that the White people are offered no meaningful alternatives to the ever-growing spiral of taxation, crime, busing, etc. He remarked that no candidate had the courage to speak up on the real root issue of race and declare himself the champion of White racial interests. In his probing analysis, he noted that Jewish money-men prominently support all candidates and that these behind-the-scenes moguls exert heavy influence on the issues brought forth in the elections. "The whole thing," he concluded, "is a farce!"

9 May — The Commander met with a number of disenchanted members from one of the older right-wing organizations. These individuals realize the racial implications of contemporary politics and seek to do some really constructive work in the South Florida area. The Commander emphasized that only the Party, with its uncompromising stand for racial interests, can provide the kind of necessary solutions to the problems facing our race in this country and that any other approach is half-hearted stop-gap measure at best. In addition to this meeting, the Party leader also held a number of private meetings in the area.

13 May — After returning to Arlington, the Commander addressed a group of Baltimore-area activists and new people with an analysis of the up-coming elections.

Further Radio Broadcasts for National Socialism

Reports indicate that tens of thousands of Americans are being reached by the race-saving message of National Socialism as Commander Koehl's new commentary program, "The Future Calls" continues on the air. The program is broadcast in the San Francisco area on KTAO-FM, 95.3 mc. at 7 p.m. Wednesdays and in St. Louis on KDNA-FM, 102.5 mc. at 8 p.m. Sundays as a part of their "New Perspectives" program. The broadcast features, after the Rudolf Hess commentary, an analysis of rising White disenchantment with the System. The program discusses the high cost of living in relation to the new "Nixonomic" policies next, with following broadcasts devoted to the farm problem and National Socialist solutions.

Lt. Tommasi on Los Angeles Radio

Lt. Joe Tommasi, head of the El Monte (Los Angeles) headquarters, was scheduled to be a featured speaker at the University of Southern California, but because of JDL "threats" and cowardice on the part of university officials, Lt. Tommasi appeared instead on a popular local radio station for 1½ uninterrupted hours. According to his report, call-in response was highly favorable, with many callers totally agreeing with the NS viewpoint while registering hostility to Jewish pressures. As usual, brave telephone warriors of the JDL made ninny of themselves with their obscenities and irrational comments. Lt. Tommasi was thus able to expose hundreds to the realities of Jewish pressure groups and censorship. Due to recent Party confrontations and publicity there, Jewish groups and other anti-White types have been growing concerned over the Party's increasing ability to defend itself in the courts. QUIXOTIC?

Unpopular Causes Hold No Fear for Nazis' Attorney

James R. White, the attorney who has been defending the American Nazi Party members operating out of the El Monte headquarters, is cool, enigmatic and outspokenly rebellious.

Those who have heard him speak

in courtroom recesses might easily classify him as a right-winger because of his joking references to takeover of the government.

And others who might have heard him speak about his background as a lawyer might categorize him as an idealist, a strongly committed civil libertarian. White says he has defended Black Muslims, Black Nationalists, Black Panthers and others who are similarly unpopular.

From appearances, it has been White alone who has kept the Nationalist Socialist White People's (Nazi) Party legally viable. But White denies it, maintaining he is only one of six lawyers working to defend the rights of the highly controversial party.

Nazis Know Law

One of the factors that distin-

guish the local Nazis from other radical groups is that they are well versed in the law and are able to move within legal limits. By doing so they avoid being arrested.

The demonstration Jan. 30 in front of the headquarters at 4375 N. Peck Road in El Monte is an example. The Nazis were able to stand on their property and face a hostile crowd while holding rifles on their hips because the Nazis were within their legal rights.

Often their appearance at a demonstration arouses others into violent action and arrest while the Nazis are exercising a basic freedom guaranteed under law.

White is scheduled to defend the Nazis Monday in West Covina and El Monte Municipal courts.

Blacks Stay Out of Class At Hammond

Two busloads of black students at Alexandria's racially troubled Francis Hammond secondary school boycotted classes this morning and rode off to a caucus at a city church.

The "students left for the Roberts Memorial Methodist

Church about 10 a.m., an hour after the first school bells had rung.

Meanwhile, most of Hammond's 400 black students mulled in the hallways and argued with school officials about last Friday's racial fighting which led to two arrests, six suspensions and one minor injury to a teacher.

What angered black Hammond students most was growing talk that an all-white fraternity here is affiliated with the National Socialist White People's Party of Arlington County (the Nazis).
