So far this coalition has resulted in several incidents and much publicity for the Party in the Los Angeles and Southern California area.

The latest episode is taking place in the courts, where city officials are attempting to get Lt. Tommasi on trumped up charges of an occupancy violation. Lt. Tommasi uses the El Monte headquarters for his residence as well as his place of work. The accompanying news clipping of 13 July details these latest bureaucratic maneuvers.

In Arlington, Commander Koehl has stated that Lt. Tommasi has been given the go ahead to fight this unholy alliance of city officials and JDLers in any way possible. ## EM Nazi Leader Ordered To Enter A Plea Today

Judge Roy L. Norman overruled a demurrer, July 6, filed in defense of Nazi leader, Joseph C. Tommassi and ordered him to appear in court today (July 13) and plea.

Tommasi, head of the Los Angeles and Orange counties factions of the National Socialist White People's (Nazi) Party, is charged with violating a city law that requires all businesses to obtain a certificate of occurancy.

#### Mugging by Blacks Leads to New Recruits in Cincinnati

A comrade in Cincinnati reports that his activism and vocal support of the National Socialist White Power stance is bearing fruit. According to his latest activity report, several high school-age youths who had been inquiring about the Party came to his house. One had been beaten by a gang of Blacks when he thrashed one of their members who had harassed some younger White kids. The Cincinnati National Socialist immediately armed himself and returned to the scene of the beating, searching for the Black attackers. Finding that they had fled, he returned home. Later on that evening, a group of White youths knocked on his door. Here is the story in his own words:

"... I heard a knock on the front door and found myself confronting a group of White youths hollering "White Power,' etc. I invited them in and gave a little speech of what White Power was all about. They were all greatly excited and I came to find out that they were a smaller group of a greater one of about 40 youths who had rallied to protect the two that had come to my house earlier. I gave them all White Power literature, and was begged out of White Power buttons. I was told that they were getting their money together to purchase White Power T-shirts which I'll order from the Cleveland unit. I met with this larger group and gave out another bunch of literature and discussed practical racial unity and participation against our racial enemies. It was truly amazing how quickly they rallied around the White Power Aryan Cross. I gained a number of new names for our building ST unit who are fighters in every sense of the word. This was an inspiring moment for me, and an outstanding demonstration of what out future holds once our movement reaches the massive proportions needed to win.

"We have a victory here and I'm proud of those who participated. Heil Hitler!"

#### NY State Education Report Cites NS Literature as Cause of White 'Backlash' in Schools

A fifteen page report of the NY State Department of Education was printed in full in the July 21 edition of *The Geneva Times*. The report, filling two pages of the paper, credited NS activists and NSWPP literature as "the factor which precipitated" Whites standing up and fighting back against the Black atrocities occurring in the Geneva high schools.

The Party leaflet "UPTIGHT ABOUT SCHOOL . . . or just about the Niggers?" was cited by the report as accurately reflecting the White kids' attitude about conditions in the school and about their Black classmates. School administrators, shocked at the findings of the investigation, feel that the institution of a Black studies program open to all students would help alleviate the "hurt" feelings of Negro students.

And, of course, the report itself recommended "mandatory training in race relations" for all teachers, the hiring of more Black teachers and administrators, and a curriculum which "should provide for all children an understanding of the contributions of the Negro, Puerto Rican, and other minority groups."

National Headquarters recommends that activists counter this "education" with the mass distribution of White Power literature. When the lies inherent in these liberal programs are exposed, the youth and their teachers will know where to turn for the truth and the answer to their problem.

#### JDL Tries to Sue Party for \$10 Million

Chagrined at the ignominous thrashing they received at the hands of hundreds of Party supporters in the Philadelphia suburb of Kensington several weeks ago, the JDL has decided to try an indirect and less painful attack on the Party.

In keeping with their typical sheenie mentality, the gefilte-fish goons of the JDL have tried to hurt the Party in the pocketbook since their physical assaults upon National Socialists have resulted in nothing but bad bruises and big hospital bills for them.

The Jews have found that in making the NSWPP their adversary they are dealing with more than unarmed Arabs! The article, from the *Philadelphia Inquirer*, is reproduced in full.

### ACLU Declines Role in Lawsuit Against 'Nazis'

The American Civil Liberties Union (ACLU) on Thursday turned down a request by the Jewish Defense League (JDL) to handle a \$10 million libel suit against the Nationalist Socialist White Peoples Party.

In a 90-minute discussion at the ACLU office at 260 S. 15th st., four JDL leaders tried to persuade ACLU executive director Spencer B. Coxe that they deserved representation as much as Kensington neo-Nazi leader Charles Kress.

The ACLU had recently defended Kress against charges filed with the Human Relations Commission. Witnesses testified that Kress, of E. Cumberland st., conducted a campaign of anti-Semitism and racial hatred.

"I UNDERSTAND your position and I entirely sympathize with the way you feel," Coxe told the group. "But you must understand that the Civil Liberties Union never becomes involved in libel suits and this matter is out of our scope."

#### Some Guidelines for the Congress

There have been numerous inquiries regarding matters connected with attending this year's Congress. Below is information which will be of help to many delegates. Please take careful note of the standards and requirements. They reflect the National Socialist life-style and will be enforced to insure that this year's Congress is a truly inspiring tribute to the memory and spirit of Lincoln Rockwell!

Registration: All delegates must be registered to attend the Congress. Registration will take place up to 2300 hours Friday, 1 September. A limited number of registrations will be handled Saturday morning, the 2nd, between 0700 and 0900. Those arriving late will have to wait until the noon recess to register. Late arrivals cannot be admitted to the Congress sessions until they are registered.

Registration cards were enclosed in the previous NS Bulletin. If you plan to attend return them with your \$3 registration fee right away. To be eligible to attend, a person must have been a Party Member or Official Supporter as of 31 July 1972. Except in certain special instances, persons who have become Official Supporters since 1 July 1972 are required to have their OS dues paid up three months in advance (August — October) in order to be eligible for the Congress.

Good Standing: This means that all dues and pledges are paid up to date. No one who is not in good standing will be admitted to the Congress. Contact National Headquarters if there are any questions concerning this matter.

Transportation: We consistently have more drivers and vehicles than people who are willing to take advantage of them. If you need transportation, please notify National Headquarters immediately.

Interviews: There will be no membership interviews during the period from 1-4 September. Persons interested in an interview at some time before or after the Congress must submit their requests no later than 10 August.

Appearance: All delegates are expected to look and act like worthy representatives of the National Socialist movement, so that they may be active participants in all events of the Congress.

Hair – For male delegates, this means they must have proper haircuts. (No excessive length, no ducktails, no mutton-chop sideburns. Hair should taper off neatly to a shadow at the sides, back and sideburns. Sideburns should not extend below the midpoint of the ear.) Persons with long and/or shaggy hair will not be admitted to the Congress. (If there is any question as to what constitutes acceptable hair length, simply refer to a photograph of Adolf Hitler, Lincoln Rockwell, or Commander Koehl.)

Mustaches — Mustaches must be neatly trimmed and groomed. Beards, properly groomed, will be allowed for elderly delegates only.

Dress - Party Members should wear Party uniform during the Congress. (This consists of khaki shirt, black cloth tie, black oxfords and belt, and black [or dark] trousers. Suit coat is optional.)

Male delegates other than full Party Members, including Probationary Members, should wear suit and tie, except for ST uniforms during the Sunday rally. NO levis, bellbottoms, leather jackets, sandals or other "mod" or garish attire will be allowed. Similarly, no German military paraphernalia will be permitted to be worn.

Women delegates should wear a dress or skirt and blouse in good taste. Miniskirts, "hot-pants" or slacks will not be allowed.

ST Demonstration: Stormtroopers participating in this year's Congress rally must have a complete uniform (including the regulation helmet available only through National Headquarters for \$12.95; it is suggested that ST should send in orders with full payment and request that the helmets be held for them at National Headquarters, since they may not arrive by return mail in time for the Congress.)

CORRECTION: In the accommodations leaflet sent out with the 15 July Bulletin a mistake was made in reference to Direction No. 2, "From the South." After following Route 27 to Wilson Blvd., be sure to turn right, and then turn left at N. Franklin Rd. Corrections were made before the accommodations flyer was sent out, but check your copy and make sure.

#### WHERE THE ACTION IS!

19-23 August — "OPERATION BEACHHEAD" will commence. Troops are urgently needed. This is the really BIG activity of the summer! See the special flyer enclosed in the 1 July Bulletin. Then ACT!

25 August — Special ceremonies will be held at National Headquarters to commemorate the fifth anniversary of the death of Lincoln Rockwell. All comrades who can are invited to attend. Proceedings will commence at 2000 hours.

26 August — Grand Opening of the new local Party Headquarters in Baltimore. All National Socialists are invited to attend — especially those on the Eastern Seaboard. Stormtroopers will be in uniform. More details later.

2-4 September — The fourth annual North American Congress of the World Union of National Socialists will be held in the Arlington area. This will mark the 10th anniversary of the founding of WUNS and the fifth anniversary of the death of the man who founded it — Lincoln Rockwell. Registration cards have been sent out with the 15 July Bulletin. Make your plans to attend now!

4 September - A White Power rally will be held in Baltimore at 1200 hours. All Congress delegates are invited to participate.
